Large m agneto-therm all e ect and the spin-phonon coupling in a parent insulating cuprate P $r_{1:3}La_{0:7}C$ uO $_4$

The magnetic-eld (H) dependence of the thermal conductivity of $Pr_{1:3}La_{0:7}CuO_4$ is found to show a pronounced minimum for in-plane elds at low temperature, which is best attributed to the scattering of phonons by free spins that are seen by a Schottky-type speci c heat and a Curie-W eiss susceptibility. Besides pointing to a strong spin-phonon coupling in cuprates, the present result demonstrates that the H-dependence of the phonon heat transport should not be naively neglected when discussing the (H) behavior of cuprates, since the Schottky anomaly is ubiquitously found in cuprates at any doping.

I. IN TRODUCTION

To elucidate the nature of the superconducting ground state, the quasiparticle (QP) transport properties are widely studied in high-Tc cuprates at low temperature (T), and the discussions are often based on the magnetic-eld (H) dependence of the therm al conductivity .^{1,2,3,4,5,6,7} The most striking ndings include a \plateau" in the (H) isotherm at low tem perature, 1,2,3an increase in the QP population due to the supercurrents around vortices,4 and the magnetic-eld-induced QP localization in underdoped cuprates.^{5,6,7} A common assumption in these previous works is that the phononic therm alconductivity p is independent of H and all the H-dependence of is of electronic origin. This assum ption m ay seem reasonable, because the vortex scattering of phonons (which is important in conventional superconductors) som ehow becom es insigni cant at low tem perature in cuprates.⁸ However, phonons could interact also with magnetic excitations and be scattered, which would introduce som e H-dependence in p. Therefore, it is in portant to elucidate how the low -T phonon heat transport is a ected by magnetic excitations in cuprates, particularly in the superconducting doping regime. Remember, even though antiferrom agnetic (AF) magnon excitations are likely to be irrelevant in the superconducting regime, Schottky anom alies in the speci c heat, which are usually attributed to excitations of localized free spins, are commonly found in superconducting cuprates.9,10,11,12,13,14,15

To gain insight into the possible H -dependence of $_{\rm p}$, it is useful to study parent insulating cuprates, where it is expected that the electronic contribution is absent and $_{\rm p}$ can be unambiguously studied; how ever, it has been discussed that in AF insulating materials the magnon excitations can also act as heat carriers or scatterers,^{16,17,18,19} which brings complications to the analysis of the (H) data of insulating samples. In particular, Jin et al.²⁰ recently reported a large magnetic-eld-induced enhancement of in Nd₂CuO₄ (NCO), a parent insulating cuprate in the tetragonal T⁰-phase, and they proposed

that the increase in gives evidence for the magnon heat transport becoming active due to the closing of a m agnon gap in the magnetic eld. Note that in NCO the m agnons for the Cu spins should not contribute to carrying heat because of a large (5 m eV) gap, and thus it m ust be the N d m agnons that is relevant r^{21} the existence of the Nd-m agnon contribution to the heat transport has been backed up by a more recent study by Liet al.²¹ Considering these ndings, to unambiguously investigate the H dependence of $_{\rm p}$, we turn to the Pr_{1:3}La_{0:7}CuO $_4$ (PLCO) system where there is essentially no magnetic contribution from the rare-earth ions. Although it was found that a sm all m agnetic m om ent is induced in P r^{3+} ions (whose ground state is singlet and would be e ectively nonmagnetic), 22,23 in Pr_{1.3}La_{0.7}CuO₄ as much as 35% of the Pr^{3+} sites are diluted by nonmagnetic La^{3+} ions and thus the Prm agnons, even if exist, should be strongly dam ped and give negligible contribution to the heat transport. Also, the single crystals of PLCO were found to show very clean phonon heat transport (e.g., p of PLCO is up to 5 tim es larger at 20 K com pared to La_2CuO_4 ²⁴) so that exotic scattering mechanism s of phonons are expected to be rather easily seen in PLCO without being masked by scatterings by disorder.

In this paper, we report detailed them al conductivity, speci c heat, and m agnetic susceptibility m easurem ents of high-quality Pr_{1:3}La_{0:7}CuO₄ (PLCO) single crystals. At low tem perature, the (H) curve shows a striking dip feature, which is di erent from previous data on sim ilar T^{0} -phase compounds, $Pr_{2}CuO_{4}$ (PCO) and NCO.^{20,25} Our new result on (H) indicates that excitations of free spins, evidenced by the speci c heat and the magnetic susceptibility data, are responsible for the peculiar H dependence of the phonon heat transport. Since the Schottky-type specic heat that is indicative of the existence of free spins is found almost ubiquitously in high-T_c cuprates, 9,10,11,12,13,14,15 the present result suggests that the phonon heat transport can be H dependent at low tem perature in a wide range of cuprate sam ples and one should be careful upon discussing the QP properties based on (H) behavior. Physically, the present result points to a strong spin-phonon coupling in cuprates,

which m ight bear intriguing implications on the mechanism of high- T_c superconductivity.

II. EXPERIMENTS

H igh-quality P $r_{1:3}La_{0:7}CuO_4$ single crystals are grown by the traveling-solvent oating-zone technique in owing oxygen.²⁴ The partial substitution of La for Pr not only stabilizes the crystal grow th^{24,26} but also disturbs the possible Prm agnons and makes them irrelevant as heat carriers, which is useful for the purpose of this work. For the heat transport measurements, the crystals are cut into rectangular platelets with a typical size of 2.5 0.5 0:1 mm³ (where the edges are made to be parallel to the crystallographic axes within 1) and annealed in owing Ar to rem ove excess oxygen.²⁴

The a- and c-axis therm al conductivities ($_{a}$ and $_{\rm c}$) are measured by a steady-state technique in a $^{3}{\rm He}$ refrigerator.⁵ Two RuO₂ chip sensors are used for the \top" and \bottom " therm om eters on the sample. For the magnetic-eld dependent (H) measurements, the base tem perature of heat sink is precisely controlled by an ac resistance bridge (Linear Research LR-700) within 0.01% accuracy with another RuO₂ therm om eter or a Cemox therm om eter (for above 10 K), and the magneticeld-dependence of the therm om eters were carefully calibrated beforehand using a SrT iO 3 capacitance sensor and a high-resolution capacitance bridge (Andeen Hagerling 2500A), which allow to keep the tem perature unchanged with a very high precision (0.1 m K at 0.3 K and 1 mK above 1K) during the magnetic eld sweeps. The relative uncertainty of the (H) measurement was conm ed to be typically less than 1%. Speci c heat and m agnetic susceptibility m easurem ents are carried out using a Physical Properties Measurement System and a SQUD magnetometer (Quantum Design), respectively.

III. RESULTS AND DISCUSSIONS

A. Therm al conductivity




FIG. 1: Temperature dependences of $_{a}$ and $_{c}$ of PLCO single crystals in zero eld. Inset: vs T³ plot of the low T data below 0.43 K. Thin solid lines show the T³ dependence expected in the boundary-scattering regime.

Figure 1 shows the tem perature dependences of $_{a}$ and $_{c}$ of PLCO in zero eld down to 0.30 K, where the data above 4 K are a reproduction from Ref. 24. As already discussed, one can assume that both $_{a}$ and $_{c}$ show purely phononic therm al conductivity in this insulating com pound, and the large m agnitude of the phonon peak evidences a high quality of our PLCO crystals.²⁴ The inset of Fig. 1 shows that the boundary-scattering regime of phonons (where $_{p}$ T³) is achieved below 0.35 K.




FIG. 2: (a) { (e) M agnetic eld dependences of in PLCO single crystals for various con gurations of the heat current $J_{\rm H}$ and the m agnetic eld. (f) C om parison of H $_{\rm dip}$ (where the (H) curve shows a minimum) for $J_{\rm H}$ k a, H k [110] to the spin-reorientation eld H $_{\rm sr}$ for the same eld direction (P lakhty et al., R ef. 29).

Figure 2 shows our main result, the peculiar magneticeld dependences of at temperatures from 0.36 to 18 K, for several di erent con gurations of heat current and magnetic eld. Notably, a pronounced dip in the (H) = (0) curves is observed for in-plane elds at

low tem pratures. At rst sight, this may seem a typical (H) behavior in a spin- op system where m agnons act as phonon scatterers.²⁷ The zero-eld is purely phononic, because there are no low energy m agnons due to the anisotropy gap in the m agnon dispersion; when the m agnetic eld is applied, the Zeem an energy causes the m agnon excitations to become gapless at the spin- op transition eld H_{sf}, but the gap opens again at higher eld; consequently, the m agnon scattering of phonons is the strongest at H_{sf} where the m agnons are the m ost populated, and causes a dip in the (H) curve.²⁷

In the T⁰-phase com pounds of NCO, PCO, and PLCO, the magnetic structures are essentially identical and spin- op (or spin-reorientation) transition of the longrange-ordered Cu spins has been studied by the neutron scattering: $2^{2,23,28,29,30,31,32,33}$ The Cu spins form a noncollinear structure with the spin easy axes of [100] and [010] in zero- ekd; depending on the magnetic- ekd direction, a rst-order transition (for H k [100]) or a continuous spin-reorientation transition (for H k [110]) is induced, and in both cases the high- ekd state has a collinear spin structure. If one tries to interpret our

(H) data in terms of this well-studied spin reorientation, several problem s becom e apparent: M ost notably, the characteristic eld for the spin reorientation, H_{sr} , is known to decrease upon heating, while the \dip" eld, H_{dip} , where the (H) curve shows a minimum, increases upon heating. W e show quantitative com parison between H_{sr} and H_{dip} for H k [110] in Fig. 2(f), where it becomes clear that H $_{\rm dip}$ is not likely to be related to the spin reorientation. Also, H_{dip} is observed to be very close for H k [100] and H k [110], while H_{sr} is much larger for H k [100] than for H k [110].^{23,30,33} Furtherm ore, the H dependence of $_{\rm c}$ is very similar to that of $_{\rm a}$, which is di cult to understand in the spin- op scenario because the c-axis phonons can hardly couple with the magnons of the two-dimensional spin system. Therefore, the peculiar (H) behavior in PLCO is clearly not due to the m agnon scattering of phonons associated with the spin reorientation.

It is known from previous neutron experiments^{22,23} that the exchange eld of the ordered Cu spins induces a small (0.1_B) ordered moment on Pr^{3+} ions. One may expect that the Prm agnons should contribute to the (H) behavior. Since the weak Prm oments are induced by the interaction between Cu and Prions, the Prm agnons, if exist and play a role (as either heat carriers or scatterers) in determining the (H) behavior, should a ect (H) in a way that corresponds to the spin reorientation transition. Therefore, the lack of correspondence between H_{dip} and H_{sr} means that not only Cu m agnons but also Prm agnons are irrelevant to the observed (H) behavior, which is likely due to the considerable dilution of the Pr sites by nonm agnetic La³⁺ ions.




FIG.3: (a) Tem perature dependences of the speci c heat of a PLCO single crystal in various magnetic elds along [110]. (b) Schottky anom aly for H k [110], obtained by subtracting the phonon contribution from the raw data in panel (a). (c) Schottky anom aly at 4 T for di erent orientations of H, together with the theoretical curves expected for the Schottky anom aly for 1% of s = 1/2 m om ents with the anisotropic Lande factor g = 2 (for [100] and [110]) and g = 1.25 (for [001]). (d) M agnetic eld dependences of the peak tem perature in the Schottky anom aly for the three directions.

B. Specicheat

To investigate the actual scatterers of phonons and the origin of the peculiar (H) behavior, the speci c heat of PLCO is measured at low tem perature using a large single crystal (34 mg, Ar-annealed) from the same batch. As shown in Fig. 3, there is a pronounced H -dependent enhancement, whose tem perature and eld dependences are fully consistent with the two-level Schottky anom aly due to free s = $1/2 \text{ m om ents}^{9,15}$

where g is the Lande factor. The concentration of free spins is n=R, where R is the universal gas constant. In our data, the peak position of the Schottky anomaly, T_{peak} , increases linearly with H [see Fig. 3(d)], which precisely follows Eq. (1) and allows us to determ ine the g factor. Moreover, tting of the data to Eq. (1) [see Fig. 3(c)] gives the concentration of the free spins to be

1%, which is too large to be associated with impurities and suggests the existence of some intrinsic mechanism to produce free moments.




FIG. 4: (a) Temperature dependences of susceptibility a and $_{\rm c}$ of a PLCO crystal in oxygenated (as-grown) and reduced (A r-annealed) states. Panels (b) and (c) m agnify the low-T part; solid lines show ttings with the formula (T) = $_0 + C = (T)$, where the rst and second terms are T-independent background and additional Curie-W eiss contribution, respectively; the C parameter for the reduced sam – ple is consistent with 1% of s = 1/2 free spins with g = 2 (g = 1.25) for H ka (kc).

C. M agnetic susceptibility

A nother evidence for the existence of free m om ents in PLCO is the magnetic susceptibility () data. Figure 4 shows the tem perature dependences of for H k a and H kc(a and c) in 0.5 T eld. Our data are essentially consistent with those for PCO single crystals,³⁴ including the low-T uptum that is observed in both a and c.As theoretically discussed by Aharony's group,³⁵ the magnetic susceptibility of $R_2 C u O_4$ (R = N d, Pr, or Sm) is governed by the magnetic states of rare-earth ions. The ground multiplet of Pr^{3+} ion is ${}^{3}H_{4}$ in the tetragonal crystalline electric eld (CEF), so that Pr^{3+} ions have a singlet ground state with a well separated (18 m eV) rst-excited state.³⁵ Therefore, the low -T susceptibility is predicted to be T -independent, 35 and the observed low -T uptum, which is well described by the Curie-W eiss law, must com e from som e free m om ents not considered in the m ean-eld theory. Note that the sensitivity of the low-T to the oxygen treatment, shown in Fig. 4, uptum in suggests that the free m om ents do not originate from im purity ions, but are produced by som emechanism inherent to PLCO.Candidates for such a mechanism include an appearance of Pr⁴⁺ ions in som e particular crystalenvironment or som e \free" C u^{2+} spins possibly produced in the AF dom ain boundaries.^{36,37} Incidentally, the analyses of the Schottky anom aly and the Curie-W eiss contribution are consistent with the same an isotropic g factor, which gives con dence that the two phenomena are of the same origin.

D . Phonon scattering by param agnetic m om ents

W hatever the origin of the free moments, they are clearly correlated with the H-dependence of for inplane elds. Although there has been no report in the cuprate context, it has been known that phonons can be scattered by free param agneticm om ents that form a twolevel system $,^{38}$ where the energy levels of the two states split in magnetic elds by E due to the Zeeman energy. In this situation, phonons are typically scattered in the following way: A phonon with energy E excites the low er-level state of a m agnetic m om ent to the higher-level state and is absorbed by a direct process; then, another phonon with the same energy (but with a dierent wave vector) is subsequently emitted by the higher-level state as it relaxes. Since the phonon spectrum has a (broad) maximum at $4k_B T$, this \paramagnetic scattering" of phonons is the strongest when the Zeem an energy E is equal to $4k_B T$. Naturally, this causes a dip at H_{dip} in the (H) isotherm with H_{dip} roughly proportional to T,³⁸ which is actually the case in our data below 2 K [see Fig. 2(f)]. Note that the free spins them selves do not carry heat because there is no dispersive collective excitations due to the negligibly sm all interactions between these diluted spins.

In passing, we note that the peculiar (H) behavior in NCO (Ref. 20) may also be understood in terms of the param agnetic scattering of phonons without em ploying the m agnon heat transport, at least for T > 1.5 K: It has been discussed that the doublet ground state of the N d³⁺ ions in NCO is split slightly (3K) in zero eld due to the interaction with Cu spins,³⁵ which causes the Nd³⁺ ions to form a two-level system; hence, the phonons may well be scattered by param agnetic N d³⁺ ions at T > 1.5K, since the Nd ions show Neel order only below 1.5 K,³⁵ and a su ciently large H can remove the param agnetic scatterings and enhance signi cantly.³⁸ Thus, although the magnons are likely to be carrying heat below 1.5 K²¹ their role at higher tem perature had better be scrutinized.

We should point out that we do not currently have a good understanding for the enhancement of with H k c shown in Fig. 2 (e), but it may be that for this eld direction some additional heat carriers are induced and add a major contribution on top of $_{\rm p}$ (H). One possibility is a remaining contribution of Prm agnons, although as much as 35% of the Pr³⁺ sites are diluted by nonm agnetic La³⁺ ions in PLCO. Remember that La-free PCO single crystals had been reported to exhibit a large enhancement of with H²⁵, which might share a common origin to the present behavior shown in Fig. 2 (e).

A lthough the interaction between phonons and the free spins has been known for a long time,³⁸ such phenom enon and its impact on the heat transport have never been revealed for cuprate materials. The present results demonstrate that the phonon heat transport can be H dependent at low temperature in high- T_c cuprates whenever excitations of free spins (that cause a Schot-

tky anomaly in the specic heat) are present. The effect of the param agnetic scattering is particularly pronounced in PLCO, probably because in this parent com pound the phononic heat transport is very clean and also the Schottky anom aly is large. In the superconducting doping regime of cuprates, while the Schottky anom aly is alm ost ubiquitously observed,^{9,10,11,12,13,14,15} its contribution is much smaller than that in PLCO and also the phonons are additionally scattered by doped carriers, both of which cause the contribution of the paramagnetic scattering to be reduced. Nevertheless, it is likely that some fraction of the H dependence of is due to the param agnetic scattering of phonons even in superconducting samples, and therefore an analysis of (H) should be done very carefully. Note that, while quantitative analyses of (H) would be dicult in light of the param agnetic scattering of phonons, qualitative com parisons of the (H) behavior for dierent dopings^{5,6} would still be legitim ate, because the Schottky anom aly is observed across the whole doping range without any clear doping dependence.

Lastly, the present result suggests, together with the curious magnetic shape-memory e ect in $La_2 \times Sr_x CuO_4$,³⁹ that the spin-phonon coupling is rather strong in cuprates. The signi cance of the spin-phonon coupling in doped cuprates, although still remains to be veried, is rather naturally expected based on the behavior of the parent com pound. Because of this coupling, AF uctuations and phonons may couple in an unusual way in these materials and this could be the reason why the mechanism of high-T_c superconductivity is so di cult to understand. In this regard, it is useful to note that possible roles of the spin-phonon coupling

in the peculiar electronic state of doped cuprates have been theoretically discussed. 40,41

IV. SUMMARY

We measure the magnetic-eld dependence of the thermal conductivity of a parent insulating cuprate $Pr_{1:3}La_{0:7}CuO_4$ to elucidate the possible eld dependence of phonon heat transport in cuprates. A striking dip feature is found in (H) isotherms for in-plane elds at low tem perature. The \dip" eld is found to increase linearly with T at low tem perature, which is indicative of the phonon scattering by free spins. Both the low -T speci c heat and the magnetic susceptibility are measured to give supplemental evidence for the existence of free spins. Since the Schottky-type speci c heat that signies the existence of free spins is found ubiquitously in high-T_c cuprates in a wide doping range, the present result suggests that the H -dependence of the phonon heat transport should not be naively neglected, particularly when one tries to extract the QP inform ation from the quantitative analyses of (H). In addition, the present result points to a strong spin-phonon coupling in high-T_c cuprates.
