# D istribution of the superconducting gap in an YN $i_2B_2C$ Im studied by point contact spectroscopy.

The di erential resistances  $R_d = dV = dI(V)$  of point contacts between a norm almetal and a c axis oriented YN  $i_2B_2C_m$  ( $T_c = 15.2 \text{ K}$ ) in the superconducting (SC) state have been investigated.  $R_d(V)$  contains clear "gap" features connected with processes of Andreev rejection at the boundary between norm almetal and superconductor that allow the determination of the SC gap and its temperature and magnetic eld dependence. A distribution of from  $m_{in} = 1.5 \text{ meV}$  to  $m_{ax} = 2.4 \text{ meV}$  is revealed; however the critical temperature  $T_c$  in all cases corresponded to that of the lm. The value 2  $m_{ax}/k_B T_c = 3.66$  is close to the BCS value of 3.52, and the temperature dependence

(T) is BCS-like, irrespective of the actual value. It is supposed that the distribution of can be attributed to a gap anisotropy or to a multiband nature of the SC state in YN  $i_2B_2C$ , rather than to the presence of nodes in the gap.

IN T R O D U C T IO N

During the last ten years, the class of nickel borocarbide com pounds RN i<sub>2</sub>B<sub>2</sub>C, where R = Sc, Y, Lu, Dy, Ho, Er, Tm and other rare-earth ions, has attracted considerable attention in the superconducting community [1]. This interest is caused by the unusual properties of these materials related to the rich interplay of superconductivity and magnetism, when R is a magnetic rare-earth ion. In this context, it is remarkable that the superconducting transition tem perature T<sub>c</sub> can be higher than the N celter perature  $T_N$  as for R = Tm and Er, but also com parable with  $T_N$  as for R = Ho and even lower than  $T_N$  as for R = D y. N on m agnetic com pounds with R = Sc, Y and Lu have the highest  $T_c$  values of 15K, 15.5K and 16.5K, respectively. They are type II superconductors and have three-dimensional, practically isotropic electronic structure, while their crystal structure com prises alternating RC and N2B2 layers. Noteworthy recent experiments including tunnelling [2] and point contact m easurem ents [3, 4] on bulk single crystals have shown that the unusual superconducting properties of nickel borocarbides exhibit strong an isotropy. In particular, a hybrid (s + g) wave superconducting state has been proposed [5, 6] for the compounds with R = Y and Lu, characterized by four point nodes of the superconducting order param eter in the [1,0,0] and [0, 1,0] directions. This conclusion was based on investigations of the angular dependence of


the therm al conductivity [7] and speci c heat [8] under an applied external magnetic eld of single crystals at low tem peratures. Point-contact m easurem ents [3] also revealed a strong gap anisotropy. In the [100] direction, not only the gap is 4.5 tim es sm aller, but also the transition tem perature was found to be half (!) that in the [001] direction. It is also important to note that a thorough analysis of upper critical eld H c2 (T) data for YN 12B2C and LuN i/B2C single crystals clearly showed that superconductivity in these compounds is strongly a ected by their multiband nature [9]. In order to gain further insight into the interplay of the sym metry of superconducting order parameters, their anisotropy and multiband nature, additional studies are necessary. In the present work, direct m easurem ents of the gap am plitude distribution have been perform ed on epitaxial c axis oriented YN i2B2C thin Im using point-contact spectroscopy [10].

### EXPERIM ENTAL TECHNIQUE

In this paper, we present the results of point contact m easurem entsm ade on a high quality  $Y N \frac{1}{2}B_2 C$  lm [11]. The lm was prepared by pulsed laser deposition on an M gO single crystal substrate. The SC transition tem perature  $T_c = 15.2 K$  (with transition width  $T_c = 0.3 K$ ) was determ ined from resistive m easurem ents. The residual resistance ratio R (300K)=R (T  $T_c$ ) of the lm was about 8. X-ray data indicate that the lm consists of sm all crystallites having their prim ary orientation with the c axis perpendicular to the substrate surface.

The measurement cell was placed in a ow cryostat, enabling measurement at a series of temperatures up to  $T_c$  and higher. Point contacts were created by touching




FIG. 1: (a) D i erential resistance R  $_{\rm d}$  (V) of point contact Y N i\_2B\_2C {Ag with norm al state resistance R  $_{\rm N}$  = 3.5, m easured at di erent tem peratures. (b) N orm alized R  $_{\rm d}$  (solid) curves for this contact and those values calculated by BTK theory (dashed). The theoretical curve at 4.2K is calculated with 1:67 m eV, Z 0:43 and 0:55 m eV. The tem - perature dependence (T) is shown in Fig. 3 (b). Curves are o set vertically from the lower curve for clarity.

sharpened Cu and Ag wires to the Im surface directly within the cryostat at liquid helium temperature. An unfortunate disadvantage of this 'needle{anvil' m ethod is the sensitivity of the contacts to m echanical vibrations and changes in temperature. As a result, only around one quarter of the prepared contacts w ith stood m easurem ent above liquid helium temperature

U sing a technique of synchronous detection of weak (10–30 V) modulating signal harmonics, the rst harmonic of the modulating signal V<sub>1</sub> [proportional to the di erential resistance R<sub>d</sub>(V) = dV=dI(V)] was recorded as a function of the bias voltage V.

## EXPERIM ENTAL RESULTS

A series of  $R_d$  (V) m easurem ents with clear doublem inimum features near V = 0 connected with the Andreev re ection of electrons at the superconductor { normal

m etal (S  $\{N\}$  interface are shown in Figs.1(a) and 2(a).

For voltages exceeding the gap value, all curves exhibit m axim a caused, m ost likely, by the suppression of superconductivity in (part of) the contact. Such behavior testi es to a deviation from the spectral (ballistic) regime (i.e., the inelastic electron m ean free path becomes less than or about the size of the contact) with increasing bias voltage at the contact (see [10], Chapter 3).

The size of the gap was calculated using the modied BTK theory (see [10], Chapter 3.7). The presence of maxim a in  $R_d$  (V) prevented the coincidence of the calculated and measured curves throughout the voltage range; therefore an adjustment was carried out so that both curves coincided in the region of the gap ( ,+ ) and at the higher voltages beyond the maxim a. Prelim inary, unadjusted curves were normalized to  $R_d$  (V; T >  $T_c$ ). During calculation, the parameters Z and were xed or varied in small limits up to 5{10%. The results are shown in Figs.1(b) and 2(b). We note also that the con-




FIG.3: (a) The temperature dependence of the gap (T) obtained from the BTK t for ve di erent contacts (open symbols). The theoretical BCS curve is drawn to coincide with the average value of the ve contacts (closed symbols). (b) The temperature dependence (T) norm alized to (T = 4.5 K) form inim al (open squares), m axim al (open circles) and average (closed circles) gap values, along with the theoretical BCS curve.

tacts shown in Figs.1 and 2 had, respectively, the minim aland m axim algap values among all the contacts that with stood low temperature measurement.

In Fig.3(a), the dependences (T) are shown for a number of di erent contacts, for each of which a series of R<sub>d</sub> (V) curves at di erent tem peratures was measured. For all these contacts, the SC minimum in R<sub>d</sub> (V) disappeared at a tem perature interval of 14{16K, corresponding to the T<sub>c</sub> value (152K) of the Im.

In Fig.3(b), the tem perature dependences for the m axim aland m inim al (T = 4.5 K) are show n, norm alized to these values (2.24 m eV and 1.67 m eV, respectively). A lso the norm alized (T) tem perature dependence obtained by averaging all ve contacts of Fig.3(a), and the theoretical BCS dependence are depicted. We reiterate that the com plete data (m easured, norm alized and calculated spectra) for the sm allest and largest gap are presented in Figs.1 and 2.

In total, 29 curves, on which the structure with two




FIG. 4: Distribution of values obtained from measurement of 29 contacts with di erent counter electrodes Ag (15 contacts, dark bars) and Cu (14 contacts, gray bars). The arrow species the value corresponding to the BCS ratio 2  $_{0}$  =k<sub>B</sub> T<sub>c</sub> = 3:52, with T<sub>c</sub> = 15:2K.




FIG.5: D istribution of contact resistances  $R_0 = R_d (V = 0, T = 42 \text{ K})$  for the same contacts as in Fig.4. Inset: gap values of these contacts. Solid circles designate those contacts for which a series of tem perature measurem ents were carried out, with results shown on Fig.3(a).

m inim a is clear enough to allow an unequivocal determ ination of using the standard procedure of adjustment of theoretical curves described above, have been selected from num erous measured spectra. From the results of the calculation, the histogram in Fig.4 was constructed. Irrespective of the counter electrode used, is distributed in an interval between 1.5 m eV and 2.4 m eV.

Half of the selected contacts had contact resistances between 2 and 3, as seen on the distribution of N (R) values in Fig.5. The inset shows the values obtained for contacts of di erent norm al state resistance. Solid circles designate those contacts for which a series of tem -




FIG. 6: (a) D i erential resistance R  $_{\rm d}$  (V) of the same point contact YN  ${\rm k}_2B_2C$  {Cum easured for di erent R  $_0$  = R  $_{\rm d}$  (V = 0, T = 42K) values as a result of consecutive contact short-circuits by a current pulse. (b), (c), (d) The variation in the values , and Z with R  $_0$ .

perature m easurements were carried out and superconductivity conmed to disappear between 15K and 16K, corresponding to the  $T_c$  value of the lm, independent of the value.

In Fig.6(a), R<sub>d</sub> (V) is shown for contacts produced by consecutive electric short-circuit of the sam e contact from  $R_{\rm N}~=~20~$  down to  $R_{\rm N}~=~4~$  . It is seen that as the contact resistance is reduced, hum ps start to appear to a greater degree, and the intensity of the local maximum at zero bias increases. The latter is possible to explain, proceeding from [12] where it is shown that in the diffusive regime R<sub>d</sub> (V) looks like the presence of a barrier with Z = 0.55 in the ballistic regime. In other words, for a clean  $S\{N \text{ boundary } w \text{ it hout a barrier } (Z = 0) in$ the di usive regime, it is possible to observe a maximum in R<sub>d</sub> (V) at zero bias, sim ilar to the ballistic case with Z = 0.55. In reality, from Fig.6(c) it is seen that the parameter Z grows with the reduction of contact resistance, com ing nearer to the value 0.55. It is necessary to note that the value for these contacts is practically independent of their resistance, rem aining around 2.2 0.1 m eV.O n the other hand, the param eter grows strongly with resistance, as observed experim entally for m any superconductors of di erent sorts (see Fig. 12.14 in [10]), although the reason for this remains under discussion.

## DISCUSSION

The presented point contact m easurem ents show a distribution of the SC gap in the electronic density of states of an YN  $i_2B_2C$  lm. Important and essential is the fact that irrespective of the size of the gap, ranging from 1.5m eV to 2.4m eV, the observed critical temperature corresponds to the  $T_c$  of the lm. This excludes the possibility of a distribution of the gap on the lm surface owing to its non-uniform structure. Another possible source of a gap variation is the proxim ity e ect resulting in gap suppression at the surface. How ever, we assume that in this case the gap value should correlate inversely with the point contact resistance, in other words with the size of the contact: the smaller the size, the lower the gap value measured. How ever, this is not the case. The gap value varies even for contacts with nearly equal resistance Fig.5 (inset)], and has a tendency, if any, to rise with increasing resistance [Fig.6 (b)].

Hence, it is natural to rst assume the presence of a gap anisotropy. Unfortunately, the use of a lm does not allow measurements to be made along di erent crystallographic directions. How ever, as m entioned previously, the lm is predom inantly caxis oriented, and consists of sm all crystallites. Thus it is reasonable to expect that with contacts prepared by touching a Im plane with a needle, we will mainly register a gap along the c axis. Yet, taking into account that the contribution to point contact conductivity result from some nite solid angle, the point contact axis is not well xed along the c axis and with the possible m isorientation of som e crystallites our data can be interpreted as the observation of the gap an isotropy with  $m_{ax}/m_{in}$ 1.6. W e also note that, as seen from Fig.4, the ratio 2  $m_{ax}=k_B T_c$  is close to the standard BCS value of 3.52.

As to the presence of a hybrid gap with s + g wave order parameter symmetry and point nodes in certain directions, we never observed gaps less than 1.5 m eV. The results of point contact measurements in [3], giv-0.45 m eV along the a axis, give rise to some ing questions. Firstly, the dependence (I) for the a directions looks at least atypical; secondly, the critical tem perature in this direction was found to be two times less than in the bulk; and thirdly, even for the maxim algap,  $2 m_{ax} = k_B T_c$ 2.86, much lower than the BCS value. This raises the doubt of whether to take into account that nickel borocarbides are more likely superconductors with strong coupling. We note that the single crystals investigated in [3] had a signi cantly lower T<sub>c</sub> 14.6K, in comparison with the value 15.5K usually quoted in the literature. Thus, an insu cient sample quality is apparently responsible for the reported "anisotropy" of the SC order parameter in [3].

Considering the role of disorder in anisotropic superconductors, nonmagnetic in purity scattering has profound e ects on hybrid s + g wave superconductors with point nodes. It is mentioned in [6] that a disorderinduced quasiparticle energy gap opens up even for innitesimal scattering rates. This may be a reason why we did not observe any nodal features in the SC gap. However, in purity scattering also decreases the critical tem perature, which is not observed in our investigations. Thus, according to [6], a disorder-induced energy gap of about 10 K  $1\,\mathrm{m}\,\mathrm{eV}$  corresponds to a  $T_{\rm c}$  reduction to 13 K .

Concerning the e ect of the pressure produced by point-contact form ation on the gap distribution, we expect that under such a pressure the critical tem perature should also vary in the same way as the gap. However, no such variation is observed, suggesting that there is no m easurable e ect due to pressure in this experiment.

Let's consider the question of the realization of multiband superconductivity in RN i2B2C (R = Y, Lu), considered in [9]. We cannot distinguish whether the observed gap distribution is a consequence of an isotropy or a multiband electronic structure. In this connection, we note that the authors of Ref. [4], investigating point contact spectra of a LuN  $i_2B_2C$  single crystal, found that the calculated theoretical curves better describe the experim entaldata when a two-gap adjustm ent is used, although in the R<sub>d</sub> (V) curves, only one gap m in im um is visible. In so doing, the relation between the maxim aland minim al gap was found to be around 1.75 in the c direction and 1.5 in the ab plane. This is close to the value found by us, <sub>max</sub>= <sub>min</sub> 1.6. To this it is possible to add that our prelim inary data after analysis of about 60  $R_{d}$  (V) spectra measured on a cleaved  $YN_2B_2C$  single crystal also show a gap distribution. In this case for 80% of the contacts the gap is distributed in the same range from  $1.5\,\mathrm{m\,eV}$  to  $2.4\,\mathrm{m\,eV}$  , while for 20% of the contacts the gap ranged m ore from 2.5 m eV to 3.0 m eV, and one can discern maxima in the entire gap distribution at 2.0 m eV and 2.4 m eV. Interestingly, to t the experim ental dV=dI curve for the c direction in LuN i2B2C in Ref. [4] (Fig.13), the authors used a gap distribution with two peaks also around 2.0 m eV and 2.5 m eV .




FIG. 7: (a) Calculated magnetic eld dependences of (closed circles) at Z = 0.58 for an (closed squares) and  $Y\,N\,i_2B_{\,2}C$  (Cu point contact (R  $_0$  = 2.8 , T = 4.2K). Open squares show the magnetic eld behavior of for another contact with sm all gap value. The dotted curve shows the behavior /  $(1 B = B_{c2})^{1=2}$  of the pair potential of a type II superconductor in the vortex state according to A brikosov's theory. D ashed lines connect circles and open squares as guides to the eye. In set: reduced experimental R<sub>d</sub> (V) in zero eld and in magnetic elds of 1T and 5T. (b) Behavior of the excess current in a magnetic eld. The inset shows sym metrized experimental and theoretical  $R_d^{-1}$  (V) in zero eld. The excess current was determ ined as the integral of the calculated  $R_d^{-1}$  (V) after subtraction of the norm all state conductivity (horizontal dashed line). Error bars were determ ined as the integral of the di erence between theoretical and experim en $tal R_d^{-1}$  (V) curves. The greatest di erence arises due to the presence of m in in a in the experimental  $R_d^{-1}$  (V) curves at biases exceeding the gap energy.

A prominent feature of a multiband superconductor is also the specic behavior of the excess current in the point contacts. In [13] it was revealed that in the twoband superconductor  $M gB_2$ , the excess current has a strongly pronounced positive curvature in a magnetic eld. In Fig.7, the behavior of the SC gap and the excess current in a magnetic eld for one of the YN  $i_2B_2C$ contacts is shown. It can be seen that, while the behavior of the gap is sim ilar to that of the pair potential of a type II superconductor in the vortex state and has negative curvature [Fig.7(a), closed squares and dotted curve], the excess current has a strong positive curvature [Fig.7(b)]. A similar behavior of the gap and the excess current in a magnetic eld was observed by us for several of the investigated contacts (R  $_{\rm d}$  (V ) have been processed for four contacts). A nother consideration is that a sm all gap has an alm ost linear decrease under a magnetic eld [Fig.7(a), open squares]. This is sim ilar to the theoreticalbehavior of the sm all gap in  $M gB_2$  calculated in [14]. Thus, our observation of the excess current and sm all gap

behavior under a magnetic eld may be taken in support of a multiband SC state in YN  $i_2B_2C$ .

## CONCLUSION

Studies of the SC gap and its temperature dependence (T) in  $YNi_2B_2C$  have shown a distribution of values from min 1.5 meV up to max 2.4 meV,

however in all cases with a BCS-like (T) dependence. The observed 2  $m_{ax}=k_B T_c$ 3.66 is also close to the BCS value of 3.52, and the critical tem perature in all cases corresponded to that of the lm, thus excluding the possibility that the observations result from heterogeneity in the properties of the lm. It is most probable that the distribution of the gap can be attributed to gap anisotropy, or to the multiband nature of the SC state in  $Y N i_2 B_2 C$ . The positive curvature in the behavior of the excess current under applied magnetic eld (Fig.7(b)) tends to support the multiband scenario. Proceeding from the stated results, and also prelim inary investigations of  $Y N i_2 B_2 C$  single crystals, the presence of point nodes in the SC order parameter of YN  $i_2B_2C$  is considered to be unlikely. The analogous conclusion is reached also in a recent work [15] on the basis of the observation of a sudden disappearance of de Haas {van Alphen oscillations at the transition to the m ixed state. Finally, in a recent preprint [16], the authors of Ref.[3] have m odi ed their earlier claim s and com e to the conclusion from the analysis of the eld variation of their dV=dI spectra that the unconventional gap function observed in  $Y N i_2 B_2 C$ could originate from multiband superconductivity.
