R econstruction of the phase of matter-wave elds using a momentum resolved cross-correlation technique

W e investigate the potential of the so-called X FROG cross-correlation technique originally developed for ultrashort laser pulses for the recovery of the amplitude and phase of the condensate wave function of a Bose-E instein condensate. Key features of the X FROG method are its high resolution, versatility and stability against noise and some sources of system atic errors. A fier showing how an analogue of X FROG can be realized for Bose-E instein condensates, we illustrate its e ectiveness in determ ining the amplitude and phase of the wave function of a vortex state. The impact of a reduction of the number of measurem ents and of typical sources of noise on the eld reconstruction are also analyzed.

M any of the remarkable properties of atom ic Bose-E instein condensates (BECs) originate from the fact that in those systems a single wave-function is occupied by a m acroscopic number of particles [1, 2, 3, 4, 5]. The am – plitude of this complex wave function corresponds to the atom ic density and can comparatively easily be measured using for example absorption or phase contrast in aging [6, 7, 8, 9, 10]. The phase of the wave function, on the other hand, is relatively hard to measure directly. Still, its measurement is essential for the characterization of m any quantum degenerate atom ic systems, such as e.g. rotating BECs with vortices [11].

A situation in m any ways sim ilar is encountered in the context of ultrashort laser pulses of a few optical cycles duration. The characterization of these pulses, which are of considerable interest in both fundam ental science and applications, requires likew ise the know ledge of both am plitude and phase.

The m easurem ent of the tim e-dependent phase of ultrashort laser pulses has found a solution that is in m any respects optim al in the so-called Frequency-R esolved O ptical G ating (FROG) m ethods [12, 13, 14, 15]. These m ethods, which can be adapted to m any di erent situations, o er very high resolution and precision, are stable against noise, and can even com pensate for or detect som e sources of system atic errors. Single-shot m easurem ents are straightforw ard [16], and m easurem ents of

elds with less than one photon per pulse on average have also been successfully demonstrated. A lm ost every aspect of the FROG -m ethods has been studied in depth. G ood starting points for accessing the wealth of research literature on that subject are the review article [17] and Ref. [18].

The similarity of the phase retrieval problem s for ultrashort pulses and atom ic condensates naturally leads one to ask whether the optical FROG techniques can be extended to the atom -optical dom ain. This paper answers this question in the a mative by demonstrating how a speci c version of the general FROG method, called cross-correlation FROG (XFROG), can easily be translated to the atom -optical case [19, 20, 21]. Section I brie y reviews the fundam entals of X FROG phase retrieval and discusses how it can be adapted to cold-atom scenarios. As an illustration, section II shows the reconstruction of the spatial phase of a rotating BEC with a vortex. We also investigate the sensitivity of the reconstruction to several sources of noise characteristic of cold atom s, as well as the im pact of a reduction in the num ber of measurem ents on the eld retrieval.

I. PRINCIPLES OF THE XFROG METHOD




FIG. 1: (Color online) Basic experimental setup for the XFROG method. G is a diraction grating and the spectrum of the signal eld is recorded with the CCD array.

The basic experimental setup for the eld reconstruction of an ultrashort laser pulse by means of the XFROG method is shown in Fig. 1. For simplicity we assume that only one direction of polarization of the electrical

eld needs to be considered. The unknown eld (t) is mixed with a known reference eld $_{ref}$ (t) in a nonlinear crystal with $^{(2)}$ nonlinearity after a variable delay . The elds $_{ref}$ and should be of roughly comparable duration which means in practice that the pulse durations can di er by up to about an order of magnitude. The sum frequency signal is

The form of that eld shows that the reference pulse acts as a gate for the pulse, hence the acronym XFROG. The signal significant spectrally analyzed. The resulting spectrum,

is the key quantity. It contains enough information to reconstruct amplitude and phase of the pulse (t).

To see how this works [33], we rst note that it is sufcient to nd sig (t;) since (t) can then be obtained by simply integrating over | up to a multiplicative constant that can be determined from the normalization

of . Thus the problem is cast in the form of a twodimensional phase retrieval problem. Problems of this type have been studied for decades in the context of in age restoration, see e.g. [22, 23].

The eld $_{sig}$ can be found from $I_{X FROG}$ by m eans of the m ethod of generalized projections [23, 24, 25]. From Eqs. (1) and (2) it is clear that $_{sig}$ m ust simultaneously belong to the two sets [34]




FIG.2: (Color online) Illustration of the constraint sets 0 and F (a) in the case where 0 and F are convex and their intersection contains exactly one element and (b) in the non-convex case with more than one element in the intersection. Fig. (a) also shows a typical trajectory of the generalized projections algorithm.

Figure 2a suggests that one can nd the solution to this problem, called a feasibility problem in mathem atics and especially in optimization theory, by iteratively projecting onto the two constraint sets 0 and F. For closed convex sets with exactly one point of intersection, this method always leads to a unique solution. In our case, though, the constraint sets are not convex and their intersection consists of more than one function, as illustrated in Fig. 2b. Hence, the algorithm of generalized projections is not guaranteed to converge for every initial guess and even if it does the solution is not unique. Still, in practice it converges for a vast m a prity of initial guesses and the ambiguity in the solution is physically reasonable. (In particular, XFROG determ ines the eld

 $_{\rm sig}$ up to a constant phase.) On those rare occasions when the algorithm does not converge for a particular initial guess, this non-convergence is revealed by a large distance of the xed point from the constraint sets in a sense that willbe m ade precise below . Then one can sim – ply restart the reconstruction algorithm with a di erent initial guess.

Speci cally, sig is found from $I_{X FROG}$ as follows:

which is closer to the set 0 than $\frac{(n)}{sig}$ (t;).

5.Use the Fourier transform

as a new input in step 2, and iterate until the error Z in Eq. (8) becomes su ciently small.

Upon exit from the algorithm, $^{(n)}$ is the retrieved eld. It turns out that in step 4 a simple line m inimization along the gradient of Z with respect to $^{(n)}$ is su cient. A good starting point for that m inimization is the m inimizer $^{(n-1)}$ of the previous step.

An important characteristic of the XFROG method is its robustness, which results from two main reasons: First, the XFROG signal contains a high degree of redundancy: If $I_{X FROG}$ is measured on a grid of size N Ν the 2N unknowns of the eld (t) { its real and im aginary parts { are retrieved from N 2 m easured values. The XFROG algorithm makes use of this high degree of redundancy to yield a highly stable pulse retrieval. Second, the functional form of sig is very restrictive in the sense that a random ly generated sig will not correspond to any physical pulse . Thus, if the XFROG signal has been deteriorated by system atic errors the XFROG algorithm will not converge for any initial guess and one can conclude that the data is corrupted. A nother advantage of XFROG is the extrem ely high tem poral resolution that is achieved by making use of the Fourier domain information. Instead of being determined by the length of the reference pulse, it is essentially given by the response time of the non-linear medium.

W e now turn to the central point of this paper, which is to adapt the XFROG m ethod to the characterization of matter-wave elds. We consider speci cally the case of atom ic bosons, with two internal states denoted by " and #. The atom s are assumed to be initially in a pure Bose-Einstein condensate (BEC) at temperature T = 0, with all atom s in internal state #. The corresponding atom ic eld operator is

where (r) is the condensate wave function and $C_{\#}$ is the bosonic annihilation operator for an atom in the condensate.

The states " and # are coupled by a spatially dependent interaction of the generic form

that is switched on at time t = 0. This could be provided for example by a two-photon R am an transition, with V then being proportional to the product of the mode functions of the two lasers driving the transition.

For short enough times the "-component of the atom ic eld is then

W hen measured as a function of the shift R between coupling and condensate, the momentum distribution of the "-atom s is therefore an XFROG signal, with the role of the reference eld being played by the space dependent coupling strength. Hence, the XFROG algorithm can be used to fully recover the eld , n (q;R) being measured using for example absorption imaging after free expansion.

In some sense, the situation for atom s is simpler than for ultrashort laser pulses. This is because a gate function of size com parable to the condensate size, such as e.g. the coupling strength V (r), is readily available. W hile in the case of photons the only possible gate is another ultrashort laser pulse, and hence one must use nonlinear mixing to obtain a signal suitable for XFROG, for atom sone can use processes that are linear in the atom ic eld. Furtherm ore, since the interactions between cold atom stend to be stronger and o er a richer variety than is the case for light, a wide choice of processes can be employed to generate signals that can be used for FROG algorithm s. Speci c examples include s-wave interactions, the atom optics analog of optical cubic nonlinearities, as well as the recently dem onstrated coherent coupling of atom s to m olecules, which corresponds to optical quadratic nonlinearities [26, 27, 28, 29, 30, 31].

A fully three-dimensionalXFROG scheme as suggested by Eq. (16) is hard to realize in practice. First, it requires a very large number of measurements. Ten dierent shifts in each direction correspond to a total of 1000 nuns of the experiment. The large amount of data necessary for the fully three-dimensional scheme also poses serious challenges to the numerical reconstruction algorithm as far as computermemory and time are concerned. Second, in time-of-ight absorption imaging one typically measures the column-integrated density so that the three-dimensionalmomentum distribution is not directly accessible. It appears therefore preferable to limit the reconstruction to have a two-dimensional scheme.

It can be easily veri ed that if the eld and the coupling strength can be factorized as

where z is the direction along which the imaging is done, Eq. (16) remains valid if we interpret r and R as twodimensional vectors in the plane perpendicular to z and q as a corresponding two-dimensional momentum. M any

elds of practical interest can at least approximately be written in the form Eq. (17). For example, the twophoton Raman coupling mentioned earlier is of that type provided that the lasers are directed along z and the Rayleigh length is much longer than the extend of the atom ic cloud in that direction. As a concrete example we demonstrate in the next section how the matter wave

eld of a rotating BEC with a single vortex [11] can be directly reconstructed using the XFROG m ethod.

II. RECONSTRUCTION OF A VORTEX-FIELD

W e consider a BEC at tem perature T = 0 in a sphericaltrap.W e assume that the Thom as Ferm isopproxim ation holds and that the healing length = $(8 \text{ an}_0)^{1=2}$, with a the s-wave scattering length and n_0 the atom ic density at the center of the trap, is much smaller than the Thom as-Ferm i Radius R = $(15N_a a=a_{osc})^{1=5}a_{osc}$ of the cloud. Here, N_a is the number of atom s in the condensate and a_{osc} is the oscillator length of the atom s in the trap. Under these assumptions the structure of the vortex core is essentially the same as that of a vortex in a uniform BEC and its wave function can to a good approximation be written as [32]

where we have used cylindrical coordinates with the vortex core at the sym metry axis. As discussed above, the z-dependence of the wave-function is unimportant and we will not regard it any further. In the following we use =R = 0.1, but none of our results depend strongly on this ratio as long as =R 1. The real part of the wave-function (18) is shown in Fig. 4a.

As an interaction H am iltonian, or 'reference' eld' in the language of XFROG, we use Eq. (12) with the G aussian

the z-dependence being again irrelevant for our purposes.

W e have simulated an XFROG signal on a grid of 64 64 points using of Eq. (18) and the reference eld (19), and applied the XFROG algorithm to reconstruct the eld. In order the determ ine the optim alwidth of V we have repeated this procedure for various values of w. For each run we have determ ined the ²-error per degree of freedom [35]




FIG.3: ² error of the reconstructed vortex eld after 100 iterations as a function of the width w of V .

after 100 iterations. Here, N is the num ber of grid points in one direction. The results of these simulations are sum marized in Fig. 3. They show that the XFROG algorithm works rather well for a wide range of widths provided that they are comparable to the size of the condensate. As a rule of thum b, for our data 2 errors sm aller than 10² mean that the algorithm has qualitatively recovered the original eld. The com paratively poor quality of the retrieved elds for larger widths is mainly due to unphysical correlations across the boundaries arising from the periodic boundary conditions that we are using. These e ects can in principle be avoided by using a larger grid. The best results were obtained for widths 0.3R and in all that follows we use w = 0.35R. ofw Larger widths tend to render the algorithm more stable, in the sense that it will converge to the correct solution for more initial quesses, while narrower reference elds result in faster convergence, but for fewer initial quesses.

Several stages of the reconstruction algorithm are shown in gures 4(b)-(d). (The eld reconstruction in this example takes about 30 m inutes on a Pentium 4 CPU and uses approximately 400 MB of memory.) We show only the real part of the eld, as the im aginary part shows a similar degree of agreement. The XFROG error Z of Eq. (8) for the same simulation run is shown in Fig. 5 as a function of the number of iterations. A lso shown is the deviation from the reconstructed eld from the original eld². The gure shows that the algorithm converges exponentially after som e initial stagnation. It also shows that, after the ambiguity in the total phase has been taken into account, the XFROG error Z is a good measure of the actual discrepancy between reconstructed and original eld. This is in portant for real-life applications since in practice one does not know the original eld so that ² cannot be calculated and only the XFROG error is accessible.

Time of ight absorption imaging is a comparatively easy way to obtain many data points in the Fourier domain, but it is cumbersome to obtain the data sets for di errent shifts R because each such set requires a new run of the experiment. Thus a natural question is the sensitivity of the algorithm to the number of displacements for which a measurement is performed.

To answer this question we have calculated XFROG signals I_{XFROG} on grids of dimension n n, interpolated them onto a larger grid of dimension N N using cubic splines, and applied the XFROG algorithm to the resulting XFROG signals. Fig. 6 shows an example for n = 10. The recovered eld shows good agreement with the original eld, with di erences in some details, e.g. near the maxima, resulting from the smoothing property of the interpolation with splines.

To quantitatively characterize the dependence of the success of the eld recovery on the number of measurements we have evaluated 2 of the recovered eld after 100 iterations as a function of n. The result is shown




FIG.4: (C olor online) R econstruction of a vortex state on a grid of 64 64 points. Figure (a) shows the real part of the original state and gures (b)-(d) show the initial guess and the reconstructed state after 50 and 100 iterations, respectively.

in Fig. 7. W hile the discrepancy between the recovered

eld and the original eld grows as expected as the number of m easurem ents decreases, the eld is qualitatively retrieved down to n = 7. For even smaller n the eld reconstruction fails. In those cases the algorithm is honest enough to adm it its failure by generating a large residual XFROG error. Nonetheless, the conclusion is that a rather lim ited number of m easurem ents is su cient to accurately m easure the eld.

We remark that these considerations are actually overly pessim istic. In reality one often knows the size of the atom ic cloud and the XFROG signal is clearly zero if there is no overlap between coupling V and atom ic eld

. Thus, m any data points in the XFROG signal can be padded with zeros. Even those zeros contain usable inform ation for the XFROG algorithm because they encode a support constraint for the recovered eld. Support constraints, together with Fourier dom ain inform ation, are widely used in image reconstruction for astronom ic im agery and under certain circum stances they characterize an im age com pletely. Furtherm ore, am ong the rem aining non-zero m easurem ents som e will give excessively sm all signals. In practice one can replace these m easurem ents by other displacem ents that give a stronger signal.

In an actual experiment the measurement of an XFROG signal will be subject to several sources of noise. In that case the intersection of the sets 0 and F in Fig. 2 will in general be empty, and the XFROG algorithm determines a eld that has the correct XFROG signal, i.e. belongs to the set F, and at the same time minimizes the distance to the set 0 as measured by Z.

The XFROG signal Eq. (8) is insensitive to uctuations in the total phase of the atom ic eld from one run of the experim ent to the other, i.e. for di erent R | a consequence of the non-interferom etric character of FROG m ethods in general. Hence it is su cient to study the im pact of uncertainties in the m easurem ent of the displacem ents R them selves and in the total intensity of the XFROG signal from shot to shot. The latter can arise from variations of the number of atom s in the original




FIG.5: FROG error Z and eld error 2 for the simulation run of Fig. 4.




FIG.6: (Color online) Reconstruction of the eld of Fig. 4 with the XFROG signal simulated on a grid of 10 10 and interpolated on a grid of 64 64 after 100 iterations.




FIG.7: ² error of the recovered eld after 100 iterations as a function of the number of measured data points n (same parameters as in gures 4 and 5).




FIG. 8: (Color online) Same as Fig. 6 but with simulated noise R=R=0:1 and I=I=0:1 in the XFROG signal.

condensate, from uctuations in the coupling strength, and from uctuations in the interaction times. We have simulated XFROG signals with Gaussian uctuations in R and in shot-to-shot total intensity I with variances R and I, respectively. Note that with our choice of normalization for and V the total intensity of the XFROG signals is of order one so that we can treat absolute errors and relative errors in I as being the same.




FIG.9: (Coloronline) 2 error of the recovered eld after 100 iterations as a function of several noise sources.

We have applied the XFROG algorithm to these contam inated signals and we have measured ² after 100 iterations. To be more realistic, we have simulated the XFROG signals only on a grid of 10 10 and interpolated onto a grid of 64 64 as above. We have simulated the situation with errors in R only, errors in I only, and errors in both R and I. The results are sum marized in Fig. 9. We were able to qualitatively reconstruct the atom ic eld up to relative errors as large as R=R 0:3 and

I=I = 1. The algorithm was found to be signi cantly less sensitive to uncertainties in the total intensity than to uncertainties in the displacements. Even XFROG signals with I=I = 1 yield recovered elds of very high quality. The relatively high residual errors for I=I = 0.4and I=I = 0.8 come about because the XFROG algorithm did not nd the global minimum of Z for the particular initial guess. Restarting the algorithm with a di errent initial guess (but with the exact same contam inated XFROG signal) lead to residual errors that nicely interpolate the the other data points.

Figure 8 shows the retrieved eld after 100 iterations for R = R = 0.11 and I = I = 0.11. The broad features of the original eld are clearly reproduced and the noisy

ne structure is exclusively due to the uctuations in R and could be smoothed out by convolution with a Gaussian of width comparable to the healing length. Thus, although the error in the retrieved eld increases with increasing noise, we conclude that the algorithm is not very sensitive to noise and yields at least reliable qualitative information. In a sense, the eld as recovered by the XFROG m ethod contains much less noise than the

input data. This is rem iniscent of the situation encountered in image reconstruction e.g. in astronom ical applications. And it was exactly for the purpose of rem oving noise from images by using a mixture of position space and Fourier space information that many of the methods described in this paper were rst discussed.

In sum m ary we have shown how the powerfulX FROG m ethod of ultrafast optics can be adapted to phase m easurem ent applications in ultra-cold atom ic system s. In particular, this technique is capable of correctly recovering a vortex state and it is robust against noise, with a num ber of actual m easurem ents that can be reduced to experim entally feasible values.

An interesting question for the future is how the XFROG method can be used to study situations were there is no well de ned phase of the atom ic eld for fundamental reasons. For example the XFROG technique could be a valuable tool for diagnosing the transition of an elongated BEC (with long range phase coherence) to a quasi one-dimensional Tonks-G irardeau gas (without phase coherence), or the transition of a rapidly rotating BEC into the quantum Hall regime. The XFROG method could also be of interest in the study of the so-called BCS-BEC crossover where a super uid of Cooper pairs goes over into a BEC of tightly bound molecules.
