First-Principles Simulations of Inelastic Electron Tunneling Spectroscopy of Molecular Junctions

Abstract

A generalized G reen's function theory is developed to simulate the inelastic electron tunneling spectroscopy (ETS) of m olecular junctions. It has been applied to a realistic m olecular junction with an octaned it higher embedded between two gold contacts in combination with the hybrid density functional theory calculations. The calculated spectra are in excellent agreement with recent experimental results. Strong temperature dependence of the experimental ETS spectra is also reproduced. It is shown that the ETS is extremely sensitive to the intra-m olecular conformation and to the molecule-metal contact geometry.

Inelastic electron tunneling spectroscopy (ETS) has been recently applied to the molecular junctions [1, 2, 3]. The measured spectra show well-resolved vibronic structures corresponding to certain vibrational norm alm odes of the molecule. It helps to understand the vibronic coupling between the charge carriers and nuclear motion of molecule. The ETS has also been found to be sensitive to the experimental setups, for instance, distinct difference has been revealed between the spectra of alkanethiolm olecular junctions measured by Kushmerick et al. [1] and W ang et al.[2]. It is therefore expected that the ETS can be used as a tool to identify the geom etrical structures of the molecule-metal interface, an in portant factor in the design and characterization of molecular devices. The basic theory of ETS has been known form any years[4]. Its extension to the molecular wires [5, 6], atom ic m etal w ires [7] and m olecular junctions [5, 8, 9], however, has just appeared in the literature very recently, partly motived by the success of the experiments. The theoretical modellings are generally based on the G reen's function theory at di erent levels, and have contributed to many fundamental understandings of the inelastic electron tunneling processes inside a m olecular/atom ic junction. However, none of the theoretical studies has been able to make realistic comparisons with the experim ental spectra.

In this letter we present a new computational scheme based on our early developed quantum chemical approach for electron transport in molecular junction [10]. The vibronic coupling is introduced by expanding the electronic wavefunction along di erent vibrational norm almodes. We have applied this new method to the gold-octaned ithiolate-gold junction. The electronic structures and vibrationalmodes are calculated using the hybrid density functional theory (DFT). The simulated spectra are in excellent agreement with the experimental ones. Our computational scheme can be easily applied to other systems. Theoretical simulations are extremely useful for assigning the experimental spectra and to reveal many detailed informations that are not accessible in the experiments.

O ur approach is also based on the G reen's function form alism. We divide the molecular device into three parts, source, drain and extended molecule, as shown in Figure 1. The source and drain are described by an electrive mass approximation (EMA), while the extended molecule is treated with the hybrid density functional theory. The extended molecule is in equilibrium with the source and drain through the line up of their electrice Ferm i level. This approach is proved to lead to very good descriptions for the experimental results[10]. The current density for the three-dimensional electrodes along the molecular axis z is given

as[10]

where n^{S} and n^{D} are the density of states (DOS) of the source and drain, respectively. E_f is the Ferm ienergy, and T is the device working tem perature. V_D is the external voltage. The transition matrix element from the source to the drain, T (V_D;Q)T (V_D;Q), is dependent on the vibronalmotion, Q, and can be written as[10]

where J and K run over all atom ic sites of the molecule, which are denoted as 1,2,...,N, site 1 and N are two end sites of molecule that connect with two electron reservoirs. V_{JS} (V_{DK}) represents the coupling between atom ic site J (K) and reservoirs S (D).Orbitalj i is the eigenstate of the Ham iltonian (H_f) of a nite system that consists of the molecule sandwiched between two clusters of metal atom s: H_f j i = " j i. The product of two overlap matrix elements hJ j ih jK i represents the delocalization of orbitalj i. Here parameter z is a complex variable, $z = E + i J^K$, where E is the energy related to the external bias and Ferm i level, at which the scattering process is observed. JK is the escape rate which is determined by the Ferm iG olden rule

A ll the key parameters are obtained from the calculations of the nite metal-molecule cluster. The use of the nite system allows us easily including the vibronic coupling since the description of vibronic coupling in a molecular system has long been established. The nuclear motion dependent wavefunction can be expanded along the vibrational norm alm ode using a Taylor expansion. The ETS experiment is offen done at electronic order established. The region. The adiabatic harm onic approximation can thus be applied, therefore, only the rest derivative like $\frac{0}{0}$ needs to be considered, where Q_a is the vibrational norm alm ode a of the extended molecule. The working form ula we have used for ETS calculations follows the same principle as the one given by Troisi, Ratner, and Nitzan [5].




FIG.1: Structures of the gold-octaned it hiol-gold junctions with triangle (A) and chain (B) local contacts.

We have calculated an octaned ithiolate, $SC_8H_{16}S$, embedded between two gold electrodes through S-Au bonds. The extended molecule consists of two gold trimers bonded with an

octaned ithiolate molecule. The gold trimers were tested in two basic conformations - a triangle and a linear chain, see Figure 1. For the triangle conguration, the sulfur atom is placed above the the middle of the triangle, resembling the hollow site of a Au (111) surface. Geometry optimization and electronic structure calculations have been carried out for the extended molecules of di erent congurations at hybrid DFT B3LYP level [11] using G aussian03 program package with the LanL2D Z basis set [12]. In the case of the triangle conguration, two di erent schemes have been used for the geometry optimization. The rst geometry is obtained by optimizing octaned ithiol in gas phase and then replace the term inal hydrogens with the gold contacts without further optimization (Tr1). The second geometry is obtained by optimizing the rst geometry with the same xed gold and sulfur distance (Tr2), which is also the approach for the chain conguration (Ch1). The S-Au distance in all calculations is xed to 2.853A. The QCME program [13] has been employed for all the ETS calculations.




FIG.2: Inelastic electron tunneling spectrum of the octaned it highlight from (A) experiment [2], (B) calculation for the Tr1 conguration and (C) calculation for the Tr2 conguration. The I-V curves are given in the inserts of (A) and (B). The working temperature is 4.2 K.

The calculated ETS of the octaned ithiolate junction with the triangle gold trimers are shown in Figure 2, together with the experimental spectrum of W ang et al. at temperature 4.2 K [2]. One can clearly see that the calculated result for Tr1 conguration is in excellent agreement with the experiment. The calculations do not only reproduce all the major spectral features observed in the experiment, but also provide very detailed features that are smeared out by the background due to the encasing $Si_{\rm B}N_4$ marked with stars [2]. Both theory and experiment shows that the intensity of the vibronic feature follows the order: (C-C) (131m V) > (CH₂) (155m V) > (CH₂) (185m V). It should also be mentioned that

theory and experiment agrees well for the current-voltage characteristics (I-V) which are determined mainly by the elastic scattering, see the inserts of the Figure 2 (A) and (B).

The ETS calculated with the Tr2 con guration, Figure 2 (C), shows also very rich structures. However, its spectral procless are quite dimension through the Tr1 con guration, as well as the experiment of W ang et al[2]. For instance, the spectral peak at 155 mV ((CH_2) mode) has the largest intensity, instead of the mode of (C-C) at 131 mV. The Tr1 and the Tr2 con gurations have the same Au-S bondings, but slightly dimension intra-molecular conformations. The sensitivity of the ETS with respect to the molecular geometry is really high. It can thus be concluded that the molecular geometry and contact con guration of the device in the experiment of W ang et al[2] is very close to our Tr1 con guration.




FIG. 3: Tem perature dependent ETS of the octaned it his late junction from (A) experiment[2], and (B) calculation for the Tr1 con guration. The intensity is in arbitrary unit.

The calculated temperature dependence of the ETS of the Trl conguration is shown in Fig.3 together with the experimental results of W ang et al[2]. The agreement between the theory and the experiment is more than satisfactory. The evolution of the spectral bands upon the increase of the temperature is the same for both the experiment and the calculation. As an example, in both cases, the peak formode (CH_2) at 185 mV disappears at 35K, and the peak formode (CH_2) at 155 mV becomes invisible at 50K. Our simulations indicate that the observed temperature dependence is mainly due to the changes of the Ferm i distribution.

In Table I, the assignments of the vibronic bands observed in theoretical and experimental spectra are shown. It can be seen that the vibrational frequencies given by the B 3LY P calculations are in very good agreement with the experiments. Our computational scheme also allows to calculate the spectral linewidth directly, which is determined by the orbital characters and molecule-metal bonding, see Eq. 3. The calculated full width at half maximum (FW HM) for the spectral probe of mode (C-C) at 132 m V is found to be around 4.3 m eV, in good agreement with the experimental result of 3.73 0.98 m eV [2]. However, it is also noticed that such a band is attributed from several modes of the same character with vibration frequencies 1012, 1038, 1061, 1069, 1084, 1090, 1097, and 1100 cm⁻¹, respectively, covering a range of 11.0 m eV. The overlapping between diment vibration modes makes it is possible to determine the actual intrinsic lindwidth of the spectral proble from a single vibration mode.




FIG. 4: Inelastic electron tunneling spectroscopy from (A) experiment for C11 m onothiol [1] and (B) calculation for the Ch1 conguration. The working temperature is 42 K.

We have calculated the ETS of the gold chain con guration (Ch1), shown in Figure 4(B), to exam ine the dependence of the ETS on the molecule-metal bonding structure. Indeed, the ETS of Ch1 shows a distinct di erence in spectral intensity distribution from those of the Tr1 and the Tr2 con gurations. The spectral peak of mode (CH₂) at 382 mV has become e the absolute dom inate feature in the spectrum. Furthermore, the intensities of di erent spectral features follow the order of (C-C) (132 mV) < (CH₂) (172 mV) < (CH₂) (382 mV), com pletely di erent from the results of the Tr1 and the Tr2 con gurations. The Au-S bonding structure of the Ch1 con guration di ers from that of the Tr1 and the Tr2, resulting a noticeable di erence in their spectral pro les for the mode (Au-S) around 40 mV. The changes in molecular conformations seems to be the major cause for the large di erence in the spectral intensity distributions of two devices. It is found that the molecule in the Ch1 con guration is twisted around the otherwise linearly oriented molecular back-bone in

the Trl con guration. It is interesting to note that the spectrum of the Chl con guration resembles the experimental IETS of an alkanem onothiol molecule, $HS(CH_2)_8H$ (Cll)[1], quite well, as clearly demonstrated in Figure 4. The molecule-metal bonding structure of the Cll is very dienent from that of octane dithiol. Such a dierence should be rejected by the spectral projectral intensity distribution [1, 2] related to the molecular vibration modes implies that the molecular conformations in two experimental setups is very dierent. The molecular back-bone of the octane dithiolate junction in the device of W ang et al.[2] should be linear, while it is slightly twisted for the Cll in the device of K ushmerick et al[1].

In conclusion, we have proposed a new computational scheme that is capable of describing the ETS of molecular junctions with unprecedented accuracy. Our rst-principles calculations provide reliable assignments for the experimental spectra and reveal important details that are not accessible in the experiment. We have also demonstrated that the ETS is a powerful characterization tool for molecular devices.
