Som e form al properties on superstatistics and superposition of statistical factors

#### Abstract

By focusing on the interchangeable role in a generating function (ie., $\$ \mathrm{E}$ in the Laplace transform), the superstatistics proposed by Beck and Cohen can be viewed as a counterpart of the canonical partition function. Som e form al properties of this superstatistics are presented in connection w th them odynam ic structures and inform ation aspects. For any com bination of the localequilibrium statistical factor and the form of uctuating eld, which are ingredients ofm aking a generic superstatistics, a variance of the uctuating quantity appears in the correction term. This fact enables us to relate param eters contained in the statistical factor with the variance in any situation.

## I. INTRODUCTION

Superposition ofstatisticalfactors can be considered as a new attem pt to try to form ulate a statisticalm echanical description for unusual system such as ones having a uctuating tem perature eld. Since, in the traditional equilibrium statistical $m$ echanics, we suppose that system $s$ are put in constant $w$ ith a heat reservoir (in canonicalensem ble), situations that arise inhom ogeneity in intensive variables over spaces considered $m$ ay be outside the schem e of conventional treatm ents [11 , "2,

In this paper, we will be particularly concemed with presenting som e detailed structure of the notion of the superposition of statistical factors and its relation to the
uctuation. The purpose of this paper is to understand what aspects of a system the superposition of the statistical factors delineates. To this end we especially take up of a $m$ ixture of the Boltzm ann factors, which is recently proposed by Beck and C ohen [3] quantity superstatistics. A ll considerations through this paper is a situation where local inverse tem peratures , which is usually assum ed to be a constant in the ordinary canonicalensem ble theory, are not hom ogeneous in space but di er by positions.
$T$ he superstatistics denoted by sym bolB ( $E$ ) allow s the in nite types of system 's distribution in energy $E$, once the uctuating distribution $f()$ is given. Three crucial prem ises taken by Beck and Cohen are (a) a system is partitioned into cells that can be considered to be reached an equilibrium locally, which is characterized by a single intensive variable (b) its statistical factor is $G$ ibbsian (c) the separation betw een tw o tim e scales is adequate, that is, the tim e for relaxing to the each local equilibrium state is $m u c h$ faster than that for varying the distribution of . Under these assum ptions B ( $\mathbb{E}$ ) is calculated by integrating $f() e^{E} w$ ith respect to from zero to

[^0]in nity. Then the usualB oltzm ann factor for the system is obtained only when the system has hom ogeneous tem perature $=\mathrm{h}$ i i.e., $\mathrm{f}(\mathrm{r})=(\mathrm{h} i)$. In this view, the linear average of the Boltzm ann factors over can contain inform ation that characterizes the $m$ acroscopic behavior.

From a form al point of view, Beck and Cohen exempli ed that the correction to the equilibrium factor $e^{h}$ ie universally follows $\left(1+{ }^{2} E^{2}=2\right)$, as long as $E$ is sm all, where is the standard deviation of $f()$. E specially when $f\left(\right.$ ) represents the ${ }^{2}$ distribution the associated superstatistics produces the T sallis type pow er-law distribution $\left[\left[_{1}^{\prime}, 1,4\right]\right.$, 1 , and by com paring $w$ ith the correction term $\left(1+\left(q^{-1} 1\right) h^{2} E^{2}=2\right)$ for the ${ }^{2}$ distribution, the param eter $q$ contained in the statistical factor $\left[\frac{1}{2}\right]$ can be form ally related as $q=1+(=h i)^{2}$. Then the case $q=1$ corresponds to no uctuation in ,i.e., constant tem perature over the system. O nce the B ( $E$ ) is given, the form $s$ of entropy and the associated energy constraints can be determ ined $\left[\frac{6}{[6}\right]$ and the $m$ axim um -entropy principle can be a good tool for estim ating a statistical properties [1]'1].

A s of today, we have taxonom y for the applications of superstatistics (inexhaustive list) : the log-norm altype in turbulence $\overline{6}, \overline{1}, \overline{1}, \overline{1}$,$] and the { }^{2}$ type in solar ares $[10]$, cos m ic rays[1] $]$ and $w$ ind velocities in aiport [12 1$]$. A violent gravitationalprocess can be another possible class of superstatistics, where the G aussian distributions in velocity
 O ther recent_applications of the superstatistics are brie y review ed in [15].

At the present status, how ever, there seem s no guiding principle (dynam icalmechanism) to choose any speci c com bination of the form $s$ for the local distribution and the uctuation distributions. W e m ust only refer to the $m$ echanism as a certain com plex dynam ics and can not answer how com plex it is. In this sense, the present status on its necessity for introducing $B(E) m$ ay still be contentious $\left.[16,1]]_{1}\right]$. This am biguity is also related to the fact that some phenom enological data can be tted for reasonable regions w ith a generalized exponential functions having $m$ ore than tw o param eters [18], and this fact, how ever, does not im ply that the system can be uniquely
described by the underlying generalized statistical mechanics based on the param eterized entropy which should be m axim ized.
$T$ hese facts are ourm ain reason for avoiding going into discussion of a speci c physical system in this paper, instead we shall explore som e form al connections to the them odynam ic relation and to inform ation structure. The plan of this paper is as follows. In Sec.II, we investigate six properties possessed by $B$ ( $E$ ), which have not been presented so far. The subsections $A$ and $C$ are concemed w ith the connection to them odynam ic structures. From a view point of inform ation, we provide a universal relation by considering one dim ensional system in subsections D. In subsections B, E and F we give results which are direct consequences from the de nition but are w orth presenting in future developm ents. Sec.III devotes to a discussion for the notion of supenposition of statistical factors and to a sum $m$ ary.

> II. SOME FORMALPROPERTIESOFB(E)
> A. Existence of average in

Let us assum e that the system considered is situated in an environm ent where few partitioned region has large tem perature and the num ber of regions in the system grow steadily as their tem peratures go dow. $n$. $T$ he $m$ ost probable distribution for the regions would be the increasing function of . From the de nition, the superstatistics has the follow ing properties:
(i) $B(E)!1$ when $E!0$.
(ii) $B(E)$ is a $C^{1}$-class function $w$ ith respect to $E$ for any $\mathrm{E}>0$, i.e.,

W e shall nd that bierepresents the average inverse tem perature in section IIIE1.

## B. B ehavior w ith low tem perature cut-o

Next, we are concemed w th a behavior of the superstatistics at higher tem perature. If $\mathrm{f}(\mathrm{)}$ has an asym $\mathrm{p}-$ totic approxim ation,

This states that when $f($ ) consists of som e di erent power laws in , the corresponding superstatistics is expressed by the superposition of the pow er law s in energy w th di erent exponents.

## C. Representation by speci cheat

In this section we delineate the superstatistics in the light of a them odynam ic quantity i.e., the speci c heat of the system. As was supposed in section IIA, we assum e that $f($ ) represents the density of states of inverse tem peratures in a system around , which m onotonically increases w ith . Then the probability to nd a system w ithin the interval and +d can be expressed as

Since the speci c heat can be usually considered as behaving $O(\mathbb{N}), N$ being the num ber ofparticles in the system, the term which contains $\mathrm{C}_{\mathrm{v}}$ contributing as O ( ln N ) in $\ln B(E)$ becom es negligible in com parison $w$ ith others for large $N$. In that case $E+\ln f()$ is $m$ ainly responsible for the them odynam ic property of the system. H ow ever we m ust take into account $C_{v}$ for system $s w$ ith smalln.

> D. B (E) as an in form ation and its correction by uctuation

To illustrate $m$ ore inform ation aspects on the superstatistics by uctuation $f()$, let us take a look at another point. The uctuation distribution can be calculated by an inverse Laplace transform w ith keeping $E$ constant:

We instead focus on the evaluation for the interm ediate energy region. In order to delineate further structure which is universally possessed by B (E) , we consider one dim ensional system whose segm ent at position $n$ is assum ed to be in a local equilibrium prescribed by a Boltzm ann factor $e{ }^{n E}$. In order to see the $e$ ect of the uctuation of tem perature on the bit num ber of whole system, we can borrow an approach that was taken by [251] for the canonical entropy of very large black holes obeying the B eckenstein $H$ aw king area law [2G]. In this approach, it was show $n$ to have the universallogarithm ic correction to the $m$ icrocanonicalblack hole entropy. The superstatistics for the present system $m$ ay be expressed as

where ( $f \mathrm{~g}$ ) is a quantity which is uniquely determ ined in a system once a distribution of ${ }^{1}$ 's is given. Let us consider a bound which is satis ed by B ( $E$ ) from a perturbation theory about the distribution of the inverse tem peratures over the system. W e express the di erence in ( $f \mathrm{~g}$ ) betw een a certain realization of ${ }^{1}$ distribution over a system and its coarse-grained one as ( $f$ g) (i.e., $\quad(f \mathrm{~g})=(\mathrm{f} \mathrm{g}) \mathrm{c}(\mathrm{f} \mathrm{g})$ ). By the coarse-grained inverse tem perature eld we m ean that the system has a single hom ogeneous one over the system and it appears to be reached at an equilibrium states if we look at whole system from far away. If we look closer at the system we should see the uctuating eld. This illustration also relates to the number of division of the whole system considered. The role of $i$ 's in the exponential function is just the same as the spin variables $f_{s} g$ in the Ising H am iltonian system, where the partition function and the system 's energy are quantities for discussing the theory instead ofB ( $E$ ) and respectively. Therefore we can write

It is worth noting that when is simply equivalent to the equality holds and B ( $\mathbb{E}$ ) provides the Boltzm ann factor, which corresponds to the environm ent w ith no uctuation in .

## III. D ISCUSSION AND SUM M ARY

In this paper, we have investigated som e them odynam ical structures and in form ation aspects of the superposition of statistical factors which is achieved by the assum ption of the Gibbsian local equilibrium distribution and the existence of the spacial uctuation of the inverse tem perature over the system . W e spotlighted som e structural side of the superstatistics rather than the concrete application of it to the physical system .

To em phasize the notioeable sim ilarity in the structure to the canonical partition function, we can take a standpoint of the generating function $[1]$ ] w hich is constructed by a product of a statistical factor and a structure function ! ( $\mathrm{X}_{\mathrm{R}_{1}}$ (density of states). The generating function $G()=1_{1}!($ )e $d$ can be related to the variance of its variables as

From this observation, we arrived at a view that the canonical partition function and superstatistics have a universal relation to the degree of dispersion of environm ental variables irrespective of the form of density of states (for $E$ and ),

indicating that they are two di erent aspects of the single generating function (Table.I). In order to extract underlying structure of notion of supenposition of statistical factors, we here study $m$ ore generic circum stance for a statistical factor $g(; E)$, which is assum ed to be 0 cally realized. W ew rite $g($;E) $=g(h i ; E)(h i ; ~ ; E)$, where $(h i ; ~ ; E)=g^{1}(h i ; E) g(; E)$. Therefore the superstatistics of the general statistical factor $g$ becom es

This allow s us to conclude that it is possible to relate param eters contained in the distribution ! ( ) to the tem perature dispersion 2 for any statistical factors. Beck and $C$ ohen show ed that when $!()$ is the gam $m$ a distribution and $g=e^{E}$ an index $q$ appearing in the $T$ sallis factor can be expressed as $q=h{ }^{2} i=h i^{2}\left[\underline{\beta}_{1}^{\prime}\right]$. H ow ever, as we dem onstrated above, this feature applies universally for the other com bination of supenposition of statistical factors [3] ${ }^{1}$ ] ] once we assum e the local equilibrium states for each partitioned region. W e give tw o exam ples when the local equilibrium does not obey the G ibbsian form. In the cases of a $T$ sallis type pow er-low and a stretched exponential type local equilibrium, we respectively have

(444') when
$\mathrm{q}=1$ and $=1$ because the statistical factors recover the G ibbsian.
A Athough the superstatistics constructed in the sense of [13] plays a role of a new distribution incorporated by system 's global inform ation on uctuating inverse tem perature, it is not nom alizable w ith respect to energy E. T he situation is true for a partition function $Z()$ in the usual statisticalm echanics, which gives ${ }_{0}^{1} \mathrm{Z}(\mathrm{)d}$ \& 1. We m ay construct a con jugate distribution function Eq. (2 $\mathbf{2}_{1}^{1}$ ), allow ing us to write the eld $f()=B(E) e^{E} p_{s}$ for the purpose ofexplaining ( tting) observed distribution functions. A quantity $\ln B^{1}(E)=E$ can capture states of the system and can be nite even when E ! 1 [ [ $[34]$ due to concavity of $\ln B^{1}(\mathbb{E})$. In this paper, we did not consider the dynam ical $m$ echanism to keep the uctuation $\mathrm{f}(\mathrm{)}$ as a speci c form. Instead, wewould like to $m$ ention what we can say m ore about a relation betw een variance
and a them odynam ic force (a nity) when we regard $F(t) \quad \ln B(E)=E$ as a fundam ental quantity to see the approaching process to uniform tem perature over the system :

where $B_{t}(\mathbb{E})$ is a superstatistics calculated from f() at tim etand $B_{0}(E)$ denotes one that from uniform tem perature. $\mathrm{B}_{0}(E)$ is equivalent to the factor $\mathrm{e}^{\mathrm{h}} \mathrm{iE}$. Then, in consideration of the universal correction term derived for all types of $f()$, up to the second order in energy,
$F(t)$ is found to be $p(t)=\quad \ln 1+\frac{1}{2}^{2}(t) E^{2}=E$, or equivalently $\quad(t)=P^{P}\left(e^{E} F(t) \quad 1\right)=E$, expressing that the system has a single tem perature in the course of the therm odynam ics foroe vanishes.

In summ ary, we have explored som e form al properties of the superposition of statistical factors proposed by Beck and Cohen. To understand what the notion of superstatistics represents, we have attem pted to see links to inform ation and therm odynam ic relation. N onequilibrium states or relaxation processes to uniform tem perature eld over the system would be interesting for the fiuture research.
