Conform alField Theory Approach to the Two-ChannelAnderson Model

A bstract

The two-channel Anderson in purity model serves as a prototype for describing heavy-ferm ion materials with a possible mixed-valent regime with both quadrupolar and magnetic character. We report on the low-energy physics of the model, using a conformal eld theory approach with exact Bethe Ansatz results as input.

As is well-known, several uranium -based heavy ferm ion m aterials exhibit m an ifest non-Ferm i liquid behavior at low temperatures. A particularly intriguing case is that of the UBe₁₃ compound. It has been suggested that the electric quadrupolar degrees of freedom of the uranium ions (in $5f^2$ con gurations) in the Be₁₃ host are overscreened by the local orbitalm otion of the conduction electrons, producing a two-channelK ondo response of this m aterial [1]. Taking into account the possibility that the magnetic $5f^3$ con gurationsm ay also be at play, one is led to consider the two-channel Anderson in purity m odel [1]

where H₀ is the free part of the H am iltonian. The conduction electrons ^y carry spin (=";#) and quadrupolar (=) quantum numbers, and hybridize with a local uranium ion via a matrix element V. The ion is modeled by a quadrupolar [magnetic] doublet of energy $_{\rm q}$ [$_{\rm s}$], created by a boson [ferm ion] operator b^y [f^y]. Strong C oulom b repulsion im plies single occupancy of the localized levels: f^yf + b^yb = 1.

We have carried out a nonperturbative analysis of the model, exploiting boundary conformal eld theory [2] to trade the hybridization interaction in (1) for a scale invariant boundary condition on the conduction electrons. Identifying the proper boundary condition im mediately identi esthe critical theory to which the model belongs. By a numerical t to the exact Bethe Ansatz solution [3] of (1) we can determ ine all parameters and scales of this theory, thus obtaining a complete descrip-

tion of the low -energy dynam ics of the m odel. O ur m ost important results can be sum m arized:

The model renorm alizes to a line of xed point Ham iltonians param eterized by the average charge hf^yf i at the impurity site (Fig. 1), all n_c exhibiting the same zero-tem perature impurity entropy $S_{imp} = k_B \ln^2 2$, typical of two-channel Kondo physics [4]. The low-tem perature speci c heat induced by the impurity takes the form $_{s}T \ln (T_{s}=T) + _{q}T \ln (T_{q}=T) + O(T),$ C_{imp} = where $s_{[q]}$ and $T_{s_{[q]}}$ are amplitudes and temperature scales respectively, m easuring the participation of the spin [quadrupolar] degrees of freedom in the screening process. Sim ilarly, the impurity response to a magnetic [quadrupolar] eld is also of two-channelK ondo type, $s_{im p}^{s [q]}$ $s [q] \ln (T_s [q] = T),$ with the amplitudes s [q] decreasing exponentially with [].We have also calculated the Ferm iedge singularities caused by tim e-dependent hybridization between conduction electrons and impurity. These are coded by the scaling dimensions of the pseudo-particles b^y and f^y in (1), and we nd that $x_b = (3 + 2n_c^2) = 16$ and $x_f = (5 - 4n_c + 2n_c^2) = 16$ respectively. We point out that the values of the pseudo-particle scaling dimensions as obtained by various approximation schemes, e.g. NCA and large-N calculations [5], deviate from our exact result.

The conformal eld theory formalism allows us to determ ine also the asymptotic dynam ical properties of the model, incl. G reen's functions and resistivities. We have calculated the self-energy of the electrons and nd that it leads to a zero-temperature resistivity independent of the level separation : $(T = 0) = 3n = 4 \ (e \ V_F)^2$, with n_i the (dilute) impurity concentration, the density of states at the Ferm i level, and v_F the Ferm i velocity. The nite-temperature calculation is in progress.
