## D irect Observation of Quadrupolar Excitons in the H eavy-Ferm ion Superconductor P rO $s_4Sb_{12}$

We report inelastic neutron scattering experiments performed to investigate the low energy magnetic excitations on single crystals of the heavy-fermion superconductor P rO  $s_4 Sb_{12}$ . The observed excitation clearly softens at a wave vector Q = (1,0,0), which is the same as the modulation vector of the eld-induced antiferro-quadrupolar ordering, and its intensity at Q = (1,0,0) is smaller than that around the zone center. This result directly evidences that this excitonic behavior is derived mainly from nonmagnetic quadrupolar interactions. Furthermore, the narrowing of the linewidths of the excitations below the superconducting transition temperature indicates the close connection between the superconductivity and the excitons.

The relation between magnetism and superconductivity in heavy-fermion (HF) systems is one of the most interesting research areas in condensed matter physics. Magnetic uctuations due to strong C oulomb repulsion and hybridization between f electrons and conduction electrons are believed to be the origin of both the HF behavior and the superconductivity. In general, how ever, f electrons in systems with high crystal symmetry also have nonmagnetic orbital degrees of freedom and they can interact with conduction electrons through the orbital channels. Therefore, the nonmagnetic orbital uctuations might also lead to the HF superconductivity.

The led skutterudite compounds  $RT_4X_{12}$  (R: rare earth or actinide, T: transition m etal, X: pnictogen) crystallize in the body-centered cubic space group Im 3, in which R ion is surrounded by a cage of 12 X ions. These com pounds show a wide variety of therm al, m agnetic and transport properties due to strong c f m ixing e ects and a 'rattling' motion of R ion resulting from the unique crystal structure. Am ong them, PrOs4Sb12 is the rst Pr-based HF superconductor with the superconducting transition temperature  $T_c = 1.85$  K [1, 2]. The large 350 m J/m olK<sup>2</sup> of the specic Sommerfeld coe cient heat and the large jump at  $T_c$  (C = T<sub>c</sub> 500 m J/m olK<sup>2</sup>) suggest that heavy quasiparticles participate in the superconducting transition. Speci c heat, m agnetization and therm al conductivity show double superconducting phase transitions [1, 3, 4]. No coherence peak in  $1=T_1$  has been found at T<sub>c</sub> in the NQR experiment [5]. Furtherm ore, SR m easurem ent reveals that the superconducting state breaks the tim e reversal sym m etry [6]. The existence of a eld-induced antiferro-quadrupolar (AFQ) ordered phase above 5 T near the superconducting phase naturally suggests that the nonm agnetic quadrupolar de-

grees of freedom play an important role in this unusual superconductivity [7, 8]. In PrO  $s_4$ Sb<sub>12</sub>, 4f electrons are well-localized under the cubic crystal eld (CF) with  $T_{\rm h}$  symmetry. This is evidenced by dHvA experiment which shows the closeness of the Ferm i surface between PrO s<sub>4</sub>Sb<sub>12</sub> and LaO s<sub>4</sub>Sb<sub>12</sub> [9] and by inelastic neutron scattering (INS) experiments which show the clear CF excitations [1, 10, 11]. Compared to other HF superconductors, the well-localized nature of 4f electrons is characteristic to thism aterial. The CF levelschem e is wellestablished by elastic [8] and INS experiments [10, 11] and is composed of the  $_1$  singlet ground state, the  $_4^{(2)}$  triplet rst excited states above the CF gap = 0.7 m eV and other excited states located at much larger energy above (2) excitations should be 10 meV. The low-lying 1 responsible for the large value. Furtherm ore, the study on  $Pr(Ru_{1 x} O s_{x})_{4}Sb_{12}$  series show s that a tiny variation of leads to a large variation of [12].

In this Letter, we report on high resolution IN S experim ents on single crystals of P rO  $s_4Sb_{12}$ , focusing attention on the low-lying singlet-triplet excitations. We found a clear softening of the excitation at the zone boundary Q = (1,0,0) and a peculiar Q-dependence of the excitation intensity. This result gives the direct evidence for the excitons derived from nonm agnetic quadrupolar interactions between 4f electrons. Furtherm ore, the tem perature dependence of the excitations suggests that the new 'quadrupolar' excitons are coupled to the HF superconductivity.

Single crystals of PrOs<sub>4</sub>Sb<sub>12</sub> were grown by Sb-selfux method. In order to gain counting statistics in the INS experiments, we used two single crystals. The total mass is about 6.8 g. One of them is the same as




FIG. 1: (Color online) Energy spectra of excitations in PrOs $_4\,\rm Sb_{12}$  with di erent Q vectors along the [1,0,0] direction at 0.07 K (open circle) and at 3.9 K (closed circle). Lines are the two Lorentzian t.

used for the previous IN S experim ents [10]. Their superconducting transitions at T<sub>c</sub> 1:8 K were con rm ed by specic heat measurements performed on small pieces of each crystals. Neutron scattering experiments were carried out using the cold neutron three-axis spectrom eters IN 12 and IN 14 located at the Institut Laue-Langevin, G renoble. D at a presented in this Letter were exclusively taken on IN14 and are consistent with IN12 preliminary data. The incident beam was provided by a vertically focused pyrolytic graphite (PG) monochrom ator. A liquid-nitrogen cooled Be Iter placed after the PG m onochrom ator was em ployed to cut down higher-order contam ination of neutrons. A horizontally focusing PG was used as analyzer. Energy scans at constant Q along the [1,0,0] direction were performed with the xed nal neutron energy 3.0 m eV and with collim ation open-60'open-open. The energy resolution determ ined by the incoherent signal is 0.10 m eV full width at half m axim um (FW HM). The assembly of two single crystals has a totalmosaicness of 1:3, corresponding approximately to the mosaicness of each individual crystal. The assem bly was mounted in a <sup>3</sup>He-<sup>4</sup>He dilution refrigerator and a standard <sup>4</sup>H e cryostat with (hk0) as horizontal scattering plane. The latter was used especially for measuring excitations in the vicinity of T<sub>c</sub>. A background was determ ined by using the neutron energy gain data and was subtracted. The intensity of neutron scattering along the [1,0,0] direction  $I_{obs}(Q;!)$  is proportional to the dynam ic structure factor  $S(Q;!) = S_{zz}(Q;!) + S_{yy}(Q;!)$ as  $I_{obs}(Q;!) / A(Q)f^2(Q)S(Q;!)$ , where A(Q) is the absorption coe cient and f (Q) the magnetic form factor of  $Pr^{3+}$  ion. A (Q) was determined by measuring the Qdependence of the incoherent scattering intensity under the same geometrical condition for the scattering angle and the sample rotation angle as energy scans in Fig.1. By using this experim entally determ ined absorption coe cient, we got S(Q;!).

Figure 1 shows the dynam ic structure factor S(Q;!)of  $PrOs_4Sb_{12}$  with di erent Q vectors along the [1, 0, 0] direction at the lowest tem perature 0.07 K and at 3.9 K. The peaks around 0.4 0.8 m eV correspond to the (2) CF transition. In both superconducting and 1 norm al states, the clear softening of the low -lying excitations at the zone boundary Q = (1, 0, 0) with m in imum energies of 0.43 m eV and 0.55 m eV respectively has been observed. Note that the wave vector (1, 0, 0) is the same as that of the eld-induced AFQ ordering, suggesting the in portance of the quadrupolar degrees of freedom even in zero magnetic eld, which is more directly evidenced by the Q-dependence of the excitation intensity as discussed later. In the superconducting state, the spectra show sharp peaks with linewidths of 0.2 meV, indicating the localized character of 4f electrons. In the norm al state, on the other hand, the peaks signi cantly broaden and their positions shift to higher energies. In Fig. 1, a faint peak seem s to be around 1 m eV. How ever, it has not

been observed in the IN 14 experim ent using the  ${}^{4}\text{H}\,\text{e}\,\text{cryo-stat}$ . Therefore, we consider that the slightly enhanced intensity at about 1 m eV appears to be an artifact of the experim ental set-up. The observed S (Q ;!) was tted to two Lorentzian line shapes, corresponding to the tail of incoherent signal and the peak around 0.4 0.8 m eV .For all the spectra, the tting param eters of the incoherent tail are xed as those determ ined at the lowest tem perature.

Figure 2 (a) is the dispersion curves obtained from the tting in Fig.1. The energy of the excitations m onotonically softens from the zone center to the zone boundary in both the norm aland superconducting states, while the energy decreases uniform ly for all Q vectors with decreasing tem perature. This behavior seems to be accounted for as magnetic excitons, which have been extensively studied in rare earth metals and compounds for over three decades [13], but the interactions that modulate the CF levels to create so-called excitons are not necessarily magnetic exchange. Indeed, the agreem ent between the wave vector of the softening and the modulation vector of the eld-induced AFQ ordering [8] most naturally indicate that the interaction between quadrupolar momentsQ<sub>i</sub> remains the principal interaction. How ever, we must also take into account the interaction between magnetic m om ents M i, because the bulk m agnetic susceptibility indicates nite antiferrom agnetic correlations [3]. Therefore, the experim ental determ ination of the nature of the main interaction is a fundam ental issue to clarify the mechanism of the superconductivity in PrO  $s_4Sb_{12}$ .

The monotonic decrease of the exciton energy from the zone center to the zone boundary suggests that the nearest-neighbor interaction is dominant in  $PrOs_4Sb_{12}$ .




FIG. 2: (Color online) (a) D ispersion relations for the peaks around 0.4 0.8 m eV and (b) Q -dependence of the integrated intensity along the [1, 0, 0] direction at 0.07 K (open circle) and 3.9 K (closed circle) obtained from S(Q;!) in Fig.1. In Fig.2 (b), the intensity is norm alized by that at Q = (2.2,0,0) for T = 0.07 K. D ashed lines are quides for the eyes

W e, therefore, assume the following e ective Ham iltonian of interactions,  $H = D_M$  i,  $M_i + D_Q$  i,  $Q_i Q_j$ [14], where  $D_M$  and  $D_Q$  denote the coupling constants of magnetic and quadrupolar interactions, respectively. The Fourier transforms of the coupling constants in boc lattice are  $D_i(q) = 8D_i$   $j = x, y, z \cos(q_j a=2)$  (i = M; Q). If magnetic and quadrupolar interactions coexist in the singlet-triplet system, the exciton dispersion relation within the random phase approximation is written as [15]

where and are the o -diagonal matrix elements of magnetic and quadrupolarm on entsbetween  $_1$  and  $_4^{(2)}$ , respectively [16]. When  $D_Q = 0$ , Eq. (1) becomes the usual form of magnetic excitons [13]. The observed dispersion curves follow the antiferro-case of Eq. (1), i.e.  $D_M$ ;  $D_Q > 0$ . As pointed out by Shiina et al., the magnetic and nonmagnetic interactions give the same energy dispersion but they give opposite Q -dependence of the intensity. Therefore, the intensity analysis is a de nitive test that can distinguish the nature of the interaction. The theoretical integrated intensity I(q) = S(q; !) d! is given by [15]

W hen the antiferro-quadrupolar uctuations give rise to the dispersion of excitations, Eq. (2) predicts that I(q) at




FIG. 3: Energy spectra of excitations in PrOs $_4\,\rm{Sb}_{12}$  at Q = (1,0,0) for di erent temperatures. Lines are the two Lorentzian t.

the zone boundary, where the nonm agnetic quadrupolar uctuations are stronger, is smaller than I(q) at the zone center. The opposite behavior comes from the fact that I(q) is proportional to the magnetic correlation function. This conclusion is universal and also does not depend on the details of system.

In Fig. 2 (b), we plot the Q-dependence of the integrated intensity determined by subtracting the incoherent signal from S(Q;!) in Fig. 1 and summing the remaining counts. The observed Q-dependence of the intensity is quite di erent from that of the usual magnetic excitons. The intensity at the zone boundary is smaller than that around the zone center in both norm al and superconducting states. The experimental results agree with Eq. (2) for  $j \ ^2_J D_Q \qquad j \ ^2_J D_M$ . This result directly evidences that the observed excitonic behavior is derived mainly from nonmagnetic quadrupolar interactions. W ithin our know ledge, PrO s<sub>4</sub>Sb<sub>12</sub> is the rst example of the excitons due to quadrupolar interactions.




FIG.4: Tem perature dependence of (a) the energy and (b) the linew idths of the peaks at Q = (1,0,0). D ashed line denotes the theoretical curve of the excitons (see text).

We also observed the strong temperature dependence of excitation spectra at Q = (1,0,0) as shown in Fig. 3. By the same thing procedure as in Fig. 1, we plot the temperature dependence of the energy and the linew idths (FW HM) of the peaks around 0.4 0.8 m eV in Fig. 4 (a) and (b), respectively. A ssum ing that the interactions are only quadrupolar, the temperature dependence of the exciton energy is given by multiplying the term of D<sub>Q</sub> (q) of Eq. (1) by a temperature renorm alization factor  $\frac{1 \exp(-\pm k_B T)}{1+3 \exp(-\pm k_B T)}$ , in the same way as usual magnetic excitons [13]. The theoretical curve for = 0:7 0:1 m eV and <sup>2</sup>D<sub>Q</sub> = 0:029 0:01 m eV approximately reproduces the observed peak shift as shown by the dashed line in Fig. 4 (a). It is obscure whether the energy of the peaks decreases gradually or decreases with a distinct anom aly

at T<sub>c</sub> as decreasing temperature. This ambiguity may com e from the fact that the superconducting energy gap is comparable with the CF gap =  $0.7 \text{ meV} \cdot 0 \text{ n}$  the other hand, the linew idths of the peaks exhibit a discontinuous decrease just below  $T_c$  as shown in Fig. 4 (b), suggesting the close connection between the quadrupolar excitons and the superconductivity. This result agrees with the general observation that for rare earth ions dissolved in superconducting materials, the CF linewidth reacts to the Cooper pairing [17, 18]. Exciton based superconductivity theory also predicts that the life time of excitons gets longer below T<sub>c</sub> [19]. The novelty of  $P rO s_4 Sb_{12}$  is the exotic feedback between and due to the proxim ity of multipolar instability. The open underlying questions are if the coherence among the excitons is associated with the entrance in a multipolar state of tiny order parameter and if there is any link of our neutron results with double structure of the speci c heat at  $T_c$ .

The usual BCS superconductor PrRu<sub>4</sub>Sb<sub>12</sub> with norm ale ective m ass [12, 20, 21] also has the singlet-triplet CF level scheme but the CF gap between  $_1$  and 5.26 m eV, which has been determ ined by our recent INS experiments on a polycrystal sam ple [22], is much larger of  $PrOs_4Sb_{12}$ . This fact clearly indicates that than the smallness of , namely the existence of some degrees of freedom in low energy region, is the necessary condition for the mass enhancement. This is consistent with a mechanism of the mass enhancement through the c f m agnetic exchange in the singlet ground state system [23]. In addition, when 4f electrons have magnetic degrees of freedom in such low energy region, the local magnetic uctuations may be expected at low temperatures. In such a case, the resulting m agnetic quasi-elastic scattering is usually detected in INS experiments as in Ce-based HF com pounds. In PrO s<sub>4</sub>Sb<sub>12</sub>, how ever, quasielastic scattering has not been detected at least above 0.2 m eV as shown in Figs. 1 and 3. This result suggests other nonmagnetic mechanism rather than that due to

m agnetic uctuations. On the other hand, the signi cant broadening of spectral shape in the norm al state clearly suggests the importance of the c f interaction. Com – bining these facts, the mass enhancement as well as the superconductivity in PrOs<sub>4</sub>Sb<sub>12</sub> may originate from the strong c f interaction through the quadrupolar channels.

In sum mary, new 'quadrupolar' excitons, which are CF excitations modulated by quadrupolar interactions, are realized in PrOs<sub>4</sub>Sb<sub>12</sub>. A clear softening of this excitation occur at Q = (1,0,0). On cooling, all the exciton branch softens. Moreover the tendency of the narrowing of linew idths below  $T_c$  suggests that the quadrupolar excitons are related to the HF superconductivity and vice versa.
