Current D issipation in Thin Superconducting W ires: A ccurate N um erical Evaluation U sing the String M ethod

Abstract

Current dissipation in thin superconducting wires is num erically evaluated by using the string m ethod, within the fram ework of tim e-dependent G inzburg-Landau equation with a Langevin noise term. The most probable transition pathway between two neighboring current-carrying m etastable states, continuously linking the Langer-Am begaokar saddle-point state to a state in which the order parameter vanishes som ewhere, is found num erically. W e also give a num erically accurate algorithm to evaluate the prefactors for the rate of current-reducing transitions.

The picture of resistive (current-reducing) phase slips was not discussed by Little [1]. Langer and Am begaokar then used a G inzburg-Landau free-energy functional to analytically obtain the lowest free-energy saddle point between two current-carrying metastable states [2]. The time scale of the resistive phase slips have been formulated by M cC um – ber and Halperin [3]. The theory developed in Refs. [2] and [3] is generally referred to as the Langer-Am begaokar-M cC um ber-Halperin (LAM H) theory. Recently, new technique has been developed for fabricating superconducting nanow ires. Since resistive transition region broadens with decreasing cross-sectional area of the wire, nanow ires therefore becom e ideal sam ples for a more precise test of the LAM H theory [4]. For this purpose, a quantitative evaluation of the therm al-activation rate of phase slip events is needed. In particular, this is the case since the therm al rate serves as the background for distinguishing quantum uctuations at low temperature, a topic of considerable basic scienti c interest [4]

Recently, the string method [5[8] has been presented for the numerical evaluation of them ally activated rare events. This method is boates the most probable transition pathway connecting two metastable states in conguration space. This is done by evolving strings, i.e., smooth curves with intrinsic parametrization, into the minimal energy path. The transition rates can then be computed using an umbrella sampling technique which simulates the uctuations around the most probable path. In this paper we show that the string method can be employed as an eligent numerical tool for the study of therm ally activated phase slips in thin superconducting wires below T_c .

The system is modeled by a one-dimensional (1D) time-dependent G inzburg-Landau equation (TDGLE) with a Langevin noise term. Applying the string method to this particular system, we obtain the most probable transition pathway between two neighboring current-carrying metastable states. This pathway continuously connects the Langer-Ambegaokar saddle-point state [2] to a state in which the order parameter vanishes som ewhere to allow a phase slip of 2, as rst proposed by Little [1]. We also give a num erically

accurate algorithm to evaluate the prefactors for the rate of resistive phase slips.

II.STRING METHOD

To outline the string m ethod [5], consider a system governed by the overdam ped Langevin equation

where is the frictional coe cient, q denotes the generalized coordinates fq_ig , $q_i = @q_i=@t$, $r_i = @=@q_i$, and i(t) is a white noise satisfying $h_i(t)_j(t^0)i = 2 k_B T_{ij}$ (t 0), with k_B denoting the Boltzm ann constant and T the temperature. M etastable and stable states are located in conguration space as the minim a of the potential V (q). A ssum eq_A and q_B are the two minim a of V. In terms of the topography of V (q), the most probable uctuation which can carry the system from q_A to q_B (or q_B to q_A) corresponds to the lowest intervening saddle point between these two minima. The minimal energy path (MEP) is de ned as a sm ooth curve q (s) connecting q_A and q_B with intrinsic param etrization such as arc length s, which satis es

where $(r V)^{?}$ is the component of r V norm alto the path q (s). This MEP is the most probable pathway for therm ally activated transitions between q_A and q_B . To num erically locate the MEP in conguration space, a string q (s) (a smooth curve with intrinsic parametrization by s) connecting q_A and q_B is evolved according to

A re-param etrization is applied once in a while to enforce accurate param etrization by arc length. The stationary solution of Eq. (3) satisfies Eq. (2) which defines the MEP.

Once the MEP is determined, the lowest saddle point is known and the transition rate can be computed by evaluating the uctuations around the MEP [5]. Following K ramers' approach and its generalizations [9 $\{11\}$, the transition rate is given by

where q_s is the saddle point found at the MEP, H (q) denotes the Hessian of V (q), and $_s$ is the negative eigenvalue of H (q_s). (By de nition, H (q_s) has one and only one negative eigenvalue.) The determ inant ratio in Eq. (4) are num erically obtained by linear interpolation as follows [7].

The expectation value Q () can be num erically evaluated in the canonical ensemble governed by potential U (q). In practice, the ensemble is generated by solving

To apply the above technique to the present problem, it is noted that the Hessian at the saddle point, H (q_s), has a negative eigenvalue $_s$. G iven this $_s$ and the corresponding norm alized eigenvector u_s , the inde nite H (q_s) has to be modiled to give a positive de nite H' (q_s):

where is a positive parameter. It follows that det $f(q_s)$ and det $H(q_s)$ are related by

if we remember that the determ inant is the product of the eigenvalues. From the MEP q (s) parametrized by the arc length s, the eigenvector u_s can be obtained by evaluating dq (s)=ds at the saddle point, followed by a normalization, and $_s$ is then computed from $_s = [u_s]^T H (q_s)u_s$. The ratio detH (q_A) =detH (q_s) can be readily computed according to Eq. (9) because H (q_A) and H (q_s) are both positive de nite. The determinant ratio in the rate expression (4) is then obtained from

III. PHASE-SLIP FLUCTUATIONS IN ONE-DIMENSIONAL

SUPERCONDUCTOR

A.One-D im ensional Superconductor

For a superconducting wire below T_c , if the transverse dimension d the coherence length (T), then the variations of the order parameter over the cross section of the wire are energetically prohibited. The wire sample therefore becomes a 1D superconductor, with

being a function of a single coordinate x along the wire. The G inzburg-Landau free-energy functional is of the form

where is the cross-sectional area of the wire, $K = h^2 = m$ with m the elective mass of the Cooper pair, and $_0$ and are both phenom enological parameters. The time evolution of is governed by the time-dependent G in zburg-Landau equation (TDGLE)

This noise generates a random motion of and stabilizes the equilibrium distribution, which is proportional to exp f $F[(x)]=k_B Tg$.

For the convenience of presentation and com putation, we use the dimensionless form

B.Current-Carrying M etastable States

Consider a closed superconducting ring. Periodic boundary condition for (x) is imposed by (l=2) = (l=2) where l is the circum ference of the ring. M etastable current-carrying states _n are obtained from the stationary G inzburg-Landau equation

where k_n is the wave vector, f_n is the amplitude, and n is an integer. The dimensionless current density in the n state is given by $J_n = f_n^2 k_n = (1 \quad k_n^2)k_n$. The m etastability of n requires $j_{k_n} j < k_c = 1 = \frac{p}{3}$. In the presence of therm odynam ic uctuations, the lifetime of these m etastable states is nite. When the lifetime is made su ciently short, the decay of persistent current becomes observable.

C.Current-Reducing Phase-Slip Fluctuations

The decay of persistent current in a superconducting ring m ay be explained by dividing the -function space into di erent subspaces, each labeled by an integer n, de ned through (l=2) (l=2) = 2 n according to the periodic boundary condition for $= j \frac{1}{2}$. In each -function subspace there is a current-carrying m etastable state _n, de ned as a local m inimum of F.

On the one hand, there are m any low energy congurations that are frequently accessed by the uctuating system. Nevertheless, such low energy uctuations cause no change of the phase di erence (l=2) (l=2) across the whole ring, and therefore the global phase coherence persists. On the other hand, there exist therm odynam ic uctuations that lead to transitions between di erent -function subspaces. These uctuations involve large am plitude uctuations of . Heuristically, if vanishes som ewhere, then (l=2) (l=2) may change (slip) by 2 and hence the system moves from one subspace to another (from $_n$ to $_{n+1}$ or $_{n-1}$) [1]. Since larger persistent current means higher free energy, transitions among dierent metastable states tend to reduce the persistent current on average. Large amplitude uctuations usually cost free energies much higher than $k_B T$, therefore phase-slip events are rare. Only when the cross section of the ring is very small and the temperature is close enough to T_c , the decay of persistent currents due to infrequent phase-slip uctuations becomes observable.

D.Free-Energy Saddle Point

Based on the G inzburg-Landau free-energy functional F, Langer and Am begaokar have derived the lowest saddle point $_{s}(x)$ between the two neighboring metastable states $_{n}(x)$ and $_{n-1}(x)$ [2]. This $_{s}$ state corresponds to the most probable uctuation which can carry the system from $_{n}$ to $_{n-1}$ (or from $_{n-1}$ to $_{n}$). Analytical expressions for the saddle-point state $_{s}$ and the dimensionless energy barriers $F = F[_{s}] F[_{n}]$ and $F_{+} = F[_{s}] F[_{n-1}]$ are given in Appendix A. In Sec. V, we will show that using the string method, $_{s}$ and F can be numerically obtained from the MEP connecting $_{n}(x)$ and $_{n-1}(x)$.

IV.APPLICATION OF THE STRING METHOD:FLUCTUATION TIME SCALE

The time scale of the therm odynamic phase-slip uctuations is determined by the Langevin equation (13). The transition rates for the transitions $n_1 ! n_n$ and $n_1 ! n_n$ and be written as

num erical evaluation of has never been reported. Here we outline a num erical scheme for the evaluation of so that a complete solution of the LAM H theory may be obtained. Results based on this scheme will be presented in Sec. V.

The vector forms for the metastable state $_n$ and the saddle-point state $_s$ can be easily obtained. The Hessian of F [(x)] is given by

The general expression (4) for the therm al-activation rate can be directly applied to the phase-slip uctuations, with some elaboration for the symmetry properties of the system. A coording to Eq. (4), the dimensionless form of the prefactors in Eq. (18) can be form ally written as

where H_{n-1} , H_n , and H_s are the three Hessians evaluated at $_{n-1}$, $_n$, and $_s$ according to H [] in Eq. (21), and $_s^{(1)}$ is the lowest (negative) eigenvalue of H_s .

The free energy F is invariant under the gauge transform ation (x) ! $(x)e^{i}$ and the translational transform ation (x) ! $(x x_0)$. (The gauge invariance in terms of is equivalent to the rotational invariance in terms of). As a consequence, H_n must have a zero eigenvalue $\binom{1}{n}$ (the lowest one, other eigenvalues are all positive), with the corresponding eigenvector

where $_{s}$ is the vector form for $_{s}$ and $_{s}^{(2)}$ is the normalization factor. The translational invariance of F leads to another zero eigenvalue $_{s}^{(3)}$ because the phase-slip center in the saddle-point state $_{s}$ can be continuously shifted (see Eq. (A1)).

The presence of the zero eigenvalues $\binom{(1)}{n}$, $\binom{(2)}{s}$, and $\binom{(3)}{s}$ requires some extra e orts in evaluating the prefactors in Eq. (22). While the gauge invariance comes from an unphysical degree of freedom and hence $\binom{(1)}{n}$ and $\binom{(2)}{s}$ are simply discarded, the translational invariance, however, points to the fact that phase-slip uctuations in dimensions are equally probable. The total rate for a transition, say n_{-1} ! n, should be obtained by summing over all the phase-slip uctuations across the whole length of the system. This is achieved as follows.

The prefactors in Eq. (22) appear to diverge because of the presence of $[{3 \ s}]^{1=2}$ in (detH_s)¹⁼². This $[{3 \ s}]^{1=2}$ is contributed by the integral

Thus the prefactors in Eq. (22) are proportional to the system length, as required physically by the translational symmetry of the system. In Ref. [3] an analytical expression has been derived for (see Appendix. B). Below we outline a method for evaluating numerically.

The eigenspace of H_s corresponding to the zero eigenvalue is two-dimensional. An orthonormal basis can be constructed from the saddle-point state $_{s}(x)$. The translational invariance of F gives r $_{s}(x)$ as an eigenvector of H_s: H_sr $_{s}(x) = 0$. The gauge invariance gives $u_{s}^{(2)}(x)$ in Eq. (24) as another eigenvector of H_s: H_s $u_{s}^{(2)}(x) = 0$. Both r $_{s}(x)$ and $u_{s}^{(2)}(x)$ are readily computed from $_{s}(x)$ numerically. Based on these two nonorthogonal eigenvectors, the eigenvector $u_{s}^{(3)}(x)$, norm alized and orthogonal to $u_{s}^{(2)}(x)$, is obtained:

where is related to the norm alization factor $s^{(3)}$ in Eq. (28) by $= [s^{(3)}]^{-1}$. Heuristically, Eq. (28) de nes $u_s^{(3)}(x)$ to represent a special direction in the -function space. A long this direction, the change of s(x) is a \pure" translation of the phase-slip center, without any rotation of the global phase angle, which is an unphysical degree of freedom. Then in Eq. (29), the projection of $d_s(x)$ onto $u_s^{(3)}(x)$ measures the in nitesimal translation of the phase-slip center in the -function space, along the physically nontrivial direction of $u_s^{(3)}(x)$. W ith the help of Eq. (29) and $R^{(3)} dx_c = 1$, Eq. (27) is obtained from Eq. (26).

To sum marize, the dimensionless expressions for the prefactors are obtained as

where the zero eigenvalues $_{n}^{(1)}$ and $_{s}^{(2)}$ are on itted and Eq. (27) is used for $[_{s}^{(3)}]^{1=2}$. Here det⁰ in det⁰H_n 1 and det⁰H_n indicates that the only zero eigenvalue is to be om itted when computing the determ inant, and det⁰ in det⁰H_s indicates that the two zero eigenvalues are to be om itted when computing the determ inant. Using those relevant eigenvectors (corresponding to the negative and zero eigenvalues), the matrices H_n 1, H_n, and H_s can all be modiled into positive de nite matrices (as expressed by Eq. (11)), for which the determ inant ratio can be computed according to Eq. (9).

V.NUMERICAL RESULTS

A.M inim al Energy Path

The string method has been employed to calculate the MEPs connecting neighboring metastable states $_{n}$ and $_{n-1}$. All quantities in the numerical calculation are dimensionless. The length of the system is l = 32. The local minima of F are given in Eq. (17) with jnj 9. (The maximum jnjallowed by $j_{n} j < k_{c}$ is 9.)

We rst show in Fig 1 the MEP which connects $_4$ to $_3$. The string is discretized by M = 101 points in the (x)-function space. The initial string is taken from a linear interpolation between $_4$ (x) and $_3$ (x). In order to reach the MEP, the string is evolved toward the steady state according to Eq. (3), with the potential force given by

$$-F[(x)] = r^{2} + 2^{2}$$

During this process, the string is re-param etrized by arc length every 10 steps. In the calculation, (x) is represented by a column vector of 2N entries, with the x interval [0;1] discretized by a uniform mesh of N = 100 points. Spatial derivatives in the potential force are discretized using central nite di erence.

To x the global rotation of the system, a spring force is applied to the endpoint order parameter (0). In the form of $f_0 = K_2(0)$ with K = 50, this force restricts (0) to the real axis.




FIG.1. Minimal energy path from $_4$ to $_3$. Left column: (Re ;Im) as a function of x; Right column: j jas a function of x. The gures at the top and bottom correspond to $_4$ and $_3$, respectively. The third from the top is for the saddle point. In the fourth gure, j jreaches zero in the middle.

The rst column in Fig 1 displays a sequence of the congurations along the MEP from $_4$ (x) to $_3$ (x), and the second column displays the corresponding sequence of j (x) j. A long this particular MEP, there is a phase slip of 2, nucleated in the middle of the system. Through this phase slip, the winding number changes from n = 4 to n = 1 = 3. From Fig. 1, it is seen that j (x) j rst decreases and reaches zero somewhere (at x = l=2, see the fourth gure from the top), then the phase slip occurs and j (x) j rebounds to accomplish the transition. The third gure from the top shows the saddle point $_{s}$ (x) between $_{4}$ (x) and $_{3}$ (x), which has a locally diminished amplitude and possesses the highest energy along the MEP.

Little [1] rst pointed out that a persistent current in a closed bop will not be destroyed, \unless a uctuation occurs which is of such an am plitude that the order param eter is driven to zero for some section of the loop". However, the con guration of a vanishing orderparam eter am plitude som ewhere does not necessarily correspond to the lowest saddle point between two current-carrying m etastable states. U sing the stationary G inzburg-Landau equation, Langer and Ambegaokar [2] have obtained the analytical solution for the freeenergy saddle point. They also pointed out the following: \It is plausible that, from this state of locally diminished am plitude, the system will run downhill in free energy through

a con guration in which the amplitude vanishes som ewhere, and nally will achieve the con guration in which one less loop in occurs across the length L." This picture about the transition pathway has been quantitatively con rm ed by the MEP obtained here.




FIG.2. Transition pathway obtained from stochastic simulation, from $_4$ to $_3$ with them all noise. Left column: (Re ;Im) as a function of x; Right column: j j as a function of x. The gures at the top and bottom correspond to $_4$ and $_3$, respectively. The third from the top is closest to the saddle point. In the fourth gure, j j reaches zero in the middle.

For comparison, we have carried out direct simulations for the motion of in the pres- 2_0 (T_c ence of therm al noise, using the stochastic equation (20). For $k_B T$ $T \tilde{f} = ,$ reasonably clean transition pathways can be obtained from the rare transition events which carry the system from one metastable state to the other. Figure 2 displays a sequence of (x) and j (x) j collected along a transition pathway from $_4$ (x) to $_3$ (x), calculated for ${}^{2}_{0}(T_{c} = T)^{2} = . A \text{ com parison of Figs. 1 and 2 shows remarkable}$ 1 = 32 and $k_B T = 0.02$ similarities. The advantage of a MEP is also seen from this comparison: As a smooth path in con guration space, the MEP reveals the transition behavior better than those noisy pathways obtained from stochastic simulations. W hile some ne features of the transition may be lost due to the noise in stochastic simulations, they can be well preserved in the MEP. In particular, in order to obtain a clean pathway from stochastic simulation, the tem perature must be kept low enough to reduce local uctuations, but a low temperature inevitably makes the transition events rare and di cult to catch, thus requiring very long simulation time.




FIG.3. Scaled free energy F evaluated along the MEP from $_4$ to $_3$, plotted as a function of the arc length s in the (x)-function space. The $_4$ state is taken as the reference point where s = 0.




FIG.4. Scaled free energy F evaluated along the MEPs connecting a sequence of m etastable $(n \in 0)$ and stable (n = 0) states, plotted as a function of the arc length s in the (x)-function space. The scaled system length is l = 32 and the zero-current state (n = 0) is taken as the reference point where F = 8 and s = 0. The maximum jnjallowed by $jk_n j < k_c$ is 9. The plot here is up to n = 8.

Figure 3 shows the energy variation along the MEP from $_4$ to $_3$. The dimensionless free-energy barrier for the transition $_4$! $_3$ is obtained as F = F[$_s$] F[$_4$] = 0:338. Figure 4 shows the energy prole along the MEP from $_8$ to $_8$. This MEP consists of 16 segments, each connecting two neighboring metastable states $_n$ and $_n$ 1, with n running from 8 to 7.

B.Prefactor

In calculating the prefactor in Eq. (30) for n = 4, we use the following procedure: (1) From the MEP calculated in Sec. VA, the minimum $_n$ and the saddle point $_s$ are obtained.

(2) The (unphysical) degenerate directions $u_n^{(1)}$ at $_n$ and $u_s^{(2)}$ at $_s$ in the -function space are obtained by simple rotation according to Eqs. (23) and (24).

(3) The degenerate direction $u_s^{(3)}$ at $_s$ in the -function space is calculated using Eq. (28), and the parameter de ned in Eq. (29) is then obtained to be 0.894.

(4) The unstable direction $u_s^{(1)}$ at $_s$ is obtained from the normalized difference between two neighboring con gurations, evaluated at the saddle point along the MEP. The corresponding negative eigenvalue is obtained as $_s^{(1)} = hu_s^{(1)}$; $H_su_s^{(1)}i = 0$:364;

(5) The Hessians H $_{\rm n}$ and H $_{\rm s}$ are modi ed to give two positive de nite matrices

where $n_{n}^{(1)}$ and $s_{s}^{(i)}$'s are all positive parameters; In our calculation the parameters $n_{n}^{(1)}$ and $s_{s}^{(i)}$'s are set to be 1.




FIG.5. The expectation value Q () de ned in Eq. (7), plotted as function of f in the interval [0;1].

(6) The ratio det $H'_n = \det H'_s$ is calculated using Eq. (9). Figure 5 shows the expectation value Q (), de ned in Eq. (7) as a function of in the interval [0;1]. This interval of is discretized using a non-uniform mesh of 352 points. Since Q () varies rapidly near = 0 and 1, more points are distributed near these two ends, with the grid size = 5 10⁴. In the middle of [0;1], a larger grid size = 1.25 10² is used. For each , the stochastic equation (10) is simulated with = 1, and Q () is obtained from a time average over 10^5 realizations. The calculated value of the ratio det $H'_4 = \det H'_s$ is 0.608. U sing this ratio and the computed negative eigenvalue at the saddle point, we obtain the ratio det⁰ H₄=jdet⁰⁰ H_sj = 1.06. O ther sets of values have also been used for $n^{(1)}_n$ and $s^{(i)}_s$ in Eqs. (31) and (32), and in Eq. (7), but the nal result of det⁰ H₄=jdet⁰⁰ H_sj is not sensitive to those values.

Using l= 32 and ${}^{2}_{0}$ (T_c T)² = H^{2}_{c} (T)=2 = 50k_BT (used in stochastic simulation), and the numerical values of F = F[s] F[4]= 0:338, ${}^{(1)}_{s}$ = 0:364, = 0:894, and det⁰H₄=jdet⁰⁰H_sj= 1:06 obtained in Secs. V A and V B, we are ready to compute the rate (in the unit of 1= (T))

It follows that the dimensionless rate is approximately 7 10 7 . This value is in reasonable agreement with what has been estimated through stochastic simulations.

VI.DISCUSSION

In this paper we have demonstrated that by using the string method, them al transition rates as formulated in the LAM H theory can be numerically evaluated, even at low temperatures. In particular, the pre-exponential factor may also be determined to some precision. Thus the "electrical resistance" of a 1D superconductor may be evaluated quantitatively. However, it has to be pointed out that quantum tunneling e ect, which can be important at low temperatures, is not taken into account in the present formulation. W ork is presently underway to show that quantum tunneling can be similarly treated through the string method, thus enabling a complete quantitative account of the current dissipation phenomenon in 1D superconductors.

satisfying $k_{n-1} < k_s < k_n$. Note that the amplitude of s(x) is diminished in a small region around x = 0, the phase-slip center. Here we note that translating the phase-slip center from x = 0 to x_c will produce another saddle point $s(x - x_c)$, because the free energy of the system is translationally invariant. From the explicit expressions for n and s, the dimensionless energy barriers can be readily obtained:

Here $F = F[_s] F[_n]$ and $F_+ = F[_s] F[_n_1]$. Since $F < F_+$ (for $k_s > 0$), the transition from $_n$ to $_{n-1}$ is more probable than that from $_{n-1}$ to $_n$. As a consequence, therm ally activated phase slips are current-reducing dissipative process.

is obtained. This equation indicates that while r_{s} is an eigenvector of H_{s} corresponding to the zero eigenvalue, i.e., $H_{s}r_{s} = 0$ by de nition, it can be decomposed into two physically distinct components. The rst component,

is the eigenvector corresponding to the zero eigenvalue ${}_{\rm s}^{(2)}$, arising from gauge invariance. The second component,

is the eigenvector corresponding to the zero eigenvalue ${}_{s}^{(3)}$, arising from translational symmetry. Here a constant is introduced for normalization. It is easily seen that the global rotation of the phase angle is achieved by changing $_{s}$ in the direction of $u_{s}^{(2)}$ while the translation of the phase-slip center is achieved by changing $_{s}$ in the direction of $v_{s}^{(3)}$.
