D ynam ical density functional theory: binary phase-separating colloidal uid in a cavity

Abstract. The dynamical density functional theory of Marconi and Tarazona [J. Chem. Phys., 110, 8032 (1999)], a theory for the non-equilibrium dynam ics of the onebody density pro le of a colloidal uid, is applied to a binary uid mixture of repulsive Gaussian particles con ned in a spherical cavity of variable size. For this model uid there exists an extrem ely simple Helm holtz free energy functional that provides a remarkably accurate description of the equilibrium uid properties. We therefore use this functional to test the assumptions implicit in the dynamical density functional theory, rather than any approximations involved in constructing the free energy functional. We nd very good agreem ent between the theory and Brownian dynam ics simulations, focusing on cases where the con ned uid exhibits phase separation in the cavity. We also present an instructive derivation of the Sm oluchow ski equation (from which one is able to derive the dynam ical density functional theory) starting from the Liouville equation { a fully m icroscopic treatm ent of the colloid and solvent particles. This boarse-graining' is, of course, not exact and thus the derivation dem onstrates the physical assumptions in plicit in the Sm oluchow skiequation and therefore also in the dynam ical density functional theory.

1. Introduction

For a multi-component uid composed of particles with a large size di erence between the di erent components, a theoretical description of the (inhomogeneous) uid dynamics is challenging due to the varying equilibration timescales for the di erent species of particles in the uid. Colloidal suspensions are a particular example of such complex uids. Typically, the colloids are 10{1000nm in diameter, whereas the solvent molecules are, in the case of water, 02nm. The situations in which a theory could be used to describe the motion of inhomogeneous (con ned) colloidal particles are many. For example, in colloidal physics the use of optical tweezers to con ne and then move individual of groups of colloids is common [1]. Simulating such a uid is also computationally expensive, because of the huge numbers of solvent molecules required when simulating even a limited number of colloids. A common approach to such system s is to integrate out the degrees of freedom of the smaller particles in order to render a

description of the system based only on the (much smaller) phase space corresponding to the degrees of freedom of the big colloid particles [2].

In the case of colloidal uids in them al (static) equilibrium, this boarse-grained' approach is, at least form ally, well understood and one is able to form ulate an e ective Ham iltonian for the uid involving only the phase space coordinates of the big particles. Of course, the elective potential between the big particles is, in general, many-body in character and dependent on the density of both the solvent and colloid particles [2, 3]. For example, the depletion potential, or e ective solvent mediated interaction potential, between big hard-sphere particles dissolved in a solvent of sm all hard spheres, is oscillatory for large separations [4] and is therefore very di erent from the bare' potentials one typically encounters between the particles of a molecular uid. However, for the non-equilibrium dynamics of colloidal uids, coarse-graining is carried out on a m ore ad-hoc basis. A comm on approach is to use the e ective solvent m ediated potential obtained from the equilibrium theory together with stochastic equations of motion { i.e. the force on the colloids due to collisions with the solvent particles is modelled as a random white noise term and a frictional (Stokes) one-body drag force. The colloids are thus modelled as Brownian particles. From the (Langevin) equations of motion for the Brownian particles one can obtain the Fokker-Planck (Sm oluchowski) equation [5] for the colloid probability distribution function in phase space, and thus one is able to determ ine non-equilibrium dynam ic properties of the colloidal uid. In going to such a stochastic description of the dynam ics one inevitably neglects hydrodynam ic e ects. W e justify the above stochastic approach in Sec. 4.

In this paper we consider cases of a model colloidal uid con ned in time dependent one-body external potentials. We focus on the time dependence of the uid onebody density pro le, using the dynam ical density functional theory (DDFT) derived recently by Marconi and Tarazona [6, 7] x. In a recent paper [9] (see also Ref. [10]), it was demonstrated that this DDFT could be derived from the Smoluchowski equation, by making the assumption that the form of correlations between particles in an inhom ogeneous uid out of equilibrium, is the same as in an equilibrium uid with the same one body density pro le [6, 7, 9]. We apply the DDFT to the dynam ics of a particular model colloidal uid, the binary Gaussian core model (GCM), making a comparison between the results from the DDFT and Brownian dynamics (BD) simulation results. D zubiella and Likos [11] made a similar comparison for the one component GCM, and found good agreement between theory and simulations. The GCM is a simplem odel for the elective potential between the centers of m ass of polymers or dendrimers in solution [3, 12, 13, 14, 15, 16, 17, 18]. The reason D zubiella and Likos chose this particular model uid is that there exists a very simple, yet remarkably accurate (as we dem onstrate below for mixtures) Helm holtz free energy functional for describing the equilibrium properties of the GCM [3, 19, 20, 21, 22, 23, 24] and thus by using this functional combined with the DDFT they were able to test some of the

approximations inherent in the DDFT, rather than the approximations involved in the free energy functional. The DDFT has also been successfully applied to situations with steady currents [25, 26] and very recently, R ex et al have applied the DDFT to the GCM uid in shear and travelling wave potentials [27]. For these cases they also nd good agreem ent between theory and simulations. One particular question we wish to address here is whether the DDFT can incorporate dynam icale ects that are specific to colloidal uids composed of two different species of colloids and, in particular, dynam icale ects arising when there is phase separation and wetting phenomena in a conned colloidal uid.

The paper is arranged as follows: In Sec. 2 we introduce and brie y describe the DDFT. The results from the application of the DDFT are presented in Sec. 3. In Sec. 4 we give an alternative derivation of the Sm oluchowski equation. Starting from the Liouville equations for a mixture of colloid and solvent particles, we instructions can also be derived as the (generalised) Fokker-P lanck equations for a system of B rownian particles with stochastic equations ofm otion. The present derivation elucidates some of the physical assumptions concerning the uid dynam ics that are implicit in the K ram ers and the Sm oluchow ski equation sheds light on the status of the DDFT and the approximations. We believe this derivation sheds light on the status of under the DDFT and the approximations.

2. The DDFT

Before introducing the DDFT, we recall brie y some of the basic results from equilibrium density functional theory (EDFT) [8, 28] that are required for our discussion of the DDFT. The key quantity in EDFT is the Helmholtz free energy functional:

which is a functional of (r), the uid one-body density. For simplicity we consider a one-component uid. $u_{ext}(r)$ is a one body external potential and

is the (exact) ideal gas free energy; is the therm all de Broglie wavelength of the particles. $F_{ex}[(r)]$ is the excess (over ideal) contribution to the free energy due to interactions between the particles [8, 28]. In EDFT one considers the following grand potential functional 7.

where is the chemical potential. The equilibrium density distribution is given by the minim isation condition [8, 28]:

Thus, using Eqs. (1) { (4), one obtains the following Euler-Lagrange equation for the equilibrium uid density pro le:

where the one body direct correlation function:

= $1=k_B T$ is the inverse tem perature and $k_B T c^{(1)}(r)$ is an elective one body potential that incorporates the elect of the interparticle interactions in the uid. The central task in EDFT is to indicate approximation for $F_{ex}[(r)]$ for the uid of interest. $F_{ex}[(r)]$ is, in general, an unknowin quantity. A second functional derivative of $F_{ex}[(r)]$ gives the inhom ogeneous (O mstein-Zemike) pair direct correlation function:

O ften, approximations for $F_{ex}[(r)]$ are constructed by requiring that the approximate excess H elm holtz free energy functional generate, via Eq. (7), reliable results for $c^{(2)}(r)$, the bulk pair direct correlation function, about which much is known from the theory of bulk equilibrium uids [28, 29].

We now move on to consider a non-equilibrium uid of NB rownian colloid particles. We denote the position of the ith colloid particle by r_i , and the set of all position coordinates by r^N fr_i; :::; r_N g. The total colloid potential energy U_N (r^N ;t) is assumed to be of the following form :

which is made up of a one-body term, i.e. a time-dependent one-body external potential $u_{ext}(r_i;t)$ acts on each uid particle; a two-body term, which is a sum of (time independent) pair potentials $u_2(r_i;r_j)$; a three body term, given by a sum of three-body potentials $u_3(r_i;r_j;r_k)$ and higher body term s, each given by a sum of multi-body potentials. Since we do not include explicitly the solvent particles, this potential must include contributions from solvent mediated interactions between the colloids as well as the direct (bare) interactions between the colloids { we will return to this issue in Sec. 4k. On the Brownian time scale the equations of motion of the colloids obey the following stochastic (Langevin) equations of motion [30]:

where ¹ is a friction constant characterising the one-body drag of the solvent on the colloidal particles and G_i(t) = $\begin{pmatrix} x \\ i \end{pmatrix} \begin{pmatrix} y \\ i \end{pmatrix} \begin{pmatrix} z \\ i \end{pmatrix} \begin{pmatrix} z \\ i \end{pmatrix} (t); \begin{pmatrix} z \\ i \end{pmatrix} (t)$ is a white noise term with the property

The stochastic equations of motion (9), of course, neglect hydrodynamic interactions between the colloids.

We can de ne a probability density function $P^{(N)}(r^N;t)$ for the N colloids. The time evolution of $P^{(N)}(r^N;t)$ is described by the Sm oluchow ski equation [5]:

This equation is the (generalised) Fokker-P lanck equation for the Langevin equations (9). The Sm oluchowski equation is generally presented from this stochastic view point. However, as we show below in Sec. 4, one can argue for its use as an approximation to the exact Liouville equations: By going to the Sm oluchowski equation the description of the uid is reduced to one based solely on the position coordinates of the colloids, rather than utilising the full set of phase space coordinates for the colloid and solvent particles. However, in practice a further reduction is required in order to be able to determ ine explicitly the dynam ics of the colloids. In particular, we focus on the colloid one-body density [9, 10, 29]: Z

We now follow closely the derivation in Ref. [9]: Using Eqs. (8), (12) and (13), we nd that on integrating Eq. (11), one obtains [9, 31]:

At equilibrium, when (r;t)=0 = 0, this equation is just the gradient of the (exact) rst equation of the YBG hierarchy [29].

We are now in a position to make contact with EDFT. For an equilibrium uid the gradient of $k_{\rm B} \, {\rm Tc}^{(1)}$ (r) (see Eq. (6)), a one body force due to interactions between particles in the uid, is given by the following sum-rule [8, 9, 32]:

If we assume that we can use (15) for a non-equilibrium uid we are assuming that the elective one body force on a particle in the uid due to interactions with the other particles is the same as that in the equilibrium uid with the same one body density pro le. We make this assumption and using Eqs. (15) and (1) together with Eq. (14) we obtain the key DDFT equation [6, 7, 9]:

where F [(r;t)] is given by Eq. (1) with (r) replaced by the time dependent one-body density (r;t). Before commenting on the status of Eq. (16), we note that the above arguments can easily be generalised to the case where there are several dierent species of colloids. If there are Q dierent species of colloids, with N_q colloids of species q, such that the total number of colloidal particles is N = $\begin{bmatrix} Q \\ q=1 \end{bmatrix} N_q$, and the total colloid extra colloid extr

In this case, the Sm oluchow ski equation (11) simply becomes

where q^1 is the friction constant for the q^{th} species of colloid particle. One can then integrate Eq. (18) to obtain a DDFT for the one-body density proles. The one-body density of species q is:

i.e., $_q(r_{q;1};t)$ is given by the integral over P $^{(N)}$ with respect to all the colloid position coordinates other than those of the i = 1 colloid of species q. The multi-component generalisation of the DDFT equation (16) then becomes:

where the Helm holtz free energy functional for the multi-component colloidal uid is (c.f. Eq. (1)):

For an inhomogeneous equilibrium uid Eqs. (3) and (4) imply that the chemical potential = F = (r) is a constant throughout the body of the uid. Similarly, for

an inhom ogeneous equilibrium multi-component uid, the chemical potentials for the di erent species,

take a constant value throughout the uid. The DDFT (20) is equivalent to assuming that in the non-equilibrium uid, this is not the case, and that the gradients of the chemical potentials are the therm odynamic forces driving particle currents j_{I} of each species [9, 8]:

On combining this result with the continuity equation

one obtains the DDFT Eq. (20). The DDFT is clearly not a theory for a colloidal uid in which there is a temperature gradient. In order to incorporate such an e ect in a microscopic theory, one would need to construct an external potential that couples to both the position and momentum degrees of freedom of the colloids. In reality, such therm all e ects norm ally also in uence the solvent particles. In the present description we have e ectively assumed that the solvent acts as a heat bath, keeping the temperature of the colloids at a constant value { even in cases where the change in the external potential is such that one would nd an increase in the temperature of the uid were it a simple (molecular, non-colloidal) uid { for example under rapid compression.

A swe have already mentioned, F_{ex} [f q (r)g], the equilibrium excess Helm holtz free energy functional for the uid mixture is, in principle, an unknown quantity. There exist, depending on the uid in question, a num ber of accurate approximate functionals, which give extrem ely good results for equilibrium uid density proles for a wide variety of external potentials (see, for example, Ref. [28] and references therein). This means that the DDFT (20) is a very appealing theory for the dynamics of an inhom ogeneous colloidal uid, since it builds directly upon EDFT, one of the most successful theories for the equilibrium properties of inhom ogeneous uids. As the presentation above shows, the DDFT is clearly not an exact theory. However, the fact that, in principle, the equilibrium pro les obtained from the DDFT are almost exact leads one to expect that the theory should be reliable { at least when the uid is not too far from equilibrium.

3. Application of the DDFT to the GCM

W e argued in the previous section that the DDFT (20) should be a good theory for the dynam ics of a colloidal uid when the uid is near to equilibrium, provided we have an accurate approximation for the excess Helmholtz free energy functional F_{ex} [f_i(r;t)g] for the uid (we now use i; j, rather than q;q⁰ to label the di erent species of colloids). In this section we shall demonstrate that in the case of a particular model uid for which we do have an accurate Helmholtz free energy functional, the DDFT seems to be

reliable even for situations when the uid is quite far from equilibrium and phenom ena such as phase separation and interfacial adsorption (wetting) are present. Throughout we assume that the Brownian level of description (9) provides an accurate account of the underlying particle dynam ics.

Dzubiella and Likos [11] applied the DDFT to a one-component model uid in which the particles interact via a purely repulsive Gaussian potential, the Gaussian core model (GCM). Their choice of model uid was motivated by the fact that a simple mean-eld approximation for F_{ex} [f_i(r)g] proves to be quite accurate for the equilibrium properties, and thus they were able to test whether the DDFT formulation (16) of dynam ics is accurate. We shall say more about this model uid below. Their strategy was to consider the inhom ogeneous uid con ned in either a spherical cavity or a slit. They used EDFT to calculate the equilibrium density pro le corresponding to a particular external potential and considered cases when the external potential suddenly changed (i.e., a parameter in the external potential was either increased or decreased). Using the density pro le from the EDFT as the starting density pro le, they used the DDFT to determ ine how the density pro le of the uid evolved towards equilibrium. The reliability of their results was assessed by making comparison with BD simulation results { i.e. they num erically integrated Eq. (9) a num ber of di erent times, for di erent realisations of the stochastic noise, and then averaged over all the di erent runs in order to obtain the ensemble average time evolution of the uid density pro le. D zubiella and Likos found that the DDFT and the BD simulation results were in very good agreem ent [11]. We follow the same strategy here but for a binary mixture of GCM particles.

The one component GCM does not exhibit uid-uid phase separation [3, 19]. It is therefore of interest to nd out whether the DDFT proves to be reliable for the dynam ics of inhom ogeneous uids when there is phase separation in the uid and when related interfacial phenomena such as wetting of the cavity wall are present. The model uid we consider is the binary GCM. This uid does exhibit liquid-liquid phase separation [20, 21]. The GCM particles interact via the following purely repulsive pair potential:

and no other higher body potentials. In Eq. (25) i; j = 1;2 label the two di erent species of particles, $_{i;j} > 0$ is a param eter that determ ines the strength of the interaction and R $_{i;j}$ denotes the range of the interaction potential. Note that this potential has no hard core; the centres of the particles can overlap completely. When one considers the elective potential between the centres of m ass of polymers in a good solvent, one nds that the G aussian potential (25), with $_{i;j}$ 2k_B T and R $_{i;j}$ R_g, the polymer radius of gyration, provides a good approximation [3, 12, 13, 14, 15, 16]. When the uid density becomes su ciently high, each GCM particle interacts with a large number of neighbours, and it is established that the following mean-eld excess Helm holtz free energy functional [3, 19, 20, 21]:

becomes rather accurate. This functional generates the RPA closure for the direct pair correlation functions (c.f. Eq. (7)):

We solve the DDFT (20) for the binary GCM con ned in spherically symmetric external potentials of the form :

where r is the distance from the origin, $E = 10k_B T$ and the length-scale R is the same for both species of particles. This potential is of the same form as one of the external potentials considered in Ref. [11] for a one component uid of GCM particles. As the length parameter R is increased, the size of the cavity is increased. We consider cases where for timest < 0 the uid is at equilibrium conned in a cavity with potentials (28), with $R = R_1$. Then at t = 0 the cavity potentials change to ones with $R = R_2 \in R_1$. D ue to the spherical symmetry of the external potentials, the (ensemble average) uid one body density proles will also display spherical symmetry. In the binary GCM uid we shall consider mixtures with two di erent sets of pair potential parameters. The rst corresponds to a set giving bulk liquid-liquid phase separation and the second to a set giving m icrophase-separation [23]. We shall also assume throughout that the friction constants for the two di erent species of particles are equal, i.e., $\frac{1}{1} = \frac{1}{2} = \frac{1}{2}$, to keep the problem as simple as possible.

3.1. DDFT for a GCM uid which exhibits bulk phase separation

We consider a binary GCM uid with pair potential parameters $_{11} = _{22} = 2k_BT$, $_{12} = 1.8877k_BT$, $R_{22} = 0.665R_{11}$ and $R_{12} = 0.849R_{11}$, which exhibits bulk uid-uid phase separation. The fact that $R_{12} = (1 +)(R_{11} + R_{22})=2$, with > 0, ensures that the uid exhibits positive non-additivity and it is this feature which induces phase separation. This choice of pair potential parameters was used in a number of previous studies by the author [21, 22, 33, 34, 35]. The uid phase-separates at high total densities $= _1 + _2$, where $_1$ and $_2$ are the bulk densities of the two species. W ithin the mean-eld DFT de ned by Eq. (26) the (lower) critical point is at $R_{11}^3 = 5.6$ and concentration x $_2 = = 0.70$ [21].

The rst case we consider is that with $N_1 = 200$ big particles of species 1 and $N_2 = 100$ particles of species 2, con ned in a cavity with $R = 4R_{11}$ for t < 0. At t = 0 the cavity size is suddenly reduced to $R = 3R_{11}$. In Fig. 1 we display the evolution of the uid density pro les after this sudden compression of the cavity. We display the results from solving the DDFT (20) combined with the RPA functional (26), as well as results from BD simulations [36]. In the BD simulations we num erically integrate Eq. (9) generalised to two di erent species of GCM particles. We typically perform





Figure 1. Density pro les $_{i}(r;t)$ (DDFT results: solid line for species 1, dashed line for species 2; symbols are BD results, (+) for species 1, () for species 2) for a uid composed of N₁ = 200 particles of species 1 and N₂ = 100 particles of species 2, which is initially (t < 0) at equilibrium in an external potential of the form in Eq. (28) with R = 4R₁₁. At t = 0 the external potentials suddenly change to those with R = 3R₁₁. The pro les are plotted for various t = k_B T R²₁₁t. The two species of particles are uniform ly mixed in the cavity at t = 0, but due to the increase in density, the equilibrium pro les for the uid in the cavity with R = 3R₁₁ exhibits a degree of demixing. Note also that $_{1}$ (r = 0;t) is a non-monotonic function of time.





Figure 3. The second moment of the density proles, $m_2^i(t)$, dened by Eq. (29). The left hand gure is for the cases corresponding to the density proles displayed in Figs. 1 and 2. The right hand gure corresponds to the cases in Figs. 4 and 5. The solid lines are the second moment for species $1, m_2^1(t)$, and the dashed lines $m_2^2(t)$, for species 2. In each case, the curves with a higher value of $m_2^i(t) = 1$ correspond to a nal external potential with a larger value of R. Note that in both cases $m_2^1(t)$ is non-monotonic, whereas $m_2^2(t)$ is a monotonic function of time.


1500 di erent runs, each with di erent realisations of the stochastic noise term , and then average over all the di erent runs in order to obtain the ensemble average time evolution of the uid density pro les. In order to generate each starting con guration, we allow the uid to equilibrate for a reduced time t $k_B T R_{11}^2 t = 10$ with a xed parameter $R = R_1 (= 4R_{11})$ in the external potential, before changing this parameter to $R = R_2 (= 3R_{11})$ and determining the relaxation of the uid. In Fig. 1 the density pro les at t = 0 correspond to those of the equilibrium uid in a cavity with $R = 4R_{11}^+$. W hen the external potential parameter $R = 4R_{11}$, the two species of GCM particles are m ixed within the cavity, although because the walls of the cavity favour species 1, there is a higher density of species 1 around the outside of the cavity. This preference of the cavity wall for species 1 is due to the fact that the cavity wall potentials for both species of particles decay into the uid with the same decay length. This results in an e ective attraction between the wall and species 1 [22]. For smallt > 0, the initial bom pression' of the uid results in the growth of a sharp peak in the densities of both species around $r' R_2 = 3R_{11}$. This causes a density wave' to travel through the uid into the centre of the cavity. The uid reaches equilibrium at t t_{B} ' 13, where $B = R_{11}^{2}$ is the Brownian time scale. In Fig. 1 we display the uid density pro les for the times t = 0, 0.025, 0.1, 0.3, 0.8, and 2. The prole for t = 2 e ectively corresponds to the equilibrium pro le for the external potential (28) with $R = 3R_{11}$. With this value of R the uid exhibits a degree of phase separation in the cavity due to the fact that the total

density of the uid in the cavity has increased. The particles of species 1 are mostly to be found adsorbed around the wall of the cavity and species 2 towards the centre of the cavity. In Fig. 2 we display the density proles for the reverse situation to the case in Fig. 1: The external potentials (28) are initially (t < 0) those with $R = 3R_{11}$. Then, at t = 0, the potentials are changed to those with $R = 4R_{11}$. In this case the uid reaches equilibrium when t ' 1:7. The reason that the 'compression' case (Fig. 1) is able to reach equilibrium faster than the relaxation case (Fig. 2) is that in the compression

case the shock wave' that travels inward, m ixes up the uid, which allows it to reach equilibrium faster than in the relaxation case. In Fig. 3 we display the second m om ent of the density pro le, π

 $m_{2}^{i}(t) = drr_{i}^{2}(r;t):$ (29)

D zubiella and Likos [11] found that for a one component GCM uid this is a monotonic function of time. For the relaxation (cavity expansion) case they found that m_2 (t) can be very accurately approximated by an exponentially decaying function. For the

compression case, m_2 (t) is also monotonic, and can be accurately parameterised by a function composed of two exponentials. They also found that the one component GCM uid reaches equilibrium faster in the compression case, where R is decreased at time t = 0, rather than the relaxation case. For the binary GCM uid, $m_2^2(t)$ is also a monotonic function of time (dashed lines), but interestingly, m_2^1 (t) is not (solid lines) { see Fig. 3. This is because particles of species 1 are adsorbed on the wall of the cavity and when the parameter R in the external potentials is suddenly decreased, particles of species 1 are forced more strongly towards the centre of the cavity than the species 2 particles. This causes an increase in the density of species 1 at the centre of the cavity. However, in the nal stages of the uid equilibration, the density of species 1 at the centre of the cavity decreases again. In other words, $_1$ (r = 0;t) is a nonmonotonic function of time. Similarly, when the cavity is suddenly increased in size, it is the particles of species 1 that 'feel' the space around the outside of the uid that has suddenly appeared, rather than the species 2 particles, and so it is species 1 particles that move outwards to 11 this space. However, in the nal stages of the uid equilibration process, there is a net ow of species 1 particles back towards the centre of the cavity. For these reasons, only m_2^1 (t) is a non-monotonic function of time. Dynamic processes such as these only occur when the uid con ned in the cavity is a binary uid, where the wall of the cavity has a preference for one of the species. As can be seen from Figs. 1 and 2 there is remarkably good agreem ent between the density pro les obtained from the DDFT and from the BD simulations. This agreem ent gives us con dence concerning the reliability of the DDFT for cases where the numbers of particles are such that BD simulations become computationally too expensive. Note also that the RPA functional (26) becomes increasingly accurate as the GCM uid density is increased [3, 19]; this should further in prove the accuracy of the DDFT results.

In Figs. 4 and 5 we display the DDFT results for a similar situation as in Figs. 1 and 2, except in this case the cavity is larger and the number of con ned particles is higher: $N_1 = 25000$ particles of species 1 and $N_2 = 5000$ particles of species 2 (the average densities are also higher). In Fig. 4 we display the results for the case when the uid, for t < 0, is at equilibrium in a cavity with potentials given by Eq. (28) with $R = 9R_{11}$. Then at t = 0 the potentials change suddenly to those with $R = 13R_{11}$. We plot the density proles for t = 0, 0.02, 0.04, 0.06, 0.1, 0.5, 1, 5, 10, 20, 30 and 1. (Here and elsewhere, the t = 1 density pro les are those obtained using EDFT for cavity potentials with $R = R_2$. In the present case $R_2 = 13R_{11}$.) We see that at t = 0 the uid is strongly phase separated in the cavity, with the phase rich in species 1 wetting' the wall of the cavity, and the phase rich in species 2 at the centre of the cavity. The nalequilibrium con guration, t! 1, when the cavity radius $R = 13R_{11}$, is that where the two species of particles are mixed together in the cavity, although the preference of the cavity wall for species 1 ensures that the density of species 1 is still higher around the outside of the cavity. In order to reach this equilibrium con guration the uid rst exhibits a quick' ow of the phase rich in species 1 to 11 the space created around the outside of the uid by the cavity expansion. There is then a second 'slow'

process whereby the two dem ixed phases m ix, i.e. the di usion of particles across the uid-uid interface is a slow process.

For the reverse (cavity compression) situation, the results are displayed in Fig. 5. Fort < 0 the uid is at equilibrium in a cavity with potentials given by Eq. (28) with $R = 13R_{11}$. Then at t = 0 the potentials change suddenly to those with $R = 9R_{11}$. We plot the density proles for t = 0, 0.02, 0.1, 0.5, 1, 3, 5, 10, 15, 20, 35 and 1. In this case the uid reaches equilibrium slightly faster than in the case where the cavity size is increased. This is because in the cavity compression case, the sudden decrease of R at t = 0 sends a particle concentration wave' into the centre of the cavity (see Fig. 5) which allows the uid to reach equilibrium faster. This wave' form s as a dip in the density pro le of species 1 and a peak in pro le for species 2 couple together and m ove towards the centre of the cavity. The amplitude of the wave increases with proximity to the centre of the cavity. As can be seen in the right hand qure of Fig. 3 for both these cases the second m om ents of the density pro les, given by Eq. (29), show sim ilar behaviour to the cases with fewer particles in Figs. 1 and 2 { see Fig. 3. m_2^1 (t) is a non-monotonic function of time, whereas m_2^2 (t) is a monotonic function of time. As for the cases in Figs. 1 and 2, this is due to the fact that the species 1 particles are adsorbed on the cavity wall, rather than the species 2 particles.

3.2. DDFT for a GCM uid which exhibits m icrophase separation




Figure 7. This is the reverse case of that displayed in Fig.6. Initially (t < 0) the uid is at equilibrium conned in external potentials of the form in Eq. (28) with $R = 3R_{11}$. Then at t = 0, the external potentials suddenly change to those with $R = 4R_{11}$. The profess are plotted for various $t = k_B T R_{11}^2 t$. The initial t = 0 conguration is an onion' structure.

We now consider a binary GCM uid with pair potential parameters the same as in the previous subsection except that $R_{12} = 0.6R_{11}$, i.e. $R_{12} = (1 +)(R_{11} + R_{22})=2$, with < 0; the uid exhibits negative non-additivity. This uid does not exhibit bulk uid-uid phase separation. Due to the negative non-additivity there is a propensity to ordering in the uid in which particles of species 1 have as nearest neighbours particles of species 2, and vice versa [23]. We refer to this phenomenon as 1-2 ordering'. At high total densities EDFT predicts that this GCM uid freezes into a crystal in which the particles are highly delocalized, with Lindem ann parameters as high as 90% near melting [23]. When the uid is con ned in a spherical cavity and the uid density is high enough, the uid forms an onion' structure of alternating layers, one particle thick, of the two di erent species [23] (see also Figs. 6, 7, 9 and 10). Sim ilarly, when the high density mixture is con ned in a planar slit the density pro les show that uid form s alternating layers of the two di erent species parallel to the walls of the slit [23]. At lower densities the two di erent species of particles are mixed. This microphase separation is associated with the fact that the bulk uid exhibits an instability with respect to periodic density modulations { a '-instability'. For more details regarding the origin of this instability see Ref. [23] and references therein. Here our interest is limited to the question: Can the DDFT describe the form ation of bnion' structures in a spherical cavity with potentials given by Eq. (28) when R is reduced, and can the DDFT describe the onion in elting when R is increased?

W e follow a strategy similar to that taken in the previous subsection and make




Figure 6. Density profes $_{i}(r;t)$ (solid line is DDFT results for species 1, dashed line for species 2; symbols are BD results, (+) for species 1, () for species 2.) for a uid composed of N₁ = 200 particles of species 1 and N₂ = 150 particles of species 2, which is initially (t < 0) at equilibrium conned in external potentials of the form in Eq. (28) with R = 4R₁₁. Then at t = 0, the external potentials suddenly change to those with R = 3R₁₁. The profess are plotted for various t = k_B T R²₁₁t. This model uid exhibits microphase-separation. The nalt = 1 con guration is an onion' structure.




Figure 8. The second moment of the density proles, $m_2^i(t)$, de ned by Eq. (29), for a GCM uid exhibiting microphase-separation, with density proles displayed in Figs. 6 and 7. The solid lines are the second moment for species 1, $m_2^1(t)$, and the dashed lines $m_2^2(t)$, for species 2. In each case, the curves with a higher value of $m_2^i(t)$ 1) correspond to a nalexternal potential with a larger value of R. Note that in both cases $m_2^1(t)$ is non-monotonic, whereas $m_2^2(t)$ is a monotonic function of time, as was the case in Fig. 3 for a GCM uid that exhibits bulk phase separation.

a comparison between the results from DDFT and BD simulations for cases with a limited number of particles, in order to demonstrate the reliability of the DDFT for this particular GCM uid and then we apply the DDFT to cases where the number of particles is too high for simulations to be a realistic tool for studying the dynam ics. In Fig. 6 we display the density proles for a uid composed of $N_1 = 200$ particles of species 1 and $N_2 = 150$ particles of species 2, which is initially (t < 0) at equilibrium con ned in external potentials of the form in Eq. (28) with $R = 4R_{11}$. Then at t = 0the external potentials are suddenly changed to those with $R = 3R_{11}$. We display the density pro les fort = 0, 0.025, 0.05, 0.1, 0.5 and 1. In the initial t = 0 density pro les we see that there is little sign of the uid exhibiting 1-2 ordering. As was the case for the uid described in the previous subsection, the wall potentials result in an e ective attraction between the wall of the cavity and particles of species 1. Therefore there is an increased density of species 1 around the wall of the cavity. Following the compression in the cavity at t = 0, there is an initial in- ow of uid towards the centre of the cavity and an increase in the density of the uid near to the cavity wall. Following this initial stage, the uid relaxes into a con guration which exhibits a pronounced degree of 1-2 ordering { see the t = 1 gure in Fig. 6. In Fig. 7 we display the results for the reverse situation, i.e. when the uid is initially (t < 0) at equilibrium con ned in external potentials of the form in Eq. (28) with $R = 3R_{11}$, then at t = 0, the external potentials suddenly change to those with $R = 4R_{11}$. We display the pro les for t = 0, 0.025, 0.05, 0.1,0.5 and 1. In both cases the agreement between the DDFT and the BD simulations is rem arkably good. Fig. 8 displays the results for the second moment of the density pro le, de ned by Eq. (29). As in the previous subsection, in the present case the moments m_{2}^{1} (t) for species 1 are non-monotonic functions of time, whereas the moments m_{2}^{2} (t) are monotonic functions of time. The uid which exhibits 1-2 ordering is able to reach equilibrium faster than the uid considered in the previous subsection which exhibits bulk phase separation. This is because the average distance the particles must di use to be arranged in a m icrophase separated distribution is shorter than in the case where the nal equilibrium con guration is that exhibiting bulk' phase separation. In the latter case the particles of species 1 must di use to the outside of the cavity, whilst particles of species 2 must di use to the centre of the cavity in order to reach equilibrium.




Figure 10. This is the reverse case of that displayed in Fig. 9. Initially (t < 0) the uid is at equilibrium con ned in external potentials of the form in Eq. (28) with $R = 10R_{11}$. Then at t = 0, the external potentials suddenly change to those with $R = 8R_{11}$. The density pro les (solid line for species 1, dashed line for species 2) are plotted for various t = $k_B T R_{11}^2 t$.

In Figs. 9 and 10 we display the DDFT results for a similar situation, except now the cavity is larger and the number of conned particles is also much bigger: $N_1 = 16000$ particles of species 1 and $N_2 = 15000$ particles of species 2 (the average densities are also higher). In Fig. 9 we display the results for the case when the uid, for t < 0, is at equilibrium in a cavity with potentials given by Eq. (28) with $R = 8R_{11}$. Then at t = 0 the potentials change suddenly to those with $R = 10R_{11}$. We plot the density proles for t = 0, 0.02, 0.06, 0.1, 0.2, 0.5, 0.7, 1 and 1. At t = 0 the two diment species { an onion' structure. The nall equilibrium con guration, t ! 1, is that where the two species of particles are uniform by mixed in the cavity, although, due to the preference of the cavity wall for species 1, the density of species 1 is higher in the outer region of

the cavity. The equilibration process is almost an order of magnitude shorter in time than in either of the cases in Figs. 4 or 5 for the GCM uid exhibiting bulk liquid-liquid phase separation, even though the num ber of particles involved in these cases is sim ilar. This is because the particles must di use a distance R_{11} , the particle size, in order to go from a state with 1-2 ordering to a mixed state, whereas for the uid exhibiting bulk' phase separation the particles must di use a much larger distance R, the radius of the cavity. For the reverse (cavity compression) situation, the results are displayed in Fig. 10. Initially, for t < 0, the uid is at equilibrium in a cavity with potentials given by Eq. (28) with $R = 10R_{11}$. Then at t = 0 the potentials change suddenly to those with $R = 8R_{11}$. We plot the density pro les for t = 0, 0.01, 0.02, 0.06, 0.1,02, 0.5, 0.7 and 1 . As with the cavity expansion case in Fig. 9 this process is almost an order of magnitude quicker in time than in either of the cases in Figs. 4 or 5. The com pression causes the total uid density to rst increase around the wall of the cavity, before increasing near the centre of the cavity. This results in the bnion' layers form ing rst in the outer region and then developing inwards towards the centre of the cavity as the uid equilibrates.

4. Liouville, K ram ers and Sm oluchow ski equations

We now turn to the question of what approximations are involved in the present description of the uid dynamics. Under what circum stances can the equations of motion for a solution of colloids suspended in a solvent of much smaller particles be




Figure 9. Density pro les $_{i}(r;t)$ (solid line for species 1, dashed line for species 2) for a uid composed of N $_{1}$ = 16000 particles of species 1 and N $_{2}$ = 15000 particles of species 2, which is initially (t < 0) is at equilibrium con ned in external potentials of the form in Eq. (28) with R = 8R $_{11}$. Then att = 0 the external potentials are suddenly changed to those with R = 10R $_{11}$. The pro les are plotted for various t = $k_B T R_{11}^2$ t. This model uid exhibits microphase separation. The initial t = 0 con guration is an bnion' structure.

approximated by the stochastic equations of motion (9)? Or, equivalently, in which situations can the time evolution of the probability density function for the full system of colloid and solvent particles be approximated by the Sm oluchowski equation (11)? In Refs. [37, 38] these questions are addressed for the case of a uid in which one of the particles is much larger than the rest and when the solvent friction coe cient

 1 is su ciently large, that one can argue that the time evolution of the probability distribution function for the single big (colloid) particle is governed by the single particle Sm oluchowski equation. Here we present an argument which is a simplied generalisation (for N big colloid particles) of this argument. The derivation does not contain new ideas. However, we do make connections between older, well known, results concerning the dynamics of colloidal uids and more recent developments in the theory of solvent mediated elective potentials between colloids in solution [3]. The following therefore provides much insight to the physics incorporated in the Sm oluchowski equation and therefore also in the DDFT, and applies generally to colloidal uids.

We consider a uid consisting of a single species of N colloid particles of mass m,

suspended in a single component solvent composed of S solvent particles, of mass M. We denote the coordinates of the ith colloid by r_i and m om entum p_i . The set of colloid position coordinates we denote by r^N fr_i ; :::; r_N g and similarly p^N fp_i ; :::; p_N g. For the solvent particles we denote the location in phase space of the th solvent particle by (R ; P). Just as for the colloids, we denote the sets R^S fR_1 ; :::; R_S g and P^S fP_1 ; :::; P_S g. The Ham iltonian for this system is:

where the rst two terms on the right hand side are the colloid and solvent kinetic energy contributions to the H am iltonian. V_N (r^N ;t) is the colloid potential energy:

which is assumed to be made up of a one-body term (external potential v_{ext} (r_i ;t) on each colloid particle) a two-body term (v_2 (r_i ; r_i) is the pair potential), a three body

term $v_3(r_i;r_j;r_k)$, etc. Note that $V_N(r^N;t)$ describes the direct or bare colloid-colloid interaction potential; it does not involve e ective solvent mediated interactions and is therefore not the same as $U_N(r^N;t)$ in Eq. (8) { we will further clarify this issue later (see Eq. (43)) . Similarly, $V_S(R^S;t)$ is the solvent potential energy and $V_{N;S}(r^N;R^S)$ is the potential energy arising from interactions between the colloid and the solvent particles.

We can de ne a phase space probability density function $f^{(N+S)}(r^N;p^N;R^S;P^S;t)$ for the uid, and its time evolution is governed by the (exact) Liouville equation [29]:

where

are forces on the particles. The Liouville equation is a statem ent of the continuity of $f^{(N+S)}$ in phase space over time.

Since the solvent particles are much smaller than the colloids, they will equilibrate on a time scale $_{\rm s}$ much smaller than the time scale $_{\rm c}$ on which the colloids equilibrate, i.e. $_{\rm c}$ $_{\rm s}$. We are interested in phenomena that occur on time scales $_{\rm c}$, so we can assume that electively the solvent particles equilibrate instantaneously, and when we integrate over the solvent degrees of freedom in Eq. (32) we obtain an equation similar to the Liouville equation for a one component und of N particles, but with an additional bolvent' term due to interactions between the colloid and solvent particles:

The term ${}^{R} dP {}^{s} {}^{R} dR {}^{s} Z_{i} f^{(N+S)}$ in (36) is proportional to the average force exerted on colloid i by the solvent particles. On this boarse-grained' time scale ${}_{s}$, the leading order contributions to this force are a one body (Stokes) drag force on each colloid,

For generality we assume V_N (r^N ;t) contains higher body terms, although it is generally assumed that the bare interactions between particles are pairwise with no higher body terms. In principle, the higher-body terms arise from integrating over quantal degrees of freedom in obtaining V_N (r^N ;t).

 p_i , where is a friction coe cient, and a force term, x_i , due to solvent mediated interactions between the colloids. This force is

where $_{N}$ (r^{N}) is the elective solvent mediated potential between the colloid particles. For an equilibrium uid $_{N}$ (r^{N}) = $k_{B} T \ln Q_{S}$ (r^{N}), where Q_{S} (r^{N}) is a partial partition function [3]:

and $_{\rm S}$ is the de-B roglie wavelength for the solvent particles. For the equilibrium $_{\rm N}$ (r^N) can, in principle, be calculated. In general

where ∇ is the volum e of the system, $_0$ is a zero-body potential [3], $_1$ (r_i) is the solvent m ediated one-body potential (for example with the uid container walls), $_2$ (r_i;r_j) is a two body pair potential, $_3$ (r_i;r_j;r_k) is a three body potential, and so on. These potentials are generally density dependent. We shall assume that the non-equilibrium solvent m ediated potential is the same as the equilibrium solvent m ediated potential (39). This approximation should be reliable on time scales $_{s}$, since on these time scales the solvent particles are electively at equilibrium. Thus the leading order term s in a Taylor expansion of the force term in Eq. (36) can be expressed as:

where is a mobility coe cient, which, in principle, is a function of the colloidal phase space coordinates. However, we shall assume and to be constants. If we now substitute Eq. (40) into Eq. (34), retaining only the two leading order terms, then we obtain:

We recognise this as the K ram ers equation { i.e. a generalised Fokker-P lanck equation [5]. At this point we can also make the connection between the constants and via the uctuation dissipation theorem, and we nd that $= m k_B T$. In other words, when $= m k_B T$, the equilibrium colloid reduced probability distribution function is correctly given by

where V_N (r^N), the term describing the direct interactions between the colloids, is given by Eq. (31) with a time independent external potential.

We now clarify the dierence between the potentials U_N (r^N ;t) in Eq. (8) and V_N (r^N ;t) in Eq. (31). We see that the total colloid potential U_N (r^N ;t), is given by (see Eqs. (31) and (39)):

i.e., we see explicitly here that $U_N(r^N;t)$ is the sum of the direct colloid interaction potential (31) and the solvent mediated potential (39). In Eq. (8) we can therefore identify the total colloid elective one body potential $u_{ext}(r_i) = v_{ext}(r_i) + \frac{1}{1}(r_i)$, as the sum of a direct potential and a solvent mediated potential. Similarly, the total colloid elective pair potential $u_2(r_i;r_j) = v_2(r_i;r_j) + \frac{1}{2}(r_i;r_j)$, the total colloid elective three body potential $u_3(r_i;r_j;r_k) = v_3(r_i;r_j;r_k) + \frac{1}{3}(r_i;r_j;r_k)$, and the higher body elective potentials are a sum of a direct contribution and a solvent mediated contribution.

The K ram ers equation (41) can also be obtained as the (generalised) Fokker-P lanck equation for the time evolution of the probability density function for N colloid particles with the following stochastic equations of motion [5]:

where $G_i(t) = ({}_i^x(t); {}_i^y(t); {}_i^z(t))$ is a white noise term with correlations given by Eq. (10). In a stochastic treatment of the colloidal uid one considers the above equations of motion, (44), solely for the colloids and one incorporates the e ect of the solvent via the stochastic noise term, the friction coe cient and the solvent mediated potential $_N(r^N)$. In the treatment above, we arrived at the K ramers equation (41) by approximating the Liouville equation for the full system of solvent and colloid particles.

In deriving the K ram ers equation (41) it is clear that we made a very large reduction in number of degrees of freedom in the description of the uid, since we have integrated over the solvent degrees of freedom. However, there are still 6N degrees of freedom in (41) and further reductions are required. We now focus on the colloid probability density function Z

In order to obtain an equation for the time evolution of $P^{(N)}(r^N;t)$ we have to make further approximations. The following is a generalisation of the \quick and dirty" approach in Ref. [2] (see also Refs. [5, 39]). On integrating with respect to the colloid momentum degrees of freedom in Eq. (41), we obtain the following continuity equation:

and we have used the fact that the integrals ${}^{R}dp_{i}(@f^{(N)}=@p_{i}), {}^{R}dp_{i}(@^{2}f^{(N)}=@p_{i}^{2})$ and $dp_{i}(@p_{i}f^{(N)})=@p_{i})$ are all equal to zero.

A lso, if we multiply Eq. (41) through by $p_k = m$, the velocity of the kth colloid, and then integrate over all the colloid momentum degrees of freedom, we obtain:

If we now make a local momentum equilibrium 'approximation [2], which sets term s such as $dp^{N} p_{i;a}p_{j;b}f^{(N)} = m k_{B}TP^{(N)}_{i;j a;b}$, where $p_{i;a}$ is the a {component (a;b = x;y;z) of the momentum of the ith particle, then we nd that Eq. (48) reduces to

If the friction constant is su ciently large then we can neglect the rst term in (49), as it will be negligible compared to the friction term J_k , on the Brownian time scales $_B$, and we obtain:

where = 1 = m. Substituting (50) into Eq. (46), we obtain the Sm oluchow skiequation (11).

The Sm oluchow ski equation is generally presented from the stochastic view point, starting from the Langevin equations of motion (9). However, as shown above, one can argue for its use as an approximation to the exact Liouville equations for the time evolution of the probability density function for colloidal uids. The above derivation demonstrates the physical conditions under which the time evolution of the probability density functions is described by the Sm oluchow ski equation. By going to the Sm oluchow ski equation (with an elective potentials between the colloids), the description of the uid is reduced to one based on only the position coordinates of the colloids, rather than the full set of phase space coordinates for the colloid and solvent particles, which is, of course, a signi cant simpli cation.

5. D iscussion and conclusions

In Sec. 2 we introduced the DDFT of M arconi and Tarazona [6, 7] for colloidal uids, following a recent derivation in Ref. [9] of the DDFT starting from the Sm oluchowski equation. We emphasise that this is an approximate theory. In Sec. 3 we applied the DDFT to the speci c case of a binary uid of GCM particles con ned in a spherical cavity of variable size. We nd that the DDFT is able to describe accurately the time evolution of the highly structured uid one-body density pro les. We nd a variety of collective dynamic processes that are accounted for by the DDFT. For example, the

case in Fig. 5, where we see a particle concentration 'wave' travelling through the uid into the centre of the cavity that allows the uid to equilibrate into the phase-separated con guration slightly faster than one would expect, bearing in m ind the results displayed in Fig. 4, which showed that the uid-uid interface persists for a long time after the cavity radius R is increased. Such phenom ena are very di cult to simulate because of the large num ber of particles involved. It is in situations such as these where the DDFT should provide a useful tool to analyse the uid dynam ics.

Our strategy is to ist consider cases of only a few hundred particles where BD simulations can be used to assess the accuracy of the DDFT results. In these test cases with fewer particles, where the uid exhibits a limited degree of phase separation and wetting behaviour, we ind excellent agreement between the DDFT and the BD simulation results (see for example Figs. 1 and 2). This gives us condence to trust the reliability of the DDFT when applied to cases with many more particles, where comparison with simulation becomes computationally too expensive. We predict that were one to perform a BD simulation for (say) the cases presented in Figs. 4 and 5, one would ind just as good agreement between the DDFT results and BD simulation results. In fact, one should argue that since the total uid densities are higher in these situations, and the fact that the RPA functional (26) becomes more accurate at higher densities [3, 21], the results from the DDFT should be even more reliable in these cases.

In Sec. 4, we derive the Sm oluchowski equation, starting from the exact Liouville equations by making a series of approximations in order to go from a description of the uid in terms of the full set of colloid and solvent phase space coordinates to a (far more manageable) description solely in terms of the colloid position coordinates (the Sm oluchowski equation (11)). Such integration over degrees of freedom is a process that is required in order to render a practical statistical description of any condensed matter system. We believe our derivation is useful because it highlights some of the approximations involved in the Sm oluchowski equation for colloids and therefore also in the DDFT and thus sheds light on the status of the DDFT.

The Sm oluchow ski equation is usually presented from the stochastic view point, since it is the Fokker-Planck equation for the Langevin equations (9). This connection makes it clear that the Sm oluchow ski equation and thus the DDFT neglect hydrodynamic e ects. To include hydrodynamic e ects one would have to treat the solvent at a level beyond that taken here, where the e ects of the solvent are incorporated in the DDFT via the e ective solvent mediated potential between the colloids and in the friction coe cient ¹. One can build in hydrodynam ic e ects in the Sm oluchow ski equation by replacing with a matrix _{ij}, describing the hydrodynam ic coupling between colloids i and j [9, 40, 41]. However, this makes the reduction of the Sm oluchow ski equation to a DDFT much less straightforward.

We conclude that the DDFT, Eq. (20), should provide a good theory for the dynamics of the one body density of a colloidal uid, even when there is phase separation and wetting of interfaces, provided that i) the friction constant characterising the solvent, 1 , is large enough and ii) there exists an accurate approximation for

the excess Helmholtz free energy functional F_{ex} []. Many colloidal uids can be accurately modelled as elective hard-sphere uids and therefore we expect that the DDFT combined with fundamental measure free energy functionals [42, 43] for hard spheres to provide a reliable theory for the dynamics of the one body density pro le of a (hard-sphere) colloidal uid.
