We propose a method to indicut the community structure of a complex network. In this method the ground state problem of a ferrom agnetic random eld Ising model is considered on the network with the magnetic eld $B_s = +1$, $B_t = 1$, and $B_{i6\,s,t} = 0$ for a node pair s and t. The ground state problem is equivalent to the so-called maximum ow problem, which can be solved exactly numerically with the help of a combinatorial optimization algorithm. The community structure is then identies of from the ground state Ising spin domains for all pairs of s and t. Our method provides a criterion for the existence of the community structure, and is applicable to unweighted and weighted networks equally well. We demonstrate the performance of the method by applying it to the B arabasi-A bert network, Zachary karate club network, the scientic collaboration network, and the stock price correlation network.

I. IN TRODUCTION

The network theory is a useful tool for the study of complex systems. Universal features of some biological, social, and technological systems have been studied through their network structure [1, 2, 3]. Recent studies have revealed that some complex networks have the community structure, which means that highly interconnected nodes are clustered in distinct parts. The community may represent functional modules in biological networks [4, 5, 6, 7], industrial sectors in economic networks [8, 9], and cliques of intim ate individuals in social networks [10].

Recently various methods have been suggested for nding out the community structure in a given network [11]. Girvan and Newman proposed an algorithm based on iterative rem oval of links with the highest betweenness centrality [10, 11, 12]. The betweenness centrality of an edge is given by the number of the pathways passing through it among shortest paths between all node pairs [13]. Nodes in di erent com munities, if any, would be connected through rare inter-community links. Hence one could isolate com munities by removing links with the highest betweenness centrality repeatedly. Sim ilarm ethods were also considered in Refs. [14, 15, 16]. Optim ization techniques were also considered to nd out the com munity structure. In those approaches, the community structure is found by optim izing an auxiliary quantity, such as the modularity [17, 18]. Some physical problem s turned out to be useful in detecting the community structure. For example, the q-state Pottsm odel [19], the random walks [20], and the electric circuit problem [21] were studied.

Those methods proved to be successful in detecting existing communities. On the other hand, it would be desirable to develop a method which can not only detect the community structure but also verify its existence. M ost algorithms developed are suitable for unweighted networks, whereas many real-world networks of interest are weighted [22]. O nem ay modify and generalize the algorithms developed for unweighted networks. However, such a generalization may not be straightforward [22]. So it would also be desirable to develop a method that works for unweighted and weighted networks equally well.

In this paper we propose a method for nding out the com m unity structure, which ful 11s the requirem ents described above. Our approach is motivated from the observation on the Zachary network, a classical example of social networks with the community structure [10]. It is an acquaintance network of 34 members in a karate club. Once there arose a conjict between two in uential m embers, which resulted in the breakup of the club into two. It is reasonable to think that the members would tend to minimize the number of broken ties, which can be accomplished by the breakup in accordance with the community structure. In fact, the resulting shape after the breakup coincides with the community structure of the original karate club network [10]. It suggests that the com m unity structure of a given network m ay be found by simulating the breakup caused by an enforced frustration am ong nodes.

We simulate the breakup by studying the ferrom aqnetic random eld Ising model (FRFIM): The Ising spins 1 are assigned to all nodes i = 1; ...; N, they ini = teract ferrom agnetically through links, and the quenched random magnetic eld B_i is applied to each spin. The ferrom agnetic interaction represents the cost for broken ties, and the random eld is to introduce the frustration. In particular, we consider the case where the positive in nite magnetic eld is applied to one spin and the negative in nite magnetic eld to another. It amounts to in posing the boundary condition that the two spins are in the opposite state. It simulates the conject as raised by the two members in the Zachary network. Then, we will identify the community structure from the ground state spin dom ain pattern of the FRF \mathbb{M} .

This paper is organized as follows. In Sec. II we introduce the FRFM in general weighted networks. The ground state problem of the FRFIM can be solved exactly with a num erical algorithm, which will be explained in Appendix. Then the method for nding out the community structure is presented. In Sec. III, we apply the method to several networks and present the results. W e conclude the paper with sum m ary and discussion in Sec.IV.

II. M ETHOD

Consider a weighted network G of N nodes. Connectivity of G can be represented with the weight matrix ;Ng, where is a prescribed weight fJ_{ij}j;j = 1; or strength of a link between nodes i and j if they are connected or $J_{ij} = 0$ otherwise. We assume that the weights are non-negative, J_{ij} 0, and that the weights are symmetric, $J_{ij} = J_{ji}$. For an unweighted network, the matrix elements take the binary value 0 or 1, and the weight matrix reduces to the usual adjacency matrix.

The FRFM on the network is de ned with the Ham iltonian

$$H = \frac{1}{2} X X B_{i i j} B_{i i j}, \qquad (1)$$

where i =1 is the Ising spin variable at each node i. The spins interact ferrom agnetically with the coupling strength fJ_{ij}g. They are also coupled with the quenched random magnetic eld fB_ig.

The FRFM model has been studied extensively in d dimensional regular lattices in order to investigate the nature of the glass phase transition (see Ref. [23] and references therein). It has also been studied to investigate the disorder-driven roughening transition of interfaces in disordered media [24]. The phase transition in the FRFM on complex networks would also be interesting, which has not been studied so far. The issue will be studied elsewhere [25].

The specic feature of the FRFM depends on the distribution of the random eld fB_ig. In this work, we consider the simple yet inform ative magnetic led distribution given by

for certain two nodes s and t. It am ounts to im posing the boundary condition that s = +1 and t =1, which induces frustration among nodes. This specic random eld distribution is adopted in order to m in ic the con-

ict as in the Zachary network. In the ground state nodes are separated into di erent spin dom ains, which will be related to the com m unity structure of the underlying network.




FIG. 1: Zachary karate club network. The links connecting nodes that are (not) in the same community are represented with solid (dashed) lines. The dotted lines separate the com munities.

As an explicit example, we consider the Zachary karate club network which is illustrated in Fig. 1. The node labeled as 1 (34) corresponds to the club instructor (adm inistrator). They had a con ict, which resulted in the breakup. Nodes in the side of the administrator and the instructor after the breakup are denoted with circular and rectangular symbols, respectively. W ith $J_{ij} = 1$ for all links and the magnetic eld given by Eq. (2) with s = 1 and t = 34, one can study the FRFIM on the network. Solving the ground state problem, we found that it has the degenerate ground states: The black (white) nodes belong to the + () spin dom ain in all ground states, while the gray nodes (3, 10, 29) m ay belong to either dom ain. Note that the spin dom ains alm ost coincide with the actual shape of the network after the breakup; all black (white) nodes are in the side of the administrator (instructor). The gray nodes are in the marginal state. It is reasonable to think that they do not belong to any community. In the previous work [10], the node 3 was m isclassi ed. Our result hints that it is due to the m arginality.

The example clearly shows that the FRFM is useful in nding out the community structure. For general application, (i) one needs to know the ground state (s) of the FRFM of Eq. (1) with the quenched random magnetic eld given in Eq. (2) for any node pair of s and t. Then, one needs to identify the set of all nodes that belong to the same spin domain as s and t in all ground states. Those sets will be called the cliques and denoted by C_s and Ct, respectively. The number of nodes in the clique C will be called the clique size and denoted by jCj. (ii) M ore importantly, one needs to specify the node pair s and twhich is relevant to the community structure. An arbitrary choice of s and twill not provide any inform ation on the com m unity structure. For example, if we take s = 12 and t = 15 in the Zachary network in Fig. 1, we obtain that $C_s = f12g$ and all other nodes are in C_t . This m erely m eans that the node 12 is a peripheral node.

For (i), the ground state problem of the FRF \mathbb{M} can be

solved exactly with the help of a num erical combinatorial optim ization algorithm (see Appendix). This is achieved by mapping the ground state problem onto the minimum cut problem or the maximum ow problem [26]. The algorithm allows us to nd all ground states, with which we can nd the cliques C_s and C_t for any pair of s and t. We explain the detailed procedure in Appendix.

For (ii), the community structure can be found from the distribution of the clique sizes for all pairs of s and t. For a certain pair of s and t, one may have that jC₅j Ψj 0 (1) N. It happens when s and t are peripheral nodes of the network; most nodes are not inuenced by them. Such a pair does not provide any inform ation on the community structure. One may have that O (N). This happens when s is a ĴC₅j 0 (1) ſфј peripheral node while t is inside the bulk. The cliques Cs and Ct do not correspond to a community either. On the contrary, one m ay have that 0 (1) ĴC₅j Ģj O (N). This happens only when there exist communities whose sizes are of the order of N , s and t are chosen among inuential" nodes in di erent communities. In this case, we will regard the cliques C_s and C_t as the communities in the network.

In order to distinguish the di erent cases, we de ne the $\separability" D_{st}$ for a node pair s and t as the product of the clique sizes,

It ranges in the interval 1 Dst $N^2=4$. W e propose that the community structure be detected with the distribution of the separability D_{st} for all pairs of s and t. If D_{st} . O (N) for all pairs of s and t, then we conclude that the network has no community structure. On the $O(\mathbb{N}^2)$ for a certain pair of s and other hand, if D_{st} t, then we conclude that the network consists of com munities that can be identi ed from the cliques $C_{\rm s}$ and $C_{\rm t}$. M oreover, the nodes s and t m ay be regarded as in uentialnodes of the com m unities. Therefore, in our m ethod, the existence of the community structure is veried with the scaling behavior of the maximum value of the separability with the network size.

For a given network size N, the scaling can be exampled with the quantity $\ln D_{st} = \ln N$. W ithout the component munity structure, it would be close to orm uch less than 1 for all node pairs. A node pair with $\ln D_{st} = \ln N > 1$ indicates the presence of the community structure.

III. RESULTS

We test the method by applying it to the Barabasi-A lbert (BA) network [27], the Zachary karate club network [10], the scientic collaboration network [10], and the stock price correlation network [28]. In each network, the separability was calculated for all node pairs, and the separability distribution was exam ined with a so-called rank plot, where [nD = lnN] is plotted against a norm alized rank of each node pair. The rank is assigned to each




FIG.2: The rank plot for the separability distribution for the BA network (a), the Zachary karate club network (b), the scientic collaboration network (c), and the stock price correlation network (d).

node pair in the ascending order of the separability. It is then norm alized so that the rank of the pair with the maximum value of the separability is equal to 1.




FIG.3: (Coloronline) The community structure of (a) the BA model network (N = 100), (b) the Zachary karate club network (N = 34), (c) the scientic collaboration network (N = 118), and (d) the stock correlation network (N = 137). Nodes in di erent communities are distinguished with color. The white symbols represent the marginal nodes.

The BA network is an unweighted network. It is known that the BA network does not have a community structure. We grew a BA network of N = 100 nodes, and calculated the separability D_{st} for all node pairs. The separability distribution is presented with the rank plot in Fig. 2 (a). We nd that the separability is clustered at D_{st} = 1 and near D_{st} ' N for all pairs of s and t, hence $\ln D_{st} = \ln N$. 1. This con rm s that the BA network does not have the community structure (see Fig. 3 (a)), and dem onstrates what the separability distribution looks like for networks without the community structure.

Next we study the separability distribution of the Zachary karate club network of N = 34 nodes, which is presented in Fig. 2 (b). We found that D_{st} . N for all node pairs but (1;34) and (1;33). For the pairs (s;t) = (1;33) and (1;34), we obtained the same cliques, C_s of 15 nodes and C_t of 16 nodes, which are marked with the black and the white symbols in Fig. 1, respectively (see also Fig. 3 (b)). Therefore we can conclude that there exist two communities in the network and that the nodes 1 and 34 are of the other community. In fact the administrator, respectively. The detected communities are in good agreement with the network shape after the breakup.

W e also investigate the community structure of a larger and m one complex network. We exam ine the unweighted collaboration network of N = 118 scientists in the Santa Fe Institute [10]. In this network, two nodes (scientists) are linked if they coauthored at least one article. The rank plot is presented in Fig. 2 (c). One can see that the separability is distributed broadly, which indicates that the network has multiple (more than two) communities.

In such a case, the communities can be identied by applying our method hierarchically: First of all, one can nd the node pair $(s_0;t_0)$ with the largest separability, and the corresponding cliques C_{s_0} and C_{t_0} . The clique may consist of a single community or be the union of several sub-communities. In order to investigate the substructure, one constructs the sub-network which consists of all nodes and links within each clique. Then, one can apply the method to the sub-networks. This can be performed hierarchically until a sub-network does not have the community structure any more. Or one may proceed with the iteration only when the subnetwork size is equal to or larger than a threshold value m. The resulting cliques can then be identied as communities up to a resolution m.

W ith the hierarchical application of our method, we nd the community structure of the scientic collaboration network as shown in Fig. 3 (c). Here, we identify all communities whose size are equal to or larger than m = 5. The community structure is in good agreement with that found in Ref. [10].

O ur m ethod is also applicable to weighted networks. As an example of weighted networks, we study the econom ic network of 137 companies in the New York Stock Exchange market. The network is constructed through the stock price return correlation between the companies for the 21 year period from 1983 to 2003 [28]. W ith the stock price $P_i(t)$ of a company i at time t, the return is given by $R_i(t) = \ln P_i(t+t) - \ln P_i(t)$ with the unit time interval t taken to be one day. Then, the stock price correlation is given by

$$C_{ij} = q \frac{h(R_i \quad hR_ii)(R_j \quad hR_ji)i}{(hR_i^2i \quad hR_ii^2)(hR_j^2i \quad hR_ji^2)};$$

where the angular bracket indicates the tim e average over the period. Its value ranges in the interval 1 G_{ij} 1, and is large for strongly correlated company pairs. It has been shown that the structural information of the economic system is encoded in the correlation matrix fC_{ij}g [8, 29].

In order to apply our method, all weights are required to be non-negative. Hence, we assume that the weight is given by $J_{ij} = e^{aC_{ij}}$ with a positive constant a taken to be 20. The weights are positive for all pairs of nodes, and the econom ic network is fully connected. The separability distribution is shown in the rank plot in Fig. 2 (d). As in the collaboration network, there are several nontrivial separability levels. W e identi ed all com m unities whose size is equal to or larger than 3 with the sam e hierarchical method as in the collaboration network. The resulting shape of the network is illustrated in Fig. 3 (d). We con med that the communities are formed by companies in the same industrial sector. For example, the largest com m unity consists of 13 com panies in the energy sector. This study shows that our method works well for weighted networks. We note that m any nodes (white

sym bols) rem ain unclassi ed. W e attribute it to the fullyconnectedness of the network.

IV. CONCLUSIONS

In this paper we have proposed the method for nding out the community structure of general networks. It is achieved by studying the ground state problem of the FRFM on the networks with the magnetic eld distribution given in Eq. (2) for two arbitrary nodes s and t. The cliques $C_{\rm s}$ and $C_{\rm t}$ are de ned as the sets of all nodes that belong to the sam e spin dom ains as s and t in all possible degenerate ground states, respectively. The com m unity structure is then m an ifested in the clique pattem for the pair with the maximum value of the separability D_{st} de ned in Eq. (3). Our method is motivated from the observation on the Zachary karate club network, which shows that the resulting shape of the network after breakup is determ ined by the underlying community structure. In our m ethod, the response of the networks subject to schism is simulated with the FRFIM.

In our method one can verify the existence of the community structure of a given network with the scaling property of the separability: If the separability scales as D_{st}. O (N) for all node pairs as in the BA network, the network does not have the community structure. On the other hand, if D_{st} O (N²) for a certain pair of s and t, one can conclude that the network has the community structure and that the nodes s and t are in uential nodes in each community. A nother advantage of our method is that it can be applied to both unweighted and weighted networks. Figure 3 shows the perform ance of the method in real-world networks.

O ne of the weak points of our method is the time com -

plexity. Practically the ground state problem of the FR-FIM in sparse networks of N nodes has the time com plexity of O(N) with '12 [26]. Since one has to solve the ground state problem s for all magnetic eld distributions, the total time com plexity scales as O(N²⁺). Hence, in the practical sense, our method is limited to networks of up to a few thousands of nodes. One may avoid the time com plexity problem if the important nodes are known a priori. In the network theory, importance of nodes can be measured by, e.g., the degree or the betweenness centrality. Hopefully the community structure of large networks can be studied if one incorporates such importance measure into our method.

APPENDIX A:M IN IM UM CUT AND MAXIMUM FLOW PROBLEM

This Appendix is intended to introduce the combinatorial optimization algorithm solving the ground state problem of the FRFIM.Formore rigorous description, we refer the readers to Ref. [26].

Consider a network G of N nodes with the symmetric weight matrix fJ_{ij} 0g (i; j = 1; ;N). The ferm agnetic random eld Ising model on G is de ned by the Hamiltonian in Eq. (1) with the quenched random magnetic eld fB_ig. The ground state is the spin con-

guration that has the minimum energy among all 2^N congurations. One might nd the ground state by enumerating all spin congurations, which is obviously time consuming and ine cient. We will explain the ecient way for solving the ground state problem.




FIG.4: (a) A network G with 4 nodes (led circles) and 4 links (lines) for the FRFIM.Figures represent the magnetic elds and the interaction strengths, respectively. (b) The corresponding capacitated network G⁰ with the link capacities. (c) Them aximum - ow con guration with $v^2 = 8$. The dotted lines represent saturated links with $x^2 = c$. The dashed lines X, Y, and Z represent boundaries associated with ST-cuts.

It is useful to introduce a capacitated network denoted by G⁰: Having all nodes and links of G, G⁰ contains two additional nodes S, called the source, and T, called the sink, and additional links between the source (sink) and the nodes with the positive (negative) magnetic eld. G⁰ is also a weighted network with the symmetric weight matrix fc g (; = S;T;1; ;N). For a link (ij) is the original network G, the weight is given by $c_{ij} = 2J_{ij}$. For the additional link the weight is given by $c_{si} = B_i$ for all i with $B_i > 0$ and $c_{iT} = \beta_i$ j for all i with $B_i < 0$. The weight of the network G⁰ is usually called the capacity. Figure 4 illustrates the relation between a network G of four nodes fa;b;c;dg and the corresponding capacitated network G⁰.

In the capacitated network G 0 we de ne a ST-cut as a decomposition of all nodes into two disjoint sets S and T with S 2 S and T 2 T. It will be denoted by [S;T]. For a given [S;T], some links connect nodes in the di erent

sets. The set of such links form s the boundary of the cut, which is denoted by (S;T) = f() j 2 S; 2 Tg. The cut capacity C [S;T] is then de ned as the total sum of the capacity of the boundary links, that is,

$$C [S;T] = C : (A1)$$

Figure 4 shows some examples of the cut. The boundary denoted by X is associated with a cut [fS;a;b;cg;fT;dg], whose cut capacity is 14.

There exists one-to-one correspondence between the Ising spin con guration on the weighted network G and the cut [S;T] of the capacitated network G^0 . It is achieved by assigning $_i = +1(1)$ for all nodes i in S (T) and vice versa. Hence, the sets S and T correspond to $_{\rm Up}$ and down spin dom ains, respectively, and the boundary (S;T) corresponds to the spin dom ain wall. Furtherm ore, one can easily verify that the energy E of the FRFIM of a spin con guration f $_i$ g and the cut capacity C [S;T] satisfy the relation

$$E (f_{ig}) = C [S;T] + E_0$$

where $E_0 = P_{i;j} J_{ij} = 2_{i} B_{ij} = 2$. Therefore, solving the ground state of the FRFIM on G is equivalent to nding the optimal ST-cut on G⁰ whose cut capacity is minimum. It is called the minimum cut problem.

The minimum cut problem can be further mapped on to the maximum ow problem: On the capacitated network G^0 , a ow is to denote a set of ow variables fx g ;N). For a link (ij) from de ned for all links in G^0 which are subject to a capacity given by $c_{ij} = 2J_{ij}$. constraint

Here r^{0} m eans a sum over all adjacent nodes of , () denotes the K ronecker symbol, and v is a non-negative

parameter. The mass balance constraint allows us to interpret the ow fx gasa conserved ux con guration of a, e.g., uid which is originated from the source S by the amount of v and targeted to the sink T through the network G^0 .

D ue to the capacity constraint, there exists the upper bound in v, beyond which a ow satisfying Eqs. (A 3) and (A 4) does not exist. Then, the question that arises naturally is to nd the maximum value v^2 and the corresponding ow fx² g that can be delivered. This is the maximum ow problem.

The celebrated max- ow /m in-cut theorem of Ford and Fulkerson [30] states that for a given capacitated network G⁰, the maximum ow v² is equal to the minimum cut capacity, that is to say,

$$v^{2} = \min_{[S;T]} C [S;T]$$

The rigorous proof of the theorem can be found elsewhere [26]. Intuitively the theorem states that the maximum ow is limited by the bottleneck in the network whose capacity is given by the minimum cut capacity.

The maximum ow problem can be solved numerically in a polynomial time with the augmenting path algorithm or the pre ow-push/relabel algorithm [26, 30]. In the augmenting path algorithm, one repeatedly searches for a path from S to T via unsaturated (x < c) links and updates fx g by augmenting ow s along the path. W hen the augmenting path does not exist any more, the resulting ow corresponds to the maximum ow con guration. The pre ow-push/relabel algorithm is a more sophisticated and e cient algorithm.

Once the maximum ow conguration fx[?] g is found, the minimum cut is constructed easily. Let S_S be the set of all nodes of G⁰ that can be reachable from the source S only through unsaturated (x[?] < c) links. Trivially, S_S does not include the sink T, since there does not exist any augmenting path in the maximum ow conguration. Hence, the set S_S and its complement $\overline{S_S}$ de nes a cut $[S_S; \overline{S_S}]$, which is indeed a minimum cut of G⁰.

One may not the minimum cut alternatively. Let $T_{\rm T}$ be the set of all nodes of G 0 that can be reachable from the sink T only through unsaturated links. Then, $T_{\rm T}$ and its complement $\overline{T_{\rm T}}$ denes a cut $[\overline{T_{\rm T}};T_{\rm T}]$, which is also

the minimum cut.

The two cuts $[S_S; \overline{S_S}]$ and $[\overline{T_T}; T_T]$ may be different, which implies that the corresponding FRFIM has degenerate ground states. In that case, all degenerate ground states can be found system atically [26]. In this work, we are interested in the spins that are xed in all ground states. One can easily verify that all nodes i 2 S_S (T_T) except for S (T) are in the spin state $_i = +1$ (1) in all ground states. The other nodes $j \ge S_S$ and T_T may be in either state $_j = -1$.

We provide an example illustrating the mapping between the FRFIM and the maximum ow or the minimum cut problem in Fig. 4. The maximum ow conguration is depicted in Fig. 4 (c) with the maximum ow $v^2 = 8$. The links drawn with dotted lines are saturated ($x^2 = c$). The sets of all nodes that are reachable from S and T through unsaturated links are given by $S_S = fS$; ag and $T_T = fT$; b; dg. They yield the minimum cuts [S_S ; $\overline{S_S}$] and [$\overline{T_T}$; T_T] whose boundaries are Y and Z, respectively. Hence, one nds that $_a = +1$ and $_b = _d = 1$ in all degenerate ground states. The node c does not belong to neither S_S nor T_T . Hence $_c$ may be either +1 or 1.

In the present work, we consider the FRFIM on a weighted network G with the speci c magnetic eld distribution given in Eq. (2) for a certain node pair s and t. Then, we need to nd the clique C_s (C_t) of s (t) which is the set of all nodes that are in the same spin state as s (t) in the ground state. We sum marize the method to nd the cliques:

- 1. Construct the capacitated network G^{0} .
- 2. Find the maximum ow con guration fx[?] g using the num erical algorithm s.
- 3. Find the set $S_{\rm S}$ ($T_{\rm T}$) of all nodes that are reachable from S (T) through unsaturated links with x 2 $\,<\,$ c $\,$.
- 4. Then, the cliques are given by $C_s = S_S$ fSg and $C_t = T_T$ fTg.

A fier noting the cliques, the community structure can be investigated with the method explained in Sec. II.
