Berry phase of magnons in textured ferromagnets

We study the energy spectrum of magnons in a ferrom agnet with topologically nontrivial magnetization pro le. In the case of inhom ogeneous magnetization corresponding to a metastable state of ferrom agnet, the spin-wave equation of motion acquires a gauge potential leading to a Berry phase for the magnons propagating along a closed contour. The elect of magnetic anisotropy is crucial for the Berry phase: we show that the anisotropy suppresses its magnitude, which makes the Berry phase observable in some cases, similar to the Aharonov-Bohm elect for electrons. For example, it can be observed in the interference of spin waves propagating in mesoscopic rings. We discuss the elect of domain walls on the interference in ferrom agnetic rings, and propose some experiments with a certain geometry of magnetization. We also show that the nonvanishing average topological eld acts on the magnons like a uniform magnetic eld on electrons. It leads to the quantization of the magnon spectrum in the topological eld.

I. INTRODUCTION

The Berry phase theory^{1,2,3} allowed to generalize the idea of A haronov-B ohm e ect⁴ on electrons in the electrom agnetic potential, to an analogous e ect related to a gauge potential, which arises during the adiabatic motion of a quantum system in a parametric space. Up to now a lot of e orts has been directed to understand better and to nd an experimental con mation for the Berry phase of electrons like, for example, in the case of electrons moving in a varying magnetization eld of the inhom ogeneous ferrom agnet.^{5,6}

One of the most intriguing consequences of the Berry phase theory is a possibility of the Aharonov-Bohm-like e ect on electrically neutral particles or boson elds. ^{7,8} An example of the adiabatic phase for the polarized light has been investigated by Pancharatnam ⁹ and Berry. ¹⁰ The other example is the Aharonov-Bohm e ect for the exciton, ¹¹ which is a bound state of an electron and a hole in semi conductors.

Here we consider the elect of the gauge potential and Berry phase on the propagation of magnons in textured ferrom agnets. Such quasiparticles are usually viewed as the elementary excitations of the ordered homogeneous state of a ferrom agnet but they can be also used to classify the excited states near a metastable inhomogeneous magnetic conguration. These magnons describe the dynamics of weakly excited inhomogeneous ferrom agnet.

The dynam ics of magnetization in nanomagnets is in the focus of recent activity¹² because of the importance of this problem for magnetoelectronic applications.^{13,14} It includes the switching of magnetization by electric current, spin pumping, magnetization reversal in microscopic spin valves, etc. U sually, the magnons play a negative role in the magnetization dynamics limiting the frequency of magnetic reversal, and also leading to the energy dissipation. However, they can be probably used in

the spin transport phenomena like the spin currents of magnetically polarized electrons.

Here we study the energy spectrum of spin waves in ferrom agnets with a static inhom ogeneous magnetization pro le, and we dem onstrate a possibility of observation of the Berry phase in the interference experiments on spin waves in magnetic nanostructures. Recent results of the micromagnetic computer simulation 15,16,17 of such systems demonstrate that the interference of spin waves can be really observed in magnetic nanorings with domain walls.

The equation for spin wave excitations in a general case of arbitrary local fram e depending on both coordinate and time, has been found long ago by K orenm an et al 18 in the context of local-band theory of itinerant magnetism 19 H ere we use an idea of this method to relate the adiabatic space transform ation to the Berry phase and to nd corresponding properties of the spin waves in a topologically nontrivial inhom ogeneous magnetic prole, which is a metastable state of the ferrom agnet. We

show that the magnetic anisotropy is a crucial element determining the possibility of observation of the Berry phase in real experiments.

II. M ODEL AND SPIN W AVE EQUATIONS

We consider the model of a ferrom agnet described by the Ham iltonian, which includes the exchange interaction, anisotropy, and the interaction with external magnetic eld. It has the following general form

where n (r) is the unit vector oriented along the magnetization M (r) at the point r, a is the constant of exchange

interaction, F fn (r)g is a function determ ining the m agnetic anisotropy [correspondingly, it includes a certain number oftensors relating the components of vectorn (r)] and the dependence on external eld, and M $_{\rm 0}$ is the magnitude of magnetization.

Due to the condition $n^2(r)=1$, the model is constrained and belongs to the class of nonlinear models. The stationary (saddle point) solutions for the magnetization vector $n_0(r)$ describing metastable states of the ferrom agnet, can be found by minimizing Hamiltonian (1) with the constraint $n^2(r)=1$. It was shown (see, e.g., Refs. [21,22]) that such metastable states with inhom ogeneous magnetization prole are related to the topology of ferrom agnetic ordering, and they can include skyrmions, magnetic vortices, and other topological objects.

We will be interested in describing the dynam ics of small deviations n(r) from a certain metastable pro le $n_0(r)$ with a nonuniform magnetization, $n(r) = n_0(r) + n(r)$, j n(r) j 1. Correspondingly, we assume that the solution of a saddle-point equation describing the state $n_0(r)$ is already known.

We perform a local transform ation

using the orthogonal transform ation matrix R (r). By de nition, it determ ines the rotation of local frame in each point of the space, so that the magnetization in the local frame is oriented along the z axis, $\mathbf{r}_0 = (0;0;1)$. Then we consider small deviations of magnetization s (r) from \mathbf{r}_0 . Since s(r) is small and vectors \mathbf{r}_0 are oriented along z, the vectors $\mathbf{s}(r)$ lie in the x-y plane.

The transform ation matrix in Eq. (2) is taken in a general form of orthogonal transform ation

where , , are the Euler angles determ ining an arbitrary rotation of the coordinate frame, and J_x , J_y , and J_z are the generators of 3D rotations around x, y and z axes.

Two rotation parameters (for de niteness, the angles and) can be used to de ne the frame with the z axis along the vector \mathbf{n}_0 (r). In the absence of anisotropy, the additional rotation to the angle is purely gauge transform ation. However, in a general case of anisotropic system, this rotation allows to choose the local frame in correspondence with the orientation of anisotropy axes.

The Ham iltonian of exchange interaction (the rst term in Eq. (1)) in the rotated frame has the following form

Transform ation (3) and gauge potential (5) are 3 $\,$ 3 m atrices acting on the magnetization vectors. The matrix $A_i(r)$ can be also presented as

where A_{i} (r) belongs to the adjoint representation of the rotation group.

U sing (3) and (6), we nd the explicit dependence of the gauge potential on the Euler angles

The magnetic anisotropy described by the second term in the right hand part of (1) gives after transform ation to the local frame a function F^* for (r)g with correspondingly transformed tensor elds. Here we do not restrict the general consideration of the problem by any species form of the anisotropy but in the following we consider the most important examples of easy plane and easy axis anisotropy.

The Landau-Lifshitz equations for the magnetization in the locally transformed frame are

where is the unit antisymm etric tensor, and

is the covariant derivative. The right-hand part of Eq. (8) vanishes for the magnetization pro le corresponding to a metastable state. This is seen from the Landau-Lifshitz equation in the unrotated original frame. In the following, we will use Eq. (8) for the small deviations of magnetization from the metastable state. Hence, we will consider in the right part of (8) only the terms linear in deviations.

U sing (1), (4) and (8) we nd the equations for weak magnetic excitations near the metastable state (spin waves)

Using (10) and (11) we can also present the equations for circular components of the spin wave, $s = s_x$ is,

where V (r) and w (r) are, respectively, the e ective potential and a mixing eld acting on the spin wave:

Equations (12) for s_+ (r;t) and s (r;t) are complex conjugate to each other since they both describe the same spin wave with real components s_x (r;t) and s_v (r;t).

We can see that V (r) is an elective potential prole for the propagation of spin wave. Due to the term sw (r) and $ic_s A_i^x A_i^y$ in (12), the equations for circular components s_+ and so are coupled even in the absence of an isotropy. All these terms are of the second order in derivative of the rotation angle, and they are small in the adiabatic limit corresponding to a smooth variation of the magnetization vector n(r).

III. SEM IC LASSICAL APPROXIMATION

Equations (10) and (11) can be solved in the sem iclassical approximation. The condition of its applicability is a smooth variation of gauge potential ${\bf A}_i$ (r) and elds related to the anisotropy, as well as the external magnetic eld, at the wavelength of the spin wave, kL ${\bf 1}$, where k is the wavevector of the spin wave and L is the characteristic length of the variation of ${\bf A}_i$ (r) and F fn (r)g (more exactly, the minimum of the corresponding characteristic lengths). Note that the condition of applicability of the semiclassical approximation to solve the spin-wave equations, does not require any smallness of the gauge potential itself.

Starting from Eqs. (10) and (11), we look for a general sem iclassical solution in the form

with arbitrary coe cients a, b, d, f, and a smooth function (r), so that we can neglect the second derivative of (r) over coordinate r. Substituting (15) and (16) in (10) and (11), we can not four equation for the a, b, d, f coe cients.

The solution (15), (16) describes the elliptic spin wave with an arbitrary choice of the axes x and y, and, generally, with a varying in space orientation of the principal axes of the ellipse. We can simplify our consideration by choosing the angle (r) at each point of the space in accordance with the orientation of the principal axes. The corresponding equation for (r) can be found from the condition of b = f = 0 in Eqs. (15) and (16)

U sing (17) and neglecting the term s with derivative of A $_{1}^{z}$, which are small in the semiclassical approximation, we write the spin-wave equations (10) and (11) as

Note that by xing the angle in Eq. (17), we are choosing the gauge, which de nescompletely the potential A $_{\rm i}$. We do it in spirit of the usual xing gauge in the WKB approximation.

A fler substitution of (15) and (16) with b= f=0 into (18) and (19), we come to the following equation for the momentum $k_{i}(r)$ @ (r)=0 f

Equation (20) should be solved for k_i (r) as a function of sm ooth inhom ogeneous eld A_i (r). This equation does not constraint the orientation of k (r) but determ ines the magnitude of vector k (r) for each direction in the momentum space. Let us take vector k (r) along

an arbitrary direction, de ned by a unity vector g. Then we can rewrite (20) as

and we come to the fourth-order algebraic equation for $k\left(r\right)$. It can be solved numerically, and a resulting dependence of $k_{i}\left(r\right)$ on the gauge eld in the integral $\left(r\right)=\ _{C}\ k_{i}\left(r\right)dr_{i}$ leads to the Berry phase acquired by the spin wave propagating along the contour C .

We can not the solution of Eq. (22) analytically in the limit of weak gauge potential $^{\star}\!\!\!/ A_i^z j = k$, which corresponds to the adiabatic variation of the magnetization direction n (r) and also the adiabatic rotation in space of the elliptic trajectory, $^{\star}\!\!\!/ B_i^z = ^{\star}\!\!\!\!/ B_i^z = ^{\star}\!\!\!\!/ B_i^z$ we nd

As follows from (24), the Berry phase $_{\rm B}$ (C) in the anisotropic system acquires an additional factor

 $1 + p^2 = !^2$ $^{1=2}$ depending on the magnetic anisotropy parameter p.

The denominator in (24) has a simple geometrical interpretation. Indeed, the coecients a and d in the semiclassical solution (15), (16) are the ellipse parameters, which are related to the anisotropy factor p

In this expression we extracted a term proportional to 2 N , N 2 Z . This allows to avoid the multivaluedness of Berry phase in the absence of an isotropy when = 1.23

The 1st term in (27) is proportional to the total winding num ber of rotations associated with the angles and , whereas the second term is a spherical angle on S2, which is the mapping space of the vector eldn (r). The second term in (27) has a standard interpretation of the Berry phase as the magnetic ux penetrating the contour on S2, when the eld is created by monopole at the center of Berry sphere. Following this idea, one can interpret the rst term in (27) as the ux created by the magnetic string along the z axis, penetrating through the mapping contour on the unit circle.²³ In accordance with Eq. (27), this contribution to the Berry phase vanishes for isotropic magnetic system $s_r = 1$. The rst term in (27) is the topological Berry phase (it depends only on the winding number) in contrast to the geometric Berry phase of the second term in (27).23

As follows from (24), the elective gauge eld for spin waves in the anisotropic system is $\tilde{A}_i = \tilde{A}_i^z$, and the corresponding topological eld acting on the magnons can be calculated as the curvature of connection $\tilde{A}_i(r)$

Note that there is a contribution related to the variation in space of the anisotropy parameters [second term in Eq. (28)].

We consider now in more details the motion of elliptic spin wave in the adiabatic regime. The anisotropy suppresses one of the components s_x or s_y breaking the symmetry with respect to rotations around z axis. Correspondingly, there is no gauge invariance s_+ ! $e^{i'}s_+$ and s_- ! $e^{i'}s_+$ for the circular components, and the motion ofmagnetization in the spin wave is elliptical. In the adiabatic limit of A_i^z is k, the solutions for s_x and s_y are given by Eqs. (15) and (16) with b=f=0 and the ratio of amplitudes (a=d). Thus, we could expect the local invariance to transform ations preserving the value of s_x^2 + (d=a) $^2 s_y^2$ = const instead of simple rotations in x y plane.

Using the Fourier transform ation of Eqs. (18) and (19) for $s_{x,y}$ we not the following equation for the elliptic components of spin wave, $s = s_x$ i(d=a) s_y

Equation (31) contains a factor < 1 before A_i^z and form ally looks like the equation of motion of a particle moving in the reduced gauge eld, which in turn leads to an elective suppression of the Berry phase. The calculation of Berry phase using Eq. (31) with the gauge eld suppressed by factor leads us again to Eq. (24).

In the absence of anisotropy and in the adiabatic approximation, the solution of spin wave equations has a simple form. The equations for circular components (12) are separated

It does not depend on the angle $\,$, related to the choice of gauge like in the case of electrom agnetism .

By creating a certain metastable con guration of the magnetization $n_0\left(r\right)$ in the ferrom agnet, we simulate an elective gauge potential $A_i^c\left(r\right)$, acting on the spin waves similar to the magnetic eld in case of electrons. In particular, when the averaged in space topological eld (28) is not zero, there arises the Landau quantization of the energy spectrum of magnons. In the absence of anisotropy, we not the quantized spectrum $h!_n = 2hc_s$ $h!_i(n+1=2)$, where h::im eans the average in space.

IV. INTERFERENCE OF SPIN WAVES IN MESOSCOPIC RINGS




FIG.1: Two rings with topologically nontrivial magnetization eld.

Let us consider now the ring geom etry of a ferrom agnet with a topologically nontrivial m etastable m agnetization n_0 (r). It can be, for example, a m agnetization vortex (Fig. 1a) or an even number of domain walls in one branch of the ring like presented in Fig. 1b. Such a magnetization pro le presents a metastable magnetic state.

Let us consider is the case when there is no anisotropy. If kL 1 (adiabatic regime), the lowenergy m agnetic excitations of the m etastable state are described by Eq. (32). Due to the presence of gauge potential A z (r), there is a phase shift of waves propagating from the point A, where the waves are excited, to the observation point B (see Fig. 1). The phase shift (Berry phase) equals to the integral ~ A $_{i}^{z}$ (r) dr_{i} along the ring, and by using Stokes theorem can be calculated as the ux oftopological eldB de ned in Eq. (34). It can be also presented as the spherical angle enclosed by the mapping of the ring to the circle at the unit sphere S_2 . This way we can not the phase shift of 2 and Nd for Figs. 1a and 1b, respectively, where an even N_d is the number of dom ain walls in the right arm of the ring. For example, in the case of Fig. 1b with two domain walls in the right arm, there is no interference of spin waves excited in A and coming to the point B because the corresponding




FIG. 2: M apping of the ring to the n-space S_2 (red contour) in the case of in-plane vortex m agnetization shown in Fig.1a (a) and for the same geometry with m agnetization vector deviating from the plane to the angle (b). The Berry phase is 2 in case (a) and for = =6 in case (b).

In the absence of anisotropy, the interference in the ring can be induced by rotating all magnetic moments from the plane to a certain angle (the corresponding mapping is presented in Fig.2b). The Berry phase associated with the path along the ring will be smaller than 2. For = =6 the Berry phase turns out to be. It means that the experiment with interference of spin waves propagating from A to B through two dierent arms of the ring, would result in a complete suppression of the outgoing from B spin wave. Physically, it can be realized using the ring with very small easy-plane anisotropy, p=! 1 in a weak external magnetic eld along z axis.

phase shift is 2 .

A sim ilar idea was recently proposed by Schutz et al^{25} for the radial orientation of magnetic moments under inhomogeneous magnetic eld directed from some point at the axis of the ring. This magnetic eld creates a "crown" of magnetic moments, and the corresponding mapping is similar to that presented in Fig. 2b.

However, in the case of nonvanishing easy-plane anisotropy, there is no need to apply magnetic eld to provide the interference of spin waves propagating in the geometry of Fig. 1b. In this case the Berry




FIG. 3: Spin waves on a wide ring (thin-wall cylinder made of easy-plane ferrom agnetic ribbon). The magnetization is along axis z.

phase is given by Eq. (27) with $p=2M_0=const$, and we obtain the di erence in phases for two waves $B=N_d=(1+p^2=!^2)^{1=2}$. Thus, the interference of spin waves should be clearly seen for the two-arm geometry with domain walls. The computer simulation experiments 17 con 120 m this expectation.

A nother possibility to observe the interference of spin waves can be presented by the geometry of a wide ring (thin-wall cylinder) like presented in Fig. 3. Assuming the easy-plane anisotropy of the ribbon, we obtain the ground state with a homogeneous magnetization along the axis of cylinder. The anisotropy axis is oriented radially in each point of the cylinder, and the corresponding

local fram e is shown in the gure as $x^0y^0z^0$. Due to the hom ogeneous magnetization, we get = 0, and from (7) we obtain $A_i^z(r) = 0 + e^2r_i$. The components of anisotropy vector are $u_x = cos'$ and $u_y = sin'$. U sing Eq. (34) we not that the condition $a_y = 0$ reduces to $e^2 + e^2r_i$, and from (34) we obtain $a_x = 1$. Correspondingly, the anisotropy parameter $e^2 = e^2 + e^2r_i$, and we obtain the Berry phase for the closed contour on the ring $e^2 + e^2r_i$. Were $e^2 + e^2r_i$ is the winding number of the contour C.

The Berry phase of the spin wave propagating in magnetic ring, plays the sim ilar role as the phase of electron wavefunction in the Aharonov-Bohm e ect with magnetic ux penetrating through the ring. The role of magnetic ux plays a string through the ring. The wever, the ux created by the string does not depend on the size or shape of the magnetic ring. Correspondingly, the Berry phase associated with the string has the topological origin, which makes it dierent from the Aharonov-Bohm e ect induced by the magnetic-eld ux thorough the conductive ring.

V. SPECTRUM OF MAGNONS IN A RING WITH UNIAXIAL ANISOTROPY




FIG. 4: Magnetization in a ring with uniaxial magnetic anisotropy in a homogeneous external magnetic eld along zaxis.

The other example is a ring with uniaxial anisotropy in a homogeneous magnetic eld B along the axis z like presented in Fig. 4. Due to the anisotropy and exchange interaction, the magnetization along the ring is oriented like in Fig. 4, creating a certain angle out of the ring plane.

We take the anisotropy function F in the form

which corresponds to the uniaxial anisotropy along the ring. The local frame is chosen with the axis z along the magnetization at each point, and with the z-x plane tangential to the ring (parallel to the axis z). In this case we nd $F' = \frac{2}{3}\cos^2 = 2$. The angles determining the orientation of local frame are = 0 and = r=R.

We can calculate the angle—using Eqs. (1) and (32) with vectors u and B along the axis z. Then, using the polar coordinates and the condition that n_r and n_z do not depend on the point along the ring, we not the energy




FIG. 5: Energy spectrum of magnons in the ring (Fig. 4) as a function of external magnetic eld B, where K = =2.

The gauge potential in magnetic ring induces the energy splitting of magnons propagating in the opposite directions. Using Eqs. (7) we nd $A^x = \sin = R$, $A^y = 0$, and $A^z = \cos$. It should be noted that the gauge potential is constant along the ring, so that there is no need to use the adiabatic approximation to determine the energy spectrum of magnons.

U sing Eqs. (10) and (11) after Fourier transform ation over time t and coordinate r along the ring, we nd

where $_0$ = B . Here the momentum takes discrete values k_n = 2 n=L (n = 0; 1; ...) to provide the periodicity of solution for the spin wave along the ring. We can use (38) to nd the equation for elliptic components of the spin wave

Then, using (43) we nd the energy spectrum of magnons in the ring

The spectrum is shown in Fig. 5 for several rst values of n as a function of the magnitude of eld B . We take the parameters: =2 = M $_0^2$ (it corresponds to the dipolar shape anisotropy of a magnetic cylinder), R = 75 nm, and R 2 =a = 200 . All the curves have a critical point B $_c$ corresponding to the magnetic eld, for which the magnetization M starts to deviate from the direction with = 0 . In view of Eq. (37), B $_c$ M $_0$ = a=R 2 . For n = 0 the energy of magnons at this point is the soft mode with ! = 0 . This mode corresponds to a uniform rotation of spins at each point of the ring toward a tangential to the ring direction. In the local frame it is the uniform rotation corresponding to the state with n = 0.

For $n \in 0$ and B : 0 we can not the spectrum in linear in B approximation

where $!_n(0) = !_n(0)$. It shows that the spectrum is degenerate at B = 0 with respect to the sign of n. The splitting for B \in 0 in linear approximation gives the curve for positive n below the one for the same negative in accordance with Fig. 5.

At large magnetic eld B, the systematics of levels should be changed. Namely, the lowest energy mode corresponds to the uniform global deviation of orientation of all spins from the direction along the z axis. In the local frame, it corresponds to the mode with n = 1. Thus, it would be natural to label the modes with index m = n 1, so that the lowest in energy is the spin wave with m = 0. In the limit of B! 1, each pair of modes misdegenerate. It is clearly seen from Eq. (41) with = 1. The splitting of these modes for B > Bc demonstrates the existence of topological Berry phase for the magnons on the ring because the equilibrium state is the homogeneous magnetization, which leads to the vanishing of geometric Berry phase.

VI. CONCLUSIONS

We calculated the Berry phase associated with the propagation of magnons in inhomogeneous ferromagnets

and m esoscopic structures with topologically nontrivial magnetization pro le. We found that the most important e ect is related to the magnetic anisotropy. Due to the anisotropy, the Berry phase for magnons is lower than a standard value of the spherical angle on the Berry sphere with a monopole. Besides, an additional contribution to the Berry phase arises in anisotropic systems, which can be viewed as an elect of the gauge string penetrating through the mapping contour on the unit circle.

U sing these results, we demonstrated that the Berry phase can be observable in interference experiments on magnetic rings, and controllable using the additional homogeneous magnetic eld.
