A nalytic R elations between Localizable Entanglement and String Correlations in Spin Systems

We study the relation between the recently de ned localizable entanglement and generalized correlations in quantum spin systems. Dierently from the current belief, the localizable entanglement is always given by the average of a generalized string. Using symmetry arguments we show that in most spin-1/2 and spin-1 systems the localizable entanglement reduces to the spin-spin or string correlations, respectively. We prove that a general class of spin-1 systems, which includes the Heisenberg model, can be used as perfect quantum channel. These conclusions are obtained in analytic form and con rm some results found previously on numerical grounds.

Entanglement is one of the most specic features of Quantum Mechanics (QM), rst recognized by Schrodinger [1], that has been realized in recent times to open the way to some of the most important applications of QM like teleportation, dense coding, quantum cryptography and computation [2]. Since quantum information is based on qbits and, more generally on nite-level quantum systems, spin chains em erge as natural candidates for quantum devices. Moreover, it has also been suggested recently that the quantum information perspective could give a better understanding of the structure of the ground state and of possible quantum phase transitions in Condensed Matter systems [3, 4, 5]. In this context Verstraete et al. have introduced the notion of localizable entanglement (LE) [6], which is a very attracting new concept for its possible applications to the study of quantum phase transition. In addition, the LE has a precise physical meaning to the extent that it can m easure the perform ance of certain kinds of quantum repeaters [7,8].

The LE of an interacting multipartite system is the maximum amount of entanglement that can be localized on two particles by performing local measurements on the remaining (assisting) particles. Here we stick to the class of projective Von Neumann measurements. The LE on the pair $i_{\vec{r}}j$ of an N + 2 particle state j i is dened as

The maximum is taken over all localm easurement bases fixing of the N assisting particles, j_s is the normalized two-qbit state at sites i and j obtained after performing the measurement is with outcome probability p_s . As a measure of entanglement E (j_s) for two-qbit states j_s we use here the concurrence, rst dened in [9]. Finding the optimal basis which satists execution [6] upper and lower bounds have been derived, the lower bound being given by the maximal connected correlation between sites i and

j, while the upper bound is the concurrence of assistance [10].

Interestingly, it has been observed num erically that in most spin-1/2 systems the LE equals the lower bound [11]. Sim ilar num erical studies have shown [11, 12] that the LE assum es its maximal value 1 for the ground state of the spin-1 Heisenberg model with spin 1/2 at the endpoints. The same result has been proved exactly [12] for the A eck-Kennedy-Lieb-Tasaki (AKLT) model [13]. Instead the -deformed AKLT model [12] exhibits an exponentially decaying LE with a nite entanglement length E, which is de ned in analogy with the correlation length. For the latterm odel the LE has been considered an essential indicator of the transition taking place at = 0, since here E diverges while the standard correlation length is smooth. To rule out the possibility that the LE can be ascribed to the string order correlation, the authors of Ref. [11] have given an example of a state for which E diverges even in absence of string order.

In this Letter, it is shown that the LE is given by a generalized string whose form depends on the symmetry properties of the state. In particular the following analytical results are given: i) in spin 1/2 systems we give arguments that show the tightness of the lower bound ii) for a large class of spin 1 systems, that include the Heisenberg model, the LE is proved to be 1, i.e. maximal; iii) in the -deformed AKLT model we show that the LE is connected with a string order correlation.

Throughout the text we consider a system of N assisting particles labeled from 1 to N and two qbits on which we localize the entanglement that, without loss of generality, we place at the endpoints 0; N + 1.

O noe an optim albasis fixi = $jx_1 ::: x_N$ ig is found, the LE of an N + 2 particle state j i is given by

where the preconcurrence P of an unnormalized two-qbit state ji, is de ned by P (ji) = h j y ji; and the complex conjugate is taken in the standard basis. It

is then clear that the LE can always be written as an expectation value

where the operator G (s) is given by

and the sign function is sign (z) = z = jzj for nonzero z, sign (0) = 0. As it is evident from the de nition, the G (s) operator depends on the optim albasis as well as on j i. However, in most cases G (s) takes a manageable form that depends on the symmetry property of the state. On top of that, if the signs in Eq. (3) factorize into local terms, then G (s) becomes a string G (s) = G_1G_2 G_2

In order to nd the optim albasis fisig we take an innitesim alvariation over all possible local unitary transform ations obtaining the following set of extrem al equations:

and the 's are the generators of the unitary single-site group SU (D) (D is the dimension of the single site H ilbert space), = 1; ...;D ² 1 and i = 1; ...;N.

In what follows we shall discuss separately spin 1/2, spin 1 and matrix product states.

Spin 1/2. In this case the 's are the Paulim atrices. On the basis of Eqs. (4) and (5), it is straightforward to show that if j i is real and invariant under rotations about the -axis, $P = \frac{0}{i=0}^{N+1}$, = x;y;z then an extrem al is provided by the basis. This result can readily be applied, for example, to the Ising model in transverse eld and to the X X Z H eisenberg model.

Let us consider rst the Ising model in transverse eld:

For nite N the ground state j i is unique for any and belongs to the P z = 1 sector. For j j> 1 the gap between the lowest state in the sector P z = 1 and the ground state vanishes exponentially with N and hence becomes degenerate with it in the thermodynamic limit. As the basis of z is extremal, we calculate now G $^{(z)}$. For >0 a M arshall's sign theorem ensures that, in the z basis, all the coe cients of j i in the same parity sector are nonzero and have the same sign. Then the preconcurrence P (j $_{\rm S}$ i) is positive (negative) according to whether the

parity of jsi is 1 (1). The case < 0 is reduced to the previous one by transform ing the H am iltonian (6) with a rotation about the z axis on the even sites. Collecting results, for any non-zero , we get

This implies at once that the LE calculated in this basis is L $^{(z)}$ (j i) = sign () $^{N+1}$ h j $_0^{x}$ $_{N+1}^{x}$ j i, i.e. the maximal classical correlation, that is the lower bound. For j j> 1, in the thermodynam ic limit we must be cautioned that the LE depends on the particular combination of the twofold degenerate ground states one chooses.

Let us discuss now the XXZ model

The H am iltonian com m utes with all P $^{x,y;z}$ discrete rotations, m eaning that x 's, y 's and z 's are all extrem all bases. W hich one yields the highest LE m ust be assessed by explicit calculation. Exploiting the M arshall's sign property we get G $^{(z)}$ = 0 (1) P 0 , where P 0 is the projector onto the subspace of zero m agnetization for the assisting spins. This m eans that the LE assumes the form

To evaluate G $^{(x)}$ we need the M arshall's sign property in the x 's basis. This can be achieved with a local unitary transformation which depends on the value of . For > 1 the required rotation is $_{j}$ exp i $_{2j}^{x}=2$ which acts only on one sublattice. Instead for $1 < _{Q} < 1$ we must further apply a uniform rotation of =2, $_{j}$ exp i $_{j}^{x}=4$. For N is even, the result is

In the critical regime, 1 < 1, it is well known that the transverse correlations dom inate at least asymptotically, while the z z correlations are the highest in the antiferrom agnetic phase > 1. The conclusion is that for the ground state of the XXZ model the $^{\times}$'s basis always yields the highest LE. As for the Ising model, the lower bound is attained, in agreement with the numerical simulations in Ref. [11], indicating that our local maximum is indeed a global one. It is remarkable that on the each side of the isotropic point = 1 the LE at nite size is given by dierent classical correlators. In particular it

has been observed in nite size systems that the LE between nearest-neighbour sites displays a singularity [11]. In our opinion, this fact is due to the dierent transformations required by the Marshall's theorem and cannot be attributed to the Berezinskii-Kosterlitz-Thouless (BKT) transition occurring at the same point.

W ork is in progress to extend the m ethod outlined here in presence of a m agnetic eld that breaks the P^{\times} symmetry. Nonetheless, the numerical computation of [11] anticipates that for some values of the eld, the LE is strictly greater than its lower bound.

Spin 1. Here we consider spin one assisting particles S_i ; $i=1;\ldots;N$, and two qbits at the endpoints. The extrem al equations are still given by Eqs. (4) and (5) where the 's are now the generators of SU (3), i.e. the eight Gell-M ann matrices . When both the state j i and the basis jsi are real, it is enough to consider in the extrem al Eq. (4) only the restricted set of purely imaginary generators of SU (3): () , = i , where is the Levi-C ivita symbol.

Given the richer structure of SU (3) with respect to SU (2), the invariance of the state through a rotation of around -axis, = e^{i Stot}, is not su cient to prove that the basis of S is extremal, at variance with the spin 1/2 case. Instead, if the state j i is symmetric with respect to rotations of about two (and hence any) axes, using the following (anti)commutation rules

The solution of (12) is (apart from unimportant phase factors) fixing = fili; j ig $_{\text{S}^{x,y,z}}$ ju; (j+ 1i $_{\text{J}}$ 1i) = $_{\text{Z}}$, since the matrices e^{i} $_{\text{S}^{x,y,z}}$ are all diagonal in this basis.

Surprisingly, without making any further assumption on the state j i it is possible to calculate exactly the LE in the basis fixing, nding that it reaches its maximal value, i.e. 1. The proof goes as follows. We write the state j i as

where $j_{s,i}$ 2 fjDi; j ig and j i is the i's basis for the two qbits. Due to the invariance of the state with respect to rotations of about any axis, one has $e^{i S_{tot}} = p$; p = 1 and the coe cients in (13) satisfy C_s ; $= p_{z \ 0 \ N+1} \ (1)^{n_+ \ (s)+n_- \ (s)} \ C_s$; and C_s ; $= p_x \ (1)^{n_- \ (s)+n_0 \ (s)} \ C_s$; . Here $n_- \ (s)$ is the number of times $s_i = i n_- \ (s)$ in the state $j_1 \ s_2 = n_- \ (s)$

by spin ipping the state j i. The LE can be written as

Now we use \mathfrak{F}_s ; C_s ; $j=(1)^{n_+(s)+n_0(s)}C_s$; C_s ; and $(1)^{n_+(s)+n_0(s)}=hsj^{N_+(s)+n_0(s)}$ is j=1; j=1. Finally, one obtains

This implies that Eq. (5) is automatically satised. In this derivation it has not been necessary to compute the G operator which anyway is given by G $^{(s)}$ = $p_y P \stackrel{N}{=} 1 e^{i S_1^y} P$, where P projects out the states for which the preconcurrence is zero. A long the same reasoning it can be shown that Eq. (14) remains valid for general complex j i.

The nding of Eq. (14) demonstrates that, in a spin 1 state the entanglement is fully localizable on the endpoints, with the only requirement of invariance with respect to rotation around any axis. This property is shared by ground states of a large class of systems which can be regarded as perfect quantum channels.

An example is given by the XXZ S = 1 Heisenberg model with single—ion anisotropy:

This model exhibits a very rich ground state phase diagram (see [14, 15] and references therein) with six di erent phases. A coording to num erical studies [12], the LE is one at the isotropic Heisenberg point. In the present work it is proved that the LE is always one in the entire region of parameters, in spite of the complexity of the phase diagram. Of course this makes unpractical the use of the LE for the detection of quantum phase transition in contrast to what suggested by some authors [11, 12].

One may wonder whether the maximal localizability of the entanglement is due to the presence of the two qbits at the borders. This occurs, for example, in the large-D region where the asymptotic ground state is (j";0;:::;0;#i j#;0;:::;0;"i) = 2 for which the LE is one, while in absence of the spin 1/2 at the endpoints, the ground state tends to the unentangled state j0;:::;0i.

A little care is needed in the broken sym m etry phases i.e. ferro—and antiferro—m agnetic regions where the ground states are twofold degenerate. However the requirement of invariance under $x_i y_i z_i$ was the combination of ground states in a similar manner as in the Greenberger-Home-Zeilinger (GHZ) state with maximal LE.

M atrix P roduct States. M atrix product states (M PS) are very interesting in m any respects, in particular the

xed point of the density matrix renormalization group algorithm (DMRG) yields an MPS state [16]. As was shown in Ref. [12], it is possible to calculate exactly the LE for any MPS state. This opens up the possibility of calculating approximately the LE for any one dimensional ground state. Here we revisit the examples introduced in [12] in the fram ework of our formalism. This will allow us to clarify the link between LE and correlations.

U sing the convention of [12] we write a general MPS state with open boundary condition as

where the A 's are D 2 2 m atrices which depend on the local basis $j_{i}i$, C is a normalization constant and $j_{i,N+1} = (j_{i,N+1})^{*} = 2$ is the two-qbit singlet at the endpoints.

The optim al basis $\mathbf{\dot{p}_i}$ i can be found via the method shown in [12] and, since in this case the preconcurrence takes the form det (A S_N $^{S_2}\mathbf{A}^{S_1}$), the G operator factorizes into local terms reducing to

A well known example of MPS state is the ground state of the spin-1 AKLT model, characterized by the presence of a gap, exponentially decaying spin-spin correlation function and hidden topological (string) order [13]. As any MPS, the AKLT ground state can be alternatively written in the valence bond solid (VBS) form alism. In this representation, every spin one at position i is replaced by a pair of qbits i; i each one forming a singlet with its nearest neighbor, respectively $\overline{1}$ and i+1. The on-site couple of qbits is then projected back onto the spin-1 Hilbert space by means of a single 3 4 matrix A, related to the 2 2 MPS matrices A via $h_i \not A = h_i j_i A^i$ I_i .

The -deform ed generalization y i [12] of the AKLT state is given by the matrix

The $jV_{=0}i$ state is the rotation-invariant AKLT state, while a non zero breaks the O (3) invariance down to O (2) invariance. As was shown in [12] the optimal basis is fjsig = fjDi;j ig for any , which is the same as in the previously considered S = 1 case. It is straightforward to calculate the G operator and the LE which now reads

For = 0 the LE is equal to one, while for non zero it decays exponentially with a nite entanglement length $_{\rm E}^{-1}=\lim_{\rm N\,!\,1}\,\ln{\rm (L)}=\!\!\rm N$. On the basis of Eq. (18), the connection between the LE and the string order parameter (SOP) in the y direction becomes evident. Generally the (maximally extended) SOP's g (N) are dened as

In the isotropic case = 0, all $g^{x,y,z}$ saturate to 4=9 revealing a breaking of a hidden Z_2 Z_2 sym m etry [17]. On the other hand, for Θ 0 the SOP in the z direction tends exponentially to a non-zero value G^z (1) =

behaves as the LE decreasing exponentially to zero with correlation length $_{\rm E}$. In the = 0 case the LE can be ascribed to the presence of string order. However in the deformed case, it was argued in [11] that the LE is not connected to string order since the LE is short ranged while $\rm g^2$ is non vanishing. A ctually our arguments show that in this case a connection still exists between the LE and SOP, but in the y channel.

An example of MPS state j i forwhich the LE is identically one but all the SOP's are zero was conceived in [11] and is de ned as in (16) with $A^1 = {}^z + {}^y$; $A^2 = {}^z$ iII; and fj ig is the standard basis which in this case coincides with the optimal one. It is straightforward to calculate the G operator for this state which turns out to be $G = (1)^N$ II yielding a maximal LE:

It is clear that, in this case, the LE is not connected to string param eters but rather to a classical correlation that involves a complex conjugation.

In conclusion, in this Letter we have considered the recently de ned LE and its relationship with correlations in spin system. In quantum information theory the LE has a well de ned physicalmeaning, while in condensed matter it has attracted much attention for its possible uses to detect and characterize quantum phase transitions. In particular, we have shown that for spin-1 systems parity symmetry along the three axes is sucient to assure that the LE reaches its maximal value one. This promotes spin-1 systems as realizations of perfect quantum channels, but shows that the LE is insensitive to quantum phase transitions. Using similar symmetry arguments we have put in evidence that, in the spin-1/2 case, the LE equals the maximal correlation. Both of these ndings

have been obtained analytically con mm ing the num erical results of Ref. [11]. We believe that relaxing the symmetry requirements and/or analyzing higher spin systems opens the possibility of nding examples in which the LE does not reduce to known correlations.
