#### Abstract

Q uantum dynam ics of a two-state spin system in a rotating magnetic eld has been studied. A nalytical and num erical results for the transition probability have been obtained along the lines of the Landau-Zener-Stueckelberg theory. T he e ect of various kinds of noise on the evolution of the system has been analyzed.

## I. INTRODUCTION

M olecular magnets with high spin and high magnetic anisotropy can be prepared in long-living excited quantum states by simply applying a magnetic eld [11]. In a time dependent $m$ agnetic eld, they exhibit stepw ise $m$ agnetic hysteresis due to resonant quantum tunneling between spin levels 1 has been intensively studied theoretically $w$ ithin $m$ odels em ploying Landau-Zener-Stueckelberg (LZS) e ect [31, ', 'ivin'
 at the inception of quantum theory is this. C onsider a system characterized by quantum states $71 i$ and Zi w ith energies $\mathrm{E}_{1}$ and $\mathrm{E}_{2}$ respectively. Let the system be initially prepared in the low er-energy state, jli, and the eld be changing such (due to, e.g., Zeem an interaction of the $m$ agnetic eld $w$ ith a spin) that $E_{1}$ is shifting up while $E_{2}$ is shifting down. A fter the levels cross and the distance betw een them continues to increase, the system, w ith LZS probability, $\mathrm{P}=\exp \left(\quad^{2}=2 \sim \mathrm{v}\right)$, rem ains in the state $\mathfrak{j l} i$. H ere is the tunnelspllting of $\mathfrak{j l} i$ and $2 i$ at the crossing, and $v$ is the rate at $w$ hich the energy bias betw een $j l i$ and $2 i$ is changing $w i t h ~ t i m e . ~ T h i s ~ p i c t u r e, ~$ of course, does not take into account any disturbance of the quantum states, $11 i$ and $2 i$, by the dissipative environm ent.  allowed experim entalists to use the LZS expression to extract in $m$ olecularm agnets from bulk $m$ agnetization


T he purpose of this paper is to elucidate the possibility of a detailed study of quantum spin transitions and the e ect of the environm ent in experim ents $w$ ith a rotating $m$ agnetic eld. Q uantum tunneling rates for a spin system in a rotating eld have been studied before [22]. H ere we are taking a di erent angle at this problem, by com puting the occupation num bers for quantum spin states. This approach can be useful for the descrip-
tion of experim ents that $m$ easure the tim e dependence of the $m$ agnetization. A weak high-frequency rotating eld, $\mathrm{H}_{0} \quad 10 \mathrm{e}$, can be easily achieved electronically, by applying $H_{x}=H_{0} \cos (!t)$ and $H_{z}=H_{0} \sin (!t)$. The rotating eld oflarge am plitude can be achieved by rotating the sam ple in a constant $m$ agnetic eld. In a typical molecular magnet, a rotating eld not exceeding a few kOe will result in the crossing of two spin levels only, preserving the two-state approxim ation. W e will compute the tim e evolution of the probability to occupy one of the two spin levels after a num ber of revolutions. W e w illdem onstrate that th is evolution depends crucially on whether the system is sub ject to the dissipative noise and that it depends strongly on the frequency of the noise. $T$ he equivalent of the LZS e ect in the rotating eld is studied in Sec. III. The e ect of slow and fast noise on such probability in the rotating eld is considered in Sec. IV . C onsequences for experim ent are discussed at the end of the paper.

> II. H A M ILTON IA N

W e shall start w ith the H am iltonian

where $D$ is the uniaxial anisotropy constant, $g$ is the gyrom agnetic factor, $B$ is the Bohrm agneton, and $H$ is the $m$ agnetic eld, and $S$ is an integer spin. $W$ e shall assum $e$ that the $m$ agnetic eld rotates in the $\mathrm{X} \mathrm{Z-plane}$,

At $H=0$, the ground state of the $m$ odel is double degenerate. The low est energy states correspond to the parallel ( $m=S$ ) and antiparallel ( $m=S$ ) orientation of $S$ w th respect to the anisotropy axis, $w$ th $m$ being the $m$ agnetic quantum num ber for $S$. The e ect of the extemalm agnetic eld is tw ofold. T he $Z$-com ponent of the eld rem oves the degeneracy. The X -com ponent produces a term in the $H$ am iltonian that does not com $m$ ute $w$ th $S_{z}$. C onsequently, at $H_{x} \in 0$ the in i states are no longer the eigenstates of the system. H ow ever, at

we can treat the non-com $m$ uting term in the $H$ am iltonian as a perturbation. Throughout th is article it w ill be assum ed that the system is prepared initially in one of the saturated $m$ agnetic states, say $j$ Sifor certainty. This can be easily achieved at low tem perature in m olecular $m$ agnets $w$ th high easy-axis anisotropy.

For the perturbation $V(t)=g{ }_{B} H \quad S$ the tim $e-$ dependent perturbation theory gives the follow ing expression for the transition amplitude from the initial state, $j$ Si, to any mi $^{0} i$ state $w$ ith $m{ }^{0} G$ :

An im portant observation that follows from Eq. $\left(\bar{T}_{1}\right)$ is that at $n=(2 n+1)=2(\mathrm{w}$ th $\mathrm{n}=0 ; 1 ; 2$; :::) the splitting is exactly zero. A ccording to Eq. (ī1), at large

$S$, it decreases very fast as onem oves aw ay from the level crossing, that occurs at ${ }_{n}=n=2$. This guarantees that the transitions betw een the two states are localized in time at the level crossing. This is clearly seen in Figure 1 that show s the e ect of the perturbation on the energy levels.
III. DYNAM ICSW IT H OUT NO ISE
A. A single revolution

In order to describe the evolution of the $m$ agnetization in a magnetic eld rotating in the X Z-plane, we shall com pute rst the probability of staying at the initial state after a rotation by 180 degrees, when a single level crossing takes place.

The Schrodinger equation for the coe cients of the w ave function,

$w h i c h$ is a $m$ easure of the $m$ agnitude of the $m$ agnetic eld. $N$ otice that this param eter equals ${ }_{c}=!t_{c}$, where $t_{c}=0=\left(!h_{0}\right)$ is the characteristic tim e of crossing the resonance. Thus, the condition 1 is needed for the crossing to be well localized in tim e on the tim e scale of one revolution. This condition is required for the selfconsistency of the $m$ ethod.

From Eqs. (121) one can com pute num erically the tim e evolution of the coe cients $c s$ and $c_{s}$, and, thus, the tim e evolution of the occupation num bers for any $\sim$; . In the fast $(\sim 1)$ and slow ( $\sim 1$ ) rotation regim es, analytical form ulas for the occupation probabilities can be obtained. These form ulas are useful for further analysis. Inspection ofE qs. (121) reveals that the deviation from the LZS result for slow rotation is sm all, since w th in the relevant time of the transition $u \quad 1$ and ( ) is nearly constant. On the contrary, for the fast rotation regim e, ( $\sim 1$ ), the relevant tim interval is w ider, $u \quad \sim{ }^{1=2}$. This allows a signi cant change of during the transition and $m$ akes possible a considerable deviation from the LZS result.

> 1. Fast rotation (~ 1)

Follow ing the procedure devised by $G$ aranin and Schilling [24, w, we can obtain the probability of staying at the initial state after a 180-degree rotation of the extemal magnetic eld. W e choose the direction of the $m$ agnetic eld to be initially antiparallel to the $Z$-axis. In the zero-th order of the perturbation theory $œ_{1}(u)=1$. In the rst order, such probability is then given by

 tion. T he di erence betw een the num erical result and the LZS result is considerable. Fig. at $\sim 0: 1$. H ere again Eq. $\left(1 \bar{\eta}_{1}\right)$, but not the LZS form ula, provides a good approxim ation for the -dependence of the staying probability.

The asym ptotic behavior of e (u) is e (u) ! 1 for ~! 1 . At~ 1 the coe cient e (u) rem ains close to 1. A lso, far from the crossing point, $e_{+}(u) c_{s}$, as can be seen from Eqs. (1-19) and (20). These tw o facts allow one to obtain the probability ofstaying at the initialstate in the rst order of perturbation theory:

## B. C ontinuous R otation

O ur treatm ent of the continuous rotation is based upon the sm allness of the transition tim e in com parison w th the period of the rotation. P eriodically driven two-state system s of that kind have been studied before [14].

$T$ his $m$ atrix transform $s$ a given initial state into the after-crossing nalstate in term s of the unperturbed basis. The above expression corresponds to the crossing in which the $j$ Si levelm oves up tow ards the $\dagger$ 's i level that is $m$ oving dow $n$. In the opposite case, $M$ should be replaced by the transpose $m$ atrix, $M^{T}$.

To describe the evolution of the system betw een crossings it $m$ ust be noted that, as we have shown before, far from the crossings the unperturbed basis $j$ Si; ${ }^{\prime} \mathrm{Si}$ alm ost coincides with the adiabatic basis $j+i ; j$ i, see equations (1-1) and (2d). In this region, the evolutions of $j \mathrm{Si}$ and $\bar{j} \mathrm{i}$ are then considered independent, so that they can be described by the propagator

Starting w ith the initial state, the state of the system after the $n$-th crossing can be obtained by the successive action of $M ; M^{T}$ and $G_{n}$. The tim e-dependence of the probability of nding a continuously rotating system in the in itial state $j S i$ is shown in $F$ ig $\overline{1} \mathbf{T}$. The gure show s good agreem ent of the above analytical $m$ ethod w ith num ericalcalculation. It is im portant to notice that in the absence of dissipation the system does not arrive to any asym ptotic state at ! 1. The behavior of the probability show s a long-term $m$ em ory of the initial state, which is som ew hat surprising. This prediction of the theory can be tested in real experim ent.
IV. DYNAM IC S W ITH NOISE.

W hen considering the e ect ofthe noise, it is im portant to distinguish betw een the follow ing three regim es:

where is the characteristic frequency of the noise. The rst of these conditions corresponds to the situation when a few revolutions $m$ ay occur before any contribution of the noise becom es apparent. C onsequently, during the tim e interval satisfying $t<1=$ one can use the results for the probability obtained in the previous section. Under the condition ( $\overline{3} \overline{3}$, ), , one can use the previously obtained results for a singular crossing but needs to take

into account the destruction of the relative phase of the two states by the noise before the next crossing takes place. U nder the condition ( $34{ }^{-1}$ ) the results of the previous section do not apply because the coherence of the quantum state is destroyed by the noise on a tim escale that is less than the crossing tim e.

The time dependence of the probability of nding the system in the state $j$ Si is shown in $F$ ig. $\overline{(1)}(\mathrm{F})$ for $\sim=1=3 ; S=10$, and $=0: 01$. In accordance $w$ ith the expectation, the probability for the system to occupy the state $w$ th $m=S$ (or $m=S$ ), after going through a few oscillations, tends to the asym ptotic value of 0.5. For m olecular m agnets, only the average of the probability over an ensemble of two-state dissipative system $s$ is of practical im portance. The probability shown in Fig. (G) is such an average.
B. H igh-frequency noise, ! = 1

In this lim it the coherence is com pletely suppressed, by, e.g., interaction w th phonons, and the evolution of the population of energy levels $m$ ust be described by the density $m$ atrix. In this case the population, $N \ldots s$, of the in itially occupied state $j$ Si is given by [13

The tim e-dependence of the occupation of the state j $S$ i is shown in $F$ ig $1_{1}^{-\eta}$ for $\sim=1=3 ; S=10 ; \sim=h_{0}=0: 01$. A $s$ in the case of a low-frequency noise, the probability to occupy either of the two levels tends to 0.5 after a few revolutions. The di erence betw een the two regim es is that in the case of the high-frequency noise the probability m onotonically approaches the asym ptotic value w thout exhibiting any oscillation.

## V. CONCLUSIONS

W e have studied the equivalent of the LZS e ect for a spin system in a rotating $m$ agnetic eld. Typicaltim e dependence of the probability of staying at the in itial state has been com puted for three di erent situations. The rst is the situation when the noise is irrelevant on the tim e scale of the $m$ easurem ent, $F$ ig. '진. In this case the system exhibits coherent behavior and long-term memory e ects. T he second situation corresponds to the noise that decohere quantum states within the tim e of each revolution but is slow enough to provide pure quantum dynam ics during the level crossing, Fig. 'G. The third situation corresponds to a very fast noise that does not allow the use of wave functions for the description of the crossing and requires the density-m atrix form alism, F ig. ${ }_{1}{ }_{1} 1$. . W hen the noise becom es im portant, the occupation probability of each levelapproaches $1=2$ after severalrevolutions. H ow ever, the asym ptotic behavior depends on the frequency of the noise. The three regim es discussed
 $a b l e$ to sw itch betw een di erent regim es by changing the angularvelocity of the rotating eld and/or tem perature. Experim ents of that kind can shed light on the e ect of dissipative environm ent on the resonant spin tunneling in m olecular m agnets. To be on a cautious side, one should notice that the evolution of the $m$ agnetization in a crystal ofm agnetic $m$ olecules also depends on the dipolar interactions betw een the m olecules $\left[\overline{2} \bar{\sigma}_{1}, \overline{2} \overline{2}_{1}, \overline{2} \bar{z}_{1} 1\right]$. O ur results are likely to be relevant to m olecular'm agnets $w$ hen the am plitude of the rotating eld signi cantly exceeds dipolar elds. A candidate for such a study would be, e.g., an uniaxial $N$ i-4 m olecular $m$ agnet that has no nuclear spins and that, with good accuracy, is described by the H am iltonian studied in this paper.
