# Parallels between the dynam ics at the noise-perturbed onset of chaos in logistic maps and the dynam ics of glass form ation

We develop the characterization of the dynam ics at the noise-perturbed edge of chaos in logistic m aps in terms of the quantities normally used to describe glassy properties in structural glass formers. Following the recognition [Phys. Lett. A 328, 467 (2004)] that the dynamics at this critical attractor exhibits analogies with that observed in thermal systems close to vitri cation, we determ ine the modi cations that take place with decreasing noise am plitude in ensemble and tim e averaged correlations and in di usivity. We corroborate explicitly the occurrence of two-step relaxation, aging with its characteristic scaling property, and subdi usion and arrest for this system. We also discuss features that appear to be speci c of the map.

## I. IN TRODUCTION

The erratic motion of a Brownian particle is usually described by the Langevin theory [1]. A sit is wellknown, this method nds a way round the detailed consideration of many degrees of freedom by representing via a noise source the e ect of collisions with molecules in the uid in which the particle moves. The approach to therm al equilibrium is produced by random forces, and these are su cient to determ ine dynamical correlations, di usion, and a basic form for the uctuation-dissipation theorem [1].

In the same spirit, attractors of nonlinear lowdimensional maps under the e ect of external noise can be used to model states in system s with many degrees of freedom. In a one-dimensional map with only one controlparameter the consideration of external noise could be thought to represent the e ect of many other system s coupled to it, like in the so-called coupled map lattices [2]. Notice that the general map form ula

is a discrete form for a Langevin equation with nonlinear Yriction force' term h . In Eq. (1) t = 0;1;::: is the iteration time, t is a Gaussian white noise (h  $t t^0 i = t;t^0$ ), and measures the noise intensity.

An interesting option o ered by Eq. 1) is the study of singular states known to exhibit anom alous dynamics. For instance, the so-called onset of chaos in logistic maps is a critical attractor with nonergodic and nonmixing phase-space properties, and the perturbation of this attractor with noise transforms its trajectories into genuinely chaotic ones with regular ergodic and mixing properties. A case in point here would be to obtain the atypical dynam ics near an ergodic to nonergodic transition and com pare it, for exam ple, to that in supercooled liquids close to glass form ation, where also an ergodic to nonergodic transition is believed to occur. The dynam – ical properties for such glassy states appear associated to two-tim e correlations with loss of tim e translation invariance (T T I) and aging scaling properties, as well as to subdi usion and arrest  $\beta$ , 4]. The speci c question we would like to address is whether there are properties shared, and if so, to what extent, by critical attractors in nonlinear low-dim ensionalm aps and nonergodic states in system s with m any degrees of freedom.




FIG.1: (a) Logistic m ap attractor. (b) M agni cation of the box in (a). (c) N oise-induced bifurcation gap in the m agni ed box.

Recently [5], it has been realized that the dynamics at the noise-perturbed edge of chaos in logistic maps shows sim ilarities with that observed in supercooled liquids close to vitri cation. Three major features of glassy dynam ics in structural glass form ers, two-step relaxation, aging, and a relationship between relaxation time and con gurational entropy, were shown to be displayed by the properties of orbits with vanishing Lyapunov coe cient. Interestingly, the previously known properties in control-param eter space of the noise-induced bifurcation gap (See Fig. 1) [6, 7] play a central role in determ ining the characteristics of dynam ical relaxation at the chaos threshold, and this was exploited to uncover the analogy between the dynam ical and the therm alsystem s in which the noise amplitude plays a role equivalent to a tem perature di erence T  $T_{q}$ , where  $T_{q}$  is the so-called glass transition tem perature [3, 4].

In Ref. [5] only the properties of single-tim e functions (i.e. trajectories) were discussed and here we focus the analysis on two-tim e correlations. This would allow for a closer exam ination of the analogy with glassy dynam ics as the study of the latter offen centers on two-tim e cor-

relations. However, we also look at di usion properties via the determ ination of the mean square displacem ent of trajectories in a suitably space-extended map. To lay em phasis on the sim ilarities in the dynam ics between the two types of system swe analyze the attainment of TI in the correlations caused by the action of noise. W e recall [8, 9] that exposure of attractors to noise have the features of an activated process a mechanism that is usually considered in the interpretation of relaxation processes in glass form ers. A lso we make up a simple 'landscape' picture for the properties of the noise-perturbed m ap in order to compare it with that obtained from the multidim ensional energy landscape of supercooled liquids. Aware of our crude attempt to contrast the dynamics of a single map (although equivalent to a coupled array of such maps when described via a Langevin-type equation) with that of therm alsystem swe point out the main di erences encountered. Speci cally, the dynam ics at the onset of chaos displays regular patterns absent in the known (experimental or computed) dynamics of molecular systems. These di erences re ect the peculiarities of the period-doubling route to chaos displayed by unim odalm aps.

The structure of the body of the article is as follows: In Section 2 we recall essential properties of the logistic m ap under additive noise, e.g. the bifurcation gap and its tim e-dependent manifestation at the chaos threshold. In Section 3 we present results on ensem ble-averaged twotim e correlations for & 0, the attainment of TTI, and the development of two-step relaxation as ! 0. In Section 4 we focus on time-averaged two-time correlations and the occurrence of the characteristic aging scaling at the onset of chaos with = 0. In Section 5 we present a repeated-cellm ap for di usion at the onset of chaos and show the evolution in behavior from di usive to subdiffusive and nally to localization as ! 0. In Section 6 we make nal remarks.

## II. NO ISE-PERTURBED ON SET OF CHAOS

W e describe now the e ect of additive noise in the dynam ics at the onset of chaos in the logistic m ap




FIG. 2: A bsolute values of positions in logarithm ic scales of iterations t for various trajectories at the onset of chaos  $_{\rm c}$ () starting at  $x_0 = 0$ . Empty circles correspond to = 0 where the numbers label time t = 1;;16. Full (and dashed) lines represent trajectories for noise amplitude  $= 10^{-3}$  (and  $= 10^{-6}$ ) plotted only at times t =  $2^{\rm n}$ .

where h in Eq. (1) has taken the form h  $(x) = 1 \times x^2$ . For = 0 at the onset of chaos at  $_c = 1.40115$ ::: the orbit with attractor initial condition  $x_0 = 0$  consists of positions arranged as nested power-law time subse-

of positions arranged as nested power-law time subsequences that asymptotically reproduce the full perioddoubling cascade that occurs for  $< _c$  [10, 11]. See empty circles in Fig. 2. This orbit is the last (the accum ulation point) of the so-called superstable' orbits of period 2<sup>n</sup> which occur at  $= -_n < _c$ , n = 1;2;..., a superstable orbit of period 2<sup>1</sup>. Superstable orbits include x = 0 as one of their positions and their Lyapunov exponent \_1 diverges to \_1 6]. A transient dynam ics at the onset of chaos is observed for trajectories with initial

position outside the Feigenbaum attractor but we shall not consider this in what follows. For > 0 the noise

uctuations wipe the nestructure of the periodic attractors as the iterate visits positions within a set of bands or segments similar to those in the chaotic attractors, nevertheless there remains a well-de ned transition to chaos at  $_{\rm c}($ ) where the Lyapunov exponent  $_1$  changes sign [6, 7]. The period doubling of bands ends at a - nite maximum period  $2^{\rm N}$  () as !  $_{\rm c}($ ) (see Fig. 1c) and then decreases at the other side of the transition. This e ect displays scaling features and is referred to

as the bifurcation gap [6, 7]. For instance, С  $_{\rm c}$  ( ) and =  $\ln_F = \ln_r$ , where where <sub>c</sub> (0)  $_{\rm F}$  = 0:46692::: is one of the two Feigenbaum 's universal constants (the 2nd,  $_{\rm F} = 2:50290:...,$  m easures the powerlaw period-doubling spreading of iterate positions), and  $2^{1}2_{F}2_{F}(1 + 1 = \frac{2}{F})^{1=2}$  / 6:619. See [5] and references therein. When is small the trajectories visit sequentially the set of  $2^{N}$  ( ) disjoint bands leading to a cycle, but the behavior inside each band is irregular. These trajectories represent ergodic states as the accessible positions have a fractaldim ension equal to the dim ension of phase space. W hen = 0 the trajectories correspond to a nonergodic state, since as t! 1 the positions form only a Cantor set of fractal dimension  $d_f = 0.538$  .... Thus ! 0 leads to an ergodic to the rem oval of the noise nonergodic transition in the map.

As shown in Ref. [5] when  $= _{c}()$  ( > 0) there is a 'crossover' or 'relaxation' time  $t_{x} = ^{r-1}$ , r = 1  $\ln 2 = \ln$  ' 0:6332, between two di erent time evolution regimes. This crossover occurs when the noise uctuations begin suppressing the nestructure of the attractor as displayed by the superstable orbit with  $x_{0} = 0$ described above. (See full and dashed lines in Fig. 2). For t <  $t_{x}$  the uctuations are smaller than the distances between the neighboring subsequence positions of the  $x_{0} = 0$  orbit at  $_{c}(0)$ , and the iterate position with  $\geq 0$  follow this a smaller darwind the  $_{c} = 0$  position

> 0 falls within a sm allband around the = 0 position for that t. The bands for successive times do not overlap. Time evolution follows a subsequence pattern close to that in the noiseless case. When t the width of the noise-generated band reached at time  $t_x = 2^{N}$  () matches the distance between adjacent positions, and this implies a cuto in the progress along the position subsequences. At longer times  $t > t_x$  the orbits no longer trace the precise period-doubling structure of the attractor. The iterates now follow increasingly chaotic trajectories as bands merge with time. This is the dynamical image { observed along the time evolution for the orbits of a single state  $_c$  () { of the static bifurcation gap initially described in terms of the variation of the control parameter [7].

The entropy associated to the distribution of the iterate positions within the  $2^N$  bands has the form  $S_c=2^N$  s, where s is the entropy associated to a single band. Use of  $2^N$  =  $t_x$  and  $t_x$  =  ${r-1}$ , r-1 ' 0:36685], leads to



Since  $(1 \ r)=r' \ 0.5792$  then  $t_x \ ! \ 1$  and  $S_c \ ! \ 0$ as  $! \ 0$ . See [5] for details on the derivation. We have compared [5] this expression with its counterpart in structural glass form ers, the A dam -G ibbs equation [3].

## III. TW O-STEP RELAXATION

The time evolution of equilibrium two-time correlations in supercooled liquids on approach to glass formation display a two-step process of relaxation. This consists of a prim ary power-law decay in time di erence t = t<sub>2</sub> t that leads into a plateau, and at the end of this there is a second power law decay that evolves into a faster decay that can be tted by a stretched exponential [3]. Also, the duration  $\mathsf{t}_{\mathsf{x}}$  of the plateau increases as an inverse power law of the di erence T T & O as the tem perature T decreases to the glass transition tem perature T<sub>g</sub>. The second decays are usually referred to as the and the relaxation processes, respectively  $\beta$ ]. An observable example of such correlation function, both experim entally and num erically, is the Fourier transform of the density-density correlation at time di erence t. The form er is known as the intermediate scattering function while the latter is known as the van H ove function [3].

The study of single trajectory properties (one time functions) in Ref. [5] led to the suggestion that the dynamical behavior in the map at  $_{\rm c}$ () would show parallels to the relaxation properties of glass form ers. For instance, the analog of the relaxation would be obtained by considering initial conditions  $x_0$  outside the critical attractor since the ensuing orbits display a power-law transient as the positions approach asymptotically those of the attractor. The intermediate plateau would correspond to the regime  $t < t_x$ , described in the previous section, when the iterates are con ned to nonintersecting bands before they reach the bifurcation gap, its duration  $t_x$  grows as an inverse power law of . The analog of the relaxation was proposed to be the band merging crossover process that takes place for  $t > t_x$ . To explore






FIG.3: Development of time translation invariance (TTI) in the correlation  $c_e(t_1;t=t_2-t_1)$  through the action of noise of amplitude at the onset of chaos. All trajectories start  $x_0 = 0$  and  $t_x$  is the time to reach the bifurcation gap.

m ore closely these sim ilarities we evaluated the two-time correlation function

for di erent values of the noise am plitude . In Eq. 4) h:::i represents an average over an ensem ble of trajectories all of them starting with initial conditions  $x_0 = 0$  and  $t_i = \frac{x_{t_i}^2}{x_{t_i}^2} - \frac{hx_{t_i}i^2}{x_{t_i}^2}$ .

We rst address the question of whether the exposure of trajectories to noise has the e ect of introducing, after an initial transient period, a time translation invariance (TTI) property into the correlation in Eq. (4), i.e.  $c_e(t_1;t_2)' c_e(t=t_2 t_1), t_1$  large. The presence of this e ect would be analogous to therm alization in molecular systems after which equilibrium correlations are mea-

sured or computed (in glass forming systems for  $T > T_g$ ). In Fig. 3 we show how TTI develops and is maintained for a su ciently large time di erence intervalt =  $t_e$   $t_e$ . The numerical limitation in evaluating accurate values for  $_c()$  leads to an upper bound for t, but we checked that increasing precision in  $_c()$  leads to a larger interval for t for which TTI is observed. In view of the results shown in Fig. 3 we can conclude that under external noise of weak amplitude the ensemble of trajectories 'therm alizes' asymptotically into an 'equilibrium' attractor.

The TT I property in the map still retains certain mem ory of the initial t<sub>1</sub>, only in a generic way that re ects the characteristic sym m etries of the period-doubling on set of chaos of the logistic m ap. Notice that in F ig 3 the values for  $t_1$  are of the form  $t_1 = 2^n + 1$ . It is found that both the initial decay and the value of the interm ediate plateau of ce (t) are xed when the values of t belong to the sequence  $t_1 = 2^n + k_n$  n large with k xed. However the m ain decay process of ce (t) appears to be independent of  $t_1$ . In Figs. 4 a and 4b we show the behavior of  $c_e$  (t), respectively, when  $t_1 = 2^n + 1$  and  $t_1 = 2^n - 1$ , n = 9;10; ...In the st case (Fig. 4a) the correlation maintains the initial value of unity from t = 0 until the main decay process sets in, while in the second case (Fig. 4b) there is initial decay at short times followed by a plateau that ends when the sam e m ain decay as in F ig. 4a takes place. For other values of k the correlation ce (t) shows a behavior similar to that in Fig. (4b) with di erent values for the duration of the initial decay (that we refer to as the

decay) and for the plateau, but always with the same main decay (that we refer to as the decay). The decay is itself made up of several plateaus the values of which alternate when n is varied (as shown in Figs. 4a and 4b). In all cases the duration of the main plateau coincides approximatively with the crossover time  $t_x$  at which the bifurcation gap is reached. (See the verticalarrows in Figs. 4a and 4b). Thus, the identication of the encounter of the bifurcation gap as the triggering event of the relaxation process [5] seem s to be con med by the num erical evaluation of  $c_e$  (t).

## IV. AGING

In glass forming systems when T  $T_g$ . 0 (nonequilibrium) two-time correlations lose time translation invariance, and the dependence on the two times  $t_1$  and  $t_2 = t + t_1$ , has the characteristic known as aging [4]. More speci cally, the time scale for the response to an external perturbation increases with the waiting time  $t_w$ , the time interval  $t_w = t_1$  to from system preparation at  $t_0 = 0$  to the moment of the perturbation at  $t_1$ . A sa consequence, the equilibrium uctuation dissipation relation that relates response and correlation functions breaks down [4]. In this regime the decay of response and correlation functions display a scaling dependence on the ratio  $t=t_w$  [4].




FIG.5: Aging according to the correlation  $c(t_w;t+t_w)$  given by Eq. (6) for the Feigenbaum attractor ( $=_{c}$ ; = 0). Total observation time is n = 1000. In (a) is shown the explicit dependence on the waiting time (from left to right  $t_w = 1$ ; 3; 5; 7; 9; 11). In (b) all curves collapse upon rescaling t= $t_w$ .

As indicated in Ref. [5] the power-law position subsequences shown in Fig. 2 that constitute the superstable orbit of period  $2^1$  within the noiseless attractor at  $_c(0)$  in ply a built-in aging scaling property for the single-time function  $x_t$ . These subsequences are relevant for the description of trajectories that are at rst held at a given attractor position for a waiting period of time  $t_w$  and then

released to the norm al iterative procedure. We chose the holding positions to be any of those along the top band shown in Fig. 2 with  $t_w = 2k + 1$ , k = 0;1;... One obtains [5]

where  $\exp_q(x)$  [1 (q 1) $x^{\dagger}$ ]<sup>1 q</sup> and  $_q = \ln_F = \ln 2$ . This property is gradually removed when noise is turned on. The presence of a bifurcation gap limits its range of validity to total times  $t_w + t < t_x$  () and so progressively disappears as is increased 5].

W hen = 0 trajectories are nonergodic and ensemble and time averages are not equivalent. For this reason we use a time-averaged correlation  $c(t_1;t_2)$  to study aging and its related scaling property at the onset of chaos for

= 0, instead of the ensemble-averaged  $c_e\left(t_1\,;t_2\right)$  in Eq. (4). Also for this case  $c_e\left(t_1\,;t_2\right)$  is not dened as  $_{t_1}$  = 0 when the initial positions are all  $x_0$  = 0 or  $x_{t_w}$ . We chose for  $c(t_1\,;t_2)$  the form

where  $(t) = f_{c}^{(t)}(0)$  and f(x) = 1 $x^2$ , and with  $n_0$ any positive integer and N  $n_0$  a large integer. This de nition of c (t, ;t+  $t_w$  ) is designed to capture the powerlaw patterns of the trajectories at the noiseless onset of chaos. Eq. (6) considers multiples of the two reference times tw and t + tw, i.e. times at which trajectories recurrently visit a given region of the attractor [15]. In Fig. 5a we show  $c(t_w;t+t_w)$  for di erent values of  $t_w$ , and in Fig. 5b the same data where the rescaled variable  $t=t_w = 2^n$  $1, t_{w} = 2k + 1, k = 0; 1; ..., has been used.$ We have calculated  $c(t_w;t+t_w)$  for dierent values of N and  $n_0$  and found in both cases the same result as in Fig. 5a. The characteristic scaling of aging behavior is especially clear.

#### V. SUBDIFFUSION AND ARREST.

The sharp slow down of dynam ics in supercooled liquids on approach to vitri cation is illustrated by the progression from norm aldi usiveness to subdi usive behavior and nally to a halt in the growth of the molecular mean square displacement within a small range of tem peratures or densities [12, 13]. This deceleration of the dynam ics is caused by the connement of any given molecule by a bage' formed by its neighbors; and it is the breakup and rearrangement of the cages which drives structural relaxation, letting molecules di use throughout the system. Evidence indicates that lifetime of the cages increases as conditions move tow and the glass transition, probably because cage rearrangements involve a larger num ber of molecules as the glass transition is approached [12, 13].




FIG.6: G lassy di usion in the noise-perturbed logistic map. (a) Repeated-cellm ap (thick dashed line) and trajectory (full line). (b) T in e evolution of the mean square displacement  $x_t^2$  hx<sub>t</sub>i<sup>2</sup> for an ensemble of 1000 trajectories with initial conditions random ly distributed inside [1;1]. Curves are labeled by the value of the noise amplitude.

To investigate this aspect of vitri cation in the m ap at  $_{\rm c}$  ( ), we constructed a periodic m ap via repetition of a single (cell) m ap. This setting has being used to study determ inistic di usion in nonlinear m aps, in which the trajectories m igrate into neighboring cells due to chaotic m otion. For fully chaotic m aps di usion is norm al [] but for m arginally chaotic m aps it is anom alous [14]. In our case we design the m ap in such a way that di usion is

due only to the random noise term, otherwise motion is conned to a single cell. So, we have the periodic map  $x_{t+1} = F(x_t)$ , F(l+x) = l+F(x),  $l = \dots 1$ ;0;1;..., where

Fig. 6a shows the repeated-cell m ap together with a portion of one of its trajectories. As it can be observed, the escape from the central cell into any of its neighbors occurs when F(x) j > 1 and this can only happen when > 0. As ! 0 the escape positions are con ned to values of x increasingly closer to x = 0, and for = 0 the iterate position is trapped within the cell. Likewise for any other cell. Fig. 6b shows the mean square displacement  $x_{t}^{2}$ hx<sub>i</sub><sup>2</sup> as obtained from an ensemble of trajectories initially distributed within the interval [ 1;1] for several values of noise am plitude. The progression from normaldi usion to subdi usion and to nalarrest can be plainly observed as ! 0. For small  $(10^2)$  $\mathbf{x}_{+}^{2}$ hx\_i<sup>2</sup> shows a down tum and later an uptum sim ilar to those observed in colloidal glass experiments [12] and attributed to cage rearrangements. In the map this feature re ects cell crossings.

## VI. FINAL REMARKS

A swe have shown, the dynam ics of logistic maps at the chaos threshold in the presence of noise displays elements rem iniscent of glassy dynam ics as observed in molecular glass formers. The limit of vanishing noise amplitude

! 0 (the counterpart of the limit T  $T_g$ ! 0 in the supercooled liquid) leads to loss of ergodicity. This non-ergodic state with vanishing Lyapunov coe cient  $_1=0$  corresponds to the limiting state, ! 0,  $t_x$ ! 1, of a family of small states with properties reminiscent of those in glass form ers. Some additional comments may be useful to appreciate both similarities and di erences between the two types of system s.

A ctivated dynam ics is a standard component in understanding the relaxation mechanisms of glass formation [3, 4] and so it is pertinent to note that there is a similar characteristic in the dynam ics that we studied here. It has long been known [8, 9] that the addition of external noise to a dissipative dynam ical system (here a nonlinear one-dimensional map) causes its trajectories to escape from attractors. For chaotic attractors the mean escape tim e T has an exponential A menus form

$$I \qquad T_0 \exp(E_0 = R);$$

where  $E_0$  and R are the minimum escape 'energy' and noise 'tem perature', respectively, and  $T_0$  is the inverse of the attempt rate. The di erence from the usualm olecular set up is that the escape is from the noiseless attractor and not from a minimum in the potential energy. For critical attractors, like the onset of chaos, the minimum escape energy vanishes and the escape time is expected to follow a power law with strong uctuations §, 15]. We have seen that as ! 0 an increasing number of distinct but small phase space bands are involved in an increasingly slow decay of dynamic correlations. On the other hand, in the usual picture of activated dynamics in glass formers the increase of the relaxation time as T $T_g$ ! 0 is thought to be associated to an increase in the landscape energy barriers and the assumption of some form of cooperative behavior by means of which a large number of particles are rearranged through a very slow process [3].

The structure of the phase space regions that are sam – pled by trajectories as a function of the noise am plitude resemble the manner in which a glass forming system samples its energy landscape as a function of temperature [3]. The numbers and widths of the attractor bands at noise am plitude can be thought to correspond to the numbers and extents of potential energy basins of the landscape at a given depth set by the temperature T. The 'landscape' for the attractor has certainly a very simple structure when compared to that of the multidim ensional energy landscape in a molecular system. At

= 0 there is an in nite set of minim a that consists of all the points M ! 1 of the attractor, and as increases these minima merge into nite sets of M =  $2^{N}$  () bands with N decreasing as grows. The regular merging by two in the numbers M and the features in the dynam - ics that they imprint are properties specific of logistic type maps. O therkinds of critical multifractal attractors, such as those for the critical circle map [6], would exhibit other properties characteristic of the route to chaos involved. This availability of detail would not be generally present in the measurements or numerical computation of the dynamics of a glass forming molecular system.

It is of interest to note that at  $_{\rm c}$ () the trajectories and its resultant sensitivity to initial conditions are expressed for t < t<sub>x</sub> via the q-exponentials of the T sallis q-statistics [5]. For = 0 this analytical forms are exact [10, 15] and an identity linking accordingly generalized Lyapunov coe cients and rates of entropy production, holds rigorously [11, 15]. There is nonuniform convergence related to the limits ! 0 and t ! 1 . If ! 0 is taken before t ! 1 orbits originating within the attractor remain there and exhibit fully-developed aging properties, whereas if t ! 1 is taken before ! 0 a chaotic orbit with exponential sensitivity to initial conditions would be observed.
