# A sym $m$ etry of $m$ agnetic- eld pro les in superconducting strips

#### Abstract

W e analyze the magnetic- eld pro les $\mathrm{H}_{\mathrm{z}}(\mathrm{x})$ at the upper (lower) surface of a superconducting strip in an extemalm agnetic eld, w ith $z$ perpendicular to the plane of the strip and $x$ along its $w$ idth. The extemalm agnetic eld $H a$ is perpendicular or inclined to the plane of the strip. W e show that an asym $m$ etry of the pro les $H_{z}(x)$ appears in an oblique $m$ agnetic eld $H_{a}$ and also in the case when the angular dependence of the critical current density $j_{c}$ in the superconductor is not sym $m$ etric relative to the $z$ axis. The asym $m$ etry of the pro les is related to the di erence $H \quad z(x)$ of the $m$ agnetic elds at the upper and low er surfaces of the strip, which we calculate. M easurem ent of this di erence or, equivalently, of the asymmetry of the pro les can be used as a new tool for investigation of ux-line pinning in superconductors.

## I. INTRODUCTION

In a recent Letteri' magnetic- eld pro les at the upper surface of $a$ thin rectangular $Y B \mathrm{Ca}_{2} \mathrm{Cu}_{3} \mathrm{O}_{7} \quad$ platelet placed in a perpendicular extemalm agnetic eld were investigated by $m$ agneto-opticalim aging, and the follow ing interesting observation was made: $W$ hen colum nar defects slightly tilted to the c-axis (norm al to the platelet surface) were introduced into the sam ple by heavy-ion irradiation, an asym $m$ etry of the $m$ agnetic- eld pro les relative to the central axis of the sam ple appeared, and this asym $m$ etry nonm onotonically depended on the $m$ agnitude of the extemalm agnetic_ eld $\mathrm{H}_{\mathrm{a}}$, disappearing at large $\mathrm{H}_{\mathrm{a}}$. The authors of R ef. 11 try by in-plane $m$ agnetization originating from a zigzag structure of vortiges, i.e., from their partial alignm ent along the colum nar defects. T hey also im plied that w hen the vortioes lose their interlayer coherence, the in-plane $m$ agnetization and hence the asym $m$ etry disappear. O $n$ this basis, it was claim edi that the asymm etry can be a pow erfiul probe for the interlayer coherence in superconductors. In this paper we show that the asym m etry of the magnetic eld pro les in thin at superconductors $m$ ay have a $m$ ore general origin. It $m$ ay result from anisotropy of ux-line pinning and needs not be due to the kinked structure of vortices. T he asym m etry can occur not only in layered superconductors but also in three dim ensional m aterials, and its disappearance can be understood w ithout the assum ption that the interlayer coherence is lost. Interestingly, w ithout any colum nardefects, such an asym $m$ etry ofthe $m$ agnetic eld pro-
les w as recently observed in a Nlg gn slab placed in an oblique $m$ agnetic eld ${ }^{n}$

In R ef. ${ }^{1} 14$ problem for thin at three-dim ensional superconductors w ith an arbitrary anisotropy of ux-line pinning. But these equations yield $m$ agnetic- eld pro les in the criticalstate only to the leading order in the sm allparam eter $d=w$ where $d$ is the thickness of the at superconductor
and $w$ is its characteristic lateral dim ension. In this approxim ation the $m$ agnetic- eld com ponent perpendicular to the at surfaces of the sam ple, $\mathrm{H}_{\mathrm{z}}$, is independent of the coordinate $z$ across the thickness of the superconductor and coincides $w$ ith the appropriate $m$ agnetic eld of an in nitely thin superconductor of the sam e shape fout $w$ ith som e dependence of the critical sheet current $J_{C}$ on $H_{z}$ ). A s it w illbe seen below, the asym $m$ etry of the pro-
les is related to the di erence $H_{z}$ of the elds $\mathrm{H}_{z}$ at the upper and low er surfaces of the sam ple. T hus, to describe the asym m etry of the $H_{z}$ pro les, it is necessary to consider these pro les m ore precisely, to the next order in $d=w$, taking into account the dependence of $H_{z}$ on the coordinate across the thickness of the superconductor.

In this paper we obtain formulas for $H_{z}$ and for the asym $m$ etry of the $m$ agnetic- eld pro les in an in nitely long thin strip, and discuss the conditions under which the asym $m$ etry can be observed. In particular, an asym $m$ etry alw ays w ill appear for strips in an oblique m agnetic eld, and experim ental investigation of this asym $m$ etry provides new possibilities for analyzing ux-line pinning in superconductors. W e also dem onstrate that the experim ental data of Ref. I'1 can be qualitatively understood by assum ing som e anisotropy of pinning in a three-dim ensional (not layered) superconductor.

## II. MAGNETICFIELD PROFILESOFSTRIPS

In this paper we consider the follow ing situation: A thin three dim ensional superconducting strip lls the space $\dot{\chi} j \quad w, \dot{y} j<1$, j̇j $d=2 w$ th $d \quad w ;$ a constant and hom ogeneous extemalm agnetic eld $\mathrm{H}_{\mathrm{a}}$ is applied at an angle 0 to the $z$ axis ( $\mathrm{H}_{\mathrm{ax}}=\mathrm{H}_{\mathrm{a}} \sin 0, \mathrm{H}_{\mathrm{ay}}=0$, $\left.H_{a z}=H_{a} \cos 0\right)$. For de niteness, we shall im ply below that $H_{a x}$ is $s w$ itched on rst, and then $H_{a z}$ is applied, i.e., the so-called third scenariol ${ }^{14}$ of sw itching on H a occurs (for the de nition of the nst and second scenarios see A ppendix B). It is also assum ed that surface pinning is
negligible, the thickness of the strip, $d$, exceeds the London penetration depth, and the low er critical eld $\mathrm{H}_{\mathrm{c} 1}$ is su ciently small so that wemay put B $={ }_{0} \mathrm{H}$.
$T$ he sym $m$ etry of the problem leads to the follow ing relationships:

where $j_{y}(x ; z)$ is the current density ow ing at the point $(x, z)$. In other words, the eld at the lower surface of the strip, $H_{z}(x) \quad H_{z}(x ; d=2)$, can be expressed via the eld at its upper surface, $H_{z}^{+}(x) \quad H_{z}(x ; d=2)$, as follow s:

which connects this $H_{z}(x)$ and the asymm etry of the $m$ agnetic- eld pro le at the upper surface of the strip.

A $s m$ entioned in the Introduction, to leading order in $d=w$ the critical state problem for such a strip can be reduced to the criticalstate problem for the in nitely thin strip w ith som e dependence of the critical sheet current $J_{c}$ on $H_{z}$ where the sheet current is the current density integrated over the thickness of the strip,

and $J_{c}$ is its critical value. The dependence $J_{C}\left(H_{z}\right)$ results from both a dependence of the critical current density $j_{c}$ on the absolute value of the localm agnetic induction 0 fi jand an out-of-plane anisotropy of $j_{c}$, i.e., a dependence of $j_{c}$ on the angle between the localdirection of $H$ and the $z$ axis. Sinceboth $f$ jand changewith $z$ in strips of nite thickness, this $m$ eans that $J_{c} j_{c} d$, and a dependence of $J_{C}$ on $H_{z}$ appears, $T$ he function $J_{C}\left(H_{z}\right)$ can be found from the equation

$w$ here the critical current density $j_{c}\left(H_{x} ; H_{z}\right) m$ ay have arbitrary dependence on the local $\mathrm{H}_{\mathrm{x}}$ and $\mathrm{H}_{\mathrm{z}}$; $\mathrm{H}_{\mathrm{x}}=$ $H_{a x} \quad 0: 5 \mathrm{~J}_{\mathrm{c}}\left(\mathrm{H}_{\mathrm{z}}\right)$, and $\mathrm{H}_{\mathrm{x}}^{+}=\mathrm{H}_{\mathrm{ax}}+0: 5 \mathrm{~J}_{\mathrm{c}}\left(\mathrm{H}_{\mathrm{z}}\right)$ are the $x$ com ponent of the $m$ agnetic eld at the lower and the upper surfaces of the strip. T he function $J_{C}\left(H_{z}\right)$ found from Eq. $\overline{\text { (2, }}$ ) generally depends on the param eter $\mathrm{H}_{\mathrm{ax}}$, and only within the Bean $m$ odelwhen $j_{c}$ is independent of $H$, equation $(\underline{i}-1) y$ ields $J_{C}=j_{c} d$ for any $H$ ax .

Form ula ( $\overline{2}_{1}$ ) is valid to the leading order in $d=w$ since we neglected the term $@ H_{z}(x ; z)=@ x$ in the equation rotH $=j$ and used the expression

$w$ th $j_{y}(x ; z)=j_{c}\left(H_{x} ; H_{z}\right)$ to derive form ula (2, $)$. In this approxim ation $\mathrm{H}_{\mathrm{z}}$ is independent of z inside the strip. Thus $H_{z}(x)=0$, and so the $H_{z}$ pro le is alw ays sym $m$ etric. This pro le is given by the B iot-Savart law for the in nitely thin strip

when $\mathrm{k} j$ a. Thepoints $x=$ a give the position of the ux front in the in nitely thin strip. The integral equations ( $\overline{4}, \mathbf{1})$ - (G) can be solved by either a static iteratipe $m$ ethod, or $\bar{m}$ ore conveniently by a dynam ic $m$ ethod ${ }^{515}$
An analysis of $H_{z}$ allow ing for term $s$ of the order of $d=w$ is presented in A ppendix $A$. In this case $H_{z} \in 0$, and it is given by

Inserting this expression into form ula (i, $\mathbf{q}_{1}$ ), interchanging the sequence of the integrations, and using $H_{x}(x ; d=2)=H_{a x} \quad 0: 5 J(x)$, we nd formula' $\left.{ }^{-1} 7\right)$. It follow sfrom this form ula that an asym $m$ etry of the $\mathrm{H}_{\mathrm{z}}$ pro le can appear only if the distribution of the current density $j_{y}$ across the thickness of the strip is asym $m$ etric about the $m$ iddle plane of the strip, $z=0$, and if this distribution changes, w ith x (the latter condition was not obtained in Ref. (1'1) ${ }^{1} \mathbf{n}^{\prime \prime}$

## III. CONDITIONSEOR ASYMMETRY

If the angular dependence of the critical current density is sym $m$ etric relative to the $z$ axis, $j_{c}\left(H_{x} ; H_{z}\right)=$ $j_{c}\left(\mathrm{H}_{\mathrm{x}} ; \mathrm{H}_{\mathrm{z}}\right)$, an asymmetry of the current distribution across the thickness of the strip can occur only in an oblique applied $m$ agnetic eld which breaks the relation $H_{x}(x ; z)=H_{x}(x ; z)$. Besides this, asym $m$ etry of the distribution can appear for asym $m$ etric angular dependence of $j_{c}, j_{c}\left(H_{x} ; H_{z}\right) \not j_{c}\left(H_{x} ; H_{z}\right)$, even when the extemalmagnetic eld is applied along the $z$ axis. In this section we consider the case of an oblique $m$ agnetic eld.

For a superconducting strip in an oblique $m$ agnetic eld, it was shown recently that in the region of the strip, jxj a, where a ux-free core occurs, i.e., where $H_{z} \quad 0$, the distribution of the current across the thickness of the sam ple is highly asym $m$ etric even for superconductorsw ith H -independent $j_{c}$ (the B ean m odel). U sing this distribution (which depends on how the m agnetic eld is sw itched on) and Eq.
$H_{z}(x)$ in this region of the strip. N ote that the results of such calculations $m$ ay be also applied to anisotropic strips with $j_{c}=j_{c}()$ since in this region of the strip the ux lines practically lie in the $x-y$ plane, $\dot{j}$ is independent of the coordinates, $j_{c} \quad \dot{j}(=2)$, and the results for the ux-free core obtained $w$ ith in the $B$ ean $m$ odel rem ain applicable to this anisotropic case. In Fig. I'11 we present this $H_{z}(x)$ for the anisotropic strip in the case of the third scenario ${ }^{n_{1}^{4}}$ of sw itching on $\mathrm{H}_{\mathrm{a}}$ when the eld $\mathrm{H}_{\mathrm{ax}}$ is sw itched on rst and then the com ponent $H_{a z}$ is applied, see A ppendix B. Thus, a nonzero $H_{z}$ in this region of the sample re ects the asymm etry of the ux-free core, and this $\mathrm{H}_{\mathrm{z}}$ di ens from zero in an oblique $m$ agnetic eld for any superconductor.
Thequantity $H_{z}(x)$ in the region $j x j<a$ depends on how the extemalm agnetic eld is sw itched on. In particular, when $H_{a x}$ is applied before $H_{a z}$ (the third scenario) and $j_{c} d=2<H_{a x}, H_{z}(x)$ is described by Eq. (B 9). On the other hand, for the sam e applied eld but with $\mathrm{H}_{\mathrm{ax}}$ and $\mathrm{H}_{\mathrm{az}}$, sw itched on sim ultaneously (the so-called rst scenari'('), we obtain from form ulas of Ref. ${ }^{1}$ jxj<asin 0

C om parison ofeqs. (B 9) and $(\overline{9})$ dem onstrates that m easurem ents of the asym $m$ etry of the $H_{z}$ pro les at the upper surface of the strip enable one to investigate subtle di erences betw een critical states generated by di erent scenarios of sw itching on $\mathrm{H}_{a}$ (to the leading order in the sm all param eter $\mathrm{d}=\mathrm{w}$ one has $\mathrm{H}_{\mathrm{z}}=0$ at $\mathrm{j} \mathrm{j}<$ a for any scenario). N ote also that form ulas of type (B 9) [or $(\underline{(\underline{9}})$ ]

perm it one to nd the sheet current $J(x)$ in the region $j \mathrm{j}<$ a from $\mathrm{H}_{\mathrm{z}}$.

C onsider now the region of the strip penetrated by $\mathrm{H}_{\mathrm{z}}, \mathrm{a}$ jxj w, i.e., the region where the com ponent $H_{z}$ di ers from zero. In this case it is usefulto represent Eq. $\left(\overline{7}_{1}\right)$ in another form, using the solution $\mathrm{H}_{\mathrm{x}}\left(\mathrm{z} ; \mathrm{H}_{\mathrm{z}}(\mathrm{x})\right)$ of Eq. (i-3). This solution is im plicitly given by

 ing Eq. (1-9), we can transform the integration over $z$ in Eq. ( $\mathbf{I V}_{1}$ ) into an integration over $\mathrm{H}_{\mathrm{x}}$. A fter a sim ple m anipulation, we obtain

It is clear from this form ula that $H_{z}$ depends on $x$ via the function $H_{z}(x)$, i.e., $H_{z}$ has the form : $H_{z}=d$ $\left(\mathrm{dH} \mathrm{z}_{\mathrm{z}}=\mathrm{dx}\right) \mathrm{F}\left(\mathrm{H}_{\mathrm{z}}\right)$ where F is som e dim ensionless function of $H_{z}$.

W ithin the Bean model when $j_{c}$ is independent of $H$ and $J_{c}=j_{c} d$ ，equation（ $1 \overline{1}_{1}^{\prime}$ ）yields $H_{z}(x)=0$ ，and hence the asym $m$ etry of the pro les $H_{z}(x)$ in the fiully penetrated region of the strip is absent for any $H_{a x}$ ．The asym $m$ etry appears only if there is a dependence of $j_{c}$ on jH jor ifthere is an anisotropy ofpinning（or it m ay result from both reasons）．If $j_{c}\left(H_{x} ; H_{z}\right)=j_{c}\left(H_{x} ; H_{z}\right)$ ，i．e．，if the angular dependence of the critical current density is sym $m$ etric relative to the $z$ axis，it follow from form ula （111）that $\mathrm{H}_{\mathrm{z}}(\mathrm{x})=0$ at $\mathrm{H}_{\mathrm{ax}}=0$ ．In other words， for such $j_{c}\left(\mathrm{H}_{\mathrm{x}} ; \mathrm{H}_{z}\right)$ the asym $m$ etry of the $m$ agnetic－eld pro les can appear only in an oblique $m$ agnetic eld．At sm all $\mathrm{H}_{\mathrm{ax}}$ ，Eq．（111）yields

which，in principle，enables one to reconstruct the func－ tion $j_{c}\left(H_{x} ; \mathrm{H}_{\mathrm{z}}\right.$ ）（up to a constant）ifthe function $\mathrm{H}_{\mathrm{z}}(\mathrm{x})$ at $s m$ all $H_{a x}$ and the functions $H_{z}(x)$ and $J_{C}\left(H_{z}\right)$ at $\mathrm{H}_{\mathrm{ax}}=0$ are known．Here $\mathrm{H}_{\mathrm{x}}=\mathrm{J}_{\mathrm{C}}\left(\mathrm{H}_{\mathrm{z}}\right)=2$ ，and $\mathrm{H}_{\mathrm{z}}=$ $H_{z}\left(\mathrm{x}_{0}\right)$ ．The integration in Eq．（13）is carried out over the region where $H_{z} \in \Omega_{1}$ ．

It was show $n$ recently $y^{4_{1}^{1}}$ that in the case of - dependent $j_{c}$ the $m$ agnetic eld pro les at the upper surface of the strip generally depend on the scenario of sw itching on the oblique magnetic eld．In Ref．${ }_{1}^{\prime 4}$ the pro les were analyzed to the leading order in $d=w$ ，and so they were alw ays symm etric in $x, H_{z}(x ; d=2)=H_{z}(x ; d=2)$ ．For－ $m$ ula（121），which describes the antisym $m$ etric part of the pro les（this part appears to the next order in $d=w$ ）， has been derived under the assum ption that the sign of $j_{y}$ rem ains unchanged across the thickness of the strip． This assum ption is indeed valid for the third scenario discussed in this paper．H ow ever，there exist scenarios， see，e．g．，Ref． $\bar{I}_{1}^{1} 1$, when $j_{y}(x ; z)$ changes its sign at some boundary $\mathrm{z}=\mathrm{z}_{\mathrm{C}}(\mathrm{x})$ ．It is this boundary that causes the di erence betw een the pro les for the di erent soenarios． O f course，the existence of this boundary also im plies a modi cation of form ula $(\underline{1} \ddagger)$ ．Thus，we expect that if for som e scenarios the sym $m$ etric parts of the $\mathrm{H}_{\mathrm{z}}$ pro les di er，their antisym $m$ etric parts have to di er，too．
Them agnetic－eld pro les at the upper surface of the strip are obtained either by $m$ agneto－opticis，see，e．g．， Ref．
les，errablia－Qnep－ten nd the sheet－current distribution
 In $R$ ef．＇I＇we discussed a way how to determ ine $j_{c}$ from $J_{c}\left(\mathrm{H}_{z}\right)$ ．In this context，$m$ easurem ents of $H_{z}(x)$ in oblique $m$ agnetic elds can provide additional inform a－ tion on the ux－line pinning in superconductors w hen the critical current density $j_{c}$ depends on the $m$ agnitude or direction of the $m$ agnetic eld．

To dem onstrate this，we com pare $H_{z}(x)$ for tw o types of pinning：For the rst type the critical current density depends only on the combination $\ddagger \mathrm{j}$ joos $=\mathrm{H}_{\mathrm{z}}$ where is the angle betw een the local direction of $H$ and the $z$ axis；for the second type $j_{c}$ is a function of only．The
rst situation occurs for the case of weak collective pin－ ning by point defects in the sm allbundle pinning regim e $w$ hen the scaling approach is valid $1^{111}$ ．In this case $j_{c}$ de－ pends on the combination $j$ j $\left(\cos ^{2}+{ }^{2} \sin ^{2}\right)^{1=2}$ which practically coincidesw ith H jcos $=\mathrm{H}_{\mathrm{z}}$ ifthe an isotropy param eter is sm all．Then，equation（ 1

i．e．，the asym $m$ etry is absent in the region $\dot{x} j>$ a for this type ofpinning．H ere we have taken into account that in this situation Eq．（Z己⿱⿰㇒一大口1）reduces to $J_{C}\left(H_{z}\right)=d j_{c}\left(H_{z}\right) . W e$ are com ing now to an analysis of $H_{z}(x)$ for the second type of pinning．

## C．$j_{c}$ depends only on the direction of $H$

Let us consider m ore closely the case when $j_{c}$ depends only on,$j_{c}=j_{c}()$ ，where is the angle betw een the $0-$ caldirection of $H$ and the $z$ axis．In otherwords，we shall analyze the situation when the dependence of $j_{c}$ on $j$ j $j$ is negligible．T his approxim ation can be justi ed for not too thick sam plesw ith anisotropic pinning ${ }^{14}$ H ere we also assum $e$ the symmetry $j_{c}()=j_{c}(\quad)$ ．In this case，one can express the dependence of the criticalcurrent density $j_{c}$ on and the dependence of $J_{c}$ on $H_{z_{2}}$－at $H_{a x} \in 0$ in term softhe function $J_{C}\left(H_{z}\right)$ at $H_{\text {ax }}=0$, C．T he quantity $\mathrm{H}_{\mathrm{z}}(\mathrm{x})$ ，Eq．$\left(1 \overline{1}_{1}^{\prime}\right)$ ，is also expressible in term $\operatorname{sof} J_{C}\left(H_{z} ; 0\right)$ ，the sheet current $J_{C}\left(H_{z}\right)$ at $H_{a x}=0$ ，

W enow present an exam ple ofsuch calculations for this type ofpinning．Let at $\mathrm{H}_{\mathrm{ax}}=0$ the follow ing dependence $J_{C}\left(\mathrm{H}_{\mathrm{z}}\right)$ be extracted from som e experim ental $m$ agneto－ optics data：

easily verify that the corresponding angular dependence of the critical current density takes the form :

$w$ here $t$ is a curve param eter $w$ ith range $0 \quad t \quad 1$. $T$ his dependence $j_{c}()$ is presented in $F$ ig, the function $J\left(\mathrm{H}_{z}\right)$, Eq. (1]). N ote that for $p>0$ the character of this dependence $j_{c}()$ is typical of layered high $-T_{c}$ superconductors, ${ }^{\frac{1}{2}}$ i.e., $j_{c}$ is largest for $==2$. The pro les $H_{z_{2}}(x)$ that correspond to this $J_{C}\left(H_{z}\right)$ are shown in $F$ ig. ${ }^{3}$. In $F$ igs. 2 and 3 we also show the dependences of $J_{c}$ on $H_{z}$ for $H_{a x} \in 0$ and appropriate $m$ agnetic- eld pro les in an oblique $m$ agnetic eld. $W$ ith the use ofE qs. (C-2 $\left.{ }^{(1)}\right),\left(1 \bar{L}_{1}^{\prime}\right)-\left(\overline{1} \overline{\sigma_{1}}\right)$, we calculate the quantity $\left(\mathrm{H}_{\mathrm{z}}=\mathrm{d}\right)\left(\mathrm{dH}_{\mathrm{z}}=\mathrm{dx}\right)^{1}$ as a fiunction of $\mathrm{H}_{\mathrm{z}}, \mathrm{F}$ ig. $\mathrm{I}_{1}^{\prime 1}$. Interestingly, even at not too sm all H ax $<0: 4 \mathrm{j}_{\mathrm{c}}(0) \mathrm{d}$, form ula (1-15인) gives reasonable results. An exam ple of the asym $m$ etry of the $H_{z}-$ pro les at the upper surface of the strip is presented in $F$ ig. 1. This asym $m$ etry is found from the data of Fig . 4, the known derivative $\mathrm{dH}_{\mathrm{z}}(\mathrm{x})=\mathrm{dx}, \mathrm{F}$ ig. 3, and form ulas of A ppendix B (when $\dot{x} j<a$ ). Note that the steepness of $H_{z}(x)$ near $x=$ a has a pronounced effect on the form of $H_{z}(x)$ (and this steepness essentially depends ${ }^{3}$ on the sign ofp). Thediscontinuities of $H_{z}(x)$ at $x=a, 0, w$ are caused by the inapplicability of our form ulas for $H_{z}$ there. For com parison, we also show $H_{z}(x)$ and the pro les $H_{z}(x ; 0)$ and $H_{z}(x ; d=2)$ calculated directly by solving the two-dim ensional critical state problem for a strip of nite thicknesssi In this two-dim ensional calculation the discontinuities of $\mathrm{H}_{\mathrm{z}}$ are sm oothed out on scales of the order of $d$.

## IV. STRIP $W$ IT H IN CLINED DEFECTS IN PERPEND ICULAR MAGNETIC FIELD

In a recent Letteri' ${ }^{\overline{1}}{ }^{1}$ the position of the so-called central $d$-line (the discontinuity line) at the upper surface of a thin rectangular $\mathrm{Y} \mathrm{Ba}_{2} \mathrm{Cu}_{3} \mathrm{O}_{7} \quad$ platelet $w$ asm easured by $m$ agneto-opticalim aging. In this d-line the sheet current changes its sign and the $m$ agnetic eld $\mathrm{H}_{\mathrm{z}}$ reaches an extrem um (a m inim um). W hen colum nar defects tilted to the $c$-axis were introduced into the sam ple, the $d$-line shifted relative to the centralaxis of the platelet $\frac{h_{1}}{2}$ and the value of this shift rst increased and then decreased w ith increasing perpendicular $m$ agnetic eld. A s m entioned in the Introduction, the authors of $R$ ef. '1, '1, explained the shift by the in-plane $m$ agnetization originating from a zigzag structure of vortices, and the disappearance of the $m$ agnetization and of this shift by loss of their interlayer

coherence. It is clear that the shift of the $d$-line re ects the asymm etry of the $m$ agnetic eld pro les at the upper surface of the sam ple.
The zigzag structure of vortioes occurs when the tilt angle of the local $H$ to the direction of the colum,nar defects is less than the so-called trapping angle $t^{22}$ In this case a $m$ isalignm ent of the localH and the averaged direction of the kinked ux lines appears, and this $m$ is alignm ent is of the order of ${ }^{2}\left(\mathrm{H}_{\mathrm{c} 1}=\mathrm{H}\right)(\mathrm{t} \quad)$ where $\mathrm{H}_{\mathrm{c} 1}$ is the lower critical eld and is the anisotropy param eter of the superconductor. T hem isalignm ent generates an in-planem agnetization $\mathrm{M}_{\mathrm{x}} \quad{ }^{2} \mathrm{H}_{\mathrm{cl}}\left(\mathrm{R}_{\mathrm{d}=2}\right)$, and hence one $m$ ay expect that $H_{z} \quad(d=d x){ }_{d=2}^{R_{d=2}} M_{x} d z$; see Eq. $\left(\bar{T}_{1}\right)$. N ote that if ! 0 (the interlayer coherence is lost), $H_{z}$ tends to zero. This is just the $m$ echanism of the asymm etry discussed in Ref. ${ }_{1} 11$ ' 1 and in this consideration the asym $m$ etry is due to the equilibrium part of the in-plane $m$ agnetization. H ow ever, in our approxim ation, when $H \quad H_{c 1}$ and $B={ }_{0} H$, we neglect the $m$ isalignm ent, the elds of the order of $\mathrm{H}_{\mathrm{C} 1}$, and the equilibrium part of m agnetization. In our approach we take into account only the nonequilibrium part ofm agnetization, which also generates an asym $m$ etry. This asym $m e-$ try can occur even if $H_{c 1}!0$.

In Sec. III we have considered the case when the angular dependence of $j_{c}$ is symmetric about the $z$ axis $\left[j_{c}(\quad)=\dot{j}()\right]$, and the asym $m$ etry of the $H_{z}$ pro les is caused by an inclined applied $m$ agnetic eld. H ow ever, such asym $m$ etry can also result from the \opposite" situation when the applied eld is along the $z$ axis while pinning is not sym $m$ etric about this axis. It is this situation that occurs w hen colum nar defects are introduced at an angle ${ }_{1}$ to the $z$ axis. In this case $j_{c}()$ in the interval

$j \quad j \quad j \quad 1 j<t$ is larger than outside this interval. $T$ he enhancem ent of $j_{c}$ in this interval is caused by the zigzag structure of vortices when a part of their length is trapped by strong colum nar defects, while outside the interval pinning by the colum nar defects is ine ective. Since ux lines are curved in the critical state, this enhancem ent of $j_{c}$ leads to an asym $m$ etry of the currentdensity distribution across the thickness of the strip, and thus to a nonzero $\mathrm{H}_{\mathrm{z}}$. W e carry out the calculation of the asym $m$ etry of the $H_{z}$ pro les at the upper surface of the strip and of the shift of the $d$-line for the follow ing dependence $j_{c}()$ :

which models an increased ux-line pinning by colum nar defects at angles near ${ }_{1}, F$ ig. ${ }_{1}{ }_{1}$. $H$ ere $p_{1}$ and $q_{1}$

are som e positive dim ensionless param eters ( $q_{1} \quad t^{2}$ ), and $j_{c 0}$ is the current density in a sam ple w thout colum nar defects (jco describes, e.g., pinning by point defects). A though form ulas ( $\left[_{1}\right.$ ) and (11) are still valid for thin strips w ith such $j_{c}()$, these form ulas fail near the $d$-line, and so we carry out calculations of $\mathrm{H}_{\mathrm{z}}$ here, using the num erical solutionsic of the tw o-dim ensional critical state problem for a strip of nite thickness. In Fig. 5 we show the current and $m$ agnetic- eld distributions in the strip w ith pinning described by Eq. (1'q), while in Fig. 'G the $H_{z}$ pro les and the shift of the d-line are presented.

In F ig. 6 the decrease of the shift w ith increasing Ha can be qualitatively explained as follow s: $T$ he characteristic angle of the curved ux lines in the strip is of the order of $j_{c o} d=H_{z}$ [i.e., form ost of the ux-line elem ents lies in the interval ( $j_{0} d=H_{z}$ ) $<~\left(j_{0} d=H_{z}\right)$ ]. W hen the extemalm agnetic eld increases, this angle decreases and tends to zero. Thus, the ux-line pinning (the current distribution) becom es practically uniform across the thickness of the sam ple at su ciently large $\mathrm{H}_{\mathrm{az}}$, and the shift van ishes. T hese considerations are valid for any type
of anisotropic pinning, but there is one $m$ ore reason for the disappearance of the shiff in sam ples w ith colum nar defects: $W$ hen ${ }_{1}>t$ and $j_{c 0} d=H_{z}$ is less than ${ }_{1} \quad t$, the zigzag structure of vortioes disappears in the sam ple, and the ux-line pinning by these defects becom es ineffective. T he trapping angle determ ining the width of the peak in $j_{c}$ decreases with increasing $H$ as som e pow er of $H=H$ if the applied eld is of the order of the $m$ atching
eld $H$-(H) is a m easure of the density of the colum nar defects) ${ }^{221}$ Thus, if $t>1$ at $H=0$, the disappearance of the shift can occur at som em agnetic eld associated w ith H . This is just observed in the experim ent ${ }^{12^{1}} \mathrm{~N}$ ote that in this case the disappearance of the shift is due to the disappearance of the zigzag structure of vortioes in the superconductor rather than to the loss of the interlayer coherence.
$F$ inally, we em phasize the unresolved problem of the analysis presented in this section: $T$ he shiff calculated for the experim ental ratio ${ }^{1_{1}} \quad(\mathrm{~d}=\mathrm{w}) \quad$ 0:06 is noticeably less than the experim entally observed shift ( $\mathrm{H}_{\mathrm{z}}$ decreases w th decreasing d). A variation of the param eters $\mathrm{p}_{1}$ and $q_{1}$ in Eq. (18) cannot change this conclusion. For exam ple, although the $m$ axim um value of the function $\dot{x}_{\mathrm{m}}$ in ( H ) $j$ increases $w$ ith $p_{1}$, it tends to a lim it of the order of $(d=2)$ tan 1 at $p_{1} \quad 1$; see $F i g .6$.

## V. CONCLUSIONS

We have considered $H_{z}$ pro les at the upper surface of a thin strip whose thickness $d$ is much less than its width 2 w . To the leading order in $d=w$, these pro les are symmetric in $x, H_{z}(x ; d=2)=$ $H_{z}(x ; d=2)$. However, the analysis to the next order in this $s m$ all param eter reveals the asym $m$ etry of the pro les, $H_{z}(x ; d=2) \quad H_{z}(x ; d=2)$, which coincides w ith
$H_{z}(x) \quad H_{z}(x ; d=2) \quad H_{z}(x ; d=2)$, the di erence of $H_{z}$ at the upper and low er surfaces of the strip. $W$ e calculate
$H_{z}(x)$ and show that this $H_{z}$ di ens from zero in an oblique magnetic eld $\mathrm{H}_{\mathrm{a}}=\left(\mathrm{H}_{\mathrm{ax}} ; 0 ; \mathrm{H}_{\mathrm{az}}\right.$ ) and depends on the scenario of sw itching on this eld. For de niteness, we analyze in detail the so-called third scenaria ${ }^{\prime 4}$ when $H_{a x}$ is sw itched on before $H_{a z}$.

In the region $j x j<a$ where the ux-free core occurs [w here the sym $m$ etric part of $H_{z}(x)$ is alm ost equal to zero], the asym $m$ etry of the $H_{z}$ pro les exists even for the $H$-independent $j_{c}$ (the Bean m odel) and is due to the asym $m$ etric shape of the ux-free core in the oblique $m$ agnetic eld. Outside this region ( $k j>$ a) the asym $m e-$ try appears only if $j_{c}$ depends on the $m$ agnitude of the local magnetic induction or if there is an out-ofplane anisotropy of $j_{c}$. The asym $m$ etry of the $m$ agnetic eld pro les in oblique m agnetic elds was observed in R e see also Fig. 3 e in Ref. 2 l 3.
An asym $m$ etry ofthe $\mathrm{H}_{\mathrm{z}}$ pro lesalso appearsw hen the ux-line pinning is not sym $m$ etric about the nom al to the strip plane (about the z axis). This situation occurs when inclined colum nar defects are introduced into the
strip. In this context we have discussed the experim ental data of Itaka et all ${ }^{1+1}$ It is show $n$ that although these data can be qualitatively understood from our results, there is a quantitative disagreem ent betw een the experim ental and theoretical results on the d-line shift.
