A symmetry of magnetic-eld pro les in superconducting strips

We analyze the magnetic-eld proles H $_z$ (x) at the upper (lower) surface of a superconducting strip in an external magnetic eld, with z perpendicular to the plane of the strip and x along its width. The external magnetic eld H $_a$ is perpendicular or inclined to the plane of the strip. We show that an asymmetry of the proles H $_z$ (x) appears in an oblique magnetic eld H $_a$ and also in the case when the angular dependence of the critical current density j_c in the superconductor is not symmetric elds at the upper and lower surfaces of the strip, which we calculate. M easurement of this di erence or, equivalently, of the asymmetry of the proles can be used as a new tool for investigation of ux-line pinning in superconductors.

I. IN TRODUCTION

In a recent Letter¹ magnetic - eld pro les at the upper surface of a thin rectangular Y B a_2 C u_3 O $_7$ platelet placed in a perpendicular external magnetic eld were investigated by m agneto-optical in aging, and the follow ing interesting observation was made: W hen colum nar defects slightly tilted to the c-axis (norm alto the platelet surface) were introduced into the sample by heavy-ion irradiation, an asymmetry of the magnetic-eld pro les relative to the central axis of the sam ple appeared, and this asymm etry nonmonotonically depended on the magnitude of the external magnetic eld Ha, disappearing at large H_a. The authors of Ref. 1 explained the asym metry by in-plane magnetization originating from a zigzag structure of vortices, i.e., from their partial alignment along the colum nar defects. They also in plied that when the vortices lose their interlayer coherence, the in-plane m agnetization and hence the asymmetry disappear. On this basis, it was claim ed¹ that the asymmetry can be a powerful probe for the interlayer coherence in superconductors. In this paper we show that the asymmetry of the magnetic eld pro les in thin at superconductors m ay have a m ore general origin. It m ay result from anisotropy of ux-line pinning and needs not be due to the kinked structure of vortices. The asymmetry can occur not only in layered superconductors but also in three dimensional materials, and its disappearance can be understood without the assumption that the interlayer coherence is lost. Interestingly, without any colum nar defects, such an asymmetry of the magnetic eld proles was recently observed in a Nb, Sn slab placed in an

oblique magnetic eld².

In Ref. 3,4 we explained how to solve the critical state problem for thin at three-dimensional superconductors with an arbitrary anisotropy of ux-line pinning. But these equations yield magnetic-eld proles in the critical state only to the leading order in the small parameter d=w where d is the thickness of the at superconductor and w is its characteristic lateral dimension. In this approximation the magnetic-eld component perpendicular to the at surfaces of the sample, H_z , is independent of the coordinate z across the thickness of the superconductor and coincides with the appropriate magnetic eld of an in nitely thin superconductor of the same shape (but with some dependence of the critical sheet current J_c on H_z). As it will be seen below, the asymmetry of the pro-

les is related to the di erence H_z of the elds H_z at the upper and low er surfaces of the sample. Thus, to describe the asymmetry of the H_z proles, it is necessary to consider these proles more precisely, to the next order in d=w, taking into account the dependence of H_z on the coordinate across the thickness of the superconductor.

In this paper we obtain form ulas for H_z and for the asymmetry of the magnetic-eld proles in an in nitely long thin strip, and discuss the conditions under which the asymmetry can be observed. In particular, an asymmetry always will appear for strips in an oblique magnetic eld, and experimental investigation of this asymmetry provides new possibilities for analyzing ux-line pinning in superconductors. We also demonstrate that the experimental data of Ref. 1 can be qualitatively understood by assuming some anisotropy of pinning in a three-dimensional (not layered) superconductor.

II. MAGNETIC-FIELD PROFILES OF STRIPS

In this paper we consider the following situation: A thin three dimensional superconducting strip lls the space jkj w, jyj < 1, jzj d=2 with d w; a constant and hom ogeneous external magnetic eld H_a is applied at an angle 0 to the z axis ($H_{ax} = H_a \sin 0, H_{ay} = 0$, $H_{az} = H_a \cos 0$). For de niteness, we shall im ply below that H_{ax} is switched on rst and then H_{az} is applied, i.e., the so-called third scenario⁴ of switching on H_a occurs (for the de nition of the rst and second scenarios see Appendix B). It is also assumed that surface pinning is

negligible, the thickness of the strip, d, exceeds the London penetration depth, and the lower critical eld H_{c1} is su ciently small so that we may put $B = {}_0H$.

The symmetry of the problem leads to the following relationships:

where $j_y(x;z)$ is the current density owing at the point (x,z). In other words, the eld at the lower surface of the strip, $H_z(x) = H_z(x; d=2)$, can be expressed via the eld at its upper surface, $H_z^+(x) = H_z(x; d=2)$, as follows:

and hence for the di erence $H_z(x) = H_z^+(x) = H_z(x)$ of the elds at the upper and lower surfaces we obtain the form ula

which connects this H $_{\rm z}$ (x) and the asymmetry of the magnetic-eld prole at the upper surface of the strip.

A sm entioned in the Introduction, to leading order in d=w the critical state problem for such a strip can be reduced to the critical state problem for the in nitely thin strip with some dependence of the critical sheet current $J_{\rm c}$ on H $_{\rm z}$ where the sheet current is the current density integrated over the thickness of the strip,

and J_c is its critical value. The dependence J_c (H $_z$) results from both a dependence of the critical current density j_c on the absolute value of the local magnetic induction $_0$ H jand an out-of-plane anisotropy of j_c , i.e., a dependence of j_c on the angle between the local direction of H and the z axis. Since both H jand change with z in strips of nite thickness, thism eans that $J_c \in j_c d$, and a dependence of J_c on H $_z$ appears. The function J_c (H $_z$) can be found from the equation,^{3,4}

where the critical current density $j_c(H_x;H_z)$ may have arbitrary dependence on the local H_x and $H_z; H_x =$ $H_{ax} = 0.5J_c(H_z)$, and $H_x^+ = H_{ax} + 0.5J_c(H_z)$ are the x component of the magnetic eld at the lower and the upper surfaces of the strip. The function $J_c(H_z)$ found from Eq. (2) generally depends on the parameter H_{ax} , and only within the Bean model when j_c is independent of H, equation (2) yields $J_c = j_c d$ for any H_{ax} . Formula (2) is valid to the leading order in d=w since we neglected the term $(H_z(x;z)=0x)$ in the equation roth = j and used the expression

with $j_y(x;z) = j_c(H_x;H_z)$ to derive form ula (2). In this approximation H_z is independent of z inside the strip. Thus $H_z(x) = 0$, and so the H_z pro le is always symmetric. This pro le is given by the Biot-Savart law for the in nitely thin strip

Here the sheet current J(x) follows from the critical state equations for this strip:

when $\dot{\mathbf{x}}$ j a. The points \mathbf{x} = a give the position of the ux front in the in nitely thin strip. The integral equations (4) - (6) can be solved by either a static iterative m ethod, or more conveniently by a dynam ic m ethod.^{5,6}

An analysis of H $_z$ allowing for terms of the order of d=w is presented in Appendix A. In this case H $_z$ \in 0, and it is given by

This expression can be also derived from the following $\sin p \ln considerations: U \sin q \operatorname{div} H = 0$, we write

From Eq. (3) it follows that

Inserting this expression into formula (8), interchanging the sequence of the integrations, and using $H_x(x; d=2) = H_{ax} = 0.5J(x)$, we nd formula (7). It follows from this formula that an asymmetry of the H_z prole can appear only if the distribution of the current density j_y across the thickness of the strip is asymmetric about the middle plane of the strip, z = 0, and if this distribution changes with x (the latter condition was not obtained in Ref. 1).⁷

III. CONDITIONSFOR ASYMMETRY

If the angular dependence of the critical current density is symmetric relative to the z axis, $j_c (H_x; H_z) = j_c (H_x; H_z)$, an asymmetry of the current distribution across the thickness of the strip can occur only in an oblique applied magnetic eld which breaks the relation $H_x(x; z) = H_x(x; z)$. Besides this, asymmetry of the distribution can appear for asymmetric angular dependence of j_c , $j_c (H_x; H_z) \in j_c (H_x; H_z)$, even when the external magnetic eld is applied along the z axis. In this section we consider the case of an oblique magnetic eld.

A. Region where H $_z$ 0




FIG.1: A symmetry of the magnetic eld prole H $_z(x)$ at the upper surface of a thin strip with d = 0:1w and $j_c()$ given by Eq. (17) with p = 1, q = 4, see Fig.2. Here H $_{az}$ = 0:4, H $_{ax}$ = 0.5; the magnetic elds are measured in units of $j_c(0)$ d. The dash-dot line shows 3 H $_z(x)$ calculated with Eq. (14) and form ulas of A ppendix B. The discontinuities of this line seen at x = 0, x = a, and x = w are due to inapplicability of our approximation in the vicinity of these points. For com – parison, the solid line with dots shows 3 H $_z(x)$ calculated directly by solving the two-dimensional critical state problem ⁶ (creep exponent = 200 1; London depth = 0:1d). The dashed line and the solid line without dots give the proles H $_z(x;0)$ and H $_z(x;d=2)$, obtained directly from this solution of the two-dimensional problem.

For a superconducting strip in an oblique magnetic eld, it was shown recently that in the region of the a, where a ux-free core occurs, i.e., where strip, ix j 0, the distribution of the current across the thick-Ηz ness of the sam ple is highly asymmetric even for superconductors with H -independent jc (the Bean m odel). Using this distribution (which depends on how the magnetic eld is switched on) and Eq. (7), one can calculate $H_z(x)$ in this region of the strip. Note that the results of such calculations may be also applied to an isotropic strips with $j_c = j_c$ () since in this region of the strip the ux lines practically lie in the x-y plane, i is indepen- $\frac{1}{2}$ (=2), and the results for dent of the coordinates, jc the ux-free core obtained within the Bean model remain applicable to this anisotropic case. In Fig. 1 we present this $H_z(x)$ for the anisotropic strip in the case of the third scenario⁴ of switching on H_a when the eld H_{ax} is switched on rst and then the component H_{az} is applied, see Appendix B. Thus, a nonzero H_z in this region of the sample re ects the asymmetry of the ux-free core, and this Hz di ers from zero in an oblique magnetic eld for any superconductor.

The quantity $H_z(x)$ in the region $\dot{x}_j < a$ depends on how the external magnetic eld is switched on. In particular, when H_{ax} is applied before H_{az} (the third scenario) and $\dot{j}_c d=2 < H_{ax}$, $H_z(x)$ is described by Eq. (B9). On the other hand, for the same applied eld but with H_{ax} and H_{az} switched on simultaneously (the so-called rst scenario⁸), we obtain from form ulas of Ref. 8 at

C om parison of Eqs. (B 9) and (9) dem onstrates that m easurem ents of the asym m etry of the H $_z$ proles at the upper surface of the strip enable one to investigate subtle di erences between critical states generated by di erent scenarios of switching on H $_a$ (to the leading order in the small parameter d=w one has H $_z = 0$ at jcj < a for any scenario). Note also that form ulas of type (B 9) [pr (9)]

permit one to nd the sheet current J(x) in the region jxj < a from H $_z$.

B. Region where $H_z \in 0$

Consider now the region of the strip penetrated by H_z , a jxj w, i.e., the region where the component H_z di ers from zero. In this case it is useful to represent Eq. (7) in another form, using the solution H_x (z; H_z (x)) of Eq. (3). This solution is implicitly given by

where H_x and H_x^+ are the same as in Eq. (2). Using Eq. (10), we can transform the integration over z in Eq. (7) into an integration over H_x . After a simple manipulation, we obtain

It is clear from this form ula that H_z depends on x via the function $H_z(x)$, i.e., H_z has the form : $H_z = d$ $(dH_z=dx)F(H_z)$ where F is some dimensionless function of H_z . W ithin the Bean model when j_c is independent of H and $J_c = j_c d$, equation (11) yields $H_z(x) = 0$, and hence the asymmetry of the proles $H_z(x)$ in the fully penetrated region of the strip is absent for any H_{ax} . The asymmetry appears only if there is a dependence of j_c on H jor if there is an anisotropy of pinning (or it may result from both reasons). If $j_c(H_x; H_z) = j_c(H_x; H_z)$, i.e., if the angular dependence of the critical current density is symmetric relative to the z axis, it follows from form ula (11) that $H_z(x) = 0$ at $H_{ax} = 0$. In other words, for such $j_c(H_x; H_z)$ the asymmetry of the magnetic eld. At small H_{ax} , Eq. (11) yields

where $H_x = J_c (H_z)=2$, and $J_c (H_z)$ is the dependence of the critical sheet current on H_z at $H_{ax} = 0$. The integration of this form ula leads to the relationship $\frac{7}{2}$.

which, in principle, enables one to reconstruct the function $j_c(H_x; H_z)$ (up to a constant) if the function $H_z(x)$ at small H_{ax} and the functions $H_z(x)$ and $J_c(H_z)$ at $H_{ax} = 0$ are known. Here $H_x = J_c(H_z)=2$, and $H_z =$ $H_z(x_0)$. The integration in Eq. (13) is carried out over the region where $H_z \in 0$.

It was shown recently⁴ that in the case of H-dependent jc the magnetic eld pro les at the upper surface of the strip generally depend on the scenario of switching on the oblique magnetic eld. In Ref. 4 the pro les were analyzed to the leading order in d=w, and so they were always symmetric in x, H_z (x;d=2) = H_z (x;d=2). Formula (11), which describes the antisym metric part of the pro les (this part appears to the next order in d=w), has been derived under the assumption that the sign of j, remains unchanged across the thickness of the strip. This assumption is indeed valid for the third scenario discussed in this paper. However, there exist scenarios, see, e.g., Ref. 4, when $j_v(x;z)$ changes its sign at some boundary $z = z_c(x)$. It is this boundary that causes the di erence between the pro les for the di erent scenarios. Of course, the existence of this boundary also implies a modi cation of formula (11). Thus, we expect that if for som e scenarios the sym m etric parts of the H z pro les di er, their antisym m etric parts have to di er, too.

The magnetic- eld pro les at the upper surface of the strip are obtained either by magneto-optics, see, e.g., Ref. 9,10,11,12, or using Hall-sensor arrays.¹³ These pro-

les enable one to nd the sheet-current distribution J (x), 14,15,16,17,18,19,20 and then the dependence J_c (H $_z$). 12 In Ref. 4 we discussed a way how to determ ine j_c from J_c (H $_z$). In this context, measurements of H $_z$ (x) in oblique magnetic elds can provide additional inform ation on the ux-line pinning in superconductors when the critical current density j_c depends on the magnitude or direction of the magnetic eld.

To demonstrate this, we compare H_z(x) for two types of pinning: For the set type the critical current density depends only on the combination $\frac{1}{2}H$ jcos = H_z where is the angle between the local direction of H and the z axis; for the second type j_c is a function of only. The

rst situation occurs for the case of weak collective pinning by point defects in the smallbundle pinning regime when the scaling approach is valid.²¹ In this case $j_{\rm c}$ depends on the combination $\frac{1}{2}$ $j_{\rm c}cos^2$ + $^2\sin^2$ $)^{1=2}$ which practically coincides with $\frac{1}{2}$ jcos = H $_{\rm z}$ if the anisotropy parameter is small. Then, equation (11) gives

i.e., the asymmetry is absent in the region $j_z j > a$ for this type of pinning. Here we have taken into account that in this situation Eq. (2) reduces to $J_c (H_z) = dj_c (H_z)$. We are coming now to an analysis of $H_z (x)$ for the second type of pinning.

C. j_c depends only on the direction of H

Let us consider m one closely the case when j_c depends only on , $j_c = j_c$ (), where ~ is the angle between the local direction of H and the z axis. In other words, we shall analyze the situation when the dependence of j_c on jH j is negligible. This approximation can be justimed for not too thick samples with an isotropic pinning.⁴ Here we also assume the symmetry j_c () = j_c (). In this case, one can express the dependence of J_c on H_z at $H_{ax} \in 0$ in term softhe function J_c (H $_z$) at H $_{ax} = 0$, 3,4 see Appendix C. The quantity H_z (x), Eq. (11), is also expressible in terms of J_c (H $_z$) on the set of the set o

Here we have used the parametric representation (C1), and form ulas (C2) that determ ine the auxiliary variables t_{+} and t . As to Eq. (12), it takes the form :

where $J_c(H_z)$ is the H_z dependence of J_c at $H_{ax} = 0$.

W e now present an exam ple of such calculations for this type of pinning. Let at H $_{ax} = 0$ the following dependence J_c (H $_z$) be extracted from some experimental magneto-optics data:

where $H_{cr} = j_c(0)d=2$, while $j_c(0)$ and the dimensionless p and q are positive constants. Using Eqs. (C1), one can




FIG.2: A ngular dependence of the critical current density $j_c(), Eq. (17)$, for p = 1, q = 4 (dashed line). The solid lines show the corresponding dependences of the sheet current J_c on H_z at $H_{ax} = 0, Eq. (16)$, and at $H_{ax} = 0.5, 1, 2, 5$. The dependences for nonzero H_{ax} are obtained from Eqs. (C 2), (16). The current density is measured in units of $j_c(0)$, while J_c and H_z are in units of $j_c(0)d$.

easily verify that the corresponding angular dependence of the critical current density takes the form :




FIG.3: Spatialpro les of the perpendicular eld component H_z(x) (upperplot) and of the sheet current J(x) (low erplot) of a thin strip with anisotropic pinning described by model (17) with p = 1, q = 4, see Fig.2. The various curves correspond to increasing applied eld H_{az} = 0:4 and 1 in units of j_c(0)d. The dotted, dashed, dot-dashed, and solid curves are for H_{ax} = 0, 0.5, 1, and 2, respectively. For comparison, the solid curves with dots (indicating the grid) show the pro les for isotropic pinning (p = 0).




FIG.4: The function F (H_z) H_z(x) (dH_z=dx) ¹d ¹ calculated with Eqs. (14), (16) for p = 1, q = 4 and various H_{ax} = 0.2, 0.5, 1.1, 1.4, 2. The dots show the F (H_z) calculated from Eq. (15) for H_{ax} = 0.2. H_z and H_{ax} are measured in units of j_c (0)d.

where t is a curve parameter with range 0 1. t This dependence j_c () is presented in Fig.2 together with the function $J(H_z)$, Eq. (16). Note that for p > 0 the character of this dependence $i_{c}()$ is typical of layered high- T_c superconductors,³ i.e., j_c is largest for = =2. The proles $H_z(x)$ that correspond to this $J_c(H_z)$ are shown in Fig. 3. In Figs. 2 and 3 we also show the dependences of J_c on H $_z$ for H $_{ax}$ 6 0 and appropriate magnetic-eld pro les in an oblique magnetic eld. W ith the use of Eqs. (C2), (14) - (16), we calculate the quantity (H_z=d) (dH_z=dx) 1 as a function of H_z, Fig. 4. Interestingly, even at not too sm all $H_{ax} < 0.4 j_c (0)d$, form ula (15) gives reasonable results. An example of the asymmetry of the H_z-pro les at the upper surface of the strip is presented in Fig. 1. This asymmetry is found from the data of Fig. 4, the known derivative dH $_{z}$ (x)=dx, Fig. 3, and form ulas of Appendix B (when jxj < a). Note that the steepness of H $_z$ (x) near x = a has a pronounced effect on the form of $H_z(x)$ (and this steepness essentially depends³ on the sign of p). The discontinuities of $H_z(x)$ a, 0, w are caused by the inapplicability of at x = our formulas for H_z there. For comparison, we also H_z (x) and the pro les H_z (x;0) and H_z (x;d=2) show calculated directly by solving the two-dimensional critical state problem for a strip of nite thickness. In this two-dimensional calculation the discontinuities of H_z are sm oothed out on scales of the order of d.

IV. STRIP W ITH INCLINED DEFECTS IN PERPENDICULAR MAGNETIC FIELD

In a recent Letter¹ the position of the so-called central d-line (the discontinuity line) at the upper surface of a thin rectangular YB a₂C u₃O₇ platelet wasm easured by m agneto-optical imaging. In this d-line the sheet current changes its sign and the magnetic eld H_z reaches an extrem um (a minim um). When colum nar defects tilted to the c-axis were introduced into the sample, the d-line shifted relative to the central axis of the platelet,¹ and the value of this shift rst increased and then decreased with increasing perpendicular magnetic eld. A s mentioned in the Introduction, the authors of R ef. 1 explained the shift by the in-plane magnetization originating from a zigzag structure of vortices, and the disappearance of the magnetization and of this shift by loss of their interlayer

coherence. It is clear that the shift of the d-line re ects the asymmetry of the magnetic eld pro les at the upper surface of the sample.

The zigzag structure of vortices occurs when the tilt of the local H to the direction of the colum nar angle defects is less than the so-called trapping angle t.²² In this case a m isalignm ent of the local H and the averaged direction of the kinked ux lines appears, and this m isalignment is of the order of 2 (H $_{c1}$ =H) ($_{t}$) where H_{c1} is the lower critical eld and is the anisotropy param eter of the superconductor. The m isalignm ent gener-²H_{c1} ([†]_{d=2} ates an in-plane m agnetization M $_{\rm x}$), and hence one may expect that H $_z$ $(d=dx) \int_{d=2}^{d-2} M_x dz;$ see Eq. (7). Note that if ! 0 (the interlayer coherence is lost), H_z tends to zero. This is just the mechanism of the asymmetry discussed in Ref. 1, and in this consideration the asymmetry is due to the equilibrium part of the in-plane m agnetization. How ever, in our approxim ation, when H H_{c1} and $B = {}_{0}H$, we neglect the m is alignment, the elds of the order of H_{c1} , and the equilibrium part of magnetization. In our approach we take into account only the nonequilibrium part of magnetization, which also generates an asymmetry. This asymmetry can occur even if H_{c1} ! 0.

In Sec. III we have considered the case when the angular dependence of j_c is symmetric about the z axis $[j_c() = j()]$, and the asymmetry of the H_z proles is caused by an inclined applied magnetic eld. However, such asymmetry can also result from the \opposite" situation when the applied eld is along the z axis while pinning is not symmetric about this axis. It is this situation that occurs when columnar defects are introduced at an angle $_1$ to the z axis. In this case $j_c()$ in the interval




FIG.5: Top: The anisotropic critical current density j_c (), Eq. (18) with $p_1 = 2$, $q_1 = 4$, and $tan_1 = 0.5$, that models pinning by tilted columnar defects. Bottom : Twodim ensional com putation⁶ (creep exponent = 501; London depth = w = 30 = d = 12; 120 28 grid points) of the critical state in a long strip with rectangular cross section of aspect ratio d=2w = 0.2 and with an isotropic pinning described by the $j_c()$ of the upper plot, exposed to a perpendicular eld $H_{az} = 0.2 j_{c0} d$. Shown are the magnetic eld lines (thin lines) and some contour lines of the current density $j(x;z)=j_{c0} =$ -2.75, -2.25, -1.75, :::, 2.75 (thick lines). The three inclined dashed lines indicate the direction $_1$ of the columnar pins. Note that the distribution of j_c across the thickness of the strip is asym m etric; jjc (x;z) jis m axim um where the eld lines are along the defects, and j_c j_0 is nearly constant where the deviation from this direction is large. The line $j_c(x;z) = 0$ coincides with the central magnetic eld line.

j j j __1j< __t is larger than outside this interval. The enhancement of j_c in this interval is caused by the zigzag structure of vortices when a part of their length is trapped by strong colum nar defects, while outside the interval pinning by the colum nar defects is ine ective. Since ux lines are curved in the critical state, this enhancement of j_c leads to an asymmetry of the current-density distribution across the thickness of the strip, and thus to a nonzero H_z. We carry out the calculation of the asymmetry of the shift of the d-line for the following dependence j_c():

which models an increased ux-line pinning by colum – nar defects at angles near $_1$, Fig. 5. Here p_1 and q_1




FIG.6: Top: A symmetric proles of the magnetic eld component H_z (x;z) in the plane z = 0.52d slightly above the surface of the strip of Fig. 5 with an isotropic pinning by tilted columnar defects. Shown are the cases $p_1 = 2$ (solid lines) and $p_1 = 32$ (dashed lines), with $q_1 = 4$, tan = 0.5, at applied eld values H_{az} = 0.02, 0.1, 0.2, 0.3, :::. Field unit is j_{c0}d. The slightly curved, nearly vertical lines with dots are the locus of the minim a of these H_z proles. Bottom : The position x_{m} in of the minim um of the proles H_z (x;0.52d) plotted versus the applied eld H_{az} for $p_1 = 2$:::256.

are some positive dimensionless parameters $(q_1 t^2)$, and j_{c0} is the current density in a sample without colum – nar defects (j_{c0} describes, e.g., pinning by point defects). A lthough formulas (7) and (11) are still valid for thin strips with such j_c (), these formulas failnear the d-line, and so we carry out calculations of H_z here, using the num erical solution⁶ of the two-dimensional critical state problem for a strip of nite thickness. In Fig. 5 we show the current and magnetic- eld distributions in the strip with pinning described by Eq. (18), while in Fig. 6 the H_z proles and the shift of the d-line are presented.

In Fig. 6 the decrease of the shift with increasing H_a can be qualitatively explained as follow s: The characteristic angle of the curved ux lines in the strip is of the order of j_{c0} d=H_z [i.e., form ost of the ux-line elements lies in the interval $(j_{0}$ d=H_z) < $(j_{c0}$ d=H_z)]. When the external magnetic eld increases, this angle decreases and tends to zero. Thus, the ux-line pinning (the current distribution) becomes practically uniform across the thickness of the sample at su ciently large H_{az}, and the shift vanishes. These considerations are valid for any type

of anisotropic pinning, but there is one more reason for the disappearance of the shift in sam ples with colum nar defects: W hen $_1 > _t$ and j_{c0} d=H $_z$ is less than $_1$ ÷, the zigzag structure of vortices disappears in the sam ple, and the ux-line pinning by these defects becom es ineffective. The trapping angle determ ining the width of the peak in jc decreases with increasing H as some power of H = H if the applied eld is of the order of the m atching eld H (H is a measure of the density of the colum nar defects).²² Thus, if $_{+} > _{1}$ at H = 0, the disappearance of the shift can occur at som e m agnetic eld associated with H . This is just observed in the experiment.¹ Note that in this case the disappearance of the shift is due to the disappearance of the zigzag structure of vortices in the superconductor rather than to the loss of the interlayer coherence.

Finally, we emphasize the unresolved problem of the analysis presented in this section: The shift calculated for the experimental ratio¹ (d=w) 0.06 is noticeably less than the experimentally observed shift (H_z decreases with decreasing d). A variation of the parameters p_1 and q_1 in Eq. (18) cannot change this conclusion. For example, although the maximum value of the function $j_{\text{Mm in}}$ (H) j increases with p_1 , it tends to a limit of the order of (d=2) tan 1 at p_1 1; see Fig. 6.

V. CONCLUSIONS

We have considered H_z pro les at the upper surface of a thin strip whose thickness d is much less than its width 2w. To the leading order in d=w, these pro les are symmetric in x, H_z (x;d=2) = H_z(x;d=2). However, the analysis to the next order in this small parameter reveals the asymmetry of the pro les, H_z(x;d=2) H_z(x;d=2), which coincides with H_z(x) H_z(x;d=2) H_z(x; d=2), the di erence of H_z at the upper and low er surfaces of the strip. We calculate H_z(x) and show that this H_z di ers from zero in an oblique magnetic eld H_a = (H_{ax};0;H_{az}) and depends on the scenario of switching on this eld. For de niteness, we analyze in detail the so-called third scenario⁴ when H_{ax} is switched on before H_{az}.

In the region jxj < a where the ux-free core occurs [where the symmetric part of H_z(x) is almost equal to zero], the asymmetry of the H_z proles exists even for the H-independent j_c (the Bean model) and is due to the asymmetric shape of the ux-free core in the oblique magnetic eld. Outside this region (jxj > a) the asymmetry appears only if j_c depends on the magnitude of the local magnetic induction or if there is an out-of-plane anisotropy of j_c. The asymmetry of the magnetic eld proles in oblique magnetic elds was observed in Ref.2; see also Fig. 3e in Ref. 23.

An asymmetry of the H $_z$ proles also appears when the ux-line pinning is not symmetric about the norm alto the strip plane (about the z axis). This situation occurs when inclined columnar defects are introduced into the

strip. In this context we have discussed the experimental data of Itaka et al.¹ It is shown that although these data can be qualitatively understood from our results, there is a quantitative disagreement between the experimental and theoretical results on the d-line shift.

U sing the B iot-Savart law, the H $_z$ component of the magnetic eld at the point (x_0,z_0) of the strip can be written in the form :

Since the current density $j_y(x;z)$ in the critical state of the strip changes in the x direction on a scale which considerably exceeds d, in the calculation of Q $(z;x_0;z_0)$ we may use the expansion, $j_y(x;z) = j(x_0;z) + (x = x_0)j_y^0(x_0;z)$ where $j_y^0(x_0;z) = \ell_y(x_0;z) = \ell_x_0$. 


FIG.7: The current and ux fronts in a thin strip to which rst the in-plane magnetic eld component H_{ax} is applied and then the perpendicular H_{az} (scenario 3). Shown are the fronts for H_{ax} = 0, 0.15, 0.35, 0.45 and 0.5 (or larger), and H_{az} = 0.25 in units of j_cd. The fronts for other values of H_{az} are scaled with a. The lines z^+ (x), z (x), z_1 (x), z_2 (x) are described in Appendix B.

The set two terms in Eqs. (A 5) yield $H_z(x)$ for the innitely thin strip, while the third and forth terms are corrections to this result due to the nite thickness of the strip. These corrections are relatively small (of the order of d=w).

The above derivation of Eq. (A 4) fails in the region of a, where a ux-free core occurs in the the strip, jxj sample. The boundary of the core, $x_f(z)$ [or equivalently] $z_f(x)$], can be calculated from J(x) at jxj < a; see Ref. 3. In this region, the ux lines are practically parallel to the surfaces of the sample, and they are sandwiched between the surfaces and the core. If $\dot{x}_0 = x_f (z_0) j^{<} d$, i.e., if the point (x_0, z_0) lies near the boundary of the ux-free core, one cannot transform Eq. (A2) into Eq. (A3). However, at jxj< a we can repeat the above analysis, integrating over z rather than over x in expression (A 2). If $j_{V}(x;z)$ is alm ost independent of z in the region between the core and the surfaces of the sample, we eventually arrive at the same formula (A4) for jxj< a. This formula fails only in the vicinity of the points x = a which are the positions of the ux front for the in nitely thin strip and near the points x = 0, x = w.

APPENDIX B:FLUX-FREE CORE FOR THE THIRD SCENARIO

In Ref. 8 for a thin strip in an oblique magnetic eld, the shapes of the ux-free core and of the lines separating regions with opposite directions of the critical currents were presented only for two scenarios of switching on the external magnetic eld (1: at constant angle $_0$, 2: rst H $_{az}$ then H $_{ax}$). Below we present the corresponding form ulas for the third scenario (when H $_{ax}$ is applied before H $_{az}$). A s in Ref. 8, we shall use the B ean m odel here, i.e., we assume that j_c is constant. However, the form ulas of this Appendix remain true also for the case $j_c = j_c$ () where is the angle between the local direction of H and the z axis; see below.

Let x = a be the positions of the ux front in the in nitely thin strip. W ithin the Bean model, the sheet current J(x) at a x $a = w = \cosh(H_z = j_c d) is^{24,25}$

In Fig. 7 we show the lines $z_1(x)$ and $z_2(x)$ separating the regions with opposite directions of the critical currents and the ux-free core composed of the lines $\vec{z}(x)$ and z(x).
