A nisotropic superconducting strip in an oblique magnetic

The critical state of a thin superconducting strip in an oblique applied magnetic eld H a is analyzed without any restrictions on the dependence of the critical current density jc on the local m agnetic induction B. In such a strip, j_c is not constant across the thickness of the sample and di ers from $J_c=d$, where J_c is the critical sheet current. It is shown that in contrast to the case of B -independent j_c , the pro les H $_z$ (x) of the magnetic-eld component perpendicular to the strip plane generally depend on the in-plane component H $_{\rm ax}$ of the applied m agnetic $\,$ eld H $_{\rm a}$, and on how H a is switched on. On the basis of this analysis, we explain how and under what conditions one can extract j_c (B) from the magnetic-eld pro les H $_z$ (x) measured by magneto-optical imaging or by Hall-sensor arrays at the upper surface of the strip.

I. IN TRODUCTION

One of the methods for analyzing ux-line pinning in high-T_c superconductor thin platelets is the measuring of magnetic-eld pro les at the upper surface of these superconductors when they are placed in a perpendicu-Lar external magneticeld; see, e.g., the recent review 1 and references therein. These pro les enable one to reconstruct the spatial distribution of the sheet currents J

owing in the sample, 2,3,4,5,6,7,8 (the sheet current J is the current density integrated over the thickness of the sample), and hence to extract some information on the critical currents in the superconductor.9 The magnetic-

eld pro les are measured either with magneto-optical imaging,^{10,11;1} or with Hall—sensorarrays.¹² It is clear that the investigation of the proles not only in a perpendicular but also in an oblique magnetic eld could, in principle, provide additional information on vortex pinning in thin at superconductors.

In this paper, to explain the main ideas, we shall consider a sample of the simplest shape: Let a thin superconducting strip 11 the space jxj w, jyj < 1, jzj w.A constant and hom ogeneous externalm agwithd netic eld H_a is applied in the x-z plane at an angle 0 to the z axis ($H_{ax} = H_a \sin_0 H_{ay} = 0$, $H_{az} = H_a \cos_0$). We also assume that there is no surface pinning, the thickness of the strip, d, exceeds the London penetration depth, and the lower critical eld H_{c1} is su ciently small so that we may put for the magnetic induction $B = _{0}H$.

In our recent paper, 13 a superconducting strip in an oblique m agnetic eld was analyzed in the fram ework of the Bean model (when the bulk critical current density is independent of the local magnetic induction B), and several interesting properties of the critical state for such \nonsymmetric" directions of Ha were established. In particular, it was shown that the nal critical state depends on how the applied magnetic eld is switched on, e.g., at a constant tilt angle 0, or rst its z and then its x com ponent, or vise versa. However, di erences between

these three critical states occur only in the central region of the strip where a ux-free core exists, i.e., where $H_z(x)$ at the surface of the strip is practically zero. M oreover, to leading order in the small parameter d=w, for all the scenarios the sheet current J (x) is the sam e in this region of the sample, and it coincides with the sheet current at $H_{ax} = 0$. In the region of the strip where $H_z \in 0$, the sheet current is equal to its critical value $J_c = i_c d$ and is also independent of H $_{\rm ax}$ and of how H $_{\rm a}$ is switched on. Thus, when the Bean model holds, the magnetic-eld pro les depend only on Haz, the di erences between the states do not manifest them selves in the pro les_r^{14} and hence measurements of the H z pro les in inclined magnetic elds do not provide new information on ux-line pinning. In this case, to nd j, it is su cient to extract the critical sheet current J_c from the H $_z$ pro les at $H_{ax} = 0$ in the region with a nonzero H_z and to use the relationship $j_c = J_c = d$.

However, when the critical current density jc depends on B, eq., on B jor on the angle between the local direction of B and the z axis or on both, the situation is di erent. In this case j is not constant across the thickness of the strip since B and thus jc change with z in a strip of nite thickness, and the critical value of the sheet current J_c is not simply j_cd. In such cases the problem arises how to determ ine i (B) from the magnetic-eld pro les. In the present paper we address just this problem . As it was shown in Ref. 15 (see also below), at any dependence of i on B the critical state problem for a thin strip of nite thickness can be reduced to the problem of an in nitely thin strip with some e ective dependence of the critical sheet current J_c on the z component of the local magnetic induction, $\,_0\,\mathrm{H}_{\,\mathrm{Z}}\,.$ Thus, the problem can be formulated as the reconstruction of jc (B) from the m easured J_c (H $_z$). This J_c (H $_z$) depends also on the applied H $_{\mbox{\scriptsize ax}}$, and hence som e additional inform ation on ux line pinning can, in principle, be extracted from the

H_z pro les measured in an oblique magnetic eld.

In this paper, to provide a basis of treating the re-

construction problem , we rst consider the critical-state problem for the superconducting strip in an oblique magnetic eld, without assuming any restrictions on the dependence j. (B). In contrast to the case of B-independent j., critical states in such a strip depend on how the external magnetic eld is switched on, not only in the region of the strip where the ux-free core occurs but also in the region penetrated by H $_{\rm Z}$. In particular, the proles H $_{\rm Z}$ (x) at the upper surface of the strip generally depend on H $_{\rm ax}$ and on how H $_{\rm a}$ is switched on. As an example, in this paper we in detail analyze the case when j. depends only on the angle between the local direction of H and the z axis, j. = j.(). Finally, we discuss the problem of the reconstruction of j. (B) from experimental magneticeld proles.

II. CRITICAL STATE IN A THIN STRIP

Let us consider the critical state in a thin strip with an arbitrary dependence j_c (B). In the specience access $H_{ax}=0$, this problem was solved in Ref. 15. Here we generalize the approach of that paper to the case of an oblique magnetic

eld. We assume that the eld H_a increases monotonically and imply that one of the following three scenarios occurs: In the rst scenario the magnetic eld increases under the condition $(H_{ax}=H_{az})=\tan_0=\mathrm{const.}$ In the second scenario the eld H_{az} is switched on rst and then one switches on H_{ax} , while for the third scenario the sequence of switching on H_{ax} and H_{az} is opposite. The nalmagnetic eld in all these cases is the same, $H_{ax}=H_a\sin_0$, $H_{ay}=0$, $H_{az}=H_a\cos_0$.

To the leading order in d=w , H $_{\rm z}$ is independent of z inside the strip, and the B iot-Savart law gives

where the sheet current J is the current density j_y integrated over the thickness of the strip,

When H_a increases, the penetration of the z component of the magnetic eld into the superconducting strip is found from the following equations: One has

in the regions of the strip where H $_z$ changes as compared to the previous state that existed at H $_a$ H $_a$, while in the regions where the sheet current is less than its critical value J $_c$ [H $_z$ (x)], H $_z$ remains unchanged,

In the simplest case, Eq. (2) holds in the two regions a jxj w where H_z di ers from zero, while in the

central region ix j a, one has

function $J_c(H_z)$ implicitly,

These equations, in fact, describe the critical state problem for an in nitely thin strip with some elective dependence of the critical sheet current $J_{\rm C}$ on $H_{\rm Z}$. The point x=a where $H_{\rm Z}$ vanishes [or in the general case the boundaries separating regions of validity of Eqs. (2) and (3)] is found by solving Eqs. (1)-(4).

The function J_c (H $_z$) can be found as follows: ¹⁵ Taking into account that in a thin strip the critical state gradient of the magnetic eld develops predom inantly across the thickness of the sample, we can write the equation rotH = j in the form

neglecting the derivative $@H_z(x;z) = @x$. This approxim ation is true to the leading order in d=w. Here $j_y(x;z) = \frac{1}{2}(H_x;H_z)$ is the current density in the critical state. Solving Eq. (5), one and a relation that determ ines the

where $H_x = H_{ax} = 0.5 J_c (H_z)$, and $H_x^+ = H_{ax} + 0.5 J_c (H_z)$ are the x component of the magnetic eld at the lower and the upper surfaces of the strip, $H_x (x; d=2)$. The function $J_c (H_z)$ found from Eq. (6) generally depends on the parameter H_{ax} , and only within the simple Bean model when J_c is independent of H_x , equation (6) yields $J_c = J_c d$ for any H_{ax} . At $H_{ax} = 0$, formula (6) coincides with formula (12) of Ref. 15.

In the regions of the strip where $jJj < J_c$, either the ux-free core occurs, or there is a boundary which is almost parallel to the strip plane and at which the critical current density $j_y\left(x;z\right)$ changes its sign; see below. Knowing $J\left(x\right)$ and using Eq. (5), one can calculate the shape of the ux-free core and this boundary, i.e., one can nd the critical state across the thickness of the strip. The sign of j_y above and below the boundary, as well as the sign on the right hand side of Eq. (2), follows from the prehistory of the critical state.

III. $j_{\scriptscriptstyle C}$ DEPENDS ON LY ON THE D IRECTION OF H

A nisotropic pinning is typical of anisotropic superconducting materials, and it occurs in many superconductors. Only for the case of weak collective pinning by point defects is the critical current density j_c independent of the magnetic induction in the so-called single vortex pinning regime or does it depend on B $_z$ in the small bundle pinning regime $_z^{17}$. In this case $_z^{17}$ and $_z^{17}$ can be directly found from the critical value of

the measured sheet current J_c . However, anisotropy of pinning in an anisotropic material is likely if the defects cannot be considered as point pinning centers or if the pinning is not weak. A nisotropic pinning also occurs in layered superconductors. Besides this, it is clear that any extended defects, e.g., twin boundaries or columnar defects, lead to an anisotropy of pinning even in isotropic materials.

Let us consider the case when jc depends only on , $j_c = j_c()$, where is the angle between the local direction of H and the z axis. In other words, we neglect a possible dependence of jc on H jhere. When the characteristic scale H₀ of the JH j dependence considerably exceeds the characteristic eld in the critical state of the strip, jcd, this approximation is well justi ed since one has $\frac{1}{16}$ (; †H †) j(;0) in such a strip. Hence, this approximation is quite reasonable for not too thick sam- $H_0=j_c$. On the other hand, if j_c depends ples with d on and # jseparately rather than on the combination H jcos, one cannot neglect the angular dependence of jc even in thin samples since the characteristic angles in the strip are of the order of jcd=Hz and essentially ġd. change at H z

In the case $j_c=j_c()$ with the symmetry $j_c()=j_c()$, one can reconstruct the dependence of the critical current density j_c on from the function $J_c(H_z)$ obtained at $H_{ax}=0$. Indeed, di erentiating Eq. (6) with respect to H_z , we have at $H_{ax}=0$, I_c^{15}

These form ulas give the dependence $j_c()$ in parametric form, with H $_z$ being the parameter. Inserting this parametric form of $j_c()$ into Eq. (6), we arrive at equations determining $J_c(H_z)$ at H $_{ax}$ $\in \ 0$,

where is the sign of [0:5J_c (H_z; H_{ax}) H_{ax}], J_c (H_z; H_{ax}) denotes J_c (H_z) at a given value of H_{ax}, and hence J_c (t; 0) is the sheet current at H_{ax} = 0. Note that at H_{ax} = 0 one has t₊ = t = H_z, and Eqs. (8) reduce to J_c = J_c (H_z; 0) as it should be. From the three Eqs. (8) for the three unknown variables J_c (H_z; H_{ax}), t₊, t (t₊ and t are auxiliary variables that do not appear in the nal results) one nds J_c (H_z) at H_{ax} 60. The magnetic eld proles in oblique applied eld are then obtained by inserting this excitive law J_c (H_z; H_{ax}) into Eqs. (1)-(4), and by solving these integral equations by either a static iterative method, or more conveniently by a dynamic method. 19




FIG. 1: Angular dependence of the critical current density j_c (), Eq. (10), (dashed lines) for p=1, q=4 (top, the maximum of j_c is at ==2) and for p=0.5, q=0.5 (bottom, the maximum of j_c is at ==0). The solid lines show the corresponding sheet currents J_c (H $_z$) at H $_{ax}=0$, Eq. (9), and at H $_{ax}=0.3$, 0.5, 1, 2, 5 from Eqs. (8), (9). The current density is measured in units of j_c (0), while J_c and H $_z$ are in units of j_c (0)d.

W e now consider typical exam ples of the dependence j_c (). Let at H $_{ax}$ = 0 the following dependence J_c (H $_z$) be extracted from some experimental magneto-optics data:

where $H_{\rm cr}=j_{\rm c}$ (0)d=2, while $j_{\rm c}$ (0) and the dimensionless p and q are constants $[j_{\rm c}$ (0) and q > 0]. Using Eqs. (7), one can easily verify that the corresponding angular dependence of the critical current density takes the form:

where t is a curve parameter with range 0 t 1 equivalent to =2 0. This dependence j() is presented in Fig. 1 together with the function $J(H_z)$, Eq. (9). Note that the character of this dependence $j_c()$ is typical of layered high- T_c superconductors when p > 0 and of superconductors with column are defects when p < 0. Using Eqs. (8) and (9), we note the dependences of J_c on J_c for J_c




FIG. 2: Spatial pro less of the perpendicular eld component H $_z$ (x) (upper plot) and of the sheet current J (x) (lower plot) of a thin strip with anisotropic pinning described by model (10) with p = 1, q = 4, see Fig. 1. H $_{\rm ax}$ is switched on rst and then H $_{\rm az}$ (third scenario). The various curves correspond to increasing applied eld H $_{\rm az}$ = 0.2, 0.6, 1.2. The magnetic elds and the sheet current J are in units of jc (0)d. The dotted, dashed, dot-dashed, and solid curves are for H $_{\rm ax}$ = 0, 0.5, 1, and 2, respectively. For comparison, the solid curves with dots (indicating the grid) show the pro less for isotropic pinning (p = 0). The dotted lines also correspond to the opposite sequence of switching on H $_{\rm az}$ and H $_{\rm ax}$ (second scenario).

A. Layered superconductors, p > 0

For layered superconductors (p > 0), we begin our analysis with the third scenario when H $_{\rm ax}$ is switched on rst and then H $_{\rm az}$ is applied. A ppropriate magneticeld profes obtained with Eqs. (1), (2), (4) and J (H $_{\rm z}$; H $_{\rm ax}$) of Fig. 1 are shown in Fig. 2. Note that for the third scenario one has jJ j= J $_{\rm c}$ at any point x where H $_{\rm z}$ (x) \in 0, and the penetration depth of H $_{\rm z}$ into the strip, w a, depends on H $_{\rm ax}$. A nother situation occurs when H $_{\rm ax}$ and H $_{\rm az}$ are switched on in the opposite sequence (the second scenario). A first switching on H $_{\rm az}$, the magneticeld profess are given by the dotted lines in Fig. 2. The subsequent increase of H $_{\rm ax}$ does not change either J (x) or H $_{\rm z}$ (x). Indeed, as seen from Fig. 1, J $_{\rm c}$ (H $_{\rm z}$) increases

with increasing H $_{ax}$. Hence, if J (x) were equal to its critical value J_c [H $_z$ (x)], the penetration depth of the applied eld H_{az} would decrease as compared to w $_a$ for the dotted lines of F ig. 2, and $_a$ ux lines near the points $x=_a$ would have to move against the Lorenz forces directed towards the center of the strip, which is in possible. Thus, for the second scenario the sheet current is less than its critical value for all points x. This means that although the fully penetrated critical state develops across the thickness of the strip in the regions penetrated by H $_z$, there is a boundary $z=_c(x)$ at which the critical current density j_y (x;z) changes its sign, F ig. 3, and so the magnitude of sheet current jJ j is less than J_c . It follows from Eq. (5) that the boundary $z_c(x)$ is determined by the form ula,

where $H_x = H_{ax} = 0.5J(x)$, and $H_x^+ = H_{ax} + 0.5J(x)$ are the x component of the magnetic eld at the lower and the upper surfaces of the strip at the point x, while the sheet current J(x) coincides with $J_c[H_z(x)]$ calculated at $H_{ax} = 0$, i.e., $J(x) = (x-jx)J(H_z(x);0]$. Inserting the parametric form of $J_c(x)$, into Eq. (11), we arrive at the following equations for Z_c :

Here u_+ and u_- are auxiliary variables; is the sign of $[0.5J_c(H_z;0) \quad H_{ax}]$; $H_z=H_z(x)$ is the magnetic-eld proleat $H_{ax}=0$, and sgn(x)=1 for x>0 and x<0, respectively.

For the $\,$ rst scenario of sw itching on $\rm H_a$ when H $_{az}$ and H $_{ax}$ increase simultaneously, the magnetic-eld prolles calculated for the same $\,$ nal values of H $_{az}$ and H $_{ax}$ as in Fig. 2 coincide with the prolles for the third scenario shown in this $\,$ gure.

B. Superconductors with columnar defects, p < 0 $\,$

Consider now a superconductor with column ar defects directed along the z axis. To model the sheet current J(Hz) in such superconductors, one can use Eq. (9) with p < 0, Fig. 1. In Fig. 4 we present the appropriate magnetic—eld proles. Note that these proles coincide for the three scenarios of switching on Ha (neglecting the elect of ux creep which can be dierent for dierent scenarios). However, the proles and the penetration depth of Hz depend on Hax. When Hax increases, the proles tend to those of superconductors without column ar defects [it is evident from Fig. 1 that pinning without these




FIG. 3: Current fronts and ux-free core in a thin strip with an isotropic pinning described by model (10) with p = 1, q = 4. The perpendicular magnetic eld H $_{\rm az}$ = 0.6 is applied 10 rst and then the in-plane component H $_{\rm ax}$ is increased from zero to H $_{\rm ax}$ = 0.5, 1, 2, 20 (second scenario). At jkj a = 0.339w, the ux-free core and the lines separating the regions of the strip with opposite directions of currents are plotted, using the results of Ref. 13. The new boundary z = zc (x) which occurs at a jkj w is calculated from Eqs. (12). This boundary remains practically unchanged when H $_{\rm ax}$ 8. The magnetic elds are measured in units of jc (0)d.

defects is in plied to be isotropic and to be described by the Bean model with constant $j_c() = j_c(=2)$]. The change of the proles occurs in a rather narrow interval of H_{ax} . This result can be understood from the following simple considerations: A lthough the column ard effects increase pinning in the strip, this increase occurs mainly when the angle of a ux line does not exceed the so-called trapping angle $_t$. It is this $_t$ that determines the width of the peak in $j_c()$ caused by the defects. When H_{ax} increases, the characteristic tilt of the ux lines in the strip, $H_{ax} = H_z$, also increases, and when the tilt exceeds $_t$, pinning by the columnar defects becomes ine ective.




FIG. 4: Spatialpro less of the perpendicular eld component H $_{\rm Z}$ (x) (upper plot) and of the sheet current J (x) (lower plot) of a thin strip with anisotropic pinning described by model (10) with p = 0.5, q = 0.5, see Fig. 1. The various curves correspond to increasing applied eld H $_{\rm az}$ = 0.2, 0.6. The magnetic elds and the sheet current J are in units of jc (0)d. The dotted, dashed, dot-dashed, and solid curves are for H $_{\rm ax}$ = 0.24, 0.35, and 0.6, respectively. At any H $_{\rm ax}$ > 0.6 the pro less practically coincide with those at H $_{\rm ax}$ = 0.6, while at H $_{\rm ax}$ < 0.2 the pro less are very close to that at H $_{\rm ax}$ = 0. The pro less at H $_{\rm ax}$ = 0.6 also almost coincide with the proles for isotropic pinning with jc () = j.(=2) (solid curves with dots indicating the used grid). The pro les H $_{\rm z}$ (x) and J (x) coincide for the three scenarios of switching on H $_{\rm a}$.

IV. HOW TO RECONSTRUCT jc FROM H z (x)

We now discuss the problem of the reconstruction of j_c (H) from experimental magnetice eld procedures were elaborated 1,2,3,4,5,6,7,8 which enable one to extract the spatial distribution of the sheet current J from an experimental H $_z$ procedures. In particular, for the case of the strip, equation (1) can be explicitly inverted:

E lim inating x from H $_z$ (x) and J (x) (in the region of a nonzero H $_z$), one can not the function J (H $_z$) from experim ental data; see, e.g., Ref. 9.

If the extracted J_c (H $_z$) const., this means that the Bean model is valid, and $j_c=J_c=d$. It is this formula that is commonly used to and j_c in experiments. However, this simple approach in general is not correct when J_c depends on H $_z$. It is necessary to distinguish between two situations. For the case of weak collective pinning by point defects in the small bundle pinning regime, j_c depends only on the combination j_c j_c j_c j_c j_c the critical current density is constant across the thickness of the strip, and one still has

i.e., the usual form ula is valid. On the other hand, when j_c depends on and jH j separately, and when to the rst approximation one can assume that $j=j_c()$ (see Sec. III), form ulas (7) should be used to reconstruct the $j_c()$ from $J_c(H_z)$ obtained at $H_{ax}=0$. In order to distinguish between these two situations, i.e., to choose between form ulas (7) and (14), one can use the magnetic eld proles obtained in oblique magnetic elds.

When $j_c = j_c(H_z)$, the magnetic-eld proles in oblique magnetic elds depend only on H_{az} and are the same for any scenario of switching on H_a . On the other hand, the results of Sec. III show that another situation occurs when j_c is not only a function of H_z . In this case the penetration depth of H_z depends on H_{ax} . Moreover, dierent scenarios can lead to dierent proles H_z .

When the magnetic-eld proles in oblique magnetic elds show that the dependence $j=j_c(H_z)$ cannot explain the experimental data, one can apply formulas (7) to extract $j_c()$ from the H_z proles at $H_{ax}=0$. If the sample is not too thick, $j_cd < H_0$, where H_0 is the characteristic scale of the j_d jdependence of j_c , the extracted $j_c()$ approximately gives $j_c(j+H=0)$. For thicker samples the obtained $j_c(j+H=0)$. Calculating then the magnetic
