Statistical wave scattering through classically chaotic cavities in the presence of surface absorption

W e propose a m odel to describe the statistical properties of wave scattering through a classically chaotic cavity in the presence of surface absorption. Experimentally, surface absorption could be realized by attaching an \absorbing patch" to the inner wall of the cavity. In our model, the cavity is connected to the outside by a waveguide with N open m odes (or channels), while an experim ental patch is simulated by an \absorbing mirror" attached to the inside wall of the cavity; the mirror, consisting of a waveguide that supports N a channels, with absorption inside and a perfectly re ecting wall at its end, is described by a subunitary scattering matrix S_a . The number of channels N_a , as a measure of the geometric cross section of the mirror, and the lack of unitarity $P_a = \mathbb{1}_{N_a}$ S^YSa, as a measure of absorption, are under our control: these parameters have an important physical signi cance for real experiments. The absorption strength in the cavity is quantied by $a = trP_a$. The statistical distribution of the resulting S m atrix for N = 1 open channel and only one absorbing channel, N_a = 1, is solved analytically for the orthogonal and unitary universality classes, = 1 and = 2, respectively, and the results are compared with those arising from num erical simulations. The relation with other models existing in the literature, in some of which absorption has a volum etric character, is also studied.

I. IN TRODUCTION

W ave scattering experim ents with m icrow ave [1, 2] and acoustic resonators [3] represent a fruitful eld for the veri cation of Random M atrix Theory (RMT) predictions [4, 5, 6] since, in that experim ental dom ain, externalparam eters are particularly easy to control. How ever, the cost to be paid is the presence of absorption due to power loss in the walls of the device used in the experim ents. Since the appearance of the paper by D oron et al [7] which showed the drastic in uence of absorption, m any investigations, both experim ental and theoretical, have been devoted to the study of absorption e ects on transport properties [8, 9, 10, 11, 12, 13, 14, 15, 16, 17,18, 19, 20, 21, 22] of classically chaotic cavities.

A simplem odel to describe the statistical properties of cavities including absorption was proposed by K ogan et al. [9]: it describes the system through a subunitary scattering matrix S, whose statistical distribution satis es a maximum information-entropy criterion. The model turns out to be valid only in the strong-absorption lim it. An alternative model proposed by Lewenkopfet al. [10] simulates absorption by means of N $_{\rm p}$ equivalent \parasitic channels", not directly accessible to experiment (in addition to the N physical channels), each one having an in perfect coupling to the cavity described by the transm ission coe cient T p. These parasitic channels can be interpreted in terms of the voltage-probe model originally proposed by Buttiker [23, 24], where a ctitious lead with N p channels is attached to the cavity, each one with a coupling T_p [8]. The total scattering matrix \hat{S} for this problem is unitary and has dimension $N + N_p$; the N -dimensional submatrix S thereof is the physical scattering matrix which is of course subunitary. In the lim it N_p! 1 and T_p! 0, while the product $_{\rm p} = N_{\rm p}T_{\rm p}$ is kept xed and interpreted as the absorption strength, this model was shown by B rouwer and B eenakker [8] to describe volum e absorption, in the sense that the problem described by S is equivalent to one in which all the energy levels of the closed cavity acquire a xed in aginary part, associated precisely with the absorption strength. A lihough the above quantity is not directly under experimental control, it can be chosen so as to t the experimental data [20, 21].

A Itematively, instead of considering a cavity that exhibits volum e absorption, we may think of an experim ental situation in which \absorbing patches" are literally attached to the inner wall of the cavity in a controllable fashion, giving rise to what we shall call surface absorption. The physical properties of these patches could be determ ined and controlled independently of the cavity they are used with.




FIG.1: A ballistic chaotic cavity described by the scattering m atrix S_0 , connected to a waveguide with N propagating m odes and to an \absorbing m irror". The latter is form ed by a \frustrated waveguide" that supports N_a channels and contains an absorbing barrier inside and a perfectly re ecting m irror at its end; the absorbing m irror is described by the subunitary scattering m atrix S_a .

In the present paper we propose a simple model to describe the statistical properties of wave scattering through a ballistic chaotic cavity in the presence of surface absorption as de ned above. In the model [see Fig. 1], the cavity is connected to the outside by a waveguide with N open modes (or channels), while an experimental patch is simulated by attaching to the inside wall of the cavity an \absorbing m irror", consisting of a \frustrated waveguide" that supports N_a channels, with absorption inside and a perfectly re ecting wall at its end: the m irror is described by a subunitary scattering m atrix S_a. The number of channels N_a, as a measure of the geometric cross section of the m irror, and the lack of unitarity P_a = 1_{N_a} S^y_aS_a, as a measure of absorption, are

under our control: these parameters have an important physical signi cance for real experiments. The absorption strength in the cavity is quantied by $_{a} = trP_{a}$. A lternatively, we may think of attaching to the inner wall of the cavity N_a absorbing patches, each one with a geometric cross section that supports only one channel with a known absorption.

The paper is organized as follows. In the next section we study the model for surface absorption that was described in the previous paragraph. In Sect. III we nd the relation between the present model and the parasiticchannel model also described above: we show the equivalence of the two models when, in the latter, the lim if mentioned earlier leading to volume absorption is not taken and the parameters are chosen properly. In Sect. IV we show that the model can be solved analytically in the one-channel case and for one absorbing channel. Finally, we present our conclusions in Sec. V.

II. THE MODEL FOR SURFACE ABSORPTION

The system that we are interested in and that we shall study in the present section was described in the Introduction and is shown in Fig. 1.

The scattering problem can be studied in terms of an Ν N scattering m atrix S, which in the stationary case relates the outgoing-wave to the incom ing-wave am plitudes [4, 25]. As shown schematically in Fig. 1, S can be seen as the combination of a scattering matrix S₀ which describes a ballistic cavity connected to two nonabsorbing waveguides (one with N channels on the left and the other with N_a channels on the right) and the scattering matrix S_a that describes the absorbing mirror; S_a is a xed N_a N_a subunitary matrix which can be considered as an input to the problem . The lack of unitarity of S_a is de ned by $P_a = \mathbb{1}_{N_a}$ $S_a^{y}S_a$: in the most general situation, Sa, and hence Pa, is not a diagonal matrix. The overall absorption strength of the absorbing m irror can be quantified by $a = trP_a$.

The scattering matrix $S_{\,0}\,$ is of dimension N + N $_{a}$ and has the structure

where r_0 is the N N rejection matrix for incidence on the left, r_0^0 is the N_a N_a rejection matrix for incidence on the right and t_0 and t_0^0 are the corresponding transmission matrices of dimensions N_a N and N N_a, respectively.

The matrix S_0 will be considered to belong to one of the basic sym m etry classes introduced by D yson in Q uantum Mechanics [26], which we brie y recall in order to make a more precise statement. In the \unitary" case, also denoted by = 2, the only restriction on S₀ is unitarity, due to the physical requirem ent of ux conservation. In the \orthogonal" case (= 1) S_0 is also sym m etric because of either tim e-reversal invariance (TRI) and integral spin, or TRI, half-integral spin and rotational symmetry. In the \symplectic case (= 4), S₀ is self-dual because of TRIwith half-integral spin and no rotational symmetry. In the scattering problem of scalar classical waves, the orthogonal case is the physically relevant one. However, we shall consider below both = 1 and = 2, in the understanding that the unitary case is to be considered as a reference problem, as it is often simpler to treat m athem atically than the orthogonal one.

W e assume that the barrier inside the absorbing m irror is su ciently far apart from both the entrance to the cavity at one end and the perfect re ector at the other end that the evanescent modes do not play a role [4]. Then, following the combination rule of scattering m atrices, the totalS m atrix which describes the cavity with absorption is a subunitary m atrix given by

where $\mathbb{1}_n$ stands for the unit matrix of dimension n.

The physics of Eq. (2.2) is clear. The set term on the right hand side is the rejected part of the wave that enters the cavity; the transmitted part reaches the absorbing m irror with the (m atrix) amplitude t_0 and the fraction S_a (again a m atrix) thereof returns to the cavity; the wave then su ers a multiple scattering process between the cavity and the absorbing m irror, until – nally the fraction t_0^0 leaves the cavity through the lead on the left.

The statistical features of the quantum mechanical scattering produced by the cavity shown in the lower portion of Fig. 1 {assumed to have a chaotic classical dynam ics{ are described by a measure in the S_0 -matrix space which, through the assumption of ergodicity, gives the probability of nding S_0 in a given volume element as the energy E changes and S_0 wanders through that space [4]. In the absence of direct processes, or short paths, S_0 is taken to have a uniform distribution, given by the invariant measure for the symmetry class in question. The

invariant m easure, denoted by d (S_0) , is defined by its invariance under the sym m etry operation relevant to that universality class [26, 27]; i.e.,

where U_0 and V_0 are arbitrary but xed unitary matrices in the unitary case, while $V_0 = U_0^T$ in the orthogonal case. This de nest the circular unitary (orthogonal) ensemble, CUE (COE) for = 2 (= 1).

The distribution

of the resulting scattering matrix S of Eq. (2.2) for the full system consisting of the cavity plus the absorbing m irror can in principle be calculated for a given S_a , assuming that S_0 is distributed according to the invariant m easure, Eq. (2.3). This procedure is particularly well suited for num erical simulations. Indeed, it is used in Sec. IV to study num erically the case of one open channel (N = 1) and one absorbing channel (N = 1).

O ne property of p(S) is immediately obvious: the average of S vanishes, i.e., hSi = 0, as we can see by expanding the right-hand side of Eq. (2.2) and averaging term by term.

A lthough the explicit expression for p (S) is not known for an arbitrary number of channels, the case of one open channel (N = 1) and one absorbing channel (N = 1) can be solved analytically: this is done in Sec. IV, exploiting the relation with the parasitic-channelm odel that is explained in the next section.

III. RELATION BETWEEN THE SURFACE-ABSORPTION MODEL AND THE PARASITIC-CHANNEL MODEL




FIG. 2: In the parasitic-channel model, a ballistic chaotic cavity connected to a waveguide with N propagating modes is also connected to an additional, ctitious, waveguide supporting N_p \parasitic" channels. Inside the latter waveguide there is a (non-absorbing) barrier described by the scattering matrix S_b. Only the N N submatrix \$ of the total scattering matrix of this system is accessible to experiment; it is subunitary and is taken as a model for a real cavity in the presence of absorption.

In the parasitic-channelm odel described in the Introduction and sketched in Fig. 2 the cavity is attached to a waveguide supporting N physical channels, while absorption is simulated by attaching an additional, ctitious, waveguide supporting N_p equivalent \parasitic" channels, each one with a coupling given by a transm ission coe cient T_p [8, 10].

We denote by \$ the scattering matrix that describes the whole system shown in Fig. 2, including the ctitious waveguide and the (non-absorbing) barrier inside it; \$ is of dimension N + N_p and has the structure

where the indices 1 and p denote the set of N physical and N $_{\rm p}$ ctitious channels, respectively; it is unitary for = 2 and unitary-symmetric for = 1. The N N submatrix \$ describes the cavity in the presence of absorption, as one would observe it in an experiment in which only the

physical waveguide were present; \$ is subunitary and will be referred to as the \physical" S matrix.

The tunnel barrier in the ctitious waveguide in Fig. 2, described by the 2N $_{\rm p}$ $\,$ 2N $_{\rm p}$ unitary scattering m atrix $S_{\rm b}$

in plies an imperfect coupling of the parasitic channels to the cavity; it can also be interpreted as giving rise to direct processes in a system described by $\overset{b}{9}$ [31]. Then, for a cavity whose classical dynam ics is chaotic, $\overset{b}{9}$ is distributed according to the Poisson kernel [28, 29, 30]

where $N_T = N + N_p$, d (\diamondsuit) is the invariant m easure for \diamondsuit de ned as in Eq. (2.3), assumed to be normalized to unity, and

The probability distribution of the physical scattering matrix \$ that we are interested in has to be calculated from Eq. (3.3). This is how Brouwer and Beenakker showed that, in the lim it N_p ! 1 and T_p ! 0, with the product _p = N_pT_p being kept xed and interpreted as the absorption strength, this model describes volum e absorption, in the sense that the problem represented by \$ is equivalent to one in which all the energy levels of the closed cavity acquire a xed in aginary part, associated precisely with that absorption strength [8, 11].

Let us now think of the full system shown in Fig. 2 as the combination of the cavity connected to the two waveguides (in the absence of the barrier) and described by the $(N + N_p)$ $(N + N_p)$ scattering matrix

plus the barrier described by S_b . We shall not take, in what follows, the lim it mentioned in the previous paragraph, i.e., N_p will be kept nite. As we shall see, it will also be convenient, for the description of the barrier, to drop the \equivalent-channel" assumption norm ally made in this context [Eq. (3.2)] and consider a barrier matrix S_b with the general structure

The total scattering matrix \$ is then given by

which denote the barrier rejection and transm ission matrices associated with the two waveguides in Fig. 2 [notice that in the present model the left waveguide has no barrier; hence the matrices 0_N and $\mathbb{1}_N$ in Eq. (3.8); in a more complete model there might be a barrier in the left waveguide too (see comment at the end of Sec. IV)]. The physical S matrix S of Eq. (3.1) can then be found from Eq. (3.7) to be

C om paring Eqs. (2.2) and (3.9) we see that the model for surface absorption of Sec. II and the parasitic-channel m odel of the present section can be m ade equivalent, in the sense that \$ = S, choosing the number of parasitic channels in the latter to coincide with the num ber of absorbing channels in the form er, i.e., $N_p = N_a$, choosing the two cavities to be identical, i.e., $\$_0 = S_0$, and the barrier rejection m atrix r_b^0 of the present section to coincide with the absorption m atrix of Sec. II, i.e., $r_b^0 = S_a$.

W ithin the equivalent-channel assumption, equivalence of the twom odels would require $S_a = \begin{bmatrix} 1 & T_p & 1_{N_p} \end{bmatrix}$. If in our surface-absorption model we were to take the limit that was described right after Eq. (3.4) in connection with the parasitic-channel model, we would obtain the same answer as for volume absorption by identifying $_p$ with $_a = trP_a$ where $P_a = 1_{N_a}$, $S_a^y S_a$.

The statistical distribution of the scattering m atrix \$ of Eq. (3.7) is of course given by Poisson's kernel of Eq.

(3.3), where the average S m atrix $h^{\text{O}}i$ is now given by $h^{\text{O}}i = r_B$ [see Eq. (3.8a)], instead of Eq. (3.4). Using the identi cation described right after Eq. (3.9), the calculation of the resulting distribution of S also gives the distribution of S, Eq. (2.2), for the m odel of the previous section. This procedure will be taken advantage of in the next section, in order to analyze the case N = 1, N_a = 1.

In this section we calculate, within the surfaceabsorption model of Sec. II, the distribution of the scattering matrix S of Eq. (2.2) which describes a chaotic cavity perfectly connected to a waveguide supporting one channel (N = 1), and in the presence of one absorption channel (N _a = 1); S is thus a complex number that we parametrize as

The absorbing m irror is also described by a subunitary matrix $S_a = {}^1 \overline{R_a} \, e^{i \ a}$.

We can take advantage of the equivalence with the parasitic-channel model discussed in the previous section, with the identi cation: $N_p = N_a = 1$ and $T_p = P_a = 1$ R_a , $_a = 0$. For the present case, § of Eq. (3.1) is a 2 2 unitary matrix for = 2, with the additional condition of symmetry for = 1. It can be parametrized in a polar representation as [32, 33]

W hat remains to be calculated is thus the probability distribution of the relection coe cient R, P (R). Refs. [30] and [4] give the distribution of for certain particular cases of the average S matrix, of which Eq. (4.4) is a particular case. In Eqs. (5.8) and (5.11) of Ref. [30] (or Eqs. (6.81) and (6.85) of Ref. [4]), we make the substitution 1 $T_p = \frac{R}{R_a}$, together with X = 0, Y = $\frac{R_a}{R_a}$ in (5.8) and X = $\frac{R_a}{R_a}$, Y = 0 in (5.11) of Ref. [30], (or Eqs. In principle, the distribution of S could also be obtained from its de nition, Eq. (2.2), and the fact that S₀ is distributed according to the invariant measure. This procedure is especially suited for num erical simulations. The absorbing mirror is described by the 1 1 subunitary scattering matrix $S_a = \frac{1}{R_a}e^{i_a}$, where the phase a and the rejection coecient R a are xed; 0 R a1 and for simplicity we may take, as above, a = 0. The lack of unitarity of S_a is given by $P_a = 1$ R_a . The matrix S_0 of Eq. (2.1) is a 2 2 unitary matrix that can be param etrized in a polar representation as in Eq. (4.2), with the various parameters now having an index ${}^{0}_{0}; {}^{0}_{0}; {}^{00}_{0}; {}^{00}_{0} < 2$ and 0 and the range of variation: 0 $_0$ 1; for = 1 we have the restrictions $_0^0 = _0$ 0 $_{0}^{0} = _{0}$. The distribution of S can then be obtained from Eq. (22).




FIG. 3: Distribution of R of Eq. (4.1) for a) = 2 and b) = 1 symmetries, for one open channel, N = 1, one absorbing channel, N_a = 1, and R_a = 0:1, 0.5, and 0.9. The continuous lines are the analytical results given by Eqs. (4.8) for = 2 and (4.9) for = 1. The numerical simulation was performed as explained in the text using 10^4 samples; the di erent values of R_a are distinguished by the symbols also shown in the gure. The agreement between theoretical and numerical results is excellent.

In Fig. 3 we compare the analytical results of Eqs. (4.8) and (4.9) with the results of a num erical simulation

obtained from the ensemble of Eq. (4.10) and the relation (2.2) between S and S_0 : the agreem ent is excellent.

We should point out that in real experiments the waveguide is not perfectly coupled to the cavity, as has been shown in Ref. [15], thus giving rise to direct processes. In such cases, the distribution of S must be modi ed by the procedure of Ref. [21].

V. SUMMARY AND CONCLUSIONS

We have presented a model to describe the statistical properties of wave scattering in a ballistic chaotic cavity in the presence of surface absorption: it is suggested that this type of absorption be realized in the laboratory by attaching one or several \absorbing patches" to the inner wall of the cavity. The model simulates one such absorbing patch by means of an absorbing mirror, whose physical characteristics, i.e., its cross section and its absorption properties, are, in principle, experimentally measurable.

We compare our model with the parasitic-channel

m odel introduced by other authors and nd the conditions under which the two are equivalent. It is found in the literature that in the limit of a large number of parasitic channels weakly coupled to the cavity, the parasitic-channel m odel describes absorption uniform ly distributed over the volume of the cavity; in this limit, volum e and surface absorption give the same results.

F inally, we show that ourm odel is analytically solvable for the case of one open channel, N = 1, and one absorbing channel, $N_a = 1$, for arbitrary absorption strength. The results of num erical simulations for this case are in excellent agreement with theory. In principle, this problem is am enable to experimental observation.
