Third and Fourth Order Phase Transitions: Exact Solution for the Ising M odel on the Cayley Tree

An exact analytical derivation is presented, showing that the Ising model on the Cayley tree exhibits a line of third order phase transition points, between temperatures $T_2 = 2k_B^{-1} J \ln (2 + 1)$ and $T_{B\,P} = k_B^{-1} J \ln (3)$, and a line of fourth order phase transitions between $T_{B\,P}$ and 1, where k_B is the Boltzm ann constant, and J is the nearest-neighbor interaction parameter.

Ever since the pioneering works on phase transitions and critical phenom ena, it has been clear that phase transitions of higher order are conceptually possible, but, to the best of our know ledge, up to date there has been no rigorous proof of existence of a single system exhibiting a phase transition of nite order higher then two.

One notable attempt in this direction is the work of Muller-Hartmann and Zittartz [1], interpreting the series expansion of the free energy of the Ising model on the Cayley tree in the limit of small eld H ! 0⁺, in terms of phase transitions of all even orders (from two to in nity). More precisely, their claim was that the susceptibility of order 2' (i.e. the 2'-th derivative of the free energy with respect to eld), diverges at tem perature $T_{2^{*}} = k_{B}^{-1} J \ln [1 + 2] (B^{1})^{-1}$ 1)] for ' = 1;2;:::;1 , where B is the tree branching num ber (coordination number minus 1). Thus, the zero eld susceptibility was found to diverge from T = 0 to $T_2 = k_B^{-1} J \ln [(B + 1)] = (B + 1)$ 1)], representing a line of second order phase transitions (with respect to eld), fourth order susceptibility was found to diverge between T_2 and $T_4 = k_B^{-1} J \ln [(B^{3=4} + 1) = (B^{3=4} - 1)]$, representing a line of fourth order phase transitions, while the in nite order phase transition was found to occur at the Bethe-Pierls tem perature $T_{BP} = k_B^{1} J \ln [(B + 1)=(B + 1)]$ 1)].

It is shown in this work through an exact analytical culation of the recursion relations for the derivatives of the free energy, that the exact expressions contain term s previously unnoticed [1] in the approximate analysis. Interpratation of these results requires some special consideration of symmetry breaking, the classical approach not being adequate for the system at hand. It is found that the third order derivative diverges between T_2 and $T_{\rm B\,P}$ (all the lower derivatives being nite), representing a line of third order phase transitions, while the fourth order derivative diverges between $T_{B\,P}$ and 1 (where all lower derivatives are nite), representing a fourth order phase transition line.

W e consider the nearest-neighbor Ising m odelw ith the H am iltonian

where J is the coupling constant, H is the external magnetic eld, $S_i = 1$ is the spin at site i, and hnni denotes summation over the nearest-neighbor pairs. For simplicity, hereafter we consider only the tree with B = 2, while the analysis which follows may be directly generalized for arbitrary tree branching number. Following Eggarter [2], we further consider systems situated on a single n-generation branch of a Cayley tree, composed of two (n 1)-generation branches connected to a single initial site. Thus, the n-generation branch being a single spin. The exact recursion relations for the partial partition functions of any two consecutive generation branches are easily derived [2] to be

where Z_n^+ and Z_n^- denote the partition functions restricted by xing the initial spin (connecting the two n-generation branches) into the f+g and f g position, respectively, and where we have used the notation x

 $\exp(J)$ and $y = \exp(H)$, with $= 1=k_B T$ denoting the reciprocal of the product of the Boltzm ann constant k_B and the tem perature T. The usual approach of attem pting to establish the eld dependent expression for the partition function in the therm odynam ic lim it, then nding its eld derivatives, and nally taking the lim it H ! 0 yields only approxim ate solutions for the zeroeld susceptibility [1, 3, 4]. In an earlier work [5], current authors have derived an exact expression for the zero- eld m agnetization and susceptibility, by using the strategy of nding the recursion relations for the eld derivatives of the partition function, taking the lim it H ! 0, and only then perform ing the actual iterations to reach the therm odynam ic lim it. Here we extend this approach to nd higher derivatives of the partition function.

Equation (2) can be formally dimensional with respect to eld, to nd the recursion relations for the eld derivatives of the partition function. Up to the forth derivative we nd the following recursion relations

Starting from a single spin (0-th generation branch), for which we have $({}^{k}Z_{0} = ({}^{k}h^{k} = (1)^{k}y^{1}, \pm \text{ is straight-forward to show by mathematical induction, using (2-6), that for zero eld (y = 1) the symmetry equations$

hold for a branch of arbitrary generation n. It then follows from (2–7) that the moments $S_n = \frac{1}{Z_n^+} \frac{\varrho^2 Z_n^+}{\varrho h^2}$, $T_n = \frac{1}{Z_n^+} \frac{\varrho^2 Z_n^+}{\varrho h^2}$, $U_n = \frac{1}{Z_n^+} \frac{\varrho^3 Z_n^+}{\varrho h^3}$, and $V_n = \frac{1}{Z_n^+} \frac{\varrho^4 Z_n^+}{\varrho h^4}$ satisfy the recursion relations,

where t tanh (J). Relations (8) can be iterated (by sum ming the geometric series) to yield closed-form expressions for S_n , T_n , U_n and V_n for arbitrary tree generation n, and we nd

Before proceeding with the analysis of the above exact expressions, a word is due on symmetry breaking. It has been commonly accepted for this model that all odd derivatives of the free energy with respect to eld are identically zero in zero eld because of symmetry, and only even derivatives have been analyzed [1, 6, 7] (in fact, equations sim ilar to (10) and (12) for the second and fourth derivatives have been derived in references [6, 7] by neglecting odd correlations). However, this is true for any lattice in strictly zero eld, as every spin con guration has a mirror in age (obtained by ipping all the spins) with exactly the same energy, pand inverted sign of the con gurational magnetization , Si. The usual procedure of breaking the symmetry by retaining an innitezim alpositive eld while taking the therm odynam ic lim it, and only then taking the zero eld lim it, is not suitable in the present case because the derivatives of the free energy diverge in wide tem perature regions (rather than just in a single critical point). Here it seem sm ore appropriate to break the symmetry by applying an in nitely strong local eld of in nitezim al range, which can be im plem ented by restricting a single spin into one of the two possible orientations, while considering all the possible orientations of all the other spins. In a recent work [10], the present authors have analyzed the e ect of restricting a single spin in the f+g orientation on m agnetization (rst derivative of the free energy with respect to eld), for the current system . It was found that symmetry is indeed broken by xing an arbitrary (surface, bulk or center) spin. W hile without this restriction m agnetization is identically zero in strictly zero eld for arbitrary system size, it was shown that xing any spin leads to magnetic ordering of extrem ely large system s, in a wide tem perature range (even if magnetization does go to zero in the therm odynam ic lim it for all nonzero tem peratures).

In the rest of this paper, we shall therefore adopt the

strategy of breaking the symmetry by xing a single (central) spin in the f+g (upward) orientation while taking the therm odynamic limit, and we shall henceforth use the term '-th order susceptibility for the quantities

for nite size system s, and

⁽¹⁾ is found The restricted magnetization, < m > +[5, 8] to be zero for all nonzero temperatures in the therm odynam ic lim it, (even if it retains nonzero values in a wide temperature range for systems far exceeding in number of particles the observable Universe [10]), while 2-nd order susceptibility $\binom{2}{n}$ diverges below $T_2 = 2k_B^{-1} J \ln \left(\frac{7}{2} + 1 \right)$. It was also recently shown [9] that in the therm odynam ic lim it the divergence of ⁽²⁾ in the vicinity and at T_2 is extremely weak, with critical exponent = 0, where susceptibility of a nite tree $n^{(2)}$ diverges proportionally to the three generation leveln, as n! 1. In the rest of this paper, we analyze the third and fourth order susceptibility given by $\binom{3}{n}$ $^{2}U_{n}=N_{n}$ and $n^{(4)}$ ${}^{3}V_{n} = N_{n}$, respectively.

Equations (10-12) are deceptive in the sense that at rst glance they suggest divergence of second, third and fourth order susceptibilities for arbitrary tree generation level n, at points $2t^2 = 1$ and 2t = 1 (corresponding to T_2 and T_{BP} , respectively), while in addition, the fourth order susceptibility seem s to diverge (irrespective of n) at $4t^3 = 1$ and $8t^4 = 1$ (the last corresponding to the M uller-H artm an and Z ittartz tem perature T_4 [1]). In fact, the exact expression corresponding to (12), but obtained by neglecting odd correlations [6], indeed does diverge at

 $8t^4 = 1$. On the other hand, a more detailed analysis of (10-12) shows that the interplay between the individual terms cancels out these aparent singularities at the mentioned temperature points. In particular, upon series expansion of the exact expressions (10-12) arround these points (from either side), it is found that there is no divergence for any nite n.W e give the leading terms of these expansions for large n in Tabs. I and II.




FIG.1: Scaled second, third and fourth-order zero- eld susceptibilities, calculated using form ulas (10-12), for several system sizes n = 64;128;256 and 1024. The dotted vertical lines indicate the points T_2 and $T_{\rm B\,P}$, where the transition changes from second to third, and from third to fourth order, respectively.

C onsequently, divergence of higher order susceptibilities in the therm odynam ic lim it in di erent tem perature regions is caused only by diverging generation level n, and the nite size scaling is accomplished simply by the form ula ln $\hat{n} = n$. In Fig. 1 we show the scaled curves of higher order derivatives, obtained using form ulas (10-12), for several system sizes.

It is seen from Fig.1 that there are three distinct tem perature regions, where each temperature represents a point of second, third, or fourth order phase transition. Between zero and T2 the second derivative diverges (the rst derivative being nite), and we have a second order phase transition line. Between T_2 and T_{BP} the third derivative diverges (rst and second derivatives being nite), representing a line of third order phase transitions, while the fourth order derivative diverges between $T_{B\,P}$ and 1 (where all low er derivatives are nite), representing a fourth order phase transition line. The explicit expressions for the lim iting curves, corresponding to the nite size system curves shown in Fig. 1, are obtained by $\lim_{n \to 1} \ln_n = n$, and the results taking the lim it obtained using form ulas (10-12) for di erent tem perature regions are sistem atized in Tab. III.

In conclusion, after decades of continuous interest, the Ising model on the Cayley tree continues to furnish new insights into critical phenom ena. Being a highly unphysical system (with its in nite dimension and nite order of ram i cation), Cayley tree may turn out a unique struc-

ture where phase transitions of order higher then two indeed do exist, and the latter may prove to be of only academ ic interest. On the other hand, it is possible that current ndings may turn out relevant for interpretation of experim ental data on nite size branching structures, of the real observable physical world.
