# Third and Fourth O rder Phase Transitions: Exact Solution for the Ising $M$ odel on the C ayley Tree

#### Abstract

A $n$ exact analytical derivation is presented, show ing that the Ising $m$ odel on the $C$ ayfey tree exhibits a line of third order phase transition points, betw een tem peratures $T_{2}=2 \mathrm{k}_{\mathrm{B}}{ }^{1} \mathrm{~J} \ln (\overline{2}+1)$ and $T_{B P}=k_{B}{ }^{1} J \ln (3)$, and a line of fourth order phase transitions betw een $T_{B P}$ and 1 , where $k_{B}$ is the Boltzm ann constant, and $J$ is the nearest-neighbor interaction param eter.

Ever since the pioneering works on phase transitions and criticalphenom ena, it hasbeen clear that phase transitions of higher order are conceptually possible, but, to the best of our know ledge, up to date there has been no rigorous proof of existence of a single system exhibiting a phase transition of nite order higher then two.

O ne notable attem pt in this ection is the work of M ullerH artm ann and Zittartz interpreting the series expansion of the free energy of the Ising $m$ odel on the C ayley tree in the lim it of small eld H ! $0^{+}$, in term $s$ of phase transitions of all even orders (from two to in nity). M ore precisely, their claim was that the susceptibilly of order 2' (i.e. the 2 'th derivative of the free energy $w$ ith respect to eld), diverges at tem perature $T_{2}$, $=k_{B}{ }^{1} J \ln \left[1+2=\left(B^{1} \quad 1=2^{`} \quad 1\right)\right]$ for ' = 1;2;:::;1, where B is the tree branching num ber (coordination number $m$ inus 1). Thus, the zero eld susceptibility $w$ as found to diverge from $T=0$ to $T_{2}=k_{B}{ }^{1} J \ln \left[(\bar{B}+1)=\left(\begin{array}{ll}\bar{B} & 1)] \text {, representing a line }\end{array}\right.\right.$ of second order phase transitions (w ith respect to eld), fourth order susceptibility $w$ as found to diverge betw een $\mathrm{T}_{2}$ and $\mathrm{T}_{4}=\mathrm{k}_{\mathrm{B}}{ }^{1} \mathrm{~J} \ln \left[\left(\mathrm{~B}^{3=4}+1\right)=\left(\mathrm{B}^{3=4} \quad 1\right)\right]$, representing a line of fourth order phase transitions, while the in nite order phase transition was found to occur at the B ethe$P$ ierls tem perature $T_{B P}=k_{B}^{1} J \ln [(B+1)=(B$
1)].

It is show $n$ in thisw ork through an exact analyticalcalculation of the recursion relations for the derivatives of the free energy, that exact expressions contain term $s$ previously unnotioec in the approxim ate analysis. Interpratation of these results requires som e special consideration of sym $m$ etry breaking, the classical approach not being adequate for the system at hand. It is found that the third order derivative diverges betw een $T_{2}$ and $\mathrm{T}_{\mathrm{BP}}$ (all the low er derivatives being nite), representing
a line of third order phase transitions, while the fourth order derivative diverges betw een $T_{B P}$ and 1 (where all low er derivatives are nite), representing a fourth order phase transition line.

W e consider the nearest-neighbor Ising $m$ odelw th the H am iltonian

$w$ here $J$ is the coupling constant, $H$ is the extemalm agnetic eld, $S_{i}=1$ is the spin at site $i$, and hnni denotes sum $m$ ation over the nearest-neighbor pairs. For sim plicity, hereafterw e consider only the tree w ith $B=2$, while the analysis which follow s m ay be directly generalized fo bitrary tree branching num ber. Follow ing Eggarter we further consider system s situated on a single $n$-generation branch of a C ayley tree, com posed of two ( $n$ 1)-generation branches connected to a single initial site. Thus, the n-generation branch consists of $\mathrm{N}_{\mathrm{n}}=2^{\mathrm{n}+1} \quad 1$ spins, the 0 -generation branch being a single spin. The exact recursion relations for the partialpartition functions of an wo consecutive generation branches are easily derived to be

where $\mathrm{Z}_{\mathrm{n}}^{+}$and $\mathrm{Z}_{\mathrm{n}}$ denote the partition functions restricted by xing the initial spin (connecting the two $n$-generation branches) into the $f+g$ and $f g$ position, respectively, and where we have used the notation $x$ $\exp (J)$ and $y \exp (H)$, with $=1=k_{B} T$ denoting the reciprocal of the product of the Boltzm ann constant $k_{B}$ and the tem perature $T$. The usual approach of attem pting to establish the eld dependent expression for
the partition function in the therm odynam ic lim it, then nding its eld derivatives, and nally taking the lim it H ! 0 yields or ${ }^{2}$.......... ate solutions feroeld susceptibility In an earlier work current authorshave derived an exact expression forthe zero- eld $m$ agnetization and susceptibility, by using the strategy of nding the recursion relations for the eld derivatives of the partition function, taking the $\lim$ it $\mathrm{H}!0$, and only then perform ing the actual iterations to reach the them odynam ic lim it. H ere we extend this approach to nd higher derivatives of the partition function.
Equation
can be form ally di erentiated w th respect to eld, to nd the recursion relations for the eld derivatives of the partition function. Up to the forth derivative we nd the follow ing recursion relations

B efore proceeding $w$ th the analysis of the above exact expressions, a word is due on symmetry breaking. It has been com $m$ only accepted for this $m$ odel that all odd derivatives of the free energy w ith respect to eld are identically zero in zero eld because of ny, and only even derivatives have been analyzec (in fact, equations sim ilartc and for the secor fourth derivatives have been derived in references by neglecting odd correlations). H ow ever, this is true for any lattice in strictly zero eld, as every spin con guration has a $m$ irror im age (obtained by ipping all the spins) $w$ ith exactly the sam e energy, $P^{\text {and }}$ inverted sign of the con gurationalm agnetization ${ }_{i} S_{i}$. The usual procedure of breaking the sym $m$ etry by retaining an innitezim alpositive eld while taking the therm odynam ic lim it, and only then taking the zero eld lim it, is not suit$a b l e$ in the present case because the derivatives of the free energy diverge in wide tem perature regions (rather than just in a single criticalpoint). H ere it seem sm ore appropriate to break the sym $m$ etry by applying an in nitely strong local eld of in nitezim al range, which can be im plem ented by restricting a single spin into one of the tw o possible orientations, while considering all the po orientations of all the other spins. In a recent work the present authors have analyzed the e ect of restrmeting a single spin in the $f+g$ orientation on $m$ agnetization ( rst derivative of the free energy w ith respect to eld), for the current system. It was found that symmetry is indeed broken by xing an arbitrary (surface, bulk or center) spin. W hile $w$ ithout this restriction $m$ agnetization is identically zero in strictly zero eld for anbitrary system size, it was show $n$ that xing any spin leads to $m$ agnetic ordering of extrem ely large system $s$, in a w ide tem perature range (even ifm agnetization does go to zero in the them odynam ic lim it for all nonzero tem peratures).

In the rest of this paper, we shall therefore adopt the
strategy ofbreaking the sym $m$ etry by xing a single (central) spin in the $f+g$ (upward) orientation while taking the them odynam ic lim it, and we shall henceforth use the term '-th order susceptibility for the quantities

restricted $m$ agnetization, $<m>^{+} \quad$ (1) is found to be zero for all nonzero tem peratures in the therm odynam ic lim it, (even if it retains nonzero values in a wide tem perature range for system $s$ far exanding in number of particles the observable U niverse
, while 2 -nop order susceptibility $n_{n}^{(2)}$ ditverges be. $\mathrm{T}_{2}=2 \mathrm{k}_{\mathrm{B}}{ }^{1} \mathrm{~J} \ln (\overline{2}+1)$. It w as also recently show n that in the them odynam ic lim it the divergence of in the vicinity and at $\mathrm{T}_{2}$ is extrem ely weak, w ith critical exponent $=0$, where susceptibility of a nite tree ${ }_{n}^{(2)}$ diverges proportionally to the three generation leveln, as n ! 1 . In the rest of th is paper, we analyze the third and fourth order susceptibility given by ${ }_{n}^{(3)} \quad{ }^{2} U_{n}=N_{n}$ and ${ }_{\mathrm{n}}^{(4)} \quad{ }^{3} \mathrm{~V}=\mathrm{N}$, respectively.

Equations are deceptive in the sense that at rst glance they suggest divergence of second, third and fourth order susceptibilities for arbitrary tree generation leveln, at points $2 t^{2}=1$ and $2 t=1$ (corresponding to $\mathrm{T}_{2}$ and $\mathrm{T}_{\mathrm{BP}}$, respectively), while in addition, the fourth order su sceptibility seem s to diverge (irrespective ofn) at $4 t^{3}=1$ and $8 t^{4}=1$ (the last corresponc to the M uller$H$ artm an and $Z$ ittartz tem perature $T$. . In fact, the exact expression correspond to but obtained by neglecting odd correlations indeed does diverge at

$8 t^{4}=1$ O $n$ the other hand, a m ore detailed analysis show s that the interplay betw een the individual tem s cancels out these aparent singularities at the $m$ entioned tem perature points. In partialar upon series expansion of the exact expressions arround these points (from either side), it is found that there is no divergence for any nite $n$. W e give tho leading tem $s$ of these expansions for large $n$ in $T$ abs

C onsequently, divergence of higher order susceptibilities in the therm odynam ic lim it in di erent tem perature regions is caused only by diverging generation leveln, and the nite size scaling is accom plished sim ply by the form ula $\ln { }_{n}=n$. In $F i g$. 1 we show the scaled qurres of higher order derivatives, obtained using form ulas for several system sizes.

It is seen from F ig. 1 that there are three distinct tem perature regions, where each tem perature represents a point of second, third, or fourth order phase transition. $B$ etw een zero and $T_{2}$ the second derivative diverges (the rst derivative being nite), and we have a second order phase transition line. B etw een $T_{2}$ and $T_{B P}$ the third derivative diverges ( rst and second derivatives being nite), representing a line ofthird order phase transitions, while the fourth order derivative diverges betw een $T_{B P}$ and 1 (w here all low er derivatives are nite), representing a fourth order phase transition line. T he explicit expressions for the lim iting curves, corresponding to the nite size system curves show $n$ in F ig. 1 , are obtained by taking the $\lim$ it $\lim , \ln { }_{n}=n$, and the results obtained using form ulas forci erent tem perature regions are sistem atized in 1 alo

In conchusion, after decades of continuous interest, the Ising $m$ odel on the $C$ ayley tree continues to fumish new insights into criticalphenom ena. B eing a highly unphysicalsystem ( $w$ ith its in nite dim ension and nite order of ram $i$ cation), $C$ ayley tree $m$ ay tum out a unique struc-

ture where phase transitions of order higher then two indeed do exist, and the latter $m$ ay prove to be of only academ ic interest.
