# P seudo-P ath Sem iclassical A pproxim ation to $T$ ransport through $O$ pen $Q$ uantum B illiards: D yson Equation for D i ractive Scattering

#### Abstract

W e present a sem iclassical theory for transport through open billiards of arbitrary convex shape that includes di ractively scattered paths at the lead openings. Starting from a Dyson equation for the sem iclassical $G$ reen's function we develop a diagram $m$ atic expansion that allow s a system atic sum $m$ ation over classical paths and pseudo-paths which consist of classical paths joined by di ractive scatterings ( $\backslash$ kinks"). This renders the inclusion of an exponentially proliferating num ber of pseudo-path com binations num erically tractable for both regular and chaotic billiards. For a circular billiard and the Bunim ovich stadium the path sum leads to a good agreem ent with the quantum path length power spectrum up to long path length. Furtherm ore, we nd excellent num erical agreem ent $w$ ith experim ental studies of quantum scattering in $m$ icrow ave billiards where pseudo-paths provide a signi cant contribution.

## I. IN TRODUCTION

Sem iclassical approxim ations are am ong the m ost useful tools in describing and analyzing ballistic transport in $m$ esoscopic system $s$. On a fiundam ental level, sem iclassicaltechniques allow to build a bridge betw een classical and quantum $m$ echanics: the classical paths carry an am plitude which re ects the geom etric stability of the orbits and a phase that contains the classical action and

B allistic transport through billiards has been studied ex-


 have been introduced in order to provide a qualitative and, in part, also a quantitative description of these system s. In particular, universal conductance uctuations (UCF) and the \weak localization" (W L) have been studied [12] in order to delineate characteristic di erences in the quantum transport of classically chaotic and integrable billiards. Very recently, quantum shot noise [24]
 [ $\left.{ }_{2}^{2} \overline{7}_{1}\right]$ or display a m ixed phase space [2] ${ }_{2}^{\prime}$ ] has been used as a probe of the quantum -to-classical and chaotic-to regular


T he approach of the (sem i) classical lim it of ballistic quantum transport is both conceptually as well as num erically non-trivialas it represents, generically, a m ulti-

[^0]scale problem. The tw o-dim ensionalquantum billiard (or quantum dot, see Fig. 1) is characterized by an area A or linear dim ension $D=P \bar{A}$. The quantum $w$ ires (or leads) to which the billiard is attached have the width d. In order to reach su ciently long dwell tim es such that di erences betw een transiently regular and chaotic $m$ otion becom e im portant, the relation $d=D \quad 1$ should hold. To approach the sem iclassical lim it for the $m$ otion inside the billiard requires D D ( $D$ de B roglie wave length) or equivalently kD 2 . Furtherm ore, if the (disorder) potential inside the dot varies over a length scale $a_{p}$, we should require $d \quad a_{p}$ for a sem iclassical approxim ation to hold. T hese conditions pertaining to the dot are necessary but not su cient. Since the scattering ( S ) m atrix $m$ aps asym ptotic scattering states onto each other, also the entrance and exit channelstates in the quantum w ire should reach their classical lim it,
d orkd 2 . The latter lim it is virtually im possible to reach, neither experim entally for quantum dots
 [331]. W ew ill therefore focus in the follow ing on the \interior" or \interm ediate" sem iclassical regim e pertaining to the interior of the billiard, $D \quad D$ with convex hard-w alled boundaries such that quantum di raction in the interior can be neglected, w ith the understanding, how ever, that quantum e ects due to the coupling to the asym ptotic quantum w ires have to be taken into account. A ccordingly, the term \sem iclassical approxim ations" refers in the follow ing to approxim ations to the constant-energy $G$ reen's function for propagation in the interior of the $\operatorname{dot} G\left(x ; x^{0} ; k\right)$ by an approxim ate sem iclassical lim it, G SC to be discussed below. The projections of $G$ onto asym ptotic scattering states with
transverse quantum num bers $m_{L}\left(m_{R}\right)$ yield the am plitudes for transm ission $T_{m_{I} ; m_{R}}$ from the entrance (left) to the exit (right) lead and re ections $\mathrm{R}_{\mathrm{m}_{\mathrm{I}} ; \mathrm{m}_{\mathrm{L}}^{0} \text {. Stan- }}$ dard sem iclassical approxim ations to $G$ face several fun-
 others, unitarity is violated with discrepancies in som e cases as large as the conductance uctuations the the-
 correlation 打 $3=R_{2}^{2} j$ between transm ission uctuations, $\mathbb{T}\}$, and the corresponding uctuations in the re ection, $R\}$, as a function of the wave num ber $k$ is broken. A lso, the \weak localization" e ect is consider$a b l y$ overestim ated $\left.\left[144^{\prime}, 13\right]^{\prime}\right]$. T hese di culties are due to the fact that hard-w alled billiards possess \sharp edges" at the entrance and exit leads even though the interior of the dot features a sm ooth (in the present case, a constant) potential. A t these sharp edges the contacts to the quantum $w$ ires feature spatial variations of the potential where the length scale $a_{p}$ approaches zero. C onsequently the sem iclassical lim it $D=a_{P} \quad 1$ cannot be reached, no $m$ atter how small d (or large $k$ ) is. In other words, the quantum properties of the leads in uence also the sem iclassical dynam ics in the interior. This observation is the starting point for_di ractive corrections such as the K irchho di raction $\bar{W}$

W e have recently developed_ a pseudo-path sem iclassical approxim ation (PSCA) [131] w ith pseudo-paths that result from spaw ning of classical paths due to di ractive (i.e. non-geom etric) re ections in the lead $m$ ouths (or point contacts). P seudo-pathsplay an essentialrole w hen inconporating indeterm inistic features into the sem iclassical description of transport. Their existence has also recently been pointed out in Ref. [3] [2], although no explicit num erical investigations were perform ed. W hile classical tra jectories are either ejected through the exit lead contributing to $T$ or retum back to the entrance lead contributing to $R$, a quantum wavepacket will do both. P seudo-paths interconnect otherw ise disjunct subsets of classical paths that exit either through the left or right lead. The lack of this coupling is responsible for violation of the anticorrelation of transm ission and re ection uctuations, $T^{2} \in R^{2}$, in standard sem iclassical approxim ation (SC A). Likew ise, the standard SC approxim ation is expected to fail for quantum shot noise [25] that is a signature of this quantum indeter$m$ inism. For the special case of the rectangular shaped dot $w$ th lead openings placed at the $m$ idpoints, sum $m$ ation of exponentially proliferating pseudo-paths could be accom plished by tracing trajectories in an extended zone schem e [13, 3 [3]. For arbitrarily shaped billiards and, in particular, chaotic billiards where already classical tra jectories proliferate exponentially, system atic inclusion of paths and pseudo-paths up to the sam e length is considerably $m$ ore com plicated. In the follow ing we address this problem within the fram ew ork of a sem iclassical D yson equation. W e present a diagram $m$ atic expansion that allows a system atic sum $m$ ation of classical path and pseudo-path contributions. A pplications

to the circular billiard (as a prototypical regular system) and to the B unim ovich stadium billiard (as the prototype system for chaotic scattering) show good agreem ent w ith the num erically calculated exact quantum path length spectrum. W e furthem ore apply the PSCA to recent experim entalstudies ofquantum scattering in $m$ icrow ave billiards in which pseudo-path contributions could be experim entally identi ed.

The plan of the paper is as follows: In section II we brie y review the standard sem iclassical approxim ation and previous attem pts to include di raction e ects. T he pseudo-path sem iclassical approxim ation for arbitrarily convex shaped billiards will be presented in section III em ploying a sem iclassical version of the $D$ yson equation. W e develop a diagram $m$ atic expansion of $G$ in term $s$ of paths and pseudo-paths. Its evaluation is num erically facilitated by an algebraic $m$ atrix representation that reduces path sum $m$ ations up to in nite order to a sequence of $m$ atrix $m$ ultiplications and inversions, as discussed in section IV . N um erical results and com parison with the full quantum results as well as m icrow ave experim ents are given in section $V$, follow ed by a short sum $m$ ary and outlook onto fiuture applications in sec. V I. D etails on the Fraunhofer di raction approxim ation are given in the appendix.
II. STANDARD SEM ICLASSICAL APPROXIMATION
$T$ he conductance of a ballistic tw o-term inalsystem (as depicted in Fig. 1) is determ ined by the scattering am plitudes $\mathrm{T}_{\mathrm{m}}$ through the Landauer form ula $\left[\bar{\beta}_{2} \overline{1}_{1}\right]$,

$w$ here $M$ is the num ber ofopen $m$ odes in the leads (quantum w ires) and $\mathrm{T}_{\mathrm{m}_{\mathrm{R}} ; \mathrm{m}_{\mathrm{I}}}(\mathrm{k})$ are the transm ission amplitudes from the $\mathrm{m}^{\text {th }} \mathrm{m}$ ode in the entrance lead rreferred to in the follow ing as left (L) lead] to the ( $\mathrm{m}^{0}$ ) th m ode
in the exit lead [referred to as the right $(\mathbb{R})$ lead]. In the follow ing we choose local coordinate system $s\left(x_{i} ; y_{i}\right)$, $i=L ; R$ for the leads, where $x_{i}$ denotes the longitudinal and $y_{i}$ the transverse direction of lead i. For sim plicity we use the coding ( $L, R$ ) for the entrance and exit channels throughout this publication, irrespective of the actual location at which the leads are attached. The pro jection of the retarded $G$ reen's propagator onto the transvense wave functions $m_{r_{I}}\left(y_{L}\right)$ and $m_{R}\left(y_{R}\right)$ of incom ing and outgoing $m$ odes [12] serves as starting point for $m$ ost sem iclassical theories which approxim ate trans$m$ ission amplitudes from $m$ ode $m_{L}$ to $m$ ode $m_{R}$ :

where d denotes the width of the leads. We assum e, for simplicity, that the two leads have identical width. $T$ he scattering state in the lead is the product of the transverse lead wave function $m$ ( $y$ ) and a plane wave in the longitudinal direction w th w ave vector $\mathrm{k}_{\mathrm{x}, \mathrm{m}}=$ $\overline{k^{2} \quad j n}=d^{2} j$. Both leads have a total of $(m=$ 1;:::;M ) open (i.e. transm itting) m odes. The term $\mathrm{k}_{\mathrm{x}_{\mathrm{L}}} \mathrm{j}\left(\mathrm{j}_{\mathrm{x}_{\mathrm{L}}}^{0} \mathrm{j}\right)$ denotes the longitudinal com ponent of the $m$ om entum of the incom ing (outgoing) wave function at the left lead.
$T$ he sem iclassicalapproxim ation to the scattering am plitudes is obtained by approxim ating the $G$ reen's function $G\left(x_{2} ; x_{1} ; k\right)$ in Eq. (2_2) by the sem iclassicalG reen's propagator $\mathrm{G}^{\mathrm{SC}}\left(x_{2} ; \varkappa_{1} ; \mathrm{k}\right)$. The standard sem iclassical G reen's propagator $G{ }^{S C}\left(x_{2} ; \mathfrak{x}_{1} ; k\right)$, the Fourier-Laplace transform of the van $V$ leck propagator evaluated in stationary phase approxim ation (SPA), describes the probability am plitude forpropagation from $\varkappa_{1}$ to $\varkappa_{2}$ at a xed energy, $\mathrm{E}=\mathrm{k}^{2}=2$. It can be expressed in term s of a sum over allclassicalpaths ofenergy E (or, equivalently, wavevector k) connecting these two points [1] [1]

Here, $S\left(x_{2} ; x_{1} ; k\right)=k L$ is the action of the path of length $L$. D ( $\left.x_{2} ; x_{1} ; k\right)$ is the classical de ection factor [1]I] which describes the stability of the paths and denotes the M aslov index of the path. In line with the semiclassical approxim ation, the double integrals in Eqs. (2-2) and (2.4) are frequently evaluated in stationary phase approxim ation. Physically this $m$ eans that the paths are entering and exiting the cavity only w th the discrete angles $m=\arcsin [m=(d k)]$ due to the quantization of the transverse $m$ om entum in the leads. For com pleteness wem ention at this point that the path-sum in Eq. (2, 8 . ) contains also those orbit pairs described in Ref. [23] which yield a weak-localization correction beyond the diagonal approxim ation.

Several strategies have been proposed to introduce di ractive e ects in order to quantitatively im prove the sem iclassical theory for transport through open quantum billiards. A straightforw ard way is to elim inate the SPA for the double integral in Eq. (2.4). Expanding the action in the sem iclassical G reen's function Eq. (2.8) to rst order in the transverse coordinate, the integraltakes the form of a Fraunhofer di raction integral and can be evaluated analytically $\left.{ }^{[ } \mathbb{d}\right]$. On this level of approxi$m$ ation, di raction e ects are thereby autom atically included, how ever only upon entering and exiting the cavity, not during propagation inside the cavity. Schw ieters et al. [1] $]$ em ployed $K$ irchho di raction theory to calculate the di ractional weight of paths entering and exiting the billiard. In addition, they introduced the concept of \ghost-paths": paths that are specularly re ected at the lead opening due to di ractive e ects. The proper use of a di ractions weight for classical paths allow ed the quantitative determ ination of the peak heights in the power spectra of the transm ission and re ection am plitudes [ $\left.\underline{5}_{1}^{\prime}, 1, \mathbb{l}_{1}^{\prime}\right]$ - at least for short path lengths. G host onbits could account for som e of the peaks that were $m$ issing
in the sem iclassical spectra $\left.{ }^{[51} \overline{5}_{1}^{\prime}\right]$. Several de ciencies rem ained, how ever, unresolved: unitarity of the sem iclassicals m atrix is, typically, violated; the w eak localization peak is signi cantly underestim ated, and the sem iclassicalpathlength (') spectrum [15],
fails to account for all the peaks and overestim ates the corresponding quantum pathlength spectrum for large '. For the special case of a rectangular billiard we could recently dem onstrate [1] ] that a system atic inclusion of pseudo-paths w ithin the pseudo-path sem iclassical approxim ation (PSCA) has the potential to overcom e these de ciencies. In the follow ing we derive the PSCA for an arbitrary convex billiard from a sem iclassical D yson equation and investigate its properties num erically.
III. DYSON EQUATION FOR THE PSCA

Starting point is a sem iclassical version of the D yson equation for the $G$ reen's function where the standard sem iclassical $G$ reen's function $G^{\text {SC }}$ plays the role of the unperturbed $G$ reen's function and the di ractive scatterings at the lead openings (or point contacts) are the perturbation. A ccordingly, we have

includes di ractive scatterings into the G ${ }^{\text {P SC }}$ to all orders.
$T$ he key to them ultiple di ractive scattering expansion is that $w$ ithin the sem iclassicalexpansion each pro jection operator onto the $L$ and $R$ point contacts selects classical trajectories em anating from or ending up at the leads and at the sam e tim e spaw ns new generations of classical tra jectories.
$N$ oting that G ${ }^{\text {P S C }}$ willonly be evaluated in the dom ain of $P_{L}$ or $P_{R}$, Eq. (3-3) can be reorganized in term $s$ of a $2 \times 2 \mathrm{~m}$ atrix D yson equation. W e decom pose $\mathrm{G}^{\mathrm{SC}}$ as follow s

In Eq. $(3-\overline{4})$ the index ij refers to paths that em anate from the point contact $j(j=L ; R)$ and end up at point contact $i(i=L ; R)$. Each of the four disjunct subsets of classicalpaths is, in general, in nite. In the follow ing we denote the truncated num ber of trajectories of the corresponding class by $N_{i j}$. Each $G_{i j}^{S C}$ containing a large nite num ber $\mathrm{N}_{\mathrm{ij}}$ or an in nite num ber of tra jectories is diagram atically represented by a double line, each contribution ofan individualtra jectory by a single line (Fig.2). $T$ he trajectories em anate or end on vertices representing the $L$ or $R$ point contacts.

Its solution $G^{\text {PSC }}$ denoted by solid lines can now be diagram atically represented ( $F$ ig. 3) as a sum over all
pseudo-paths that result from the couplings of classicalpath $G$ reen's functions by successive di ractive scatterings at point contacts. Only pseudopath combinations (or diagram s) contribute that are connected at vertices L or R.

Equation (3-5) can be form ally solved by $m$ atrix inversion,

resulting in a sum over (up to) in nitely long pseudo paths $w$ th (up to) an in nite num ber of di ractive scatterings. $N$ ote that the num ber of classical paths betw een tw o di ractive \kinks" and their lengths $m$ ay reach innity as well. T he handling of this double lim it plays an im portant role in the num erical im plem entation as destructive interference of pseudo-paths and classicalpaths of com parable length $m$ ust be properly taken into account. The evaluation of Eq. (3.⿹1. ) and (3. (1) is not straight-forw ard as each operator product in Eq. (3, 3)
contains a m ulti-dim ensional integral over $R^{2}$. N ote that classical paths contributing to $\mathrm{G}^{\mathrm{SC}}$ do not incorporate the nite width of the point contact since we take the lim it d! 0 in the simulation of classical paths. Instead they are specularly re ected at the open lead mouth $R$ as if there were a hard wall. Such a path will interfere with the pseudo-path that has al$m$ ost the sam e length and topology but experiences a non-specular, i.e. di ractive re ection at the sam e point contact.

A llhigher-order corrections are evaluated analogously. Each additional vertex connecting tw $\circ \mathrm{G}_{\mathrm{Sc}}$ gives rise to an additionalFraunhofer integralw th an interior re ection amplitude $r\left({ }^{0}\right.$; ).

## IV. M ATRIX REPRESENTATION OF PSEUDOPATH SUM

A num erical representation of the Dyson equation $\mathbb{E} q \mathrm{~s}$. $(3,5,1,1,0)]$ requires the truncation of the num ber of contributing paths in each of the fourbasic $G$ reen's functions Eq. $[3.4)$ ] to large but nite numbers. Let $\mathrm{N}_{\mathrm{LL}}$ denote the num ber of paths leading from $x_{\mathrm{L}}^{0}$ back to $\Re_{\mathrm{L}}^{0}$. A ccordingly, $\mathrm{N}_{\mathrm{RR}}$ is the number of paths of the class $(R!R), N_{R L}$ the number for ( $L!R$ ) and $N_{L R}$ the

A speci cm atrix elem ent ( ${ }^{0}$; ) consists of a sum of all path-com binations that contain the classicalpath as rst segm ent and the classical paths ${ }^{0}$ as last segm ent.

Forbilliards of arbitrary shape and positions of the leads, no further reductions are possible. Only for structures $w$ ith discrete geom etric sym $m$ etries ( $L$ \$ $R$ ) or tim ereversal sym $m$ etry, the num ber of non-equivalent tra jectories and thus of independent am plitudes $r\left(;^{0} ; k\right)$ is reduced.

W ith Eq. $(4 . \overline{9})$ the sem iclassical calculation of the S m atrix of a hard-w alled quantum billiard w th two point contacts is reduced to a sequence of $m$ atrix $m$ ultiplications. System -speci c input are the data (length, angle of incidence and em ission from point contact and $M$ aslov index) of each of the four classes ( $L$ ! $L ; L!R ; R$ ! L; R ! V. NUMERICALRESULTS

In the follow ing we w ill apply the pseudo-path sem iclassicalapproxim ation to the calculation oftransm ission and re ection am plitudes in di erent regular and chaotic structures (i.e. circle, rectangle and stadium ). We com pare the PSCA calculations $w$ ith the results of the standard sem iclassicalapproxim ation [ioll, exact quantum calculations [ 3 ild and $m$ icrow ave experim ents [3d].

In order to evaluate the scattering $m$ atrix elem ents $T_{m}{ }^{0} m$ and $R_{m}{ }^{0}, m$ num erically we have used the truncated form of Eq. (4. 4 d ) w ith $i \quad K$, where $K$ is the m axim um num ber of di ractive scatterings (or $\backslash \mathrm{kinks}$ "). $W$ e therefore relate $K$ to the $m$ axim um path-length 'max ofclassicalpaths included. In order to include allpseudopaths w ith at least the sam e length, we require that the length of the shortest trajectory in the system m in mul
tiplied by $K+1$ has to be larger than m ax to guarantee that allpseudo-paths up to ${ }_{\mathrm{m}} \mathrm{ax}$ are included. H ence we require

where the bracket stands for the largest integer less than the argum ent. This requirem ent only assure that each classical path is shadowed by a pseudo-path of com parable length. The converse is evidently not the case. P seudo-paths are perm ilted with path-length up to m ax $(\mathrm{K}+1)$ for which no classical counterpart of com parable length is included. W e account for this de ciency by Fourier ltering the power spectra $P$ ( $($ ) of the $S$ m atrix elem ents for ${ }^{\prime}>{ }^{\prime} \mathrm{m}$ ax. . The classical input data are determ ined analytically for the square and circle billiards while for the chaotic stadium billiards the data are generated by calculating the classical trajectories num erically.

## A $\quad$ egular structures

For regular structures classical and pseudo-paths can be easily enum erated and calculations up to very high path length ( $\quad=40$ ) have been perform ed as a sensitive test of sem iclassical approxim ations. W e present in the follow ing results for the path-length pow er spectrum Eq. [2.9)]. $F$ igs. 4 and 5 show the power spectra of the transm ission and re ection am plitudes for the second $m$ ode, $\mathrm{T}_{22}$ and $\mathrm{R}_{22}$, in the circular billiard $w$ ith penpendicular leads. $N$ ote that all the scattering geom etries which we investigate in the follow ing have the sam e cavity area $\mathrm{A}=4+$, or, accordingly, a linear dim ension $D=\frac{1+}{4+} \quad 2: 7$.

H ere wem ainly concentrate on the im provem ent of the PSCA in com parison to the SCA. For $T_{22}$, the overesti$m$ ation of long paths ( $'>$ 18) in the SCA calculation is clearly visible: com pare the peaks labeled by black arrow s in F ig. 4a w ith those in Fig . 4b. The contributions of the additionalpseudo-paths included in the P SCA are responsible for the cancellation e ects w hich suppress the peak heights. The peak heights of the P SCA agree well w ith the quantum calculations for long paths. A lso the lack of individualpeaks (ie. pseudo-paths) present in the quantum spectrum but $m$ issing in the SCA spectra (e.g. at , $27: 5$; see white arrow $s$ in $F$ ig. 4) can be addressed in the transm ission am plitude.

This defect of the SCA can be seen m ore clearly in the plot for $R_{22}$ (see arrows in the upper part of F ig. 5). T he pseudo-path sem iclassics provides for the additional peaks in agreem ent w ith the quantum calculation. T he insets in the low er part of F ig. 5 show schem atically the geom etry of dom inant pseudo-paths, which experience at least one di ractive re ection at an open lead. The num ber next to the insets gives the inform ation on how often the segm ent of a classical path has to be traversed to build up the corresponding pseudo-path.

Up to now we have compared the SCA and PSCA for open billiards w ith regular classical dynam ics. We tum now to chaotic (ie. non-regular) billiards. The
 system for structures w ith chaotic classical dynam ics. Before we discuss our num erical results, we point out some of the characteristic di erences betw een the regular and chaotic structures. In the stadium billiard the number of path bundles [8/1] up to a xed length increases exponentially. The exponential proliferation represents a $m$ a jor challenge for the sum $m$ ation of paths. $T$ his leads to technical problem s for the calculation of transport quantities in chaotic structures [3]-1 due to the lim itation of the num ber of paths that realistically can be taken into account. Furtherm ore, the path length distribution in chaotic structures di ens qualitatively from that of regular structures. For the latter we nd an algebraic decay for the classical path-length distribution

in contrast to the exponential decay for classically chaotic structures. T his is to be distinguished from the exponential decay behavior for pseudo-paths. W irtz et al. [13] have shown that for the rectangular billiard the SCA leads to a linear (algebraic) decay of the path length power spectra, while the PSCA gives rise to an exponential decay when pseudo-paths are included. H ow ever, in chaotic system s, already classical paths proliferate exponentially as a function of the path length and can account for exponential suppression of large path length. T herefore, the lack of pseudo-paths which also proliferate exponentially is less dram atically felt than in regular system $s$ where the exponential proliferation of pseudo-paths com petes $w$ th only linear proliferation of classical paths. This observation is key to the surprising ndings in previous sem iclassical calculations that the agreem ent between the sem iclassical and the quantum pathlength spectrum is better for chaotic rather than for regular system $s$ [ chaotic system $s$, the e ects of di ractive pseudo-paths can be clearly seen. Fig. 6 show s the pow er spectra of transm ission am plitudes for the stadium $w$ th perpendicular leads. For $\mathrm{T}_{11}$, rem arkably, the path-length spectra w th in PSCA displays fewer pronounced peaks than the SCA in agreem ent w th the quantum calculation. The reason is that in a chaotic system the high density of pseudo-paths e ectively causes path shadow ing of true classical paths. A s a result, som e of the classical peaks are drastically reduced by destructive interference even for com paratively short path length.

C Com parison w ith $m$ icrow ave experim ents A sa third application we discuss the com parison betw een experim ental studies of geom etry-speci c quantum scat-
tering in $m$ icrow ave billiards $\left[{ }_{3}{ }^{3} \mathbf{g}_{1}^{\prime}\right]$ and sem iclassical approxim ations (SCA and PSCA). The physics and modeling of $m$ icrow ave cavities are conceptually sim ilar to that of sem iconductor quantum dots due to the equivalence of the tim e-independent Schrodinger and H elm holtz equations [32]. M oreover, for m icrow ave frequencies
$<\mathrm{max}=\mathrm{C}=2 \mathrm{~h}[32 \mathrm{Z}]$, where h is the height of the m icrow ave billiard, only a single transverse $m$ ode is supported by the cavity. This reduces the electrom agnetic boundary conditions to D irichlet-boundary conditions allow ing for an exact correspondence betw een electrodynam ics and quantum $m$ echanics. A ccordingly, the com ponent of the electrical eld perpendicular to the plane of the $m$ icrow ave billiard corresponds to the quantum $m$ echanicalw ave function.

A direct $m$ easurem ent of transm ission and re ection am plitudes (i.e. electrical eld am plitudes) becom es possible. M oreover the sem iclassical analysis presented above is directly applicable to describe scattering in m icrow ave billiards. The geom etry of the $m$ icrow ave resonator used in the experim ent [30] is show $n$ as inset in F ig. 7. The transm ission and re ection am plitude were taken in the frequency range 13 GHz 18 G H z, where only one $m$ ode is propagating in the waveguides. Figs. 7 and 8 show the experim entaland calculated data for the power spectra of the transm ission and re ection am plitude, $\mathrm{f}_{11}$ ( $)$ 予 and $\mathfrak{F}_{11}$ ( $)$ 予. The im portant role of pseudo-paths in reproducing the correct peak pattem in good agreem ent w ith experim ental results can be seen in both the transm ission and the re ection spectra. Especially in $\mathrm{f}_{11}(`)$ distinct pseudo-paths (see insets in Fig 8b) appear which were noted in Ref. 3 am ple, the peak at , 9 (white arrow in Fig. 8a) is caused by the trajectory w ith the length , $4: 5 \mathrm{which}$, after one revolution in the billiard, is re ected back at the exit by the lead $m$ outh, so that it continues for one $m$ ore revolution. T hus its total length ' $24: 5=9$. O fcourse, such non-classicaltra jectories are not included in the standard sem iclassical approxim ation ( F ig 8a). In this special case, the re ection at the open lead $m$ outh is specular or geom etric. T his peak w ould therefore also be present in the sem iclassical approxim ation suggested by Schw ieters et al. [5] ${ }^{1}$ ]. By contrast, non-geom etric re ections ( $\backslash$ kinks") by di ractive scattering are also present, e.g. the peak at $l=7: 5$ (see inset in $F$ ig. 8b). The latter class is only contained in the P SCA.

## VI. CONCLUSIONS

W e have presented an extension of the pseudo-path sem iclassical approxim ation (PSCA) [1] ] to billiards $w$ th arbitrary convex shape. A diagram $m$ atic expansion of the sem iclassical Dyson equation for the G reen's function in term $s$ of di ractive scattering diagram $s$ is developed. T he unperturbed $G$ reen's function represents the sum over classical paths. Each encounter w ith the lead (point contact) spaw ns new tra jectories. By joining

disjunct classicalpaths due to non-geom etric (di ractive) scattering a large num ber of trajectories representing pseudo-paths results. T he D yson integral equation can be converted to an algebraic $m$ atrix equation which can be solved by power series expansion or inversion. U sing the exam ples of a circular and a stadium billiard we have shown num erically that the path-length power spectra calculated by the P SC A overcom e shortcom ings
ofstandard sem iclassicalapproxim ations by inchuding an exponentially proliferating num ber of pseudo-paths and converges tow ards quantum transport. M oreover, we have presented a com parison betw een $m$ icrow ave billiard experim ents [3]], the SCA and the PSCA calculation and nd evidence for contributions by pseudo-paths of PSCA to be present in the experim ental data. We expect that our pseudo-path sem iclassicalapproxim ation will be able to address unresolved issues of sem iclassical ballistic transport such as the problem of weak localization $\left.\left[14 \overline{4}^{\prime},{ }^{13}\right]_{4}^{\prime}\right]$, the breakdow $n$ of sym $m$ etry of the autocorrelation function in re ection and transm ission, and the sem iclassical description of quantum shot noise.

The integrals along the transverse coordinate ( $y$ ) across the opening of the point contact are evaluated in Fraunhofer di raction approxim ation. The dependence of the action in zero $m$ agnetic eld, $k L$ ( y ), on the transverse coordinate $y$ is taken into account to rst order Taylor series expansion,

The validity of the FDA hinges on the condition that the third term in Eq. (A 1) is negligible. T his term is of the order $(k d)(d=L) . k d \frac{d}{D}$ for short paths. Since in quantum billiards the asym ptotic far- eld regim e is never reached, the FDA, som ew hat counterintuitively, will fail for large kd . Indeed, in $F$ ig. 9a we show a test of unitarity $\mathrm{U}(\mathrm{k})=\mathrm{R}(\mathrm{k})+\mathrm{T}(\mathrm{k})$ on di erent levels of sem iclassical approxim ations to the rectangular billiard (inset of Fig. 9a) where the breakdown of the FDA and consequently of the PSCA for high modes m ( $m>10$ ) (or $\mathrm{kd} \& 30$ ) can clearly be seen. To highlight the failure of the approxim ation used in Eq. (A 1) or ( (3.12) we plotted in $F$ igs. 9b and 9c (solid lines) the discrepancy between the exact solution of the integral I [HS of Eq. ( $(\overline{3} . \overline{12})]$ and the corresponding Fraunhofer approxim ation. For $\mathrm{L}_{1}=\mathrm{L}_{2}=\mathrm{L}$ and $\mathrm{I}_{1}=\mathrm{L}_{2}=0$ as a function of k. Fig. 9b show s the di erence in the absolute values jㄱj 代 ${ }^{D A}$ jand $F$ ig. 9 c the absolute discrepancy in the argum ents jarg (I) $\quad \arg \left(\mathbb{E}^{D A}\right)$ j. Since the phase discrepancy reaches a fraction of unity form \& 16 (see Fig. 9c) random phases in the scattering am plitudes destroy path shadow ing by pseudo-paths and therefore cause the violation of unitarity ( F ig. 9a). T he failure of the FDA has $m$ ore dram atic consequences for the P SCA than for the SCA. This is due to the fact that in PSCA the pseudopath coupling leads to an exponentially grow ing num ber
of FDAs w ith an increasing num ber of di ractive scatterings, in contrast to the linear scaling of the num ber of FDA s involved w thin SCA. The point to be stressed is that this failure is not due to the PSCA but due to the additionalFDA. Applying $m$ ore accurate di raction integrals in this regim e is expected to rem edy the problem.
