We exam ine the nature of the collective excitations in a strongly anisotropic system of bosons interacting via Coulomb interaction. Such a system has often been used in the past to model the e ects of quantum and classical phase uctuations on the super uid density of underdoped cuprates. Depending on the anisotropy and the e ective strength of the interaction we nd four di erent regimes for the temperature dependence of the super uid density. Coulomb interaction in underdoped cuprates is argued to be e ectively short-ranged, and less then unity in appropriately de ned units.

Tem perature dependence of the super uid density (T) is one of the key properties of a super uid. This is particularly true in high-tem perature superconductors, where the linear low-tem perature behaviour of (T) at optim all doping served as early evidence for the d-wave symmetry of the superconducting order parameter [1]. A nother intriguing aspect of (T) is its evolution with underdoping, the elect of which may be expected to increase the importance of uctuations. Indeed, it has been argued that for a low value of (0) as is observed in the underdoped regime the further reduction of (T) with tem perature should be primarily due to classical phase

uctuations [2], [3]. This argument has been criticized for its neglect of C oulom b interaction, which is expected to strongly suppress classical phase uctuations below the plasm on energy and thus reinstate quasiparticles as the source of the linear temperature dependence of (T) at low T [4]. The competition between the quasiparticles and phase uctuations for the form of (T) becomes quite explicit in the so-called Io e-Larkin rule [5]

where $_{\rm qp}$ (T) is the standard BCS quasiparticle contribution in a d-wave state, and $_{\rm fluct}$ (T) is the (model-dependent) uctuation component. This transparent result was rst derived within the context of e ective gauge theories of the t-J model [6], but it may be expected to apply more generally to strongly uctuating quasi-two-dimensional superconductors with (0) $_{\rm qp}$ (0) [7].

C uprates, how ever, are strongly an isotropic m aterials, with the anisotropy between the transport properties in the ab-plane and the c-axis increasing with underdoping. It is well known that under these conditions the plasm on dispersion becom es very an isotropic as well, and the large plasm on energy gap gets replaced by a much lower one proportional to the interlayer coupling [8], [9]. One m ay therefore expect C oulom b interaction in such highly anisotropic superconductors to become less e cient in gapping the phase mode. In this paper we study in greater detail the combined e ect of large an isotropy and Coulomb interactions on (T). We model the uctuation component in Eq.1 by a layered system of bosons interacting via Coulom b interactions and with the density proportional to doping. Such an e ective theory arises naturally in several theories of underdoped cuprates [6],




FIG.1: Four regimes for the tem perature dependence of the super uid density (T) in a layered bosonic system with weak Coulom b interactions: I) quasi-two-dimensional (2D) regime with weak and e ectively short-range (screened) interaction 1=, II) quasi-2D regime with weak long-range for K (0)=t interaction for 1 K (0)=t 1= , III) three-dimensional (3D) regime with weak long-range interaction for 1, and IV) 3D regime with strong long-range inter-K (0)=t ³. K (0) = h^2 (0)=m, and t is the interaction for K (0)=tlayer Josephson coupling. = $(2 e^2 = (d)) = (h^2 = (m d^2))$ 1 is the dim ensionless strength of the C oulom b interaction, and d is the inter-layer separation.

[7], [10], [11], and provides a rather general representation of a charged layered super uid. We begin with the simple case of a two-layer system and dem onstrate that, when the layers are Josephson-decoupled, there exists a linearly dispersing phase mode at low wavevectors. This is essentially a consequence of the perfect screening of interactions in one layer by uctuations in the other. Generalizing to a system with an in nite number of layers, for a weak Coulomb interaction we nd that there are four discernible regimes for the tem perature dependence of the super uid density, controlled by the ratio between the boson density and the Josephson coupling (Fig. 1). An estim ate of the relevant param eters places the underdoped $YBa_2Cu_3O_{6+x}$ (YBCO) with $T_c > 5K$ m ly in the regime I, where the Coulomb interaction acts as an e ective short-range interaction; the long-range nature of the Coulomb interaction in this regime is irrelevant except at extrem ely low tem peratures. W e also nd that the value of the dimensionless interaction strength in YBCO is < 1, and argue that it is possible that 1.

Let us de ne the quantum mechanical action for a layered system of interacting bosons as S = $_0^0 d d^2 x L$ with

where N is the number of two-dimensional (2D) layers, t is a weak Josephson coupling between the layers, = 1=T, and we set $k_B = h = 1$ throughout, unless otherwise noted. The C oulom b interaction is

d being the separation between the layers and the static background dielectric constant. We assume the presence of a neutralizing background of density $_0$ equal to the average areal density of bosons at the chem ical potential

The nature of the excitations in the above super uid system is most explicit in a system of only two layers, which di ers already from a single layer in an important way. Let us introduce pret the usual density-phase variables [12] as $_{i}(x;) = \frac{1}{0} + \frac{1}{i}(x;)e^{i_{i}(x;)}$ and expand the Lagrangian to the quadratic order in $_{i}$ and $_{i}$,

We assumed here the usual periodic boundary conditions in imaginary time: $_{i}(\mathbf{x};) = _{i}(\mathbf{x};0)$ and $_{i}(\mathbf{x};) = _{i}(\mathbf{x};0) + 2 n_{i}(\mathbf{x})$, with $n_{i}(\mathbf{x})$ integer. By rotating the elds as $= (1 \ 2) = 2$, $= (1 \ 2) = 2$, we can decouple the above Lagrangian as $L = L_{+} + L_{-}$, with




FIG.2: The two branches! of the excitation spectrum of the two-layer system, with t = 0 and weak C oulomb interaction. The lowest mode crosses over from linear behaviour at low k to k^2 behaviour. The plasm on starts out as k before crossing to k^2 .

The branch ! describes the usual two-dimensional plasm on, !+ $4 e^2 k = m$ at low momenta. The two layers oscillate in phase and, as a consequence, !+ is independent of the Josephson coupling. The canonically conjugate variable to + is the sum of two densities, and therefore the Coulomb interaction a ects the energy of this mode, as is usual in system s with long-range interactions. In contrast, the conjugate variable to is the di erence between the two densities which can oscillate without any cost in Coulomb energy. As a result, for $(2 \quad 0 e^2 d = m)^{1=2} k$ at low momenta, and the t = 0, !dispersion of the low erbranch is the same as if the system had only a short-range interaction of strength $2 e^{2} d = .$ W ith t = 0 the layers cannot exchange particles and the density in each layer therefore m ay oscillate so as to perfectly screen the Coulomb interaction in the other. The oscillations, however, are then out of phase, and consequently when t \neq 0 this mode becomes gapped, with ! $2 \pm 0 e^2 d = at low m om enta. W e w ill refer here$ after to this energy as the Josephson gap.

The remarkable feature of the above result is that in a system with negligible Josephson interaction between the layers, the Coulomb interaction becomes e ectively short-ranged as far as the low-energy excitation spectrum is concerned. More precisely, when t = 0, ! is linear and deviates from $!_+$ signi cantly for k 1=d. For a large separation between the layers and for 1=d $(8 \text{ m}_{0} \text{ e}^{2} \text{ e})^{1=3}$, ! k !+ k. Finally, for $(8 \text{ m}_{0} \text{ e}^{2} \text{ = })^{1=3} \text{ k, !}$!+ $k^2 = 2m$. If, on the other hand, the interaction is weak or if the layers are $(8 \text{ m}_{0} \text{ e}^{2} =)^{1=3}$, brought close together so that 1=d $8 \text{ m} \text{ }_{0}\text{e}^{2}\text{d}\text{=}$, and ! k²=2m otherk for k ! wise, without the interm ediate region ! k. In this

regime! becomes identical to the phonon spectrum of the weakly interacting Bose gas. This is illustrated in Fig. 2. W ith a nite Josephson coupling ! approaches the Josephson gap for k $\frac{1}{4m}$ t. If the Josephson coupling were strong, of course, ! !, and the plasm on would resume its place as the low-energy mode of the system .

In a system with N layers, for t = 0 there are N 1 m odes with linear dispersion and only a single plasm on. This is easily established by considering the interaction m atrix $V_{ij}(k)$. W hen k ! 0, $V_{ij}(k) = (2 e^2 = k)(1 + 0 (kd))$. So in the lim it k ! 0,

and the interaction m atrix has one eigenvector with the eigenvalue 2 N e² = k, and N 1 degenerate eigenvectors with zero eigenvalue. The form er eigenvector is the total density which is canonically conjugate to the sum of the phases and describes the plasm on. The latter N 1 m odes, being orthogonal to the plasm on, are electrically neutral and consequently cross from linear dispersion at low m om enta to the Josephson gap at k = 0.

The existence of linearly dispersing modes below the usual plasmon modi es the behavior of the super uid density at low temperatures. To be speci c, we focus on the system with in nitely many layers which is relevant in the context of high-temperature superconductivity. Im - posing periodic boundary conditions in the direction orthogonal to the layers the excitation spectrum becomes

For $k_z = 0$ one nds the usual three-dimensional plasm on at $!^2(0;0) = !_p^2 = 4 e^2_0 = dm$, while when $k_z \notin 0$ and t = 0, for k = 1 = d, $!(k;k_z) = !_pk = k_z$. The latter modes become gapped when $t \notin 0$ and $!(k ! 0;k_z \notin 0) = !_p t = k_z$.

The tem perature dependence of the areal in-plane super uid density in Landau's two- uid model is given by

where n_b (!) is the usual boson occupation number [14]. We will not it convenient to express the super uid density in units of energy by de ning K (T) = \mathring{h} (T)=m; we have also restored the dimensionful Planck constant. The rescaled super uid density K (T) may then be expressed entirely in terms of dimensionless quantities as

where f(y;z) = y + (t=f) sin² (z=2); X = X = T_d are dimensionless, with $T_d = h^2 = (m \ d^2)$ as the characteristic energy scale in the problem. The parameter = 2 e²=(dT_d) is the dimensionless measure of the C oulom b interaction's strength.

Equation 13 or 14, expected to be valid for 1 and not too close to the critical temperature, leads to four distinct regimes of temperature dependence of the super uid density. Take t=K (0) 1, as is relevant to the cuprates, and consider the function K (T) as K (0) is decreased at xed t. We will assume this to crudely correspond to underdoping a high-temperature superconductor, as we discuss shortly.

 I) For K (0)=t 1, the system is quasi-2D. A ssum ing 1, to the zeroth order in the super uid density in Eq. 13 is easily seen to equal the B ose condensate in the layered non-interacting system [7], and

overm ost of the tem perature range. The deviations from Eq. 15 are most signi cant below the crossover tem perature $T_1 = K(0)$, where $K(T) = K(0) - K(T) - T^3$, and within the critical region of width T_c around T_c with $T_c - 2 - K(0) = \ln (2 - K(0)) = t$. Besides T_1 , there exists also a low er crossover tem perature T_1^0 of the order of the Josephson gap, where K(T) becomes exponentially suppressed. The latter tem perature is

The three characteristic tem perature scales for variations of K (T) will therefore satisfy the inequalities

For such an interval for to exist we obviously need t=K(0) 2 = ln (2 K (0)=t), which is comfortably satised for K (0)=t > 1. When the inequality (18) is satisfied the long-range nature of the C oulomb interaction is relevant only at very low temperatures and the interaction

appears in (T) as being e ectively short-ranged, and weak. Furtherm ore, as the ratio K (0)=t is reduced the relative tem perature range over which K (T) behaves as a power law, $T_1=T_c$, decreases as well, albeit logarithmically slow ly. One m ay interpret this decrease as that the interaction is being slow ly renorm alized tow ands zero with the reduction of the boson density [15]. The regime in which the inequalities (18) hold is marked as I in Fig. 1.

II) If K (0) is decreased further so that K (0)=t 1=, one nds T_1^0 T_1 $T_{\rm c}$. The low-tem perature behavior of the super uid density corresponds to the long-range interaction. This regime could be named the 2D, weakly interacting, long-range regime, and is labeled II in Fig. 1.

III) For K (0)=t 1, K (T) to the zeroth order in , has the form of the fully three-dimensional Bose condensate over m ost of the tem perature range, and

Note that $T_2=T_c$ now decreases as a power of K (0), which is again equivalent to the infrared renorm alization group

ow of the short-range coupling constant in a weakly interacting system of 3D bosons [7]. However, since $T_2^0 > T_2$ for K (0)=t < 1=, and 1= 1, by the time the system enters the 3D regime where K (0)=t 1 the tem - perature dependence of K (T) crosses over directly from exponential at low tem peratures to $T^{3=2}$ at higher tem - peratures. This is then the 3D, still weakly-interacting, long-range regime, labeled III in Fig. 1.

 $\rm IV$) Eventually, by reducing the density further one enters the regim ewhere the Josephson gap becomes comparable to $\rm T_c$. From Eq. 21 this occurs when

This is the strongly-interacting regime (labeled IV in Fig. 1) in which the super uid density varies exponentially over the scale of T_c . In this regime the system may be expected to eventually su or the phase transition into a W igner crystal.

To determ ine the relevant regime for cuprates one needs an estim ate of the dimensionless coupling constant . We nd that $2 e^2 = d$ 2500K assuming 30 [16] and d = 12A in YBCO. The estimate of the temperature




FIG.3: The scaled [23] super uid density K (T)=K (0) as a function of $T=T_{\rm c}$ for various values of the dimensionless interaction , and the data on underdoped YBCO [22].

scale $T_{\rm d}$ requires som e assumptions on the relation between the super uid density of the bosons and the measured super uid density. For a nite interaction

where the right-hand side is the undepleted super uid density of the non-interacting system. In the elective gauge theories of the t-Jm odel [6], or of the uctuating d-wave superconductor [7], density of bosons at low doping equals the density of holes, and thus $_0 = x=a^2$, with a the lattice constant in the ab-plane. So

Since $(a=d)^2$ 0:1 in YBCO it is convenient to take the doping x = 0:1 as the reference point, so that $T_d > K$ (0) at this particular doping. Furtherm ore, the total super uid density is related to the super uid density of the bosons via the Io e-Larkin rule in Eq. 1, written m ore precisely as

where the Z = K (0)=K _{qp} (0). M easurem ents of the super uid density and therm al conductivity lead to an estimate Z 0.8 at x 0.1 [18], and therefore

assuming conservatively that = 1. Estimating T_c 65K at x = 0:1 in YBCO, the interpolation of known results on the penetration depth yields $1 = {}^{2}(0) \quad 50 = m^{2}$ [19], which expressed in K elvins [20] leads to K tot (0) 400K. This leads to the estimate

A similar value of the lower bound is obtained by repeating the exercise at optim aldoping. The value of the dimensionless coupling in YBCO is then

There are at least two reasons to suspect that the value of the interaction parameter may lie signi cantly below our estimated upper bound in the last equation. First, for 1 K (0) would be well below the non-interacting value of h^2_{-0} =m, which would in turn yield a lower value of . Second, our estimate is evidently very sensitive to the value of Z in Eq. 28; assuming < 1, for example, would bring Z closer to unity and signi cantly increase the energy scale T_d , and thus decrease the value of . So the Eq. 30 should be understood as a very com fortable upper bound, with most likely laying well below it.

The Josephson coupling tm ay be related to the superuid density along the c-axis $K^{\,\rm c}\left(0\right)$ as

A ssum ing that the measured super uid density in very underdoped cuprates is dom inated by the bosonic com – ponent, the above ratio is 10^{-4} , and appears to become doping independent at low dopings [21]. So, we estimate

in the underdoped regime.

As the critical tem perature changes from $T_c = 92K$ at optim aldoping to $T_c = 9K$ in the extrem ely underdoped regime in YBCO, the ab-plane super uid density changes by roughly two orders of magnitude [22]. A sum ing a constant Josephson coupling in this range leads to the left-hand inequality in Eq. 19, t=K (0), being com – fortably satis ed by our estimates, and the C oulom b interaction may be safely considered to be e ectively short-ranged. A llow ing the Josephson coupling to also decrease with underdoping, which may be closer to reality, only strengthens the above conclusion. The right-hand inequality, however, would not be quite satis ed for 1.

As we argued, how ever, this is only an upper bound, and may in fact be signi cantly smaller. To see the e ect of the coupling strength on the form of the super uid density, we plot in Fig. 3 K (T)=K (0) from Eq. 14 for various values of [23], together with the experimental points [22] on YBCO with 9K T_{c} 22K. The best t is achieved for $= 10^{-3}$, although it is clear that any value < 0:1 would be almost equally good. This supports the recent proposal [7] by one of us that the super uid density in very underdoped cuprates is essentially the Bose condensate of the non-interacting layered bosonic system . The reader should also remember that whereas Eq. 14 yields the correct tem perature dependence at low tem peratures, it does not include the critical uctuations within the critical region of width T_c near T_c. These are known to modify the super uid density into K (T) (T_c T)^{xy}, with _{xy} 0:67, [24], and thus contribute to an additional rounding of the curve K (T) from its non-interacting form. The absence of any such discernible critical region in the data in Fig. 3 additionally supports our suggestion that in YBCO may be rather sm all.

Tf 1, the system crosses from a 2D, short-range 1, to a 3D long-range regime, for regime, for K (0)=t 1, and the regimes II, III, and IV from Fig. K (0)=t 1, well separated for weak coupling, now overlap signi cantly. The regime I, however, even in this case remains wide and distinct. In fact, it is well known that in ⁴He, which is a strongly interacting Bose liquid, the variation of the super uid density with temperature is well described by Landau's two- uid model, except in the critical region. It thus seem s likely that Eq. 14 would rem ain qualitatively correct overm ost of the tem perature region even if the bosonic system is not quite weakly interacting, as long as it is reasonably far from solidi cation.

In conclusion, we discussed the nature of the collective m odes in a strongly anisotropic bosonic super uid with C oulom b interaction between bosons. In particular, the in uence of the anisotropic dispersion of these m odes on the temperature dependence of the super uid density was analyzed. D epending on relative values of the anisotropy and the interaction four di erent regimes can be discerned for a weak interaction. A crude estimate of relevant parameters for cuprates show s that the C oulom b interaction in underdoped YBCO m ay be considered to e ectively be short-ranged and at least m arginally weak, and the system to be quasi-two-dimensional.
