Spin-charge separation in cold Ferm i-gases: a real tim e analysis

U sing the adaptive tim e-dependent density-m atrix renorm alization group m ethod for the 1D H ubbard m odel, the splitting of local perturbations into separate wave packets carrying charge and spin is observed in real-time. We show the robustness of this separation beyond the low-energy Luttinger liquid theory by studying the time-evolution of single particle excitations and density wave packets. A striking signature of spin-charge separation is found in 1D cold Ferm i gases in a harm onic trap at the boundary between liquid and M ott-insulating phases. We give quantitative estimates for an experimental observation of spin-charge separation in an array of atom ic wires.

One-dimensional (1D) quantum many-body systems have been at the center of theoretical and experim ental interest for the last two decades. Following the sem inalwork of Haldane [1], it has been understood that independent of their bosonic or ferm ionic nature - the low-energy behaviour of 1D quantum liquids is universally described by the so-called Luttinger liquid (LL) picture [2, 3]. Probably the most remarkable prediction is the phenom enon of spin-charge separation in the case of Ferm ions, i.e. the fact that -at low energy -the excitations of charge and spin completely decouple and propagate with dierent velocities. A de nite signature of spin-charge separation requires the observation of the two corresponding branches of excitations in the single particle spectral function [18]. In condensed matter systems, num erous experim ents have looked for spin-charge separation e.g. via photoem ission from 1D metallic wires on surfaces [4], in 1D organic wires [5], in carbon-nanotubes [6], and in quantum wires in sem iconductors, where the singular nature of the spectral functions associated with spin-charge-separation was observed in tunneling experim ents [7]. In the last few years, ultracold gases in optical lattices are providing an entirely new area of physics where strong correlations can be studied with unprecedented control and tunability of the param eters. In particular these systems open the possibility to investigate the transition between three, quasi-two and quasi-one dimension. Recently, an 'atom ic quantum wire' con guration in an array of thousands of parallel atom waveguides was realized in ultracold Ferm i gases by the application of a strong two dim ensional optical lattice [8]. The possibility to use cold atoms for studying the phenomenon of spin-charge separation was rst suggested by Recati et al. [9]. Their analysis is essentially based on the hydrodynam ic Ham iltonian of the LL; the inhom ogeneity due to the presence of a harm onic trap is treated within a local density approximation (see also [10]). In practice, with typically less than 100 atoms per atomic wire [8], observable e ects require to use stronger and more localized perturbations, where a LL description is not applicable. In addition, the e ect of boundaries, where the local density approximation breaks down, are of crucial importance. For a quantitative description of spincharge separation in 1D cold Ferm i gases, it is thus necessary to use a microscopic description like the Hubbard m odel and properly treat the inhom ogeneous case with realistic system sizes. Due to the short range nature of the interactions between cold atom s, the Hubbard model is indeed a perfect description of a situation, in which there is an additional optical lattice along the weakly con ned axial direction (for bosons, the corresponding setup has already been realized, see [11, 12]). It is an essential new feature of cold atoms in optical lattices that param eters can be changed dynam ically and the resulting tim e evolution can be studied. This gives direct access to the real-time dynamics of strongly correlated systems, a subject hardly studied so far. In this context, a successful m ethod is the recently developed adaptive tim edependent density matrix renormalization group (adaptive t-DMRG) [13] which is an e cient implementation of Vidal's TEBD algorithm [14] in the DMRG fram ework [15]. It has previously been applied to study density perturbations in bosonic 1D condensates over a large range of interaction strengths [16]. The real-time dynamics of interacting spinful Ferm ionic systems is much harder and has not been studied except for very small systems [17]. In our present work, we present num erical results of the real-time dynamics of a 1D Hubbard model for realistic sizes of up to 128 sites. Our main results are:

(i) real-time calculation showing spin-charge separation explicitly in systems of experimentally accessible size

(ii) the demonstration that spin-charge separation survives far outside the low-energy LL regime

(iii) a quantitative calculation for the e ect of spin-charge separation at the boundary between a liquid and a M ottinsulating (M I) phase which allows to observe the phenom enon in cold gases without the problems arising from the dierent densities in an array of parallel atom ic wires and to distinguish experimentally between a Mott- and a band insulator.

Our starting point is the standard Hubbard model

for Ferm ions in 1D. Its param eters are the hopping matrix element J, the on-site repulsion U > 0 between Ferm ions of opposite spin = "; # at sites j = 1;:::;L and a spin-dependent local on-site energy $"_{\rm j};$, describing both a possible smooth harm onic con nement and timedependent local potentials. One introduces a 'charge' density $n_c = n_* + n_*$ and a 'spin' density $n_s = n_*$ n_* ; in a realization with cold gases, the spin degrees of freedom are represented by two dierent hyper ne levels, and 'charge' density is particle density. Sim ilar to bosons in an optical lattice [19], the ratio u = U=J can easily be changed experim entally by varying the depth Vo of the optical lattice. We use units where both J and h are equal to one; thus time is measured in units of h=J. In the numerical calculations below, we study the dynamics of the Hubbard model using dierent initial density perturbations and the excitations resulting from adding a single particle at a given lattice site, which is expected to display the same physics as contained in single particle spectral functions Experim entally, the density perturbations may be generated by a blue-or red-detuned laser beam tightly focused perpendicular to an array of atom ic wires, which generates locally repulsive or attractive potentials for the atom s in the wires. In practice, the perturbations due to an external laser eld are quite strong, typically of the order of the recoil energy E $_{\rm r}$ and thus clearly require a nonperturbative treatm ent. In our calculations the length of the chains was chosen up to L = 128 sites, keeping of the order of several hundred DMRG states. DMRG error analysis reveals that all density distributions shown here are exact for all practical purposes, with controlled errors of less than 0 (10 $^{-3}$) [20].

We start with a homogeneous system which is perturbed by a potential $"_{j;"}$ localized at the chain center which couples only to the "-Ferm ions, i.e.




FIG. 1: Snapshots of the evolution of the density distribution are shown at di erent times. At t=0.2, a wave packet is present in the center of the system in both the spin and the charge density. Each of these splits up into two packets which move with the same velocity in opposite directions. The velocity of the charge wave and the spin wave are dierent.

The potential is assumed to have been switched on slow by enough for equilibration, and is then switched o suddenly at time t=0. In Fig. 1 (a) the density distribution of the state at t=0.2 is shown. The external potential (2) generates a dominant perturbation in the "Ferm ion distribution by direct coupling and, indirectly, a smaller perturbation in the #-density due to the repulsive interaction between the dierent spin species. The wave packets in " and #-density hence perform a complicated time evolution (Fig. 1). In contrast, the perturbations in the spin and charge density split into two wave packets each moving outwards. Their respective velocities are dierent as indicated by the arrows in Fig. 1 (b), separating spin and charge.

In the limit of an in nitesimal perturbation much broader than the average interparticle spacing, both spin




FIG. 2: Exact results for the charge velocity obtained by the Bethe ansatz are (lines) compared to the numerical results of the adaptive t-DMRG. The numerical results correspond to dierent heights of the perturbations at various charge background densities n_0 . $n_{\rm c}$ is the charge density at the maximum/minimum of the charge density perturbation. The uncertainties are of the order of the size of the symbols and stemmainly from the determination of the velocity.

and charge velocities are known analytically from the Bethe ansatz [21]. To compare our numerical ndings to the exact charge velocity, we create pure charge density perturbations, by applying the potential of Eq. (2) to both species, i.e. "j;" = "j;#, and calculate their timeevolution after switching o the potential. The charge velocity is determined from the propagation of the maxim um (m in im um) of the charge density perturbation for bright (am plitude $_{c} > 0$) and grey ($_{c} < 0$) perturbations, respectively. In Fig. 2 the charge velocities for various background densities no and perturbation amplitudes c are shown. We nd good agreem ent, if we plot the charge velocity versus the charge density at the maxim um (m in im um), i.e. $n_c = n_0 + c$. This stays true even for strong perturbations c 0:1 which corresponds to 20% of the charge density. The charge velocity is thus robust against separate changes of the background density n_0 and the height of the perturbation c. By contrast, the velocity of a spin perturbation varies strongly with its height. A possible reason for this may be the nonlinear cos -contribution in the LL description of the spin density eld, which is only marginally irrelevant, giving rise to a nonanalytic contribution to the spin-density response [3]. Nevertheless, our num erical results show that for decreasing height of the spin perturbation, its velocity approaches the value for the spin velocity obtained by the Bethe ansatz.

In order to compare the behaviour of the density perturbations with that of a single particle excitation, the time evolution of the system with one additional particle




FIG. 3: Snapshot of the time-evolution of the charge and spin densities of a single particle excitation created at time t=0 at site j=37 is shown for t=72.

added at time t=0 on site j to the ground state, is calculated numerically. In Fig. 3 a snapshot of the resulting evolution of the densities is shown for time t=72. Remarkably, as in the case of the density perturbation separate wave packets in spin and charge can be seen. This demonstrates the phenomenon of spin-charge separation directly in a single particle excitation, in close analogy to the situation of an inverse photo-emission experiment for the single particle spectral functions [4]

In a speci c experiment with arrays of parallel atom ic wires, it is necessary to take into account that there is an additional harm onic trapping potential. Moreover, individual wires have slightly dierent llings, which leads to an inhom ogeneous broadening due to the resulting dierence in velocities. In order to observe an unambiguous signal of spin-charge separation in such a situation, we suggest an experimental setup, which relies on the coexistence of a MI state and a liquid state in spatially separated regions of the parabolically conned system [22]. The idea is to use the very dierent behaviour of the charge and spin degrees of freedom in the MI phase.




FIG. 4: Tim e-evolution of charge and spin density perturbations in the presence of a parabolic trapping potential " $_{jj} = V_t a^2$ (j L=2+0.5) 2E_r . M I m arks the approxim ate M I region in the absence of the perturbation. The line denoted by idealized is a sketch of the charge density distribution without the perturbation. The presence of the perturbation enlarges the region in which the charge density is locked to $n_c = 1$. The arrows show the approximate place of the spin perturbation, and the shaded region marks the region over which the densities are averaged (cf. Fig. 5).




FIG. 5: Time evolution of the charge and spin density sum med over the sites $j_0=25$ to $j_1=35$. Vertical lines correspond to the times of the snapshots in Fig. 4

In this phase the charge excitation spectrum has a gap, whereas the spin dispersion is still linear for small momenta, and the spin velocity is nite. By contrast, in the liquid phase both excitation spectra are linear for small momenta. To exploit this, assume the system of one-dimensional wires is prepared in such a way, that a M I region is present in the center, where the charge density is locked at half-lling, $n_c=1$. At the boundary of this M I region liquid regions appear. A localized potential in

the liquid region will then create spin and charge density waves. Calculated snapshots of the time evolution in such a situation are shown in Fig. 4. Evidently, the spin density wave propagates into the M I region whereas the charge density perturbation is almost completely reected due to the charge gap in the M I. The presence of spin density oscillations which are due to the antiferrom agnetic coupling induced by the interaction obscures the exact evolution of the spin perturbation. However by averaging over several lattice sites - as is always necessary in an experiment—the e ect of spin-charge separation is clearly visible. In Fig. 5 exam ples for the evolution of the sum of the charge and the spin number of particles between site 25 and 35, N $_{\rm c}$ and N $_{\rm s}$ respectively, are show n . It is clearly seen that the sum of the charge occupation does not change, whereas the spin occupation shows the moving wave packet. The average spin velocity can be determined from Fig. 5 if the distance between the localized potential which generates the perturbation and the center of the region over which the density is measured is known. Here, the spin velocity is found to be v_s 1:1J=h which agrees nicely within the expected accuracy with the value of v_s ($n_c = 1$) = 12J=h of the Bethe ansatz. The very di erent propagation behaviour of charge and spin can as well be used experim entally to distinguish between a M I and a band insulator: In a band insulator not only the velocity of the charge, but as well of the spin would vanish, whereas, as used above, in the M I the spin velocity stays nite.

In order to quantify the requirem ents for an experim ental observation of spin-charge separation in cold Ferm i gases, we nally discuss typical parameters which need to be achieved in a setup with an array of atom ic wires [8]. Such an array consists of several thousand parallel wires with typically less than 100^{40} K atoms each. In addition to the smooth axial con nement potential with frequency !z $"_F = N$ 2 275Hz (corresponding to 0:0035), realization of a 1D Hubbard model requires adding a strong periodic potential along the tubes. For 40 K and a standard lattice constant a = 413nm the recoil energy is E_r 7kHz. An optical lattice of height $V_0 = 15E_r$ then gives an on-site repulsion U where we have used a standard value for the s-wave scattering length as $174a_0$ for the F = 9=2 m_f = and m $_{\rm f}$ = 7=2 states [23]. The resulting dimensionless interaction u 22 then leads to a central M I region with a typical size of around 20 sites. With this param eters, the time in which the spin wave travels 20 sites is of the order of a few ms. The creation of state selective potentials for two di erent hyper ne states m ay be done by using laser light whose frequency falls between the respective transitions. This might be dicult for the F = $9=2 \text{ m}_f = 9=2 \text{ and m}_f =$ 7=2 levels, but should be possible – for instance–using the F = 9=2 and F = 7=2 levels. The $1=e^2$ -radius of the potential (Eq. 2) is taken to be four lattice sites, which could be realized

approxim ately by a laser of an $1\text{=}e^2$ -radius of 2:1 m or less. Finally, to ensure that nite tem perature does not destroy the M ott insulating behaviour by them al activation, the energy scale k_B T should be smaller than the M ott energy gap. A lready the very rst experiment of 1D ferm ions in an optical lattice is very close to m atching those conditions. Im provem ents can be reached reducing the axial con nem ent frequency.

To conclude we have perform ed num erical simulations of the time-evolution of charge and spin density perturbations in the 1D Hubbard model. We clearly observe the separation of spin and charge as a generic feature of 1D ferm ions, far beyond the low-energy regime where a Luttinger liquid description applies. In addition, an experiment is suggested which exhibits the separation of the two modes from the perfect rejection of density excitations at the boundary to a Mott insulating state
