Exact therm odynam ic lim it of short-range correlation functions of the antiferrom agnetic X X Z -chain at nite tem peratures

Abstract

W e evaluate num erically certain multiple integrals representing nearest and next-nearest neighbor correlation functions of the spin-1/2 X X Z H eisenberg in nite chain at nite tem peratures.

1. IN TRODUCTION

The determ ination of correlation functions is an important task both from a theoretical and from an experimental point of view. In scattering experiments correlation functions are measured, and detailed insight into the microscopic structure of the sample can be obtained. Scattering experiments may thus well decide about the adequateness of a given (simplied) theoretical model, once its correlations functions are calculated. On the other hand, taken for granted that a theoretical model adequately describes a certain sample, the knowledge of its correlation functions is useful to estimate the quality of the experimental setup. The principal problems on the theoretical side are threefold: To deal with many-body interactions between the particles, to account for nite temperatures and to carry out the therm odynamic limit of a macroscopic sample size. With regard to these intricate di culties, techniques which allow for the exact calculation of correlation functions of at least some typical interacting quantum systems in the therm odynam ic limit are highly welcom e.

P rogress into this direction has recently been achieved by one of the authors in collaboration with A.K lum per and A.Seel (GKS) [1, 2, 3]. In these works, the one-dimensional spin-1/2 X X Z Heisenberg chain with periodic boundary conditions in a magnetic eld,

was considered. Form ulae for the correlation functions were derived by combining the quantum – transferm atrix (QTM) approach [4, 5, 6, 7] to the therm odynam ics of integrable systems with certain results for matrix elements of the X X Z -chain [8, 9] which proved to be useful before [10, 11] at T = 0. In the QTM approach, the free energy of the system is expressed in terms of an auxiliary function de ned in the complex plane [7]. This auxiliary function is determined uniquely as a solution of a non-linear integral equation. GKS found that essentially the same auxiliary function can be used to calculate m -point correlation functions for arbitrary temperatures T, again in the therm odynam ic limit. As a result, all the correlation functions of spatial range m are given in terms of m -fold integrals over combinations of the auxiliary function variables.

In this work, the integral equations are solved num erically for all tem peratures at h = 0 and

them ultiple integrals are calculated form = 2;3, where we restrict ourselves to 1 form = 3. In particular, we focus on $hS_{j}^{x}S_{j+m-1}^{x}i_{T}$ and on the emptiness form ation probability P (m). In order to estimate the quality of our data we compare them with other exact results: nst of all the nearest-neighbor correlators can be obtained independently of the multiple integral representation by taking the derivative of the free energy with respect to . Furthermore, very recently [12] a high temperature expansion of the emptiness form ation probability P (3) at = 1 has been performed up to the order (J=T)⁴², starting from the multiple integral representation. At T = 0, closed expressions are available [13, 14, 15, 16, 17, 18] as well. There are, moreover, the X X -limit (! 0) and the Ising limit (J ! 0; ! 1; J xed) where the correlation functions are known over the whole range of temperatures [19, 20, 21]. A ll these independent results provide useful tests for the accuracy of our num erics. The main error we observe is due to the discretization of the integrals, an error which, in principle, can be m ade arbitrarily small by increasing the num erical accuracy.

Besides the expected crossover behaviour from low to high tem peratures, we nd a surprising feature in $hS_j^xS_{j+m-1}^x$ if r > 1: the antiferrom agnetic correlation is maximal at an interm ediate tem perature T_0 , and not, as naively expected, at T = 0. We explain this behaviour from a competition between quantum and therm odynamical uctuations.

This paper is organized as follows: in the next section we give some details about the num erical procedure. Results are presented separately in the third section. The article ends with a summary and an outbok.

2. NUMERICAL PROCEDURE

Let $A_{1::m}$ be an operator which acts on sites 1; :::; m of the spin chain. In order to calculate $hA_{1::m}$ i_T , the operator $A_{1::m}$ is expanded in terms of the elementary matrices e,

In [3] the following multiple integral representation for the density matrix was has been obtained [35]:

Here $\binom{n}{n=1}^{m}$ and $\binom{n}{n=1}^{m}$ denote sequences of up-and down-spins, where 1 " and 2 #. The position of the jth up-spin (down-spin) in the sequence $\binom{n}{n=1}^{m}$ $\binom{n}{n=1}^{m}$ is $\binom{n}{j}$ $\binom{j}{j}$ and the number of up- (down-) spins in the corresponding sequences is de ned as $j^{+}j(j^{-})$. The contour C in (2) is given in [1]; it depends on the value of $=:\cosh$. The parameter m ay be purely real and positive (massive case, > 1), or imaginary with =:i, =2 0 (massless case, 0 1). The auxiliary functions a; a; G which occur in the integrand in (2) are solutions of the follow ing integral equations:

with = 1=T. Note that the T - and h-dependence of the correlation functions enters through the auxiliary functions, whereas the m-dependence is encoded in the m-fold integral. Thus the evaluation of (2) requires two steps: solving equations (3), (4) and then calculating the multiple integrals. In this work, the following correlation functions will be calculated num erically at




FIG.1: Integration contours a) in the massive b) in the massless case.

The function P (m) = $he_{11}^{1} ::: e_{m1}^{1} i_{T}$ is referred to as the emptiness form ation probability.

For the num erical treatm ent, it is convenient to reform ulate equations (3), (4) such that the integrations are done along straight lines parallel to the real or in aginary axes. This procedure is due to K lum per (cf. the book [22] and references therein). We review the main steps here in order to introduce a notation which will prove to be convenient for our purposes.

The integration contour C is chosen according to g. 1a) (1b)) in the massive (massless) case. In the massive (massless) regime, Re C = =2 (Im C = =2), where is a small positive quantity; the limit ! 0 is included in plicitly. A coording to eqs. (3), (4) the functions ln a, G are given in the part of the com plex plane enclosed by C, once they have been calculated on C. How ever, for the calculation of correlators, (2), these functions are only needed on C. Since in the massive case, all functions are periodic with period i, integrals along C_{1/2} in opposite directions cancel each other. We thus have to calculate the auxiliary functions along two straight lines C parallel to the imaginary (real) axis in the massive (massless) case.

Let us set focus on the calculation of the auxiliary functions in the massless case, the massive case is treated analogously afterwards. Subsequently, we comment on the calculation of the multiple integrals with the help of the auxiliary functions.

2.1. M assless case

We rst concentrate on 0 < = 2 and deal with the isotropic case = 0 at the end of this section. It is convenient to de ne

The integrations in (7) are now convolutions along the real axis, such that one can express $\ln b$ in term s of $\ln B$, $\ln \overline{B}$ by solving an algebraic equation in Fourier space and transform ing back to direct space. The result is

Note that the shift by in (9a) is necessary to ensure integrability. In a similar fashion, eq. (4) is treated. Therefore we introduce the functions

Using the substitution rules (12), (13), the general density matrix element (2) is expressed in terms of $G_b = (1 + b^{-1})$, $G_{\overline{b}} = (1 + \overline{b}^{-1})$, G_b , $G_{\overline{b}}$. This expression is rather lengthy: For an m-point-function, one obtains a sum of 3^m -m any terms, each one an m-fold integral. Here we would like to spare the reader the general expression, but rather make the following comments:

Eqs. (9), (14a) are solved numerically by iteration; the convolutions are done by applying the Fast-Fourier-Transform algorithm. Errors then arise from the truncation and the discretization of the integrals. In (2) derivatives of $G_{b\bar{p}}$ with respect to enter. These can be calculated straightforwardly by taking the n-th derivative of (14) with respect to which results in linear integral equations for $e^n G_{b\bar{p}}$.

The formulation in term softhe functions $G_{b,\overline{b}}$ is particularly suited for low tem peratures. At $T = h = 0, 1 = (1 + b^{-1}) = 1 = (1 + \overline{b}^{-1}) = 0$ such that $G_b = G_{\overline{b}}$ is given by the inhom ogeneity in (14a). Furthermore, only one of the 3^m -m any term s in (2) remains (namely the one containing only combinations of G_b ; $G_{\overline{b}}$). Then in this term all functions are known. This is the well-known result of Jim bo et al. [24] which has rst been obtained for > 1 in [23] (for a proof in the critical case and an extension to $h \in 0$ see also [10]).

The functions for the isotropic case = 0 are obtained by rescaling x ! x, $G_{b,\overline{b}}$! $G_{b,\overline{b}}$. Then in (2) algebraic functions occur instead of hyperbolic ones, and the integration kernel takes the form

2.2. M assive case

Let us go through the changes which have to be done in the massive case with respect to the massless case. Analogously to (5a), (5b), we de ne the functions

2.3. Calculating the integrals

Let us consider eq. (2), where the substitutions in plied by (12), (13) have been perform ed. One observes that due to the product of hyperbolic functions in the denom inator in eq. (2), multiple poles may occur. We explain in the following how to treat these poles numerically and show that contributions due to these poles cancel each other if there is more than one pole. For de niteness we treat the massless case, however, the arguments are directly transferable to the massive case.

The last term s in eqs. (24), (25) are additional term s caused by the pole.

Now consider the case of multiple poles. Set $!_j = x_j + i = 2$ in the product $Q_{1 a < b m} \sinh(!_a !_b i)$ and all other $!_k = x_k i = 2$. Then if j = m 1, there is one simple pole. If j < m 1, the product $\sinh(x_j x_{m-1} i) \sinh(x_j x_m i)$ occurs in the denom inator. It is not directly to show that the additional contributions due to these two poles either vanish directly or cancel each other. One should be aware of the fact that the -function in (24) yields no contribution if f_{reg} . This is the case for T = 0, where all functions are real and the determ inant in (2) vanishes if any two arguments of the auxiliary functions are equal.

W e now address the question of possible simplications of the multiple integral representation (2). Obviously, in the case m = 2 the double integration has to be equal to one single integration, since the nearest-neighbor correlators are obtained by taking the derivative of the free energy per lattice site f with respect to the anisotropy , and the free energy is given by a single integral according to [7]. Especially

The correlator $hS_j^z S_{j+1}^z i_{T=0}$ as a function of is plotted in g.3 of ref. [27]. This result has been extended to all temperatures in the range 1 1 in [28], g.2. Note from (27a)-(27c) that the sign of the T²-coe cient is positive, so that the antiferrom agnetic correlations rst decrease with increasing temperature. In the massive case, for nite , the leading temperature-dependent order may be obtained by a saddle-point integration, very similar to [29]. Then

At rst sight, the last inequality is surprising: The antiferrom agnetic correlations of $S_j^x S_{j+1}^{x} i_T$ increase with increasing temperature. Since $\lim_{T \le 1} h S_j^x S_{j+1}^x i_T = 0$, we expect a minimum at nite temperature. This will be con rm ed in the next section. Intuitively, this result can be understood as follows: At T = 0, the Ising-like anisotropy leads to a Neel-like ground state, which enhances the alignment of the spins along the z-direction. An initial increase of the temperature reduces $hS_j^z S_{j+1}^z i_T$, so that quantum uctuations of the spins are favored, and $hS_j^x S_{j+1}^x i_T$ increases. At high enough temperatures the spins become uncorrelated, so that both correlation functions decay to zero.

As far as the low-tem perature behavior of correlation functions in the massive regime is concerned, we would like to note that using the saddle-point integration technique, one nds that

for arbitrary m , with some coe cient C $_{\rm m}$.

Up to now, we were not able to derive eqs. (26a), (26b) from (2). Still, the latter equations provide a useful test for the accuracy of our num erical integration scheme for m = 2, as

explained in more detail in the following section. For m > 2, simplications of (2) have not been performed yet for any nite temperatures except at = 0 and ! 1, see below. However, for T = 0, where the integrand is known explicitly, the multiple integrals have been simplied considerably in the isotropic regime [14, 17, 18]. In the anisotropic regime, the multiple integrals have been reduced to single integrals form 4 [15, 16]. These works allow us to estimate the numerical accuracy at T = 0. In the other extreme, at T = 1, the spins are uncorrelated so that in this limiting case we also have explicit results which can be checked. Note, however, that it is rather non-trivial to reproduce these high-temperature results from the general formula (2). This was done only very recently by T suboi and Shiroishi in [12], where a high-temperature expansion of P (m) has been performed to high order in 1=T for the isotropic case. This is one further result which will serve as a reference point for estimating the accuracy of our numerics for m = 3.

The cases = 0 (free ferm ions) and ! 1 such that J = :c nite (Ising limit) allow for substantial simplications. Details will be explained in a separate publication [31], here we only give the results. For = 0, that is = =2, the convolutions in (9a), (14a) disappear, so that all functions are known explicitly for all temperatures. Then

in agreem ent with [20]. In the other extrem e, the Ising lim it, the driving term and integration kernels become constant (d(x) ! 1, (x) ! 1=(2)) such that the auxiliary functions do not depend on x and the integrations are trivial. One nds [21, 30, 31]

3. RESULTS

We ist present results of the next-neighbor correlation functions, comparing data from the double integration with those from the single integration. Results for next-nearest neighbors will be given subsequently. Correlation functions for longer distances can be evaluated in the sam e way, how ever, the num erical cost increases exponentially with the num ber of integrations. That is why for the time being in this feasibility study we do not go beyond m = 3.

3.1. Nearest neighbors

Figs. 2, 3 show P (2), $hS_j^xS_{j+1}^xi_T$, as calculated from the double integral, for P (2) together with the relative error with respect to the data obtained from the derivative of the free energy according to (26a), (26b). The single integration results can be considered as exact; the numerical error is less than 8 digits for all temperatures. We checked that the relative error for $hS_j^xS_{j+1}^xi_T$ vanishes at low temperatures as for P (2); at high temperatures, the absolute error is about 10⁴.

In both cases, the error increases with increasing temperature, reaching maximal values at J near the isotropic point. Generally, the error is considerably larger at high than at low temperatures. This is due to two reasons:

At nite temperature, the auxiliary functions are given numerically from the solutions of the integral equations, whereas at T = 0, they are known explicitly. The numerical iteration scheme necessarily induces errors due to the truncation and discretization of the integrals.

The additional contribution from poles in eq. (24) increases with increasing temperature and causes an additional error in the integrations.

We have veried that the error is reduced by decreasing the distance between two successive integration points. We conclude that the errors are mainly due to the truncation and discretization of the integrals and can be made arbitrarily small at the expense of increasing computation time.

Considering the low-temperature behavior of $hS_j^xS_{j+1}^xi_T$, one nds an initial decrease from T = 0 with a minimum at T_0 , this is illustrated in g.6. We commented on this phenomenon




FIG.2: a) Emptiness form ation probability P (2) for nearest neighbors; the upper curve corresponds to the X X lim it = i =2. The inset shows the T^2 -coe cient at low temperatures in the massless case. Straight lines indicate the exact values according to eqs. (27a), (27c). b) R elative error of P (2). The curve labeled by \setminus = 5 Ising" shows the relative di erence between the = 5-values of a) and the Ising lim it eq. (28).




FIG. 3: Correlation function $hS_{j}^{x}S_{j+1}^{x}$ i for nearest neighbors; the lower curve corresponds to = i0.8 = 2. The inset shows the T²-coe cient at low temperatures in the massless case. Straight lines indicate the exact values according to eq. (27b).

in the previous section. From g. 6 one observes that in the Ising limit, the maximum of $hS_j^xS_{j+1}^x i_T = hS_j^xS_{j+1}^x i_{T=0}$ is located at $T_0 = (J)$ 0:168.

3.2. Next-Nearest neighbors

We calculated next-nearest neighbor correlation functions for the isotropic and the massive case. In the massless case, the auxiliary functions in (2) are multiplied by a kernel which, depending on the integration variables, can increase exponentially, so that the auxiliary functions have to be determined extremely accurately over the whole integration range. This problem is still controllable for nearest neighbors, but becomes severe for m > 2. In the isotropic case, how ever, one deals with algebraic functions, which are much better to handle num erically. At

anisotropy parameter > 1 the integration range is nite, so that those problem s do not occur.

In g.4 we show the emptiness form ation probability P (3). In the isotropic case, we compare our data with the high-temperature expansion of [12] and with Q uantum M onte C arb (QMC) data which were obtained in [12]. The relative error of our data shown in g.4 is larger than in g.2, which is due to the fact that the data in (4) were calculated by using only half of the number of integration points compared to the m = 2 case. We checked at single temperature values that the error is of the sam e order as in the m = 2 case when the calculations are done with the sam e numerical accuracy. However, the computational costs would be unreasonably high. At lowest temperatures, a comparison with [14, 15, 16] yields relative errors of the order $2 \ 10^4$.

As a second example, $hS_j^xS_{j+2}^xi_T$ is depicted in g. 5. At lowest temperatures we again compare our data with the explicit results of [15, 16] which yields a relative error of 7 10³. At highest temperatures, $hS_j^xS_{j+2}^xi_T = 0$. The absolute error here is of the order 10⁻³. As in the m = 2-case we observe an increase of the antiferrom agnetic correlation with increasing T, reaching a maximum at some nite temperature T_0 in the massive regime. Fig. 6 illustrates this behaviour, where $hS_j^xS_{j-m+1}^xi_T=hS_j^xS_{j-m+1}^xi_{T=0}$ is depicted for m = 2;3 and > 1.

4. SUM MARY AND OUTLOOK

We demonstrated that an accurate numerical evaluation of the formula (2) is possible by considering the special cases m = 2 with = 0 and m = 3 with = 1. The numerical error was estimated precisely by comparing with alternative approaches. We have found that this error is only due to the discretization and, for = i, the truncation of the integrals. For m = 3 in the massless case we encountered problem s hard to deal with numerically. Also the computational costs of an extension of the numerics to m > 3 become very high if one wants to maintain the accuracy. Thus, the next step should be to address the question of in how far the multiple integrals can be simplified. Here we would like to mention two approaches.

In [12] an high-temperature expansion (HTE) has been applied to calculate P(m). The excellent agreem ent of these data with those obtained by num erically evaluating the multiple integrals directly (cf. g. 4), even at temperatures below the crossover region highlights the




FIG.4: a) Emptiness form ation probability P (3) for next-nearest neighbors. Shown are results from the 3-fold integral, from QMC [12] and high-temperature expansion (HTE) combined with Pade approximation [12]. b) Relative error of the data from the 3-fold integral with respect to the QMC and the HTE-data.




FIG. 5: The correlation function $hS_j^xS_{j+2}^xi_T$ for = 0;1. Note that at low temperatures for > 1, the correlation increases, before it starts to decrease to zero.

applicability of the HTE m ethod. On the other hand, in the works [14, 15, 16, 32] the multiple integrals have been reduced to single integrals at T = 0. The case m = 2 shows that sim plications are possible also at nite T (compare also [2]), where the integrand in (2) is given in plicitly by integral equations. Further progress m ay be expected from extending the recent results [32, 33] for the inhom ogeneous generalizations of the correlation functions of the X X Z chain to nite T. This issue is the subject of current research.




FIG.6: The correlation function $hS_j^xS_{j+m}^x _{1}i_T$ divided by its zero-tem perature value $hS_j^xS_{j+m}^x _{1}i_{T=0}$ for m = 2; 3 in the massive regime > 1. The dotted horizontal line gives the T = 0-value 1. The tem perature is normalized with respect to J.
