A eld theory of frictionless grain packings in two dimensions is shown to exhibit a zero-tem perature critical point at a non-zero value of the packing fraction. The zero-tem perature constraint of force-balance plays a crucial role in determ ining the nature of the transition. Two order parameters, < z >, the deviation of the average number of contacts from the isostatic value and, < >, the average magnitude of the force per contact, characterize the transition from the jam med (high packing fraction) to the unjammed (low packing fraction state). The critical point has a mixed character with the order parameters showing a jump discontinuity but with uctuations of the contact force diverging. At the critical point, the distribution of shows the characteristic plateau observed in static granular piles. The theory makes falsi able predictions about the spatial uctuations of the contact forces. Im plications for nite tem perature dynam ics and generalizations

to frictional packings and higher dim ensions are discussed.

Introduction In a remarkably diverse range of systems, the transition from a owing, liquid state to a 'am m ed, solid state is heralded by a dram atic slowing down of relaxations[1]. Does an equilibrium critical point underlie this glassy dynam ics? The debate surrounding this question has been spurred by the absence of any obvious static signature accompanying the rapid increase of time scales [1]. Purely dynamical scenarios have been proposed [2] to explain tim e-scale divergences with no accom panying static divergences. For therm al system s, a di erent perspective has been o ered within the fram ework of an avoided critical point  $[\beta]$  and a scaling theory based on the existence of a zero-tem perature critical point[4]. In a more recent developm ent, it has been suggested that the mechanism of jamming in both thermal and athem alsystem s is controlled by a zero-tem perature critical point (J-point) [5].

Experiments on weakly sheared granular media indicate that at a critical packing fraction there is a transition accompanied by slow dynamics, vanishing of mean stress, increasing stress uctuations and a change in the distribution of contact forces[6, 7]. Simulations indicate a criticalpoint occurring at zero temperature and a packing fraction close to the random close packing value[5]. At this criticalpoint the grain packing is isostatic, having reached the special coordination where all contact forces are completely determined by the packing geometry [1]. A theory based on this observation predicts a diverging length scale associated with the mechanical stability of the network [8]. In a di erent theoretical approach, an analogy has been drawn between the jamming transition and k-core percolation [9].

In the present work, it is shown that a statistical eld theory of two-dimensional, zero-temperature, frictionless grain packings exhibits a critical point. This point separates a disordered phase from an \ordered" one characterized by two order parameters: (i) the magnitude of the force per contact, < >, and (ii) < z>, the deviation of the contact number per grain from its isostatic value. At the critical point, the uctuations around < > diverge but those around < z> go to zero. An analytic prediction for P (F), the distribution of contact forces, is in excellent agreement with experiments[6], and the theory makes falsi able predictions regarding the spatial correlations of the forces.

Statistical Ensemble In granular matter, which is athermal, a natural control parameter is the packing fraction [1]. For short-range repulsive potentials, the corresponding statistical ensemble is one with a xed average pressure [10]. The probability P [fr<sub>i</sub>g] of a grain packing with the set of positions fr<sub>i</sub>g can be obtained by using the maximum entropy principle [11], which also forms the basis of the Edwards ensemble of granular packings [12]. Maximizing the entropy, S  $\mathbb{P}$ ] =

where  $p(fr_ig) = (1=V)^{P}_{ij}r_{ij}\frac{\theta U}{\theta r}j_{ij}$  is the pressure of the con guration frg(U is the interaction potential). The \canonical" partition function, Z() =  $\int_{r_i}^{0} P[fr_ig]$  is the generating function of all statistical averages. The Lagrange multiplier plays the role of inverse tem perature: =  $\theta S = \theta$  and the prime on the sum mation restricts it to grain con gurations satisfying the equations of mechanical equilibrium for friction less packings in d dimensions:

Here  $\langle z \rangle$  is the average number of contacts per grain, F<sub>ij</sub> is the magnitude of the contact force between grains




FIG. 1: Illustration of height eld. The dashed lines are contact forces and the heights associated with the loops are represented by the arrows encircling a loop

i and j, and f ( $r_{ij}$ ) is the function specifying the intergrain force law. At the isostatic point,  $\langle z \rangle = z_{iso} = 2d$ , the number of equations in Eq. 2 is exactly equal to the number of unknown forces,  $F_{ij}$  [14, 15] and, therefore, the forces are uniquely determined by these equations. The positions frig can then be obtained by inverting Eq. 3. For  $\langle z \rangle > z_{iso}$ , Eqs. 2 and 3 are coupled and the coupling can be parametrized by which encodes how sensitive the contact forces are to changes in the grain positions [15]:

For hard spheres, = 0, the two equations are decoupled and the only packings forwhich  $fF_{ij}g's$  and  $fr_{ij}g's$  can be determined are the isostatic ones[14]. For << 1, sm all variations in grain positions can lead to force changes comparable to the average force and Eqs. 2 and 3 are weakly coupled. An e ective way of calculating the partition function, in this limit, is to sum over all the solutions,  $fF_{ij}g$ , to Eq. 2 for a given set  $fr_{ig}$  and impose a G aussian constraint; e  $(=2)^{p_{ij}}(p_{ij} - p_{ij}^0)^2$ . Here  $p_{ij}$  is the pressure calculated from  $fr_{ij}g$  and  $p_{ij}^0$  is calculated from  $fF_{ij}g$ :

The sum over  $F_{ij}$  is constrained to only those forces which satisfy force-balance. These constraints can be incorporated through the introduction of a set of auxiliary variables, the loop forces[16]. Loop forces or heights', fh<sub>i</sub>g,[16] are vectors associated with the the voids enclosed by grains. The height vectors are related to the

the contact forces through:  $F_{ij} = h_{j^0}$   $h_{i^0}$  where  $j^0$  and i<sup>0</sup> are the voids bracketing the contact ij (cf Fig. 1). Since the F  $_{ij}$ 's around a grain sum to zero, the mapping of forces to heights is one to one, up to an arbitrary choice of a single height. For frictionless grains, the requirem ent of F ij being parallel to rij leads to restrictions on the heights. In developing the eld theory, the heights are coarse grained over a mesoscopic region with a length scale much larger than the grain radius but smaller than a typical length scale over which the height elds vary [16] to de ne a continuous height eld. It can be shown [17] that the constraint on the coarsegrained eld resulting from the frictionless property is that the height eld be divergence free and, in 2d, this in plies that the height eld can be written in term s of a scalar potential [16] :  $h_x = Q_y$ ;  $h_y =$ 0₄.A similar approach led to the de nition of a potential for frictional grain-packings[16]. The stress tensor, coarse grained over a m esoscopic region of area A, around the point r:  $^{0}$  (r) = (1=A)  $\bar{j}_{k} \bar{k}_{k} r_{jk} F_{jk}$ , is expressed in terms of as[16]

and the coarse grained pressure is,  $p^0(r)$  Tr<sup>^</sup> =  $r^2$  (r). The partition function can, therefore, be written in terms of the unconstrained eld

The coarse-grained eld carries with it a weight [] which counts the num ber of m icroscopic  $fF_{ij}g$  con gurations giving rise to the same eld. A rgum ents sim ilar to the ones employed in height-m aps of loop m odels[18], lead to []  $e^{(1-2)} e^{d^d r (r^2)^2}$ . The basic reasoning is that con gurations which are completely at, i.e.  $r^2 = 0$ , have the largest number of loops (dashed in Fig. 1) along which the contact forces can be shu ed without violating the force-balance constraint and, therefore, they are favored entropically.

At the isostatic point, z =  $z_{\rm iso}$ , p = r  $^2$  . For packings close to the isostatic one, an expansion in z  $z_{\rm iso}$  leads to

The second set of equations follow by noting that the extra pressure,  $-\frac{p}{z} j_{iso}$ , due to the introduction of an additional contact at the isostatic point is the pressure at this packing divided by the number of contacts. Just as the mapping from  $F_{ij}$ !, the mapping from  $r_i$  to the coarse-grained pressure, p(r), involves the calculation of a weight ! [p]. It can be argued that ! [p] exp(Kj(rp))) by picturing the packing of N grains in a volum e V. Entropically, it is favorable to have the grains occupy as much of the volum e as possible, leading to sm all spatial variations of the packing density and

p(r). Large pressure gradients occur in the entropically unfavorable packings where there are large variations in the packing density.

W ith these weights, the partition function is:

Here, = r<sup>2</sup> represents the magnitude of the force per contact (cfEq. 6), and the eld z has been rede ned to z  $z_{iso}$  which is restricted to the set of integers. The parametes , and K have been scaled to absorb resulting factors of  $z_{iso}$ .

Critical Point The Ham iltonian H re ects the com – petition between [] favoring = 0 and the " eld" favoring non zero . It provides a model for studying the response functions of grain packings with sm all but nite . We assume that the integer restriction on z can be ignored [19] as long as  $\frac{6}{5}$  0

In investigating whether or not there is a nite- phase transition involving the vanishing of one or more order parameters, the elds in the Ham iltonian in Eq. 7 are expanded around their average values;  $_{q} = \langle q \rangle + q$ ,  $z_{q} = \langle z_{q} \rangle + q$  and the ham iltonian written as  $H = H_{0}(\langle q \rangle; \langle z_{q} \rangle) + H_{1}(\langle q \rangle; \langle z_{q} \rangle; q; q)$ . The order parameters  $\langle q \rangle$  and  $\langle z_{q} \rangle$  are obtained by minimizing the elective potential,  $\langle \langle q \rangle; \langle z_{q} \rangle) = H_{0}(\langle q \rangle; \langle z_{q} \rangle)$  in  $(qd_{q} qd_{q}e^{H_{1}})$ . The sim-plest, non-trivial approximation, is obtained by calculating the uctuations,  $\langle j_{q} f \rangle$  and  $\langle j_{q} f \rangle$ , at the loop level, replacing all 4-point averages by 2-point averages [20], and assuming spatially uniform order parameters:  $\langle \langle q \rangle \rangle$ ,  $\langle z \rangle \langle z \rangle \langle z_{q} \rangle$ . Incorporating these results in the e ective potential and m inim izing with respect to the order parameters leads to:




FIG.2: The distribution P (< >) of contact forces (from bottom to top)  $_{\rm c} = 0.7, 0.5$  and 0.025. The inset shows the < z> = 0 cut of the potential, (< >;< z>) at di erent with !  $_{\rm c}$  from bottom to top.

For c, there is an ordered phase characterized by two order parameters. For < c, (< >;< z>) ceases to have any local m inim a or maxim a (cf Fig. 2) and < > jumps discontinuosly to 0: the physical limit of its allowed values. From Eqs. 8 and 10, as ! c, ! 1 and the q = 0 force uctuations diverge:  $<^2 > < >^2$  (1 c = ) <sup>1=2</sup>. This type of transition is indicative of the end of a line of metastable equilibrium similar to spinodal critical points. Unlike spinodals, how ever, the transition is accompanied by the disappearance of any local m inim um; a phenom enon observed in models with rigid constraints such as certain dimermodels[21]. The uctuations of z vanish as  $<^2 > < z >^2$  (1 c = )<sup>1=2</sup>.

The structure factor of the magnitude of the contact forces (the eld), S (qj) <  $j_q f >$ , provides detailed, measurable information about the spatial uctuations of the contact force. Eq. 8 predicts

where '  $(1 \quad 1 = \langle \rangle^2)$ '  $(1 \quad c^2 = 2)^{1=2}$  and a (;K) is a characteristic length scale of the model. The length scale vanishes at the critical point and S (q = 0) diverges as 1= . There is another length scale related to the width of the structure factor peak:  $1^{1}$  q<sub>0</sub> where q<sub>0</sub> =  $1 = \frac{a}{a}$ . The width diverges as  $(1 c^2 = 2)^{1=4}$ . The appearance of these two length scales, and the speci c form of S (q), are predictions of the theory that should be testable in experim ents and simulations. The length scales, land , are associated with correlations of contact forces and their vanishing implies that the length scale over which the grain packing behaves as an elastic solid is going to zero or, equivalently, the length scale over which the packing is oppy is diverging. The two exponents, 1=2 and 1=4, associated with the divergence of these com plan entary length scales are rem iniscent of the exponents discussed in theories and simulations of J-point [5, 8, 9].

D istribution of contact forces Experiments[6, 7] and simulations [5, 15] have shown that changes in the distribution of P (F) are associated with transitions involving the vanishing of stress. In the eld theory, < >corresponds to F and the distribution, P (< > ) ' e  $^{(<>;<\ z\ (<>))}.$  The critical regime has < z (< >> )) > ' 0 (cf Eq. 9) implying (< >) '  $(1=2) < >^2$  $z_{iso} < > + ln (< >)$ . The ln (< >) term results from integrating out the z eld and embodies the physicale ect of large contact num ber uctuations for small contact forces. This term leads to a power-law decay  $P(\langle \rangle) = 1 = \langle \rangle$  near = 0 and provides a qualitative explanation of the experim ental data [6]. Fig. 2 clearly demonstrates that the approach to  $_{\rm c}$  is accom panied by changes in the low -force regime of P (F) with a peak giving away to a plateau as the force uctuations diverge. Since diverging force uctuations im ply vanishing

of the shear m odulus  $1=(<^2><>^2)$ , the shape change is connected to the disappearance of yield stress. The theory does not yield the exponential tail of the force distribution which is not unexpected in a coarse-grained m odel since the large force behavior results from a stress redistribution at the particle level[6, 22].

Conclusions A eld theory, founded on general properties of T = 0 packings of frictionless grains in two-dimensions, exhibits a critical point separating a jammed, \ordered" phase with nite yield stress at large packing fractions ( > \_\_\_) from an unjammed phase where the order parameters vanish. A hallmark of the transition is a change in the distribution of contact forces re ecting diverging force uctuations. Two length scales, associated with the spatial uctuations of the contact forces, are predicted to go to zero at the critical point and should be detectable in experimental measurements of the structure factor of contact forces.

If the zero-tem perature critical point controls the low tem perature and weakly-driven behavior, then glassy dynam ics follows from general scaling argum ents [4, 23]. At

nite tem peratures, the force-balance constraint is violated and the height- eld has defects[18]. The interactions between these defects determ ine the stability of the zero-tem perature critical point and, therefore, it will be crucial to understand these interactions. The extension of the theory to frictional packings is within reach since the loop-force form alism exists[16]. A lthough the sim ilarities between two and three dimensions, observed in simulations, suggest that an extension to higher dimensions is possible, this remains an open question.
