P ressure-driven orbital reorientation and change in M ott-H ubbard gap in Y T iO_3

We investigate the crystal structure of Y T iO $_3$ at high pressures up to 30 G P a by synchrotron x-ray powder direction (T = 295 K). The variation of the T i(O bond lengths with pressure evidences a distinct change in the distortion of the T iO $_6$ octahedra at around 10 G P a, indicating a pressure-driven spatial reorientation of the occupied T i 3d(t_{2g}) orbitals. The pressure-induced reduction of the optical band gap of Y T iO $_3$ is determined quantitatively by m id-infrared synchrotron m icrospectroscopy and discussed in terms of bond length and orbital orientation changes.




FIG. 1: (a) Perovskite-type (G dFeO $_3$) crystal structure of Y T iO $_3$ (space group P nm a) [13]. (b) O rientation of the titanium $3d^1$ (t_{2g}) wavefunction at 0 and 13 GPa as derived in this work from the T iO $_6$ octahedral distortion. The orbitals shown refer to the T i site highlighted in (a). The octahedra in (b) illustrate the octahedral environment of the orbitals, but they do not m atch the size of the actual T iO $_6$ octahedra.

Orbital ordering, uctuation and excitation phenom ena of 3d electrons in transition metal perovskites have attracted much interest. For eq electron systems like LaM nO₃ [electron con guration $3d^4(t_{2q}^3e_q^1)$], lifting of energetic degeneracies due to lattice distortions (Jahn-Teller e ect) and concom itant spatial ordering of the occupied e_a orbitals are well known. In contrast, the t_{2a} states in systems like rare-earth titanates [con guration $3d^{1}$ (t_{2g}^{1})] have often been assum ed to be degenerate and thus in disfavor of orbital ordering. YTiO3 Fig. 1(a)] is a prototypical M ott-H ubbard insulator with ferrom agnetic ground state, where the question of t₂ orbital ordering has been studied in some detail. Static ordering was predicted theoretically [1, 2] and con m ed in nuclear magnetic resonance [3] and several other experim ents [4, 5, 6]. The mechanism and energetics of the ordering were studied in theoretical work [7, 8, 9, 10]. In contrast to these experim ental and theoretical ndings, the experim entally observed spin-wave excitation spectrum was taken as evidence for strong orbital uctuations [11, 12]. However, an alternative explanation, compatible with orbital order, has been proposed [10].

A ltogether, these recent studies raise a number of questions. How robust is orbital ordering in t_{2g} electron systems like YT \dot{D}_3 ? Which factors determ ine the orbital ordering in a particular compound? Can it be tuned by external parameters such as high pressure? How does orbital order relate to other physical properties, e.g., the electronic and magnetic excitation spectra? The orbital polarizations in the rare-earth titanates manifest them selves in small distortions of the TiD $_6$ octahedra [9]. It is therefore possible to study the orbital ordering of YT \dot{D}_3 by structural methods.

In this letter, we demonstrate that the T $\rm iO_6$ octahedra remain distorted under pressure, showing the persistence of orbital ordering. This order is, however, not an immutable property: experimental evidence is presented that the T $\rm i3d(t_{2g})$ orbitals undergo a pressure-driven reorientation. To relate the structural/orbital changes to

the electronic properties of Y T iO $_3$, we determ ine quantitatively (by m id-infrared spectroscopy) how the M ott-H ubbard gap decreases under pressure.




FIG. 2: (a) Selected x-ray di raction diagram s of Y T iO_3 for pressures up to 20 G Pa (T = 295 K, = 0.41 A). (b) R ietveld re nem ent of data recorded at 9.8 G Pa. $I_{\rm obs}$ and $I_{\rm calc}$ denote observed and calculated di raction intensities, respectively. M arkers show the calculated peak positions.

Angle-dispersive x-ray powder di raction experiments were performed at the beam line ID 09A of the European Synchrotron Radiation Facility in Grenoble. A nepowder was produced from an YTiO $_3$ crystal (Curie temperature Tc = 28 K) grown by a oating zone technique [14]. The sample was pressurized in a diamond-anvilcellusing condensed nitrogen as the pressure-transmitting medium. Two-dimensional diraction images were recorded with an image plate detector and converted to intensity-vs-2 diffractograms [Fig. 2] by numerical integration [15]. The structural parameters were determined by means of Rietveld renements [16, 17]. In contrast to the common practice, we calculated the statistical uncertainties of the diraction intensities from the intensity variations

along the individual di raction rings, pather than assum ing basic counting statistics (I / I). Using the experim entally determ ined uncertainties as weights in the Rietveld tting process turned out to be essential for an accurate determ ination of the oxygen atom ic positions. M id-infrared transmission experiments were conducted at the infrared beam line of the synchrotron ANKA in Karlsruhe. The spectra were recorded on 40 m thick Y T iO $_3$ crystals with a Bruker IFS66v/S Fourier transform spectrom eter equipped with an MCT detector and a m icroscope using m irror ob jectives. Synthetic type-IIa diam ond anvils were used in the infrared experiments. Condensed nitrogen and solid KClwere employed as pressure media. Pressures were determined in all experiments with the ruby lum inescence method [18].




FIG .3: Structural param eters of Y T iO $_3$ as a function of pressure. (a) Lattice param eters, (b) lattice param eters norm alized to their respective zero-pressure values, (c, d) x and z fractional coordinates of Y . The lattice param eter bwas scaled by $\overline{2}$ in (a) to obtain a pseudo-cubic representation .

The di raction diagram s of YTiO $_3$ (Fig. 2) and the measured lattice param eters [Fig. 3 (a,b)] change continuously with pressure. The ambient-pressure perovskite-type crystal structure of YTiO $_3$ is thus stable under compression up to at least 30 GPa. The compressibility exhibits a distinct anisotropy with the adirection being only about half as compressible as the band codirections [Fig. 3 (b)]; the orthorhombic strain increases with pressure. A Birch equation of state was ted to the pressure-volumedata up to 30 GPa to determine the bulk modulus B $_0$ = 163 (6) GPa and its pressure derivative at zero pressure B $_0$ = 8.5 (10); the zero-pressure volume was xed at the measured value of V $_0$ = 231.78 (2) A $_0$ 3. The increasing distortion is evident also from the variation of

the yttrium coordinates x and z w ith pressure shown in Fig. 3(c,d) [y = 1=4 by symmetry]. Under pressure, the yttrium ions clearly move further away from the \ideal" position (0;1=4;1) in an undistorted (cubic) perovskite. This shift levels o , however, at around 15 GPa.




FIG. 4: Ti(0 bond lengths in Y TiO $_3$ as a function of pressure (symbols). HTi(0 i denotes the average bond length (dashed line). G rey bands indicate estimated condence bands; solid lines are quides to the eye.

The variations of the Ti $\{0\ distances\ w\ ith\ pressure\ (Fig. 4)\ represent the most important structural information. At ambient pressure, the long Ti<math>\{0\ 2\ (a)\ distance\ exceeds$ the two shorter ones by 3% [Ti $\{0\ 2\ (a)\ and\ Ti\{0\ 2\ (b)\ denote\ the\ two\ distinct\ Ti<math>\{0\ 2\ distances\}$]. This type of distortion persists up to about 8 GPa. When increasing the pressure further, the initially short Ti $\{0\ 2\ (b)\ distance\ lengthens\ w\ ith\ increasing\ pressure,\ while Ti<math>\{0\ 2\ (a)\ shortens\ m\ arkedly.\ As\ a\ result,\ the\ two\ Ti<math>\{0\ 2\ bond\ lengths\ becom\ e\ (i)\ nearly\ equal\ at\ 13\ GPa\ and\ (ii)\ distinctly\ larger\ than\ the\ Ti<math>\{0\ 1\ distance\ distance\$

A s has been described in detailbefore [4, 9], the deformation of the T iO $_6$ octahedra re ects the spatial orientation of the t_{2g} wavefunction. To facilitate the discussion, we introduce a local coordinate system at each T i site with the x, y, and z axes parallel to the T i(0 2 (a), T i(0 2 (b), and T i(0 1 bonds, respectively [F ig. 1]. The relative T i(0 distances at 0 GPa (long along x; short along y and z) indicate nearly equal occupancy of the ixyi and ixzi orbitals. Thus, the eigenfunction is

0.5 kyi+ 0.5 kzi, in agreem ent with the experimental results [3, 4, 5, 6] and theoretical studies [1, 2, 7, 8, 9].

At 13 GPa, the T iO $_6$ octahedra are characterized by two equally long T i(0 2 bonds along x, y and a shorter T i(0 1 distance along z, i. e., the octahedra are compressed along z. Such a distortion indicates predom inant occupation of the jxyi orbital. In fact, the relative T i(0 bond lengths in Y T iO $_3$ above 13 GPa are very similar

to those in Sm T iO $_3$ at ambient pressure, where there is theoretical support for a predom inant occupation of the jxyi orbitals [9]. The changes in the Ti(O bond lengths observed in Y TiO $_3$ thus provide evidence of a pressure-induced reorientation of the t_{2g} orbitals from the initial \tilted state" with the approximate wavefunction 0.5 jxyi+ 0.5 jxzi to a situation where essentially only the jxyi orbital is occupied, as shown in Fig. 1 (b).




FIG. 5: (a) T i(0 {Tibond angles and (b) octahedral tilt and rotation angles in Y T iO $_3$ as a function of pressure. Lines are guides to the eye; the shades bands indicate condence bands.

It is interesting to note that the orbital reorientation does not correlate with anomalies in the average T i(0 distance Fig. 4], the lattice parameters Fig. 3(a,b)], or the T i(0 {T ibond angles Fig. 5]. In contrast, the change in the pressure-induced shift of the Y ions at $10\{15\,G\,Pa\,Fig.\,3(c,d)\}$ coincides with the T i t_{2g} orbital reorientation.

For a qualitative discussion of the origin of the orbital reorientation under pressure, we consider the results of recent theoretical investigations [9, 10]. Essentially, one has to take into account two e ects that induce a splitting of the $t_{2\alpha}$ states. Firstly, in the presence of the G dFeO 3type distortion, the crystal eld of the Y ions lifts the degeneracy of the Ti t_{2q} states. This splitting will increase if the Y {Tidistances are shortened, ie., under pressure. Secondly, a Jahn-Teller distortion due to the Ti-O interaction can modify or even dominate the energetics of the Tit_{2g} states. Due to the sti ening of the lattice, Jahn-Teller distortions will usually become less favorable under compression [19]. Application of high pressure is thus expected to tune the balance between these two contributions. In terms of relative Ti{O bond lengths, the situation in YTiO3 at 15 GPa is quite sim ilar to that in Sm T iO 3 at am bient pressure. In the latter case, there exists no Jahn-Teller distortion of the type encountered in YTiO3, and the competition between the crystal eld of the rare-earth ions and that of the O ions was reported to be rather balanced [20]. Quite likely, this scenario applies also to YTiO3 at 15 GPa.

The sim ilarity between YTiO $_3$ and SmTiO $_3$ has im-

portant implications regarding magnetism. In contrast to YTiO $_3$, Sm TiO $_3$ is an antiferrom agnet [21]. In view of the orbital reorientation and the coupling between spins and orbitals, one may speculate that YTiO $_3$ becomes antiferrom agnetic under pressure. YTiO $_3$ would then lose its unusual property of being simultaneously ferrom agnetic and insulating. More generally, application of pressure to YTiO $_3$ may cause similar changes in the electronic and magnetic properties as a substitution of Y by larger rare-earth ions.




FIG. 6: M id-infrared optical absorption in YTiO $_3$ under pressure (T = 295 K). (a) 1/Transm ittance spectra recorded at pressures of 1.6, 2.6, 3.7, 5.1, 6.7, 8.2, 9.8, 12.0, 14.1, and 16.0 GPa (with nitrogen pressure medium). The modulations of the spectra originate from interferences. (b) Pressure-induced shift of the optical absorption edge determined at 1/Transm ittance = 300 from two experimental runswith condensed nitrogen and KCl pressure medium, respectively.

We turn now to the question of the electronic excitation spectrum of Y T iO $_3$ under pressure and whether it is a ected by the orbital reorientation. Figure 6 depicts spectra of the reciprocal transmittance 1=T [which is related to the absorbance $A = log_{10} (1=T)$ for several pressures up to 16 GPa. In this representation, the optical absorption edge and its pressure-induced red shift are easily recognized. To obtain quantitative results on the red shift, we determ ine the energies where 1=T = 300 (corresponding to an optical conductivity ¹ cm ¹). The ambient-pressure optical gap thus determ ined at the onset of absorption amounts to 5300 cm $^{-1}$ (0.7 eV), a number that is naturally som ewhat smaller than the previously reported values of 6500 { 8000 cm $^{-1}$ (0.8{1.0 eV) deduced from re ectance measurem ents [22, 23]. The important information here is the shift of the absorption edge [Fig. 6(b)] rather than its absolute value. In the higher-pressure range, the optical band gap decreases essentially linearly with pressure at a rate of 145 (10) cm ¹/GPa.On the basis of a linear extrapolation of these data, the optical gap is expected to close at a pressure in the order of 40 GPa.

The mid-IR optical absorption of rare-earth titanates has been attributed to an excitation across the Mott-Hubbard gap [22, 24]. The Coulomb repulsion U is not expected to change under pressure so that the reduction in bandgap is a measure of the increase in bandwidth. The increasing electronic bandwidth under pressure is usually interpreted in terms of the Ti(O bond lengths

and the T i{0 {T i bond angles. In the present case, the changes in the bond angles, i.e. 1 up to 16 GPa, are relatively smallcom pared to related perovskites like rare-earth nickelates [25] or LaM nO $_3$ [19]. In fact, the average bond angle is essentially pressure-insensitive due to the opposite changes of T i{0 1{T i and T i{0 2{T i. Therefore, we suppose that the variation in the average T i{0 bond length d dom inates the reduction of the M ott-H ubbard gap E $_g$ under pressure. This can be quantiled in terms of a gap deform ation potential, dE $_g$ =d lnd = 11(2) eV in the region of linear change.

Figure 6 (b) evidences an unexpected nonlinear change of the optical gap with pressure: the initial slope of the absorption edge shift is only about half as large as compared to the region above 10 GPa. The increase in slope up to 10 GPa can hardly be correlated with changes in the average bond length or the bond angles. This seems to indicate that the pressure-induced band gap closure depends not only on the bond lengths and angles, as is usually assumed, but also on the orbital state of the transition metal ion. Such view ands support in recent theoretical work [10], where under isotropic compression (that is, without orbital reorientation) the electronic gap closure is expected to occur only at 100 GPa, i.e., at about twice the experimental estimate.

In sum m ary, the pressure-induced structural changes in YTiO $_3$ were studied in detail by synchrotron x-ray di raction. D istinct changes in the distortion of the TiO $_6$ octahedra around 10 GPa are attributed to a spatial reorientation of the occupied Ti 3d(t_{2g}) orbitals. There is a structural similarity between YTiO $_3$ at 15 GPa and Sm TiO $_3$ at am bient pressure, which suggests that YTiO $_3$ m ay lose its unusual property of being both ferrom agnetic and insulating by turning antiferrom agnetic under

compression. The combination of infrared transmission and x-ray diffraction experiments made it possible to obtain direct, quantitative information on the change of the electronic bandgap/bandwidth in a rare-earth transition metal perovskite together with a detailed knowledge of the associated structural changes. These results provide a framework for testing theoretical methods and models of the electronic structure of the t_{2g} -band titanates in the vicinity of the insulator-metal borderline.
