# PERIOD IC HOMOGENIZATION FOR INERTIAL PARTICLES

#### Abstract

W e study the problem of hom ogenization for inertial particles moving in a periodic velocity eld, and sub ject to molecular di usion. W e show that, under appropriate assum ptions on the velocity eld, the large scale, long tim e behavior of the inertial particles is govemed by an e ective diffusion equation for the position variable alone. To achieve this we use a form al multiple scale expansion in the scale param eter. This expansion relies on the hypo-ellipticity of the underlying di usion. A n expression for the di usivity tensor is found and various of its properties studied. In particular, an expansion in term s of the non-dim ensional particle relaxation tim e (the Stokes num ber) is shown to co-incide w ith the known result for passive (non-inertial) tracers in the singular lim it ! $0 . T$ his requires the solution of a singular perturbation problem, achieved by m eans of a form alm ultiple scales expansion in : Incom pressible and potential elds are studied, as well as elds which are neither, and theoretical ndings are supported by num erical sim ulations.


## 1 Introduction

U nderstanding the transport properties of particles moving in uid ow $s$ and sub ject to_ m_olecular di usion is a problem of great theoretical and practical interest [11, 23]. For the punposes of $m$ athem atical analysis, the uid velocity is assum ed to have som e statistical or geom etrical structure which m im ics features of real uid ow s, and yet is such that the resulting equation describing the $m$ otion of the particle is am enable to both analysis and e cient num erical investigations. For exam ple the velocity $m$ ay be assum ed steady and periodic in space, orm ay be assum ed to be a G_aussian random eld in space\{tim e. This is the problem of turbulent di usion $\left[1,23^{\prime} 1\right]$.

It is often the case that the velocity eld of interest is active at various length and tim e scales. C onsequently, the equations which govem the particle $m$ otion are very hard to analyze directly. In such cases an e ective equation which govems the behavior of the particles at long tim es and large scales com pared to those of the uid velocity is sought. The derivation of such an e ective equation is based on m ultiscale/hom ogen ization techniques [ $\underline{L}_{1}^{1}$ ].

This problem has been studied extensively over the last thirty years for passive tracers, i.e. $m$ assless particles. It has been show $n$ that, for periodic or random velocity elds $w$ th short range correlations, the particles perform an e ective $B$ row nian $m$ otion. The covariance $m$ atrix of this $B$ rownian $m$ otion \{ the e ective di usivity \{ is com puted through the solution of an auxiliary equation, the clll problem. In the case of steady periodic velocity elds the cell problem is a linear elliptic PDE w th periodic coe cients. Various properties of the e ective di usivity have been investigated. In particular, it has been shown that the di usivity is always enhanced (over bare molecular di usion) for incom pressible ow s $121,123^{\prime}, 29,1$ and alw ays depleted for potential ow s [461.). Extensions of the above results to the case where the $m$ olecular di usivity is m odelled as colored noise have also been analyzed [15

H ow ever, there are various applications w here the particles cannot be modelled as tracers and inertiale ects have to be taken into account. T he need for adequate m odelling and analysis of the m otion of inertial particles in various applications in science and engineering has been recognized over the last few years $w$ th a number of publications in this direction $[0,11,13 d]$. A s w ell as bringing im portant physical features into the problem, the presence of inertia also renders the $m$ athem atical study of the resulting equations $m$ ore delicate. T he purpose of the present paper is to study the long tim e, large scale behavior of inertial particles $m$ oving in periodic velocity elds, under the in uence of m olecular di usion. B oth analyticaland num erical techniques are used. From a physical standpoint the $m$ ain interest in this work is perhaps the enorm ous enhancem ent in di usion which can be introduced through relatively sm allinertial e ects; see section $6 \mathbf{1}$. From the $m$ athem atical standpoint, the $m$ ain interest is perhaps (i) the hypo-elliptic structure of the di erentialoperators arising in the m ulti-scale expansions (section '[3'1) and (ii) the elucidation of the passive tracer lim it, from w ithin the inertial particles fram ework, again by use of m ultiple scales expansions (section , 'క్',').

W e consider the di usive behaviour of tra jectories satisfying the equation

where $(t)$ is a standard $B$ row nian $m$ otion in $R^{d}$; $d$. In Figure 111 we plot a sample tra jectory of (11) w ith dim ension $d=2, \quad=1$ and $=1$; the velocity $\mathrm{v}(\mathrm{x})$ is given by the T aylor\{ G reen eld:

$T$ his gure strongly suggests that the long tim e behavior of the particles is di usive. O ur goal is to $m$ ake this type of observation precise. W e provide a $m$ athem atical form ula for the e ective di usivity, and study its properties by a combination of analysis and M onte C arlo sim ulations. The results raise a num ber of interesting questions of physical interest, regarding behaviour of the e ective di usivity, and also provide a fram ew ork for $m$ athem atical analysis to further probe questions of physical interest.

P roblem s of th is type have already been studied in a variety of situations:

1. W hen $=0, r \quad U(x) \quad 0$ and

we obtain the follow ing $m$ odel for the $m$ otion of a particle in an incom pressible steady velocity eld [271, 281]:

Here $x(t)$ denotes the particle position and $U(x)$ is the uid velocity. T he param eter $=\frac{f}{p}$ is the ratio betw een the uid density and the particle density and denotes the Stokes num ber. Equation ${ }^{(1)}(4)$ becom es Stokes' law when $=0$, i.e. when the particles arem uch denser than the surrounding uid. The model (4, (4) was analyzed num erically far two dim ensional steady incom pressible cellular ow sby C risantiet al. ${ }^{[6]}$. T heir num erical experim ents show ed that for particles slightly denser than the surrounding uid ( 0 and < 1), and for $=1$, the particles perform an $e$ ective $B$ row nian $m$ otion $w$ ith a well de ned di usion coe cient $T$ he term inertial di usion was introduced to describe this phenom enon. In $F$ igure 2 we present a sam ple trajectory of (4, ${ }_{1}^{\prime}$ ) w ith $U(x)$ given by the Taylor G reen velocity eld (2l), for $=2: 0$ and $=0: 7$. The gure again suggests long tim e behavior of the particle tra jectories which is di usive. $T$ his phenom enon has been observed and analyzed \{m ostly num erically \{by various authors $\left[6,26,137_{1}, 47_{1}, 46\right]$. The range of in which B rownian $m$ otion behaviour is observed appears to be connected to the linear stability properties of the equilibria of ( $\underline{L}^{\prime}$ '); see the discussion in section ' 6 .
2. When $=0, r \quad U(x)=0$ and $v(x)=U(x)$ (i.e._ $\left.=0 i_{n}^{-1}(4)\right)$ a sim ilar investigation was carried_out by $W$ ang et al. in $\left[47_{1}\right]$ in the case $d=3$. They studied equation (4) num erically for the three\{dim ensional A BC ow. It is well known that the stream lines of this ow are chaotic $\sqrt{2}$. It was exhibited num erically that, for su ciently sm all , the particles perform B rownian $m$ otion. The resulting di usion coe cient was evaluated num erically and its dependence on $w$ as investigated.
3. $W$ hen $>0$ and $v(x)=r V(x)$ it is possible to study the e ective behavior of particlesm oving in a periodic or random potential ow, under

 w ith $=0: 7$ and $=2: 0$.
the in uence of molecular di usion. This has been addressed by various researchers $\left[15^{\prime}, 122^{\prime}, 131_{1}^{\prime},{ }^{\prime} 155_{1}^{\prime}\right]$. In this case the particle $m$ otion is govemed by the Langevin equation:-

where $(t)$ is the standard B row nian motion in $R^{d}, \quad>0$ and $V(x)$ is a potentialw hich can be either periodic or random. It w as show $n$ by $P$ apanicolaou and Varadhan [31] that, for su ciently sm ooth random potentials $V(x)$, the particles perform an e ective $B$ row nian $m$ otion, at long length and tim e scales, w ith a nonnegative\{de nite e ective di usivity. A sim ilar result was proved for periodic potentials in [3] ] and various re nem ents were analyzed in $\left[15_{1}^{1}, 224\right]$. T he analysis of equation ( $5_{1}^{5}$ ) is greatly sim pli ed by the fact that the explicit form of the invariant distribution associated to the particle position and velocity is know $n$.
4. The problem of averaging for equations of the form [1]) w ith periodic coe cients was studied by Freidlin in [123]. He considered the equation

where $v(x)$; ( $x$ ) are sm ooth, 1 \{periodic functions_and the $m$ atrix $a(x)=$
$(x)(x)$ is non \{degenerate. It was show $n$ in [13] that as ; tend to 0 , the particle position $x$ converges to the solution of a rst order SDE $w$ ith constant coe cients, leading to linear in tim em ean $o w, w$ ith superim posed B row nian uctuations. The averaged coe cients of the lim iting SDE depend on how fast tends to 0 relative to and two di erent cases have to be distinguished.

The purpose of the present paper is to study the long tim e, large scale behavior of inertial particles satisfying (11) w hen the velocity eld is periodic w ith period 1: $v\left(x+e_{j}\right)=v(x) ; j=1 ;::: ; d$ where $f e_{j} g_{j=1}^{d}$ are the unit vectors in $R^{d} . W e$ show, by applying $m$ ultiscale techniques to the backw ard $K$ olm ogorov equation associated to (11), that, provided the drift term is centered w ith respect to the invariant distribution of the stochastic process corresponding to ( $1^{1}$ 1), the long tim e, large scale behavior of the inertial particles is govemed by an e ective $B$ row nian $m$ otion. The e ective di usivity tensor $K$ is com puted through the solution of the cell problem which is an equation posed on $R^{d} \quad T^{d}$, where $T^{d}$ is the d\{dim ensionalunit torus. It is shown that this tensor is nonnegative and that, consequently, the e ective dynam ics is well\{posed. W eem phasize that our analysis does not assum e any speci c structure on the drift term and that, in particular, it is valid forboth divergence free as well as potential ow s, provided that a centering condition on $v(x)$ is satis ed. H ow ever, in the case of potential ow s, the e ective di usivity is shown to be depleted, for all Stokes' num bers, when com pared w ith bare $m$ olecular di usion; this generalizes a know $n$ result for passive tracers.

O ur theoretical ndings are supported by num ericalsim ulationsw hich probe the dependence of the e ective di usivity on param eters such as and, when
 the Taylor\{G reen ow (i) and the long tim e behavior of the particle tra jectories is show $n$ num erically to be that of a $B$ row nian $m$ otion. T he num erically com puted e ective di usivity is com pared w th the enhancem ent for passive tracers, i.e. when $=0$, and it is show $n$ that the presence of inertia enhances the di usivity beyond the enhancem ent for the passive tracers. The problem is also analyzed through a sm all expansion of the e ective di usivity. W e show that, to leading order in , the e ective di usivity is equal to that arising from the hom ogenization of passive tracers. W e also com pute the $O()$ correction to the e ective di usivity for one dim ensional gradient ow s of the type ( $\mathbf{5}$ ) and show that it is always negative. Thus, in the one dim ensional case and for su ciently sm all but positive, the di usivity is depleted over bare m olecular di usion even further than the depletion which occurs when $=0$.

Here we analyze the problem of hom ogenization of inertial particles and derive the form ula for the e ective di usivity using form alm ulti\{scale calculations. W e em phasize that the basic hom ogenization result derived in this paper can be proved rigorously using techniques from stochastic analysis, in particular the $m$ artingale central lim it theorem [1] $\left.{ }^{1}\right]$; we refer to [16] for the rigorous proof of the hom ogenization theorem .

The paper is organized as follow s. In section we review hom ogenization for passive tracers. The derivation of the hom ogenized equation for the general second order stochastic di erentialequation (1,) w ith periodic velocity eld $v(x)$ is discussed in section ${ }_{1}, 1$, Various properties of the e ective di usivity are derived and analyzed in section 'A1. The hom ogenization result for the equation (4)', sub ject to $m$ olecular di usion, is also presented there. The sm all expansion for $K$ is studied in section ' ${ }_{1}^{\prime}$ '. N um erical experim ents for the Taylor\{ G reen ow are presented in section IG. $_{\text {. Section }}^{17}$ contains our conclusions. F inally, som e technicalresults which are needed for the rigorous justi cation of the m ulti\{scale $m$ ethod em ployed in this paper are proved in the appendix.

## 2 H om ogen ization for P assive T racers

In this section we review the hom ogenization result for passive tracers \{ i.e. $m$ assless particles \{ advected by a velocity eld $v(x)$ and sub ject to molecular
di usion:

W e do this in order to em phasize the structural sim ilarities betw een this case and the inertial case (11) which is the focus of the paper.

The velocity eld $\overline{\mathrm{v}}(\mathrm{x})$ is assum ed sm ooth and periodic w th period 1 . W e w illtake $>0$. This problem has been extensively analyzed, cf. "[4, '23, $2 d, 46]$. $H$ ere we $m$ erely outline the $m$ ain steps in the derivation of the hom ogen ized equation. N otioe that we do not assum e that the ow is either incom pressible or potential. We also rem ank that we have chosen to base our analysis on the B ackw ard K olm ogorov equation as opposed to Forw ard K olm ogorov \{i.e. the Fokker\{P lanck \{ equation, which is more custom ary. Of course, the two approaches are equivalent, provided that the eld $v(x)$ is su ciently sm ooth. W e feel, how ever, that the analysis based on the backw ard $K$ olm ogorov equation is cleaner than that based on the Fokker\{P lanck equation. Furtherm ore, the backw ard $K$ olm ogorov equation isthe starting point for the rigorous justi cation of the results reported here, see $\{16,1$, 1 ].

The process $\mathrm{x}(\mathrm{t})$ whose evolution is govemed by $\left(\bar{\sigma}_{i}\right)$ is ergodic on the torus $T^{d}$, $[\underline{4}, \mathrm{ch} .3]$ for details. $T$ his in particular im plies the existence of a unique, sm ooth, invariant density $0(x)$ which is the unique solution to the stationary Fokker\{P lanck equation. W e w ill assum e that the drift term averages to 0 w ith respect to this invariant density 0 :

The above centering condition ensures that the long tim e, large scale behavior of the particle is di usive and, in particular, excludes the possibility of the existence of an e ective drift. It is autom atically satis ed for potential ows (for which the invariant density $0(x)$ is the Boltzm ann distribution) and it reduces to the condition that the average of the drift over the unit cell vanishes for incom pressible ow S , since in this case $0(x)=1 \underset{\substack{1 \\ 1}}{1 .}$.

### 2.1 The R escaled P rocess

w th the understanding that $\mathrm{z} 2 \mathrm{~T}^{\mathrm{d}}$ and $\mathrm{x} 2 \mathrm{R}^{\mathrm{d}}$ : T his clearly exhibits the fact that the problem possesses three tim e scales of $O$ (1); $\mathrm{O}\left(\mathrm{l}\right.$ ) and $\mathrm{O}\left({ }^{2}\right) . \mathrm{W}$ e now average out the fastest scale, given by $z$.

### 2.2 M utiscale Expansion

T he backw ard K olm ogorov equation for (

Equation (14 ${ }^{(1)}$ ) is the backw ard $K$ olm ogorov equation associated to a B row nian $m$ otion $X(t)^{-} w$ ith covariance $m$ atrix $K$. W e rem ark that these form al calculations can be justi ed rigonously using either energy estim ates [ $\overline{1} 1]$, the $m$ ethod of tw o \{ scale convergence [1] $[1]$ or probabilistic $m$ ethods $[\underline{3}, 1,1321]$.

### 2.3 W ell-posedness of the Lim iting Equation

The lim iting backw ard K olm ogorov equation (142) is well\{posed, ie. the ective di usivity is a nonnegative $m$ atrix. To see this, we rst observe that

From (1d) we deduce that the ective di usivity is indeed nonnegative and the w ell posedness of the e ective equation (141) is dem onstrated.

### 2.4 Incom pressible F low s

W hether the di usivity is enhanced or depleted depends on the speci c properties of the periodic drift term. For the case where the ow is steady and either divergence free or potential m ore detailed inform ation can be obtained. In particular, for incom pressible ows we have that $0(z)=1$. Consequently the last integral on the right hand side of the penultim ate line in $\left(19_{1}^{\prime}\right)$ vanishes on account of the periodicity of $0(z)$. In som e instances we com pare the e ective di usivities for inertial particles \(w\) ith those for passive tracers. The latter are com puted by solving the cell problem directly, by \(m\) eans of a spectralm ethod sim ilar to that described in [24 \({ }^{\prime}\) ], together w ith extrapolation into param eter regim es where the dependence of the di usivity is provably linear.

\subsection*{6.1 The E ect of on D i usivity}

W e com pute the e ective di usivity as a function of the non \{dim ensional particle relaxation time for the Taylor\{G reen ow when \(=0: 0\). O ur results are presented in \(F\) igure 41 , for \(=0: 1\). For com parison, the e ective di usivity of the tracer particle \((=0)\) and that of the free particle, nam ely \(\frac{2}{2}\), are also plotted. The param eter , apart from in uencing the e ective di usivity, introduces an additional tim e scale into the problem [2d]. In particular, for large, we need to integrate the equations of \(m\) otion over a longer tim e interval in order to com pute accurate statistics.

The \(m\) ain interest in this data is that it show shighly non \{trivial dependence of the e ective di usivity on the param eter aswellas giving quantative infor\(m\) ation about how inertia enhances the di usivity over that obtained in the case of passive tracers. W e rem ark, in particular, that the e ective di usivity reaches its \(m\) axim um for \(=O\) (1). It is in this regim e that the free- ight tim e-scale for the inertialparticle is of the sam e order as that induced by the velocity eld. A sim ilar phenom enon, in a di erent context, has been observed by Vassilicos et. al.

\subsection*{6.2 The E ect of on D i usivity}

It is a well docum ented result \([6,137,14 \overline{2}, \overline{4} \overline{2}, \overline{2} \overline{6}]\) that the particle tra jectories of (4)) perform an e ective B row nian \(m\) otion even in the absence ofnoise, in certain param eter regim es. In \(F\) igure, Fa w e plot the second \(m\) om ent of the particle position as a function oftim e for values of below and above the threshold \(=0: 5\), and in the absence of noise. A s expected, the particle \(m\) otion is ballistic for \(=0: 45\) and di usive for \(=0: 55\).

In \(F\) igure , \({ }^{5} \mathrm{th}\) be plot the e ective di usivity as a function of , again in the absence of noise. Since we have chosen \(=2: 0\) we expect an e ective B rownian m otion for \(2(0: 5 ; 1)\). N otice that the e ective di usivity increases as ! \(0: 5^{+}\), and appears to diverge in the lim it. \(T\) his is to be expected, since

\subsection*{6.3 The E ect of on D i usivity}

It is well know \(n\), see e.g. [2]], that for the case of passive tracers the e ective di usivity depends on the molecular di usivity in a highly non \{linear, very com plicated way. In particular, the lim it as tends to 0 is singular and the enhancem ent in the di usivity \{ for divergence free ow s\{depends crucially on the topology of the stream lines. It is therefore interesting to study the dependence of the ective di usivity on for the inertial particles problem.

In \(F\) igure 'T1, we present the e ective di usivity as a function of the \(m\) olecular di usion for two sets of param eters: (a) for \(=0: 0\) (for which the stream lines are closed), \(=1: 0\) and (b) for \(=0: 7 ;=2: 0\) (a regim e in which there exists a well de ned e ective di usivity even in the respectively. T he di usivity of the free particle \(\frac{2}{2}\) is also plotted for com parison. M oreover, in \(F\) igure \({ }_{1} \overline{7}_{1}(a)\), we also plot the e ective di usivity for passive tracers.

In both gures we see the clear enhancem ent of di usivity over the bare \(m\) olecular value. Furtherm ore, in \(F\) igure \(1_{1}^{1}(a)\) we also observe that the enhancem ent in the di usivity is signi cantly greater for \(>0\) (inertial particles) than it is for \(=0\) (passive tracers), especially when is sm all.

A further interesting observation concems the dependence of the di usivity on . For \(=0\) the dependence is highly non-trivial, exhibiting both a local m axim um and a localm inim um. For \(=0: 7\) the presence of inertia leads to an e ective di usivity which increases as becom es sm aller. This should be contrasted w th the established fact that, for passive tracers in periodic cellular ow s, the e ective di usivity decreases linearly in , for su ciently sm all [39, '42, It w ould be interesting to understand how the enhancem ent scales w ith ! 0 and to com pare it \(w\) ith known theoretical results for the passive tracer case; in particular, it would be interesting to extend the theory of maxim ally


\section*{7 C onclusions}

The problem of periodic hom ogenization for inertial particles is considered in this paper. It is show \(n\) that, at long tim es and large scales, the inertial particles perform B row nian \(m\) otion and a form ula for the e ective di usivity is derived. Furthem ore, the dependence of the e ective di usivity on the non \{dim ensional particle \(m\) ass a (Stokes num ber) and the ratio of the uid to particle density is studied, by \(m\) eans of analysis and num erics.
It is shown that, as ! 0; the e ective di usivity converges to the one obtained from the hom ogenization of passive tracers. M oreover, it is shown through num erical experim ents that for a variety of interesting divergence free
ow s , the di usivity in the presence of inertia is enhanced m uch beyond the well docum ented enhancem ent ofthe di usivity forpassive tracers. Furtherm ore, the dependence of the e ective di usivity on and is studied num erically in som e detail.

The calculation of the e ective di usion tensor requires the num erical solution of equations (31) and (2G). It is coneivable that this task \(m\) ight be as com putationally dem anding as direct \(M\) onte \(C\) arlo sim ulations, because the do\(m\) ain of the PDE is unbounded in the \(m\) om entum variable, and because the PDE is not elliptic (only hypo-elliptic). This is to be contrasted to the case of passive tracers in periodic ows; there the calculation of the e ective di usivity
requires the solution of the elliptic PDE (1-3) on a periodic dom ain. Equations of this type can be routinely and e eciently solved using, for exam ple, a spectral \(m\) ethod. From this point of view our results \(m\) ight not provide any com putational advantage over \(M\) onte \(C\) arlo sim ulations. H ow ever, the results reported in this paper provide a \(m\) athem atical fram ew ork for rigorous analysis of the dependence of the e ective di usion coe cient on the physical param eters of the problem. W e have already undertaken such an analysis to study the lim it of sm all Stokes num ber and we plan to undertake further studies in future work.

The num erical results reported in section ' \(G\), for a sim ple tw of dim ensional steady ow, exhibit a wide range of interesting physical phenom ena. As examples we mention the dependence of the e ective di usivity on the Stokes number and the uid/particle density ratio, for a given stream line topology, question which are, we believe, of great interest to the applied com \(m\) unity. T he purpose of this work is to develop a fram ework within which such questions can be addressed. W e plan to investigate some of these issues in future work. The dependence_of the e ective di usivity for a wider class of velocity elds is undertaken in [34].

Sum \(m\) arizing, we note the follow ing speci c areas where future work would be of interest:
the extension to tim e dependent velocity elds \(v(x ; t)\), either periodic in tim e or random _in tim e \{ for exam ple w ith an O mstein \(\{U\) hlenbeck struc-

the extension to random velocity elds in space;
rigorous analysis of the param etric dependence of the e ective di usivity on , and , taking into account the free stream line topologies;
further num erical studies for velocity elds other than the sim ple Taylor G reen ows studied here \{ in particular to study problem s where the Lagrangian particle paths have open stream line topologies, such as the C hildress-Sow ard fam ily; this is in itiated in B431].

But, as we wil see, condition ( $\lambda_{1}$ ) is natural from a m athem atical point of view . If, instead, the condition $T_{T^{d}} V(x) d x=0$ is im posed, then an e ective drift can appear and then a G alilean transform ation $w$ ith respect to this e ective drift can bring the problem to the form that we consider.
