## PERIODIC HOMOGENIZATION FOR INERTIAL PARTICLES

#### A bstract

W e study the problem of hom ogenization for inertial particles m oving in a periodic velocity eld, and subject to molecular di usion. We show that, under appropriate assum ptions on the velocity eld, the large scale, long time behavior of the inertial particles is governed by an e ective diffusion equation for the position variable alone. To achieve this we use a form almultiple scale expansion in the scale parameter. This expansion relies on the hypo-ellipticity of the underlying di usion. An expression for the di usivity tensor is found and various of its properties studied. In particular, an expansion in terms of the non-dimensional particle relaxation tim e (the Stokes number) is shown to co-incide with the known result for passive (non-inertial) tracers in the singular limit ! 0. This requires the solution of a singular perturbation problem , achieved by m eans of a form almultiple scales expansion in : Incompressible and potential elds are studied, as well as elds which are neither, and theoretical ndings are supported by num erical simulations.

## 1 Introduction

Understanding the transport properties of particles moving in uid ows and subject to molecular di usion is a problem of great theoretical and practical interest [11, 23]. For the purposes of mathematical analysis, the uid velocity is assumed to have some statistical or geometrical structure which min ics features of real uid ows, and yet is such that the resulting equation describing the motion of the particle is amenable to both analysis and e cient numerical investigations. For example the velocity may be assumed steady and periodic in space, orm ay be assumed to be a Gaussian random eld in space{time. This is the problem of turbulent di usion [7, 23].

It is often the case that the velocity eld of interest is active at various length and time scales. Consequently, the equations which govern the particle motion are very hard to analyze directly. In such cases an elective equation which governs the behavior of the particles at long times and large scales compared to those of the uid velocity is sought. The derivation of such an elective equation is based on multiscale/hom ogenization techniques [4]. This problem has been studied extensively over the last thirty years for passive tracers, i.e. massless particles. It has been shown that, for periodic or random velocity elds with short range correlations, the particles perform an elective B rownian motion. The covariance matrix of this B rownian motion { the elective di usivity { is computed through the solution of an auxiliary equation, the cell problem. In the case of steady periodic velocity elds the cell problem is a linear elliptic PDE with periodic coe cients. Various properties of the elective di usivity have been investigated. In particular, it has been shown that the di usivity is always enhanced (over bare molecular di usion) for incom pressible ow s [12, 23, 29] and always depleted for potential ow s [46]. Extensions of the above results to the case where the molecular di usivity is modelled as colored noise have also been analyzed [5].

How ever, there are various applications where the particles cannot be modelled as tracers and inertial e ects have to be taken into account. The need for adequate modelling and analysis of the motion of inertial particles in various applications in science and engineering has been recognized over the last few years with a number of publications in this direction [8, 10, 38]. As well as bringing in portant physical features into the problem, the presence of inertia also renders the m athem atical study of the resulting equations m ore delicate. The purpose of the present paper is to study the long time, large scale behavior of inertial particles moving in periodic velocity elds, under the in uence of molecular di usion. Both analytical and num erical techniques are used. From a physical standpoint the main interest in this work is perhaps the enorm ous enhancem ent in di usion which can be introduced through relatively sm all inertial e ects; see section 6. From the mathematical standpoint, the main interest is perhaps (i) the hypo-elliptic structure of the di erential operators arising in the multi-scale expansions (section 3) and (ii) the elucidation of the passive tracer limit, from within the inertial particles framework, again by use of multiple scales expansions (section 5).

We consider the di usive behaviour of trajectories satisfying the equation




Figure 1: The two components of the solution of (1), (2) with = = 1.0.

where (t) is a standard B row nian motion in  $\mathbb{R}^d$ ; d 1. In Figure 1 we plot a sample trajectory of (1) with dimension d = 2, = 1 and = 1; the velocity v(x) is given by the Taylor{G reen eld:

This gure strongly suggests that the long time behavior of the particles is di usive. Our goal is to make this type of observation precise. We provide a mathematical formula for the elective di usivity, and study its properties by a combination of analysis and M onte Carlo simulations. The results raise a number of interesting questions of physical interest, regarding behaviour of the elective di usivity, and also provide a framework for mathematical analysis to further probe questions of physical interest.

Problem s of this type have already been studied in a variety of situations:

1. When  $= 0, r \cup (x) = 0$  and

we obtain the following model for the motion of a particle in an incom - pressible steady velocity eld [27, 28]:




Figure 2: The two components of the solution of (4), for U (x) given by (2), with = 0.7 and = 2.0.

Here x (t) denotes the particle position and U (x) is the uid velocity. The =  $\frac{f}{r}$  is the ratio between the uid density and the particle param eter denotes the Stokes number. Equation (4) becomes Stokes' density and law when = 0, i.e. when the particles are much denser than the surrounding uid. The model (4) was analyzed num erically for two dimensional steady incom pressible cellular ow s by C risantiet al. [6]. Their num erical experim ents showed that for particles slightly denser than the surrounding uid (1 0 and < 1), and for = 1, the particles perform an e ective Brownian motion with a well de ned di usion coe cient The term inertial di usion was introduced to describe this phenomenon. In Figure 2 we present a sample trajectory of (4) with U (x) given by the Taylor G reen velocity eld (2), for = 2:0 and = 0:7. The gure again suggests long time behavior of the particle trajectories which is di usive. This phenom enon has been observed and analyzed {mostly num erically {by various authors [6, 26, 37, 47, 48]. The range of in which Brownian motion behaviour is observed appears to be connected to the linear stability properties of the equilibria of (4); see the discussion in section 6.

- 2. When = 0, r U (x) = 0 and v(x) = U (x) (i.e. = 0 in (4)) a similar investigation was carried out by W ang et al. in [47] in the case d = 3. They studied equation (4) numerically for the three{dimensional ABC ow. It is well known that the stream lines of this ow are chaotic [2]. It was exhibited numerically that, for su ciently small , the particles perform B rownian motion. The resulting di usion coe cient was evaluated numerically and its dependence on was investigated.
- 3. When > 0 and v(x) = rV(x) it is possible to study the elective behavior of particles moving in a periodic or random potential ow, under

the in unnee of m obcular di usion. This has been addressed by various researchers [15, 22, 31, 35]. In this case the particle m otion is governed by the Langevin equation:

where (t) is the standard B row nian m otion in  $\mathbb{R}^d$ , > 0 and V (x) is a potential which can be either periodic or random. It was shown by Papanicolaou and Varadhan [31] that, for su ciently smooth random potentials V (x), the particles perform an elective B row nian m otion, at long length and time scales, with a nonnegative (de nite elective di usivity. A similar result was proved for periodic potentials in [35] and various reinements were analyzed in [15, 22]. The analysis of equation (5) is greatly simplied by the fact that the explicit form of the invariant distribution associated to the particle position and velocity is known.

4. The problem of averaging for equations of the form (1) with periodic coe cients was studied by Freidlin in [13]. He considered the equation

where v(x); (x) are smooth, 1 {periodic functions and the matrix a(x) = (x) (x) is non {degenerate. It was shown in [13] that as ; tend to 0, the particle position x converges to the solution of a rst order SDE with constant coe cients, leading to linear in time mean ow, with super-imposed B rownian uctuations. The averaged coe cients of the limiting SDE depend on how fast tends to 0 relative to and two di erent cases have to be distinguished.

The purpose of the present paper is to study the long time, large scale behavior of inertial particles satisfying (1) when the velocity eld is periodic with period 1:  $v(x + \hat{e}_j) = v(x); j = 1; \dots; dw$  here  $f\hat{e}_j g_{j=1}^d$  are the unit vectors in  $\mathbb{R}^d$ . We show, by applying multiscale techniques to the backward K olm ogorov equation associated to (1), that, provided the drift term is centered with respect to the invariant distribution of the stochastic process corresponding to (1), the long time, large scale behavior of the inertial particles is governed by an e ective Brownian motion. The e ective di usivity tensor K is computed through the solution of the cell problem which is an equation posed on  $\mathbb{R}^d$   $\mathbb{T}^d$ , where  $\mathbb{T}^d$ is the d{dim ensional unit torus. It is shown that this tensor is nonnegative and that, consequently, the e ective dynam ics is well { posed. W e em phasize that our analysis does not assume any specic structure on the drift term and that, in particular, it is valid for both divergence free as well as potential ows, provided that a centering condition on v(x) is satis ed. How ever, in the case of potential ows, the e ective di usivity is shown to be depleted, for all Stokes' numbers, when compared with bare molecular di usion; this generalizes a known result for passive tracers.

O ur theoretical ndings are supported by num erical sin ulations which probe the dependence of the e ective di usivity on parameters such as and, when the velocity eld is given by (3), : The equations of motion (1) are solved for the Taylor{G reen ow (2) and the long time behavior of the particle trajectories is shown num erically to be that of a Brownian motion. The num erically computed e ective di usivity is compared with the enhancement for passive tracers, i.e. when = 0, and it is shown that the presence of inertia enhances the di usivity beyond the enhancement for the passive tracers. The problem is also analyzed through a small expansion of the e ective di usivity. We show that, to leading order in , the e ective di usivity is equal to that arising from the hom ogenization of passive tracers. We also compute the O () correction to the e ective di usivity for one dimensional gradient ows of the type (5) and show that it is always negative. Thus, in the one dimensional case and for su ciently small but positive, the di usivity is depleted over bare molecular di usion even further than the depletion which occurs when = 0.

Here we analyze the problem of hom ogenization of inertial particles and derive the form ula for the e ective di usivity using form almulti{scale calculations. We emphasize that the basic hom ogenization result derived in this paper can be proved rigorously using techniques from stochastic analysis, in particular the martingale central limit theorem [18]; we refer to [16] for the rigorous proof of the hom ogenization theorem.

The paper is organized as follows. In section 2 we review hom ogenization for passive tracers. The derivation of the hom ogenized equation for the general second order stochastic di erential equation (1) with periodic velocity eld v(x) is discussed in section 3. Various properties of the elective di usivity are derived and analyzed in section 4. The hom ogenization result for the equation (4), subject to molecular di usion, is also presented there. The small expansion for K is studied in section 5. Numerical experiments for the Taylor (G reen ow are presented in section 6. Section 7 contains our conclusions. Finally, some technical results which are needed for the rigorous justic cation of the multi (scale method employed in this paper are proved in the appendix.

## 2 Hom ogenization for Passive Tracers

In this section we review the hom ogenization result for passive tracers { i.e. massless particles { advected by a velocity eld v(x) and subject to molecular

di usion:

W e do this in order to emphasize the structural similarities between this case and the inertial case (1) which is the focus of the paper.

The velocity eld v(x) is assumed smooth and periodic with period 1. We will take > 0. This problem has been extensively analyzed, cf. [4, 23, 29, 46]. Here we merely outline the main steps in the derivation of the hom ogenized equation. Notice that we do not assume that the ow is either incompressible or potential. We also remark that we have chosen to base our analysis on the Backward Kolm ogorov equation as opposed to Forward Kolm ogorov (i.e. the Fokker{Planck{ equation, which is more custom ary. Of course, the two approaches are equivalent, provided that the eld v(x) is su ciently smooth. We feel, how ever, that the analysis based on the backward Kolm ogorov equation is cleaner than that based on the Fokker{Planck equation. Furtherm ore, the backward Kolm ogorov equation is the starting point for the rigorous justi cation of the results reported here, see [16, 18].

The process x (t) whose evolution is governed by (6) is ergodic on the torus  $T^d$ , [4, ch. 3] for details. This in particular in plies the existence of a unique, smooth, invariant density \_\_\_\_\_\_(x) which is the unique solution to the stationary Fokker{P lanck equation. W e will assume that the drift term averages to 0 with respect to this invariant density \_\_\_\_\_\_\_\_:

The above centering condition ensures that the long time, large scale behavior of the particle is discussed and, in particular, excludes the possibility of the existence of an elective drift. It is automatically satisfies d for potential ows (for which the invariant density  $_{0}(x)$  is the Boltzmann distribution) and it reduces to the condition that the average of the drift over the unit cell vanishes for incompressible ows, since in this case  $_{0}(x) = 1^{1}$ .

### 2.1 The Rescaled Process

We use the scaling property of Brownian motion (ct) =  ${}^{p}\overline{c}$  (t) in law [17, Lem m a 2.9.4] to deduce that, under the re-scaling t ! t=  ${}^{2}$ , x ! x = we obtain

 $_{T^{d}}^{l}$  It would seem more natural from a physical point of view to impose the condition  $_{T^{d}}^{r}v(x) dx = 0$ , rather than condition (7), since the invariant density itself depends on the drift v(x). But, as we will see, condition (7) is natural from a mathematical point of view. If, instead, the condition  $_{T^{d}}^{r}v(x) dx = 0$  is imposed, then an elective drift can appear and then a Galilean transform ation with respect to this elective drift can bring the problem to the form that we consider.

with the understanding that  $z \ge T^d$  and  $x \ge R^d$ : This clearly exhibits the fact that the problem possesses three time scales of O (1);O () and O (<sup>2</sup>). We now average out the fastest scale, given by z.

### 2.2 Mutiscale Expansion

The backward Kolm ogorov equation for (8) is

Here  $L_0$  is a uniform ly elliptic operator with periodic boundary conditions on  $T^d$ . We look for a solution of equation (9) which has the form :

E quation (14) is the backward K olm ogorov equation associated to a B row nian motion X (t) with covariance matrix K. We remark that these form al calculations can be justiled rigorously using either energy estimates [4], the method of two{scale convergence [1] or probabilistic methods [3, 32].

### 2.3 W ell-posedness of the Lim iting Equation

The limiting backward K olm ogorov equation (14) is well{posed, i.e. the elective di usivity is a nonnegative matrix. To see this, we is to be retained that

From (19) we deduce that the elective di usivity is indeed nonnegative and the well posedness of the elective equation (14) is demonstrated.

### 2.4 In compressible Flows

W hether the di usivity is enhanced or depleted depends on the speci c properties of the periodic drift term. For the case where the ow is steady and either divergence free or potential more detailed information can be obtained. In particular, for incompressible ows we have that  $_0(z) = 1$ . Consequently the last integral on the right hand side of the penultim ate line in (19) vanishes on account of the periodicity of  $_0(z)$ . Thus, the elective di usivity along the vector a becomes:

This shows that transport is always enhanced over bare molecular di usion, for incompressible ows [29].

with  $_0(z)$  being the Boltzmann distribution. This shows that transport is always depleted, compared with bare molecular di usion, for potential ows [46].

## 3 Hom ogenization for Inertial Particles

In this section we will derive the hom ogenized equation which describes the motion of inertial particles at long times and large scales using multi-scale techniques. The equation of motion for the inertial particles is (1).

### 3.1 The Rescaled Process

We start by perform ing a discussive rescaling to the equations of motion (1): t! t=  ${}^{2}$ , x!  $\stackrel{\underline{x}}{=}$ . Using the fact that (ct) =  ${}^{P}\overline{c}$  (t) in law we obtain:

It is straightforward to show that the bracketed term s on the right hand side of the above equation converge to 0, as ! 0. By using the fact that the (y;z) process is fast, the martingale central lim it theorem facilitates proof that the stochastic integral which appears in the above equation converges to a B rownian motion whose covariance is given by the lim it of the quadratic variation of the stochastic integral [18], [9, Thm. 7.1.4]. The application of this theorem autom atically provides us with the well{posedness of the lim iting B ackward K olm ogorov equation. In the next section we establish this well{posedness directly, through the multiple-scales fram ework.

## 4 Properties of the E ective Diusivity Tensor

### 4.1 W ell-posedness of the Lim iting Equation

In the previous section we showed that the dynam ics of the inertial particles at large scales is governed by the backward K olm ogorov equation (32). In this subsection we prove that this equation is well{posed, i.e. that the e ective di usivity is nonnegative. To see this, we rst observe that

### 4.3 In compressible Flows

We are unable to prove the analogue of what is known for passive tracers, namely that di usion is always enhanced for incompressible ow elds. Numerical evidence, how ever, suggests that this enhancement is seen in a wide variety of situations and that, furthermore, the presence of inertia further enhances the di usivity over the passive tracer enhancement. See section 6.

### 4.4 Potential F low s

From the representation (37) we can prove that, for potential ows, the diusivity is depleted for all > 0, as is true for the case = 0 of passive tracers. As for passive tracers we use the fact that the explicit form of the invariant measure is known for potential ows. 


Figure 3: Second m om ents of the particle position versus time for the velocity eld (40). The graphs of t and  $t^2$  are also included for comparison.

# 4.6 H om ogenization W hen the C entering H ypothesis (28) is not Satis ed

In the previous section we imposed the centering condition (28) in order to ensure that there is no mean drift and that the motion of the inertial particles at long scales is di usive. In the case where this condition is not satisfied, then we expect that the elective behavior of the particles is described by a transport equation and that the di usion appears only as a higher order correction. Indeed, an analysis similar to the one presented in the previous section, using the advective rescaling t = t = and x = x = ; shows that in this case the particle motion at large scales is goverened by the following backward K olm ogorov equation

## 6 Num erical Experim ents

In this section we study the dependence of the elective dilusivity for equations (1), (3) on the non{dimensional parameters of the problem ; and . For simplicity all the experiments we perform are for the Taylor{Green ow (2)<sup>4</sup>

The closed stream lines of Lagrangian particle paths in this velocity eld is a rather special situation and we describe num erical experim ents for other stream functions, including open stream line topologies, in [34].

It is straightforward to check that the Taylor{G reen ow satis es condition (39) and hence the absence of ballistic motion at long scales is ensured. Moreover, the sym metry properties of (2) im ply that the two diagonal components of the elective di usivity are equal, whereas the o {diagonal components vanish. In the gures presented below we use the notation  $K := K_{11} = K_{22}$ .

 $<sup>^4</sup>$  In our derivation of the hom ogenized equation and the form ula for the e ective di usivity we assumed that the velocity eld is 1{periodic, rather than 2 {periodic. Of course the analysis, as well as the form ulas that we derived, are trivially extended to encompass this change of period.

Rather than solving the cell problem (42), we compute the elective diusivity using M onte Carlo simulations: we solve the equations of motion (41) num erically for dierent realizations of the noise and we compute the elective diusivity through the formula

where h idenotes ensemble average. We solve the stochastic equations of motion using M ilstein's method, appropriately modi ed for the second order SDE [19, p. 386]:

where  $r = -\frac{t}{2}$  and  $s_1 = 1$   $\frac{r}{2}$ ;  $s_2 = 1 + \frac{r}{2}$ . This method has strong order of convergence 1.0. <sup>5</sup> We use N = 1024 uniform by distributed particles in 2 T<sup>2</sup> with zero initial velocities and we integrate over a very long time interval (which is chosen to depend upon the parameters of the problem) with t 5:10<sup>4</sup> m inf1; g.

In some instances we compare the elective di usivities for inertial particles with those for passive tracers. The latter are computed by solving the cell problem directly, by means of a spectral method similar to that described in [24], together with extrapolation into parameter regimes where the dependence of the di usivity is provably linear.

### 6.1 The E ect of on Diusivity





Figure 4: E ective di usivity versus for = 0:0; = 0:1.

We compute the elective di usivity as a function of the non {dimensional particle relaxation time for the Taylor{G meen ow when = 0.0. Our results are presented in Figure 4, for = 0.1. For comparison, the elective di usivity of the tracer particle ( = 0) and that of the free particle, namely  $\frac{2}{2}$ , are also plotted. The parameter , apart from in uencing the elective di usivity, introduces an additional time scale into the problem [20]. In particular, for large, we need to integrate the equations of motion over a longer time interval in order to compute accurate statistics.

The main interest in this data is that it show shighly non {trivial dependence of the e ective di usivity on the parameter as well as giving quantative information about how inertia enhances the di usivity over that obtained in the case of passive tracers. We remark, in particular, that the e ective di usivity reaches its maximum for = 0 (1). It is in this regime that the free- ight time-scale for the inertial particle is of the same order as that induced by the velocity eld. A sim ilar phenom enon, in a di erent context, has been observed by Vassilicos et. al. [45].

### 6.2 The E ect of on Diusivity

It is a well docum ented result [6, 37, 47, 48, 26] that the particle trajectories of (4) perform an electrive B row nian motion even in the absence of noise, in certain parameter regimes. The linear stability analysis of (4) for the Taylor (G reen ow

indicates that in the parameter regime 2 (1= ;1) we expect a very complicated, chaotic behavior which m ight be interpreted as an elective B rownian motion at long times. When U (x) =  $r^2 T_G (x)$  then the noise free dynamics arising from (1) when = 0 has two sets of equilibria,  $X_0^1 = [n;0;m;0];n;m 2 N$  and  $X_0^2 = [\frac{1}{2} + n;0;\frac{1}{2} + m;0];n;m 2 N$ . The rst set of equilibria have two dimensional unstable manifold for > 1 and one dimensional for < 1; the second set have a two dimensional unstable manifold for > 1 and one dimensional for < 1; if and only if 2 ( $^1$ ;1): In this regime, all equilibria have two dimensional unstable manifolds. The basic mechanism for di usion is chaotic mixing caused by separation near the separatrices of equilibria; it is unsuprising therefore that the linear stability of equilibria play a strong role on determining the interval of in which di usion occurs.


In Figure 5a we plot the second m om ent of the particle position as a function of time for values of below and above the threshold = 0.5, and in the absence of noise. As expected, the particle motion is ballistic for = 0.45 and di usive for = 0.55.

In Figure 5b we plot the elective di usivity as a function of , again in the absence of noise. Since we have chosen = 2:0 we expect an elective B rownian motion for 2 (0:5;1). Notice that the elective di usivity increases as  $! 0:5^{\circ}$ , and appears to diverge in the lim it. This is to be expected, since = 0:5 separates ballistic motion (for < 0:5) and di usive motion (for > 0:5) motion.




Figure 6: E ective dissivity as a function of for = 0:1 and = 2:0.

In Figure 6 we plot the e ective di usivity as a function of when the particles are subject to additional molecular di usion. In this case the elective



The lines t and  $t^2$  are also plotted for comparison.




Figure 7: E ective Diusivity versus for = 0.0 and = 0.7.

diusivity is a decreasing function of .

### 6.3 The E ect of on Diusivity

It is well known, see e.g. [23], that for the case of passive tracers the e ective di usivity depends on the molecular di usivity in a highly non{linear, very complicated way. In particular, the limit as tends to 0 is singular and the enhancement in the di usivity {for divergence free ows{ depends crucially on the topology of the stream lines. It is therefore interesting to study the dependence of the e ective di usivity on for the inertial particles problem.

In Figure 7 we present the e ective di usivity as a function of the m olecular di usion for two sets of param eters: (a) for = 0.0 (for which the stream lines are closed), = 1.0 and (b) for = 0.7; = 2.0 (a regime in which there exists a well de ned e ective di usivity even in the respectively. The di usivity of the free particle  $\frac{2}{2}$  is also plotted for com parison. M oreover, in Figure 7 (a), we also plot the e ective di usivity for passive tracers.

In both gures we see the clear enhancement of di usivity over the bare molecular value. Furthermore, in Figure 7 (a) we also observe that the enhancement in the di usivity is significantly greater for > 0 (inertial particles) than it is for = 0 (passive tracers), especially when is small.

A further interesting observation concerns the dependence of the di usivity on . For = 0 the dependence is highly non-trivial, exhibiting both a local maximum and a local minimum. For = 0:7 the presence of inertia leads to an elective di usivity which increases as becomes smaller. This should be contrasted with the established fact that, for passive tracers in periodic cellular ows, the elective di usivity decreases linearly in , for su ciently small

[39, 42]. It would be interesting to understand how the enhancem ent scales with ! 0 and to compare it with known theoretical results for the passive tracer

case; in particular, it would be interesting to extend the theory of maximally and minimally enhanced di usion [24] to the inertial situation studied here.

## 7 Conclusions

The problem of periodic hom ogenization for inertial particles is considered in this paper. It is shown that, at long times and large scales, the inertial particles perform B rownian motion and a formula for the elective di usivity is derived. Furthermore, the dependence of the elective di usivity on the non {dimensional particle mass a (Stokes number) and the ratio of the uid to particle density is studied, by means of analysis and numerics.

It is shown that, as ! 0; the elective di usivity converges to the one obtained from the homogenization of passive tracers. Moreover, it is shown through num erical experiments that for a variety of interesting divergence free ows, the di usivity in the presence of inertia is enhanced much beyond the well documented enhancement of the di usivity for passive tracers. Furthermore, the dependence of the elective di usivity on and is studied numerically in some detail.

The calculation of the e ective di usion tensor requires the numerical solution of equations (31) and (26). It is coneivable that this task m ight be as computationally dem anding as direct M onte C arb simulations, because the dom ain of the PDE is unbounded in the momentum variable, and because the PDE is not elliptic (only hypo-elliptic). This is to be contrasted to the case of passive tracers in periodic ows; there the calculation of the elective di usivity requires the solution of the elliptic PDE (13) on a periodic dom ain. Equations of this type can be routinely and e eciently solved using, for exam ple, a spectral method. From this point of view our results might not provide any computational advantage over M onte C arlo sim ulations. However, the results reported in this paper provide a mathematical framework for rigorous analysis of the dependence of the elective di usion coe cient on the physical parameters of the problem. We have already undertaken such an analysis to study the limit of sm all Stokes num ber and we plan to undertake further studies in future work.

The num erical results reported in section 6, for a simple two{ dimensional steady ow, exhibit a wide range of interesting physical phenomena. As examples we mention the dependence of the elective di usivity on the Stokes number and the uid/particle density ratio, for a given stream line topology, question which are, we believe, of great interest to the applied community. The purpose of this work is to develop a fram ework within which such questions can be addressed. We plan to investigate some of these issues in future work. The dependence of the elective di usivity for a wider class of velocity elds is undertaken in [34].

Sum m arizing, we note the following speci c areas where future work would be of interest:

the extension to time dependent velocity elds v(x;t), either periodic in time or random in time { for example with an O mstein {Uhlenbeck structure as in [33, 40, 41];

the extension to random velocity elds in space;

rigorous analysis of the param etric dependence of the e ective di usivity on , and , taking into account the free stream line topologies;

further num erical studies for velocity elds other than the simple Taylor G reen ows studied here { in particular to study problems where the Lagrangian particle paths have open stream line topologies, such as the Childress-Sow and family; this is initiated in [34].

## A Appendix

In this appendix we prove the existence of a unique invariant measure for the process fx;xg solving (1) and, moreover, that the generator L of the process satis es the Fredholm alternative. This justi es the form almulti{scale calculations presented in section 3. To simplify the notation we set = 1. The equations of motion become

The proof of the existence of a unique invariant m easure for our process is based on the results of [25] and is broken into three lemmas. First, we need to prove the existence of a smooth transition probability density for our M arkov process. This is accomplished by m eans of H orm ander's theorem [36, Thm V 38.16]. Then we need to prove the compactness of phase space, for which we need to nd an appropriate Lyapunov functions. Finally, we need to prove that the transition probability density is everywhere positive. To show this we need to use a controllability argum ent. The proof of the existence and uniqueness of solutions of the Poisson equation (54) is based on Fredholm 's theorem .

Lem m a A .1. The M arkov process generated by L has a sm ooth transition probability density.

P roof. This follows by an application of H orm ander's theorem . The basic idea behind this theorem is that, even though noise does not act directly to the position variable, there is nevertheless su cient interaction between m om entum and position so that noise, and consequently sm oothness, is transm itted to all degrees of freedom . W e write the generator in H orm ander's "sum of squares" form :

The last ingredient which is needed for the proof of the ergodicity of the process generated by L is the fact the transition probability  $P_t$  is everywhere positive.

For the proof of this lem m a we refer to [25, Lem m a 3.4].

Proof of Theorem A.1. The existence of a unique invariant m easure follows from Lemmas A.1, A.2 and A.3, upon using Corollary 2.8 from [25]. In order to prove the existence and uniqueness of solutions of the Poisson equation (54) we need to prove that the generator L has compact resolvent. This is accomplished in [16, Thm 3.1, Thm 3.2].

R em ark A .1. The above lemmas enable us to conclude that the system converges exponentially fast to its invariant distribution [25].

R em ark A 2. W e a bit of extra work we can also prove sharp estimates for the invariant distribution and the solution of the Poisson equation Lf = h. W e refer to [16, Thm 3.1, Thm 3.2] for details.
