Intrinsic Low Tem perature Param agnetism in B-DNA

W e present experim ental study of m agnetization in -DNA in conjunction with structural measurem ents. The results show the surprising interplay between the molecular structures and their m agnetic property. In the B-DNA state, -DNA exhibits param agnetic behaviour below 20 K that is non-linear in applied m agnetic eld whereas in the A-DNA state, remains diam agnetic down to 2 K. W e propose orbital param agnetism as the origin of the observed phenom ena and discuss its relation to the existence of long range coherent transport in B-DNA at low tem perature.

It is now a comm on know ledge that the electrical conduction in DNA is intim ately linked to experim ental factors such as molecules' base-pair sequence, type of electrodes, surrounding counter ions and number of water molecules [1, 2, 3, 4]. The experimental accounts to date span a whole spectrum of conduction mechanism from insulators, sem i-conductors, metals to proximity induced superconductors [5, 6, 7, 8]. Magnetization is an alternative, non-invasive mean to probe the intrinsic electronic properties of m atter, as the m easurem ents do not require any electrode attachm ents. Unlike the intensive experimentale ortsmade on electronic transport in DNA molecules, their magnetization has been scarcely explored due to experimental di culties such as the overwhelm ing presence of water. Basic questions on the intrinsic magnetic properties of DNA such as the magnitude of its magnetic susceptibility, g, have remained unclear. It is widely known that DNA is diam agnetic near room tem perature with a sizable anisotropy stem ming from the presence of aromatic rings of the base pairs whose magnitude is comparable to that of benzene [9, 10, 11]. But how does the over-all magnetic state of DNA depend on intrinsic parameters (molecular structure, base-pair sequence) as well as extrinsic param eters such as counter ion types? Does DNA magnetization depend on these parameters in a way reminiscent to the electrical conduction? And if so, what are the consequences and im plications for the usage of DNA as molecular wires? To answer these adjuring questions, we have studied the low temperature susceptibility and magnetization of random ly oriented -DNA molecules and its relation to their molecular structure (A - and B-DNA) and counter ion types (Na^+) and Mg^{2+} , two parameters known to greatly in uence the electronic property of DNA [1]. We nd that the magnetization is temperature independent and diam agnetic at high tem peratures (100 K and above) regardless of water content in both Aand B-DNA structures. Surprisingly, once the molecules are su ciently wet' and thus are found in B-structure, a param agnetic upturn was observed at lower tem peratures that is non-linear in magnetic eld in addition to the atom ic diam angetic component. Collectively, these

observations reveal for the st time, the intrinsic nondiam agnetic state in DNA molecules that is intricately related to their molecular structures.




Figure 1: Evolution of magnetization (M) of NaDNA with water content. (a) M agnetization of DNA and water as a function of tem perature (T). For T > 100 K, the change in magnetization corresponds to the temperature independent diam agnetic contribution from H₂O. The num ber in bold letters indicates the order in which the measurements were taken. (b) M agnetization as a function of m agnetic eld (H) measured at T = 2 K without the contribution from water $(-7.2 \quad 10^{-10} \text{ EM U} \quad \text{G}^{-1} \quad 1^{-1})$. The straight dashed line represents the diam agnetic component of NaDNA measured at T = 150 K. The dotted curved line superim posed on the data points with $H_2O = 0.9$ l is a guide to the eye. Error bars represent the standard deviation in the measurements. Some error bars on low eld data, H 1 T, are rem oved in order to avoid crowding the graph. A Ferrom agnetic component of unknown origin was detected whose magnitude saturates 5 10 6 EMU for both NaDNA and at H 7000 G M M gD N A). This component, how ever, was independent oftem perature and of water content throughout the measurem ents and has also been subtracted.

-DNA samples (400 geach) in two counter ion types, (hereafter called NaDNA) and Mq^{2+} (MqDNA) Na^+ were prepared in quartz capillary tubes that served as sam ple holders for both m agnetization (Q uantum D esign MPMS-R2SQUD magnetometer) and structural studies (m icro-R am an spectrom eter) [12]. -DNA (16 m, 48,502 base-pairs) was chosen speci cally because the proxim ity induced superconductivity and the low temperature negative m agnetoresistive behavior were detected previously in these molecules [3]. The molecular structure of DNA changes dram atically with surrounding hydration levels. In aqueous environm ent DNA molecules are in B-DNA structure where base-pairs are stacked parallel to one another with inter-base-pair distance of 3.2 A and the helix diam eter of 19 A. W hen m olecules are dried, the bases become severly tilted o the helix axis and the helical diam eter becom es broad (23 A) [13]. The molecular structure of the samples was transformed between the dry A-DNA and the wet, natural B-DNA states by adding or rem oving water from the sam ples. In their driest states, N aD N A and M gD N A sam ples contained < 0.1 and $0.3 \ lof H_2O$, respectively. At each stage of rehydration and/or dehydration the quartz capillaries were sealed to maintain the water content constant and the magnetization and the molecular structure (via micro-Ram an spectroscopy) were studied in parallel. Figure 1a shows the magnetization (M) of NaDNA with < 0.1,




Figure 2: Evolution of R am an spectra on N aD NA: The left panel shows the evolution of R am an band corresponding to the com plex vibrationalm ode of the backbone network along the chain (5'C \rightarrow P \rightarrow C 3'). This band shifts from 807 cm⁻¹ in A \rightarrow D NA to 835 5 cm⁻¹ in B \rightarrow D NA. The right panel shows the band associated with the sym m etric stretching of the PO₂ m olety m ode. This band shifts from 1100 cm⁻¹ in A \rightarrow D NA to 1092 cm⁻¹ in B \rightarrow D NA [14].

1.9 l of water as a function of temper-0.9 and ature (I) at 5 Tesla. Originally, the sample contained 0.9 lof H_2O . Then the water content was increased to 1.9 land nally dried down to 0.1 l. By subtracting the water contribution from the total magnetization at T > 100 K, we have extracted the diam agnetic susceptibility of DNA, DNA = -0.630.1 10 6 EMU $G^{1}g^{1}$. W ithin the experimental accuracy, the diam agnetic susceptibility was found to be independent of water content, that is, A D N A = B D N A. This value, determined from two NaDNA samples, is in fair agreem ent with the calculated atom ic diam agnetic susceptibility of DNA, -0.52 10 ⁶ EMU G¹g¹. At tem peratures below 20 K, the m agnetization of NaDNA containing 1.9 and 0.9 l of H₂O indicate unexpected param agnetic up-turn that disappeared once the sam ple was dried to H₂O < 0.1 l. Figure 1b portraying M (without H₂O contribution) as a function of m agnetic

eld (H) at T = 2 K clearly presents this low temperature param agnetism . At helium tem perature, DNA in aqueous environm ent exhibits a m agnetization crossingover from diam agnetic to param agnetic that is non linear in magnetic eld. The magnitude of this paramagnetic increase, M_{para} = M_{tot} M_{dia}, is comparable to that of the diam agnetic contribution of DNA. The corresponding Ram an spectra depicting the structural transform ation from A-to B structure in NaDNA are presented in Fig. 2 [15]. Am ong the large and highly reliable index of Ram an bands corresponding to vibrationalm odes of DNA geom etry and conform ations [14], we concentrate on two bands representing the backbone vibrations to identify the structural state of our samples as described in the qure caption. W hile with $< 0.1 \ lof H_2O$, sample was found almost purely in A-state, with 0.9 1, B-DNA as wellas a sm all signature of A-DNA were observed. W ith further addition of H₂O, molecules were found entirely in

well as a sm all signature of A-D NA were observed. W ith further addition of H_2O , molecules were found entirely in the B-state. By comparing the molecular structure and them agnetization of NaD NA, it appears that B-D NA is a prerequisite condition for the low temperature param agnetism in D NA. It needs to be noted, how ever, that once the relative hum idity, RH (the weight of H_2O divided by that of dry D NA) exceeds 0.9, the D NA molecules assume B-D NA state [16]. RH = 0.9 corresponds to 0.36 l of H₂O in our sample, far less than the nom in al am ount of 0.9 l used here. This observation indicates that H_2O is not di used uniform ly due to the sample geometry and the preparation method. The more rigorous investigation on the water content and the structural analysis on N aD NA samples via X-ray di raction will be reported elsew here.




Figure 3: M vs. H of M gD NA sample measured at T = 2 K. The data presented here are treated in the same manner as in Fig. 1b. Inset: M as a function of temperature of wet M gD NA at H = 1T. D otted line represents the t to the Curie law, M (T) = C H = T, with C (the Curie constant) = 4.3 0.2 10 9 J K/ \hat{T} corresponding to 10^{15} spins of s = 1/2.

In MgDNA sample, we were unable to remove H_2O su ciently to create predom inantly A-DNA state. In fact, the Raman spectra (not shown) of the MgDNA in its driest state (0.3 1) indicated mainly B-DNA bands, and with $0.5 \log H_2O$ the molecules were found to be in purely B-DNA state. This is in marked contrast with NaDNA where the presence of A - and B - DNA were both detected at much higher water content. This observation is consistent with a known property of M g^{2+} , i.e., that prevents the transition from B-to A-DNA more e ciently than Na^+ ions [17]. The magnetization measurements on M qD NA with $0.5 \ lofH_2O$ preceded the measurements with 0.3 l. As can be seen from Fig. 3, a purely diam agnetic behaviour at low tem peratures was never achieved in MgDNA in line with the observation in NaDNA. In the driest state, only a slight decrease in

M $_{para}$ was detected. Furtherm ore, the param agnetic m agnetization was found to become independent of wa-

ter content for H_2O values higher than 0.5 1 (m easured up to 2.2 l). Tem perature dependence of the m agnetization of wet M gD NA follows the Curie law as shown in the inset. Susceptibility at higher tem peratures was determ ined to be -0.8 0.1 10 ⁶ EM U G ¹g ¹, larger than the value found for NaD NA sam ple. This di erence (0.2 10 ⁶ EM U G ¹g ¹) corresponds to the diam agnetic susceptibility of the residual bu erions (M gC $\frac{1}{2}$

and NH_4 -Accetate). It is also noteworthy that the low temperature M_{para} was found to be 4 times higher in M gD NA than in NaDNA.

The apparition of param agnetism in B-DNA at low temperature that is non-linear in applied eld is robust. There are two possible origins for the observed non-linear param agnetism : electron spin (s) and orbital m agnetism. A ssum ing the electron spins (m agnetic ions or hydroxyl radicals [18], for exam ple) to render the observed behaviour, we have t the param agnetic com ponent of the magnetization, M $_{para}$, to the B rillouin and C urie law. The best ts were obtained for s= 1/2 3/2 with the total number of spins of 10^{15} for N aD NA and

4 10¹⁵ for M gD NA, respectively. Such high concentrations of spins should be detectable by Electron Paramagnetic Resonance (EPR) provided that the signal line width does not exceed 300G. The exam ination via EPR [19] revealed no such presence in NaDNA at room tem perature. The MqDNA sample was examined between room temperature and 4 K. The only EPR absorption signal was detected at g = 4.28 which can be attributed to Fe^{3+} (s= 5/2, g = 30/7) in an asymmetric crystal eld. The num ber of these spins was determ ined to be of the order of 10^{12} , far too sm all to be responsible for the observed M para [20]. Furtherm ore, the m agnetization of H₂O used to hum idify the sam ples was exam ined separately using SQUID m agnetom eter. 2 lof H_2O , was found to contain M_{para} (5 T, 2 K) less than 10⁶ EMU. Therefore these experiments as well as the disappearance of param agnetic component in A-DNA after the drying process exclude free radicals and m agnetic in purities in water and bu er solutions from the possible origins of low tem perature param agnetism .




Figure 4: (a) Schematic view of a mesoscopic ring ux in perpendicular magnetic eld H. (b) Shape of orbital magnetization as a function of magnetic eld in the non-linear regime. (c) Simpli ed picture of a persistent current path inside and along the helical length of a B-DNA molecule involving interstrand charge transfer.

Thus far, the param agnetism appears to be an intrinsic property unique to B-DNA. An interesting possibility is the existence of persistent current loops along the DNA molecules on a mesoscopic micron scale. The mesoscopic orbitalm agnetism has been shown theoretically to be param agnetic and non-linear when repulsive electronelectron interactions dom inate over single particle e ects [21, 22]. The total $m_{\rm b}$ agnetization of the system then followsm (H) = $\frac{\sum_{k} k_{F} \frac{V}{S(T)H_{i}}}{1 + \left(\frac{H S(T)}{C}\right)^{2}}$, where $_{\rm L}$ is the Landau susceptibility, and k_F is the Ferm i wave number. The non-linear magnetization reaches its maximum at H_{o} = $_{\circ}$ =S (T), where $_{\circ}$ = h=e = 4.14 10 ⁷ G cm² is the magnetic ux quantum and S (T) is the maximum surface area enclosed inside the coherent current loop (Fig. 4(a) and (b)). The orbital magnetism associated to the persistent currents has been already observed in m esoscopic rings and 2-D squares and is considered the hallm ark of phase coherent transport at low tem peratures [23]. In our DNA samples measured at 2K, the magnitude of param agnetic signal is 2 4 times that of the total diam agnetic susceptibility. At lower tem peratures the size of orbital param agnetic susceptibility is expected to grow rapidly. W e estim ate the electron coherent length, L, using the experimental values from our measurements, $H_{0} = 1$ 2 Tesla, via S (T) = d L (T) where d is the distance between bases of B-DNA molecules. Our calculation yields the electron path on the order of 1 m along the helicalaxis of the molecules. Such circulation of electrons enclosing a nite ux can be achieved through the com bination of intra- and interstrand (across the hydrogen bonds) transfer of electrons on bases (Fig. 4c). Hydro-

gen bond assisted electronic exchange has already been witnessed in some organic molecules [24]. The value of the electron path found here agrees with the coherent length of 1 m in -DNA determined by K asum ov et al. [3] where proximity induced superconductivity was detected at T < 1 K. Our observation may also im ply a coherent electron transport along the helical length of the molecule at low temperatures, but exclusively in B-DNA, consistent with experimental reports on the DNA electronic conductivity that showed higher conductivity in wet-DNA molecules [25, 26]. Lastly, from the enhanced size of the low temperature param agnetic signal as well as the persistence of B-DNA in MgDNA, Mg²⁺ appears to facilitate the electron transfer inside DNA molecules.

In sum m ary, we have found a low tem perature, nonlinear param agnetic behaviour in the B-state of -DNA m olecules. This e ect is found in both DNA samples prepared with N a⁺ and M g²⁺ counter ions. The param agnetic susceptibility of m olecules prepared with M g²⁺ ions is found larger by a factor of 4 com pared to the N a⁺ counterpart. The present results can be interpreted by the existence of a m esoscopic orbital param agnetism in B-DNA m olecules that m ay be related to the proxim ity induced superconductivity observed in these m olecules. M agnetization of other types and aligned DNA m olecules should be exam ined in order to con m the orbital origins of this param agnetism .

- [12] Samples were obtained from New England Biolabs and Amersham Bioscience (500 g/mlwith 10mM Tris-HCl and 1mM EDTA). NaDNA: The original solution was diluted in 10 m lof 60/40 H₂O /Isopropanol solution containing 0.3 M of NaCl for co-precipitation. The solution was then centrifuged at 15 kG and at 4 $^{\circ}$ C for 35 m inutes. The precipitate was rinced in 70% Ethanoland was centrifuged again at 15 kG and at 4 $^{\circ}$ C for 15 m inutes. This procedure was repeated twice to remove the excess Na⁺ ions. MgDNA: The original solution was replaced by $9 \text{ mM} \text{ MgC} \frac{1}{2} / 20 \text{ mM} \text{ NH}_4$ -acetate bu er solution by dialysis. This solution was concentrated via centrifuging through M icrocon (M illipore) lter, down to 5 m g/m l, then lyophilized for 2 hours at room tem perature. The H_2O content of the samples were controlled by injection (M illi-Q distilled and deionized $H_2O_1 > 18 M$) or by evaporation at 45 - 55 °C (48 hours for N aD N A and over one week for M gD NA sam ples). Quartz capillary tube sample holders were obtained from Heraeus (2 mm O D .and 1 mm ID .). The H $_2\text{O}$ amount was determined using a precision scale (0.1 g). Sam ples were suspended by capillary force at the m id-height of the capillary tube.

- [15] The Ram an spectra were obtained with 514.5 nm excitation line of an Ar⁺-Kr⁺ laser in confocal micro-Ram an conguration with 10 magnication. The scattered light was analysed using a Jobin-Y von triple grating spectrom eter (T 64000) consisting of a holographic notch lter and liquid nitrogen cooled CCD detector. The radiation power at source was between 3 and 10 mW. Ram an spectra were taken at several regions within the sam ple. Spectra shown here are the accumulated averages of 10 exposures of 30-60 seconds each. The elective spectral resolution was less than 1 cm⁻¹.
