# Quantum phases in mixtures of ferm ionic atom s

### Abstract

A mixture of spin-polarized light and heavy fem ionic atom s on a nite size 2D optical lattice is considered at various temperatures and values of the coupling between the two atom ic species. In the case, where the heavy atom s are in mobile in comparison to the light atom s, this system can be seen as a correlated binary alloy related to the Falicov-K in ball model. The heavy atom s represent a scattering environment for the light atom s. The distributions of the binary alloy are discussed in terms of strong- and weak-coupling expansions. We further present numerical results for the intermediate interaction regime and for the density of states of the light particles. The numerical approach is based on a combination of a M onte-C and simulation and an exact diagonalization method. We nd that the scattering by the correlated heavy atom s can open a gap in the spectrum of the light atom s, either for strong interaction or sm all temperatures. Recent experimental progress in preparing and measuring clouds of ultracold atoms in magnetic traps has opened a new way of studying bosonic and fermionic many-particle quantum states. Among them are condensed and M ott-insulating states of bosons in optical lattices (see e.g. [1], [2], [3], [4]). In comparison with similar studies in solid-state physics, atom ic clouds enable us to design new many-particle systems by mixing di erent types of atoms [5], [6], [7]. These mixtures can form new quantum states due to the competition between the di erent types of atom s. In this paper we propose a mixture of light fermionic (e.g. <sup>6</sup>Li) atoms and heavy fermionic (e.g. <sup>40</sup>K) atoms, and study its low-temperature behavior in a (nite) optical lattice. We assume that the cloud of this mixture is prepared in a magnetic trap such that the atom s are spin polarized.

The di erence of the masses of the two types of atom s in plies two di erent and wellseparated time scales for their tunneling processes through the optical lattice. The relatively fast tunneling processes of the light atom s sets the relevant scale for the dynamics of the mixture. In contrast, the relatively slow tunneling processes of the heavy atom s are dynamically irrelevant and lead only to statistical uctuations which drive the system towards equilibrium. The latter will be discussed by the fact that the heavy particles form Ising-like (para-, ferro- and antiferrom agnetic) states. They provide a scattering environment for the light atom s. Form ally, this physical picture leads to the Falicov-K in ball model which has been used to describe complex solid-state system s [8, 9, 10, 11, 12]. A numerical study of the two-dimensional Falicov-K in ballmodel, based on exact diagonalization, has revealed the possibility of a discontineous transition between ordered and disordered phases [10]. In the follow ing we will use analytic methods as well as a combination of exact diagonalization and M onte-C arlo simulations to study large two-dimensional clusters for a better understanding of the underlying physics.

The paper is organized as follows: In Sect. 2 the model is brie y discussed, based on a functional-integral representation. A mapping to a binary-alloy model is described in Sect. 3. This gives the foundation for our analytic treatment, based on weak-and strong-coupling expansions, and for the construction of our num erical method. The num erical approach is used to evaluate the distribution of the heavy atoms and the density of states of the light atoms.

The atom is degrees of freedom are given in second quantization by local creation and annihilation operators. In the case of spin-polarized ferm ionic atom s we use  $c_r^y$  ( $c_r$ ) and  $f_r^y$  ( $f_r$ ) as the creation (annihilation) operators for the light and the heavy ferm ionic atom s, respectively, where r denotes the coordinates of the site in the optical lattice. The light atom s can tunnel with tunneling rate t, and we assume that the tunneling rate of the heavy atom s is so sm all that we can neglect it. M oreover, there is only a local interaction between the atom s in the optical lattice, i.e. only atom s in the same potential well notice each other. Since the atom s are spin-polarized ferm ions, there can be at m ost one atom per sort in each potential well, thanks to Pauli's principle. The interaction strength between light and heavy atom s is U. This allow s us to write the many-particle H am iltonian as

where  $hr; r^{0}i$  m eans pairs of nearest-neighbor lattice sites. We have assumed the same chem – ical potential for both types of atom s. This may not be very general but will serve for the purpose of studying competing quantum phases in the atom ic mixture. The model de ned in Eq. (1) is also known as the spinless Falicov-K im ballmodel [8, 9, 10, 11, 12]. It is known to describe ordered phases and phase transitions for correlated electronic systems and was recently investigated intensively in the limit of in nite dimensions [9]. We will study this model in the following for a nite lattice, using a correlated binary-alloy (CBA) approach.

#### Functional-Integral R epresentation

A grand-canonical ensemble of a mixture of light and heavy fermionic atom s at the inverse temperature =  $1=k_B T$  can be de ned by the partition function

where Tr is the trace with respect to all m any-particle states in the optical lattice. The G reen's function for the propagation of a light particle in the background form ed by the heavy atom s in imaginary time t is

These expressions can also be written in terms of a functional integral on a Grassmann algebra [13]. For the latter the integration over a Grassmann eld (r;t) and its conjugate

The discrete time is used with t = ;2; :::;, in plying that the limit ! 0 has to be taken in the end and  $^{0} = =$  is the number of time steps. (r;t) and (r;t) are independent G rassmann elds which satisfy antiperiodic boundary conditions in time (r; + ) = (r; ) and (r; + ) = (r; ). For the subsequent calculations it is convenient to rename (r;t) ! (r;t+) because then the G rassmann eld appears with the same time in the H am iltonian of the action (3).

#### THE CORRELATED BINARY ALLOY

The functional integration in Z and G can be performed in several steps, beginning with the integration of the heavy atom ic eld  $_{\rm f}$ , introducing the Ising spins and nally integrating the light atom ic eld  $_{\rm c}$  [15]. The details of this procedure are described in Appendix A.As a result we obtain for the partition function

The parameters are  $U^0 = U$ , = 1 +, and  $\hat{t}$  is the tunneling term multiplied by . Moreover,  $\theta_t$  is the time-shift operator. The Ising spin S (r) corresponds with a local occupation number  $n_f(r)$  of the heavy atom s as

The Green's function is now an averaged resolvent

The distribution is not  $Z_2$  invariant (i.e. invariant under a change S (r) ! S (r)), except for a half-led lattice (i.e. = U=2).

The representation of the G reen's function in Eq. (6) is our main analytic result. It means that the light particles tunnel through the optical lattice where they are scattered by the heavy particles. The distribution of the heavy particles is given by the distribution shown in Eq. (7). The latter depends on the temperature but also on the parameters of the light particles like t and the coupling U between the light and the heavy particles. This re ects the intim ate relationship between the two types of particles. In other words, the light particles move in a random potential form ed by the heavy particles. This random ness, form ally expressed by the Ising spins, is correlated and can be called correlated binary alloy (CBA). There is a correlation length which diverges at the phase transitions of the Ising system. In the subsequent investigation we will study these phases and their implications for the properties of the light particles.

The symmetric matrix  $\hat{t} + (U^0=2)(1+S)$  can be diagonalized with eigenvalues 1 j. Then the determinant in Eq. (8) is for 0

Since the matrix depends on the uctuating Ising spins, it is dicult to determ ine the eigenvalues. One way to get an idea about the physics of this model is to study the asymptotic regimes of strong and weak coupling, another one is to use a numerical diagonalization procedure. Both approaches shall be applied subsequently.

Approxim ations of the CBA D istribution

The distribution was studied in the case of strong coupling (i.e. the tunneling (or U<sup>1</sup>) expansion) in a number of papers [14, 15]. It leads at half-lling to an Ising model with  $Z_2$  symmetry. In the following we study the CBA distribution in weak and strong-coupling approximations as well as numerically by a Monte-Carlo simulation. The density of states of the light atom s are evaluated by a numerical procedure.

System without Tunneling

The absence of the  $Z_2$ -symmetry can be observed already in the absence of tunneling. Then we have in the limit ! 0

Thus only for 0 < < U the Ising state is param agnetic. The other regimes are ferromagnetic. In terms of the congurations of the heavy atoms there are no heavy atoms for

< 0 and a heavy atom at each site for > U. In the intermediate regime 0 < < U we anticipate that the coupling of neighboring Ising spins, caused by a non-zero tunneling rate t, will lead to ordered Ising spins at low temperatures.




FIG.1: A verage spin for a system without tunneling: U = 1 and = 10.

Tunneling Expansion

The e ect of a weak tunneling rate can be evaluated in terms of a perturbation theory with respect to t. Moreover, we take the lim it ! 0 and consider the asymptotic regime of low temperatures (i.e. 1). If we include tunneling terms up to order 0 (t<sup>2</sup>) we get for = U=2 the Ising model with nearest-neighbor spin interaction:

This model has an antiferrom agnetic low-tem perature phase. The spin-spin coupling is exponentially small in for < 0 and > U but of order  $t^2=U$  for 0 < < U. In particular, we can distinguish three di erent regimes:

Besides the two ferrom agnetic regimes for < 0 and > U we have the intermediate regime 0 < < U with antiferrom agnetic ordering. There is an exponentially small magnetic eld

for  $\notin$  U=2 which breaks the Z<sub>2</sub> symmetry. As we approach = 0 or = U the magnetic eld becomes larger. There is a rst order transition from the antiferro-to a ferrom agnetic phase when the magnetic eld starts to dominate the spin-spin interaction. This can be seen in a simple mean-eld approximation.

The Weak-coupling Lim it

In the case of weak coupling we can perform an expansion in terms of the coupling parameter U. This gives in leading order an uncorrelated binary alloy:

The Density of States




FIG. 2: Param agnetic Ising-spin con guration for t = 1, U = 3; = U=2, and = 3. White (black) squares refer to sites (un)occupied with a heavy atom.

The density of states (DOS) for the light particles can be obtained from the diagonal elements of the Green's function in Eq. (6). Its qualitative behavior depends strongly on the state of the heavy particles: In the case of a ferror agnetic state the DOS shows a single band, for the antiferror agnetic state it has a gap. For a param agnetic state of the heavy particles the form of the DOS is less obvious. We have calculated the DOS numerically for a 18 18 square lattice with open boundaries. For this purpose we have generated con gurations of the Ising spins according to the distribution function in Eq. (7), using the M etropolis algorithm. Typical con gurations with large statistical weight are shown in Figs. 2-5 for di erent values of the physical param eters U, , and .

For a given con guration fS (r)g of Ising spins the Ham iltonian




FIG. 3: M ixture of para- and antiferrom agnetic Ising-spin textures for t = 1, U = 3; = U=2,and = 7

where N is the number of lattice sites. Finally, the DOS related to the G reen's function in Eq. (6) is determined by averaging over L = 100 spin con gurations:




FIG.4: A ntiferrom agnetic Ising-spin conguration for t = 1, U = 3; = U = 2, and = 14




FIG.5: Ferrom agnetic Ising-spin conguration for t = 1, U = 8; = 0.8U, and = 14

In the following the hopping rate is set to t = 1.




FIG.6:DOS for U = 3; = U=2 (half lling) and di erent tem peratures.First row: = 3; =

Fig. 6 shows the DOS of the light particles for U = 3 and half lling (i. e. = U=2) at di erent temperatures. For small , i. e. high temperatures, the system shows a gapless m etallic band, which is symmetric around the Ferm i level, and the Ising spins form a param agnetic state. The DOS is slightly suppressed at the band center due to the interaction between the light and the heavy atom s. W hen the temperature is decreased, the Ising spins start to order antiferrom agnetically, i. e. the heavy atom s create a chessboard-like phase with empty sites. This is accompanied by the form ation of a gap around the Ferm i level and a strong enhancem ent of the DOS at the inner band edges. Very similar results were

found in a dynam ical cluster approximation on an 8 8 cluster [16].




FIG.7:DOS for = 3 at various values of the interaction U and half-lling ( = U=2). First row: U = 1; U = 4;:Second row: U = 6; U = 8:

The high-tem perature regime of the system at half lling is depicted in Fig. 7 for various interaction strengths U. For sm all interaction the DOS shows a metallic band and is peaked around the Ferm i level. For increasing U this peak gets suppressed and a band splitting to two symmetric bands occurs. The spectral weight within these subbands is highest at their center. A further increase of U leads to a shift of the lower and upper band to lower and higher energies, respectively.




FIG. 8: DOS for = 14; U = 3 (solid), U = 8 (dashed) and dimensional values of the chemical potential. First row: = 0.6U; = 0.7U: Second row: = 0.8U; = 0.9U:

Figure 8 shows the DOS in the low-temperature regime for two values of the interaction strength (U = 3, solid and U = 8, dashed) and di erent values of the chemical potential. For the latter the distribution (7) has no  $Z_2$  symmetry, i.e. is not invariant under a global spin ip S ! S. Near half lling the heavy atoms order in a chessboard con guration. This behavior is stablized for larger deviations fom = U=2 when the interaction strength is increased. As deviates even further from U=2 the Ising spins start to order ferrom agnetically. The spectral weight locally shifts to the center of each subband and globally shifts from the lower to the upper band. For the completely ordered Ising spins the lower band disappears and the system has only one band.

## CONCLUSIONS

A mixture of light and heavy fem ionic atom s is studied as a system in which the light atom s live in a correlated disordered environment. This environment is formed by the heavy atom s. The disorder is given by uctuating Ising spins with a complex temperaturedependent distribution. This distribution is  $Z_2$  (spin-ip) invariant only at half lling (i.e. = U=2) but has a broken spin-ip symmetry for  $\neq U=2$ . This symmetry breaking favors an Ising spin  $S_r = 1$  at low density (i.e. < 0) and  $S_r = 1$  at high density (i.e. > U). There is an intermediate regime where an antiferrom agentic (staggered) Ising-spin con guration is favored. Scattering on these con gurations opens a gap in the band of the light atom s.
