On the Cut-O Prescriptions Associated with Power-Law Generalized Thermostatistics

Abstract

We revisit the cut-o prescriptions which are needed in order to specify completely the form of T sallis' maximum entropy distributions. For values of the T sallis entropic parameter q > 1 we advance an alternative cut-o prescription and discuss some of its basic mathematical properties. As an illustration of the new cut-o prescription we consider in some detail the q-generalized quantum distributions which have recently been shown to reproduce various experimental results related to high T_c superconductors.

I. INTRODUCTION

There is a growing body of evidence [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25] indicating that there are important systems and processes in physics, biology, economics, and other elds, which are described by statistical distributions of the T sallis' maximum entropy form. These distributions are obtained from the extremalization of T sallis' entropic functional under the constraints imposed by normalization and the mean values of a (in general small) set of relevant quantities which are regarded as input information. The T sallis entropic measure is given by [26]

where k is a positive constant (from here on set equal to 1), w is the total number of m icrostates in the system, fp_i ; i = 1; ::: ; w g are the associated probabilities, and the T sallis param eter q is any real number. It is straight forward to verify that the usual Boltzmann-G ibbs (BG) logarithm ic entropy, $S = \int_{i}^{p} p_{i} \ln p_{i}$, is recovered in the lim it q! 1. T sallis maximum entropy distributions have been found to be relevant, for instance, in various astrophysical scenarios [1, 2] and in the study of the phenom enon of non-linear di usion [3, 4,5]. The description of the behaviour of chaotic maps at the threshold of chaos constitutes another successful eld of application for the T sallis formalism [6, 7, 8, 9, 10, 11]. It is im portant to stress that some of the aforem entioned developm ents involve a quantitative agreem ent between experim ental data and theoretical models based on T sallis maximum entropy distributions. For instance, it was experimentally found that pure electron plasmas in Penning traps relax to metastable states whose radial density proles do not maximize the Boltzmann-Gibbs entropy [12]. However, Boghosian showed that the observed proles are well described by a T sallis distribution with q close to 1=2 [13]. Beck's recent investigations on fully developed turbulent ows constitute another interesting application [14, 15, 16, 17]. General overviews on T sallis' form alism and its diverse applications can be found in [22, 23, 24]. An updated bibliography is available in [25].

The form alsolutions to Tsallis' maximum entropy variational problem, the so called q-maxent distributions, are not always positive real numbers. In order to guarantee the real and positive character of these q-maxent distributions it is necessary to introduce appropriate cut-o prescriptions. The aim of the present work is to discuss one possible cut-o

prescription for the case of T sallis parameter q > 1. Recent studies by various authors suggest that there are two classes of non-extensive descriptions, corresponding, respectively, to q < 1 and q > 1. For instance, earlier applications to low-dimensional dissipative maps at the edge of chaos yield q-values less then 1 [6], while it was latter realized that there is another class of q-values greater than 1 [8]. A similar situation occurred in the case of turbulence [17, 18]. So far the q < 1 case has been studied in greater detail, and is consequently better understood, than the q > 1 case. We believe that the present work may contribute to a deeper understanding of this latter case.

The paper is organized as follows. In section II we review the T sallis cut-o prescription. In section III we propose an alternative prescription for the case q>1. In section IV we illustrate our prescription with a q-generalized Ferm i-D irac distribution and we prove that, in this case, the present prescription leads to a thermodynam ically consistent formalism. Some conclusions are drawn in section V.

II. TSALLIS'CUT-OFF PRESCRIPTION

When, in addition to normalization, one only has the mean energy constraint, T sallis' distribution can be parameterized as [27]

where q is a real number (T sallis' parameter), $_i$ is the energy of microstate i, and the partition function Z_q is an appropriate normalization constant. This distribution can be regarded as the q-generalization of the G ibbs canonical distribution. In order to guarantee that the microstates probabilities p_i are non-negative real numbers, it is necessary to supplement expression (2) with an appropriate prescription for treating negative values of the quantity under square brackets. That is, we need a prescription for the value of p_i when

The sim plest possible prescription, and the one usually adopted, is to set $p_i = 0$ whenever inequality (3) holds [26, 27]. This rule, usually referred to as \T sallis' cut-o prescription", may seem at rst sight just an ad-hoc solution to the above \negativity issue". However, in many species seemarios, T sallis' cut-o prescription turns out to be a physically sensible

one. It is instructive to mention a few examples. In the polytropic models of self-gravitating N-body systems, which are described by T sallis' maximum entropy distributions, the cut-ocorresponds to the escape velocity from the system [28]. Other interesting examples involve the so-called q-gaussian distributions,

which reduce to the standard gaussian distribution in the limit q! 1. For q < 1 there are important non-linear disusion and Fokker-Planck equations, with multiple applications in diverse elds, which admit exact analytical solutions of the q-gaussian form with the T sallis cut-o [3, 4, 5]. Finally, it is possible to construct one dimensional quantum mechanical potential functions, exhibiting interesting properties related to shape invariance and, again, admitting exact ground state wave functions of the q-gaussian form with the T sallis cut-o [29]. It is clear from the above examples that T sallis' cut-o prescription is indeed a physically reasonable one. This prescription may not constitute, however, the complete and nal answer to the negativity issue. In order to clarify this, we have set to realize that T sallis' prescription covers two very diserent situations:

- (a) When q < 1 there is a special (positive) value of the quantity , ($_c$) for which the probability distribution becomes zero. In this case the probability distribution is set equal to zero for > ($_d$). With this prescription the probability distribution remains a continuous function of . Even the rst derivative of p with respect to is, for a certain range of q-values, continuous at the cut-opoint.
- (b) When q > 1 a completely dierent picture obtains. Now there is a particular (negative) value of , (), such that when approaches () from the left p!
 +1. In this case T sallis' cut-o rule prescribes that p is to be set equal to zero for all < ().

Two comments are in order. First of all, most of the concrete physical realizations of Tsallis' cut-o that have so far been studied (and, in particular, the three examples previously mentioned by us) correspond to the q < 1 (case (a)) instance. Secondly, the cut-o prescription is much less palatable in case (b) than in case (a). In the latter case, p() is a continuous function while in the former case it jumps from +1 to 0 at the cut-o

point. The main aim of our present contribution is to discuss a possible alternative to the q> 1 case of the cut-o prescription.

III. ALTERNATIVE CUT-OFF PRESCRIPTION FOR q> 1.

T sallis' maximum entropy distributions can be conveniently written in terms of the qgeneralized exponential function

Notice that this last expression contains T sallis' cut-o condition, which is absorbed into the de nition of the q-exponential function $e_q(x)$. In terms of the q-generalized exponential, T sallis' distribution is

We are going to introduce now an alternative generalization $e_q(x)$ of the exponential function, de ned in the following way. For q < 1 we set $e_q(x) = e_q(x)$. And for q > 1, we propose

The function $e_q(x)$ has, for q > 1, some desirable properties. First of all, $e_q(x)$ complies with the \exponential-like" relation

On the other hand, $e_q(x)$ is clearly continuous at x=0 (See Figure 1). Furtherm ore, we have

im plying that $\frac{d}{dx}e_q(x)$ is, for q > 1, continuous at x = 0.

Now, the alternative cut-o prescription that we want to consider is tantam ount to adopting for the q-generalized G ibbs ensemble a distribution of the form,

The generalized exponential function $e_q(x)$ allows them to express our cut-o prescription, and the corresponding generalization of the canonical distribution in a compact form. Our aim in the present Letter is to explore some important physical consequences of our cut-o prescription. In particular, we want to address its therm odynamic consistency. It would be interesting to investigate in detail the mathematical properties of the function $e_q(x)$ but, of course, that is not our aim here. For our present purposes we only need the basic features of $e_q(x)$ already mentioned. A similar situation arose in the case of Tsallis' generalized exponential $e_q(x)$: this function was introduced as a compact and elegant notation for Tsallis' maximum entropy distributions. The extensive literature on the purely mathematical properties of $e_q(x)$ only appeared afterwards.

IV. THE GENERALIZED FERM I-D IRAC DISTRIBUTION.

A. The Standard M axim um Entropy Principle for Quantum D istributions

The quantum mechanical distributions can be obtained from a maximum entropy principle based on the entropic measure (the upper signs corresponding to bosons and lower one to ferm ions) [30, 31, 32]

where n_i denotes the number of particles in the i^{th} energy level with energy i. The extrem alization of the above measure under the constraints imposed by the total number of particles,

and the total energy of the system,

leads to the standard quantum distributions,

$$n_i = \frac{1}{\exp(i_i) - 1}$$

In the above equation the m inus sign corresponds to the Bose-E instein distribution and the plus sign corresponds to the Ferm i-D irac one.

B. The Nonextensive Maximum Entropy Principle for Fermions

In order to deal with non extensive scenarios (characterized by $q \in 1$) we propose the extended measure of entropy,

That the entropic functional (15) constitutes a natural generalization of (11) can be easily realized if we express it in terms of the so-called \q-logarithms",

where the q-logarithm is de ned as [23, 24, 25]

In the lim it q! 1 (16) reduces to (11). However, the main physical motivation for introducing the measure (15) is that it leads, via the maximum entropy principle, to quantum distribution functions that have been very successful in the study of a concrete and important physical phenomena: high T_C superconductivity [21]. Furthermore, as we shall presently explain, the formulation of a variational principle in terms of (15) allows to prove the thermodynamical consistency of the cut-o prescription used in [21].

The relevant constraints leading to the q-generalized quantum distributions are the total number of particles,

The extrem alization of the entropic measure (15) under the constraints (18) and (19) leads to the variational problem

whose form alsolution is

$$n_{i} = \frac{1}{1 + [1 + (q 1)(+ _{i})]^{\frac{1}{q-1}}};$$

where and are the Lagrange multipliers associated, respectively, with the total number of particles and the total energy. Notice that we are using here un-normalized q-constraints, instead of using the normalized q-constraints studied in [33]. Within the present context it is not necessary to use the normalized q-values, because our variational problem is formulated in terms of mean occupation numbers. These numbers are not probabilities and, consequently, do not need to be normalized. Furthermore, both constraints, the one associated with the total number of particles, and the one corresponding to the total energy, are formulated using the same kind of q-values. This allows to re-formulate the variational problem in terms of standard linear constraints and to prove that the invariance under uniform shifts of the (single-particle) energy spectrum still holds (see reference [32] for details).

Quantum distributions of the form (21) have been studied by many researchers in recent years [21, 34, 35, 36, 37, 38, 39, 40]. Now, the form alsolution (21) needs to be supplemented with an appropriate cut-o prescription to deal with negative values of the quantity + $_{i}$. For q > 1, our cut-o prescription is tantam ount to adopt in expression (21) a new value of q[32],

It is interesting to notice that the transform ation (22) also arises in other contexts as, for instance, in the study of renormalization-group dynamics at the onset of chaos in logistic maps [10].

Them ost basic requirem ent of a therm ostatitistical form alism is to be therm odynam ically consistent. That is, the therm ostatistical form alism must lead to the standard therm odynam ical relationships among therm odynam ical variables such as entropy, energy, tem perature, etc [33, 41, 42, 43]. We are now going to prove that this is indeed the case with our present form alism. Let us consider the entropic functional

where the function $C_q(x)$ is de ned by

The function $C_q(x)$ is discontinuous at x=1=2 (See Figure 2). In fact, the lim it value of $C_q(x)$ when we approach x=1=2 from the right is

while the \lim it value when $C_q(x)$ is approached from the left is,

However, the left and right lim it values of the rst derivative $dC_q=dx$ at x=1=2 are both equal to 0. That is, the rst derivative $dC_q=dx$ is continuous at the cut-o point (See Figure 3).

If we extrem alize the entropic measure (23) under the constraints (18) and (19) we obtain the set of equations

The q-generalized Ferm i-D irac distribution with our new cut-o prescription is depicted, for $q = 1; \frac{4}{3}$, and $\frac{5}{3}$ in Figure 4. For comparison purposes, the q-generalized Ferm i-D irac distribution with the standard cut-o rule is exhibited in Figure 5.

When the variational problem is formulated in terms of the entropic measure (23), the cut-o prescription need not be imposed on the maximum entropy distribution after we obtain the formal solution of the variational problem. On the contrary, the solution of the variational problem already contains the cut-o prescription. We can say that the prescription is incorporated into the denition (23) of the entropic functional itself. In terms of the generalized exponential function (7), our q-generalized quantum distributions for fermions can be written as

Now, it can be shown [44, 45] that any therm ostatistical formalism based upon the constrained extremalization of an entropic functional (that is, based upon Jaynes maximum entropy approach) complies with the thermodynamical relationships (which, in the context of Jaynes' maxent formulation are often referred to as Jaynes' relationships). This implies that the q-generalization of the Fermi-Dirac distribution considered in this work, which incorporates the cut-orule we are here advocating, complies with the thermodynamical

relationships. Similar calculations as the ones we have performed here can be done for the case of bosons, leading to the q-deformed Bose-Einstein distribution,

A comment concerning the status of the q-deformed quantum distributions (31-32) is in order here. This distributions were introduced by Buyukkilic and Demirhan (BD) [34]. BD attempted to derive these distributions in [34] from the full N -body, (-space[31]) qgeneralized grand canonical ensemble, in a manner similar to the standard, q = 1 (BG) case [31]. It is in portant to realize that BD 's derivation does not yield the exact quantum statistics associated with the full N -body, (-space[31]) q-generalized grand canonical ensemble [35]. The BD distributions, which have been used by many people [36, 37, 38, 39, 40], can be regarded only as an approximation. Indeed, numerical evidence has been reported suggesting that, for ferm ions, the BD distributions constitute a reasonable approximation in som e cases [39]. Furtherm ore, a recent BCS s-wave model for high T_c superconductivity, which uses (31) for the quantum distribution functions of the independent quasi-particles [32], exhibits remarkable agreement with the available experimental data if a value of the 1:6 is adopted [21]. This suggests that, at least at some level, such T sallis param eter q quantum distributions might provide a reasonable (-space[31]) description of some quantum many body systems. It is important to realize that a similar state of a airs occurs with many of the other experimental veri cations of the q-nonextensive therm ostatistics. In m ost cases a successful account of the experim ental data has been achieved by recourse to a -space theoretical model [2, 14, 23, 24]. To determ ine the detailed connection between these successful -space descriptions of concrete physical phenomena, on the one hand, and the -space formulation, on the other, still constitutes an open and form idable problem. It, therefore, seems prudent, for the time being, to pay serious attention to the -space treatm ents, whenever they reproduce experim ental data.

V. CONCLUSIONS

A fler considering in detail the usual cut-o prescriptions for the q-m axent probability distributions, and discussing their most important concrete physical realizations, the follow-ing conclusions are inescapable. First of all, the main physical realizations of the standard

cut-o rule correspond to the case q < 1. Secondly, the usual prescription for q > 1 is physically not as interesting classically as the usual cut-o rule for q < 1. In the present e ort we proposed an alternative rule for the case q > 1. We illustrated our proposal with q-generalized quantum distributions that have already been successfully applied to the study of both high T_c superconductivity [21] and the formation of the quark-gluon plasma [40]. In the particular example of the q-generalized quantum distributions we have proved that our cut-o prescription leads to a thermodynamically consistent formalism. Even though we have focused here upon T sallis' generalized thermostatistics, it has not excaped our attention that the present considerations may be also relevant for other non-standard thermostatistical formalisms that have recently been proposed [46, 47].

Further developments and applications of our variable-q T sallis formalism, and the exploration of its relationship with problems, will be greatly welcome.




FIG.1: The generalized exponential function $ex_q(x)$ for q = 1;4=3;5=3. All depicted quantities are dimensionless.




FIG. 2: The function $C_q(x)$, appearing in the de nition of the entropic functional, for q=1;4=3, and 5=3. All depicted quantities are dimensionless.




FIG. 3: The derivative $dC_q(x)=dx$ of the function $C_q(x)$ appearing in the de nition of the entropic functional, for q=1;4=3, and 5=3. All depicted quantities are dimensionless.




FIG. 4: The average ocupation number n_i for the q-generalized Ferm i-D irac distribution (28), which incorporates our new cut-o prescription, as a function of ($_i$) and for the same q-values as in Figures (1-3). All depicted quantities are dimensionless.




FIG. 5: The average ocupation number for the q-generalized Ferm i-D irac distribution with the standard cut-o prescription, as a function of ($_{\rm i}$) and for the same q-values as in Figures (1-3). All depicted quantities are dimensionless.
