# Decon ned Quantum Criticality at the Quantum Phase Transition from Antiferrom agnetism to Algebraic Spin Liquid

We investigate the quantum phase transition from antiferrom agnetism (AF) to algebraic spin liquid (ASL). We propose that spin 1=2 ferm ionic spinons in the ASL fractionalize into spin 1=2 bosonic spinons and spinless ferm ions at the quantum critical point (QCP) between the AF and the ASL. Condensation of the bosonic spinons leads to the AF, where the condensed bosonic spinons are conned with the spinless ferm ions to form the ferm ionic spinons. These ferm ionic spinons are also conned to make antiferrom agnons as elementary excitations in the AF. A pproaching the QCP from the AF, spin 1 critical antiferrom agnetic uctuations are expected to break up into spin 1=2 critical bosonic spinons. Then, these bosonic spinons decay into the bosonic spinons and the spinless ferm ions. As a result the ferm ionic spinons decay into the bosonic spinons emerge at the QCP. This coincides with the recent studies of deconned quantum criticality [1, 2, 3, 4]. When the bosonic spinons are gapped, the ASL is realized. The bosonic spinons are deconned to describe the ASL.

## I. IN TRODUCTION

Nature of quantum criticality is one of the central interests in modern condensed matter physics. Especially, decon ned quantum criticality has been proposed in various strongly correlated electron systems such as low dimensional quantum antiferrom agnetism on square lattices[1, 2, 3, 4, 5, 6, 7, 8, 9] and geometrically frustrated lattices [10, 11, 12, 13] and heavy ferm ion liquids[14, 15, 16, 17, 18]. In the present paper we focus our attention on the quantum antiferrom agnetism in two dimensional square lattices. Starting from the antiferrom agnetic Heisenberg model, one can derive the 0(3) nonlinear model (NLM) as an elective eld theory. Utilizing the CP $^1$  representation of the N L M, one can show that although the appropriate o -critical elementary degrees of freedom are given by either spin 1 excitons (gapped param agnons) in the param agnetism or spin 1 antiferrom agnons in the antiferrom agnetism, at the quantum critical point (QCP) such excitations break up into m ore elem entary spin 1=2 excitations called spinons[1, 2, 3, 4]. This is the precise meaning of the decon ned quantum criticality in the context of quantum antiferrom agnetism .

In the present paper we investigate the quantum phase transition from antiferrom agnetism (AF) to algebraic spin liquid (ASL) based on the decon ned quantum criticality of the O (3) N L M [l, 2, 3, 4]. According to one possible scenario[6], the pseudogap phase in high  $T_c$  cuprates is proposed to be the ASL for spin degrees of freedom. In this respect it is considerable to understand how the ASL emerges from the AF, i.e., the quantum phase transition between the AF and the ASL. The ASL is the state described by quantum electrodynamics in two space and one time dimensions (QED<sub>3</sub>)

in terms of massless Dirac spinons interacting via U (1) gauge uctuations[6]. On the other hand, low energy physics of the AF is well understood by the O (3) N L M in term s of Neel order parameter elds [19]. O ne can say that the AF results from the ASL via spontaneous chiral sym m etry breaking (S SB) [20, 21, 22, 23, 24]. The central question in this paper is the nature of the QCP, where the S SB occurs. Concretely speaking, we exam ine how the Neel order parameter elds in the NL M can be smoothly connected to the ferm ionic spinons in the QED<sub>3</sub> by studying the QCP. We apply the decon ned quantum criticality of the O (3) N L M to the QCP between the AF and the ASL. Approaching the QCP from the AF, critical antiferrom agnetic spin uctuations in the NLM are conjectured to break up into critical bosonic spinons, consistent with the previous studies [1, 2, 3, 4]. Based on this conjecture we propose that the critical bosonic spinons hybridize with the ferm ionic spinons in the Q E D 3 via K ondo-like couplings, screening out spin degrees of freedom of the ferm ionic spinons and thus, making spinless fermions. In other words, it can be stated that the ferm ionic spinons in the ASL fractionalize into the bosonic spinons and the spinless ferm ions at the QCP. In this paper we construct a critical eld theory at the QCP and discuss how the AF and the ASL recover from the critical eld theory.

In the language of high energy physics the present study exam ines the chiral phase transition in QED<sub>3</sub>. In this respect we would like to point out an interesting previous study of the chiral phase transition [25]. In the study [25] the authors calculated a ferm ion-antiferm ion scattering am plitude in order to nd light scalar mesons (ferm ion-antiferm ion com posites) showing up as poles in the scattering am plitude. Approaching the QCP from the symmetric phase (ASL in the context of quantum antiferrom agnetism), the authors could not nd the poles in the scattering am plitude. This leads them to the conclusion that there are no light mesons corresponding to order parameter uctuations. Based on this result they proposed that the chiral phase transition is dierent from usual second order phase transitions described by Landau-G inzburg-W ilson type theories of order parameter uctuations. Our present scenario of the decon ned QCP for the chiral phase transition seems to be consistent with this previous study since the decon ned QCP is not described by uctuations of ferm ion-antiferm ion com posite order parameters owing to spin fractionalization.

# II. FERM ION IC NON LINEAR MODEL AS AN EFFECTIVE FIELD THEORY FOR QUANTUM ANT IFERROM AGNET ISM

We consider the following e ective action called fermionic\_nonlinear model

is a massless D irac spinon with a avorindex  $\ln S_{ASL}$ = 1; :::; N associated with SU (N) spin symmetry. a is a compact U (1) gauge eld mediating long range interactions between D irac spinons. e is an internal electric charge of the D irac spinon.  $S_{ASL}$  in Eq. (1) was proposed to be an elective eld theory for one possible quantum param agnetism (ASL) of SU (N) quantum antiferrom agnets on two dimensional square lattices [6]. However, the stability of the ASL has been suspected owing to instanton excitations of compact U (1) gauge elds[26]. Condensation of instantons (magnetic monopoles) is believed to cause con nem ent of charged particles [27, 28, 29], here Dirac spinons. Recently, Hermele et al. showed that the ASL can be stable against instanton excitations[7]. Ignoring the compactness of U(1) gauge elds a , one can show that the  $S_{ASL}$  has a nontrivial charged xed point in two space and one time dimensions [(2 + 1)D]in the lim it of large avors [7, 8, 9], identied with the ASL. Hermele et al. showed that the charged critical point in the case of noncom pact U (1) gauge elds can be stable against instanton excitations of compact U(1) gauge elds in the lim it of large avors[7]. Condensation of instantons can be forbidden at the stable charged xed point owing to critical uctuations of Dirac ferm ions. The  $S_{ASL}$  in Eq. (1) is a critical eld theory at the charged critical point, where correlation functions exhibit power law behaviors with anom alous critical exponents resulting from long range gauge interactions [9, 30].

This is the reason why the state described by the  $S_{ASL}$  is called the ASL. In appendix A we brie y discuss how the elective QED<sub>3</sub>,  $S_{ASL}$  in Eq. (1) can be derived from the antiferrom agnetic H eisenberg m odel.

However, we should remember that the ASL criticality holds only for large avors of critical D irac spinons. If the avor number is not su ciently large, the internal charge e is not screened out satisfactorily by criticalDirac ferm ions. Then, gauge interactions can make bound states of D irac ferm ions, resulting in m assive D irac spinons. This is known to be spontaneous chiral symmetry breaking (S SB) [20, 21, 22, 23, 24]. In the case of physical SU (2) antiferrom agnets it is not clear if the ASL criticality remains stable owing to the S SB causing antiferrom agnetism . It is believed that there exists the critical avor number N  $_{\rm c}$  associated with S SB in QED<sub>3</sub>[20, 21]. But, the precise value of the critical num ber is far from consensus [21]. If the critical value is larger than 2, the S SB is expected to occur for the physical N = 2 case, resulting in massive spinons. On the other hand, in the case of N  $_{\rm c}$  < 2 the ASL criticality remains stable against the S SB. Experim entally, an antiferrom agnetic long range order is observed in the SU (2) antiferrom agnet. This leads us to consider the S SB in the ASL. In Eq. (1)  $S_M$  represents the contribution of a ferm ion m ass due to the S SB.m is a m ass parameter corresponding to staggered m agnetization. n represents uctuations of Neel order parameter elds regarded as Goldstone bosons in the S SB. ~ is Paulim atrix acting on the spin ( avor) space of D irac spinons. The mass pacan be determined by a <u>self-consistent</u> gap ram eter m  $e^2 \exp[2 = N_c = N_c$ equation, given by m 1] in the 1=N approximation [20]. Varying the avor number N controls the mass parameterm . In the present paper we use the mass m as a controlling parameter of the quantum phase transition. This is analogous to a quantum phase transition in the N L  $\,$  M , where the quantum phase transition is realized by varying the spin sti ness param eter associated with the value of spin in the system [31]. For completeness of this paper we brie y sketch the derivation of dynam ical m ass generation in appendix B. There are additional ferm ion bilinears connected with the Neel state by "chiral" transform ations because the  $S_{ASL}$ in Eq. (1) has more sym metries than those of the Heisenberg m odel[23, 32, 33]. These order param eters are associated with valance bond orders [23, 32, 33]. But, in the present paper we consider only the Neel order parameter in order to take account of the AF described by the O (3) NLM.

Contributions of high energy spinons in  $S_{\rm A\,S\,L}$  +  $S_{\rm M}$  lead to the  $S_{\rm N\,L}$   $_{\rm M}$  in the gradient expansion [24, 32, 34]. This elective action is nothing but the O (3) N L M describing a collinear spin order. In the  $S_{\rm N\,L}$   $_{\rm M}$  we introduced a Lagrange multiplier eld to impose the rigid rotor constraint  $j_{\rm R}\,j^2$  = 1. In appendix C we give a detailed derivation of the N L M . The totale ective action  $S_{\rm A\,S\,L}$  +  $S_{\rm M}$  +  $S_{\rm N\,L}$   $_{\rm M}$  called fermionic N L M in Eq. (1) naturally describes the quantum AF resulting from the

ASL via S SB at half lling. Based on this ferm ionic O (3) N L M we investigate the Q C P of the AF to A S L transition.

In Eq. (1) we concentrate on the K ondo-like spin coupling term n ~ between antiferrom agnetic spin uctuations n and D irac ferm ions . This term shows that an antiferrom agnetic excitation of spin 1 can fractionalize into two ferm ionic spinons of spin 1=2. But, long range gauge interactions prohibit antiferrom agnetic spin uctuations from decaying into spinons. Because massive Dirac spinons in the S SB can generate only the Maxwellkinetic energy for the gauge eld a via particlehole polarizations, they should be con ned to form spin 1 antiferrom agnetic uctuations owing to the e ect of instantons. Remember that the Maxwell gauge theory shows con nem ent of charged matter elds in (2 + 1)Dowing to the condensation of instantons [27, 28, 29]. As a result spinon-antispinon com posites appear to be identied with spin 1 antiferrom agnetic uctuations, i.e.,  $n = h \sim i$ , where h::: denotes a vacuum expectation value. A resulting e ective eld theory for this antiferrom agnet is obtained to be

where the N eel vector is represented as  $n = (\sim; n^3)$  with  $n^3 = \begin{bmatrix} r & r \\ 1 &$ eld theory for small uctuations of ~ elds around the Neelaxis  $n^3$  by using  $n^3 = 1$  (1=2)  $\frac{1}{2}$ . The last term in the last line represents interactions between antiferrom agnons. Low energy physics in this conventional quantum antiferrom agnet is well described by the interacting antiferrom agnons[19].

# III. QUANTUM PHASE TRANSITION FROM ANT IFERROM AGNET ISM TO ALGEBRAIC SPIN LIQUID

#### A. E ective Field Theory

Reducing the mass parameterm in Eq. (1) results in the QCP of the AF to ASL transition. It is important to realize that although the D irac spinons are con ned to form antiferrom agnons in the AF, they should be deconned to emerge in the ASL. In order to investigate their con nem ent to decon nem ent transition, D irac spinons should be explicitly introduced in the elective action. Especially, it needs much care to treat the  $S_{M}$  in Eq. (1) representing spin fractionalization. In the AF the spinon

mass can be considered to be in nite owing to the connem ent of spinons, allowing us to ignore the process of spinon fractionalization. This permits us to integrate over the spinon degrees of freedom com pletely and obtain the e ective N L M Eq. (2) in term sofonly the Neelorder param eter elds. On the other hand, near the QCP this full integration of spinons is di cult to be justi ed. Because the mass parameter m becomes small near the critical point, the spin fractionalization cannot be ignored and thus, should be taken into account appropriately. Neel elds and D irac spinons should be treated on equal footing. In order to solve the Kondo-like spin coupling term  $S_M$  in Eq. (1), we utilize the CP<sup>1</sup> representation  $n = \frac{1}{2}z^{y} \sim 0z \circ \text{ or equally, } n \sim U^{3}U^{y}$ , where z is a bosonic spinon and U, its corresponding SU (2) m a $z_{\#} = z_{\#}^{y}$  . (1) in terms of the fractionalized elds U o and , we already m entioned that the K ondo 3 0. coupling term is completely solved to be m In this representation the scattering e ect of ferm ionic by spin uctuations n appears in the kispinons netic energy of spinons as  $(U^{y}@U) \circ \circ$ , where currents of the spinless ferm ions couple to those of the bosonic spinons,

This is nothing but the gauge sym metry of the U (1) slave boson representation. On the other hand, the latter  $U_{c}(1)$

This new boal gauge sym metry originates from the CP<sup>1</sup> representation and implies that there should be a U (1) gauge eld corresponding to the gauge sym metry. Indeed, perform ing some standard algebra such as the Hubbard-Stratonovich transformation, we can reach the following elective action

Here c is a new compact U (1) gauge eld guaranteeing the U<sub>c</sub>(1) local gauge symmetry, where the gauge eld c is transformed into  $c^0 = c + 0$  # under the transformations in Eq. (6). g is an internal charge of the bosonic spinons U<sup>Y</sup><sub>0</sub> and the spinless fermions

. The spinless ferm ions have both internal charges, e and g. The kinetic energy of the SU (2) matrix U<sup>y</sup> can be expressed into the familiar CP<sup>1</sup> representation, Tr  $\frac{Nm}{4}$  j(@ ic <sup>3</sup>)U<sup>y</sup>  $\frac{p}{J} = \frac{Nm}{2}$  j(@ ic )z  $\frac{f}{J}$ . The M axwellkinetic energy of the gauge eld c can be safely introduced as the contribution of high energy bosonic spinons because the M axwell gauge action is irrelevant in (2+1)D in the renorm alization group (RG) sense and thus, does not a ect physics of the QCP.

W e would like to emphasize that Eq. (7) is just another representation of Eq. (1). For this exact transform ation to be physically meaningful beyond a mathem atical derivation, there should exist the decon ned quantum criticality of the NL M allowing decon ned bosonic spinons at the QCP. In other words, at least the NL M in the e ective eld theory Eq. (7) should be stable in the RG sense. This is the reason why we use the term , "based on the conjecture of the decon ned quantum criticality," in the introduction. Fortunately, this decon ned quantum criticality was shown to exist in Refs. [2, 3] by an RG analysis, as will be discussed later. Based on the exact transform ation and the existence of the decon ned quantum criticality, we discuss the QCP between the AF and the ASL.W hen the decon nem ent of bosonic spinons is not allowed owing to instanton effects of compact U (1) gauge elds c, the e ective eld theory Eq. (7) becomes unstable in the present decoupling scheme and thus, another e ective theory necessarily results. This indeed happens away from the QCP, where the O (3) N L M with the Neel vectors and the  $Q \ge D_3$  with the massless D irac spinons and slave boson U (1) gauge elds recover from Eq. (7) in the AF and in the ASL, respectively.

The gauge transform ation Eq. (3) introduced for solving the Kondo coupling term in Eq. (1) may be still suspected to be unnatural although sim ilar decoupling schem es have been utilized in the context of the K ondo lattice m odel[15, 16, 18]. In this respect it is necessary to understand the present m ethodology m ore deeply by com paring this with other well studied ones. A good example is a d wave BCS theory for superconductivity of high  $T_c$  cuprates [35, 36]. In the context of d wave superconductivity the coupling term of j je i c, c, between Cooper pairs and electrons plays the same role as the Kondo coupling term of m n ~ 0 0 between spin uctuations and D irac spinons in the context of antiferrom agnetism. Here jjand are the amplitude and phase of Cooper pair elds, analogous to m and n, respectively. In order to solve this coupling term several kinds of gauge transform ations are introduced [35, 36]. In these decoupling schemes critical phase uctuations of Cooperpairs screen out charge degrees of freedom of electrons, causing electrically neutral but spinful electrons called "spinons". As a result the phase factor disappears in the coupling term when it is rewritten in terms of spinons. Instead, this coupling e ect appears as currentcurrent interactions of neutral spinons and phase elds of Cooper pairs in the kinetic energy of electrons. Depending on the gauge transform ations, Z<sub>2</sub> [35] or U (1) [36] gauge elds are obtained. In this respect the gauge transform ation Eq. (3) naturally extends the methodology of charge U (1) sym m etry in the context of superconductivity to that of spin SU (2) symmetry in the context of antiferrom agnetism .

In order to convince critical physicists of the e ective action Eq. (7), in appendix D we show that Eq. (7) can be derived directly from the antiferrom agnetic Heisenberg H am iltonian in a standard fashion. We would like to suggest one good reference [37] which derives a sim ilar e ective action with Eq. (7) from the Hubbard H am iltonian using the same decoupling scheme.

## B. Quantum Phase Transition from Antiferrom agnetism to A lgebraic Spin Liquid

Now we discuss the quantum phase transition between the AF and the ASL based on Eq. (7). The critical value of the mass parameter m for the antiferroto para-magnetic transition is assumed to be m<sup>c</sup>. In the case of m > m<sup>c</sup> condensation of bosonic spinons occurs,  $< U^{y_{0}} > 6 0$  (< z > 6 0), causing the AF. The spinon condensation leads the gauge eld c to be massive (Anderson-Higgs mechanism). In the context of gauge theories this phase corresponds to the Higgscon nem ent phase[28, 29], where the matter elds with internal charge g are con ned to form gauge singlets. The condensed bosonic spinons U  $_{0}$  are con ned with

the spinless ferm ions  $\circ$  and other bosonic spinons U  $^{y}$ to make the ferm ionic spinons and the Neel order parameter elds n, respectively. Integrating over the massive U(1) gauge eld c in Eq. (7), we obtain the following Lagrangian of L =**(**@ ia) + $\frac{1}{2e^2}$  j  $a^2 + m \sim 0 \quad n + \frac{Nm}{4}$  j  $n^2$ , where the local interactions between spinless ferm ions are cancelled. In the AF the Neel vectors align to the z direction. (2). The massive Dirac spinons should be con ned to form the antiferromagnons . As a result the conventional AF described by Eq. (2) recovers from Eq. (7).

In our recent study [34] we proposed an interesting possibility that massive D irac spinons can appear to make broad continuum spectrum at high energies in inelastic neutron scattering [38]. The mechanism of spinon deconnem ent results from the existence of ferm ion zero modes in single instanton potentials. Neel vectors can make a skyrm ion con guration around an instanton of the com – pact U (1) gauge eld a . Remarkably, in the instantonskyrm ion composite potential the D irac spinon is show n to have a zero mode. The emergence of the ferm ion zero mode forbids the condensation of instantons, resulting in the decon nement of D irac spinons in the AF. Notice that the D irac spinons are massive ow ing to S SB.

Approaching the QCP (m ! m<sup>c</sup>), the critical bosonic spinons z  $(U^{y})$  would be decon ned [1, 2, 3, 4] to exhibit broad continuum spectrum in spin susceptibility. In Ref. [2] Berry phase is shown to play a crucial role for the decon nem ent of bosonic spinons at the QCP. Berry phase gives rise to destructive interference for instanton excitations of the c gauge elds. As a result only quadrupled instanton excitations contribute to a partition function for the N L M . These quadrupled instanton excitations are known to be irrelevant at the QCP [2]. On the other hand, in Refs. [1, 3, 4] the spinon decon nem ent is claim ed to occur even in the absence of Berry phase. In these studies [1, 3, 4] the crucial point is the existence of quantum criticality itself. Internalelectric charges of spinons can be su ciently screened by critical uctuations of spinons. The smaller internal

electric charges, the larger internalm agnetic charges. As a result instanton excitations can be irrelevant at the QCP. Especially, in Ref. [3] the present author pointed out that the  $CP^1$  action of the NLM in the easy plane lim it has two kinds of xed points owing to an additional vortex gauge eld in the dual vortex representation. One is the charged xed point (inverted XY xed point) and the other, the neutral xed point (XY xed point). In Ref. [3] the inverted XY xed point is identied with the QCP studied by Senthil et al.[2]. The inverted XY xed point is shown to be unstable against instanton excitations and the instanton excitations are proliferated. Since condensation of instantons does not allow spinon unbinding, this is consistent with the conclusion of Senthiland cow orkers, that is, with the absence of spinon decon nem ent without a Berry phase term . At the inverted XY critical point the spinon decon nem ent can occur only in the presence of Berry phase. On the other hand, the XY xed point is shown to remain stable against instanton excitations. From the RG analysis in Ref. [3] one sees that although o criticality the instantons are relevant everywhere, they become irrelevant at the XY QCP. This allows spinon decon nem ent, which is di erent from the conclusion by Senthilet al.[2], since this novel critical point does not coincide with their one. The XY xed point is, instead, identi ed with the QCP studied by Bernevig et al.[1], thus showing that the decon nem ent of spinons takes place even without the Berry phase. See Ref. [3] for details. We would like to mention the result of M onte-C arlo simulation [4] supporting the existence of decon ned spinons at the QCP of the O (3) NL M without Berry phase. They claim ed that critical uctuations of bosonic spinons result in a nonlocal action of U (1) gauge elds and this contribution causes the decon nem ent of spinons[4].

A lthough the internal charge g is decon ned owing to critical uctuations of the bosonic spinons, the spinless ferm ions would not appear at the QCP. Remember that the carries the internal charge e. The spinless ferm ions would fiel con ning interactions mediated by U (1) gauge uctuations a owing to their nite mass m<sup>c</sup> at the QCP. Ignoring antiferrom agnetic spin uctuations, i.e., n = 2 in the mean eld level, one can nd that the antiferro-to para-m agnetic transition is determ ined by the self-consistent gap equation in Ref. [20] (appendix B). In this case the spinon massm

point. However, allowing spin uctuations beyond the mean eld level, the critical value of the spinon mass for the magnetic transition would not be zero. This can be justiled by the RG analysis of the O (3) N L M . Using the standard poor man's scaling for the  $S_{N L M}$  in Eq. (1), one obtains the wellknown RG equation for the spin still ness m in (2 + 1)D [39]

where l is a scaling parameter and , a positive numerical constant. This RG equation yields three xed points;  $m ! 1, m ! 0, and m ! m^{c} = , cor$ responding to AF, quantum disordered param agnetism, and QCP, respectively. The nonzero critical coupling in m<sup>c</sup> ~ 0 0 n at the QCP seems to be consistent with that of the Kondo lattice model[14, 15, 16] which has a similar structure with Eq. (7). Integration over the massive ferm ions generates the Maxwell kinetic energy of the gauge eld a . In this case the well known classic result by Polyakov [27] can be applied, leading to con nem ent of the charge e. The resulting critical eld theory is obtained from Eq. (7) to be  $L_{QCP} = \frac{Nm^{\circ}}{2} j(0)$  ic  $zj + \frac{1}{2q^2} j0$  cf, where c is a noncompact U (1) gauge eld. In appendix E, in order to con m this critical eld theory we derive the similar critical theory in a di erent way, where the Neel elds are not introduced.

In the case of m < m<sup>c</sup> the bosonic spinons are gapped, < U<sup>Y</sup><sub>0</sub> >= 0 (< z >= 0). In order to correctly describe the ASL, the massive bosonic spinons should be con ned with the spinless ferm ions to form the ferm ionic spinons. In other words, the internal charge g should be con ned via gauge uctuations c . As the RG Eq. (8) shows m ! 0, the spinless ferm ions would becom e massless in the quantum disordered param agnetism . O ne can think that the vanishing m assm akes the

eld critical, resulting in decon nem ent of the internalcharge g owing critical uctuations of these ferm ions. How ever, this guess is not correct. The vanishing ferm ion mass gives rise to one problem that the strength of local interactions goes to in nity in Eq. (7). In order to treat the in nitely strong local interactions, we perform the Hubbard-Stratonovich transform ation in Eq. In the above we utilized m ! 0. Integration over the auxiliary eld  $3_{0} = 0,$ results in the local constraint, elds do not screen out the inindicating that the ternal charge g. Only the Maxwell kinetic energy is available, causing con nem ent of the charge g[27]. The gapped bosonic spinons should be con ned with the spin-

less ferm ions to make the D irac spinons. Since the e ective eld theory Eq. (7) is unstable in the parameter range of m < m<sup>c</sup>, a new e ective theory necessarily = U  $\circ \circ$  into Eq. (7) under the results. Inserting  $^{3}$   $_{0}$   $_{0}$  = 0 and integrating over the constraint of gapped bosonic spinons U  $^{y}$  , we can obtain the following Lagrangian of  $L_{ASL} = (0 \text{ ia }) + \frac{1}{2e^2} \mathbf{j} \mathbf{0} \text{ af}$ . Local interactions of spinon currents j f would appear in the above e ective Lagrangian, but this term does not a ect low energy physics because it is irrelevant in (2 + 1)D in the RG sense. As discussed earlier, the D irac spinons with the internal charge e are decon ned to emerge at the charged xed point of the  ${\rm L}_{\rm ASL}$  . We summarize the quantum phase transition from the AF to the ASL in Table I.

#### IV. SUMMARY

In sum mary, we proposed the fractionalization of the D irac spinons into the bosonic spinons and spinless ferm ions near the quantum critical point between the antiferrom agnetism and the algebraic spin liquid (Table I). Based on this conjecture we constructed the "m other" critical eld theory Eq. (7) and showed that the antiferrom agnetism and the algebraic spin liquid can successfully recover from Eq. (7).

## APPENDIX A

In appendix A we brie y sketch how to obtain the  $S_{ASL}$  in Eq. (1) from the antiferrom agnetic Heisenberg model on two dimensional square lattices,  $H_J =$  $_{\langle i;j\rangle}$  S<sub>i</sub> S<sub>j</sub> with J > 0. Inserting the following J spinon representation for spin,  $S_i = \frac{1}{2}f_i^y \sim 0 f_i \circ into$ the above Heisenberg model, and performing the standard Hubbard-Stratonovich transformation for an exchange interaction channel, we obtain an e ective one body Ham iltonian for ferm ions coupled to an order param eter,  $H_{eff} = J_{(i;j)}^{f} f_{i}^{y} i_{j}f_{j}$  h c:. Here  $f_{i}$ is a ferm ionic spinon with spin = ";#, and ij is an auxiliary eld called a hopping order parameter. Notice that the hopping order parameter ij is a complex number de ned on links ij. Thus, it can be decomposed into  $ij = j_{ij} \dot{p}^{i_{ij}}$ , where  $j_{ij} j$  and ij are the amplitude and phase of the hopping order param eter, respectively. Inserting this representation for the

ij into the e ective H am iltonian, we obtain H  $_{\rm eff}$  =  $f_{\langle i;j\rangle} j_{ij} j_i^{Y} e^{i_{ij}} f_j$  h:c:W e can easily see that J this e ective Hamiltonian has an internal U (1) gauge symmetry,  $H_{eff}^{0}$  [ $f_{i}^{0}$ ;  $f_{ij}^{0}$ ] =  $H_{eff}$  [ $f_{i}$ ;  $f_{ij}$ ] under the following U (1) phase transformations,  $f_i^0 = e^{i_i} f_i$  and  $_{ij}^{0} = _{ij} + _{i} _{j}$ . W hen a spinon hops on lattices, it obtains an Ahamov-Bohm phase owing to the U (1) gauge eld  $a_{ij}$ . It is known that a stable mean eld phase is a ux state if an antiferrom agnetic order is not taken into account [6, 22]. This means that a spinon gains the phase of when it turns around one plaquette. In ux phase low energy elementary excitations are the m assless D irac spinons near nodal points showing gapless Dirac spectrum and U(1) gauge uctuations [6, 22]. In the low energy lim it the amplitude j<sub>ij</sub> j is frozen to  $j_{ij} = J_j < f_j^y f_i > j_A$  resulting e ective eld theory for this possible quantum param agnetism of the antiferrom agnetic H eisenberg m odel is Q E D 3 in term s ofm assless Dirac spinons interacting via compact U (1) gauge elds,  $S_{ASL}$  in Eq. In the  $S_{ASL}$  = is a four component massless D irac ferm ion, where = 1;2 represents its SU (2) spin ("; #) and denote the nodal points of (=2; =2)in momentum space. U sually, SU (N) quantum antiferrom agnets are considered by generalizing the spin com ponents = 1;2 into = 1;2; :::; N . The two component are given by  $f_1^+ = f_{n_{10}}^+$ ,  $f_{n_{20}}^-$ ,  $f_{n_{20}}^$ spinors  $\stackrel{+}{_2}$  =  $\stackrel{f_{\#1e}}{_{f_{\#1o}}}$  , and  $_2$  =  $\stackrel{f_{\#2o}}{_{f_{\#2e}}}$  , respectively. In the spinon eld  $f_{abc} = "; #$  represents its SU (2) spin, b = 1;2, the nodal points (+; ), and c = e;o, evenand odd sites, respectively [22]. Dirac matrices are given by 0 = , and  $_{2} = \begin{bmatrix} 1 & 0 \\ 0 & 1 \end{bmatrix}$ , respectively, where they satisfy the Cliord algebra [; ]<sub>+</sub> = 2 [22].

#### APPENDIX B

In appendix B, for com pleteness of this paper we brie y sketch how we obtain the dynam ically generated spinon mass m in  $S_M$  in Eq. (1). A single spinon propagator is given by  $G^{-1}(k) = G_{0}^{-1}(k)$ (k), where  $G_0^{1}(k) = i k$  is the inverse of a bare spinon propagator, and (k), a spinon self-energy resulting from long range gauge interactions. The spinon self-energy is determ ined by the self-consistent gap equation, (k) = $\frac{d^3q}{(2)^3}$ Tr[G(kq)D(q)], where D(q) is a renormalized propagator of the U(1) gauge eld a due to particle-hole excitations of massless D irac ferm ions. The

self-energy can be written as  $(k) = m (k)^{3}$  for staggered m agnetization [22]. Inserting this representation into the above self-consistent gap equation, we obtain the following expression for the spinon mass, m (p) = $\frac{d^3k}{(2)^3} \frac{m}{k^2 + m^2} \frac{m}{(k)} D$ (p k). In the above Tr stands for not a functional but a usual matrix trace for both avor (spin) and spinor indices. In going from the third to the fourth line we have dragged the factor  $e^{ikx}$  through the operator, thus shifting all di erential operators 0 + 0 + ik [24]. Expanding the argument of the logarithm ic term in powers of  $0 + and of 2ik + 0^2$ , one can easily obtain the expression in the fl line. Performing the momentum integration, we obtain an elective spin still ness proportional to the mass parameter m of D irac spinons. Eq. (C2) is nothing but the O (3) N L M describing a collinear spin order. Note that higher order derivative terms in the RG sense.

We should comment the reason why imaginary terms do not arise in the present NL M because some previous studies have shown the emergence of imaginary

term s[40, 41]. Following the evaluations in Ref. [41], one can obtain two imaginary terms in the irreducible representation of gam m a m atrices; one is a coupling term ia J between topologically nontrivial ferm ionic currents  $J = \frac{1}{8}$ n @ n @ n and U (1) gauge elds a , and the other, a geometrical phase N [n][40, 41]. The key point is the representation of Dirac gamma matrices[42]. Here, we utilized four-by-four D irac matrices by combining the two nodal points. Note that the signs of Paulim atrices in the D irac gamm a matrices are opposite for the nodal points . This fact results in cancellation of the imaginary terms. The rst imaginary term can be considered from a variation of the logarithmic term in Eq. (C1) with respect to the gauge eld а

Another way to say this is that the signs of mass terms for the D irac ferm ions ( $_{n}^{+}$  and  $_{n}$ ) at the two D irac nodes (+ and ) are opposite, resulting in cancellation of the parity anomaly[42]. This AF would not be conventional since it breaks not only time reversal symmetry but also parity symmetry. When this AF disappears via strong quantum uctuations, its corresponding quantum disordered param agnet is expected to be the chiral spin liquid [32, 43, 44]. In the present paper we did not discuss the quantum phase transition from this anom alous antiferrom agnetism to the chiral spin liquid.

The ansatz of an antiferrom agnetic order leads us to the saddle point equations of the three order param eters,  $_{ij} = Jhf_j^y f_i i$ ,  $m_i = \frac{J}{4}(1)^i hf_i^y$   $^3 {}_0 f_i {}_0 i 2$ , and  $_i = \frac{J}{4} hf_i^y f_i$  i. At half lling the saddle point value of the charge density wave order param eter is given by  $_i = J=4$ . Shifting the  $a_i$  eld into  $ia_i$  !  $ia_i$  J=4 in Eq. (D 1) leads to the follow ing e ective Lagrangian

Here  $_{0} = j_{ij}j$  and  $m = m_{i}$  2 are amplitudes of the order parameters, assumed to be uniform in space and time.  $a_{ij}$  is the phase of  $_{ij}$  and  $\sim_{i}$ , that of  $m_{i}$ .

In order to derive Eq. (7) from the above elective Lagrangian Eq.  $(\underline{D} 2)$ , one can use the Haldane mapping of  $i_i = (1)^i n_i \ 1 \ \Sigma_1^2 + \Sigma_i$ , where  $n_i$  is a unitary vector representing the Neel eld, and  $\Sigma_i$ , the canting vector orthogonal to  $n_i [31, 39]$ . Using the C P<sup>1</sup> representation of  $n \ \sim = U^3 U^y$  and introducing the gauge transform ation of d = U  $_0^y f_0$  in Eq. (D 2), one reaches the following Lagrangian

Integrating over the spinless ferm ions d , expanding the resulting ferm ion determ inant to the second order of U<sup>y</sup>@ U and L , and integrating out the canting elds L , one can nally obtain the O (3) N L M . This procedure is well derived in Ref. [37]. Combining the spinless ferm ions with this N L M in order to exam ine the m agnetic Q C P , and perform ing the Hubbard-Stratonovich transform ation used in section III-A, one can nd an effective action with an emergent U (1) gauge eld c sim – ilar to Eq. (7) in the continuum lim it.

We would like to comment how the present study can be expanded to the case of geometrically frustrated lat-)tices. Remember that in the present paper a collinear spin order is considered to result in the O (3) N L M in Eq. (1). In the frustrated antiferrom agnets non-collinear spin orders are expected and thus, the present N L M cannot be applied. In this case the unitary vector  $\sim$  in Eq. (D 2) should be generalized to impose non-collinear spin orders. This requires a di erent kind of Haldane m apping from the above. In this case a param agnetic phase resulting from each non-collinear spin order is an interesting problem. Remember that in appendix C we m entioned an exciting quantum phase transition from an anom abus antiferrom agnetism to the chiral spin liquid. These two interesting studies rem ain as future works.

## APPENDIX E

In order to con m the present description of the QCP, we derive the similar critical eld theory, but in a totally di erent way where the Neel order parameter elds are not introduced. We consider the following elective H am iltonian (appendix A and D)

describing staggered magnetization in the ux phase of the Heisenberg model[46]. Because the ux phase results in massless D irac fermions near the nodal points, the QED\_3 with S SB,  $L_{QED}$  = (@ ia ) + m  $+\frac{1}{2g^2}$  j@ af can be derived from Eq. (E1). We perform bosonization by attaching a ux to the fermionic spinon,  $f_i$  =  $b_i$  exp i  $_j$  (i j) (n  $_{j^{\prime\prime}}$  +  $n_{j\#}$ ), where  $b_i$  is a statistically transmuted bosonic spinon with  $n_i$  =  $f_i^{\gamma} f_i$  =  $b_i^{\gamma} b_i$  [47]. Our strategy is to rew rite Eq. (E1) in terms of the new ly introduced boson elds  $b_i$ ,

with the constraint of 2  $b_i^y b_i 2 = (\tilde{r} a^{cs})_i$ , arising from the ux attachment. Here  $a_{ij}^{cs}$  is a Chem-Simons gauge eld with a statistical angle = , guaranteeing the statistical transmutation of the fermionic spinons. Eq. (E2) can be written to be in a general gauge in the continuum lim it

where the boson eld b is replaced with a coarse grained in the continuum limit. Comparing Eq. (E3) eld with the QED<sub>3</sub> with S SB, the Dirac Lagrangian in the QED 3 is replaced with the K lein-Gordon one in the same dispersion relation owing to the bosonic statistics eld in the ux phase. m is a phenom enologof the ical boson mass associated with the magnetization m in Eq. (E1) and u , strength of local interactions. m is assumed to be a function of the ferm ion avor number N. As N approaches the critical value N  $_{\rm c}$ , m goes to zero. The above bosonization procedure can be found in Ref. [48], but in an opposite direction (boson to ferm ion instead of ferm ion to boson). The main point is that at the QCP (m ! 0) the Chern-Simons gauge eld does not play any roles [48]. Shifting the gauge eld a to  $c = a + a^{cs}$  and integrating over the Chem-Sim ons gauge eld, we obtain a higher order derivative of the gauge eld c , (@ C) (@ @ c). This higher order derivative term is irrelevant at the QCP in the RG sense. The resulting e ective eld theory is obtained to be  $L_{QCP} = j(0 \text{ ic }) \quad j^2 + m^2 j \quad j^2 + \frac{u}{2} j \quad j^4 + \frac{1}{2q^2} j \quad c_1^2.$ Remarkably, this critical eld theory has the same form as that derived in a di erent way earlier [49]. It is im portant to realize that this e ective Lagrangian can be physically meaningful only at the QCP because the com pactness of the gauge eld c can be irrelevant only at the QCP.Remember that away from the QCP this e ective eld theory becom es unstable in the RG sense owing to spinon condensation in the case of  $m^2 < 0$  and instanton condensation in the case of  $m^2 > 0$ , respectively. Especially, the case of  $m^2 > 0$  corresponds to the ASL in the ferm ion representation. This discussion shows that the statistics of spinons is ferm ionic in the ASL.
