E ect of space-time dispersion on the propagation of electrom agnetic waves in photonic crystals

A bstract

We study the in uence of the space and time dispersion on the frequency dependence of the wave vectors of electrom agnetic waves propagating in three-dimensional photonic crystals. Two types of structures are considered: media with weak periodic modulation of the permittivity, and photonic crystals com posed of the periodically arranged identical resonant dielectric particles. It is shown that in these systems, in contrast to electrons in solid crystals, di erent types of excitations exist. For example, a peculiar kind of polaritons arises in the photonic crystals due to the interaction of the electrom agnetic eld, eigenoscillations of the dielectric m edium, and D ebye resonance. The widths of the transparency zones and of the band gaps have been calculated as functions of the frequency and of the param eters of the media. It is shown that in the photonic crystals with dispersion, the number of transparency bands is larger than in nondispersive systems, and the width of the gaps in the frequency spectrum of photons depends on the wave vector. The interaction of di erent types of waves deform s the B rilbuin zone, so that it m ay not have a plane boundary (for example, a sphere), in which case the classical Bragg condition does not hold.

1 Introduction

The propagation of waves in periodic structures is a topic of profound im portance, both for understanding the general properties of matter-radiation interactions, and for the ever-increasing number of practical applications (for example, photonic crystals) [1], [2], [3]. In spite of the close similarity to the quantum – mechanical problem of electrons in a crystal lattice, the propagation of classical waves in photonic crystals exhibits many rather unusual distinctive features. The most dram atic example of such a di erence is the e ect of time and space dispersion, which has no analogue in the motion of conduction electrons. W hile the propagation of electrom agnetic waves in hom ogeneous dispersive m edia has been thoroughly studied [4], the e ect of dispersion on the radiation propagating in periodic structures still remains poorly understood. The exceptions are periodic multiple quantum well structures (periodic arrays of dielectric layers), for which the polariton spectrum and the optical response have been studied in considerable detail [5], [6], [7], [8]. In the recent publication [9], the exciton-polariton susceptibility matrix was calculated, taking into account the well-well interaction, and the polariton dispersion curves for an in nite periodic array of quantum wells have been computed. Some interesting polariton-induced e ects were discovered. However, the one-dimensionality of the system considered prevented the investigation of important e ects inherent only in dispersive media of higher dim ensionality. In the present paper, we deal with the linear wave equation of the m ost general type and study the spectral properties of dispersive periodic dielectric m edia, namely, the e ect of the time and space dispersion on the frequency dependence of the wave vector. The methods employed (am all perturbation and local perturbation methods) in pose no restrictions on the dimensionality of the system. As formulated, the problem is closely related to the calculation of the energy of an electron as a function of the wave vector in periodic crystals. How ever, in contrast to the later case, the solution of the corresponding dispersion equation for electrom agnetic waves can have several branches, i.e. di erent types of waves can propagate. The interaction of these waves is the crucial factor in the form ation of the photonic spectrum, and gives rise to rather unusual e ects. In particular, it deforms the Brillouin zone, so that it may not have a plane boundary (for example, a sphere), in which case the classical Bragg condition is violated.

W e consider the most general form of the wave equation

where \hat{H} and \hat{h} are arbitrary functions of $\frac{\hat{\theta}}{i\hat{\theta}r}$ and $\frac{\hat{\theta}}{i\hat{\theta}t}$; and \hat{h} is a periodic function of r with periods $r_n = n_1r_1 + n_2r_2 + n_3r_3$; where r_1 ; r_2 ; r_3 de ne the unit cell of the photonic crystal, and n_1 ; n_2 ; n_3 are integers. In non-dispersive media, Eq. (1) becomes a classical second-order wave equation; space-time dispersion corresponds to higher-order derivatives with respect to the coordinates and the time in Eq. (1).

A coording to the B loch theorem , the solution of this equation has the form

where E (r) is a periodic function with periods r_n .

O ur goal is to investigate the spectrum of waves propagating in the periodic system, i.e. to nd the dependences, $!_1(k)$, of the frequency ! on the wave vector k (the subscript l indicates di erent types of waves). The periodic functions E (r) and $\hat{h}(r; \frac{\theta}{\theta r})$ can be expanded in Fourier series,

Equation (6) is the dispersion equation that determ ines the function ! (K). From Eq. (2); it follows that ! (K) is a periodic function of K with periods K_n [10], [11]. To avoid problem s associated with the in nite rank of the determ inant in Eq. (6), we consider two limiting cases: a weak periodic modulation that corresponds to the nearly-free electron approximation, and a crystal, for which the method of local perturbation is applicable (an analog of the tight-binding approximation).

2 W eak periodic m odulation

In this section, we assume that the amplitude of the periodic modulation of the medium is small, so that

It is important to note that this correction is of second order in the small perturbation h.

A similar gap exists in the energy spectrum of electrons in a periodic potential [10], with the following important di erence: the width of the gap in the frequency spectrum of photons, Eq. (24), depends on the wave vector $\tilde{\kappa}$:

Equation (22) de nes the surface that is the boundary of the Brilbuin zone of the photon. For an isotropic medium, the frequency $!_n$ depends on the modulus of the wave vector, and the solution of Eq. (22) is $k^2 = k^2$. Hence, the equation for the Brilbuin zone boundary takes the form

which is the equation of a plane in \tilde{K} -space. Eq. (25) coincides with the well-known Bragg condition.

M uch m ore unusual is the photonic spectrum when two roots of Eq. Equation (29) is the equations of a sphere with the center at \tilde{K}_R and having radius R. The spherical shape of the Brilbuin zone originates from the interaction of di erent types of waves (n and q), and has no precedent in the theory of electrons in periodic lattices. In the absence of interactions, Eq. (29) loses its physical meaning, and R² becomes negative

It is interesting to point out another distinctive feature of photonic periodic structures. In contrast to electrons, in electrodynam ics the radiation (or scattering) problem exists along with the eigenvalues problem considered above. In this case, the frequency, !, is an external parameter, and the dependence of the wave vector on the frequency, \dot{k} (!); is to be found. This dependence can be obtained from the solution of the eigenvalues problem, ! (\dot{k}). From Eqs. (16) and (23) it follows that

3 Periodic array of resonant particles

In this section, we consider a photonic crystal composed of periodically arranged identical dielectric particles having refractive index n, and study the spectrum of excitations (eigenwaves) associated with a resonance in a single particle. Such a resonance exists when the particle size, d; is of order of the wavelength inside the particle, $=\frac{2}{n!}$; (M i resonances, for example). This system is an analog of the tight-binding m odel in the solid state theory [12], and presents an opposite limiting case to that considered in the previous section. Indeed, while in a medium with weak periodicm odulation, the band gap is sm all compared to the conduction band, the gaps in the spectrum of the photonic crystal studied in this section are much wider than the passing zones.

In what follows, we consider the frequency range in which the wavelength of the radiation in the medium (having refractive index n_0) is larger than the typical size of the particles

In this case, the problem can be handled by means of the local perturbation method (LPM) [13], [14], [15], [16]which is based on the assumption that the (unknown) eld is independent of the coordinates inside each particle. In contrast to the Born approximation, which considers only weak scattering, LPM leaves room for arbitrarily large amplitudes of scattered elds, and does not rule out the existence of resonances that take place when d $\frac{2 c}{n!}$.

Equation (1) now takes the form

where the spatial-time dispersion of the homogeneous host medium is incorporated in \hat{H} . The operator $\hat{\Phi}$ is non-zero only inside the particles and depends

on their shape, position, and dielectric properties. For the sake of sim plicity, we shall assume that the dielectric particles possess only time dispersion.

Since $\frac{1}{2}$ in Eq. (33) is a periodic function of r, the solution of Eq. (33) can be written in the form of Eq. (2). If the inequality (32) holds, the LPM approximation is applicable, in plying that

(41) corresponds to the resonance frequencies of an isolated single particle, while the third term gives the corrections due to the multiple scattering (interactions). Note that the number of solutions depends on the explicit form of the functions "₀ (!) and "(!), and can be larger than two.

Multiple scattering between neighboring particles leads to the broadening of the discrete levels $!_{1,2}$ into passing zones of nite width. Frequencies $!_{1,2} = !_{01,02} + !_{1,2}$ correspond to a peculiar kind of polaritons that arise in photonic crystals with time dispersion due to the interaction of the electrom agnetic eld (!), eigenoscillations of the dielectric medium (!_0); and D ebye resonance (!_s).

For the width of the interaction-induced passing zones, $4 \, !_{1,2}$; Eq. (45) yelds

Term s independent on \dot{k} (sm all shifts of !_{1,2}) are om itted in Eq. (51). Recall that for the exponent in the G reen function to be real (stability condition), it is necessary that

One can see from (51) that the zone width is maximal at $!_i =$ and is equal $!_i = \frac{a}{b}!_i$: For $\frac{2}{!_{0,1,2}^2}$ increasing, the width decreases exponentially, and at $\frac{2}{!_{0,1,2}^2} >> 1$; the zone structure disappears. When the spacing between levels, $j!_1 = !_2 j$; is of order of $!_s$; the width of the passing zone is $\frac{b}{a} >> 1$ times smaller than the size of the band gap.

To conclude, tim e-spatial dispersion causes in portant di erences in the spectrum of photons in periodic dielectric systems from that of electrons in solid state crystals. It gives rise to di erent types of waves, changes the number and structure of passing zones and band gaps, and dram atically deform s the B rillouin zones.
