W e analyze the spectral and transport properties of ballistic quasione-dimensional systems in the presence of spin-orbit coupling and in-plane magnetic elds. Our results demonstrate that R ashba precession and intersubband coupling must be treated on equal footing for wavevectors near the magnetic eld induced gaps. We not that intersubband coupling limits the occurrence of negative e ective masses at the gap edges and modi es the linear conductance curves in the strong coupling limit. The eld of the magnetic eld on the spin textured orientation of the wire magnetization is discussed.

I. IN TRODUCTION

Controllable manipulation of electron spins with electric elds (gates) is a central requirement to spintronic devices. Sem iconductor heterostructures o er the possibility of electric control of spins through intrinsic spinorbit interactions. A major contribution to spin-orbit e ects in two-dimensional (2D) electron gases of narrow – gap sem iconductors originates from the macroscopic electric eld con ning the electron gas.¹ This implies an asymmetry in the quantum -well potential (the Rashba e ect), which can be further tuned with gate voltages. The resulting spin-orbit coupling has been demonstrated in experiments.^{2,3,4}

In this paper, we are concerned with the Rashba interaction in ballistic quantum wires. Interestingly, these systems have been proposed as basic elements for practical applications such as spin-dependent eld-e ect transistors⁵ and spin lters⁶ and have been also considered as detectors of entangled pairs of electrons⁷ and of the hyper ne nuclear spin dynam ics.⁸ The Rashba interaction is described by the Ham iltonian,

where $p = (p_x; p_y)$ is the linear momentum and x, y are Paulim atrices. Spin transistors exploit the Rashbainduced precession of spins ($_1$ term for transport along the x-direction). However, in Eq. (1) there is an additional term, proportional to $_2$, which m ixes nearest subbands with opposite spins and induces anticrossings at the degeneracy points of the wire's energy spectrum $^{9,10}_{2,10}$ O by buokly, in a device one has $_1 = _2$, but it is of conceptual interest to distinguish in Eq. (1) between the two contributions (see below).

W hen an in-plane magnetic eld is externally applied or it arises from ferrom agnetic leads attached to the wire, the Zeem an splitting opens gaps in the wire spectrum, 6,8,11,12,13 strongly a ecting the transport properties. It also in uences the spin dynamics since whereas the Rashba precession random izes the spin direction (a common spin quantization axis can be de ned only for large wavevectors), the magnetic eld tends to

align the spins parallel to it. M any works neglect^{8,11,12,13} the e ect of Rashba intersubband coupling (RIC) in quantum wires in the presence of in-planem agnetic elds. Here we demonstrate that both Rashba precession and intersubband coupling must be treated on equal footing for wavevectors near the subband gaps. We nd that R IC hinders the form ation of subband m axim a, sm oothing the gap edges and, as a consequence, strongly a ecting the conductance steps. This conclusion is most relevant to the strong coupling limit, when spin-orbit and con nem ent energy scales are of the same order of m agnitude. Section II presents the model and analyzes its characteristic energy subbands. In Sec. III we show the spin expectation values and m agnetization distributions while Sec. IV focusses on the linear conductance and, nally, the conclusions are contained in Sec.V.

II. HAM ILTON IAN AND ENERGY SPECTRUM




FIG.1: (Color online) Schematic representation of the wire potential H $_{\rm conf}$ V (y) = m $!_0^2 y^2$ =2 and magnetic eld orientation considered in this work.

We consider a quantum wire, form ed when a 2D gas is further con ned in one direction [see Fig. 1]. The connem ent is assumed parabolic in the y-direction, H $_{\rm conf}$ = m $!_0^2 y^2 = 2$, giving a wire orientation along x. An in-plane magnetic eld B = (B cos ;B sin) acts through the Zeem an Ham iltonian H $_z$ = g $_B$ B (cos $_x$ + sin $_y$)=2. O rbitalm agnetic e ects are absent in this geometry since they arise only from perpendicular elds.^{4,14,15} A dding all contributions, the resulting quasi-1D Ham iltonian reads,

Since the system is translationally invariant along x, the wave function dependence on this variable is e^{ikx} , with k the propagation wavevector. It is then useful to recast the Ham iltonian for a given wavevector, H _k, in dimensionless form t^{15}

with the characteristic lengths $l_0 = \frac{p}{-m!_0}$ (con ne- $\sim^2 = mg_B B$ (Zeem an coupling, g > 0)¹⁶ ment), $l_{Z} =$ and $l_i = \sim^2 = 2m_i$ (i 2 1;2, Rashba interaction). We use in Eq. (3) the bosonic operator a_k (a_k^y) which lowers (raises) a subband index for xed k, thereby $\hat{n}_k = a_k^{Y} a_k$ is the number operator. The third term in the right-hand side of Eq. (3) describes the free propagation motion in the x-direction whereas the forth and ffh contributions correspond to Rashba precession (l_1) and to RIC (l_2) , respectively. The 4 Rashba coupling induces subband spin splitting whereas it is clear from Eq. (3) that the 12 term couples adjacent subbands with opposite spins. In writing H_k we have om itted the Coulomb interaction between the electrons since its e ect can be taken into account, at least in part, via a renorm alized R ashba coe cient. 17

D ue to the presence of R IC, H $_{\rm k}$ is not diagonalizable except for a special wavevector (see below). Yet, it is easy to show that for eldsparallel to the wire the two R ashba term s contribute equally. W ithout R ashba interaction the energy dispersion of a given subband is $E_{nk}^{(0)} = (n + 1=2) + (kl_0)^2 = 2 + (l_0 = l_z)^2 = 2$ with n = 0;1;2;::: and = 1. We not the energy correction to rst order in the R ashba couplings:

Equation (4) already shows two noticeable features: (i) W hen \notin 0 there is a Rashba-induced splitting proportional to k, well known from studies of spin-orbit e ects at B = 0 (see, e.g., Ref. 18), which combines with the Zeem an splitting to yield multiple subband crossings; and (ii) RIC (the l_2 term) does not contribute to rst order but for = 0 the Rashba precession (l_1) term is also zero. This implies that when = 0 both Rashba term s contribute to second order in the couplings. The full second-order correction reads:




FIG.2: (Coloronline) (a) D ispersion relation for $= 0, \frac{1}{k} = 2l_0$, and $l_1 = l_0$. Solid line corresponds to the case where the R ashba intersubband coupling is fully included ($l_2 = l_1$) while dashed line shows the case without it ($l_2 = 1$). (b) Same as (a) for = =2.

Adding all corrections one has E_{nk} ' $E_{nk}^{(0)} + E_{nk}^{(1)} + E_{nk}^{(2)}$, which is valid for $l_0; l_2$ $l_1; l_2$ and $l_0 \notin l_2$. It should be emphasized that in the above perturbative analysis we have taken as expansion parameters $l_0=l_1$ and $l_0=l_2$, assuming that the remaining factors of the two R ashba terms are similar, i.e., that kl_0 ' 1. O by ously, in the limit of very large k the R ashba procession term, proportional to kl_0 , will clearly dominate over the R IC.

Further progress is made if we diagonalize the total H am iltonian in the absence of R IC, i.e., setting $\frac{1}{2}$! 1 in Eq. (3). The exact eigenstates and eigenenergies (in ~!_0 units),

are labeled, as before, with three quantum numbers: the propagation wavevector k, the index n of the corresponding 1D harmonic oscillator wavefunction $_n$ (y), and the branch-splitting quantum index = 1. The notation has been simplied by dening the complex number $z_k = (l_0 = l_z)^2 e^{i} = 2 + i(kl_0 = 2)(l_0 = l_1)$ and its argument $_k = A \operatorname{rg}[z_k]$. This complex quantity is taking into account the relative in portance of Zeem an and R ashba precession energies, as can be seen more clearly when

rewriting it like $z_k = [(g_B B = 2)e^i + i_1k] = \sim !_0$.

The energy spectrum of Eq. (7), for = 0 and ==2 is plotted with dashed lines in Figs. 2(a) and (b) for $l_z = 2l_0$ and strong spin-orbit $l_1 = l_0$ (taking 10 m eV nm and InAs parameters the above values would 02 meV and B correspond to $\sim !_0$ 0:1 T, which can be achieved experimentally).⁴ For both angles the spectrum show senergy crossings between subbands with $n \in n^0$ and opposite. For = -2 there are additional crossing points for kl 02 between subbands of opposite and equal n. Noticeably, for = 0 the Zeem an eld produces gaps at k = 0 and around that point the spectrum shows local maxim a for the = 1 subbands. From Eq. (7) we see that a local maximum (minim um) occurs at the = 1 subbands when $\frac{1}{2}$ > 21 $(l_z < 2l_1)$. Thus, changing the magnetic eld a ects dram atically the spectrum and, as discussed below, the transport properties.

Solid lines in Figs.2(a) and (b) show the e ect of R IC. We have obtained the spectrum with a direct numerical diagonalization of Eq. (3) in the basis of Eq. (6), truncating to a large enough \underline{n} . The intersubband matrix elements of H $_2$ (il=2 2l₂)(a^y a) x read

As an alternative method, we have also discretized H $_{\rm k}$ in real space with nite di erences and diagonalized the resulting matrix. Both methods give identical results. W hen R IC is fully included we nd that the crossings of di erent-n subbands (dashed lines) become anticrossings (solid lines) as expected. Importantly, for = 0 and high energy subbands R IC converts the maxima into minima [see, e.g., the second and third subbands in Fig 2 (a)].

Figure 2 also shows a conspicuous downward shift of the solid lines with respect to the dashed ones for k-values close to the central gaps (for = 0) or degeneracy points (for = =2). This can be easily explained by noting that the minimum gap condition for $\mathbf{6} = 2$ or crossing point for = =2 is given by Im $[\mathbf{z}_{k_g}] = 0$ with solution $k_g = (l_1 = l_2^2) \sin$. When this occurs the H am iltonian (3) can be exactly solved since H $_2$ does not couple states with di erent -indices [see Eq. (8) and note that + 0 = 2 $_{\circ}$]. The H am iltonian for each ,

represents a harm onic oscillator with a shifted transverse m om entum and a global negative energy constant. As a result, the exact states at the minimum gap are those of Eq. (6) shifted in m om entum, e^{im} $_{2y=^{2}}$ $_{nk_{g}}$ (x;y), and the exact eigenenergies show a rigid shift $E_{nk_{g}}$ $l_{0}^{2}=8l_{2}^{2}$ ¹⁹

For = =2 [Fig.2(b)] we not new energy degeneracies entirely due to the presence of RIC in addition to the anticrossings similar to the = 0 case. For 0 < < =2there is a local minimum or maximum at k_g depending on the size of $_2$ with respect to $_1$ and B. Our results, thus, demonstrate that including intersubband coupling is essential in any theory of strong R ashba interaction in quantum wires in the presence of magnetic elds and for k values near the subband gaps.

To see how sensitive the local maxim a are to the effect of R IC we calculate the second-order correction in H $_2$ to the energy spectrum at = 0 and then nd the dimensionless e ective mass at the extrem um of the n branch, m =m $_n$ = $0^2 E_{nk} = 0 \ (k l_0)^2 \ j_{z=k_g}$. The sign of m determ ines the character of the extrem um , electron-like (m > 0) or hole-like (m < 0):



For $_2 = 0$ and large $_1$ ($l_1 < l_2 = 2$), m_n becomes negative for = 1 subbands, leading to a maximum in the energy spectrum, in agreement with our previous conclusions. However, for strong enough R IC the elective mass sign is reversed. We emphasize that this is an elect purely due to the R IC and it is even stronger for increasing n, con rm ing the num erical results of F ig. 2 (a). Equation (10) is a perturbative result and works well provided the con nement is the smallest length scale $(l_0 \quad l_2; l_1; l_2)$. Only for very wide wires $(l_1; l_2; l_2 \quad l_0)$ we num erically recover maxima ($m_n < 0$).

III. SP IN OR ENTATION AND MAGNETIZATION

In general, when both Rashba terms are present spin is not a good quantum number and we nd spin textures, with the spin direction depending on k and the wire transversal coordinate y. On the contrary, if R IC is neglected the states are proper eigenspinors even in the presence of an in-plane magnetic eld,¹¹ as seen from Eq. (6). Therefore, the existence of clear spin textures is a signature of the RIC term . The local spin components for the lowest subband at three di erent propagation momenta are shown in the upper plots of Fig. 3. W hile all in-plane spins are essentially collinear, a sizeable z-component, sim ilar in magnitude to the in-plane one, precludes the de nition of a com m on spin axis w hen $k \downarrow_0 \in 0$ and thus shows the importance of R IC. The local z-m agnetization in real space $h_z(y)$ is antisymmetric in y, leading to a vanishing integrated $h_z i_r^{20}$ and giving rise to spin accumulations at the wire edges which are rem iniscent of the intrinsic spin Hall $e \operatorname{ect}_{r}^{21}$ but here the e ect arises in a con ned system .²².






FIG.4: (Coloronline) Same as Fig. 3 for the second subband.

There are exceptional cases where the spin is well dened even in the presence of both magnetic eld and R IC. Forjkl₀j 1 one always nds asymptotic eigenstates of v_{r}^{20} irrespectively of the magnetic eld orientation , as seen in the lower plot of Fig. 3. For states with large negative (positive) k the spin is $h_y i =$ 1(+1). Im portantly, for k = 0 (the minimum gap point for = 0) we num erically nd h $_{x}i =$, regardless of the strengths of magnetic elds and intersubband coupling. This is clear from Eq. (9), which show s that the spinors are eigenstates of x at the minimum gap momentum. Therefore, there is always a given wavector k_g = $(l_1\!=\!l_2^2) \sin$, satisfying $k_{\alpha} = 0$, for which the propagation direction is also the spin quantization axis. Away from this special point, $_{\rm x}$ tends to zero (see Fig. 3) m ore slow ly for stronger elds. Lower plot in Fig. 3 displays also the spin expectation values h xi and h yi when RIC is not taken into account (dashed lines). As we will see later, the e ect of R IC in higher subbands is more notable but we emphasize that even in the low est subband the e ect of Rashba intersubband coupling is not negligible due to the observation of spin textures.

W e plot in Fig. 4 the spatially dependent m agnetization and the spin expectation values for the second subband with the same parameters as in Fig. 3. The e ect of R IC is more pronounced than in the low est subband as seen from the spin textures, which contain a noncollinear distribution even for the in-plane spin. In addition the local z-m agnetization is bigger than in the low er subband and exceeds the horizontal components, leading to large spin accum mulations at the wire edges. For k = 0we again nd that all local spins are properly aligned in the direction of transport. Rem arkably, the spin expectation values h_xi and h_yi change drastically when the Rashba interaction is fully included as shown in low er Fig. 4. When R IC is absent, both expectation values display abrupt jumps due to the subband crossings. A swe pointed out earlier, R IC avoids these crossings and this is re ected in a much sm oother behavior of h_xi and h_yi.

O pposite sign accum ulations of the z-m agnetization at the wire edges are already found in the B = 0 case.^{19,20} D i erences with respect to the zero eld case, how ever, can be sum marized in that the magnetic eld causes nonzero x-m agnetization across the wire for wavevectors around the minimum gap point. The tilted distributions of in-plane magnetizations in Fig. 3 are due entirely to the x-component of the eld. A dditionally, the texturing of the horizontal magnetization of the second subband (Fig. 4) is due to the combination of B and R IC. The magnetic eld also shifts the minimum gap momentum k_g from its zero value at vanishing B, for which an exact solution was obtained in the preceding section.




FIG. 5: Variation of the conductance with R ashba intensity and the Fermi energy in the full R ashba model ($l_2 = l_1$, upper panel) and neglecting R IC ($l_2 = 1$, lower panel). We set $l_2 = 1.8 l_0$ and parallelm agnetic eld = 0. A rigid shift with R ashba intensity has been taken into account de ning ~=~!_0 = =~!_0 + $l_0^2 = 8 l_1^2$. The numbers in the plateaus give the conductance in units of the conductance quantum. R ight sm all plots show vertical cuts of the corresponding left gures for the given values of $l_0 = 2 l_1$.

IV. TRANSPORT PROPERTIES

The linear conductance G at zero temperature is directly related to the wire subband structure through the form $ula_r^{9,11}$

which accounts for the number of occupied subbands propagating in a given direction and the conductance quantum per spin component, $G_0 = e^2 = h$. In Eq. (11), is the Fermi energy while ${}_{i}^{(j)}$ and m ${}_{i}^{(j)}$ denote, respectively, the energy and e ective m ass at the j-th local extrem um in the i-th subband. W e have also de ned (x) and sgn (x) as the step and the sign functions. For subbands containing a single m in im um G only attains $e^2 = h$ steps when is increased. In the case of more com plicated subbands it is easy to see from Eq. (11) that the linear conductance step is doubled whenever the Ferm i energy exceeds two local minim a but is below the energy of the maximum lying in between them. Once exceeds the energy of the maximum, the conductance is decreased by $e^2=h^{8,11}$ As discussed above the R IC can convert subband m axim a into m inim a and, therefore, G


is generally reduced when both term s are included.

For = 0 we plot in Fig.5 the linear conductance for the cases with R IC , $l_2 = l_1$ (upper panel), and without it, $l_2 = 1$ (lower panel). When RIC is not included, G alternates, with increasing , steps of $+2e^2 = h$ with downward jumps of \vec{e} =h due to the presence of maxim a in the lower subbands.¹¹ W hen R IC is included two m a pr m odi cations are apparent: a) Stronger Rashba couplings are needed to observe the alternate steps of $+2e^2$ = h and e^2 = h, and b) in any case this anom alous pattern of steps vanishes when increasing the Ferm i energy. Particularly, as shown by the insets, when $l_0=2l_1=$ 1 the sequence of conductance steps in units of G_0 is +2; 1;+1;+2; 1;+1;::: when RIC is neglected, and +2; 1;+1;+1;+1;::: when it is included. Therefore, Fig. 5 proves that to observe the modi cations of the linear conductance steps due to the Rashba interaction it is essential to have a relatively low Ferm i energy or, equivalently, a rather sm all num ber of propagating m odes.


Figure 6 shows the case = = 2. In low er Fig. 6, when l_2 = 1 , the conductance consists of regular jumps of one conductance quantum . From Fig. 2 (b) we determ ine that the width of the odd conductance plateaus corresponds to the Zeem an energy whereas the width of the even plateaus am ounts to 1 $(a=l_z)^2$ (in units of ~!₀). This physical scenario is strongly modied when RIC is taken into account, as seen in the upper Fig. 6 where the conductance shows a much richer behavior. It is remarkable the occurrence of restoration of the spin degeneracy for special values of the Rashba coupling and magnetic eld where the third and fin conductance plateaus collapse. In general, the tendency is to suppress regions for odd values of G. Thus, G presents wide (narrow) plateaus for even (odd) values of the conductance quantum but their widths are not trivially related to either the Zeem an energy or the con nem ent energy alone. Besides, at large Rashba strengths we also nd decreasing jum ps in the conductance.

V. CONCLUSIONS

W e have discussed the spectrum , spin orientation and linear transport of ballistic quantum wires in the presence of Rashba interaction and in-plane magnetic elds at an angle with the propagation direction. A nalytical and num erical results dem onstrating the crucial in portance of the Rashba intersubband coupling for all these properties and for k values near the subband gaps have been presented. At strong spin-orbit coupling the modications in the energy subbands include the appearance of sizeable shifts, anticrossings as well as big reductions of the subband maxima. The changes in subband structure lead to precise predictions for m easurem ents of the linear transport properties, such as a severe reduction of the anom alous conductance steps when = 0 and a nontrivial dependence of the steps with the Rashba intensity for = =2, with collapsing points for the odd plateaus.



Spin textures in the local magnetization are obtained only when the Rashba intersubband coupling is taken into account. Opposite-sign accum ulations of the spin zmagnetization at the wire edges are strongly dependent on the k-value and subband index. For subbands above the lower one we have shown that the horizontal magnetization is also textured. At a particular momentum (the minim um -gap momentum), depending on magnetic eld strength, orientation, and Rashba intensity, the analytical solution having the spin along the transport direction has been obtained. We believe these results are relevant for the future design of spin transistors and spin liters.
