#### Abstract

M otivated by a biased di usion of $m$ olecular $m$ otors $w$ ith the bias dependent on the state of the substrate, we investigate a random walk on a one-dim ensional lattice that contains weak links (called \bridges") which are a ected by the walker. N am ely, a bridge is destroyed w ith probability p when the walker crosses it; the walker is not allowed to cross it again and th is leads to a directed m otion. The velocity of the walker is determ ined analytically for equidistant bridges. T he special case of $p=1$ is $m$ ore tractable both the velocity and the di usion constant are calculated for uncorrelated locations of bridges, including periodic and random distributions.

## I. IN TRODUCTION

Them otion of a particle depends on the m edium. Of ten the inverse is also true, that is, the particle $m$ otion changes the medium . Such problem s are characterized by an in nite mem ory | not only the present position of the particle, but the entire past determ ines the future and they are usually extrem ely di cult. Perhaps the m ost fam ous exam ple is the self-avoiding walk which is a random walk on a lattice $w$ th the recoction that hops to already visited sites are forbidden Sim ilarly in a path-avoiding walk, a random walkeris not allowed to go over already visited links. H ere we exam ine a generalization of the path-avoiding walk in which the medium is a lattice w ith two kinds of links, strong and weak: strong links are una ected by the walkerw hile w eak links, called bridges, \bum" when they are crossed by the w alker. T he random walker is not allowed to cross a bumt bridge. O bviously the bumt bridge $m$ odel reduces to the pathavoiding walk if all links are w ${ }^{-1}$. We also investigate a stochastic bumt bridge $m$ ode in which the crossing of an intact bridge leads to buming only w ith a certain probability p,while w th probability $1 \quad p$ the bridge re$m$ ains intact.

The stochastic bumt bridge m odel is a sim pli cation .... oroposed to m im ic classical m olecular m c R ecently II has been show $n$ that the stochastic bumt bridge m odelw ith tw o w eakly coupled tracks (the walker $m$ oves on the ladder and the hopping rate betw een the tracks is sm all com pared to the hopping rate along the tracks) accurately describes experim ental results on the $m$ otion of an activated collagenase on the collagen bril.

W e shall focus on the one track stochastic bumt bridge m odel. Forbidding the crossing of bumt bridges essentially im poses a bias, and the goal is to com pute the velocity $v(c ; p)$ and the di usion coe cient $D(c ; p)$ as functions of the density of bridges $c$ and the bridge buming

[^0]probability p. The velocity and the di usion coe cient also depend on the positioning of the bridges. $W$ e shall tacitly assum e that the bridges are placed w thout correlations, and we shall often specify our ndings to two particularly interesting and natural positioning of the bridges | a regular equidistant spacing and a random distribution.

The rest of this paper is organized as follow $s$. In the next section, we describe various versions of the brumt bridge m odel and outline the m a jor results. Section is devoted to the derivation of the velocity and the di usion coe cient for the bumt bridn $m$ odel and a modi-
ed bumt bridge m odel. In Se the stochastic bumt bridge $m$ odel is studied, and the velocity is com puted for equidistant bridans. Finally, a few open questions are discussed (Sec V arious calculations are relegated to the A ppendices.

## II. M A IN RESULTS

In all versions of a bumt bridge model, the walker asym ptotically behaves as a biased random walk. M athem atically this $m$ eans that the probability of nding the walker at position x is a G aussian centered around $h x i=v t w$ th $w$ idth $h x^{2} i \quad h x i=2 D t$.

Away from the bridooc the walker hops to adjacent sites equiprobably ( $F$ if $T$ hus if there were no bridges, the velocity would be equalto zero and the di usion constant would be equal to $1 / 2$ (the lattice spacing and the tim e step between the hops are set to unity). B ridges (which are assum ed to be intact in itially) generate a directed $m$ otion. The velocity $v$ of the walker depends on the density of bridges $c$ and on the bridge distribution. $P$ articularly sim ple expressions are obtained for periodically and random ly positioned bridges

O fcourse, in the periodic case the density c attains only inverse integer values ( $1 ; 1=2 ; 1=3 ;:::$ ) while when bridges are placed at random the density can attain any value $0<c 1$.

In the realm of continuum approxim ation ${ }^{\text {nh }}$ e velocty v (c) has been com puted by M ai et al. Unexpectedly, the continuum approxim ation is exact in the periodic case; for random locations, the continuum approxim ation gives $v(c)=c=2$. This result is asym ptotically exact in the sm allc lim it, albeit overallit is just an approxim ation which $m$ ore and $m$ ore deviates from the exact result as the density approaches $\mathrm{c}=1$ (that is, for the path-avoiding walk).

The dependence of the di usion coe cient on the density of bridges $c$ is also relatively sim ple for periodically and random ly positioned bridges

The di usion coo cient $m$ onotonously decreases as cincreases (see Fif and D (1) $=0$ since on a lattice fully covered by bridges, the walker m oves determ in istically. The inishing ofD (c) has apmamently been observed in Ref Intriguingly, equation gives $D_{\text {per }}(+0)=1=3$ (D) ran $(+0)=3=2$ ) which is smaller (larger) than the $\backslash$ bare" di usion coe cient $D_{\text {bare }}=1=2$ that characterizes di usion on the one-dim ensional lattioe without bridges. This sudden jump of the di usion coe cient occurs when the density becom es positive. The reason is that any positive c (irrespectively how ever sm all it is) $m$ akes the lasting in uence on the fate of the walker who is foroed to rem ain to the right of the last bumt bridge. $T$ hus the very rare buming events substantially a ect the di usion coe cient.

The details of the walker dynam ics at the boundary of the bumt bridge a ect the velocity and the di usion coe cient. To ilhustrate this assertion recall that in the fram ew ork of the bumt bridge $m$ odel the walker at the boundary of the bumt bridge alw ays $m$ oves to the right. A nother naturalde nition is to allow an attem pt to cross the bumt bridge | the attem pt fails and the walker re$m$ ains at its position. W e cal ated the velocity for this m odi ed bumt bridge mode

Perhaps the largest di erence betw een the two $m$ odels is that in the realm of the $m$ odi ed bumt bridge $m$ odel the walker never m oves determ in istically $\mid$ even when $\mathrm{c}=1$ it moves di usively although the di usion coe cient is sm all, nam ely it is 4 tim es sm aller than the bare di usion coe cient. $N$ ot surprisingly, the quantitative predictions of the two madols am cubstantially di erent when c is large (see Figs

For the stocnastic bumt bridge m odel, we com puted only the velocity, and only for periodically located bridges. W e found

For c p, the distance betw een neighboring bridges is large. T hus the walker typically crosses the next bridge several tim es and hence alm ost all bridges get bumt. $T$ hemfore the $p=1$ results ought to be recovered. Equation show sthat this is indeed correct in the periodic case; in the random case (w here we do not know an exact solution) we sim ilarly expect $v$ ( $c ; p$ ) $c=2$ when $c \quad p$. In the com plim entary lim it p $\quad c$, the $w$ alker on average $m$ akes $m$ any steps before the buming occurs, and it is intuitively obvious that we can renorm alize c! 1 and sim ultaneously $p!q p$. Hence $v(c ; p)!v(1 ; q)$ when $\mathrm{p} \quad \mathrm{c}$, and therefore the asym ptotics gixon in can also be extracted from the sim ple solution

A nother interesting and experim entally accessible quantity is the fraction of bridges left intact by the walker. In the long time lim it it can be expressed as

$F$ igure show $s$ that the fraction of intact bridges is a decreasing function of $p$ for $x e d c$ (this is intuitively obvious) and an increasing function of c for sed p. This latter feature is understood by noting that on average a bridge is visited $m$ ore often when the density of bridges gets sm aller.

## III. THE BURNTBRIDGEMODEL

The walker hops x ! x 1 equiprobably when it is aw ay from the bumt bridges. T he lattioe spacing and the tim e step betw een successive hops are set to unity, and therefore the di usion coe cient is $D=1=2$ for the lattioe w th no bridges. W e assum e that in itially allbridges are intact. Let the walker cross a bridge for the rst tim e from the left. T his im plies that the w alkerw illnever cross it again and determ ines the fate of the w alker, nam ely the walker willdriff to the right and the closest bumt bridge willalwaysbe on the left. By de nition, when the walker is on the right boundary of the bumt bridge, it alw ays $m$ akes the step to the right.

Two special positioning of the bridges are regular
(equidistant locations) and random. These are tw o m ost interesting cases, although the form alism can be straightforw ardly extended to arbitrary distributions as long as the distances betw een neighboring bridges are uncorrelated.
A. Velocity and Di usion coe cient

The walker successively crosses the intact bridges which im m ediately tum into bumt bridges. Instead of the original walker it proves convenient to consider an equivalent walk whose position at time $t$ is on the right edge of the the last bumt bridge. This walk is still discrete in space and tim e, but the step length is now equal to the distance betw een successive bridges, and the tim e betw een the steps is at least as large as the step length. In general, we denote by ( $x$; $t$ ) the probability that the walk $m$ akes a step of length $x$ after waiting $t$ units of time.
$T$ he follow ing derivation is essentially the discrete tim e version fecalled continuous time random walk (C TRW) This title refers to the continuous nature of the the waiting tim e distribution, while in our m odel the discrete nature of tim e is essential, and therefore we present the com plete derivation of the necessary results. N ote also that even though ourw alk alw ays steps to the right, the derivation is the sam e as for a general w alk which can step in both directions; hence, we present a generalderivation.

For the system with bim odalbridge distribution and apparently for an arbitrary uncorrelated positioning of bridges, the di usion coe cient exceeds that of the corresponding periodic system at the sam e bridge density. This general assertion is easy to verify in a particularly interesting case when the density of bridges vanishes. A straightforw ard analysis of q fusion coe cient is larger than 1/3, wnich is the di usion coe riont in the periodic case ( $q_{1}=0$ or $q_{2}=0$ ). From Eq. one nds that for a 1 , the $m$ aximal di $u$ sion coe cient, approxim ately $D \quad \frac{10}{81} r^{2}$, is achieved when the system is predom inantly com posed of shorter segm ents ' 1 , nam ely when $q_{2} \quad r^{2}=2$. Therefore a $\backslash$ supenposition" of tw o equidistant distributions, each characterized by the di usion coe cient $1 / 3, \mathrm{~m}$ ay have an anbitrarily large di usion coe cient.

## 2. Sim ulations

The velocity and the di usion coe cient of the walker are determ ined using the basic form ulas $v=h x i=t$ and $D=\left(h x^{2} i \quad h x \neq 1\right)=2 t$. Since the $m$ otion is self-averaging, sim ulating a single walker for a long time is su cient to obtain the velocity. To $m$ easure the di usion coe cient, how ever, one has to perform averages over several runs. In the case of random ly distributed bridges, one also has to averan over the bridge distribution.
$F$ igur show s num erical results for the di usion Co e cient at various tim es. The convergence to the theoretical predictions is slow when the density of bridges is sm all. D uring a short tim e interval the walker does not reach the second bridge, and actually behaves as a simple random walk with a re ecting boundary at the origin. H ence the probability of nding the particle at position $\mathrm{x} \quad 0$ is a G aussian centered around the origin, and the form alde nition ofthe di usion coe cient yields D $=1=2 \quad 1=$. For the tim e intervals large com pared to the tim e (ofthe order of $c^{2}$ ) betw een overtaking successive bridges, the coarse-grained $m$ otion becom es sim ilar to a biased random walk with the di usion coe cient approaching the theoreticalpredictions: $D(+0)=1=3$ in the periodic case and $D(+0)=3=2$ in the random case.

## B . C orrelation function

A rrelation function $m$ easu experim entally in Ref is apparently proportiona to the probability $C$ ( $t$ ) that the walker at the site $x_{0}$, will be at the sam $e$ position tim et later.

As a warm up, consider the extrem e cases of the lattioe w ithout bridges ( $c=0$ ) and the lattice fiully covered by bridges $(c=1)$. In the form er case, the correlation function obviously vanishes for odd $t$ while for even $t$ it is given by the well-known expression

The correlation function is m erely the probability that this ordinary random walkerwillbe at $x=0$ at timetand will rem ain inside the extended cage in interm ediate tim es. T his is a classic problem in probability theory whose solution is a cum bersom e sum of expressions like w ith altemating (positive and negative) signs. T neretore we em ploy a continuum approxim ation which becom es asym ptotically exact when ' 1 (and accordingly $c=111$ ). The solution is an in nite series of exponentially decaying term s . Recall, how ever, that in the stochastic version $(p<1)$ when the walker attem pts to hop over the bridge from the left and the bridge bums, the walker actually rem ains at the sam e position. This suggests to $m$ odify the rule at the boundary of the bumt bridge | the walker either $m$ oves one step to the right or rem ains at the sam e position if it has tried the forbidden $m$ ove across the bumt bridge. This de nes the modi ed bumt bridge $m$ odel.
$T$ he calculation of $v(c)$ and $D$ (c) goes along the cam lines as for the original bumt bridge modol (Sec and leadcto the mesults presented in Sec nd displayed on $F$ igs

Forc = 1, thedi usion coe cientofE o is the same D $(1)=1=8$ in both the periodic and the random case. $T$ his particular result also follows from an independent calculation which we present here as it provides a good check of self-consistency. The key sim plifying feature of the lattioe fully covered w ith bridges is that the walker never hops to the left. T he position $x_{t}$ of the walker after $t$ time steps satis es

IV. THESTOCHASTIC BURNTBRIDGE M ODEL

A part from random ness in hopping, the stochastic bumt bridge $m$ odel has an additional stochastic elem ent | crossing the bridge leads to buming with probability p while with probability $1 \quad p$ the bridge rem ains intact. To avoid the possibility of trapping we additionally assum e that if the particle attem pts to cross the bridge from the right and the bridge bums, the attem pt is a failure and the walker does not $m$ ove. W e have succeeded in com puting $\mathrm{v}(\mathrm{c} ; \mathrm{p})$ in the situation when the bridges are equidistant. W e again em ploy an anmmach involving auxiliary functions $T(x)$ (see A ppendi and $L(x)$ (dened below ). P erhaps, the entire problem fan he treated by a direct approach discussed in A ppendi but that approach is $m$ ore lengthy and we have only succeeded in com puting the velocity for $\mathrm{c}=1$ that way.

W e must determ ine the average position of the rst bridge that bums, and the average time of that event. $T$ he walker starts at $x=0$, but it is again useful to consider a m ore general situation when the walker starts at an arbitrary position $x$. D enote by $L(x)$ the average position of the walker at the $m$ om ent when the rst bridge bums. The walker hops x ! x 1, and therefore

The calculation of the di usion coe cient seem sto be very challenging. For a system fill of bridges ( $c=1$ ), how ever, the walk is som ew hat analogous to the $p=1$ (and $c<1$ ) case, and D $m$ ight be nnacible to derive us ing the approach presented in Sec The com plete analysis appears to be very cum bersome, but if p! 0 in addition to $c=1$, the sucoessive bumt bridges are (on average) separated by large gaps and therefore one can em ploy a continnous treatm ent. Follow ing the steps described in Sec e obtained $D=1=4$. Thispredic tions agrees w ith sm ulations. Interestingly (see Fig
$D$ is a non $m$ onotonous function of $p$.
Solving the stochastic bumt bridgem odelfor random ly distributed bridges does not look possible in the realm of the above fram ew ork. Indeed, instead of working w ith ordinary determ inistic recurrences like me has to tackle stochastic recurrences (see A ppenal

## V．D ISC U SSIO N

O ur current understanding of the stochastic bumt bridge m odel is certainly incom plete｜only the periodic case is som ew hat tractable，albeit even in this situation we do not know how to com pute various interesting quan－ tities like the di usion coe cient or the probability that in the nal state tw o nearest bumt bridges are separated by $k$ intact bridges．

In $m$ any biological applications，$m$ olecular $m$ otors m ove along a hom ogeneousprn er lam ent（kinesin and m yosin are classicalexam ples ，while in other applica－ tions the track is inhom ogeneous（this particularly hap－ pens when $m$ otors $m$ ove along D NA ）．It w ould be inter－ esting to study the bumt bridge $m$ odelw hen in addition to the disorder related to location of the bridges there is the disorder associated w ith hopping rates．E arlier w ork ．．nn walkers under the in uence of a random force and references therein）and recent work moti－ vatea by single－m olecule－．．．．．．．．ents on $m$ otors $m$ oving along a disordered track $m$ ay be useful in that regard．
