The independent scattering approximation in the saturated regime

We show that a saturable single-frequency elastic T -m atrix approach to scattering of light by atom s agrees rem arkably well with a master equation description in the regime of unsaturated atom s, or for large separation between the atom s. If the atom s are in each other's near- eld and the saturation of the atom s is high enough, the two approaches yield di erent results.

#### I. IN TRODUCTION

A pplications of multiple scattering of light by pointscatterers are often based on the assumption that the scatterers under consideration scatter light independently from one another. All the scattering properties of each individual scatterer can then be expressed by a single m athem atical object called the scatterer's T -m atrix [1, 2]. This single-scatterer T -m atrix is used as a building block in multiple-scattering theories [3] which can accurately describe m any interesting phenom ena [4, 5]. H ow ever, the use of T -m atrices usually in plies that one considers only elastic scattering. A though the restriction of scattering events to the pure elastic ones is justi able in some cases, it is not necessarily correct for, e.g., scattering of high-intensity incident light elds [6].

In this paper, we will consider scattering of light by two atoms. The \atoms" could be implemented as any type of sub-wavelength quantum objects, for example: trapped atoms, quantum dots [7], trapped ions [8] or dye molecules. If we model the atoms as point-dipoles, we can use the T-matrix formalism to describe scattering of incident light. A liternatively, we can model the atoms as two-level systems, in which case multiple scattering of light can be studied using a master equation [9, 10, 11]. The system is then characterized by a density matrix, representing the coherences and populations of the atom ic levels. Scattering of incident light then determines the evolution of the density matrix, while taking into account all orders of multiple scattering as well as inelastic scattering of light.

The goal of this paper is to compare the scattering properties of two atoms as described by a simple T - m atrix approach and a (computationally much more involved) master equation approach. We will show that a saturable single-frequency elastic T - m atrix approach agrees remarkably well with a master equation description in the regime of unsaturated atoms or for large separation between the atoms.




FIG.1: The system under consideration: two identical atoms s 1 and 2 are positioned in free space at a distance  $r_{12}$  from each other. Both atoms have a two-level internal structure. The upper level has a lifetim e  $\frac{1}{ba}$ . Both atoms interact with an incident eld; this interaction is depicted by the dashed arrow s.

The new aspect of this work is the comparison of two approaches which seem completely di erent at rst but are in fact closely connected. We stress that the two approaches them selves, reviewed for clarity in sections II and III of our paper, have been extensively studied previously (see, e.g., [1, 9])

This paper is organized as follows. We start in Section II by describing the system we are considering. A master equation approach allows us to calculate how a near-resonant monochrom atic incident eld is scattered. In Section III, we consider the same system, and use a T - matrix approach to determ ine the scattering properties of the system. In Section IV we compare both m ethods. In Section V, nally, we discuss the applicability of our results to other atom ic system s.

## II. THE DENSITY MATRIX APPROACH TO SCATTER ING OF LIGHT

We start by considering the system shown in Figure 1. Two identical atoms are positioned in free space, separated by a distance  $r_{12} = jr_{12}j$ . Both atoms are modelled as a two-level system with upper level b and lower level a, separated by an energy di erence  $\sim!_{ba}$ . Decay between both levels occurs according to the decay

rate  $_{ba}$ . A transition dipole m om ent  $d^{i}_{ab}$ , i 2 f1;2g is associated with both b! a transitions. Both transition dipole m om ents are chosen to be equal in m agnitude and orientation:

An incident monochrom atic eld E<sub>0</sub> with wave vector  $k_0$  interacts with both atom s. The frequency  $!_0 = j_{k_0} j_c$  of the incident eld is tunable and chosen near the b! a resonance (c is the velocity of light in free space). For simplicity, we have taken the wave vector  $k_0$  of the incident eld perpendicular to  $r_{12}$ . This choice of  $k_0$  ensures that both atom s always feel the same phase of the incident eld, which makes the calculations som ewhat easier without a ecting the generality of our results.

W e will now derive the master equation of the system; the following derivation closely follows [12]. The total H am iltonian  $\hat{H_0}$  describing the energies of the systems, the electrom agnetic eld and interactions is, in the standard electric dipole and rotating wave approximation, given by

The Ham iltonian of both individual atom s is given by

with  $\hat{S}_i$  the dipole raising and low ering operators of atom i. Both atom s are coupled to the three-dimensional multimode electrom agnetic eld with H am iltonian

where the operators  $\hat{a}_{k}^{y}$  and  $\hat{a}_{k}$  respectively create and annihilate a photon in demode (k; ). The modes of the electrom agnetic eld are taken to be in a vacuum state. Both atom s also interact through the H am iltonian

with an incident eld E  $_0$  with frequency  $!_0$ , where the Rabi frequency is given by  $jl_{ab}$   $fj=\sim$ . Finally, the atoms interact with the multimode vacuum eld through the Ham iltonian

with  $L^3$  the quantization volume, " $_0$  the vacuum permittivity and " $_k$  the unit polarization vector of the eld mode (k; ).

The dynamics of the total system can be expressed in terms of the M aster equation for the density m atrix ^. The M aster equation is, in the standard Born and M arkov approximation, written in the Lindblad form, given by [12, 13]

It is clear from equations (10) and (11) that the vacuum induces coupling between both atoms [14, 15, 16, 17]. The parameters  $^{(12)}$  and  $^{(12)}$  are not associated with individual system s, but with the total system as a whole. The cross-dam ping  $^{(12)}$  represents incoherent coupling between both atom s through spontaneous em ission




FIG.2: The coherent coupling (Figure a) and the incoherent coupling (Figure b) (in units of ) as a function of the dimensionless parameter x  $!_{ba}r_{12}=c$ . We have chosen perpendicular to  $r_{12}$ , which is the case in the system studied in this paper.

where we dened the dimensionless parameter x  $!_{\text{ba}}r_{12}=c$ , and where we used the fact that ?  $r_{12}$ . Both couplings  $^{(12)}$  and  $^{(12)}$  depend strongly on the distance between the atoms and the orientation of and  $r_{12}$ . In Figure 2 we show how  $^{(12)}$  and  $^{(12)}$  evolve as a function of x. For large separations (x 1), the two couplings  $^{(12)}$  and  $^{(12)}$  vanish, independent of the orientation of the dipole moments. However, for sm all separations (x 1),  $^{(12)}$  and  $^{(12)}$  diverges for sm all separations,  $^{(12)}$  reduces to the single-atom decay rate

The standard method of solving the Master equation (8) is to calculate equations of motion for the density matrix elements and solve them by direct integration [18, 19]. This procedure means a set of 16 linear di erential equations has to be solved. Using the resulting density matrix, we will calculate the total eld, resulting from the scattering of E  $_0$ . We therefore need to establish a relation between the total eld and the calculated density matrix ^ (t). Before establishing such connection, we note that from a didactic point of view, it is easier to connect both methods described in this paper if we calculate the total eld in the far-eld zone, i.e., jrj  $r_{12}$ ; (!  $_{ba}$ =c) <sup>1</sup>. We stress, however, that our conclusions are also valid for observation points r in the near-eld zone. The total electric eld operator is given in the far-eld by [10]

In the steady-state regime, the coherences in the system (the  $\circ$  -diagonalelements of the density matrix) oscillate in phase with the incident eld. We can easily study the behavior of the coherences by transforming to the interaction picture

Expression (21) expresses the total eld E on resonance as a function of the scattering properties of the atom s, without making any assumptions regarding the independence of both scatterers.

# III. THE T-MATRIX APPROACH TO SCATTER IN G OF LIGHT

We now reconsider the system shown in Figure 1. We model both atoms as point-dipoles with dipole moments given by (1), and study the dynamics of the system using a T-matrix approach instead of a density matrix approach. The total eld E at any position in the three-dimensional coordinate space can be written as the sum of the incident eld and the eld scattered by both atoms [20]:

where the integrations are over the full three-dimensional coordinate space. The 3 3 dyadic G reen's function  ${}^{\$}_{G_0}(!;r)$  has as representation in coordinate space [21]:

where denotes the tensor product. The 3 3 unit tensor is denoted as  $I^{(3)}$ . We note that the G reen's (23) function is related through (24) to the coherent coupling <sup>(12)</sup> and incoherent coupling <sup>(12)</sup> which arise in a master equation approach (see expressions (15)) by

indicating that coupling through the vacuum is intimately connected to ordinary free-space propagation. The T-m atrix  $\tilde{T}$  of the total scattering system is given by

where the delta-functions clearly depict the local character of both scatterers. The the  $_{\rm s}2$  2 unit tensor is denoted by I<sup>(2)</sup>. The 2 2 m atrix D is given by

Each atom has a T-m atrix element t(!) describing its scattering properties. In the system we are considering the T-m atrix elements of both atoms are equal because the atoms are identical. In the limit of low-intensity incident elds, the T-m atrix element t(!) is given by the well-known expression for the dynam ic polarizability of a two-level atom [22]

For incident waves of higher intensities, both atom s will show saturation e ects. The extension of expression (28) beyond the low-intensity limit is given by [23, 24]

which takes into account the bss of photons at frequency ! due to inelastic scattering; the inelastically scattered photons at frequencies !  $^{0}$   $\frac{6}{2}$  ! are not described. The saturation parameter s is de ned as (see, e.g., [9])

Equation (31) is the result of a T-m atrix calculation, expressing the total eld E as a function of the incident eld E  $_0$  and the scattering properties of both atom s, explicitly assuming that they are independent from one another.

## IV. COMPARISON OF BOTH METHODS AND DISCUSSION

W e now compare expressions (21) and (31) and discuss their discrepancies. We consider three regimes.

### A. Low-saturation incident eld

If the saturation is very small (s 1), the steadystate value of the density matrix can be calculated analytically. The resulting steady-state expectation value  $\hat{S}_i$ , i 2 f1;2g is, using the linear expression (28),

which yields, if substituted in (21), the same expression (31) as given by a T-m atrix approach, hereby proving the validity of the T-m atrix form alism for low-intensity incident elds for arbitrary separation between both atom s.

### B. A tom s in each other's far-eld: $r_{12}$ (! $_{ba}=c$ )<sup>1</sup>


In the lim it of large separation between both atoms  $r_{12}$  (!  $_{ba}$ =c) <sup>1</sup>, both the coherent coupling <sup>(12)</sup> and the incoherent coupling <sup>(12)</sup> reduce to zero. In this regime, the density matrix ^ obeys



where  $_0$  is the (2 2) density matrix corresponding to a single two-level system (see, e.g., [9]), and Tr<sub>i</sub> stands for the trace over atom i. In other words, if both atom s are in each other's far-eld, the single-atom density matrix factorizes out in two single-atom density matrices. This result corresponds with the intuitive expectation that the independent scattering approximation (31) is valid for large separation.


## C. A rbitrary separation and incident eld in the saturated regim e




FIG.3: The realpart of the eld component  $E[!]=E^{(0)}$  on resonance, evaluated at the perpendicular bisector of  $r_{12}$ . The R abi frequency of the incident eld is chosen = 1. The eld has been calculated using both the T-m atrix form alism (solid line) and the density matrix form alism (dotted line). The eld has been plotted as a function of the detuning , for (a) atom s in each other's far-eld, and for (b) atom s in each other's near-eld.

If the saturation parameters is of order 1 or larger and the separation between the atom s is of the order of (or sm aller than) ( $!_{ba}=c$ )  $^{1}$ , no easy analytic expressions for the density matrix exist. However, the density matrix and the total eld can still be evaluated num erically. In Figure 3 - 6, we have calculated E [;r] using expressions (21) and (31). Obviously, the num erical value of the total eld com ponent E [**!;**r] depends on num erous param eters such as the incident eld strength, the distance between both atom s, the evaluation point r and the frequency of the incident eld. It is not our intention, however, to fully explore the entire (! ha  $!_0$ ;r;r<sub>12</sub>; ) parameter space. We only want to point out that di erences between both methods do arise, and explain why.





(a)  $r_{12} = 100 (!_{ba} = c)^{-1}$

As an example, the eld has been evaluated at the perpendicular bisector of  $r_{12}$ . The eld is shown in units of




FIG. 4: The imaginary part of the eld component E [!\_0]=E  $^{(0)}$  on resonance, evaluated at the perpendicular bisector of  $r_{12}$ . The Rabi frequency of the incident eld is chosen = = 1. The eld has been calculated using both the T-matrix form alism (solid line) and the density matrix form alism (dotted line). The eld has been plotted as a function of the detuning , for (a) atom s in each other's far-eld, and for (b) atom s in each other's near-eld.

Figure 3 and 4 show the eld as a function of the detuning  $2(l_{ba} l_0)$ . Figure 5 and 6 show the eld as a function of the Rabi frequency , expressing the intensity of the incident eld. It is clear that if both atom s are in each other's far- eld  $(r_{12} (l_{ba}=c)^{-1})$ , or if the saturation parameter is very small (s 1), the predictions of the T-m atrix approach and the density matrix approach coincide, as explained above. However, we see that for atom s in each other's near- eld  $(r_{12} (l_{ba}=c)^{-1})$ , the predictions of both approaches deviate for increasing sat-


uration parameter of the incident eld. At very high saturation (s 1), both approaches again yield the same results.

We can explain the di erence between both approaches as follows. For low -intensity incident elds, both atoms scatter light purely elastically. At higher intensities, m ore light is scattered inelastically (and less light elastically). In a T-m atrix approach, the coupling of both atom s with inelastically scattered light is not taken into account. This explains why, in the case of a single scatterer, the T-m atrix approach is exact, why for multiple scatterers, problem s can arise when using T-m atrices. The reason for this is that in the regime where the Tm atrix approach breaks down, it is in possible to quantify the incident light on each scatterer, since the incident light to a certain extend consists of incoherent light, generated by multiple inelastic scattering between both

atom s. It is then no longer possible to de ne a singlescatterer scattering property, since coherences arise between di erent scatterers, which are induced by inelastically scattered light. Finally, at very high intensities of the incident eld, both atom s will be com pletely saturated, regardless of the approach one uses to calculate the eld. This saturation explains why for large s, the results produced by both m ethods again coincide.

## V. EXTENSION

We stress that the breakdown of the independent scattering approximation we describe here applies to many other systems. In general, all systems where the contribution of incoherent light is not negligible will

experience a breakdown of the independent scattering approximation. If, for example, one wishes to describe atom is systems with gain [23] or the e ect of saturation on coherent backscattering [25, 26, 27] using independent atom s, one is limited to large separations between the atom s. If one wishes to describe these systems for atom s in each other's near-eld, then the atom s cannot be described (from a light scattering point of view) as individual entities; they are to be considered as one large indivisible system . Only a description taking into account all self-induced internal coherences, such as a density-matrix description, then produces correct results.

### VI. SUMMARY

In this paper, we studied the scattering properties of a system consisting of two atoms in free space. The scattering of incident monochrom atic light has been considered, using both a saturable single-frequency elastic T-m atrix approach and a density matrix approach. The former method assumes both atoms to be independent, while the latterm ethod does not make such initial assumption. We found that in the regime of low saturation parameters, or for large distance between both atoms, both approaches yield the same predictions. However, if the atoms are in each other's near-eld and the saturation parameters

is high enough, the two approaches produce di erent results. This discrepancy is due inelastic scattering of light, which is not taken into account in a T-m atrix approach.
