# Far- eld approxim ation for hydrodynam ic interactions in parallel-w all geom etry

A bstract

A com plete analysis is presented for the far-eld creeping ow produced by a m ultipolar force distribution in a uid con ned betw een two parallel planar walls. W e show that at distances larger than several wall separations the ow eld assum es the H ele-Shaw form, i.e., it is parallel to the walls and varies quadratically in the transverse direction. T he associated pressure eld is a two-dim ensional har$m$ onic function that is characterized by the sam emultipolar num berm as the original force $m$ ultipole. U sing these results we derive asym ptotic expressions for the G reen's m atrix that represents Stokes ow in the wall-bounded uid in term s of a multipolar spherical basis. This Green's matrix plays a central role in our recently proposed algorithm $\mathbb{P}$ hysica A $x x, x x x$ (2005)] for evaluating $m$ anyłoody hydrodynam ic interactions in a suspension of sphericalparticles in the parallelw all geom etry. Im plem entation of our asym ptotic expressions in this algorithm increases计se ciency substantially because the num erically expensive evaluation of the exact $m$ atrix elem ents is needed only for the neighboring particles. O ur asym ptotic analysis will also be useful in developing hydrodynam ic algorithm sfor wall-bounded periodic system $s$ and im plem enting acceleration $m$ ethods by using corresponding results for the tw o-dim ensional scalar potential.

## 1 Introduction

N um erical and theoretical investigations of particle motion in suspensions bounded by planar walls require e cient m ethods for evaluating hydrody-

[^0]nam ic interactions in these system s . Exam ples of phenom ena where the hydrodynam ic wall e ects are im portant innonntive particle motion in quasiboidin ensional colloidal suspensions , and nnform ation dynam ics of a DNA molecule in a parallel-plate $m$ icrochanne-

Several m ethods for evaluating hydrodynam ic interactions in wall-bounded system s have been proposed. In some studies, the ow re ectad from the
 di erence techniques. In a di erent -noroach , the exact point-force solution for the ow between the walls wored. W all e ects were also included using a multiph m and several approxim ation $m$ ethods were proposed . . . While all of these $m$ ethods have their m erits, they also have som e essential disadvantages, such as a high num erical cost or an insu cient (in $m$ any cases unknown) accuracy.

Recently we have derived . , a novel algorithm for evaluating hydrodynam ic friction $m$ atrix in a wall-bounded suspension of spheres under creepingow conditions. ${ }^{3}$ O ur C artesian-rep resentation $m$ ethod relies on transform ations between a spherical basis set of solutions of Stokes equations (this set is consistent w ith the particle geom etry) and a C artesian basis set (which is consistent w ith the wall geom etry). T he algorithm provides highly accurate results for $m u l t i p a r t i c l e ~ f r i c t i o n ~ a n d ~ m o b i l i t y ~ m a t r i o e s . ~$

U sing our approach, we have obtained several interesting num erical results. In particular, we have show $n$ that the friction $m$ atrix undergoes a crossover from the quasi-three-dim ensional to quasi-two-dim ensional form when the interparticle distance becom es larger than the wall separation H.W e have also observed an unusually large resistance coe cient for a long rigid chain of spheres in transverse $m$ otion ( $w$ ith respect to the orientation of the chain) in a narrow, wall-bounded space. Since both these e ects involve ow on the length scale 1 H , they are not captured by the usual singlewall superposition approxim ation whir 'pes not properly take the far-eld ow into account (as dem onstrated in '.

Large-scale studies of particle dynam ics in the ton geom etry require efcient simulation algorithm s . In our approach the m ost expensive part is evaluation of the $G$ reen's $m$ atrix $G$ in the $m u l t i p o l a r ~ r e p r e s e n t a t i o n . ~$ This $m$ atrix is a key quantity in our algorithm | its elem ents correspond to the coe cients in the expansion of the hydrodynam ic $G$ reen's tensor for the wall-bounded system into multipolar basis elds. The inverse of the $G$ reen's $m$ atrix combined $w$ ith the one-particle re ection $m$ atrioes yields the $m$ ultiparticle hydrodynam ic friction $m$ atrix.

In our algorithm . the $m$ atrix $G$ is expressed in term $s$ of lateral Fourier

integrals w ith respect to the tw o-dim ensional wave vector in a plane parallel to the walls. Evaluation of these integrals is especially di cult for widely separated particles due to the oscillatory character of the integrands. In the present paper we derive $m$ uch sim pler asym ptotic form ulas for the $m$ atrix $G$ in the far- eld regim e.W hen the particle separation is su ciently large, these form ulas can be used instead of the Fourier integrals, resulting in a signi cant reduction of num erical cost (and in other im portant sim pli cations).

O ur analysis of the asym ptotic form of the $m$ atrix $G$ relies on the observation that in the far- eld regime the velocity eld in the space between the walls assum es a sim ple H ele-Shaw (ie. the hubrication) form . A coordingly, the ow eld has only the lateral com ponents and it varies quadratically across the space between the walls. Such a ow eld is entirely determ ined by the corresponding pressure eld, which is a two-dim ensional harm onic function that depends only on the lateral coordinates. It follow s that at large distances $r \quad H$, the full three-dim ensional hydrodynam ic problem is reduced to a much sim pler two-dim ensional scalar problem for the pressure.

This paper is organized as follow s. O ur m ethod for evaluating $m$ anyparticle hydrodynam ic interactions in the parallelw all geom etry is sum marized in Secs. 2 and 3 . Section 2 recalls the induced-force form ulation of the problem, and Sec. 3 summ arizes the foroem ultipole expansion $m$ ethod. The m ain theoretical results of the present analysis are given in Sec. 4, where the Hele-Shaw approxim ation for the far-eld ow is discussed, and explicit expressions for G reen's $m$ atrix $G$ are derived. In Sec. 5 we present som e results of num erical calculations. W e show the dependence of G reen's m atrix elem ents on the intenparticle distance, and we illustrate the role of their fareld behavior in the description of hydrodynam ic interactions in rigid arrays of spheres. C oncluding rem arks are given in Sec. 6, and som e technical details are presented in the appendioes.

## 2 M ultiparticle hydrodynam ic interactions

### 2.1 Hydrodynam ic resistance

$W$ e consider the $m$ otion of $N$ spherical particles of the radius a, which are suspended in a uid ofviscosity , under creeping- ow conditions. The system is bounded by two planar parallel walls at the positions $z=0$ and $z=H$, $w h e r e r=(x ; y ; z)$ are the $C$ artesian coordinates. $T$ he centers of particles $i=$ $1::: \mathrm{N}$ are at positions $\mathrm{R}_{\mathrm{i}}=\left(\mathrm{X}_{\mathrm{i}} ; \mathrm{Y}_{\mathrm{i}} ; \mathrm{Z}_{\mathrm{i}}\right)$, and the translational and rotational particle velocities are $U_{i}$ and $i$. The extemal foroes and torques acting on the particles are denoted by $\mathrm{F}_{\mathrm{i}}$ and $\mathrm{T}_{\mathrm{i}}$. It is assum ed that the ow eld satis es
the no-slip boundary conditions on the particle surfaces and the walls.
For a system of spheres undergoing translational and rotational rigid-body $m$ otion with no extemal ow, the particle dynam ics is characterized by the resistance $m$ atrix
de ned by the linear relation

The dot in the above equation denotes the $m$ atrix $m$ ultiplication and contraction of the $C$ artesian tensorial com ponents of the resistance $m$ atrix. O ur goal is to calculatn the msistance $m$ atrix , or its inverse, the $m$ obility $m$ atrix . O urm ethod . for evaluating these quantities is outlined below.

### 2.2 Induced-force form ulation

Thee ect of the suspended particles on the surrounding uid can be described in term $s$ of the induced-force distributions on the particle surfaces. These distributions can be written in a form

is the $G$ reen's function for the Stokes ow in the presence of the boundaries; the $G$ reen's function $T\left(r ; r^{0}\right)$ is decom posed into the $O$ seen tensor

and the part $\mathrm{T}^{0}\left(\mathrm{r} ; \mathrm{r}^{0}\right)$ that describes the ow re ected from the walls. In Eq. (5) it is assum ed that the particles m ove w ith given velocities, but no extemal ow is im posed.

The resistance relation (2) is linked to the induced-force distributions (3) through the expressions

for the total force and torque, respectively. To determ ine the resistance $m$ atrix (1) we thus need to evaluate the induced foroes (3) for given translationaland angular velocities of the particles.

### 2.3 B oundary-integral equations for the induced forces

For a system of particles $m$ oving $w$ ith the translational and angular velocities $U_{i}$ and ${ }_{i}$, the induced-foroe distribution (3) can be obtained from the boundary-integral equation

is the rigid-body velocity eld associated w ith the particle $m$ otion, and $S_{i}$ is the surface of particle $i$. In the boundary-integralequation (9), $z_{i}$ denotes the one-particle scattering operator that describes the response of an individual particle to an extemal ow in an unbounded space. This operator is de ned by the linear relation

### 3.1 Sphericalbasis elds

A $s$ in a standard force-m ultipole approach
the boundary-integralequation (9) is transform ed into a linear $m$ atrix equation by projecting it onto a spherical basis of Stokes To this end we use the reciprocal basis sets de ned by C ichocki et al. . We introduce, how ever, a slightly di erent norm alization to exploit the full sym $m$ etry of the problem .

The singular and nonsingular spherical basis solutions of Stokes equations $\mathrm{v}_{\mathrm{lm}}(\mathrm{r})$ and $\mathrm{v}_{\mathrm{lm}}^{+}$( r ) ( w ith $\mathrm{l}=1 ; 2 ;:: ; \mathrm{m}=1 ;::: ; l_{\text {; and }}=0 ; 1 ; 2$ ) have the follow ing separable form in the spherical coordinates $r=(r ; ~ ; ~)$ :

The coe cients $V$ m ( ; ) and $V_{l m}^{+}$( ; ) are com binations ofvector spherical harm onics $w$ th angular order land azim uthal orderm. This property and the $r$-dependence in equations (12) de ne the Stokes- ow elds $\mathrm{v}_{\mathrm{lm}}$ (r) up to norm alization.

W e use here a convenient norm alization introduced in . which em phasizes various sym $m$ etries of the problem . Explicit expressions for the functions $V{ }_{\mathrm{lm}}$ in this norm alization are given in Appendin. A. We note that both in our present ${ }^{-n d}$ in the originalnom alization , the basis elds $v_{l m}$ satisfy the identity

The reciprocal basis elds and the bra\{ket notation (15) allows us to conveniently represent expansions of Stokes ow elds into the com plete sets of nonsingular and singular basis elds (12). ### 3.2 M atrix representation

Equations (18) and (20) indicate that the $m$ ultipolar $m$ om ents $f_{i}(\mathrm{~m}$ ) are identical (apart from the trivialfactor ) to the expansion coe cients of the ow eld scattered by an isolated particle in unbounded space into the singular basis elds $\mathrm{v}_{\mathrm{lm}}$.

To obtain a linear $m$ atrix equation for the set of force $m u l t i p o l a r m$ om ents $f_{i}$ ( $l m$ ), representation (18) is inserted into the boundary-integral equation (9), and the resulting expression is expanded into the nonsingular basis elds

The nst term $Z_{i}{ }^{1}\left(l_{i} \quad j{ }^{0}\right)$ is associated $w$ ith the one particle operator $Z_{i}{ }^{1}$ in equation (9), and it relates the force multipoles $f_{i}\left(l^{0}{ }^{0}{ }^{0}\right)$ induced on particle i to the coe cients in the expansion of the ow eld incom ing to this particle into the nonsingular spherical basis elds (12b). By the spherical sym $m$ etry, this term is diagonal in the indioes $l$ and $m$ and is independent of $m$. The $G$ reen's $m$ atrioes $G_{i j}^{0}\left(\mathrm{~lm} \quad j l_{m}{ }^{0}\right.$ ) and $G_{i j}\left(\mathrm{~m} \quad j l_{m}{ }^{0}{ }^{0}\right)$ are associated w ith the integral operators that involve the kemels $T^{0}\left(r ; r^{0}\right)$ and $T\left(r ; r^{0}\right)$.U sing the orthogonality relations (14) one can show that the elem ents of these $m$ atriges correspond to the expansion of the ow produced by a foroem ultipole centered at $R_{j}$ into the nonsingular basis ( 12 b ) centered at $R_{i}$.
$\square \mathrm{mm}$.in expressions for the single-particle re ection m atrix $\mathrm{Z}_{i}{ }^{1}$ arew ell know n . Q uadrature form ${ }^{-1-n}$ for the $G$ reen's $m$ atrix $G_{i j}$ have been derived in our recent publication . , where the $m$ atrix elem ents $G_{i j}$ ( m are represented as a combination of the free-space $G$ reen's matrix and the wall contribution $G_{i j}^{0}\left(\mathrm{~m} \quad j l^{0}{ }^{0}\right)$ that is given in a form of a H ankel transform of a product of several sim plem atriges. The H ankeltransform arises from angular integration of lateral Fourier m odes of Stokes ow.

The $m$ any-particle resistance $m$ atrix (1) can be obtained by solving Eq. (21) and projecting the induced force multipoles onto the total force and torque
(8). Explicit expressions for the maistance $m$ atrix in term $s$ of the generalized friction $m$ atrix $M{ }^{1}$ are given in . . In num erical applications, the system of linear equations (21) is truncated at a given multipolar order $l$, and the resulting approxim ate frintion $m$ atrix is supplem ented $w$ ith a lubrication correction (as described in

4 Far- eld approxim ation

Calculation of the exant matrix elem ents $G_{i j}\left(\mathrm{~lm} \quad j \mathrm{l}^{0}{ }^{0}\right.$ ) by our C artesianrepresentation $m$ ethod ' requires num ericalevaluation of $H$ ankeltransform $s$ that involve the B essel functions $J_{m} m 0\left(k \circ_{i j}\right)$. H ere $k$ is the $m$ agnitude of the lateral wave vector, and $\circ_{i j}=\operatorname{jog}_{i} \quad \circ_{j} j$ where $\circ_{i}=\left(X_{i} ; Y_{i}\right)$ denotes the lateral position of particle $i$. For large interparticle distances $\%_{i j}$, the factor $J_{m} \mathrm{~m}^{\circ}\left(\mathrm{k} \%_{i j}\right)$ undergoes rapid oscillations as a function of $k$. Thus, evaluation of the Fourier integrals in the $H$ ankel transform $s$ is num erically expensive for such con gurations.

In the follow ing sections we derive explicit asym ptotic expressions for the $m$ atrix elem ents $G_{i j}\left(\mathrm{~m} \quad j l_{m}{ }^{0}{ }^{0}\right.$ ) at large interparticle distances $\%_{i j} \quad H$. A swe will see, these expressions have a very sim ple form, and do not require evaluation of the Fourier integrals.

### 4.1 H ele-Shaw form of the far- eld ow

O ur asym ptotic analysis relies on the observation that in the far- eld regim e the ow between two parallelwalls assum es the H ele-Shaw form. A ccordingly, the asym ptotic pressure eld $p=p^{\text {as }}$ varies only in the lateral direction, and the associated ow eld has the lubrication form

The asym ptotic expressions (27) and (29) can be obtained 'by expanding the boundary-value problem for Stokes ow in the space betw een the walls in
the sm all param eter $\mathrm{H}=\quad$ 1, where $\quad$ is the distance from the force distribution that generates the uid $m$ otion. Since the velocity eld (27) itself satis es the Stokes equations and boundary conditions exactly, one can show that the higher-order term $s$ in the asym ptotic expansion mish. This property indicates that the correction term s are subdom inant ' which in tum suggests that the asym ptotic behavior (27) and (29) is approached exponentially. This conclusion is consistent w th the direct analysis of the asym ptotic form ft the G reen's function in the space betw een the walls by Liron and M ochon (see the discussion in Sec. 4.4 below ).

### 4.2 A sym ptotic basis sets

Relation (39) indicates that the correction to the far- eld O( ${ }^{2}$ ) asym ptotic behavior of the uid velocity $u$ decays exponentially with . M oreover, the vertical com ponent of the force $F$ does not contribute to the $O\left({ }^{2}\right)$ behavior.

W e note that for each $m$ only several force $m$ ultipoles (51) produce a nonzero far- eld velocity (50). This behavior results from the properties of the $m$ atrix $\mathrm{C}\left(\mathrm{Z}_{2} ; \mathrm{lm}\right)$ that appearers in relation (52); the form of this matrix is analyzed in Sec. 4.6 below. A further discussion of the multipolar elds in the space betw een the walls is given in A ppendix B .

### 4.6 Explicit expressions for the transform ation $m$ atrix C

A general structure of the $m$ atrix $C$ can be inferred using scaling argum ents. A coording to Eq. (12b) spherical basis elds $v_{\text {Im }}^{+}$( $r \quad R_{i}$ ) are hom ogeneous functions of the order l+ $\quad 1$ of the relative-position vector $r=r \quad R_{i}$. Sim ilarly, Eqs. W e close our theoretical considerations w ith a rem ark that the asym ptotic form $G_{i j}^{\text {as }}$ of the $G$ reen's $m$ atrix $G_{i j}$ is approached exponentially for $R_{i j}!1$ because Liron M ochon form ula (39) is exponentially accurate at large distances. A s in relation (39), the lengthscale for this approach is set by the w all separation H. The asym ptotic expression (46) should thus be very accurate when the interparticle distance $R_{i j}$ is larger than several w all separations H. $T$ his conclusion is supported by our num erical results discussed in the follow ing section.

5 N um erical exam ples

### 5.1 M atrix elem ents

A typical behavior of the $G$ reen's matrix $G_{i j}$ is illustrated in $F$ igs. 1 and 2. $T$ he results are show $n$ for the $m$ atrix elem ents

theory because in the asym ptotic regim e $\%_{12} \quad \mathrm{H}$ they are directly related to the far- eld multipolar ow (50) according to Eq. (B.7). In all exam ples, the vertical coordinates of the points (1) and (2) are $Z_{1}=Z_{2}=\frac{1}{4} H$. For other con gurations the $m$ atrix elem ents have a sim ilar behavior.

W e present our results in the form of the rescaled elem ents de ned by the relation

The nonzero asym ptotic elem ents are quadratic functions of the vertical coordinate $Z_{1}$, and they are at $m$ ost quadratic in $Z_{2}$ but can also be linear or constant in this variable, as indicated by Eqs. (46) and (56). The far-eld ow (50) is related to these elem ents by Eq. (B .9).

Figure 1 ilhustrates the behavior of them atrix elem ents $G_{12}(1 \quad 10 j 11)$ with

Them atrix elem ents (61) are directly related to them ultipolar ow elds (50), as indicated by Eq. (B.7).Therefore, we nd that Eq. (61) corresponds to the slowest possible far- eld decay of the ow produced by a multipolar force distribution. The multipoles (60) include the horizontal Stokeslet ( $1=1$, = 0 ), rotlet ( $1=1,=1$ ), stresslet ( $1=2,=0$ ), and three other multipoles, one of which has the sphericalharm onics order $l=3$. The num erical results shown in $F$ ig. 1 indicate that the approach of $G_{12}$ to the asym ptotic values is exponential, which is consistent with our discussion in Sec. 4.

Figure 2 ilhustrates the behavior ofm atrix elem ents (58) for $l=4$ and $=0$. U nlike the elem ents presented in $F$ ig. 1, the rescaled elem ents $G_{12}(1 \quad 10 j 4 \mathrm{~m} 0)$ $w$ ith $m=0 ; 1$ vanish at large separations \% $H$, which is consistent $w$ ith condition (54). The rem aining rescaled elem ents w th $\mathrm{m}=2 ; 3 ; 4$ tend exponentially to nonzero asym ptotic values.

5.2 A pplications in m ultiparticle hydrodynam ic-interactions algorithm s

T he sim plest num erical application of our asym ptotic form ulas (46), (55), and (56) is to implem ent them directly in the induced-force-m ultipole equation (21). To this end, the $m$ atrix (26) is represented as the superposition of the long-range asym ptotic part and the short-range correction, i.e.,

To obtain the correction term $G_{i j}(\mathrm{~m} \mathrm{jlm})$, rst the expression $G_{i j}\left(\mathrm{~m} \quad j l^{0 m} 0\right.$ an calculated using the $C$ artesian-representation $m$ ethod described in . . and next, the asym ptotic expression is subtracted from the result. Since the correction term is short ranged, the

where the truncation distance \%as is of the order of several wall separations H. The results show $n$ in $F$ igs. 1 and 2 and other sim ilar tests indicate that the asym ptotic approxim ation for the $G$ reen's $m$ atrix is very accurate for $\%$ oas \& $3 H$. Thus, the num erically expensive contribution $G_{i j}$ has to be evaluated only for the neighboring particles at an $\mathrm{O}(\mathbb{N})$ cost.

To test our asym ptotic approach and illustrate the role of the long-and shortrange contributions to the $G$ reen's $m$ atrix $G$, we consider a benchm ark case of a linear rigid array of $N$ touching spheres translating in the center plane in the space between closely spaced walls. The spheres are on a line parallel to the x direction and the array is $m$ oving either in the x (longitudinal) or $y$ (transverse) direction. $W$ e focus on the translational friction coe cients evaluated per particle,
where ${ }_{i j}^{\mathrm{tt}}$ is the component of the translational resistance tensor ${ }_{i j}^{\mathrm{tt}}$ de ned in $\sim$, and $k$ is the one-particle lateral translational resistance coe cient

A s ilhustrated in $F$ ig. 3 (see also discussion in the longitudinal and transverse friction coe cients (64) behave di erently. The longitudinal coe cient ${ }_{C}^{x x}$ decreases w th the length of the array $N$, while the transverse coe cient ${ }_{C}^{Y y}$ increases with $N$. For tight con gurations with sm all gaps be-

tween the wall and particle surfaces (the case show in Fig. 3) the decrease of ${ }_{C}^{x x}$ is m oderate because the friction force is dom inated by the local resistance due to the dissipation in these gaps. In contrast, the increase of ${ }_{C}^{y y}$ is large due to collective long-range e ects.

The m echanism of these collective e ects can be explained using the results for the pressure eld around arrays of the length $N=10$ and 20 plotted in Figs. 4 and 5. The gures show the norm alized asym ptotic far-eld pressure

(where $U$ is the velocity of the array), which was evaluated using the $m$ ethod described in A ppendix C.T he results for the longitudinalm otion of the array

shown in $F$ igs. 4 (a) and 5 (a) indicate that the pressure eld is only weakly a ected by the length of the array, and its $m$ agnitude is the largest near the array ends. In contrast, the pressure shown in Figs. 4 (b) and 5 (b) for the transverse $m$ otion increases approxim ately linearly $w$ th the array length N , and its m agnitude is m axim al near the chain center. T his large pressure am plitude is associated w ith the ow of the displaced uid around the ends of the array in the con ned space. The ow is signi cant over the distance that scales w ith the length of the array $l=2 \mathrm{~N}$ a (where a is the sphere radius). In the $H$ ele-Shaw regim e the pressure gradient is proportional to the uid velocity; hence, the pressure itself is proportional to N .

To further elucidate the e ects of the short-range and far- eld ow com ponents, the exact num erical results for the resistance coe cients (64) are com pared in $F$ ig. 3 w ith the asym ptotic approxim ation (62) and (63). W e also show results obtained using a much cnuder approxim ation, where the whole G reen's m atrix is truncated at a certain distance 0 , i.e.,

O ur num erical calculations indicate that the truncation (66) yields poor results. The far- eld ow contribution is especially im portant for the transverse $m$ otion of the array because of the positive-feedback e ect: For this $m$ otion the dipolar Hele-Shaw ow eld generated by a given particle acts as a back ow on the other particles. This back ow, in tum, produces an increase in

the induced force distribution that generates the dipolar ow. This back ow $m$ echanism, resulting in the large transverse resistance, is consistent w ith our discussion of the pressure eld shown in Figs. 4 (b) and 5 (b) .

In contrast to the crude approxim ation (66), a truncation of the short-range part (63) of the G reen's m atrix yields accurate results already w ith m oderate values of the truncation param eter $\%_{o_{a s}}$. The results shown in F ig. 3 indicate that the truncations at $\%_{\mathrm{os}}=\mathrm{H}=1$ for the longitudinalm otion and at $\% \mathrm{as}=\mathrm{H}=$ 2 for the transverse $m$ otion are su cient. The results with $\%$ as $=H \quad 3$ (not shown) are essentially indistinguishable from the exact results.

6 C onclusions

O ur paper presents a com plete analysis of the far- eld ow produced by an arbitrary force multipole in the space bounded by two parallel planar walls. W e have show n that a force multipole characterized by the multipolar num bers 1 m produces, at large distances, a Hele-Shaw ow driven by a twodim ensionalm ultipolar pressure eld of the azim uthalorderm. T he am plitude of this ow has been explicitly obtained for an arbitrary order of the source force $m$ ultipole.

O ur asym ptotic results were applied to evaluate the multipolar matrix elem ents $G_{i j}$ ( $\mathrm{lm}_{\mathrm{j}} \mathrm{lm}{ }^{0}{ }^{0}$ ) of the $G$ reen's tensor for Stokes ow in the wallhoundod dom ain. This $m$ atrix is used in our recently developed algorithm for evaluation of the multiparticle friction tensor $i_{j}$ in a suspension
con ned between two parallelwalls. The elem ents of the $m$ atrix $G$ ij are equivalent to the expansion coe cients in the displacem ent theorem for Stokes ow in the bounded dom ain. Such a displacem ent theorem relates the ow produced by a force multipole centered at a point $R_{j}$ to nonsingular multipolar ow s centered at a point $\mathrm{R}_{\mathrm{i}}$. W e have show n that in the far- eld regim e the $m$ atrix elem ents $G_{i j}\left(m \quad j l m{ }^{0}{ }^{0}\right.$ ) can be expressed in term s ofm uch sim pler displacem ent form ulas for the tw o-dim ensional scalar potential.
$W$ e have found that the $m$ atrix $G_{i j}$ achieves its asym ptotic behavior when the lateral distance betw een the centers of the particles $i$ and $j$ exceeds several wall separations H. Evaluation fth exact $m$ atrix elem ents in term $s$ of lateral Fourier integrals derived in . is thus needed only for the neighboring particles. Therefore, application of the asym ptotic expressions in our hydrodynam ic-interaction algorithm yields an im portant im provem ent of its num ericale ciency. (T he far- eld contribution to the $G$ reen's $m$ atrix cannot be sim ply neglected for som e problem s such a crude approxim ation leads to entirely w rong values of the friction $m$ atrix; cf. discussion in section 52).

Severalother im portant consequences stem from the fact that we have reduced a com plex hydrodynam ic problem to a sim pler problem of a two-dim ensional scalar potential. First, since fin 2 scalar potential the multipolar ow elds in a periodic system are known , the results of our analysis can be used to develop an algorithm for hydrodynam ic interactions in a periodic wall-bounded system .W thout the asym ptotic expressions, evaluation of the periodic h...drodynam ic $G$ reen's $m$ atrix would be $m$ uch $m$ ore di cult, as discussed in

N ext, for scalar potant'als, fast multipole and PPPM acceleration techniques are well developed . . C om bined with our asym ptotic results, such $m$ ethods can be applied for fast evaluation of hydrodynam ic interactions in wallbounded suspensions. D evelopm ent of accelerated algorithm s for suspensions w ill require im plem entation of certain techniques that are speci c to multiparticle hydrodynam ic system s , e.g. an appropriate preconditioning of the G reen'sm atrix and incorporating the hubrication interactions into the calculation schem e. These techniques were und in acmated Stokesian-dynam ics algorithm s for unbounded suspensions ' and '. O ur present asym ptotic results greatly facilltate developm ent of acoelerated algorithm s for w all-bounded system S , and our research is currently focused on this problem.
