Far- eld approxim ation for hydrodynam ic interactions in parallel-wall geom etry

A bstract

A complete analysis is presented for the far-eld creeping ow produced by a multipolar force distribution in a uid con ned between two parallel planar walls. We show that at distances larger than several wall separations the ow eld assum es the Hele-Shaw form, i.e., it is parallel to the walls and varies quadratically in the transverse direction. The associated pressure eld is a two-dimensional harmonic function that is characterized by the same multipolar numberm as the original force multipole. Using these results we derive asymptotic expressions for the Green's matrix that represents Stokes ow in the wall-bounded uid in terms of a multipolar spherical basis. This G reen's matrix plays a central role in our recently proposed algorithm [Physica A xx, xxx (2005)] for evaluating many-body hydrodynam ic interactions in a suspension of spherical particles in the parallel-wall geom etry. Im plem entation of our asymptotic expressions in this algorithm increases its e ciency substantially because the num erically expensive evaluation of the exact m atrix elements is needed only for the neighboring particles. Our asymptotic analysis will also be useful in developing hydrodynam ic algorithms for wall-bounded periodic systems and implementing acceleration methods by using corresponding results for the two-dim ensional scalar potential.

Keywords: hydrodynamic interactions, con ned systems, Stokes ow, suspensions, Hele-Shaw ow

1 Introduction

Numerical and theoretical investigations of particle motion in suspensions bounded by planar walls require e cient methods for evaluating hydrody-

nam ic interactions in these systems. Examples of phenomena where the hydrodynam ic wall e ects are important include collective particle motion in quasi-bidimensional colloidal suspensions [1, 2, 3, 4, 5], and conformation dynamics of a DNA molecule in a parallel-platemicrochannel [6].

Several m ethods for evaluating hydrodynam ic interactions in wall-bounded systems have been proposed. In some studies, the ow re ected from the walls was calculated num erically using either boundary-integral [7] or nitedi erence [6] techniques. In a di erent approach [8], the exact point-force solution for the ow between the walls [9] was used. W all e ects were also included using a multiple-re ection technique [10], and several approximation m ethods were proposed [11, 12, 13]. W hile all of these m ethods have their m erits, they also have some essential disadvantages, such as a high num erical cost or an insu cient (in m any cases unknown) accuracy.

Recently we have derived [14, 15], a novel algorithm for evaluating hydrodynam ic friction matrix in a wall-bounded suspension of spheres under creepingow conditions.³ Our Cartesian-representation method relies on transform ations between a spherical basis set of solutions of Stokes equations (this set is consistent with the particle geometry) and a Cartesian basis set (which is consistent with the wall geometry). The algorithm provides highly accurate results for multiparticle friction and mobility matrices.

U sing our approach, we have obtained several interesting numerical results. In particular, we have shown that the friction matrix undergoes a crossover from the quasi-three-dimensional to quasi-two-dimensional form when the interparticle distance becomes larger than the wall separation H. We have also observed an unusually large resistance coe cient for a long rigid chain of spheres in transverse motion (with respect to the orientation of the chain) in a narrow, wall-bounded space. Since both these elects involve ow on the length scale 1 H, they are not captured by the usual single-wall superposition approximation which does not properly take the far-eld ow into account (as demonstrated in [14]).

Large-scale studies of particle dynam ics in the two-wall geom etry require efcient simulation algorithms. In our approach [14, 15] the most expensive part is evaluation of the G reen's matrix G in the multipolar representation. This matrix is a key quantity in our algorithm | its elements correspond to the coe cients in the expansion of the hydrodynam ic G reen's tensor for the wall-bounded system into multipolar basis elds. The inverse of the G reen's matrix combined with the one-particle re ection matrices yields the multiparticle hydrodynam ic friction matrix.

In our algorithm [14, 15] the matrix G is expressed in terms of lateral Fourier

integrals with respect to the two-dimensional wave vector in a plane parallel to the walls. Evaluation of these integrals is especially di cult for widely separated particles due to the oscillatory character of the integrands. In the present paper we derive much simpler asymptotic form ulas for the matrix G in the far-eld regime. When the particle separation is su ciently large, these form ulas can be used instead of the Fourier integrals, resulting in a signi cant reduction of numerical cost (and in other important simplic cations).

O ur analysis of the asymptotic form of the matrix G relies on the observation that in the far-eld regime the velocity eld in the space between the walls assumes a simple Hele-Shaw (i.e. the lubrication) form. A coordingly, the ow eld has only the lateral components and it varies quadratically across the space between the walls. Such a ow eld is entirely determined by the corresponding pressure eld, which is a two-dimensional harmonic function that depends only on the lateral coordinates. It follows that at large distances r H, the full three-dimensional hydrodynamic problem is reduced to a much simpler two-dimensional scalar problem for the pressure.

This paper is organized as follows. Our method [14, 15] for evaluating manyparticle hydrodynam ic interactions in the parallel-wall geometry is sum marized in Secs. 2 and 3. Section 2 recalls the induced-force formulation of the problem, and Sec. 3 sum marizes the force-multipole expansion method. The main theoretical results of the present analysis are given in Sec. 4, where the Hele-Shaw approximation for the far-eld ow is discussed, and explicit expressions for G reen's matrix G are derived. In Sec. 5 we present some results of numerical calculations. We show the dependence of G reen's matrix elements on the interparticle distance, and we illustrate the role of their fareld behavior in the description of hydrodynam ic interactions in rigid arrays of spheres. C oncluding remarks are given in Sec. 6, and some technical details are presented in the appendices.

2 Multiparticle hydrodynam ic interactions

2.1 Hydrodynam ic resistance

We consider the motion of N spherical particles of the radius a, which are suspended in a uid of viscosity , under creeping-ow conditions. The system is bounded by two planar parallel walls at the positions z = 0 and z = H, where r = (x;y;z) are the Cartesian coordinates. The centers of particles i = 1:::N are at positions $R_i = (X_i;Y_i;Z_i)$, and the translational and rotational particle velocities are U_i and _i. The external forces and torques acting on the particles are denoted by F_i and T_i. It is assumed that the ow eld satis es

the no-slip boundary conditions on the particle surfaces and the walls.

For a system of spheres undergoing translational and rotational rigid-body motion with no external ow, the particle dynamics is characterized by the resistance matrix

The dot in the above equation denotes the matrix multiplication and contraction of the Cartesian tensorial components of the resistance matrix. Our goal is to calculate the resistance matrix , or its inverse, the mobility matrix . Our method [14, 15] for evaluating these quantities is outlined below.

2.2 Induced-force form ulation

The e ect of the suspended particles on the surrounding uid can be described in terms of the induced-force distributions on the particle surfaces. These distributions can be written in a form

By the de nition of the induced force [17, 18, 19], the ow eld

is identical to the velocity eld in the presence of the moving particles. Here

is the G reen's function for the Stokes ow in the presence of the boundaries; the G reen's function T $(r;r^0)$ is decomposed into the O seen tensor

and the part T $^{0}(r; r^{0})$ that describes the ow re ected from the walls. In Eq. (5) it is assumed that the particles move with given velocities, but no external ow is imposed.

The resistance relation (2) is linked to the induced-force distributions (3) through the expressions

for the total force and torque, respectively. To determ ine the resistance m atrix (1) we thus need to evaluate the induced forces (3) for given translational and angular velocities of the particles.

2.3 Boundary-integral equations for the induced forces

For a system of particles moving with the translational and angular velocities U_i and $_{i}$, the induced-force distribution (3) can be obtained from the boundary-integral equation

is the rigid-body velocity eld associated with the particle motion, and S_i is the surface of particle i. In the boundary-integral equation (9), Z_i denotes the one-particle scattering operator that describes the response of an individual particle to an external ow in an unbounded space. This operator is de ned by the linear relation

where v_i^{in} is the velocity incident to particle i.For speci c particle m odels (e.g., rigid particles or drops), explicit expressions for the operator Z_i are known [20, 21, 22].

3 Force-multipole expansion

3.1 Spherical basis elds

A s in a standard force multipole approach [23, 24] the boundary-integral equation (9) is transformed into a linear matrix equation by projecting it onto a spherical basis of Stokes ow. To this end we use the reciprocal basis sets de ned by Cichocki et al. [21]. We introduce, however, a slightly di erent norm alization to exploit the full symmetry of the problem.

The singular and nonsingular spherical basis solutions of Stokes equations v_{lm} (r) and v_{lm}^+ (r) (with $l = 1;2; \ldots; m = l; \ldots; l;$ and = 0;1;2) have the following separable form in the spherical coordinates r = (r; ;):

The coe cients V $_{\rm lm}$ (;) and V $_{\rm lm}^+$ (;) are combinations of vector spherical harm onics with angular order land azim uthal order m. This property and the r-dependence in equations (12) de ne the Stokes-ow elds v $_{\rm lm}$ (r) up to norm alization.

W e use here a convenient normalization introduced in [15], which emphasizes various symmetries of the problem . Explicit expressions for the functions V $_{\rm im}$ in this normalization are given in Appendix A.W e note that both in our present and in the original normalization [21], the basis elds v $_{\rm im}$ satisfy the identity [25]

where T_0 (r r^2) is the 0 seen tensor (7). Relation (13) assures that the Lorentz reciprocal sym m etry of Stokes ow is rejected in the sym m etry of the resulting matrix representation of the problem [24].

Following [21] we also introduce the reciprocal basis elds w $_{\rm in}$ (r), de ned by the orthogonality relations of the form

is the inner product, the asterisk denotes the complex conjugate, and $_{a}^{s}$ is denoted in Eq. (4). The reciprocal basis elds and the bra{ket notation (15) allows us to conveniently represent expansions of Stokes ow elds into the complete sets of nonsingular and singular basis elds (12). In particular, any Stokes ow u (r) that is nonsingular in the neighborhood of a point $r = R_{i}$ has an expansion

3.2 Matrix representation

The matrix representation of the boundary-integral equation (9) is obtained using the multipolar expansion

of the induced-force distributions (3). The multipolar moments in the above expression are given by the projection

according to the orthogonality condition (14). The de nition (19) of the multipolar expansion is justiled by the identity

which follows from the representation (13) of the O seen tensor. Equations (18) and (20) indicate that the multipolar moments $f_i(Im)$ are identical (apart from the trivial factor) to the expansion coe cients of the ow eld scattered by an isolated particle in unbounded space into the singular basis elds v_m .

To obtain a linear matrix equation for the set of force multipolar moments $f_i(m)$, representation (18) is inserted into the boundary-integral equation (9), and the resulting expression is expanded into the nonsingular basis elds

(12b), which yields

The rst term $Z_i^{(1)}(l; j^0)$ is associated with the one particle operator $Z_i^{(1)}$ in equation (9), and it relates the force multipoles $f_i(lm^{(0)})$ induced on particle ito the coe cients in the expansion of the ow eld incoming to this particle into the nonsingular spherical basis elds (12b). By the spherical symmetry, this term is diagonal in the indices l and m and is independent of m. The Green's matrices $G_{ij}^0(lm jlm^{(0)})$ and $G_{ij}(lm jlm^{(0)})$ are associated with the integral operators that involve the kernels $T^0(r;r^0)$ and $T(r;r^0)$. U sing the orthogonality relations (14) one can show that the elements of these matrices correspond to the expansion of the ow produced by a force multipole centered at R_i into the nonsingular basis (12b) centered at R_i.

Explicit expressions for the single-particle re-ection matrix Z_i^{-1} are well known [21, 26]. Quadrature formulas for the G reen's matrix G_{ij} have been derived in our recent publication [15], where the matrix elements G_{ij} (lm j lm⁰) are represented as a combination of the free-space G reen's matrix [26, 24] and the wall contribution G_{ij}^{0} (lm j lm⁰) that is given in a form of a Hankel transform of a product of several simple matrices. The Hankel transform arises from angular integration of lateral Fourier modes of Stokes ow.

The many-particle resistance matrix (1) can be obtained by solving Eq. (21) and projecting the induced force multipoles onto the total force and torque

(8). Explicit expressions for the resistance matrix in terms of the generalized friction matrix M¹ are given in [15]. In num erical applications, the system of linear equations (21) is truncated at a given multipolar order 1, and the resulting approximate friction matrix is supplemented with a lubrication correction (as described in [15]).

4 Far-eld approximation

Calculation of the exact matrix elements G_{ij} (lm jlm⁰) by our Cartesian-representation method [15] requires numerical evaluation of H ankel transforms that involve the Bessel functions $J_{m \ m} \circ (k \otimes_{ij})$. Here k is the magnitude of the lateral wave vector, and $\otimes_{ij} = \beta_i \otimes_j j$, where $\otimes_i = (X_i; Y_i)$ denotes the lateral position of particle i. For large interparticle distances \otimes_{ij} , the factor $J_{m \ m} \circ (k \otimes_{ij})$ undergoes rapid oscillations as a function of k. Thus, evaluation of the Fourier integrals in the H ankel transforms is numerically expensive for such con gurations.

In the following sections we derive explicit asymptotic expressions for the matrix elements G_{ij} (lm j lm⁰) at large interparticle distances $%_{ij}$ H. A swe will see, these expressions have a very simple form, and do not require evaluation of the Fourier integrals.

4.1 Hele-Shaw form of the far-eld ow

O ur asymptotic analysis relies on the observation that in the far-eld regime the ow between two parallel walls assumes the Hele-Shaw form . A coordingly, the asymptotic pressure eld $p = p^{as}$ varies only in the lateral direction, and the associated ow eld has the lubrication form

and r_k is the two-dimensional gradient operator with respect to the lateral position = (x;y).By the incompressibility of the ow eld (27), the pressure eld p^{as} satisfies the two-dimensional Laplace's equation

The asymptotic expressions (27) and (29) can be obtained [27] by expanding the boundary-value problem for Stokes ow in the space between the walls in

the small parameter H = 1, where is the distance from the force distribution that generates the uid motion. Since the velocity eld (27) itself satisfies the Stokes equations and boundary conditions exactly, one can show that the higher-order terms in the asymptotic expansion vanish. This property indicates that the correction terms are subdom inant [28], which in turn suggests that the asymptotic behavior (27) and (29) is approached exponentially. This conclusion is consistent with the direct analysis of the asymptotic form of the G reen's function in the space between the walls by Liron and M ochon [9] (see the discussion in Sec. 4.4 below).

4.2 A sym ptotic basis sets

To nd the far-eld form of the velocity eld produced by induced-force multipoles and to obtain the corresponding asymptotic expressions for the elements of the G reen's matrix G_{ij} (lm j lm⁰), it is convenient to de ne appropriate basis sets of Hele-Shaw ow and pressure elds. The sets of singular and nonsingular pressures are de ned by the relation

in Eq. (35), the scalar elds with the same sign of the indices $m; m^0 \in 0$ do not couple in the displacement relation (34). We also note that the matrix (35) satisfies the symmetry relation

As a direct consequence of the displacem ent theorem (34) for the scalar pressure elds, we have the corresponding displacem ent relation for the Hele-Shaw basis ow s (32)

The term with m = 0 in the above relation vanishes because $v_0^{as+} = 0$ according to Eqs. (31b) and (32). The prime at the summation sign has been introduced to emphasize that this term is om itted.

In the following section we will derive a diagonal representation (analogous to (13) and (33)) for the hydrodynamic G reen's tensor describing the asymptotic far-eld response of the uid con ned between walls to a point force.

4.3 A symptotic G reen's tensor

An explicit expression for the far-eld ow produced by a point force in the space between the walls has been derived by Liron and M ochon [9] (see also [29]). A coording to their results, the far-eld ow produced by a force F applied at the position $(0;0;z^0)$ can be expressed in the form

The above relation can also be obtained by a direct expansion of the boundary-value problem in the small parameter H = [27].

Relation (39) indicates that the correction to the far-eld 0 (²) asymptotic behavior of the uid velocity u decays exponentially with . Moreover, the vertical component of the force F does not contribute to the 0 (²) behavior.

Equation (39) can be rephrased as an expression for the asymptotic form T $^{\rm as}$ of the full G reen's function (6)

(where the dagger denotes the transpose of the tensor). Due to the translational invariance of the system in the lateral directions, the G reen's function (40) satis as the identity

U sing Eqs. (32) and (33) and noting that the G reen's function (40) is quadratic both in primed and unprimed transverse variables, we not the relation

4.4 A symptotic form of the two-wall G reen's matrix

The asymptotic form of the matrix elements (26) can be obtained by projecting relation (44) onto the reciprocal basis elds w $_{\rm im}^+$ centered at the points R $_{\rm i}$ and R $_{\rm j}$. The resulting expression involves the matrix elements

Thus, the matrix element C (\mathbb{Z}_2 ; Im) represents the amplitude of the Hele-Shaw basis eld v_m^{as} in the far-eld multipolar velocity (50). Only one term contributes to this ow according to Eq. (52) because of the cylindrical sym-metry of the problem.

The asymptotic multipolar ow elds (50) can also be expressed in terms of the matrix elements (46). To this end the right side of Eq. (50) is expanded in the spherical basis elds (12b) with the help of identity (16). The expansion yields the relation

We note that for each m only several force multipoles (51) produce a nonzero far-eld velocity (50). This behavior results from the properties of the matrix C (\mathbb{Z}_2 ; lm) that appearers in relation (52); the form of this matrix is analyzed in Sec. 4.6 below. A further discussion of the multipolar elds in the space between the walls is given in Appendix B.

4.6 Explicit expressions for the transform ation m atrix C

A general structure of the matrix C can be inferred using scaling arguments. A coording to Eq. (12b) spherical basis elds v_{lm}^+ (r R_i) are hom ogeneous functions of the order 1+ 1 of the relative position vector $\mathbf{r} = \mathbf{r} = \mathbf{R}_i$. Similarly, Eqs. (31b) and (32) in ply that the Hele-Shaw basis elds v_m^{as+} (r $\$_i$) are combinations of hom ogeneous functions of the order jn j 1, jn j and jn j+ 1 of r_i . Since the coe cients C (Z $_i$; lm) are independent of r_i , relation (49) in plies that the non-zero elements of C (Z $_i$; lm) satisfy the condition

The range = 0;1;2 of the index = 1 jn j in equation (56) result from the conditions jn j land (54). All other elements of the matrix C vanish.

We close our theoretical considerations with a remark that the asymptotic form G $_{ij}^{as}$ of the G reen's matrix G $_{ij}$ is approached exponentially for R $_{ij}$! 1 because Liron-M ochon formula (39) is exponentially accurate at large distances. As in relation (39), the lengthscale for this approach is set by the wall separation H. The asymptotic expression (46) should thus be very accurate when the interparticle distance R $_{ij}$ is larger than several wall separations H. This conclusion is supported by our num erical results discussed in the follow – ing section.

5 Num erical exam ples

5.1 Matrix elements




Fig. 1. Rescaled matrix elements G_{12} (1 10 jl1) versus lateral distance $\$_{12}$ for $Z_1 = Z_2 = \frac{1}{4}H$; values of parameters land as labeled. Exact solution (solid lines); asymptotic behavior (dotted lines).




Fig. 2. Rescaled matrix elements G_{12} (1 10 j 4m 0) versus lateral distance $\$_{12}$ for $Z_1 = Z_2 = \frac{1}{4}H$; values of parameter m as labeled. Exact solution (solid lines); asymptotic behavior (dotted lines).

A typical behavior of the G reen's matrix G_{ij} is illustrated in Figs. 1 and 2. The results are shown for the matrix elements

theory because in the asymptotic regime $\$_{12}$ H they are directly related to the far-eld multipolar ow (50) according to Eq. (B.7). In all examples, the vertical coordinates of the points (1) and (2) are $Z_1 = Z_2 = \frac{1}{4}H$. For other con gurations the matrix elements have a similar behavior.

W e present our results in the form of the rescaled elements de ned by the relation

For those values of parameters 1 and for which the matrix elements (59) do not vanish, the factor (+1) $(\%_{12})$ $(\%_{12})$ $(\%_{12})$ corresponds to the far-eld behavior of G_{12}^{as} (1 10 j l), according to Eqs. (35) and (46). In the asymptotic regime $\%_{12}$ H the rescaled elements G^{as}_{12} (1 10 j l) depend only on the vertical coordinates Z_1 and Z_2 . The nonzero asymptotic elements are quadratic functions of the vertical coordinate Z_1 , and they are at most quadratic in Z_2 but can also be linear or constant in this variable, as indicated by Eqs. (46) and (56). The far-eld ow (50) is related to these elements by Eq. (B.9).

Figure 1 illustrates the behavior of them atrix elements G_{12} (1 10 jl1) with

A llthese functions approach nonzero asymptotic values G^{as}_{12} (1 10 jl1) \in 0 for large interparticle distances $\$_{12}$ H, according to Eqs. (46) and (54). The corresponding behavior of the unscaled m atrix elements (58)

follows from Eqs. (31a), (35), and (46).

The matrix elements (61) are directly related to the multipolar ow elds (50), as indicated by Eq. (B.7). Therefore, we not that Eq. (61) corresponds to the slowest possible far-eld decay of the ow produced by a multipolar force distribution. The multipoles (60) include the horizontal Stokeslet (l = 1, = 0), rotlet (l = 1, = 1), stresslet (l = 2, = 0), and three other multipoles, one of which has the spherical harm onics order l = 3. The num erical results shown in Fig.1 indicate that the approach of G_{12} to the asymptotic values is exponential, which is consistent with our discussion in Sec. 4.

Figure 2 illustrates the behavior of matrix elements (58) for l = 4 and = 0. Unlike the elements presented in Fig.1, the rescaled elements G_{12} $(1 \quad 10 \text{ j4m } 0)$ with m = 0; 1 vanish at large separations % H, which is consistent with condition (54). The remaining rescaled elements with m = 2; 3; 4 tend exponentially to nonzero asymptotic values.

5.2 Applications in multiparticle hydrodynam ic-interactions algorithm s

The simplest num erical application of our asymptotic form ulas (46), (55), and (56) is to implement them directly in the induced-force-multipole equation (21). To this end, the matrix (26) is represented as the superposition of the long-range asymptotic part and the short-range correction, i.e.,

The asymptotic part G_{ij}^{as} (lm jlm⁰) can be evaluated from our explicit formulas at a low numerical cost. To obtain the correction term G_{ij} (lm jlm), rst the expression G_{ij} (lm jlm⁰) is calculated using the Cartesian-representation method described in [14, 15] and next, the asymptotic expression is subtracted from the result. Since the correction term is short ranged, the

matrix G_{ij} (lm j lm⁰) can be truncated by setting

where the truncation distance $\$_{as}$ is of the order of several wall separations H . The results shown in Figs. 1 and 2 and other sim ilar tests indicate that the asymptotic approximation for the Green's matrix is very accurate for $\$_{as}$ & 3H . Thus, the numerically expensive contribution G_{ij} has to be evaluated only for the neighboring particles at an O (N) cost.

To test our asymptotic approach and illustrate the role of the long-and shortrange contributions to the G reen's matrix G, we consider a benchmark case of a linear rigid array of N touching spheres translating in the center plane in the space between closely spaced walls. The spheres are on a line parallel to the x direction and the array is moving either in the x (longitudinal) or y (transverse) direction. We focus on the translational friction coe cients evaluated per particle,

where $_{ij}^{tt}$ is the component of the translational resistance tensor $_{ij}^{tt}$ de ned in Eq. (2), and $_{k}$ is the one-particle lateral translational resistance coe cient [16, 14].

As illustrated in Fig. 3 (see also discussion in [15, 14]) the longitudinal and transverse friction coe cients (64) behave di erently. The longitudinal coe cient $_{C}^{xx}$ decreases with the length of the array N, while the transverse coe cient $_{C}^{yy}$ increases with N. For tight con gurations with sm all gaps be-




Fig. 3. Normalized longitudinal and transverse friction coecients per particle $_{\rm C}^{\rm xx}$ and $_{\rm C}^{\rm yy}$ for linear arrays of touching spheres in the center plane between the walls, for wall separation H = 2a = 1:05. Crosses represent exact results; open symbols represent asymptotic approximation (63) with $_{\rm as}$ =H = 1 (squares) and 2 (circles); solid symbols correspond to truncation (66) with $_{\rm 0}$ =H = 2 (squares), 4 (circles) and 6 (triangles). For the longitudinal coecient $_{\rm C}^{\rm xx}$ the open squares and circles coincide with the crosses.

tween the wall and particle surfaces (the case show in Fig. 3) the decrease of $_{C}^{xx}$ is moderate because the friction force is dominated by the local resistance due to the dissipation in these gaps. In contrast, the increase of $_{C}^{yy}$ is large due to collective long-range e ects.




Fig. 5. Same as Fig. 4, except that for N = 20.

The mechanism of these collective e ects can be explained using the results for the pressure eld around arrays of the length N = 10 and 20 plotted in Figs. 4 and 5. The gures show the norm alized asymptotic far-eld pressure

(where U is the velocity of the array), which was evaluated using the m ethod described in Appendix C. The results for the longitudinal m otion of the array




Fig. 4. Contour plots of the normalized asymptotic pressure eld (65) around a rigid array of N = 10 touching spheres moving in the center plane between parallel walls, for wall separation H = 2a = 1:05. Longitudinalmotion (a); transverse motion (b). The dotted lines delim it the regions where the asymptotic approximation is not valid.

shown in Figs. 4(a) and 5(a) indicate that the pressure eld is only weakly a ected by the length of the array, and its magnitude is the largest near the array ends. In contrast, the pressure shown in Figs. 4(b) and 5(b) for the transverse motion increases approximately linearly with the array length N, and its magnitude is maximal near the chain center. This large pressure amplitude is associated with the ow of the displaced und around the ends of the array in the con ned space. The ow is significant over the distance that scales with the length of the array l = 2N a (where a is the sphere radius). In the Hele-Shaw regime the pressure gradient is proportional to the uid velocity; hence, the pressure itself is proportional to N.

To further elucidate the e ects of the short-range and far-eld ow components, the exact num erical results for the resistance coe cients (64) are compared in Fig. 3 with the asymptotic approximation (62) and (63). We also show results obtained using a much cruder approximation, where the whole G reen's matrix is truncated at a certain distance $_0$, i.e.,

Our num erical calculations indicate that the truncation (66) yields poor results. The far-eld ow contribution is especially in portant for the transverse motion of the array because of the positive-feedback e ect: For this motion the dipolar Hele-Shaw ow eld generated by a given particle acts as a back ow on the other particles. This back ow, in turn, produces an increase in

the induced force distribution that generates the dipolar ow. This back ow mechanism, resulting in the large transverse resistance, is consistent with our discussion of the pressure eld shown in Figs. 4 (b) and 5 (b).

In contrast to the crude approximation (66), a truncation of the short-range part (63) of the G reen's matrix yields accurate results already with moderate values of the truncation parameter a_{as} . The results shown in Fig. 3 indicate that the truncations at $a_{as}=H = 1$ for the longitudinal motion and at $a_{as}=H = 2$ for the transverse motion are su cient. The results with $a_{as}=H = 3$ (not shown) are essentially indistinguishable from the exact results.

6 Conclusions

Our paper presents a complete analysis of the far-eld ow produced by an arbitrary force multipole in the space bounded by two parallel planar walls. We have shown that a force multipole characterized by the multipolar num bers lm produces, at large distances, a Hele-Shaw ow driven by a twodimensionalmultipolar pressure eld of the azim uthal orderm. The amplitude of this ow has been explicitly obtained for an arbitrary order of the source force multipole.

Our asymptotic results were applied to evaluate the multipolar matrix elements G_{ij} (lm jlm⁰) of the Green's tensor for Stokes ow in the wallbounded domain. This matrix is used in our recently developed algorithm [14, 15] for evaluation of the multiparticle friction tensor $_{ij}$ in a suspension con ned between two parallel walls. The elements of the matrix G_{ij} are equivalent to the expansion coe cients in the displacement theorem for Stokes ow in the bounded domain. Such a displacement theorem relates the ow produced by a force multipole centered at a point R_j to nonsingular multipolar ows centered at a point R_i . We have shown that in the fare eld regime the matrix elements G_{ij} (lm jlm⁰) can be expressed in terms of much simpler displacement formulas for the two-dimensional scalar potential.

We have found that the matrix G_{ij} achieves its asymptotic behavior when the lateral distance between the centers of the particles i and j exceeds several wall separations H. Evaluation of the exact matrix elements in terms of lateral Fourier integrals derived in [15, 14] is thus needed only for the neighboring particles. Therefore, application of the asymptotic expressions in our hydrodynam ic-interaction algorithm yields an important improvement of its numerical e ciency. (The far-eld contribution to the G reen's matrix cannot be simply neglected of the friction matrix; cf. discussion in section 5.2).

Several other in portant consequences stem from the fact that we have reduced a complex hydrodynam ic problem to a simpler problem of a two-dimensional scalar potential. First, since for a scalar potential the multipolar ow elds in a periodic system are known [30], the results of our analysis can be used to develop an algorithm for hydrodynam ic interactions in a periodic wall-bounded system .W ithout the asymptotic expressions, evaluation of the periodic hydrodynam ic G reen's matrix would be much more di cult, as discussed in [27].

Next, for scalar potentials, fast multipole and PPPM acceleration techniques are well developed [31]. Combined with our asymptotic results, such methods can be applied for fast evaluation of hydrodynam ic interactions in wallbounded suspensions. Development of accelerated algorithms for suspensions will require implementation of certain techniques that are specific to multiparticle hydrodynamic systems, e.g. an appropriate preconditioning of the Green'smatrix and incorporating the lubrication interactions into the calculation scheme. These techniques were used in accelerated Stokesian-dynamics algorithms for unbounded suspensions [32] and [33]. Our present asymptotic results greatly facilitate development of accelerated algorithms for wall-bounded systems, and our research is currently focused on this problem.

C Far-eld pressure distribution

As discussed in Sec. 4, the ow and the pressure elds in the Hele-Shaw asymptotic regime (27) are uniquely related (up to an additive constant in the pressure). Thus, many of the asymptotic formulas, expressed here in terms of the velocity elds, can be translated into the corresponding expressions for the pressure.

This remark applies, in particular, to Eq. (52) for the asymptotic multipolar ow (50). We introduce the asymptotic multipolar pressure eld p_{lm}^{as} (r), which is dened by the relation

Equation (C 2) can be conveniently used to evaluate the far- eld disturbance pressure p^{as} in a many-particle system. This equation describes the asymptotic pressure produced in the far- eld regime by a single force multipole (51), as indicated by Eqs. (50) and (C 1). To determ ine p^{as} , the multipolar moments f_i (lm) of the force distributions (18) induced on the surfaces of

particles i = 1; :::; N are evaluated by solving the force-multipole equations (21). Combining the solution with (C 2) yields
