# M any-particle hydrodynam ic interactions in parallel-w all geom etry : C artesian-rep resentation $m$ ethod

## A bstract

This paper describes the results of our theoretical and num erical studies of hydrodynam ic interactions in a suspension of sphericalparticles con ned between two parallelplanar walls, under creeping- ow conditions. W e propose a novel algorithm for accurate evaluation of the $m$ any-particle friction $m$ atrix in this system $\mid$ no such algorithm has been available so far.

O ur approach involves expanding the uid velocity eld into sphericaland C artesian fundam entalsets of Stokes ow S. The interaction of the uid w th the particles is described using the sphericalbasis elds; the ow scattered w th the walls is expressed in term s of the C artesian fundam ental solutions. At the core of ourm ethod are transform ation relations betw een the spherical and C artesian basis sets. T hese transform ations allow us to describe the ow eld in a system that involves both the walls and particles.

W e used our accurate num erical results to test the singlew all supenposition approxim ation for the hydrodynam ic friction $m$ atrix. T he approxim ation yields fair results for quantities dom inated by single particle contributions, but it fails to describe collective phenom ena, such as a large transverse resistance coe cient for linear arrays of spheres.

## 1 Introduction

Equilibrium and nonequilibrium behavior of colloidal suspensions in con ned geom etries has recently been extensively discussed. Exam ples of recent papers include experim ental studies of particle deposition on chem ically pattemed

 gations have also been considerably in uenced by developm ent of new experim ental techniques, including the evanescent-w ave m icroscopy $[\overline{\overline{0}}, 1,19,1]$, com puterized video m icroscopy

W hile the equilibrium structure of con ned colloidal suspensions is fully determ ined by the particle\{w all and intenparticle interaction potentials, the dynam ics is also signi cantly a ected by the $m$ any-body hydrodynam ic foroes. The e ect of the hydrodynam ic interactions on particle $m$ otion can be expressed in term $s$ of the $N$-particle friction and $m$ obility $m$ atrices depend on the particle positions and the wall geom etry.

For spherical particles in an unbounded space, e cient algorithm sfor evalu-

 bounded by a single planar wall; the particle\{w all hydrodynam ic interactions were inchuded using the im age representation of the ow re ected from the wall

M uch less progress hasbeen $m$ ade for suspensions con ned betw een tw o planar walls (e.g, in a slit pore, or between two glass plates). For a single particle, several ad hoc approxim ations for the $m$ obility $m$ atrix have been proposed $\underline{\underline{2}} \overline{2}, \overline{2} \overline{2} \overline{3}]$, and num erical results obtained by boundary-integral $m$ ethods are available $\left.{ }_{2}^{2} \overline{4} \overline{4}, 12 \overline{2} \overline{2}, r i \overline{1} \overline{1}\right]$. Recently, we have developed an exact in age representation of the ow between two walls [1] $\left[\begin{array}{ll}-1\end{array}\right]$ which allow s accurate evaluation of the single-particle friction $m$ atrix by a m ultipolar expansion technique. H ow ever, none of the above $m$ ethods has been generalized to $m u l t i p a r t i c l e ~ s y s t e m ~ s, ~$ due to a large num erical cost of boundary-integral calculations or the slow convergence of the im age solutions.

Two extensions of the free-space Stokesian-dynam ics algorithm [i] bounded system s have been proposed by B rady and his collaborators $\underline{\underline{2}} \bar{q}, 1 / 2 \overline{1} \overline{1}$, '
 $m$ ethod has not been further explored. T he results obtained using the second m ethod are only qualitative, because the walls are porous and rough.

To overoom e the above-m entioned problem s , we adopt here an altemative ap-
proach, based on Fourier analysis of the ow eld re ected from the walls. ${ }^{21}$ ' A coording to our m ethod, the ow eld in the system is expanded using two basis sets of solutions of Stokes equations| the spherical and the C artesian basis. The spherical basis is used for a description of the ow eld scattered from the particles, and the C artesian basis is appropriate for the w allgeom etry. The key result of our study is a set of transform ation form ulas for conversion betw een the spherical and C artesian representations. The transform ation for$m$ ulas allow to evaluate the spherical $m$ atrix elem ents of the $G$ reen function for Stokes ow in the presence of the walls in term sof sim ple two-dim ensional Fourier integrals.

The results of our theoretical analysis have been im plem ented in a num erical procedure for evaluating multi-particle hydrodynam ic interactions in a suspension of spheres con ned between two planar walls. The procedure com bines the expansions of the ow eld into the spherical and C artesian basis elds w th the two-particle supenposition approxim ation for the friction m atrix, in order to include slow ly convergent hubrication corrections. Since the force m ultipoles induced on particle surfaces are included to arbitrary order, highly accurate results are obtained.

E xam ples of num erical results for tw o-particle and $m$ any-particle system $s$ are provided. In particular, our results illustrate the role of the far- eld ow produced in the space between the walls by the m oving particles. $W$ e show that the singlewall supenposition approxim ation does not correctly describe the far- eld ow, and thus it fails to capture som e im portant collective phenom ena such as the increased hydrodynam ic resistance due to the back ow produced by the $m$ oving particles.

This paper is organized as follow s . In Section 2 we sum m arize the inducedforce form ulation of the Stokes- ow equations for a multiparticle system in the wall presence. In Section 3 the induced-force equations are transform ed into an in nite array of algebraic equations for the induced-foroe multipoles, using a multipolar expansion of Stokes ow.

O ur m ain theoretical results are presented in Sections 4\{7. In Section 4 the C artesian basis sets ofStokes ow sare de ned, and the transform ation form ulas for conversion between the C artesian and the spherical multipolar bases sets are derived. The displacem ent and conversion form ulas are then used to obtain two-dim ensional Fourier representations of the $m$ atrix elem ents of G reen operator for in nite space (Section 5), halfspace bounded by a single wall (Section 6), and a region bounded by tw o parallel planar walls (Section 7).

A num erical algorithm for com putation of hydrodynam ic interactions in a suspension of spheres con ned in a region bounded by two parallel walls is described in Section 8. Num erical exam ples of the friction $m$ atrix, evaluated using this algorithm, are given in Section 9.D irections for further developm ent of our $m$ ethod are indicated in the concluding Section 10. Som e technical details are presented in A ppendioes A \{D .

2 Induced-force form ulation

W e consider a suspension of $N$ spherical particles of radius a m oving in an incom pressible $N$ ew tonian uid of viscosity. The suspension is bounded by a single planar wall or two parallel planar walls. The creeping- ow conditions are assum ed; therefore, the uid ow in the system depends only on the instantaneous particle con guration and velocities. The con guration is described by the positions ( $\mathrm{R}_{1} ;::: ; \mathrm{R}_{\mathrm{N}}$ ) of particle centers. The translational and rotational velocities of the particles are $U_{i}$ and $i$, where $i=1 ;::: ; N$ :

Thee ect of the suspended particles on the surrounding uid can be described in term s of the induced forøe distributions on the particle surfaces

T he induced force distribution $F_{i}$ on the surface of particle $i$ and the $o w v_{i}^{\text {in }}$ incident to this particle are linearly related. T he relation can be expressed in the form

In the follow ing sections, equation (15) is transform ed into an in nite set of algebraic equations for the $m$ ultipole $m$ om ents of the induced foroe, with coe cients expressed in term sof two-dim ensional Fourier integrals.

3 M atrix representation

### 3.1 Sphericalbasis

The $m$ atrix representation of equation (15) is obtained by expanding uid velocity elds into sets of fundam ental solutions of Stokes equations in sphericalcoordinates, and expressing the induced-foroe distributions in term s of the corresponding force multipoles. In our analysis we em ploy sets of basis elds that are closely related to the sets introduced by C ichockiet al 1 how ever, a di erent nom alization to em phasize im portant sym m etries of the problem .
$T$ he singular and nonsingularbasis sets of solutions ofStokes equations $v_{l m}(r)$ and $\mathrm{v}_{\mathrm{lm}}^{+}$( r ) (where $\mathrm{l}=1 ; 2 ;::: ; \mathrm{m}=1 ;::: ; 1 ;$ and $=0 ; 1 ; 2$ ) are de ned by the follow ing conditions: (i) the basis velocity elds are hom ogeneous functions of the radial variable $r$,

### 3.2 Equations for induced-force $m$ ultipole $m$ om ents

In the multipolar-representation $m$ ethod, the boundary-integralequation (15) is transform ed into an in nite set of linear algebraic equations for the $m$ ultipolarm om ents of the induced-forøe distributions (1). T he m ultipolar expansion of the distribution $F_{i}$ is de ned by the relation

A ccording to the above relation, the $m$ ultipolarm om ents $f_{i}(\mathrm{~lm})$ can be interpreted as the expansion coe cient of the ow eld $v{ }_{i}^{\text {out }}$ scattered by the particle $i$ into the basis velocity elds (16). It follow s that the matrix $Z_{i}{ }^{1}\left(l_{i} j^{0}\right)$ relates the expansion coe cients of the incident and the scattered ow s. Relations (68) \{ (73) and (88) \{ (91) represent the key results of the analysis presented so far. In Section 5 we apply these results to express the sphericalm atrix elem ents of the free-space $G$ reen operator (33) in term s oftw o-dim ensional Fourier integrals (which can be explicitly evaluated in this case). T he Fourier representations ofm atrix elem ents (34) for a system bounded by a single planarw alland by tw o parallelplanar walls are derived in $x 6$ and $x 7$, respectively. $T$ hese results enable e cient num erical evaluation of the $m$ ultiparticle friction $m$ atrix in wall-bounded suspensions. D escription of our algorithm is given in Section 8, and exam ples of num erical results are show in Section 9.

In this section we apply the C artesian displacem ent form ulas (70) and transform ation $m$ atrices (88) $\{(90)$ to express the spherical displacem ent $m$ atrix $S_{S}^{+}$in term $s$ of tw o-dim ensional Fourier integrals. Such a representation can be utilized in developing num erical algorithm s for evaluating hydrodynam ic interactions in doubly periodic system s. M oreover, the analysis allow s us to introduce som e techniques that will be used in the discussion of the ow in wall-bounded suspensions (cf. Sections 6 and 7).
$W$ e recall that the displacem ent $m$ atrix $S_{S}^{+}$and the corresponding spherical $m$ atrix elem ents (33) of the O seen operator are equivalent, as indicated by the form ula (43). To $m$ ake the notation in this and the follow ing sections parallel, we express our results in term s of the $m$ atrix elem ents $G_{i j}^{0}\left(\mathrm{~lm} j \mathrm{l}_{\mathrm{m}}{ }^{9}\right)$.

6 Single-w all G reen operator

Sim ilar techniques can be used to evaluate the $m$ atrix elem ents of the $G$ reen operator (34) in a system bounded by a single planar wall. W e assum e that the wall is in the plane

Explicit expressions for scattering $m$ atrioes for such system $s w i l l$ be derived in forthcom ing publications.

Explicit expressions for the im age foroe $m$ ultipole system corresponding to an arbitrary source force multipole have recently been derived by C ichocki and Jones $\underline{\underline{2}-\overline{1}} \mathbf{- 1}] ;$ we have veri ed that the integral (111) yields results equivalent to their expressions.

The $m$ ain application of the Fourier representation of the singlewall $G$ reen operator $\mathrm{G}^{0}{ }_{i j}$ is in the subtraction technique that is im plem ented in our algorithm for evaluating the multiparticle friction $m$ atrix in a tw $O$-w all system .

In this application (in m ore detail described in Section 82) expressions (111) and (112) are used in conjunction w th the results of Ref. [20] to accelerate the convergence of the Fourier integrals for the twow all $G$ reen operator.

7 Two-wall G reen operator

In this section we generalize the analysis of Section 6 to a system of particles con ned betw een two parallel planar walls. We assum e that the walls are in the planes

The above relations, together with equation (70), im ply that $g_{T w}\left(k ; \operatorname{lm} j 1 m{ }^{9}\right)$ depends on the $z$-coordinates of the walls and the points $i$ and $j$, but is independent of the lateralcoordinates, consistently with the translational invariance of the system. Since the tw ow all scattering $m$ atrix (136) is m ore com plex than its one-particle counterpart, the integration in equation (132) (unlike (111)) cannot be analytically perform ed. H ow ever, num erical integration is straightforw ard, except when the lateral distance between points $i$ and $j$ is large, in which case the oscillatory character of the integrand becom es im portant.

8 Stokesian-dynam ics algorithm for suspension betw een tw o walls

The theoretical results derived in the previous sections enable developm ent of e cient num erical algorithm $s$ for evaluation of $m$ any-body hydrodynam ic interactions in suspensions of spherical particles con ned between two planar walls. To our know ledge, such algorithm s have not been available so far. In what follow s, we describe a m any-particle Stokesian-dynam ics algorithm based on our theory.

In Section 8.1 we sum $m$ arize expressions that relate the $m$ atrix $M$ in the forcem ultipole equation (48) to the resistance $m$ atrix in a suspension ofm any spheres. O ur transform ation form ulas relating the spherical and C artesian basis elds are em ployed in Section 82, where a sim ple num erical-integration procedure for evaluating the elem ents of the $m$ atrix $M$ is described. The
 $w$ ith the order of the force $m$ ultipoles included in the calculation are outlined in Section 8.3. Exam ples of num erical results for the friction $m$ atrix of a single particle, a pair of particles, and in $m$ any-particle system $s$ are presented in Section 9.

### 8.1 Resistance m atrix

We focus on a system of $N$ spheres undergoing translational and rotational rigid-body m otion (7) w th no extemal ow. The particle dynam ics in the system is characterized by the resistance $m$ atrix
de ned by the linear relation
betw een the translationaland rotational particle velocities $U_{j}$ and $j$ and the forces and torques $\mathrm{F}_{\mathrm{i}}$ and $\mathrm{T}_{\mathrm{i}}$ applied to the particles. T he dot in equation (139) denotes the $m$ atrix $m$ ultiplication and contraction of the $C$ artesian tensorial com ponents of the resistance $m$ atrix. A detailed discussion of a m ore general resistance problem, which involves an extemal linear ow and the stresslet induced on the particles, is presented in R ef. $\left.{ }_{\underline{2}}^{2} 1 \overline{1}\right]$.

### 8.2 Evaluation ofm atrix $M$

The evaluation of the resistance $m$ atrix ${ }_{i j}^{A B}$ from expression (146) requires solving the set of linear algebraic equations for the induced-foroe m ultipoles (48) to obtain the generalized friction coe cients $\mathrm{F}_{\mathrm{ij}}$ ( $\mathrm{lm} \quad j 1 \mathrm{~m}{ }^{0}{ }^{0}$ ). Them atrix $M$ in the equation (48) is given as the sum of three term $S$ (49). The rst two term S , i.e., the single-particle scattering m atrix $\mathrm{Z}_{\mathrm{i}}$ and the m atrix $\mathrm{G}_{\mathrm{ij}}^{0}$ representing the ow in in nite space, are know n explicitly $\left[A-11^{-1}, \underline{1} 7\right]$. T he rem aining term | the two-wall contribution $G_{i j}^{0} \mid$ is evaluated num erically, using relations (132) \{ (136) along w ith our expressions for the $C$ artesian displacem ent $m$ atrioes (70), the transform ation $m$ atrioes (90), and the singlew all scattering $m$ atrix (103).

A s already $m$ entioned at the end ofSection 7, num ericalevaluation of the integral (132) is straightforw ard for su ciently sm all lateral separations betw een particles $i$ and j. For large interparticle separations $i_{i j}$, how ever, the integration is $m$ ore di cult because of the oscillatory behavior of the integrands

A typical form of the wall-interaction contribution (k) is presented in the right panel of gure 1. Unlike the results for $(k)$, the integrand $(k)$ in this exam ple is negligible already after several oscillations. T hus, the function

In our algorithm, the contribution $G_{i j}^{0}\left(\mathrm{~m} \quad j l^{0}{ }^{0}\right)$ to the $m$ atrix elem ents (132), associated w th the com ponent (k) of the integrand, is evaluated by num erical integration using the Sim pson rule. T he slow ly convergent onew all contributions (151) are calculated analytically, using the explicit im agerepresentation expressions $\underline{\underline{[ } \underline{Q}] \text { ] (cf., the discussion in Section 62). }}$

O ur num erical tests indicate that this procedure yields accurate results for $i j=H$. 20. The procedure can be further im proved, either by subtracting several term $s$ associated w ith higher-order wall re ections of the sourae multipole [2] $\overline{2} \overline{1}]$, or by deriving asym ptotic form ulas for the integrals (132) .

### 8.3 C onvergence w ith multipolar order

O ur num ericalprocedure for evaluating the friction $m$ atrix involves truncation of the linear system (48) by neglecting the induced force multipoles $f_{i}(\mathrm{~lm})$ of the order $l>I_{n}$ ax.$T$ his $m$ ultipolar approxim ation converges very slow ly w ith the truncation order $l_{n}$ ax if any tw o particles are close together or a particle is close to a wall. Such a behavior stem $s$ from a rapid variation of the ow eld in the near-contact lubrication regions. T hem echanism is well known and has been observed for particles in in nite space and in the presence of a single wall. To overcom e this di culty we em ploy a standard method, originally introduced by $\left[1 \overline{1}_{1}^{1}\right]$, according to which the lubrication forces are included in the friction $m$ atrix using a supenposition approxim ation. W e follow closely the im plem entation of the $m$ ethod described by $\underline{\underline{2} \overline{1} 1]}$ in their study of a single wall problem . A coordingly, the resistance $m$ atrix (138) is represented in the form

 isolated pair of particles $m$ and $n$ in the unbounded space, and $m$ ( $m$ ) is the single-particle resistance $m$ atrix for a sphere in the subspace bounded by the wall = L;U.The supenposition contributions (157) and (158) in equation (156) can be calculated w ith high accuracy, using $m$ ethods discussed below . $T$ he convergence $w$ th the truncation order $l_{n}$ ax of the $m$ ultipolar approxim ation
is much faster than the convergence of the multipolar approxim ation [ $\left.{ }_{i j}\right]_{l_{\text {ax }}}$ itself, where $\mathbb{B}]_{\text {max }}$ denotes the quantity $B$ evaluated using the $m u l t i p o l a r$ expansion truncated at $l=l_{n a x}$. Therefore the evaluation procedure based on equation (159) yields accurate results for the friction $m$ atrix at a substantially reduced num erical cost.

In our im plem entation, the two-particle components ${\underset{m m}{(0)}(m n) \text { and }{ }_{m n}^{(0)}(m n) ~(m) ~}_{m}$ of the friction $m$ atrix in the superposition form ula (157) are evaluated using a combination of the hubrication resistance expressions [14] and the series

O ur num erical results indicate that for large and $m$ oderate $w$ all separations $H$ (com pared to the particle diam eter) the m ultipolar approxim ation (159) converges rapidly w ith the truncation order $l_{n}$ ax. For con gurationsw ith $H \quad 2 a$ the convergence is less satisfactory, particularly for the transverse com ponents of the friction $m$ atrix. Thisbehavior is ilhustrated in gure 2 , where the relative error for the lateral and vertical com ponents

T he results corresponding to truncations at even orders of $l_{n}$ ax are $m$ ore accurate than the results corresponding to truncations at odd orders. The multipolar-truncation error for the o -center particle position (161b) is $m$ uch $s m$ aller than the error for the center con guration $w$ ith the sam e values of the particle\{wall distance $h$.

A sim ilar dependence of the truncation error on $l_{n}$ ax was observed form anyparticle friction $m$ atrix: the error is $s m a l l$, except when the wall separation is com parable to the particle diam eter. T his behavior suggests that the relatively large error for such tight con gurations results from an interaction betw een the lubrication layers| this e ect is not accounted for in the supenposition term $s$ in equation (159). The problem, how ever, requires further investigations in order to develop better approxim ation $m$ ethods.

## 9 N um erical results

In this section we give som e exam ples of num erical results for the hydrodynam ic friction $m$ atrix in system s of spherical particles con ned between two parallel planar walls. T he calculations for a single particle and for particle pairs, depicted in Figs. 3 and 4, were perform ed using the m ultipolar approxim ation (159) w ith the truncation at the order $l_{n}$ ax $=12 . T$ he $m$ ulti-particle calculations, depicted in F igs. 5 and 6 , were obtained using $l_{n}$ ax $=8$. These truncations are su cient to obtain results w ith the accuracy better than the resolution of the plots. A $m$ ore extensive set of num erical results is presented


### 9.1 Two-particle friction $m$ atrix

Figure 3 ilhustrates the behavior of the translational com ponents of the twoparticle resistance $m$ atrix, nom alized by the Stokes friction coe cient $0=$ 6 a,

The e ect of the interparticle interactions is $m$ ost pronounced for the longitudinal com ponent ${ }_{11}$, because of the strong $O\left({ }^{1}\right)$ lubrication resistance for particles in relative $m$ otion along the line connecting their centers. For the $m$ otion in the transverse directions $y$ and $z$, a signi cant interparticle-interaction e ect is seen only for very sm all interparticle gaps, because the transverse interparticle lubrication resistance has a m uch weaker logarithm ic singularity $O$ (log ) than the longitudinalone.
$T$ he results in the right panels of F ig. 3 indicate that for sm all interparticle distances all three com ponents 12 , $=x ; y ; z$, of the $m$ utual friction $m$ atrix are negative. The negative sign indicates that the hydrodynam ic force $\mathrm{F}_{1}^{\mathrm{H}}=$
$F_{1}$ produced on particle (1) by the $m$ otion of particle (2) points in the sam e direction as the particle velocity. W hen the distance between particles is increased, the transverse com ponents $\frac{\mathrm{yy}}{12}$ and $\frac{\mathrm{zz}}{2 \mathrm{c}}$ change sign, which results from the back ow associated w th the ow eld scattered from the walls. In contrast, the longitudinal com ponent ${ }_{12}^{x \times}$ rem ains negative. $W$ e note that the badk ow e ect does not occur in the unbounded space.

### 9.1.2 Far- eld behavior

At large interparticle separations ${ }_{12}=\mathrm{d} \quad 1$, the $m$ utual com ponents ${ }_{12}$ of the two-particle resistance $m$ atrix vanish, and the self-com ponents 11 tend to the corresponding one-particle values

the wall separation $H$ for the center particle position $h=\frac{1}{2} H . O$ ur present one-particle results agree w ith those of Jones [1]ini] and w ith our earlier solution obtained using the im age-singularity technique $\underline{\underline{1} \overline{1}} \mathbf{1}$ I].

T he asym ptotic approach of the tw o-particle friction $m$ atrix ij to the lim iting values at large 12 can be determ ined from the far- eld behavior of the ow eld $v^{\text {as }}$ produced by a particle moving in the horizontal direction $e \quad(=$ $x ; y)$. By expanding the ow $v^{\text {as }}$ in the $s m$ all param eter $H=$, where $H$ is the horizontal distance from the $m$ oving particle, we nd that

The above results are consistent with the asym ptotic expression for the ow eld produced in the space betw een the walls by a Stokeslet pointing in the horizontal direction tīisil]. (A general analysis of the far- eld ow will be presented elsew here.)

T he result (170) im plies that the asym ptotic far- eld behavior of the lateral com ponents of the friction $m$ atrix is

In contrast to the results (171) and (172), the lim its ${ }_{11}^{2 z}=$ bar ? and ${ }_{12}^{2 z}=0$ forthe verticalcom ponents of the friction $m$ atrix are approached exponentially on the lengthscale $H$. The num erical results show $n$ in $F$ ig. 3 agree w ith the above analysis. In particular, the signs of the longitudinal and transverse friction coe cients $\frac{x x}{12}$ and $\frac{y y}{y y}$ for ${ }_{12}=\mathrm{d} \quad 1$ are opposite, consistent w ith expressions (168) and (169).

### 9.2 Linear arrays of spheres

In order to ilhustrate the role of the far- eld ow for in wall-bounded system s , we present, in $F$ ig. 5, the resistance function ofrigid linear arrays ofN touching spheres. T he spheres are placed in the m id-plane betw een the walls on a line pointing in the $x$ direction. The gure show sthe diagonal com ponents of the translational resistance $m$ atrix of the array treated as a single rigid body

The norm alization of the resistance $m$ atrix (173) corresponds to the hydrodynam ic friction evaluated per one sphere. The results shown in the Fig. 5 are
further rescaled by the corresponding one particle results (167), and they are plotted versus the nom alized wall separation $H=d$ for several values of the chain length N .

The results in F ig. 5 indicate that for large separations between the walls (com pared to the chain length) all three com ponents of the resistance $m$ atrix decrease $m$ onotonically $w$ ith N . C onsistent w ith the behavior of elongated particles in unbounded space $\left[\underline{1}-\overline{6},{ }_{1}, \bar{i}_{2} \bar{T}_{1}\right]$, we nd that $c \quad 1=\operatorname{logN}$ and ${ }_{C}^{\mathrm{yy}},{ }_{C}^{\mathrm{Zz}}$, $2{ }_{C}^{\mathrm{xx}}$ for $1 \quad \mathrm{~N} \quad \mathrm{H}=2 \mathrm{a}$. In contrast, for m oderate and sm all values of the wall separation $H$ the behavior of each com ponent $c$ of the resistance $m$ atrix (173) is qualitatively di erent. T he longitudinal com ponent ${ }_{C}^{x x}$ decreases $m$ onotonically $w$ ith $N$, while the other tw o com ponents ${ }_{C}^{y y}$ and ${ }_{C}^{z z}$ increase with $N$ due to back ow associated w ith the presence of the walls. T his e ect is particularly pronounced for the transverse com ponent ${ }_{C}^{\mathrm{Yy}}$, where the increase is by a factor greater than three for $\mathrm{N}=20$ in the regim e H = 12 .

The qualitatively di erent behavior of the transverse resistance coe cients ${ }_{C}^{x x}$ and ${ }_{C}^{y y}$ is associated w ith the opposite directions of the asym ptotic ow eld (168) on the horizontal lines parallel and perpendicular to the velocity of a particle. A ccording to relations (168) and (169), the ow eld $v^{\text {as }}$ in front and behind the $m$ oving particle points in the direction of the particle velocity. This results in a cooperative e ect leading to a reduced resistance per particle for the longitudinalm otion ofan array. The direction ofthe ow on the penpendicular line is opposite, which produced a cum ulative e ect leading to a large increase of the resistance coe cient ${ }_{C}^{y y}$. Thise ect is further discussed in Ref.

### 9.3 Supenposition approxim ation

To illustrate the e ect of the hydrodynam ic interactions between walls on particle dynam ics in wall-bounded system $s$, the results of our accurate num erical calculations are com pared to the singlew all superposition approxim ation

In the above equation, ${ }_{i j}^{L}(\underset{i j}{U})$ represents the friction $m$ atrix for a system ofN particles in the presence of the lower (upper) wall, and ${ }_{i j}^{(0)}$ is the corresponding friction $m$ atrix in the absence of the walls. $W$ e em phasize that, unlike the superposition term $s$ in equations (156)-(158), all quantities on the right side ofequation (174) represent the fill N -particle friction m atrioes| the supenposition refers only to the wall contributions. The subtraction of the free-space
term ${ }_{i j}^{(0)}$ assures that the $m$ atrix ${ }_{i j}^{S}$ has a comect lim it if the distance of the particles to one of the walls (or both walls) tends to in nity.

In Fig. 3, the translational friction coe cients

evaluated in the supenposition approxim ation, are plotted along $w$ ith the accurate results for the tw o particle system. The right panelofF ig. 4 rep resents the ratio ${ }_{11}={ }_{11} \mathrm{~s}$ for a single particle. T he results indicate that the supenposition approxim ation is quite accurate for the single-particle friction coe cients and the self-com ponents of the two-particle friction $m$ atrix | the $m$ axim alerror for these quantities is about 18\% (also see the $m$ ore extensive one-particle

$T$ he superposition approxim ation is $m$ uch less accurate for the $m$ utual com ponents 12 of the tw o-particle friction m atrix, as show n in the right panels of F ig. 3. The accuracy of approxim ation (174) is especially poor for the transverse com ponent ${ }_{12}$ for sm all values of the wall separation $H$. M oreover, the approxim ation yields an incorrect $O\left({ }^{1}\right)$ asym ptotic behavior of the $m$ utual friction coe cients for large.

The failure of the superposition approxim ation is particularly pronounced for the transverse com ponent of the friction coe cient (173) for rigid chains of spheres. A s shown in the second panel of $F$ ig. 6, relation (174) grossly underestim ates the coe cient ${ }_{C}^{y y}$ for long chains, especially for sm all and $m$ oderate values of the nom alized wall separation $\mathrm{H}=\mathrm{d}$. T he supenposition approxim ation is insu cient in this regim e, because it does not accurately reproduce the far- eld interparticle interactions associated w th the ow (168).

## 10 C onclusions

$T$ his paper presents results of a theoretical and num erical study ofm any-body hydrodynam ic interactions in suspensions of spherical particles con ned between two parallel planar walls. O ur prim ary results include the derivation of transform ation relations betw een spherical and $C$ artesian basis sets of solutions of Stokes equations. The transform ation form ulas enable construction ofStokes- ow elds that satisfy appropriate boundary conditions both on the planar walls and on the spherical particle surfaces. U sing these transform ations, we have developed an e cient num erical procedure for evaluating the $m$ any-body resistance $m$ atrix characterizing hydrodynam ic forces acting on suspension particles in the tw o-w all geom etry.

The basis sets of Stokes ow s that are em ployed in our analysis are closely
related to the spherical solutions introduced by Lam b $[\underline{\overline{4}} \overline{9}]$ and C artesian so-
 choice of the de ning properties, how ever, we have achieved a sym $m$ etric $m$ atrix form ulation of the hydrodynam ic-interactions problem. T he underlying sym $m$ etries of the basis sets include the curl expressions linking the basis elds of di erent tensorial character, and the diagonal representations of the $O$ seen tensor in the spherical and C artesian bases. Exploring the sym $m$ etry relations in our canonical form ulation, the problem has been reduced to a set of sim ple explicit expressions.

The results of our theoretical analysis were im plem ented num erically in an algorithm for evaluating the $m$ any-particle resistance $m$ atrix in the tw $o-w$ all system. As a whole, the algorithm is quite com plex, because it involves a large num ber of com ponents. These com ponents include constructing $m$ atrix elem ents of the $G$ reen function in term $s$ of lateral Fourier integrals, using subtraction techniques to im prove convergence of the integrals for con gurations w ith widely separated particles, solving a linear system of equations for induced-force m ultipoles, and correcting the solution for slow ly convergent hubrication contributions. A ll the elem ents in the procedure, how ever, are either given explicitly or in term s of sim ple quadratures.

O ur num erical algorithm has been used to evaluate the hydrodynam ic resistance $m$ atrix for a single particle, a pair of particles, and linear arrays of particles con ned betw een two planar walls. The results for the linear arrays indicate that the far-eld ow in $m$ any-particle system $s m$ ay produce significant collective e ects. A characteristic exam ple is the large hydrodynam ic resistance for the transverse $m$ otion of an elongated array in a narrow space between the walls. A simple superposition approxim ation in which the ow scattered from the walls is represented as a combination of two singlewall contributions fails to describe such collective phenom ena.

O ur current im plem entation of the Stokesian-dynam ics algorithm for suspensions con ned betw een tw o parallelplanar walls allow s evaluation of hydrodynam ic interactions in a system of about a hundred particles. For a given num ber of particles, the num erical cost of the $m$ ethod increases $w$ ith the particle separation (especially for $>20 \mathrm{H}$ ). This increase results from the oscillatory character of the integrands in the Fourier representation of them atrix elem ents of the $O$ seen integral operator. T he lim itation can be rem oved by subtracting several term s of the multiple-im age sequence for the ow produced by the force multipoles induced on the particles. The subtracted contributions can be evaluated explicitly ${ }_{\underline{2}=1}^{2} \overline{1} 1$.

An altemative and $m$ ore e cient approach is to use asym ptotic expressions for the far- eld form of the ow eld produced by the foroe multipoles in the space betw een the walls. W e have recently derived a com plete set of such
expressions. An im portant advantage of this approach is its sim plicity| the asymptotic multipolar ow elds can be obtained from the solution of the tw o-dim ensional Laplace's equation for the pressure eld in the Hele-Shaw approxim ation. In particular, algorithm $s$ based on this $m$ ethod can be relatively easy generalized for periodic system $s$. M oreover, the e ciency of such algorithm s can be substantially im proved by applying the acceleration $m$ ethods that have been developed for Laplace's equation [5̄2̄]. W e w ill describe these results in forthcom ing publications.
