4D-XY quantum criticality in a doped M ott insulator

A new phenom enology is proposed for the super uid density $_{\rm s}$ of strongly underdoped cuprate superconductors based on recent data for ultra-clean single crystals of Y Ba₂Cu₃O_{7 x}. We show that the puzzling departure from U em ura scaling and the decline of the slope as the T_c = 0 quantum critical point is approached can be understood in terms of the renormalization of quasiparticle e ective charge by quantum uctuations of the superconducting phase. We then employ (3+1)-dimensional XY model to calculate, within particular approximations, the renormalization of $_{\rm s}$ and its slope, explain the new phenom enology, and predict its eventual dem ise close to the QCP.

The manner in which superconductivity in high-T_c cuprates gives way to M ott insulating behavior is a longstanding puzzle of fundam ental im portance. The anom alous behavior is revealed most strikingly in studies of the doping (x) and tem perature (T) dependence of the super uid density $_{s}$ [1, 2]. As the doping is reduced, both s and the critical tem perature T_c decline while the maximum superconducting gap $_0$ increases. This dichotom y, along with the empirical U emura relation $T_c / s [3]$, led to suggestions by num erous authors [4, 5, 6, 7, 8] that the superconducting transition in the underdoped cuprates is a phase-disordering transition and the pseudogap state [9] above T_c should be thought of as a \phase-disordered" d-wave superconductor. Experiments indeed show evidence for magnetic vortices [10], strong uctuation diamagnetism [11], and ferm ionic nodal quasiparticles [12] in the pseudogap state of high- T_c compounds. In addition, there is credible evidence that the superconducting transition in many compounds is in the 3D-XY universality class [13, 14, 15, 16] with a wide critical region, exactly as one would expect near a phase-disordering transition.

The focus of the present Letter is to obtain a theoretical understanding of the behavior of $_{\rm s}$ in strongly underdoped cuprates. Theoretical e orts to date have overwhelm ingly addressed the phenom enology summarized by Lee and W en [2]. However, recent experiments performed in unprecedented proximity to the M ott insulator in ultraclean single crystals of YBa₂Cu₃O_{7 x} (YBCO) [17, 18, 19] and in high quality Im s [20] are quietly overtuning the old paradigm : (i) Unlike optimally doped and weakly underdoped sam ples, the strongly underdoped data show no visible 3D-XY critical region in sam ples with T_c < 25K; rather, the approach to T_c is m ean-eld like. (ii) M easurements indicate a relationship between the critical temperature and the T = 0 super uid density of the form

a signi cant departure from the U em ura scaling. (iii) The overall doping and tem perature dependence can be param etrized as

where $y = T_c(x)=T_c^{max}$ is a measure of the doping x, $T_c^{max} = 93K$ is the maximum critical temperature for




FIG.1: Behavior expected in the vicinity of the (3 + z)D - XY quantum critical point in the doping tem perature plane. Solid line $T_c(x)$ represents the superconducting phase transition; dashed lines are crossovers.

YBCO, A ' 66m eV, and B ' 9.5. The dem ise of superconducting order described by Eq. (2) signals a profound departure from predictions of RVB-type theories and earlier param etrizations of $_{\rm s}$ (x;T) [2, 21]. In what follows, we demonstrate how this new phenomenology follows simply and elegantly from an elective theory describing a phase-uctuating d-wave superconductor.

The absence of any visible 3D-XY uctuation region in the data is surprising since one would naively expect phase uctuation e ects to become more pronounced in the underdoped region as the system approaches the Mott insulator. Upon closer inspection, however, one nds that the observed behavior is entirely consistent with the behavior of a system approaching a quantum critical point [22, 23]. Indeed, the $T_c(x)$ line in Fig. 1 must term inate at a quantum critical point (QCP), which by continuity must be in the universality class of the (3 + z)-dimensional XY model, the imaginary time

providing the extra z dimensions (z 1 being the dynam ical critical exponent.) Since D = 4 is the upper critical dimension for XY-type models, our QCP sits either right at (z = 1) or above (z > 1) its upper critical dimension, and thus we expect mean eld critical behavior, possibly with unimportant logarithm ic corrections if z = 1 [22, 23]. As indicated in Fig. 1, when crossing the nite-temperature transition close to the QCP one still encounters the classical uctuation region, but its width is now much reduced, and it is likely invisible in experiments.

There is a simple consistency check for the above scenario. If the underdoped region is indeed controlled by the (3 + z)D - XY point then there exists a simple scaling relation between $T_c(x)$ and s(x;0) which reads [22, 24]

For d = 2 we recover the U em ura scaling, irrespective of the value of z. In d = 3, as it appears to be the case in YBCO, we get $T_c / \frac{z=(1+z)}{s}$, consistent with the experimental observation of Eq. (1), if 1 z 2.

It would thus appear that general argum ents based on the proxim ity of the underdoped cuprates to a putative (3 + z)D-XY QCP naturally explain items (i) and (ii) in the foregoing list. The scaling analysis leading to Eq. (3), however, only holds when the \bare" parameters of the theory describing the critical degrees of freedom exhibit no signi cant tem perature dependence. In cuprates, quasiparticles in the vicinity of d-wave nodes give rise to a linear tem perature dependence in s which is likely to modify the scaling. In order to address this issue and item (iii) one needs to go beyond the general scaling argum ents and consider a speci c model. In the rest of the paper, we form ulate and study a particular version of the quantum XY model. We show that, when nodal quasiparticles are included through the e ective param eters of this model, it leads to a phenom enology that is consistent with the data.

The simplest model showing the XY -type critical behavior is given by the H am iltonian

$$H_{XY} = \frac{1}{2} \sum_{ij}^{X} \hat{n}_{i} V_{ij} \hat{n}_{j} = \frac{1}{2} \sum_{ij}^{X} J_{ij} \cos(n_{i} - n_{j}); \quad (4)$$

Here \hbar_i and h_i are the number and phase operators representing C ooper pairs on site r_i of a cubic lattice and are quantum mechanically conjugate variables, $[\hbar_i; h_j] = i_{ij}$. The sites r_i do not necessarily represent individual C u atom s; rather one should think in terms of \coarse grained" lattice model valid at long lengthscales where m icroscopic details no longer matter. C lassical [26, 27] and quantum [24, 28] versions of the XY model have been em ployed previously to study phase uctuations in the cuprates.

The 1st term in H $_{\rm X\,Y}$ describes interactions between C ooper pairs; we take

The second term in H_{XY} represents the Josephson tunneling of pairs between the sites; $J_{ij} = J$ for nearest neighbors along the a and b directions, J^0 along c, and 0 otherwise. In the absence of interactions, J clearly must be identied as the physical super uid density. We thus take

$$J = J_0 \qquad T \tag{6}$$

with = $(2 \ln 2 =) v_F = v$, as in a BCS d-wave superconductor. The T-linear term describes suppression of the mean-eld super uid sti ness by nodal excitations.

On a qualitative level, the physics of the quantum XY model (4) can be understood in terms of the competition between the uctuations in the local phase "i and charge fi. These are constrained by the uncertainty relation 'i ni 1 which im plies that interactions, which tend to localize charge, also necessarily promote phase uctuations, which then erode the super uid density. Ultimately, for su ciently strong V ij, a superconductor-insulator (SI) transition takes place. Charge becomes localized, and an insulating pair W igner crystal is form ed [25]. The latter can be viewed as a superconductor with com pletely disordered phase. In the rest of the paper we assume that the strength of interactions increases with underdoping and use V_{ij} to tune ourm odel across the SI transition.

To gain quantitative insight into the behavior of $_{\rm s}$ in the XY model (4), we employ two complementary approaches: the self-consistent harmonic approximation (SCHA) [26, 28], valid for weak interactions, and an expansion in the small order parameter [29, 30], valid for strong interactions in the vicinity of the SI transition.

In the SCHA one replaces H $_{\rm X\,Y}$ by the \trial" harm onic H am iltonian

$$H_{har} = \frac{1}{2} \sum_{ij}^{X} \hat{n}_{i} V_{ij} \hat{n}_{j} + \frac{1}{2} \sum_{hiji}^{X} K_{ij} (N_{i} N_{j})^{2} : (7)$$

The constants K_{ij} = K (K⁰) are identied as the renormalized ab-plane (c-axis) super uid densities [26], and are determined from the requirement that E_{har} hH_{XY} i_{har} beminimal. The cuprates are characterized by smallvalues of the anisotropy ratio = $J^0=J$. A nisotropy essentially interpolates between the cases d = 2 and d = 3 and thus profoundly a ects the approach to the thermal

phase transition. However, for the quantum phase transition the e ect is very weak. We illustrate this point below by solving the limiting cases = 1 (isotropic 3D superconductor) and = 0 (decoupled 2D layers) analytically and the interm ediate case 0 < < 1 num erically.

The trial H am iltonian H $_{\rm har}$ is quadratic in ${\rm \hat{n}_i}$ and ${\rm \stackrel{\prime\prime}{_j}}$ and can thus be easily diagonalized,

where V_q is a Fourier transform of V_{ij} and $Z_q = P_{a_{=1}}^{d} \sin^2(q=2)$, d=2;3. For short range interactions V_q ! const as q ! 0; we have $!_q q$, i.e. an acoustic phase mode. For C oulomb interactions, $V_q = 1=q^2$ as q ! 0; we have $!_q$! $!_{pl}$, i.e. a gapped plasm a mode. Sim ple power counting then show s that at low T the contribution from the phase mode to the super uid density is

In either case the low -T behavior of $_{\rm s}$ will be dominated by the quasiparticle contribution included via Eq. (6). However, as we demonstrate below quantum uctuations of the phase lead to strong renorm alizations of both the T = 0 am plitude of $_{\rm s}$ and the slope .

Using $hcos(n_i n_j)i_{har} = exp \left[\frac{1}{2}h(n_i n_j)^2 i_{har}\right]$, an identity valid for harm onic H am iltonians, we obtain

$$E_{har} = hH_{XY}i_{har} = \frac{p_{\overline{KS}}}{KS} Je^{\frac{p_{\overline{S=K}}}{S=K}}; \quad (10)$$

with the parameter $p = (2dN)^{-1} p = p = \sqrt{\sqrt{2}q}$ describing the aggregate strength of interactions. M inimizing E har with respect to K we nd

$$K = Je \frac{p_{S=K}}{p_{M}}$$




FIG. 2: Panel (a) shows SCHA result, the critical theory Eq. (14), and the interpolation discussed in the text (dashed line) for the case d = 3 with short-ranged interactions. Inset: solid line is the exact solution of Eq. (11a) and the dashed line is its approximation Eq. (11b). Panel (b) displays $_{\rm S}$ (x;T) from Eq. (11b) for several values of S. Inset illustrates the e ect of an isotropy: the curves (bottom to top) correspond to = 0.0; 0.3; 0.6; 1.0. Solid lines are solutions of Eq. (11a) for d = 2; 3 and short range interaction (we nd S=U 0.040 for d = 3 and S=U 0.058 for d = 2). D ashed lines are num erical solutions of the corresponding an isotropic equations.

(11a)

where the last expression approximates the exact solution over much of the regime of interest (see inset to Fig. 2a.) The exact solution of Eq. (11a) exhibits a rst order transition at S 0.541 J. This is an artifact of the SCHA; close to the transition phase uctuations become of the order of =2 and the harm onic Ham iltonian (8) is no longer a legitim ate approximation to H_{XY} . Below we devise an interpolation form ula based on Eq. (11b) that will represent an acceptable solution everywhere except very close to the SI transition.

To obtain the leading temperature dependence, we substitute $J = J_0$ T into Eq. (11b) and expand to leading order in T:

$$_{s}(x;T)' J_{0} 1 \xrightarrow{p} \overline{S=J_{0}} T 1 \frac{1^{p}}{2} \overline{S=J_{0}} : (12)$$

This is our main result. As expected, both the amplitude and the slope are reduced by quantum uctuations. Crucially, we observe that the T = 0 amplitude decays faster than the slope. In particular, for $S=J_0$ not too large the above expression is consistent with the experimentally observed behavior Eq. (2) if we identify $y'(1 = \frac{1}{2} S=J_0)$. In the language of Ref. [21] the parameter y can be interpreted as the quasiparticle charge renorm alization factor.

If we follow Lee and W en [2] and determ ine T_c as the temperature at which the super uid sti ness vanishes, then Eq. (12) in plies, to leading order, that $_{\rm s}({\rm x};0)$ T_c^2 , in agreement with the empirical relation Eq. (1). The agreement with the scaling result (3) is, however, entirely coincidental since our description of the super-uid density in the SCHA involves an interplay between nodal quasiparticles and noncritical quantum phase uctuations.

For arbitrary anisotropy 0 < < 1, the SCHA yields a pair of equations for K and K⁰ with structure sim ilar to Eq. (11a). These are easily solved numerically [31], and we give some representative results in the inset to Fig. 2b. Inspection of this data reveals that all the characteristic features of the d = 2;3 limiting cases remain

in place for general an isotropy. For realistic an isotropies $= 10^{2} \quad 10^{3}$ the results become practically indistinguishable from the d = 2 case.

In the regime of strong uctuations it is useful to consider the grand canonical partition function for H_{XY} expressed in the path-integral representation as a trace over bose eld'_i(), Z = D' exp(S=h), with the action

$$S = \frac{1}{2} \begin{bmatrix} Z & X \\ d & '_{i}V_{ij} \end{bmatrix}^{1} J_{ij} \cos('_{i} \ '_{j}) : (13)$$

Following Refs.29 and 30, we introduce an auxiliary complex eld $_i()$ to decouple, via the familiar Hubbard-Stratonovich transformation, the cosine term in the above action. For short range interaction the decoupled action is local in the $'_i()$ eld and the D' functional integral can be performed exactly, to any order in powers of and its derivatives. The eld assumes the role of the order parameter of the SI transition. K exping only term s up to j f and replacing the spatial lattice by the continuum yields the desired eld-theoretic representaand $r = (d=a_0^2)(1 \quad 4dJ=U), u = (7da_0^{d-4}=8)J^2(4d=U)^3,$ and $c^2 = (4da_0^2=3)(U=4d)^3=J, w$ ith a_0 the lattice spacing.

The above action S_e predicts a second order SI transition when r changes sign, i.e. when $U = U_c = 4dJ$. A nisotropy again interpolates sm oothly between the lim – iting cases [31] and gives $U_c = 4(2 +)J$. In (3 + 1) dimensions we expect mean eld theory to work near this transition. In particular, the super uid density will be given by the saddle-point value of the order parameter $j_0 f = r=u$ which yields

$$_{\rm s}$$
 (x;T) = $\frac{8}{7} \frac{U}{12J}^2$ (J U=12) (14)

with J given by Eq. (6) and doping param etrized by U. The C oulom b interaction can also be incorporated in S_e by introducing a gauge eld, but the analysis near the critical point of the resulting action is more involved [30] and beyond the scope of this Letter.

The main panel of Fig. 2 (a) combines Eq. (14) with the SCHA result adapted to the case of a short range interaction, for which S = 0.48 (U=12). The actual solution must interpolate smoothly between SCHA at small S=J and critical theory near the transition. The dashed line represents an empirical extension of Eq. (11b) to $K = J [I \quad S=J \quad (S=J)]$ with = 0.625, which we expect to be very close to the exact solution, as can be veri ed by quantum M onte C arbo or a similar technique. This interpolation still exhibits the leading be-

havior of Eq. (12), consistent with experimental data [17, 18, 19, 20] as summarized by Eq. (2).

Our results thus lend further support to the picture of underdoped cuprates as superconductors with a large pairing gap scale but super uid sti ness that is severely suppressed by M ott physics. In our approach, the latter is modeled by the charging energy terms in the XY Ham iltonian (4) which signi cantly renorm alize both the T = 0 amplitude of the super uid density s(x;T) and the quasiparticle e ective charge re ected by the slope of its T-linear term . A key new observation of this work is that the system atics of these renorm alizations m atches that found in underdoped cuprates. In particular the suppression of the amplitude is faster than that of the slope, in agreem ent with the experim ental data [17, 18, 19, 20] sum marized in Eq. (2). As illustrated in Fig. 2, this behavior persists over a wide range of interaction strengths. C lose to the SI transition, the critical theory S_e takes over. In this regime s(x;T) is given by Eq. (14), which im plies that the slope of the T-linear term stops decreasing and in fact begins to increase. Thus, our m odelo ers a testable prediction that very close to the SI transition the phenom enology of Eq. (2) will ultimately break down. W hile the quantitative details of these predictions depend on the speci cs of our model and the approxim ations em ployed, the general features are controlled by the symmetry and dimensionality and should be robust.
