On the Truncation of Systems with Non-Summable Interactions

A bstract

In this note we consider long range q-states Potts models on Z^d , d=2. For various families of non-sum mable ferrom agnetic pair potentials (x)=0, we show that there exists, for all inverse temperature >0, an integer N such that the truncated model, in which all interactions between spins at distance larger than N are suppressed, has at least q distinct in nite-volume G ibbs states. This holds, in particular, for all potentials whose asymptotic behaviour is of the type (x)=kxk=0. These results are obtained using simple percolation arguments.

K eyw ords: long range Potts model, percolation, phase transition, truncation, non-sum mable interaction.

1 Introduction

The existence of phase transitions, in lattice systems of equilibrium statistical mechanics, is a mathematically well posed problem in the canonical framework of in nite-volume G ibbs states with summable interactions [14]. For such interactions, the D obrushin Uniqueness Theorem guarantees uniqueness of the G ibbs state at high temperature, and non-uniqueness at low temperature is usually obtained as a consequence of high sensitivity to boundary conditions. The two-dimensional Ising model, for example, can be prepared in distinct them odynamic states by taking the thermodynamic limit along sequences of boxes with dierent boundary conditions. The combination of these high and low temperature behaviours leads to a well dened nite critical temperature $T_c > 0$. In general, the low temperature phases, $0 < T < T_c$, are described by local deviations from the ground state con gurations of the ham iltonian, at which the measure concentrates when T! 0.

For non-sum mable interactions, in nite G ibbs states and the therm odynam ic lim it are not de ned. Physical quantities like the free energy or pressure density don't exist, due to the fact that in the lim it of large volumes, the energy of the system grows faster than its size. Even the use of boundary conditions, in nite volumes, poses problem s. The pathological behaviour of non-sum mable system swaswell described by D yson [10]: \W hen [the potential is non-sum m able] there is an in nite energy-gap between the ground states and all other states, so that the system is completely ordered at all nite temperatures, and there can be no question of a phase transition". In other words, since the cost for ipping any given spin is in nite, the temperature, even very high, can never obtain to create local deviations from the ground states, as the ones described above in the case of sum mable potentials: at any temperature the system is \frozen" in one of its ground states, and no critical temperature can be de ned. Therefore one can infer that in nitely large lattice systems with non-sum m able potentials have, independently of the m ethod used to describe them, trivial them odynam ic behaviour. Nevertheless, various ways of rescaling the therm odynam ic potentials have been considered in the litterature, in view of obtaining non-trivial pseudo-densities in the thermodynamic limit. See for example [17] for a di erent scaling of the free energy of gravitational and electrostatic particle system s, or [8], [25], [7], where mean eld versions of ferrom agnetic spin models with non-sum m able interactions have been studied num erically.

In the present note, we study non-sum mable systems by using a simpler approach which is the following. Let , denote the G ibbs distribution of the system with ferrom agnetic pair interaction in nite volume. Since nothing can be said, in the sense of weak convergence, about the existence of the therm odynamic limit

we rst truncate the potential by suppressing interactions between points at distance larger than N:

Since $_{\rm N}$ has nite range, the in nite-volume truncated model with measure $_{\rm N}$ = $_{\rm N}$ is well de ned. When $_{\rm N}$ is non-summable, the phenomenon which we observe is the following: for any temperature, the measure $_{\rm N}$ becomes sensitive to boundary conditions once N is large enough (but nite). That is, if has a nite set of ground state congurations indexed by s, then the measures $_{\rm N}^{\rm S}$ = $_{\rm N}^{\rm S}$ is obtained by taking the thermodynamic limit along a sequence of boxes with dierent boundary conditions, dieronce N is suiciently large: $_{\rm N}^{\rm S}$ & $_{\rm N}^{\rm S}$ when s & s $_{\rm N}^{\rm S}$. Moreover, in the limit N ! 1, each $_{\rm N}^{\rm S}$ converges weakly to $_{\rm S}$, the Dirac measure concentrated on the ground state congurations. This concentration phenomenon

in the lim it N ! 1 at any xed temperature T>0 is thus sim ilar to the one discussed above for sum mable interactions in the lim it T! 0, and is in agreement with Dyson's heuristic description of non-sum mable interactions. Notice that in our approach, the interaction between any pair of spins is restored in the lim it N ! 1, and no mean eld rescaling is ever used.

In Section 2 we show that the scenario presented above indeed occurs for the ferromagnetic Potts model (d 2), for various families of non-sum mable potentials. Our results include, for instance, all potentials with slow algebraic decay (see Theorem 1):

which are the usual non-sum mable potentials considered in physics. Nevertheless, our aim is to treat general interactions, which need not be asymptotically regular as in (2), but can have an irregular structure. We also give two results for sparse interactions, which are of independent interest. In Section 3 we give the inequality which allows to study this problem via independent long range percolation and then reform ulate and prove all our results in this setting. As will be seen, the proofs are simple geometric arguments. In Section 4 we conclude with some general remarks.

This work originated with the study of the problem of truncation in independent long range percolation [11] (see [22], [24], [3] for other cases treated in the litterature). Therefore, the results presented in Section 3 give more particular cases where this problem can be solved.

2 Long Range Potts Ferrom agnet

exists, the untruncated G ibbs m easures (w ith N = 1) is are well de ned, and the problem of knowing if $s \in s^0$ for some $s \in s^0$ s depends strongly on the temperature. When is not sum mable these measures are not dened, and we study "s at large N . We rem ind that for xed N, in the lim it of very low temperature, ! 1, the typical con gurations of $\begin{tabular}{l} \begin{tabular}{l} \$ ([23]). When the temperature is xed and N becomes large, we observe essentially the sam e phenom enon. In view of the argum ent of D yson cited in the Introduction, it is reasonable to believe that at any xed > 0, each of the measures $\int_{0}^{2\pi} concen$ trates, when N ! 1, on a single con guration, which is the ground state s. This is the statem ent of the following conjecture. Let $_{\rm s}$ denote the Dirac m ass on (;F) concentrated on the ground state con guration s, and write "s") s when "s converges weakly to $_{\rm s}$ in the lim it N $\,!\,$ 1 .

Observe that $_{N}^{iS}$) $_{S}$ implies $_{N}^{iS}$ ($_{0}$ = s)! 1 in the limit N! 1, i.e. a phase transition occurs in the truncated model for large enough N. Since the system is ferrom agnetic, the sequence $_{N}^{iS}$ ($_{0}$ = s) $_{N-1}$ is non-decreasing, but the fact that it converges to 1 is not trivial. A nother way to formulate the conjecture is: $_{C}$ ($_{N}$)! 0 when N! 1, where $_{C}$ ($_{N}$) is the critical inverse temperature of the model with potential $_{N}$, i.e.

The conjecture is dicult to prove in such generality, since we don't assume any kind of regularity on . For example, the potential

which will enter in the family of interactions considered in Theorem 2, satis es the hypothesis of the conjecture. U sual perturbation techniques, such as P irogov-Sinai Theory [23], are of no use for studying the truncated version of this kind of potential, since the domain of validity for the temperature shrinks to zero when the range of interaction, here N, grows.

Remark 1.0 beeve that since the G ibbs state of any one-dimensional model with nite range interactions is always unique (see for example Theorem (8.39) in [14]), Conjecture 1 is false in dimension 1. This shows that a symmetry of the kind (3) is necessary.

For d 2, our 1st result shows that the conjecture is valid under some assumption on the speed of divergence of the series (5).

Remark 2. As can be seen easily, condition (6) is satisfied by all potentials which have slow algebraic decay, as in (2):

We shall see later, in Remark 3, that for such potentials the range 0 < d can be extended to 0 d, using the multiscale analysis of [3].

Sparse Interactions. We also give two results for potentials which don't have the symmetry (3). Namely, we consider interactions only along directions parallel to the coordinate axis e_i , $i=1;\ldots;d$, where $e_1=(1;0;\ldots;0)$, $e_2=(0;1;0;\ldots;0)$, ..., $e_d=(0;0;\ldots;1)$. That is, we are given a sequence (n_1,n_2,\ldots,n_n) 0, and (n_1,n_2,\ldots,n_n)

Notice that (9) implies (8), but with no information on the speed of divergence. Our second result is where we prove our conjecture under the general condition (8), with no assumption on the speed of divergence, but only in dimensions three or more:

3 Independent Long Range Percolation

To show that the truncated q-states Potts model exhibits a phase transition, it is su cient to show that

Our purpose is to obtain the following stronger limiting behaviour:

Consider the graph $(Z^d; E^d)$, d = 1, where E^d is the set of all unoriented edges $e = fx; yg = Z^d = Z^d, x \in y$. Edge con gurations are elements! 2 f0;1g^{E^d}. For a given function $p : Z^d = 0$;1 with

called edge probability, we consider the bng range percolation process in which each edge e = fx;yg is open (! (e) = 1) with probability p(x = y), and cbsed (! (e) = 0) with probability 1 = p(x = y), independently of other edges. This process is described by the product measure on the -eld on $f0;1g^{E^d}$ generated by cylinders, given by

where $_{\rm e}$ (! (e) = 1) = p(x y) is a Bernoulli m easure on f0;1g, independent of the state of other edges. O beeve that P is well-de ned even when p is non-sum m able. De ne the truncated edge probability

and denote by $P_{\rm N}$ the truncated product measure dened as in (14) with $p_{\rm N}$ instead of p. We shall be interested in the percolation probability $P_{\rm N}$ (0 \$ 1), which is the probability of the event in which there exists, in the truncated model, a path of open edges connecting the origin to in nity. When $P_{\rm N}$ (0 \$ 1) > 0, we say the truncated system percolates.

As can be seen in the following proposition, the percolation probability is a relevant quantity for showing all our results for the dependent Potts model, once the edge probability is well chosen in function of the potential .

U sing (11), (16) shows that percolation in the truncated independent model in plies phase transition in the truncated Potts model. This holds once the potential and

the probability p are related by (15), which is well suited for our purposes since (15) im plies that and p are bound to have the same asymptotic behaviour: as can be seen, there exist two positive functions C = C (;q) such that

In particular, non-sum mability of implies non-sum mability of p. A lthough it does not appear exactly in this form in the litterature, (16) is standard, and can be obtained via the random cluster representation of the measure $^{is}_{N}$, and its domination properties with respect to Bernoulli product measures. We refer to [1] or [15] for details.

By Proposition 1, long range independent percolation can be used to show all the results stated previously for the Potts model. We therefore reformulate and prove the equivalent of the results of Section 2 in the context of independent percolation, in which our conjecture is that when (13) holds and

In fact Theorem 4 can be obtained, under condition (19), using the multiscale analysis of Berger [3], for all 0 d. Our Theorem allows p to have gaps, but does not cover the case = d, unless is assumed su ciently large.

Proof of Theorem 4: The proof is a simple (almost trivial) blocking argument. Fix N large. For each s 2 S = f(s_1 ;:::; s_d): s_i = 1g, de ne the quadrant Q_s^N (0) = fy 2 Z^d : 0 < s_iy_i N; i = 1;2;::;dg. For any x 2 Z^d , let Q_s^N (x) = x + Q_s^N (0). A site x is good if there exists, for all s 2 S, a site y 2 Q_s^N (x) such that the edge

where we used the inequality $\log(1 - t)$ to valid for all t < 1, and $c_1 > 0$ is a constant that depends only on the dimension. Next, consider a partition of Z^d into disjoint blocks of linear size 3N, obtained by translates of the block $C^N(0) = [0;3N)^d \setminus Z^d$. That is, each block of this partition is of the form $C^N(z) = 3zN + C^N(0)$, for some renormalized vertex $z \in Z^d$. We say a block $C^N(z)$ is good if each $x \in Z^d$ is good. Now for two points $x \in Z^d$, the events fx is goodg and




Figure 1: Illustration of a good site x in the two-dimensional case.

is 1-dependent, i.e. X_z^k and $X_{z^0}^k$ are independent when kz $z^0k > 1$. By a Theorem of Liggett, Stacey and Schonmann [21], $(X_z^k)_{z^2Z^d}$ stochastically dominates an independent Bernoulli process $(Z_z^k)_{z2Z^d}$ of parameter k > 0, and (21) in plies $\lim_{k \to \infty} \frac{1}{k} = 1$. Take k large enough such that $k > p_c(Z^d; site)$, where $p_c(Z^d; site)$ is the critical threshold of Bernoulli nearest-neighbour site percolation. For such k, the process $(Z_z^k)_{z \ge z^d}$ is supercritical and by dom ination there exists an in nite cluster of good boxes. It is easy to see that any in nite connected component of good boxes yields an in nite connected component of sites of the original lattice. By taking N large one can thus make P_N (0 \$ 1) arbitrarily close to 1.

 $_{x2B_{N}}$ p(x) for large Remark 4. Criterium (18) concerns the behaviour of the sum N, and not the details of the function p(). This has an interesting consequence, as the following discussion shows. Assume p is such that (18) holds. Then Theorem 4 guarantees the existence of som e N such that the system whose edges e = fx; yq are allofsize at most kx yk N, with edge probabilities p(), satis es \mathbb{R} $(0 \$ 1) > 0. As seen in the proof, the integer N is xed once the sum of the edge probabilities passes a given value K $_{\rm N}$, i.e.

Now, observe that the function p can be modied inside B_N , but as long as the sum is preserved, the percolation probability remains positive. For example, if $: B_N : B_N$ is any permutation preserving the symmetry k (x)k = k (y)k for kxk = kyk, then

and so the truncated system $w_{\vec{p}}$ th edge probability p(()) also percolates. This $_{\mathrm{x2B}_{\mathrm{N}}}$ p(x), rather than the individual edge probacom m ent suggests that the sum bilities, is the relevant param eter in the study of percolation in the truncated model. This property can also be easily veri ed for long range percolation on trees.

Sparse Connections. We now give two results concerning systems where connections are not isotropic, and we will consider the case where a connection can be opened between two sites x; y only if these lie on a same coordinate axis. That is, $p(x) \in 0$ only if x is parallel to one of the coordonate axis e_i , i = 1; ...; d. In this case the probabilities p(x) are determined by a sequence $(p_n)_{n=1}$, $p_n \ge [0;1]$, and

Since this result has already appeared in [11] we shall only rem ind the strategy of the proof, which is very dierent, in spirit, from that of Theorem 4. We consider the two dimensional case d = 2. Nevertheless, the core of the proof is to use properties of nearest-neighbour percolation in high dimensions d. Denote by $p_{\rm c}$ (Z $^{\rm d}$) the percolation threshold of nearest-neighbour Bernoulli edge percolation on Z $^{\rm d}$. It was shown by K esten [19] that

$$p_{c}(Z^{d})! 0 \text{ when } d! 1:$$
 (26)

Then, let f1;2;:::;Lg^{d 2} Z^2 denote the slab of thickness L in Z^d . It was shown by G rim m ett and M arstrand [16] that the slab percolation threshold satis es

$$p_c(f1;2;:::;Lg^{d-2} Z^2)! p_c(Z^d) when L! 1:$$
 (27)

Now call 2 the lim sup in (25), and consider some diverging sequence $n_1; n_2; \ldots$ for which p_{n_k} . By (26) and (27) there exists a dimension d and an integer L (both depending on) such that for all k,

$$p_{n_k} > p_c(f1;2;:::;Lg^{d-2} Z^2)$$
: (28)




Figure 2: The embedding of the slab f1;2g Z^2 Z^3 in $(Z^2;E^2)$.




Figure 3: The embedding of the cube f1;2g³ on the positive axis of (\mathbb{Z}^2 ; \mathbb{E}^2), using long range edges. We have chosen $n_{i_1} = n_1$, $n_{i_2} = m \inf n_k : n_k > n_{i_1} g$, and $n_{i_3} = m \inf n_k : n_k > n_{i_1} + n_{i_2} g$, in order to avoid overlapping. Then, an in nite number of copies of this cube must be glued together, to form the slab f1;2g³ \mathbb{Z}^2 embedde in (\mathbb{Z}^2 ; \mathbb{E}^2).

It is then clear how to pursue: we embed the slab f1;2;::;Lgd 2 Z² in (Z²;E²), using edges of sizes taken in the set fn1;n2;:::g. Here, N must be taken large enough. The point is that we only need a nite number of sizes, and that by (28) each edge of the embedded graph has probability at least > p. (f1;2;:::;Lgd 2 Z²) of being open. This guarantees that the independent truncated process on this graph is supercritical, hence contains with probability one an in nite cluster: P_N (0 \$ 1) > 0. The simplest case for which the embedding can be easily understood is when d = 3 and L = 2, which we illustrated on Figure 2. For higher dimension, for example in the case where d = 5, we have represented on Figure 3 an embedding of the cube f1;2g³ in (Z²;E²), which shows what must be done in the general case. The formal embedding of the slab f1;2;:::;Lgd 2 Z² can be found in [11]. We leave it as an exercise to the reader to show that (26) can be used again to show that $\lim_{N} P_N$ (0 \$ 1) = 1.

Remark 5. In order to deduce Theorem 2 from Theorem 5, one must estimate

Observe that C (;q) goes to zero when & 0. Therefore, the dimension d and the thickness L of the slab used in the proof above diverges for large temperatures.

R em ark 6. Theorem 2 follows from Theorem 5 and Proposition 1. Recently, Bodineau [5] has proved the analog of the result of Grim mett and Marstrand [16] (which we used in (27)) for the percolation threshold of the random cluster measure associated to the Ising model (q=2). Therefore, using the main result of [5] and the same embedding as above, one can obtain a more direct proof of Theorem 2 for the case q=2, without using Proposition 1.

Theorem 6. (d 3) If

$$p_n = +1$$

then $\lim_{N} P_{N}$ (0 \$ 1) = 1.

Proof. The proof relies on the fact that sequences p_n that satisfy (29) already im ply percolation in one dimension. So for a while we consider long range percolation on $(Z;E^1)$, and denote by P^1 the product measure on $f0;1g^{E^1}$ associated to the sequence $(p_n)_{n-1}$. By Borel-Cantelli we have $\Rightarrow P^1$ (0 \$ 1) = 1. For simplicity we rst assume that there exists, for all m 2 Z, a sequence $n_1 = 0; n_2; \ldots; n_k = m$ such that $p_{j_{n_{i+1}} n_{ij}} > 0$. This implies, by [2], that the in nite cluster is unique. We can thus write

$$P^{1}(0 \ \$ \ 1) P^{1}(0 \ \$ \ 1 \ ; 1 \ \$ \ 1 \) P^{1}(0 \ \$ \ 1 \) P^{1}(1 \ \$ \ 1 \) = {}^{2};$$

where we have used, in this order, uniqueness of the in nite cluster, FKG inequality, and translation invariance. For a < b let T_L (a;b) = [a L;b+L]. Then f0 \$ 1 in T_L (0;1)g % f0 \$ 1g when L ! 1 . Therefore for all > 0 there exists L such that for L L ,

$$P^{1}(0 \$ 1 in T_{I}(0;1))$$
 : (31)

Since

$$^{2} = 1 > p_{c} (H);$$




Figure 4: The honeycomb lattice H and its embedding in \mathbb{Z}^3 , denoted \mathbb{H}^0 .

 (32)

where p_c (H) is the percolation threshold of the honeycom b lattice H , we can take small enough such that 2 > p_c (H), and x L L . Back to d = 3, consider the embedding of H in Z^3 , denoted H 0 , depicted on Figure 4. To each edge e = fx;yq 2 H 0 corresponds a one dimensional subgraph

(Z (e); E^1 (e)) (Z 3 ; E^3) which consists of all the points (and long range edges) contained in the line supported by e; (Z (e); E^1 (e)) is nothing but a copy of (Z; E^1), embedded in (Z 3 ; E^3), containing e. All the previous considerations on (Z; E^1) (for example the intervals T_L (x; y)) can be adapted in each subgraph (Z (e); E^1 (e)). An important property of the embedding we have chosen is that the graphs (Z (e); E^1 (e)), (Z (e); E^1 (e)) associated to two different edges e; E^0 2 H E^0 have disjoint sets of edges. We now define an edge E^1 exists, in

(Z (e); E^1 (e)), a path connecting x to y in T_L (x; y). C learly, edges are good independently and for N = 2L + 2,

 (e is good) = P_N^1 (x \$ y in T_L (x;y)) 2 > p_c (H):

Therefore, there exist in nite paths of good edges, yielding the existence of an in nite cluster on (Z 3 ; E 3) with edges of sizes smaller than N . C learly, $\lim_{N} P_N$ (0 \$ 1) = 1, which nishes the proof. When the assumption made at the beginning is not satis ed, it su ces to replace P 1 (0 \$ 1), in (30), by P 1 (0 \$ K) for a well chosen K. The rest of the proof can be adapted in a straightforward way.

Observe that the only place where we used the divergence of the series (29) was to obtain $P^{1}(0 \ 1) = 1$. A variant of Theorem 6 can therefore be reformulated under a m gre abstract condition on the sequence $(p_n)_{n=1}$, which can hold also when the series p_n converges:

Theorem 7. (d 3). Assume the sequence $(p_n)_{n=1}$ is such that $\Rightarrow P^1(0 \ 1)$ satis es 2 > p_c (H) and that the one-dim ensional in nite cluster is unique. Then P_N (0 \$ 1) > 0 when N is large enough.

FinalRem arks

We have considered the problem of truncation in the long range Potts model with non-sum mable ferrom agnetic interactions, via simple percolation techniques. We have shown that for various fam ilies of potentials, a phase transition occurs in the truncated model as soon as the parameter of truncation N is taken su ciently large. Notice that by Proposition 1 all the existing results on truncation in long range percolation ([22, 24, 3]) have their counterpart in the long range Potts model. We hope that embeddings, as those we used in the proofs of Theorem s 5 and 6, m ight be used for possible generalisations since they don't require any particular regularity of the potential/edge probability at in nity, and give som e insight into new m echanism s of phase transitions in systems with long range interactions.

Before ending, we make two remarks concerning the problem of truncation.

A Mean Field Limit. As our results show, in nite systems with non-sum mable interactions have trivial dependence on the temperature. In the physics litterature, som e m ethods have been used in view of understanding the properties of large but nite systems with non-summable interactions. These methods rely essentially on the study of the mean eld version of the original model. Namely, since the energy of the nite system grows faster than its size in the lim it of large volumes, the model is modied ([7,8,25]) by dividing the total ham iltonian by a well chosen power of the volume j j. In the case of Ising spins x = 1 with ferrom agnetic interactions d, this m eans considering the following form alidentity: (x) = kxk , 0

The scaling parameter $\,$ must be chosen in function of $\,$ in order to obtain a well de ned them odynam ic $\,$ lim it for the potential $\,$ j $\,$ (x $\,$ y), leading to a mean eld inverse critical temperature $\,$ c(). Then, the \critical inverse temperature $\,$ c(;) of the real system in a nite volume $\,$ can be infered to go to zero as $\,$ c(;) $\,$ c()jj $\,$. It was numerically observed ([8], [25]) that $\,$ c() depends weakly on , which has lead the authors to conjecture that all the systems with $\,$ d have the same them odynamic behaviour, i.e. identical to the pure mean eld case $\,$ = 0. This \universal" mean eld behaviour was then given an intelligible explanation by Vollm ayr-Lee and Luiten [26].

We now wish to present an argument in favor of our conjecture, similar in some ways to the strategy of [26]. A part from helping to understand our conjecture, it also sheds some light on the weak dependence in observed numerically in [8], [25]. For simplicity we consider the case q=2, i.e. the Ising model. Remember that Conjecture 1 claims that when is non-summable, then $_{\rm c}(_{\rm N})$! 0 as N ! 1, where $_{\rm c}(_{\rm N})$ is the critical inverse temperature of the truncated model $_{\rm N}$. De ne

and consider the form alidentity:

where we have de ned the rescaled quantities

$$b_{N} = e_{N}; \quad b_{N}(x) = \frac{N(x)}{e_{N}}$$

Since $\lim_N e_N = +1$ (we assume is non-sum mable), we have $\lim_N b_N^0 = +1$. M oreover, the new potential b_N^0 has the following properties: 1) it has range at most N , 2) it is sum mable

$$b_{N}(x) = 1;$$

and 3) $\lim_{N} b_{N}(x) = 0$ for all x. Such properties rem ind those of Kac potentials, which are of the form (x) = d'(x), where '(x) = 0 is bounded, supported by $[1;+1]^{d}$, with '(x)dx = 1, and > 0 is a small scaling parameter. thus has the following properties: 1) it has range [1,2) it is sum mable:

$$(x)dx = 1 8 > 0;$$

and 3) $\lim_{t \to 0^+} (x) = 0$ for all x. It is well known ([18], [20]) that such potentials give, in the van der W aals $\lim_{t \to 0^+} 0^+$, a justication of the van der

W aals-M axwell theory of liquid-vapor equilibrium: in this limit, the properties of the system converge to those of mean eld, regardless of the details of the function '. M oreover, it is known ([9], [6]) that for > 0 the model is a good approximation to mean eld: a phase transition occurs before reaching the mean eld regime, and $\sup_{>0-c} (-) < +1$.

It is tempting to ask whether this mean eld behaviour of K ac potentials at small also holds for our potential $^b{}_N$ at large N , and to identify the parameters 1 and N . Although $^b{}_N$ is not obtained by a rescaling of a given function, as is, one can expect that for a reasonable potential (for example of the type (2)), the critical temperature $_c(^b{}_N)$ is uniformly bounded in N: $\sup_{N=c}(^b{}_N) < +1$. Therefore, if N is large enough so that $^b{}_N > \sup_{N=c}(^b{}_N) = _c(^b{}_N)$, we have a phase transition in the truncated model $_N$, as predicted by our conjecture. Moreover, since we expect that the properties of the system with $^b{}_N$ converge to those of mean eld when N! 1, independently of the ne structure of , this again is in favor of the non-dependence on observed in [8] and [25].

On the General Problem of Truncation. We have seen that in the long range ferrom agnetic Potts model, non-sum mable interactions with the sym metry (3) are pathological in the sense that in the \lim it N $\,!\,$ 1 $\,,$

for all > 0 and all s 2 f1;2;:::;qg. A natural question is to ask whether this weak convergence also occurs in the case where is som mable, i.e. when i^s is well de ned. Is it that

in the lim it N ! 1 ? The answer to this question is negative in d = 1. Namely, for the Ising model q = 2, there exist sum mable potentials for which $^{''}$ ($_0$ = +1) > $\frac{1}{2}$ at low temperature ([10],[13]), but $^{''}$ ($_0$ = +1) = 0 for all N as well known (see Remark 1). On can thus wonder if the weak convergence (35) occurs in dimensions d 2. If this happens to be the case, it would lead to the following highly non-trivial fact: assume is sommable and that a phase transition occurs in the untruncated system:

Then, if (35) holds, there exists an integer N such that a phase transition occurs in the truncated model:

$$_{N}^{s} (_{0} = s) > \frac{1}{q}$$
:

That is, the tail of the interaction plays no important role in the occurence of phase transitions in sum m able long range m odels. This question is again the analog of the general problem of truncation that has been posed in the context of long range percolation: if P (0 \$ 1) > 0, does there exist some large N such that P_N (0 \$ 1) > 0? This is believed to be true in general, with no assumption on the edge probability (other than, say, the sym metry (13), or for sparse interactions as (23)). This property is non-trivial for the following reason: the truncated measure P_N converges weakly to P, but the Portmanteau Theorem (see [4]) doesn't apply, due to the fact that in the product topology, the boundary of the event f0 \$ 1 g has strictly positive probability (1, in fact). One can thus not conclude that P_N (0 \$ 1)! P (0 \$ 1). Our results of Section 3 and various existing results [22, 3, 24, 11] give a rm ative answer to the problem of truncation for particular cases.
