## The Interplay of Spin and Charge Channels in Zero D im ensional System s

We present a full edged quantum mechanical treatment of the interplay between the charge and the spin zero-mode interactions in quantum dots. Quantum uctuations of the spin-mode suppress the Coulomb blockade and give rise to non-monotonic behavior near this point. They also greatly enhance the dynamic spin susceptibility. Transverse uctuations become important as one approaches the Stoner instability. The non-perturbative elects of zero-mode interaction are described in terms of charge (U (1)) and spin (SU (2)) gauge bosons.

The importance of electron-electron interactions is emphasized in low-dimensional conductors. In onedimension interactions in the charge and spin channels are separable Considering zero-dim ensional quantum dots (QDs), the "Universal Ham iltonian" [1, 2] scheme provides a framework to study the leading interaction modes: zero-mode interactions in the charge, spin (exchange) and Cooper channels. W hile this Ham iltonian is simple, the physics involved is not at all trivial. The charge channel interaction leads to the phenom enon of the Coulomb blockade (CB). The exchange interaction leads to Stoner instability [3], which, in m esoscopic system s as opposed to bulk, is modi ed [1]. Attention has been given to the intriguing interplay between the charge and the spin channels. This is manifest, for example, in the suppression of certain Coulomb peaks due to "spinblockade" [4]. In a recent theoretical study [5] the e ect of the spin channel on C oulom b peaks has been analyzed employing a master equation in the classical limit.

In this Letter we study both transport through a m etallic grain and the dynam ic m agnetic susceptibility of the latter. Speci cally we nd that (i) the spin modes renorm alize the CB, thus modifying the tunneling density of states (TD oS) of (hence the di erential conductance through) the dot (cf. Fig 2 and Eq. 23). For an Isinglike spin anisotropy (represented by 1 ) the longitudinalm ode partially suppresses the CB. Transverse m odes act qualitatively in the same way, but as one approaches the Stoner instability point (from the disordered phase), the e ect of transverse uctuations reverses its sign and acts towards suppressing the conductance (i.e., enhancing the CB). This results in a non-monotonic behavior of the TD oS. (ii) The longitudinal magnetic susceptibility <sup>22</sup> (25) diverges at the therm odynam ic Stoner Instability point, while + (25) is enhanced but remains nite. How ever, one notes that the static transverse susceptibility is enhanced by the gauge uctuations.

Our study is the rst full edged quantum mechanical analysis of spin uctuations and the charge-spin interplay in zero dimensions. The non-perturbative e ects of zero-m ode charge interaction (e.g. zero-bias anom aly [6]) are described in terms of the propagation of gauge bosons (U (1) gauge eld) [7]. Here we adopt similar ideas to account for spin uctuations described by the non-abelian SU (2) group. The C oulom b and longitudinal spin components are accounted for "exactly", while transverse spin uctuations are analyzed perturbatively (with the easy-axis anisotropy, [8]). These uctuations become important as one approaches the Stoner instability. Here we restrict ourselves to the C oulom b valley regim e and ferrom agnetic exchange interaction.

Before proceeding we recall that beyond the therm odynam ic Stoner instability point,  $J_{th} = ($  being the m ean level spacing) the spontaneous magnetization is an extensive quantity. At smaller values of the exchange coupling,  $J_c < J < J_{th}$ , nite magnetization shows up [1], which, for nite systems, does not scale linearly with the size of the latter [9]. Its non-self-averaging nature gives rise to strong sam ple-speci c m esoscopic uctuations. The incipient instability for nite systems is given by  $J_c = = (1 + )$  for an even number of spins in the dot and  $J_c = = (1 + =2)$  for an odd number [10].

H am iltonian and correlators. Our QD is taken to be in the metallic regime, with its internal dimensionless conductance g 1. D iscarding both Cooper and spinorbit interaction channels, the description of our metallic QD allows for only two other channels, namely charge and spin. W hile the charge interaction is invariant under U (1) transformation, the spin interaction possesses a non-abelian SU (2) symmetry associated with the noncommutativity of the quantum spin components.

The Universal Ham iltonian now assumes the form

Here denotes a single-particle orbital state with spin projection . For simplicity, below we can ne ourselves to the GUE case. The Ham iltonian  $H_c = E_c (n N_0)^2$  accounts for the Coulomb blockade,  $E_c = e^2=2C$  is a charging energy, n the number operator; N<sub>0</sub> stands for a

positive background charge tuned to a Coulomb valley. The Hamiltonian

represents the spins S  $\circ \frac{1}{2}^{P} a^{y}$ ;  $\sim \circ a$ ;  $\circ$  interaction within the dot. Hereafter we assume strong easy axis anisotropy [8],  $= J_2 = J_k < 1$ . In this case the spin rotation sym m etry is reduced to SO (2). W e w ill treat the term s of transverse and longitudinal (Ising) uctuations independently.

we obtain a Lagrangian which includes a term quadratic in L = M . Here we have used a spinor notation =  $( \ _{\#} \ _{\#} )$  and the matrix M is given by

Our goal here is to obtain the GF.We rst add source elds to the Lagrangian

Gauge transform ation. We now apply a (non-unitary) transformation to gauge out both the Coulomb and the longitudinal part of the spin interaction  $M^{\sim}$  = W M W <sup>1</sup>. We have  $\tilde{}$  = W () and  $\tilde{}$  = W <sup>1</sup>() with

Here () accounts for the U(1) uctuations of the charge (longitudinal) uctuations,

In dening the gauge elds  $_0$  [7] and  $_0^z$  one needs to account for possible winding numbers  $(k; m = 0 \quad 1; :::)$  [11]:

In Eq.(11) initial conditions W(0) = 1 and periodic boundary conditions W(0) = W() are used. As a result, the diagonal part of the gauged inverse electron's GF (M) does not depend on the nite frequency components of elds. The o -diagonal part

can be taken into account by a perturbative expansion in < 1. We represent  $M^{\sim} = (G^{[0]})^{-1} + w$  ith  $G^{[0]}()^{-1} = ((e^{-1} + i_{0})) + e^{-2} + w$  and the self-energy  $= e^{p} - e^{2} + e^{-2} + e^{-2}$ . We next calculate the G reen's function

Hereafter h:::i\_ (h:::i\_{tr}) denotes G aussian averaging over uctuations (transverse uctuations) of the bosonic eld (~; ) and ~= +  $^{z}_{0}$ + i  $_{0}$ . Integrating over all G rassmann variables and expanding M with respect to the transverse uctuations, one obtains [12]




FIG. 1: First and second order Feynm an diagram s contributing to electron's GF. Solid line represents  $G_{i}^{[0]}$ ; double dashed line stands for combination of C oulom b and longitudinal bosons; single dashed line denotes a longitudinal boson while the zig-zag line represents h<sup>+</sup> (1) (2)i.

In the spirit of [7], the interaction of electrons with the nite-frequency charge and longitudinalm odes  $\begin{pmatrix} n & n \\ n \end{pmatrix}$  m ay be interpreted in term sofa gauge boson [13] dressing the electron propagator (cfF ig.1a). The exact electronic GF (depending on winding numbers [11]) is given by [7]

The exchange interaction e ectively modiles the charging energy. For long-range interaction this correction is small  $E_c=J$  ( $k_F L$ )<sup>d 1</sup> [2] (L is a linear size of the d-dimensional conned electron gas,  $k_F$  is a Ferm imomentum), while for contact interaction  $E_c$  J=4 = 0 [2].

Transverse uctuations. The rst non-vanishing diagram of our expansion (14) is depicted in Fig.1b. Here

In Eq.(19) the rst term is a manifestation of the white noise uctuations of the elds ~ arising from the G aussian weight factor (cf. Eq. (15)). The second term is related to the non-G aussian factor in D and re ects the feed-back of (the D -dependent) G <sup>[D]</sup> on D . Note that the transverse components are always accompanied by the gauge factors e <sup>2</sup>, hence the longitudinal bosons contribute to the dynam ics involving the transverse uctuations.

To proceed we now sum Eq.(14) over . Perturbative corrections to the electron GF coming from transverse

uctuations are now expanded in and summed up in the factor  $F_{?}$

The e ects of disorder are incorporated in the bare density of states  $_0 = 1 = .$  We denote  $_f$   $_i$ . At - nite tem peratures we employ the conform al transform ation 1=( $_i$   $_f$ )! =(sin( $(_i$   $_f$ )=)). The factors ff<sup>(n)</sup>g<sup>(m)</sup>g refer to diagrams containing n + m D (zigzag) line correlators, in n (m) of which we employ the rst, -function (second, constant) tem of Eq. (19). The ff<sup>(m)</sup>g factor is  $^{n+2m}$ . Here we calculate F<sub>2</sub> to order  $^2$ .

In general, we may write the elective transverse gauge boson as D<sub>2</sub> (;) = exp (\$(;)) [14]. \$ preserves the symmetry (in) with respect to =2 to all orders of . It can therefore be written as S<sub>2</sub> (;  $\frac{2}{2}$ ).

The rst term in (21) (of order ) is given by

This contribution is of the same origin as that of the longitudinal boson part (namely it comes from the  $\frac{1}{J}_{0}^{2}$  a term in Eq. (19).) Along with the other m = 0 terms in (21) it can be exponentiated [14], resulting in J=4 ! J (1 + 2)=4 in the expression for  $S_{k}$ . For the isotropic m odel one obtains (1 + 2)=4 ! S (S + 1).

There are contributions to S<sub>?</sub> arising from the second term of Eq.(19). As a result, the lowest, <sup>2</sup> contribution (the ff<sup>(0)</sup>g<sup>(1)</sup>g term of the expansion (21)) leads to a non-G aussian contribution to S<sub>?</sub> which is  $\frac{2}{2} \frac{2}{(J)} [-2]^2$ . It is easy to show that below the incipient Stoner instability,  $J < J_c$ , S<sub>?</sub> is dom inter the point it is the second (singular Stoner) term in (19) which dom inates.

Tunneling density of states. The conductance  $g_T$  is  $_Z$  related to the tunnelling DoS through  $g_T = \frac{e}{\sim} d$  () ()  $\frac{\varrho f_F}{\varrho}$  where  $f_F$  is the Fermi distribution function at the contact and is the golden rule dot-lead broadening. To obtain the TD oS from the GF, Eq.(20), we deform the contour of integration in accordance with [7]. As a result, the TD oS is given by [15]




FIG. 2: The spin-norm alized tunneling density of states shown as function of energy. Insert: TD oS as function of temperature.

have computed the temperature and energy dependence of the TD oS for various values of . These are depicted in F ig 2. The energy dependent TD oS shows an intriguing non-monotonic behavior at energies comparable to the charging energy  $E_c$ . This behavior, absent for J = 0, is due to the contribution of the second term in Eq.(19). It is amplied in the vicinity of the Stoner point, and signals the e ect of collective spin excitations (incipient ordered phase).

Spin susceptibilities. The spin susceptibilities are dened through

The longitudinal susceptibility ( $^{zz}$ ) is not a ected by the gauge bosons. By contrast, the transverse  $^+$  acquires the gauge factor he<sup>2</sup> ( $^{j}$ i<sub>m</sub>;  $_{z}$ , where the average is perform ed with respect to the Gaussian uctuations of  $^{z}$  and, in principle, the winding numbers (cf. Eq.(12)). In practice, since T > J, only the m = 0 winding should

where  $_0 = 1$ =. The above susceptibilities are given as function of . To obtain the dynamic susceptibilities one needs to Fourier transform and then continue to real frequencies. <sup>zz</sup> (25) [16] diverges at the thermodynamic Stoner Instability point, while <sup>+</sup> remains nite. Notwithstanding, the static transverse susceptibility is enhanced by the gauge uctuations. The dynamic behavior (including relaxation processes) and the corrections to will be discussed elsew here.[17].

Sum marizing, we investigate in uence of spin and charge zero-mode interactions on the TD oS and the susceptibilities. Longitudinal spin uctuations suppress the CB and the static longitudinal susceptibility is greatly enhanced near the Stoner instability. Transverse uctuations generally tend to suppress the CB, but also contain a term which dom inates the dynam ics near the Stoner instability and enhances the CB. The transverse susceptibility will be enhanced as well. On a more technical level, C oulom b interaction is described in terms of A belian (U (1)) gauge theory and lead to G aussian gauge factor, the spin interaction, being a subject of non-A belian (SU (2)) gauge gives rise to non-G aussian gauge factors.
