## Extended variational cluster approxim ation for correlated system s

The variational cluster approximation (VCA) proposed by M.Pottho et al. Phys. Rev. Lett. 91,206402 (2003)] is extended to electron or spin system swith nonlocal interactions. By introducing more than one source eld in the action and employing the Legendre transformation, we derive a generalized self-energy functional with stationary properties. Applying this functional to a proper reference system, we construct the extended VCA (EVCA). In the limit of continuous degrees of freedom for the reference system, EVCA can recover the cluster extension of the extended dynam ical mean-eld theory (EDM FT). For a system with correlated hopping, the EVCA recovers the cluster extension of the dynam ical mean-eld theory for correlated hopping. Using a discrete reference system com posed of decoupled three-site single in purities, we test the theory for the extended H ubbard m odel. Quantitatively good results as com pared with EDM FT are obtained. We also propose VCA (EVCA) based on clusters with periodic boundary conditions. It has the (extended) dynam ical cluster approximation as the continuous limit. A number of related issues are discussed.

#### I. IN TRODUCTION

In the past decade, the dynamical mean-eld theory (DMFT) was developed as a powerful technique for the study of correlated electron system s.<sup>1,2</sup> Much knowledge have been obtained on the strongcorrelation e ect in three-dimensional systems, such as the M ott-H ubbard m etal-insulator transition,  $^{2,3,4}$  it in erant ferrom agnetism,<sup>5,6</sup> and the colossal magnetic resistance in manganites,<sup>7</sup> etc. Recently there are DMFT studies combined with ab initio energy band calculations for realm aterials.<sup>8,9</sup> O ne of the m any ways to derive the dynam icalm ean- eld theory is to approxim ate the exact Luttinger-W ard functional by a local one which depends only on the local G reen's functions.<sup>2</sup> The latter is then obtained from an e ective single-impurity model with a self-consistently ascribed bath. This approximation becom es exact in the lim it of in nite spatial dim ensions. For nite-dimensional systems, this approximation ignores the spatial uctuation e ects from the outset, and the nonlocal interactions in the model are treated only on the Hartree level.

In order to take into account the spatial uctuations beyond DMFT, besides the system atic 1=D expansion approach,<sup>10,11</sup> various cluster algorithm s, e.g., the cellular DMFT (CDMFT),<sup>12,13,14,15</sup> and the dynam ical cluster approximation (DCA),<sup>16</sup> have been proposed. The form er uses clusters with open boundary conditions, and the latter has periodic boundary conditions. These methods not only produce a k-dependent self-energy, but also include the short-range part of the nonlocal interaction within the cluster. On the other hand, DMFT has also been extended to treat the nonlocal interaction terms in the H am iltonian more satisfactorily. In this respect, there is the extended DMFT (EDMFT) for including the nonlocal density-density or spin-spin interactions,<sup>17,18,19</sup> and the DMFT for correlated hopping<sup>20,21</sup> (DMFTCH) for treating the correlated hopping term s. An approach based on ctive in purity models has been proposed to e ectively circum vent the possible noncausality problem in previous cluster algorithm s.<sup>22</sup> All these developments have led to various dynam icalmean - eld algorithm s and their cluster extensions,<sup>23</sup> which constitute one of the most active elds of the strongly correlated electron theories.

Recently, another cluster theory, the variational cluster approximation (VCA), was proposed by Pottho et al.<sup>24</sup> This theory provides a rather general framework to form ulate cluster approximations for a lattice ferm ion system s. In the VCA, di erent approximations are realized by using di erent reference system s. Such reference system s can have di erent degree of com plexity, ranging from a two-site system <sup>25</sup> to a cluster embedded in several auxiliary baths. In the limit of continuous bath degrees of freedom, the VCA recovers the form ula of CDM FT in the sim ple basis. The DM FT is obtained from the VCA by using a single-in purity reference system with continuous degrees of freedom.

The VCA is constructed from a self-energy functional which is obtained by doing a Legendre transform ation on the Luttinger-W and functional [G].<sup>27,28</sup> The Luttinger-W and functional plays an important role in the theories of correlated ferm ion system s. It was not constructed in 1960s in the course of expressing the therm odynam ical grand potential through perturbative skeleton diagram expansions.<sup>27</sup> Later, it was shown that this functional is very useful in constructing conserving and consistent approxim ations for correlated m any-body system s.<sup>28,29</sup> The derivation of the VCA crucially depends on the following properties of the Luttinger-W and functional.<sup>24</sup> (i) The self-energy as a functional of the full G reen's function is

given by the functional derivation of [G],

(ii) W hen evaluated at the physical value of the G reen's functions, [G] is related to the equilibrium grand potential through the relation,<sup>30</sup>

(iii) [G] depends only on the interaction part of the H am iltonian, and does not contain explicit dependence on the hopping term. In the derivation of the VCA, (i) and (ii) guarantee that the grand potential as a functional of the self-energy [] can be constructed by Legendre transform ation. This functional is stationary at the physical values of the self-energy . (iii) guarantees that any reference system sharing the same interacting part of the original H will have the same form of the functional

[G], and hence the same form of the functional [] (although their actual values depend on the hopping part and m ay well be di erent). The VCA is constructed by identifying the stationary point of [] in a self-energy function space limited by the reference system s as the approximate solution of . One of the merits of the VCA is that by using a reference system with small decoupled clusters and limiting the number of variational parameters, therm odynamically consistent and system atic physical results for a correlated electron system can be obtained with much less numerical e  $\operatorname{ort}^{24,31,32}^{24,31,32}$ 

One open question is, in the spirit of the VCA, how one can take into account the nonlocal interaction term beyond the Hartree approximation. In the VCA, it is possible to include longer-and longer-range nonlocal interactions by increasing the size of the cluster. However, for interactions beyond the cluster size, employing the Hartree approximation amounts to de ning a reference system with a di erent nonlocal interaction from the original Ham iltonian, and hence with di erent functional []. Thus the condition for establishing the VCA is not ful lled exactly and further approxim ation beyond the VCA is introduced. In this respect, the EDMFT was devised to incorporate the e ect of the nonlocal interaction. The problem s with EDMFT are that rst, calculations are num erically very dem anding because of the introduction of additional continuous boson ic bath (s) in EDMFT.Usually the quantum Monte Carlo (QMC) technique has to be used to solve the impurity problem, and hence the study is limited to nite tem peratures.<sup>19</sup> Second, the EDMFT is basically a single-impurity approach and can produce only local self-energies. To obtain the k-dependent self-energy, one needs a cluster extension of EDMFT such as the EDMFT+CDMFT schem e proposed by Sun et al.<sup>19</sup> or the extended version of the DCA for including nonlocal interactions.<sup>16</sup> Both of them are very heavy num erical tasks. Therefore, it is desirable to extend the VCA to handle the systems with nonlocal interactions. In the continuous limit, the

EDM FT and EDM FT+CDM FT should be recovered if one takes a single-in purity reference system and cluster reference system, respectively. Hopefully the exibility and e ciency of the VCA will enhance the study of correlated electrons with nonlocal interactions. W ithin the same fram ework, this kind of extended the VCA (EVCA) can be constructed for a system with correlated hoppings. For this system, the EVCA theory in the continuous limit should recover the DM FTCH if one uses a single-im purity reference system, and become a cluster extension of DM FTCH if one uses a cluster reference system.

The purpose of this paper is to present such an extension of the VCA. The original Luttinger-W ard functional is a functional of the full one-particle G reen's function. To extend the VCA, we st express the [G; ] by the generalized grand potential functional [G;]<sup>35</sup> This is accom -Luttinger-W ard functional plished through a Legendre transform ation.<sup>36</sup> Here, besides the one-particle G reen's function G, a certain two particle-G reen's function should be chosen according to the form of the nonlocal interactions. For the construction of [G; ], we use a derivation that is form ally different from that of Chitra et al,<sup>35</sup> but is more suitable for the present purpose. This is embodied, e.g., in that the universality of [G; ] and [G; ] is easily understood from the derivation process. Recently such a nonperturbative construction has appeared for the Luttinger-W ard functional [G] $^{25}_{\bullet}$  In our work a similar construction for the case of multiple variables is carried out.

Starting from (G; ), the generalized self-energy functional<sup>24</sup>  $_{\rm EVCA}$  [;] is obtained by doing another Legendre transform ation with respect to G and . The stationary value of this functional equals the exact grand potential of the original system  $^{37}_{\prime}$  and it is reached at the exact value of the self-energies. In contrast to [] which is only independent of hopping term of the Ham iltonian, the form of EVCA [; ] is independent of not only the hopping term, but also the nonlocal interactions. It is hence possible to evaluate it in a clusterized reference system sharing local interactions with the original Ham iltonian. Finally, the EVCA is obtained by identifying the stationary point in the generalized self-energy space of a reference system as the approximate solution of the original system . This part of our construction is in the same spirit as the VCA  $r^{24}$  although the derivation is form ally di erent.

In this paper, as speci c exam ples, we describe the extension of the VCA for two systems with nonlocal interactions. One is the Hubbard model with nonlocal density-density C oulom b repulsion, the other is the Hubbard model with correlated hopping. In both cases, the Ham iltonians have a nonlocal interaction term that can be treated on the Hartree level within DMFT, and can be partly taken into account within the cluster in CDMFT or DCA m ethods. For the Hubbard model with densitydensity interaction, num erical results are given for the sim plest reference system, in which each decoupled cluster is a single in purity problem with three sites. We will call this scheme three-site EVCA. Its results are found to be quantitatively close to the EDMFT results. Finally, based on the real space form ula of the DCA by Biroliet al,<sup>13</sup> we propose a VCA and EVCA that utilize clusters with periodic boundary conditions. In the continuous limit, this version of the VCA will lead to the DCA instead of the CDMFT, and correspondingly, the EVCA form ula will lead to the extended version of DCA.

The plan of this paper is the following. In Sec. II, we present the construction of the EVCA for the Hubbard model with nonlocal density-density interaction. In Sec. III, the EVCA is constructed for the Hubbard model with correlated hopping. Section IV is devoted to the EVCA formula with translation invariance. We discuss some issues related to the VCA and EVCA in Sec. V.A sum mary is given in Sec. VI.

## II. NONLOCAL DENSITY -DENSITY INTERACTION

In this section, we will rst obtain a grand potential functional [G; ] expressed via the generalized Luttinger-W and functional [G; ]. The grand potential functional  $_{LW}$  [G; ] that bears stationary properties is obtained as a byproduct. The EVCA form ula is established in general form . Num erical calculations are carried out for the three-site EVCA and results are tested.

O ur construction of [G; ] is nonperturbative and does not employ the diagram matic expansion. Essentially, the way that we construct the multiple variable Luttinger-W and functional is the same as that used by B aym<sup>29</sup> for one variable case, but here a Legendre transform ation is employed explicitly. Therefore, our derivation relies neither on the applicability of the W ick's theorem, nor on the convergence of the sum mation of the skeleton diagram s. It only relies on the assumption that the Legendre transform ation, whenever required, can be carried out. This assumption has been argued to be correct for the one-variable case.<sup>26</sup>

Besides interacting one-particle G reen's function, the generalized Luttinger-W and functional is supposed to be also a functional of two-particle G reen's functions. There are various two-particle G reen's functions, such as the density-density G reen's function, spin-spin G reen's function, and the occupation-correlated electron G reen's function, etc. Our way of constructing the generalized Luttinger-W ard functional is general and does not depend on the type of the Green's function. The type of the two-particle G reen's function is determined by the speci c form of the nonlocal interaction in the system. For the Hubbard model with a nonlocal densitydensity interaction, the generalized Luttinger-W ard functional is considered as a functional of the full G reen's function G and the full density-density G reen's function  $i_{j}$  ( <sup>0</sup>) = hT  $n_{j}$  ( ) $n_{j}$  ( <sup>0</sup>) i. For other system s, it is straightforward to incorporate the speci c type of twoparticle G reen's functions as variables of  $% \mathcal{L}^{(n)}$  . The Hubbard model with correlated hopping will be considered in Sec.III.

#### A. Generalized Luttinger-W ard functional

<sup>P</sup> Here, the notations are standard. <sup>P</sup><sub>i;j</sub> indicates the sum of sites i and  $j_p$  independently. is the chem ical potential, and H<sub>loc</sub> = U <sub>i</sub> n<sub>i</sub>"n<sub>i</sub># is the local H ubbard interaction. This model was recently studied using EDMFT.<sup>34</sup> The statistical action for Eq. (3) reads

The grand partition function is expressed through the path integral as

Equation (8) in fact gives out the grand potential as a functional of  $G_0$  and  $_0$ . In the following, we will do the Legendre transform ation on the functional  $[G_0; _0]$ . However, since we have explicitly assigned values to  $G_0$  and  $_0$  in Eqs. (5) and (6), we introduce  $\mathfrak{S}_0$  and  $\mathfrak{S}_0$ 

as variables of the grand potential functional. For the clarity of the derivation, it is useful to distinguish a variational variable and the physical value of it. In the follow ing, we use the symbol with a tilde on top to denote a quantity that can be varied, and the symbol without a tilde to denote the xed physical value of that quantity.

By de nition, e = 0 dependence of the physical value when  $\mathfrak{S}_0 = \mathfrak{G}_0$ and  $e_0 = 0$ . From Eq. (11), it is in portant to observe that the functional form of  $\mathfrak{G}_0$ ;  $e_0$  is determined by the form of  $H_{loc}^0$  as well as the speci c way of introducing  $\mathfrak{G}_0$ and  $e_0$  in Eq. (11). It does not depend on the values of  $\mathfrak{G}_0$  and  $e_0$ .

W e de ne the interacting one-particle G reen's function  ${\mathfrak G}$  and the connected two-particle density-density G reen's function  ${\mathbb G}$  as

Note that  $\mathfrak{S}$  (<sup>0</sup>) is anti-periodic in (<sup>0</sup>) and <sup>e</sup> (<sup>0</sup>) is periodic, with the period . The Fourier transformation of them corresponds to functions of fermionic and bosonic Matsubara frequencies, respectively. With the above de nitions, it is easily seen that

As functionals of  $\mathfrak{G}_0$  and  $\mathfrak{e}_0$ ,  $\mathfrak{G}$  and  $\mathfrak{e}$  will get their respective physical values when  $\mathfrak{G}_0 = \mathfrak{G}_0$  and  $\mathfrak{e}_0 = \mathfrak{g}_0$ . Note that for nonzero  $\mathfrak{G}_0^{-1}$  and  $\mathfrak{e}_0^{-1}$ , even in the case  $H_{loc} = 0$ , the calculation of  $\mathfrak{G}$  and  $\mathfrak{e}$  is a complicated many-particle problem and their values are in general not equal to  $\mathfrak{G}_0$  and  $\mathfrak{e}_0$ .

To do the double Legendre transformation for  $e[\mathfrak{F}_0; e_0]$ , we introduce an intermediate functional  $\mathfrak{F}[\mathfrak{F}; e_0]$ ,

On the right hand of Eqs. (20) and (21), we have explicitly written  $\mathfrak{G}_0$  and  $\mathfrak{e}_0$  as functionals of  $\mathfrak{G}$  and  $\mathfrak{e}$  which are regarded as independent variables. That this can be done is in plied by our original assumption. From Eq. (19), the functional dependence of  $\mathfrak{e}$  on the one- and two-particle G reen's functions is obtained as

The next step to construct a generalized Luttinger-W and functional is to introduce the one-particle self-energy e and the quantity e. In the following, we will de ne them as

Here, the inverse should be considered as the matrix inverse in the space, time, and spin coordinates. In the de nition of<sup>e</sup>, we introduce a real parameter . Physically, the bosonlike nature of the operator  $n_i$  may advocate the value = 1=2, and it was actually taken by m any authors.<sup>33</sup> However, since  $n_i$  () is not a strict real boson eld, the value of cannot be determined to be 1=2 from rst principle. We will discuss this issue further in Sec. V B.C om bined with Eqs. (20) and (21), the above de nitions lead to the following equations:

W ith Eqs. (23) (26), we are now ready to introduce  ${}^{e}({}^{e}; {}^{e})$ , which is a generalization of the original Luttinger-W ard functional  ${}^{e}({}^{e})$ . It is de ned as

There are several in portant properties of this functional, parallel to the properties of the original Luttinger-W and functional [G]. This is easily obtained from Eqs. (25) (27). <sup>e</sup> and <sup>e</sup> acquire the physical values and if they are evaluated at physical G reen's functions fG; g. Here, the physical meaning of  $= {}_{0}{}^{1} + {}^{1}$  is somewhat obscure. In analogy to the one-particle self-energy, it can be regarded as an elective density cumulant that plays the role of the self-energy for two-particle G reen's functions.<sup>38</sup> (ii) The grand potential functional can be expressed by <sup>e</sup> as

Here,  $\mathfrak{S}_0^{-1}$  and  $\mathfrak{e}_0^{-1}$  are both considered as functionals of & and e. Eq. (30) is obtained by combining Eqs. (22) and (27). Unlike the original Luttinger-W ard functional [G],  $e (\mathcal{G}; e)$  is nonzero in the case of  $H_{loc} = 0$ . Therefore the explicit expression of e (\$; e] in this lim it is still a nontrivialm any-body problem . (iii) The form of the functional e (; e] is determ ined only by the form of H  $_{loc}$  once the type of the two-particle G reen's function eis chosen. This is easily understood as a consequence of our derivation process. As stated above, the functional dependence of  ${}^{e}$   $[{}^{e}_{0}; {}^{e}_{0}]$  on  $f {}^{e}_{0}^{-1}; {}^{e}_{0}^{-1}$  g  $\mathbb{E}$  qs. (9) (11)] is determ ined only by the form of H  $_{\rm loc}$  as well as by the speci c form of Eq. (11) in which  $\mathfrak{G}_0^{-1}$  and  $\mathfrak{e}_0^{-1}$  are introduced. This is also true for the functional derivatives of e  $[\mathcal{G}_0; \mathcal{C}_0], \mathcal{G}$  and  $\mathcal{C}$ , and their inverse functionals. Following Eq. (19),  $\mathbb{P}[\mathcal{P}; e]$ , the Legendre transform ation of  $e[\mathfrak{F}_0^1; e_0^1]$  also bears the same property. And our conclusion follows Eq. (27) im m ediately.

In the original paper of Luttinger and W ard, a functional expression of e that is stationary at the physical value of  $\mathfrak{G}$  is obtained. It is very in portant for devising various kinds of therm odynam ically consistent approxim ations. Here, the functional form of the grand potential functional that is stationary at the physical value of  $\mathfrak{f}\mathfrak{G}; e^{}\mathfrak{g}$  is obtained from a modi cation on  $\mathfrak{G}\mathfrak{F}; e^{}\mathfrak{g}$  of Eq. (30); namely, in Eq. (30), we replace the  $\mathfrak{S}_0$  and  $\mathfrak{S}_0$  with their respective physical values  $G_0$  and  $_0$  de ned in Eqs. (5) and (6). The above derivation, when reduced to the case of one variable  $\mathfrak{G}$ , will lead to the functional  $_{LW}$  [ $\mathfrak{G}$ ]. It is actually what Luttinger and W and obtained by skeleton diagram expansion, and can be taken as a starting point of constructing consistent approximations. However, for the construction of the EVCA in the following, we will not make use of the form of  $\mathfrak{e}_{LW}$  [ $\mathfrak{G}$ ;  $\mathfrak{e}$ ]. Instead, we take the functional form  $\mathfrak{e}$  ( $\mathfrak{G}$ ;  $\mathfrak{e}$ ] as a further starting point toward EVCA.

#### B. EVCA for density-density interaction

In this section, we continue to derive the EVCA for the Hubbard model with nonlocal density-density interaction (3). The derivation is based on the generalized Luttinger-W and functional  ${}^{e} (\mathcal{G}; {}^{e}]$  obtained in Sec. II A. The grand potention  ${}^{e}$  has been expressed by  ${}^{e}$ . To go further, we follow the original idea of Pottho  ${}^{24}$  and apply a Legendre transform ation to  ${}^{e} (\mathcal{G}; {}^{e}]$ ,

A nother in portant m erit of  $e_{EVCA}$  is that its functional dependence on  $f^e;^e g$  is only determ ined by the form of H <sub>loc</sub>, and it has nothing to do with the concrete values of e and e, or equivalently of  $\mathfrak{E}_0$  and  $e_0$ . This is the consequence of the Legendre transform ation applied to  $e \mathfrak{F};^e$ ] which also has such a property. Combining Eqs. This equation plays a fundam ental role in the construction of EVCA.Based on the same functional for the reference system, we can introduce the EVCA.

To conveniently express the EVCA equations, we st de ne the reference system, apply Eq. (39) to the reference system, and nally introduce the approximation that leads to the EVCA equations. The reference system is composed of identical clusters of original lattice sites, and each site in the cluster may be coupled to a num ber of noninteracting bath sites. Hoppings and nonlocal interactions are allowed only inside each cluster, while the local interaction H  $_{\rm loc}$  on each site is the same as in the original H am iltonian. For clarity, we introduce a subscript c to denote a matrix with zero matrix elem ent between sites on di erent clusters. For an exam ple,  $\mathfrak{G}_{cij} = 0$  if sites i and j belong to di erent clusters. Therefore, we can always write matrix  $\mathfrak{G}_c$  in block diagonal form by num bering the lattice sites in an appropriate order.  $\mathfrak{G}_{c}^{I}$  denotes the submatrix on the Ith cluster. To project out the block diagonal part of a generalm atrix A, we use the symbol  $A_j$ . That is,  $A_{j_j} = A_{ij}$  if i and j belong to same cluster, and  $j_{A} j_{ij} = 0$  otherwise. The submatrix of A on the Ith cluster is denoted by  $A \stackrel{!}{J}$ .

This set of equations apply in the case where the reference system has continuous degrees of freedom, such as a cluster where each site is coupled to continuous baths. It can be regarded as an extensions of the EDMFT toward the cluster algorithm .<sup>19</sup> Note that in this form ula, the clusters of the reference system have open boundary conditions like CDM FT.W e therefore denote this extension as EDM FT + CDM FT. It will generally lead to selfenergies that are not spatially translation invariant. As in CDMFT, the self-energies for the lattice model should be reevaluated from the cluster self-energies obtained from Eq. (55). Di erent schem es of estim ators have been discussed in Ref. 13. When the solutions are con ned to be spatial translation invariant, each cluster becom es identical. In particular, for the reference system composed of one in purity embedded in two baths described by local Weiss  $eld \mathfrak{E}_0^{1}$  and  $e_0^{1}$ , the original EDM FT equations will be recovered. In this case, the right hand of the st two lines of Eq. (55) can be evaluated in momentum space, and the local G reen's functions are written as integrals with free density of states. If the reference system has only nite degrees of freedom, the variation of  $f_c^e; e_c g$  cannot be arbitrary. We can use a nite number of variational parameters and  $\mathfrak{P}$  to specify the Green's functions  $\mathfrak{G}_{0c}^{-1}$  ( $\mathfrak{P}$ ) and  $e_{0c}^{-1}$  ( $\mathfrak{P}$ ), respectively. Equation (58) is only one of the m any possible ways to construct the discrete version of the EVCA equations. In Eqs. (59) (60), the ferm ion and boson contributions are combined through the cross derivation terms  $e_c \notin e = e$  and  $e_c \notin e = e$ . B oth Eqs. (59) and (60) and Eq. (63) are extensions of the VCA  $^{24}$  to include the nonlocal density-density interactions beyond H artree approximation. They recover the continuous version Eq. (55) in the continuous bath lim it. It is noted that Eqs. (59) and (60) are formally exact, while Eq. (63) is not. Equation (63) can be regarded as a further approximation based on Eqs. (59) and (60) to neglect the cross-derivative terms. In our numerical study of the three-site EVCA, how ever, it is found that due to the very large energy scale di erence between ferm ion and boson contributions to the grand potential, in the rst version of EVCA, the cross-derivative terms s will spoil the self-consistent equations and make it dif-

cult to nd the stationary point. The second version, Eqs. (61) (63), works much better. As shown in the next section, it gives out rather satisfactory results for the extended Hubbard model.

In the above theories, it is rather exible to select the reference system according to the nature of the problem at hand. One can select the size and the shape of the cluster,<sup>31,32</sup> the number of discrete bath sites, as well as the de nition of the variational parameters used in the reference system. For comparable complexity of the reference system, it is expected that the lower spatial dimensions the system has, the more e cient it is to use larger size of the cluster instead of to use larger num ber of bath sites. In the VCA study of the Mott-Hubbard transition,<sup>24,39</sup> qualitatively correct results have already been obtained by using a reference system in which each decoupled cluster contains only two sites, one impurity site and one ferm ion bath site. This shows the amazing e ciency of the VCA. It is expected that EVCA m ay share these advantages of the VCA, and becom es a powerful technique for the study of strongly correlated electron systems. Interesting physical problems, such as di erent phases in the extended Hubbard model, the competition between the Kondo and Ruderm an-Kittel-Kasuya-Yosida (RKKY) interaction, etc., may be studied by EVCA using sm all reference systems.

### C. Three-site EVCA: An exam ple

In this subsection, as an example, we present some num erical results for the simplest realization of the EVCA for the extended Hubbard model. Chitra et al. studied the in uence of the nonlocal Coulomb repulsion on the M ott m etal-insulator transition using EDM FT and the projection technique.<sup>34</sup> They found that the longrange Coulom b repulsion will change the second-order M ott transition at zero temperature into a rst-order transition. Here we use the second version of the discrete EVCA, Eqs. (62) and (63), to illustrate the im – plem entation of EVCA, and focus only on the properties of the m etal and the insulator. For sim plicity, we only consider the half-lling and param agnetic phase. M ore detailed studies on the extended H ubbard m odel will be published elsewhere. The H am iltonian that we will study is Eq. (3),




FIG.1: Structure of a three-site unit cell of the reference system H am iltonian (66). Filled dot denotes in purity site, open dot and square denote ferm ion and boson bath site, respectively.

 $G_0^{-1}$  and  $_0^{-1}$  are therefore the same as in Eqs. (5) and (6). We consider a reference system composed of disconnected lattice sites, each of which is coupled with two bath sites: one ferm ionic site and one bosonic site. The unit cell of the reference system is schematically shown in Fig. 1. This is an extension of the two-site DM FT that works well on a qualitative level in the study of the M ott-H ubbard transition.<sup>24</sup>

These densities of states can be realized by nearest-neighbor couplings  $t_{ij}$  and  $V_{ij}$  on the Bethe lattice in the lim it of the coordination number  $z \ ! \ 1$ , with scaling t ! W =2  $^{\prime}$   $\overline{z}$  and V !  $V_0=2$   $\overline{z}$ , respectively. It is noted that within the present formula, the description of the nonlocalC oulom b repulsion  $V_{ij}$  is on  $V_{2}$  brough two quantities  $V_0(\ )=1=N_k (V_k)$  and  $_jV_{0j}=V_{k=0}$ . It is apparent that the description is far from complete. A complete description should take into account di erent contributions from each k component of  $V_{ij}$ , which can be realized partly by using larger a cluster in the reference system .

A nother point is that using the above scaling and in the lim it z ! 1, we get a diverging  $V_{k=\,0}$ . This re ects the fact that our present EVCA formula for density-density interaction is not a well-de ned theory for in nite-dimensionalm odels. The same problem exists for the sym metry-broken EDM FT. How ever, this does not prevent the theory from being a good approximation for

nite-dimensional systems. In our calculation, we simply take  $V_{k=\ 0}$  as an independent parameter for the original system. This parameter can be absorbed into the denition of , and does not play a role in the half-lled case. We simply set  $V_{k=\ 0}$  = 1 in the calculation.

The numerical aspect of implementing the VCA has been studied in detail.<sup>24,39</sup> Here we use a M atsubara frequency formalism, and the calculation is composed of several steps. First, diagonalize the three-site H am iltonian Eq. (66), and calculate the G reen's functions G and through Eqs. (71) (73). Second,  $1=N_{\rm f}$  and  $1=N_{\rm b}$  in Eq. (69) are evaluated. Finally, we search for the point in the space of f;V; ; g where  $1=N_{\rm f}$  is stationary with respect to the ferm ion parameters  $\,$ ,V, and 1=N $_{\rm b}$  with respect to the boson parameters ; . The G reen's functions at such stationary points are our solutions for the three-site EVCA. For the boson operator b, we take N $_{\rm b}<1\,$  optimized orthogonal states as the bases.  $^{41}$  The  $\,$  nal results should converge with respect to N $_{\rm b}.$  For the half-lied system that we consider here, the particle-hole symmetry condition of the reference H am iltonian Eq. (66) is

It is found that with  $N_b = 8$ , the particle-hole symmetry is already satisfied very well, and the results do not change on further increasing  $N_b$ . W ith this  $N_b$  and considering the conservative quantity  $n_*$  and  $n_{\#}$ , the size of the largest matrix to be diagonalized is 48. This enable us to scan the parameter space quite quickly. For the parameter that is un xed within our theory, we take the value = 1=2, same as in other EDM FT studies.<sup>33</sup> The in uence of different selection of will be discussed elsewhere.




FIG.2: The  $_{\rm f}$  and  $_{\rm b}$  in the vicinity of the metallic stationary point at T = 0.01, U = 1.0, and V\_0 = 0.5. They are shifted by their stationary values  $_{\rm f}$  and  $_{\rm b}$ , respectively, and magnied by = 100. V , , and denote the corresponding values at the stationary point.

In the following, we summarize our results for the extended Hubbard model. Since the main purpose is to check the theory, the study is limited to half lling and in the paramagnetic, charge-disordered phase. At low tem – peratures, a critical  $U_c$  value separates the metallic and the Mott insulating phases. The nonlocal C oulom b repulsion  $V_0$  may in uence the  $U_c$  value, and may even change

the nature of the phase transition. For  $V_0$  su ciently large, a charge-ordering phase becomes more stable. The description of such ordered phase needs the symmetry-broken version of EVCA.Our discussion below resides in the metallic and insulating phase separately, and leave the detailed study of the M ott transition and charge-ordering transition for later work.

W = set W = 1:0 as the energy unit. A llthe data show n here are obtained for a tem perature  $T = 0.01 < T_{c}$ , where 0:014 is the critical tem perature of the st-order  $T_{c}$ M ott transition obtained for the two-site VCA. In Fig 2, an example is shown for the stationary point of  $f_f$  and b at U = 1.0 which is on them etalside of the M ott transition. Since we xed = 0, there are three free variational parameters left, , V, and . It is a metallic solution with nite V values. The vertical scales in Fig. 2 (a) and 2 (b) shows that f changes two orders of magnitude larger than b, given similar variation of the parameters. This is a hint of why the rst version of EVCA (58) works not so well in this case and we have to adopt the EVCA Eq. (62). Now we check to what extent the above three-site EVCA solution is close to the EDMFT solution. In the continuous bath lim it, the EVCA Eq. (56) with sem icircular density of states (74) will lead to the following EDMFT relations:




FIG. 3: (a) The density-density G reen's function at the stationary point for T = 0.01, U = 1.0, and  $V_0 = 0.5$ ; (b) the discrepancies between certain quantities, which should be zero in the continuous limit of bath, see text. = 1=2.

W hen the baths have only nite degrees of freedom, the solutions of EVCA Eq. (63) will be di erent from the continuous lim it solutions, and hence Eq. (76) will not be satis ed anym ore. Therefore the discrepancies between the three quantities can be taken as a criterion for the quality of the three-site EVCA solution. In Fig. 3(a), the solution of the G reen's functions  $(i_n)$  at the stationary point for T = 0.01; U = 1.0 is shown. The di erences between  $(V_0^2=4)$  (i<sub>n</sub>) and (i<sub>n</sub>), and that between  $(V_0^2=4)$  (i<sub>n</sub>) and  $(V_0^2=4)Y$  (i<sub>n</sub>) are shown in Fig. 3(b). It is seen that the ful llm ent of Eq. (76) is rather good for the present case, although we have only three variational parameters. The relative discrepancy in the sm all-frequency regime is less than 1% . This shows that the EVCA indeed has the sim ilarm erit of the VCA, i.e., it is very e cient to represent the continuous baths degrees of freedom by a small cluster. For other  $V_0$  values, we observed that with V<sub>0</sub> increasing, the relative discrepancies also increases. Up to the upper boundary  $V_{max}$  of the param eter V<sub>0</sub>, the relative discrepancies are less than 10% .

For xed U and T, the upper boundary  $V_{max}$  is dened as the value of V above which the pole in the integral expression of Y (i  $_n$ ) [second equation of Eqs. (77)] enters the range  $[V_0;V_0]$ . This will lead to a singular peak in Y (i n) and the EDMFT equation (76) no longer has a solution. This problem of EDMFT was observed previously.<sup>19,38</sup> In the EVCA formula, it appears in the second expression of Eq. (69) where the absolute value is used in the argum ent of logarithm . This does not change the stationary point, but can form ally extend the form alism to all regime of  $V_0$ . In the regime  $V_0 > V_{max}$  however, we nd no physical EVCA stationary point, which is consistent with the nonexistence of an EDMFT solution in this regime. This breakdown of the present form alism in the large- $V_0$  regime is related to the instability of the symmetry-unbroken solutions. It is expected that in the regim e  $V_0 > V_{m ax}$ , a sym m etry-broken solution should be stable in the corresponding EVCA equations.<sup>19</sup>




FIG. 4: C on parison of the three quantities related to the electron G reen's function at the stationary point for T = 0.01, U = 1.0, and  $V_0 = 0.5$ .

In Fig. 4, we compare the three quantities for the electrons, W  $^2$ =4Im G (i!<sub>n</sub>), Im (i!<sub>n</sub>), and W  $^2$ =4Im X (i!<sub>n</sub>) at the same stationary point as in Fig. 3. Since there is only one pole !<sub>n</sub> = 0 in the hybridization function (i!<sub>n</sub>), the discrepancies among them enlarge in the small-frequency limit. However, they are fairly small when the frequency is larger than the com - m on crossing point.

In both Fig. 3 and 4, it is interesting to observe that there are certain common crossing points among the three quantities. In each subequation of Eq. (76), the two successive identities are not independent. One im plies the other. Therefore the three quantities com pared in Fig. 3(b) as well as in Fig. 4 always cross at com m on points. There are two frequency values of and one of !, at which the rst and second equation of Eq. (76) are satis ed, respectively. This corresponds to the fact that we have two free parameters; for bosons and one free parameter V for fermions in the three-site unit cell at half lling. Therefore, the EVCA algorithm can also be regarded as a speci c way of xing a num ber of boson and ferm ion M atsubara frequencies on which the EDMFT equation are satis ed exactly. In the limit of in nite degrees of freedom of the reference system, the EDMFT equations are then ful led at all frequencies. This again shows that EDMFT is the continuous lim it of one-in purity EVCA. This observation also provides a possibility of constructing theories parallel to the EVCA. One can conceive certain ways of selecting the M atsubara frequencies at which the EDMFT equation is satis ed exactly. The number of such frequencies represents the degrees of freedom of the reference system and can be increased in a controlled way. However, a unique criterion for the qualities of di erent such approaches is still lacking.




FIG.5: (a) D ouble occupancy as a function of  $V_0$  for T = 0.01, U = 1.0. The vertical dashed line marks out the boundary  $V_{m ax}$  0:72, above which the symmetry-unbroken three-site EVCA solution doesnot exist. (b) The density-density G reen's function (i  $_n$ ) for several  $V_0$  values. From top to bottom,  $V_0 = 0.7$ ; 0:5; 0:3, and 0:0.

For T = 0.01 and U = 1.0, the metallic symmetryunbroken solution of EVCA persists up to Vm ax 0:72. W ith increasing interaction strength Vo, the density-(i<sub>n</sub>) increases uniform ly on density G reen's function all energy regime, as illustrated in Fig. 5(b). This shows that the charge uctuations in the metallic phase are enhanced by the nonlocal interactions. At half lling, the totalweight of  $(i_n)$  is given by hni hni<sup>2</sup> + 2D = 2 D, where D =  $hn_n_{\#}i$  is the double occupancy. In Fig. 5(a), we show the double occupancy D as a function of  $V_0$  for U = 1.0 and T = 0.01. It is an increasing function up to V<sub>m ax</sub> where the symmetry-unbroken solution disappears. Physically, the enhancement of the charge uctuations is related to the dynam ical screening of the local repulsion by the nonlocal interactions. This e ect has been observed in previous EDMFT studies of the extended H ubbard m  $odel_{r}^{19}$  and m ay have qualitative in uence on the metal-insulator phase transition.<sup>34</sup>

In the insulating phase, the charge uctuations are suppressed to very much extent, and the e ect of nonlocal interaction is almost negligible at low temperatures. Our calculation at T = 0.01; U = 3.2 gives a stationary point V = 0.04, = 1.1, and = 0.012. The double

occupancy at this stationary point is D = 3.6  $10^4$ . It is expected that the nite V here is due to the nite tem perature that we use. At exactly zero tem perature, the two-site VCA gives zero double occupancy and vanishing (i<sub>n</sub>). This will lead to vanishing of the W eiss eld  $_0^1$  according to the EVCA equations Eq. (76). Therefore, we expect that for the three-site EVCA, the

nite V<sub>0</sub> does not play a role in the zero-tem perature insulating phase, and the results are the same as in the pure Hubbard model. Of course, this is an artifact of the three-site EVCA. It is known that for the Hubbard model, the double occupancy D is nite even in the insulating solution at zero tem perature. More detailed study on the e ect of nonlocal interaction on the metallic and insulating phases and M ott metal-insulator transition is to be carried out system atically in the EVCA approach.

#### III. CORRELATED HOPPING

In this section, we construct EVCA for the Hubbard model with correlated hopping. The correlated hopping term is expected to play an important role in the phenom enon of itinerant ferrom agnetism  $^{42}$  W e consider the following H am iltonian,  $^{21}$

the DMFTCH has already been developed,  $^{20,21}$  where the lattice m odel ism apped into one in purity embedded into several baths. Each bath is coupled to a di erent com – ponent of the impurity degrees of freedom. The EVCA form ula to be established in the following is an extension of DMFTCH to larger cluster size as well as to discrete bath degrees of freedom.

## A. Generalized Luttinger-W ard functional

Similar to the construction for the nonlocal densitydensity interaction in Sec. II, we rst generalize the Luttinger-W ard functional for the Hubbard model with correlated hopping in this subsection. For convenience, we de ne the projected creation and annihilation operator as

It is noted that sim ilar with the de nition of fG; g in Sec.II,  $\mathfrak{S}_0$  is not the value of  $\mathfrak{S}$  at H  $_{\rm loc} = 0$ . This is because in the action Eq. For the next step, a Legendre transform ation is applied to  ${}^{e} (\mathfrak{F}_{0})$  in a similar way as in the previous section. We introduce an interm ediate functional  $\mathbb{P}$ ,

Here the cluster index I is dropped. This set of equations has the same form as the VCA equation for the pure Hubbard model, but with di erent de nitions of  $\mathfrak{G}_c$ . Here  $\mathfrak{G}_c$  is the two-particle G reen's function instead of the usual one-particle G reen's function. In the case of one-in purity reference system, Eq. (106) reduces to the equation of DM FTCH proposed by Shvaika,<sup>21</sup> which is proved to be exact in in nite spatial dimension<sup>20</sup> In this sense, Eq. (106) is a generalization of DM FTCH to cluster reference system. For the reference system with discrete degrees of freedom, Eq. (105) produces for each cluster index I,

This discrete version of EVCA equation allows for more exible and e cient selection of the reference system. It is actually a more general form, since in the continuous limit, the continuous EVCA equation Eq. (106) is recovered.

## IV. TRANSLATION -IN VARIANT VCA AND EVCA

In this section, we put forward the VCA and EVCA equations that are based on a cluster reference system with periodic boundary conditions. W hen using a reference system with continuous degrees of freedom, the VCA will recover the DCA of Jarrellet al., and the EVCA will become an extension of the DCA including nonlocal interactions.

The DCA and CDMFT are developed independently to extend the original single-in purity DMFT form alism tο nite clusters. The CDMFT is designed on clusters with open boundary conditions, while the DCA adopts periodic boundary conditions for the cluster. Both formalism s recover the DMFT in the one-impurity case, and become exact in the lim it of large cluster size. However, with increasing cluster size, the two methods have apparently di erent convergence properties. Recently, detailed com parisons between the perform ance of DCA and CDMFT have been m ade.<sup>13,43</sup> It was pointed out that the real-space formula of DCA can be obtained by replacing the bare electron dispersion (k) in the CDMFT equations with a di erent one  $^{cyc}$  (K; K<sub>c</sub>). This means that the formula of CDMFT can be changed into that of DCA by simply replacing the bare G  $^{1}_{0CDMFT}$  in that theory with the corresponding  $G_{0D CA}^{1}$ , and vice versa.

The VCA (Ref. 24) and our construction of EVCA in Secs. II and III all make use of clusters with open boundary conditions. They can recover the CDM FT and EDMFT (or DMFTCH), respectively, in the case of continuous bath degrees of freedom . However, since these theories give out self-energies which are not translation invariant, som e kind of estim ator should be used to calculate the lattice self-energies from the cluster ones. Here, we construct a di erent version of VCA such that it has a m om entum -space representation sim ilar to DCA. In the continuous lim it, it recovers the form alism of DCA.Sim ilarly, the EVCA form a lism developed in previous sections can also be adapted to using periodic boundary conditions for the clusters of the reference system . In the continuous lim it, it leads to an extension of DCA form ula to treat nonlocal interactions (or correlated hopping).

Our discussion in the following is for a D-dimensional hypercubic lattice. Other lattice structure can be discussed sim ilarly. The num ber of sites and site interval for the ith dimension are denoted as N<sub>i</sub> and  $a_i$ , respectively. W e divide the whole lattice into geom etrically identical clusters of size (L<sub>1</sub>a<sub>1</sub>;L<sub>2</sub>a<sub>2</sub>;:::;L<sub>D</sub> a<sub>D</sub>). The number of total clusters is N =L =  $\begin{array}{c} Q & D \\ D & D \\ \vdots = 1 & N & i = L \end{array}$ . The site vector of a cluster is denoted as  $l = (l_1 a_1; l_2 a_2; \dots; l_p a_p)$ , with  $l_i =$ 0; ...;L<sub>i</sub> 1. W e de ne the super-lattice site vector as r =  $(r_1L_1a_1;r_2L_2a_2;...;r_DL_Da_D)$ , with  $r_i = 0;...;N_i=L_i$  1. Any lattice vector  $n = (n_1 a_1; n_2 a_2; :::; n_D a_D)$  with  $n_i =$ 0;1;:::;N<sub>i</sub> 1 is uniquely expressed as the sum m ation of a super lattice site vector and a cluster site vector, n = 1+ r. In the rst Brillouin zone of the three lattices, the original lattice, the cluster lattice, and the super lattice, their corresponding inverse vectors are denoted as k, K<sub>c</sub>, and K, respectively. Here, we consider translation-invariant  $t_{n_1n_2}$  and assume that it has a periodic boundary condition on the D-dimensional lattice. A loo, only translation-invariant solutions of  $\mathfrak{S}_c$  and  $\mathfrak{e}_c$  are considered. For lattice symmetry-broken solutions, one should take care of the sublattice indices. The VCA equation is formally the same as the EVCA equation Eq. (106) for the correlated hopping,

DCA can produce a translation-invariant cluster selfenergy, which can be directly identi ed as the lattice self-energy, in contrast to CDM FT.

This can be easily veried since the Fourier transform ation to Eq. (122) over the superlattice site vector will lead to the real-space form ulation of DCA. Comparison of Eq. (111) and Eq. (122) show sthat DCA and CDM FT can be described by a unied equation with dierent bare electron dispersion. One is (k) for CDM FT; the other is <sup>cyc</sup> (K;K<sub>c</sub>) for DCA. The corresponding bare G reen's function entering the theory is G<sub>0</sub> and G<sub>0D CA</sub>, respectively. Because (k = K<sub>c</sub>) = <sup>cyc</sup> (K;K<sub>c</sub>), when cluster size L increases, the number of K<sub>c</sub> points increases. <sup>cyc</sup> (K;K<sub>c</sub>) will tend to (k) uniform ly in the k space. This shows the equivalence of CDM FT and DCA in the large-cluster lim it.

The merit of the real-space form ula of DCA is that it not only has a translation invariant form as in the k-space form ula, but also allows for the study of the phases with reduced translation invariance or system without translation invariance, such as an antiferrom agnetic phase or disordered system. With the above discussion, it is straightforward to put down the VCA equations for a general reference system while still keeping a translation invariant form. This is done sim ply by using G  $^1_{\rm OD CA}$  in the originalVCA equations. We get

This is the DCA equation adapted for discrete reference system. In the continuous bath limit, it recovers the original DCA equation.<sup>16</sup> DCA has already been im – plemented with various cluster solvers.<sup>23,43,49</sup> W ith Eq. (124), it is now possible to study the discrete version of DCA on reference systems with smaller cluster H ilbert space using numerical methods such as exact diagonalization. And the exibility and e ciency of the VCA is thus combined with the merit of translation-invariant self-energy of DCA.

For the EVCA, a translation invariant form can also be obtained along the same line. For the case of the density-density interaction, we use the modil ed hopping matrix  $t_{n_1n_2}^{cyc}$  Eq. (120), and de ne the interacting parameters V  $^{cyc}$  as

Similarly, the EVCA for correlated hopping can also be implemented in a translation invariant way. We simply replace the bare G reen's function in Eq. (107) with the DCA version, and the obtained EVCA equation reads

#### V. DISCUSSION

In this section, several issues about EVCA are discussed. We rst discuss the EVCA equations for the ordered phase. Then, the EVCA is constructed after carrying out a Hubbard-Stratonovich transform ation on the original system. Com parison with previous EVCA equations shows that the Hubbard-Stratonovich transform ation plays a nontrivial role here. U sing the sam em ethod, the EVCA for the Heisenberg model, a correlated spin system is obtained straightforwardly. The problem swith EVCA for bosonic systems are discussed. Finally, we point out that our construction applies equally well to classical models, such as the Ising model.

#### A. EVCA for ordered phase

W hen the system is in the ordered phase induced by the corresponding nonlocal interactions, the implementation of EVCA need to be modi ed according to broken symmetry. This issue has been discussed thouroughly in the context of EDM FT.<sup>19,35,38</sup> Here, a sim ilar strategy can be taken to handle the ordered phase in EVCA. EVCA equations developed in Secs. II and III, such as Eqs. (59), (60), and (63), are still valid. The Hartree contribution should be singled out by using the norm al ordered operator in the original Ham iltonian. How ever, care should be taken when we write down the reference Ham iltonian and evaluate the trace term s in those equations. In the case of a bipartite charge-ordered phase, for example, the W eiss elds appearing in the action of the reference system should obey the two-sublattice sym metry of the ordered phase. The trace terms in Eqs. (59), (60), and (63) should also be evaluated on the two sublattices. These will lead to di erent nal expressions for the EVCA functional and EVCA equations from the sym m etry-unbroken case. D etailed expression w illbe discussed elsewhere in combination with model studies.

# B. The role of H ubbard-Stratonovich transform ation

Up to now, the EVCA equations discussed in this paper are constructed directly for the original electron Ham iltonian. One can also rst carry out a Hubbard-Stratonovich (HS) transformation on the nonlocal interaction terms in the Ham iltonian, and construct the EVCA equations for the resulting e ective electronphonon Ham iltonian. This latter approach is widely used in EDM FT studies since it facilitates the em ployment of the M onte C arb algorithm. It has been claimed that the two approaches are equivalent to each other.<sup>19</sup> Here taking the extended Hubbard m odel Eq. (3) as an example, we study the role of HS transformation. It is found that in general the two approaches are nonequivalent. For Ham iltonian (3), the direct construction starts from the action (11),

where  $G_0^{1}$  and  $_0^{1}$  are given by Eqs. (5) and (6), respectively.

At this stage, one could apply the HS transform ation to Eq. (131) to introduce phonon elds. This is not a change to the EVCA equations but a possible way to solve the reference system. However, there is another essentially di erent approach to construct EVCA itself. O ne can apply the HS transform ation to the original electron action Eq. (4), obtain an equivalent electronphonon action, and construct the EVCA for the nonlocal phonon-phonon interaction term. In this approach, after the Hartree contribution to the phonon term is singled out, we introduce the source elds for the electron and phonon operators as before, and obtain the action

The actions  $S_A$  and  $S_B$  are equivalent in the sense that for  $\mathfrak{G}_{0c}^{-1} = 1 = 4^{e_{0c}}$ , they give the same therm odynam ical average values for the same operator.  $\mathfrak{G}$  is de ned as in Eq. (13). We de net the density-density G reen's function, phonon G reen's function, and phonon self-energy as

It is seen that the two set of equations Eqs. (131) (133) and Eqs. (134) (139) are similar, but the operators appearing in the corresponding reference actions  $n_i$  and ihave dimensional events. Besides Eq. (136), the only direct connection between the two sets of equations occurs when  $\mathfrak{G}_{0c}^{-1} = 1 = 4^{\mathsf{e}}_{0c}$  is satisfied in the self-consistent calculations. However, even at this special point where the two actions are equivalent, the two set of EVCA equations are dimensional events. In such case, considering  $\mathbf{e}_{\mathsf{B}} = \mathbf{e}$ and Eqs. (136) (138), we reexpress the phonon equation  $\mathfrak{G}_{\mathsf{C}} = -\mathbf{j}(Q_0^{-1} - \mathbf{f}_{\mathsf{C}}^{-1})^{-1}$  jby the density-density G reen's function  $\mathbf{e}$  defined by  $\mathfrak{S}_{\mathsf{A}}$  as

This equation is di erent from the corresponding one in Eq. (133). In general,  $\mathcal{G}_{0c}^{1} = 1 = 4^{e}_{0c}$  is not guaranteed in the EVCA self-consistent calculations, and we have even less connection between the two approaches. Therefore our conclusion is that in general there is no reason for the two set of EVCA equations to give out the same results. This is true also for discrete EVCA form alism or for EDM FT, the single-im purity lim it of the continuous EVCA. We should therefore take into account this di erence when we com pare the results from di erent EDM FT or EVCA calculations.

It is noted that in the HS transformation approach, besides the electron eld we deal with real phonon elds. This seems to provide a justication of the selection of = 1=2 since it leads to the exact solution  $\mathfrak{G} = 1=2\mathfrak{G}_0$ ,  $\mathfrak{G} = \mathfrak{G}_0$  in the lim it of the nonelectron-phonon interaction and U = 0. However, since the electron-phonon interaction is a xed nite value in the reference system, this lim it is actually not reachable in the EVCA calculations. A clear criterion for the selection of the value is therefore still lacking in the present theory.

## C . EVCA for correlated spin system s and boson system s

O ur constructions of EVCA in Secs. II and III have the interesting advantage of universality. It is free to introduce di erent source elds for each pair of nonlocally coupled operators, no matter it is a pair of oneparticle operators such as  $c_i$  (for the usual VCA), or a many-particle one such as  $n_i$  (for density-density interaction) or  $c_i n_i^-$  (for correlated hopping). Once the source

elds are introduced for these operators, the subsequent derivation procedures are the same, and similar EVCA equations are obtained. Except in the de nitions of the G reen's functions, the nature of the nonlocally coupled operators does not play a role in the derivation. Therefore, it is rather straightforward to apply these derivations to system s other than correlated ferm ions. At the same time, the Luttinger-W ard functional that is most frequently utilized in correlated ferm ion system s, can now be generalized for correlated spin system s and boson systems. This also holds for the EDMFT. For example, the EDMFT equations for the K ondo lattice m odel with RKKY interactions can reduce to that for the Heisenberg model by simply discarding the electron degrees of freedom. As shown in the following, the EDMFT for Heisenberg model will be recovered by our EVCA in the continuous bath lim it. We also discuss the EVCA for correlated boson system s.

W e start from the H eisenberg m odel

Here, = x;y;z are the spin components. = 1=2 is usually used. The latter equation is regarded as the matrix equation in the lattice, time, and spin space. The same procedure as in Sec. II will lead to the following form of the free energy functional:

Here, the trace is carried out in the lattice coordinate, time, and spin space.  $\mathbb{P}_{LW}$  is stationary at the physical value of the Green's function, and up to a constant, its value at the stationary point is the physical value of the free energy. The derivative of the generalized Luttinger-W and functional [<sup>e</sup>] with respect to <sup>e</sup> gives the selfenergy. The free-energy functional necessary for the construction of EVCA equation reads

 ${\tt W}\,$  ith this equation, it is possible to study the H eisenberg m odel with discrete reference system s.

The EDMFT has been used to study the coupled ferm ion-boson system  $^{44}$  where the bosons are phonons. Recently the correlated boson systems is studied intensively in the context of cold boson atoms in the optical lattice. The bosonic Hubbard model<sup>45</sup> is one of the sim plest models to describe the boson atom s which have particle number conservation.

where H  $_{\rm loc} = U \begin{bmatrix} P \\ i (a_i^y a_i & 1) a_i^y a_i \text{ describes the local repulsion between bosons. The idealEVCA for this model should be able to describe both the Bose-E instein consensation phase and the M ott insulator phase. For this problem , it is in portant to know that what kind of W eiss$ 

elds are necessary for the description of the physics. From the usual splitting of the boson eld into sum of condensate wave function and the quasiparticle eld, it is plausible that besides the norm alboson G reen's function, the new W eiss elds should include the condensate

elds as well as the anom abus G reen's functions.<sup>46</sup> T he corresponding self-energy functional and EVCA equation can be derived in a similar way as for ferm ions. D etailed work in this direction is in progress. It would be interesting to explore the EVCA for correlated bosons and m ake com parison with the results from other approaches.

## ${\tt D}$ . ${\tt EVCA}$ for classical system s

In this part, we derive the EVCA equations for a classical system, the ferrom agnetic Ising m odel. The purpose is to show that EVCA applied on larger clusters m ay be used as a useful tool for the study of classical systems. Here we consider the classical Ising m odel

 $S_i^z$  is the z component of spin 1=2. The summation is over pairs, and we assume  $J_{ij} > 0$ . Because all the operators present in this model commute with each other, there is no quantum uctuations in this model. In this case, instead of introducing a time-dependent source eld as for the Heisenberg model, it is su cient to introduce static ones  $\begin{bmatrix} e & 1 \\ oc \end{bmatrix}_i$ . Taking into account of the possible symmetry-broken phase, the reference system with an open cluster boundary condition has the action

and the partition function

Following the same procedure as before, we get the following EVCA equations:

Equations (154)-(156) form a closed set of self-consistent equations for the Ising model. The W eiss elds are real variables.

For the sim plest case of the one-site cluster, we obtain the following self-consistent equations:

This set of equations is di erent from the usual W eiss mean-eld equations. It has been obtained (with di erent parameter de nitions) by Pankov et al. in a sem iclassical analysis of EDM FT.<sup>47</sup> It was found that this mean-eld theory predicts a better phase transition tem - perature than the W eiss mean-eld theory. How ever, the

order of the transition is given incorrectly. Instead of a second-order transition, this one-site theory gives a rstorder phase transition for dimensions d < 4. It is expected that the approximation will be improved by using a larger cluster size. However, it is still an open question whether the correct order of the phase transition can be obtained in EVCA with larger clusters.

## VI. SUMMARY

In this paper, we extend the VCA to include the nonlocalinteractions. A universalway of constructing this theory is described for di erent system s, i.e., the Hubbard model with density-density interaction, the Hubbard model with correlated hopping, the Heisenberg model, and the Ising m odel. The construction m ethod proposed here is universal, and may deserve further consideration in the context of the general variational principle.<sup>48</sup> Taking the extended Hubbard modelas an example, we show that the sim plest three-site EVCA can already produce results very close to those of the EDM FT. The latter can only be realized in the lim it of a continuous reference system . A number of existing theories are obtained as lim iting cases of EVCA.W e arrive at a cluster extension of EDMFT for a system with nonlocal interactions, and arrive at a cluster extension of the DM FTCH for system s with correlated hopping. VCA (EVCA) equations which are based on clusters with periodic boundary conditions are also proposed. This produces translation-invariant solutions and has the DCA (DCA extended to include nonlocal interaction) as the continuous lim it. The high e ciency and exibility of the EVCA makes it possible to study a large class of correlated system swith less num erical cost by adopting a relatively simple reference system . Som e interesting issues about EVCA are discussed.
