New asymptotic behaviour of the surface-atom force out of therm al equilibrium

The Casim in-Polder-Lifshitz force felt by an atom near the surface of a substrate is calculated out of therm al equilibrium in terms of the dielectric function of the material and of the atom ic polarizability. The new force decays like $1=z^3$ at large distances (i.e. slower than at equilibrium), exhibits a sizable tem perature dependence and is attractive or repulsive depending on whether the tem perature of the substrate is higher or smaller than the one of the environm ent. Our predictions can be relevant for experiments with ultracold atom ic gases. Both dielectric and metal substrates are considered.

An intense e ort has been devoted in the recent years to study the force felt by an atom near the surface of a substrate (see, for example, [1,2] and references therein). These studies are motivated both by the possibility of technological applications [3] as well as by the fundamental search for stronger constraints on hypothetical non New tonian forces [4]. Experimental and theoretical research has also recently focused on the forces acting on ultracold atom ic gases, including atom ic beam s [5, 6, 7], Bose-E instein condensates [2, 8, 9, 10] and degenerate Ferm i gases [11].

The force generated by the surface contains in general two independent components. The rst one is related to zero-point uctuations of the electrom agnetic eld. At short distances z (typically less than fractions of microns) this force behaves like $1=z^4$ and is the analog of the van der W aals-London interatom ic force. At larger distances the inclusion of relativistic retardation e ects gives rise to a di erent $1=z^5$ dependence characterizing the so-called C asim in-Polder regime [12, 13, 14]. Notice that both the van der W aals-London and C asim in-Polder forces depend on the tem perature only through the dielectric properties of the substrate. The resulting tem perature dependence is usually negligible.

The second component of the force is due to the thermal uctuations of the electrom agnetic eld. This e ect was rst considered by Lifshitz [15] who employed the theory of electrom agnetic uctuations developed by Rytov [16]. We will refer to it as to the Lifshitz force. At distances larger than the therm al photon wave length $T = \sim c = k_B T$ (corresponding to 7:6 m at room tem perature) this force decays, at therm al equilibrium, like $1=z^4$, is attractive, is proportional to the tem perature and provides the leading contribution to the total force. C onversely, the zero-point uctuation component prevails at sm aller distances. In the present paper we are interested in the therm alcom ponent of the force. The Lifshitz force was originally evaluated at full therm odynam ic equilibrium . A non trivial issue is the study of the force out

of them alequilibrium [17, 18], characterizing con gurations where the tem perature of the substrate and the one of the surrounding walls located at large distances (hereafter called environm ent tem perature) do not coincide. The problem is relevant both for practical reasons, due to the possibility of tuning the two tem peratures independently, and for a better understanding of the interplay between zero-point and therm al uctuation e ects. Α rst important investigation of the surface-atom force out of therm al equilibrium was carried out by Henkelet al. [17] who calculated the force generated by a dielectric substrate at nite tem perature by assuming that the environm ent tem perature is zero. The principalm otivation of that paper was the study of the force at short distances. In this Letter we show that, out of therm al equilibrium, the force acting on the atom exhibits a new asymptotic behaviour, characterized by a $1=z^3$ decay at large distances.

Let us consider an atom placed in vacuum at distance z from the at surface of a substrate m ade of a m aterial with dielectric function "(!) = " $^{0}(!)$ + i" $^{0}(!)$. We choose a coordinate system with the xy plane coinciding with the interface and the z axis such that the substrate occupies the region with z < 0 and the vacuum the region with z > 0. In this Letter we assume that the substrate is locally at therm al equilibrium at a temperature $T_{\rm S}$ which can di er from the environment temperature $\mathbb{T}_{\!\!E}$, the global system being out of therm al equilibrium, but in a stationary regime. The total electrom agnetic eld will be in general the sum of the radiation produced by the substrate and the one of the environm ent. In particular this latter radiation will be partially absorbed and re ected from the substrate. The forces produced by the T_E and T_S components of the radiation add incoherently. In typical experiments with ultracold atom ic gases the environm ent tem perature is determ ined by the chamber containing the substrate and the trapped atom s. W e further treat the atom s as being at zero tem perature in the sense that the surrounding radiation is not able to popu-

late their excited states which are assumed to be located at energies \sim !_{at} much higher than the therm alenergy:

This condition is very well satis ed at ordinary tem peratures. A ctually the rst optical resonance of R b atom s corresponds to $1.8 \ 10^4$ K In general the force acting on a neutral atom can be written as [17, 19]

holding in lowest order perturbation theory with i = x;y;z. Here and in the following we use Einstein's sum - mation convention. The rst term describes the eld

uctuations correlated with the induced atom ic dipole moment while the second ones involves the dipole uctuations correlated with the induced electric eld. At therm al equilibrium, where $T_{\rm S}$ = $T_{\rm E}$ $\,$ T, the force can be conveniently written in the form

where we have separated the contribution $F_0(z)$ arising from the T = 0 zero-point uctuations and the one arising from the therm al uctuations. At large distances the T = 0 force exhibits the C asim in-P older asymptotic behaviour

with the function $("_0)$ de ned, for example, in [2]. Conversely, the therm all force approaches the Lifshitz law

which then provides the leading contribution to the total force. The asymptotic law (5) is reached at distances larger than the therm all wavelength $_{\rm T}$. In the above equations $_0 \equivalent = 47.3 \quad 10^{24} \mbox{ cm}^3$ for Rb atom s) and $"_0$ are, respectively, the static polarizability of the atom and the static dielectric function of the substrate. It is worth noticing that only the static optical properties enter the asymptotic laws (4) and (5), the corresponding dynamic e ects becoming in portant only at shorter distances. It is also worth noticing that the asymptotic behaviour of the therm al force has a classical nature, being independent of the P lanck constant. The explicit behaviour of the force (3) at all distances has been recently investigated in [2].

Let us now discuss the behaviour of the force when the system is not in equilibrium (neq). Also in this case the force can be written as the sum of the zero temperature contribution $F_0(z)$ and of a therm al contribution which, how ever, will di er from F_{th}^{eq} if $T_s \notin T_E$:

The purpose of the present Letter is to calculate the force (6) and in particular to exploit its behaviour at large

distances. Let us rst consider the case of a substrate at nite temperature ($T_{\rm S} = T \in 0$) in the absence of the environment radiation ($T_{\rm E} = 0$). This problem was solved by Henkelet al. [17] who obtained the result

for the therm alcontribution to the force originating from the uctuations of the eld (). In eq.(7) ${\bf G}_{\!\!R}$ is the G reen function relative to the electrom agnetic eld. The variable r_1 should be integrated on the volum e V_S occupied by the substrate which provides the source of the therm al radiation. The argument r instead de nes the position of the atom outside the substrate. The G reen function G $_{\rm ik}$ then reduces to its transmitted component [20].

The force (7) contains a repulsive coordinate independentwind part (arising from the transmitted propagating modes) proportional to $^{00}(!)$ and produced by the absorption of photons by the atom , and a dispersive part (arising from the transmitted evanescent modes) proportional to 0(!). Due to the condition (1) the wind contribution can be ignored and the real part $^{0}(!)$ can be replaced with its static (! = 0) value 0. Furtherm ore also the term s arising from the dipole uctuations can be ignored in the evaluation of the therm al force which can be conveniently rewritten in the form $F_{th}^{neq}(T_S;0;z) = 4_0 (\mathfrak{g}_z U_E (T_E;0;z))$ where $U_E = E^2 = 8$ is the therm alcom ponent of the electric energy density in vacuum . The dispersive component of the force (7) can be explicitly worked out by introducing the Fourier transform g_{ik} [!; K; z_a ; z_b] of the G reen function G_{ik} [!; r_a ; r_b] where K is the component of the electrom agnetic wavevector parallel to the interface. By explicitly expressing the function q_{ik} in terms of the transmitted Fresnel coe cients [20] and using the procedure described in [21] we

nd, after som e lengthy algebra, the important result

where we have introduced the dimensionless variable q = K c=!. Eq. (8) provides the thermal force generated by the substrate in the absence of the environment radiation. In order to discuss the more general case $T_S \notin T_E \notin 0$, we make use of the additivity property of the thermal force which can be written, in general, as the sum of two contributions: $F_{th}^{neq}(T_S; 0;z) + F_{th}^{neq}(0;T_E;z)$, produced, respectively, by




FIG. 1: Surface-atom potential energy V^{neq}(z) = $\sum_{k=1}^{K} dz^{0}F^{neq}(z^{0})$ calculated from eq.(9), for dierent thermalcon gurations.




FIG. 2: Surface-atom force F $^{\rm neq}\left(z\right)$ calculated from eq.(9), for di erent therm al con gurations.

the radiation of the substrate and of the environment. Their additivity can be checked by evaluating separately the two contributions and verifying that their sum, at therm al equilibrium, reproduces the Lifshitz force F_{th}^{eq} [22]. The full surface atom force out of equilibrium can be nally written in the convenient form

where the equilibrium force F $^{\rm eq}$ (T;z) is given by (3) while F $_{\rm th}^{\rm neq}$ (T;0;z) is de ned by eq.(8).

In gs. 1, 2 and 3 we show the explicit results for the potential energy, the force and the gradient of the force obtained starting from eq.(9) as a function of the




FIG.3: Surface-atom gradient of the force $@F^{neq}(z)=@z$ calculated from eq.(9), for di erent therm al con gurations.

distance from the surface for di erent choices of $T_{\!S}$ and T_E. Calculations have been done for a sapphire substrate and for rubidium atom s. For F^{eq} (T;z) we have used the predictions of [2]. The gure clearly shows that the thermale ects out of equilibrium are sizable (solid lines), thereby providing prom ising perspectives for future m easurements of the surface atom force at large distances. In particular in order to increase the attractive nature of the force it is much more convenient to heat the substrate by keeping the environm ent at room tem perature (lower solid line) rather than heating the whole system (dashed line). When $T_S < T_E$ (upper solid line) the force exhibits a characteristic change of sign re ecting a repulsive nature at large distances (see also discussion below). At short distances the therm alcorrection to the force becom es smaller and smaller and is determined by the tem perature of the substrate. We have reported the results for the potential, for the force and for the gradient of the force because the corresponding predictions can be of interest for di erent types of experim ents with ultra cold gases. Experiments based on the study of the center of m ass oscillation of a trapped gas are sensitive to the gradient of the force [2]. The corresponding frequency shifts produced by the surface-atom interaction have been recently measured [10] in conditions of therm al equilibrium in agreement with the predictions of theory [2]. Conversely experiments based on Bloch oscillations are sensitive to the force itself [11, 23]. Finally one can also think at interference experiments with Bose E instein condensates in a double well potential. For large separations between the wells the position of the corresponding interference fringes are sensitive to the potential [24].

In the last part of the letter we discuss the large z behaviour of the out of equilibrium force. In this limit only values q 1 are in portant in the evaluation of the integral (8). By making the substitution $q^2 = 1 = t^2$; and

the t 1 expansion we nd that the force (8) exhibits the non trivial asymptotic behaviour

Notice that the force exhibits a slow er $1=z^3$ decay with respect to the one holding at therm al equilibrium where it decays like $1=z^4$ (see eq. (5)). In the above equation we have introduced the function

which depends on the optical properties of the substrate. For tem peratures m uch sm aller than the energy $\sim !_c = k_B$, where $!_c$ is the lowest characteristic frequency of the dielectric substrate, we can replace f (!) with its low frequency limit (" $_0 + 1$)= " $_0$ 1. The force (9) felt by the atom then approaches the asymptotic behaviour

holding at low tem perature and at distances larger than $_{\rm T} = "_0 - 1$ where $_{\rm T}$ is the therm alphoton wave length calculated at the relevant tem peratures $T_{\rm S}$ and $T_{\rm E}$ [25]. Eq.(12) shows that, at large distances, the new force is attractive or repulsive depending on whether the substrate tem perature is higher or sm aller than the environment one. Furtherm ore it exhibits a stronger tem perature dependence with respect to equilibrium and contains explicitly the P lanck constant. The new dependence of

F^{neq} (T;0;z) on temperature and distance can be physically understood by noticing that the main contribution to the z-th dependent part of the electric energy U_E arises from the black-body radiation in pinging on the surface in a small interval of angles, of order of ($_{\rm T}$ =z)², near the angle of total rejection. This radiation creates slow ly damping evanescent waves in vacuum. As a result F^{neq} (T;0;z) turns out to be, in accordance with eq.(12), of order of ($_{\rm T}^2$ =z³)U_{BB}, where U_{BB} / T⁴ is the energy density of the black-body radiation.

Equation (12) holds for a dielectric substrate where " $_0$ is nite. For a metal, if one uses the D rude model, one has " $^{(0)}(!) = 4 = !$ with the real part " $^{(1)}(!) \frac{\text{remaining}}{"^{(0)}(!)=2} = p \frac{\text{nite as } ! ! 0 \text{ so that one } \text{nds f } (!) ! \frac{\text{mo}(!)=2}{"^{(0)}(!)=2} = a \text{ di erent tem perature dependence}$

where (3=2) 2:61 is the usual Riem ann function.

In conclusion in this Letter we have calculated the surface-atom force out of them al equilibrium and pointed out the occurrence of a new asymptotic behaviour at large distances. Our predictions could be tested in experiments with ultracold atom ic gases trapped close to the surface of a substrate.
