Duality between nodal lines statistic and the Casim ir energy

A bstract

U sing the statistical description comm on to random waves and quantum elds we show how the probability of having a nodal line close to a (translationally symmetric) reference curve is related to the C asim ir energy of an appropriate con guration of conductors.

I. INTRODUCTION

Random waves (RW) have been an object of interest for their statistical properties both in wave mechanics and statistical mechanics. In wave mechanics they turned out to be an incredibly interesting and rich scenario for studying the statistics of topological properties, like phase singularities [1]. In optics they made a good statistical model for speckle patterns [2] in laser beams. In quantum mechanics they have been studied [3, 4] in connection with semiclassical wave functions in chaotic billiards. In statistical mechanics their properties have been put in connection with the statistic of defects and vortices [5] and an interesting duality with a percolation problem has been put forward recently [6].

The purpose of this paper is to exploit in a new direction the description of RW in terms of quantum eld theory (QFT). I will make a quantitative connection between the ground state energy (or Casim ir energy) of a scalar eld in a given con guration of sem i-penetrable conductors in d 1 space dimensions and the probability of having a certain con guration of nodal lines in d dimensions.

This paper is far from being exhaustive or self-contained. I will brie y introduce the concept of random wave referring the reader to the existing literature for their statistical properties, in particular the properties of their nodal lines. I will then rephrase the concept of Casim ir energy for a scalar eld in a static background (a toy model for QED where the static background models the conductors) in a language closer to that of random waves statistics. I will then point out the connection between Casim ir energy in this background and probability of having a certain nodal line con guration. Finally I will draw some consequences on the nodal line probability and comment on the possible extensions on which further work is needed.

II. RANDOM WAVES

An isotropic random wave (RW) in d dimensions is the random function de ned on a subset of R^d (we will not use any particular notation for vectors but there is little room for

confusion) as

where the phases $_{j}$ are uniformly distributed in [0;2] and the vectors k_{j} are random variables as well. We will assume isotropy of , i.e. (k) is an even, analytic function of the length of the vector k.

For any nite J them oments h (x_1) :: (x_n) i are not factorizable, but in the lim it J! 1 W ick theorem holds [1] (among other things one requires the existence and niteness of at least the second moment, i.e. h 2 (x)i < 1):

In the following we will hence always assume the $\lim \pm J ! 1$ is taken.

W ick's theorem is equivalent to saying that the statistical properties of RW can be described by a Gaussian probability functional

where Z is a normalization constant and $h(x^0;x) = h(jx^0 - x)$ for isotropic RW. From this probability functional the reader could already recognize the usual set-up of the statistical mechanics of a non-interacting real eld. The function h is determined by the spectrum (k) (and vice versa). We will now determ their connection.

To this purpose is convenient to pass to the Fourier components of the eld $_k$ = R $\,^{d^d}xe^{ikx}\,$ (x) and de ne h (k) through

In term s of k the probability functional is

The limiting Gaussian probability functional (3) or (5) can describes the statistical properties of (1) if we choose the spectrum (k) as

which means that in the lim it J! 1 the sum over k_j must be substituted by the integral in d^dk whose measure is given by right-hand side of (6). This is the promised connection between h(x) and (k). In this way when J! 1 the propagator G tends to

where we used the fact that is even in k to substitute eikx for cos(kx).

There are at least two hatural choices for the spectrum h (k):

The scalar eld spectrum $1=h(k) = (x_i)=(k+m^2)$ where one has to introduce the cuto to ensure the niteness of $G(x_i,x) = h^2(x_i)$.

The very singular monochrom atic spectrum h(k), such that $1=(2 \text{ h(k)})=(\frac{1}{2} \text{ K})$. This last choice gives G(x;0) = J_0 (K x) which is a statistical model for the solutions of the Schrodinger equation = K² in chaotic billiards.

III. CASIM IR ENERGY AND NODAL LINES

We now turn to the main point of this paper: the connection between nodal lines properties and Casim ir energy. For simplicity at the moment we assume d=2, the generalization to other dwill be straightforward.

Following [4] we introduce the functional

where the integral is de ned over the reference line = fx(s) is [0; ']g and parameterized with the length of the line itself, s. For any given reference curve , X [] is a random variable whose generating function S () is de ned as

It has been shown in [4] that S () can be interpreted approximately as the probability of having a nodal line in the tube of radius $r = (h(r)^2i)^{1-3}$ built around the reference curve (in d dimensions 1=3 gets substitutes by 1=(d+1)). Notice that the radius r of the tube goes to zero when ! 1. The approximation allowing us to interpret S as the probability of having a nodal line relies mainly on a mean-eld approximation where

 2 =(r 2)! 2 =h(r) 2 i as discussed in [4]. It is not easy to estabilish the limits of this approximation so we will adopt it as a working hypothesis and we will see later a situation in which it possibly fails. From now on we will simply say that S is the probability to have a nodal curve 'without referring to the tube radius r or the approximation within which this interpretation has been derived.

Let us write in (9) P [] explicitly inside the probability functional

Let us now specialize the problem in two ways:

Here $e^2 = e^2 = e^2 = e^2$ and E the Casim ir energy in the background V and

We can now establish the promised connection between the generating functional S () and the Casim ir energy E of the corresponding background as

In words: The probability of having a (translationally sym metric) nodal line in a random wave ensemble is related to the Casim ir energy of a conguration of conductors given by a constant-time section of .

The generalization to d dimension is easily obtained (and is already understood in the previous paragraph). Since a nodal hypersurface has codimension 1 so does its constant- x_0 section. Hence the problem maps to the Casim ir energy of codimension 1 surfaces. The dual Casim ir problem then is the usual problem of penetrable, codimension 1 surfaces (see [7] for the case with arbitrary codimension). For example, the d=4 case maps into the R^3 Casim ir problem with penetrable 2-dimensional surfaces. The limit ! 1 is the limit of perfect conductors (or Dirichlet limit, because = 0 on the conducting surfaces).

In the rest of the paper we will use this duality to make statements on the nodal line statistic from the knowledge of the properties of C asim ir energy.

IV. APPLICATIONS

Let us start with a well known problem of a Casim ir energy calculation: the presence of various divergencies, when taking ; ! 1 . We will now discuss the interpretation of these divergencies for the nodal lines probability.

A volume divergence / V $^{d+1}$ (divergent when ! 1) is removed by the factor of 1=Z in our denition of P []. This term is however independent of the presence and shape of . In QFT it would represent a cosmological constant term. For what concerns the divergencies arising when ! 1 (the so-called D irichlet limit) let us recall that the tube radius r built around the reference line , goes to 0 when ! 1 . It is then natural that the probability S () of having a nodal line within a distance r from goes to zero when ! 1 . This re ects in the fact that E ! +1 when ! 1 .

We also know that the interaction energy (the one that depends on the distance between the bodies) remains nite when ; ! 1 . This means that there are some properties of the nodal lines, connected with the interaction part of E, which are well-defined also when the tube radius r! 0 and the cuto goes to in nity. In order to identify them we must define a quantity which stays nite in this limit. Led by the intuition about the Casimir energy of rigid conductors we recognize that this problem is related to the removal of the self-energy for rigid, disconnected bodies. Suppose then our curve—is composed of two disconnected pieces = $_1$ [2 (we always require them to be straight and both parallel in the x_0 direction). Their Casimir energy can be written as

where the rst two terms are independent on the distance between the nodal lines and the last term goes to zero when the distance between the two curves goes to in nity (this can be taken as a de nition of $E_{\rm int}$). The term s $E_{\rm 1,2}$ are the energies of isolated plates.

Let us de ne the quantity P as the ratio of the probability of having $_1$ [$_2$ and the probability of having both $_1$ and $_2$ independently of each other:

The interpretation of P is the following: if P > 1 (P < 1) then it is easier (m ore dicult) to nd a nodal line $_2$ if another line $_1$ is present.

The interaction energy E_{int} is always nite (even when m ! 0 and/or ; ! 1) and hence so is P . Moreover we know from quantum eld theory that $E_{int} < 0$ and that it increases when the nodal lines are pulled apart. Hence we can say that the presence of a nodal line $_1$ makes it easier for another nodal line to be born. Hence in this case nodal lines induce other nodal lines in their vicinity.

The choice of the scalar eld spectrum allows us to use all the machinery of QFT (including the Ham iltonian formulation) to calculate the Casim ir energy $E_{\rm int}$. Depending on the value of ; ; m and the distance between the nodal lines a, we can use a weak or a strong coupling approximation for $E_{\rm int}$. Since has dimension $^{\rm cl}$ ('is a length scale) the relevant dimensionless parameter is = a $^{1=({\rm cl}\ 1)}$. Moreover assuming m, h(r) 2 i 2 we have $1=r^{{\rm cl}+1}$ 2 . By choosing a; r; we have 1 for weak coupling and 1 for the strong coupling regime.

We will now make some explicit sample calculation in these two regimes.

In the weak coupling regime can use a Feynman diagram expansion [8] (one must use the Euclidean cuto on the kintegrals) for the Casimir energy E

where E_1 is given by the tadpole diagram, E_2 is given by the 2 legs diagram and so on. We will now calculate the rst two terms of the series (20) showing that E_1 drops between numerator and denominator in P and then calculating the rst correction to P, i.e. E_2 . We will also show that $E_2 < 0$, which implies P > 1, in a region of order 1 = m around any nodal line.

For the tadpole diagram we have

Since R dxV (x) does not depend on a, the tadpole diagram does not contribute to the interaction energy $E_{\rm int}$ and hence does not contribute to P. We must then go to the next diagram, the one with two legs to not the rst non zero correction to $E_{\rm int}$. The two-legs diagram contribution can be written as

It contains an a-dependent interaction term. To calculate this a-dependent term we can send ! 1 (for d=2 we can take this \lim it safely) and by means of the usual technology for handling Feynm an diagram swe nd

where is the error function. Then P can be written, to this order in , as

As we said before P decreases when a increases. Moreover for a 1=m we can do an asymptotic expansion for nding

The strong coupling lim it has to be tackled with dierent, non-perturbative techniques.

The d = 2 case can also be solved exactly for any number n of parallel nodal lines by using the techniques in [7]. The resulting exact expression for n 3 is too cumbersome to be presented here and we refer the reader to [7] for details.

Two parallel nodal lines separated by a distance a in the limit! 1 are dual to the problem of two points in 1 space dimension at a distance a. The Casim ir energy for this con quration is:

We can use this formula to make some predictions about P. To begin we know that $E_{\rm int} < 0$ and that it has a minimum at a = 0 as $E_{\rm int}$ (a = 0;)' $\log(2)=2$ (here we put for simplicity m = 0). It can be proved that this is also equal to $E_{\rm single}(2)$ 2 $E_{\rm single}(3)$ (where $E_{\rm single}(3)$ is the energy of a single delta function when (1, 1), which appeals to intuition since at a = 0 we are just superposing two delta functions to create a delta function with double strength. If m > 0 it can be proved that $E / \exp(2ma)$ and hence again E / 1 when a $E_{\rm single}(3)$ 1=m. In any case we can say that P decreases when a increases.

A di culty must be noticed here, concerning how far one can push the interpretation of S as the probability of having a nodal line . Reasoning like in [9], assuming D irichlet boundary conditions on a line intersecting the x_1 axis at say $x_1 = 0$ we have then to expand our RW in series of $\sin(k_jx_1)$ (with random coe cients). Reasonably the subset of RW that has a nodal line on should be expandible in this basis as well. If moreover our

spectrum is cut o at then one expects that for a = one should nd much fewer nodal lines (the rst zero of $\sin z$ is at z=). In fact a \sin ilar phenom enon is found in [9] for the monochrom atic spectrum. The nodal line length density normalized to its asymptotic value goes to 0.5 for x=0. However increasing x_1 the nodal line length density suddenly increases to a value higher than the asymptotic value and then relaxes, oscillating, to 1. In analogy our quantity P should then start from a value < 1 at a=0, increase in a region 1= to a value P > 1 and then relax to P = 1. Evidently the rst, O (1=) region is not captured by our analysis, while the second one is. This, as we said in the discussion after Eq. (9), can possibly be traced back to the failure of the mean eld'approximation that was used to link S with the true probability of noting a nodal line [4]. We have hence learned that we must assume a 1= for our results to hold. Equation (30) for a 1=;1=; and m = 0 gives

The higher dimension (d > 2) case cannot be solved in general, due to its strong geometry dependence. The constant time section of can be any hypersurface representing disconnected conductors in space. The Casim ir problem is the most generic one and we do not posses an elicient way of solving it. We know however how to solve the case of parallel, large (actually, in nite) d 2 hyper-planes (lines in d = 3, planes in d = 4 etc.). The result for m = 0; ! 1 is

where S is the d 2 dimensional area of the hyper-planes, a their separation and the proportionality constant depends on d.

One of the main problems of Casim ir physics is to not exective (analytical or numerical) ways of calculating the Casim ir energy for arbitrary congurations of perfect conductors. Despite recent developments [10, 11] this problem escapes analytical solution for all but the simple parallel plates case. We then expect to gain some insights from the other side of the duality, namely the nodal lines distributions.

V. EXTENSIONS AND FURTHER DEVELOPMENTS

Extension to di erent spectra. It would be interesting to know how much of what we said in this paper, based on the scalar eld spectrum, is valid for other spectra (like the monochrom atic spectrum). The monochrom atic, as well as other kinds of isotropic spectra cannot be modelled by an Hamiltonian eld theory, even thought their probability functional is gaussian. The high degree of non-locality of these spectra implies that the free energy F is not extensive. Hence we could not even de nea T-independent quantity like the Casim ir energy E. It is hence of great interest for a eld theorist to grasp some of the properties of these generalized free QFTs in terms of some, more intuitive perhaps, statistical properties of random waves.

Extension to codimension > 1. Generically nodal lines of real elds have codimension 1 (lines in the plane, etc.) because they are defined by a single condition, namely (x) = 0. Codimension 2 or higher nodal lines are non-generic and have extremely low probability of occurring. For example the probability of having (x) = 0 at an isolated point requires both (x) = 0 and (x) = 0 at the same point. This is extremely unlikely in the sense that it has measure 0, and would never show up in a Montecarlo simulation. We know in fact from [7] that conductors of codimension 2 and higher cannot be defined with (x) = 0. They must be defined as a limit (x) = 0. However the generating functional (x) = 0. It diverges badly. A ctually, since (x) = 0 in a for (x) = 0 it is not well-defined for (x) = 0 in the probability distribution of (x) = 0 and shrinking to codimension (x) = 0 in such a way that this divergence and the ininitesimal probability of a codimension (x) = 0 in such a way that compensate, giving a nite value for (x) = 0.

Extension to complex elds and phase singularities. A nodal line of a complex eld is a more interesting object than that of a real eld [1]. Complex eld nodal lines are phase singularities whose strength can be interpreted as a topological charge [5]. Various correlation functions of this charges have been calculated by means of the Gaussian eld technology. It would be interesting to see what the Casim ir energy analogy has to say on these objects.

Numerics. One of the main reasons this duality is interesting is that it could lead to a more e cient numerical algorithm for computing Casim in energies of conductors of arbitrary

shape. However this issue is beyond the scope of this paper and we leave them for future work.

VI. CONCLUSIONS

We have shown that there is a dual description of random waves in terms of quantum eld theory. In particular we put forward and started the exploration of the duality between the probability of having a nodal line close to a given disconnected reference curve and the C asim ir energy of a conguration of conductors.

We used this duality to infer some properties of the distribution of nodal lines and we proved that, for the scalar eld spectrum, nodal lines induce other nodal lines in their proximity. This last statement just follows from the attractive nature of Casimir interactions.

This duality can be used in the other direction to gain inform ation on the Casim ir energy of an arbitrary con guration of conductors from the statistical properties of the nodal line.
