## M icroscopic m easurem ent of photon echo form ation in groups of individual excitonic transitions

The third-order polarization em itted from groups of individual localized excitonic transitions after pulsed optical excitation is measured. We observe the evolution of the nonlinear response from the case of a free polarization decay for a single transition, to that of a photon echo form any transitions. The echo is shown to arise from the mutual rephasing of the em ission from individual transitions.

N on linear optical spectroscopy is a powerful technique when investigating the electronic structure and dynam ics of matter. Speci cally, the third-order nonlinearity probed in four-wave mixing (FW M), spectral holeburning, and pump-probe experiments can be used to determ ine hom ogeneous line-shapes of inhom ogeneously broadened transitions. This was rst employed for nuclear spin transitions excited by radio-frequencies, which show spin echoes [1]. The availability of ultrafast laser pulses allowed the echo technique to be extended to optical frequencies [2, 3]. More recent experiments have seen the e ect of inhom ogeneous broadening be circum vented by measuring on individual systems, such as single atom s in traps, single m olecules on surfaces, or single localized exciton states in sem iconductor quantum dots. This is currently only possible in the optical frequency range in which highly sensitive detectors are available. In such experiments, the measurement time has to be much longer than the dephasing time in order to collect a su cient num ber of photons. During this time, uctuations in the environm ent lead to slow spectral di usion of the frequency of the investigated transitions (e.g. by the Stark e ect), resulting in an inhom ogeneous broadening in the measurement due to the time-ensemble [4]. As a result, the typical line-width of sem iconductor quantum dots at low tem peratures m easured in single-dot photolum inescence is 10-1000 eV [5, 6, 7, 8], while the hom ogeneous line-width determ ined in photon echo experiments is about 1 eV [9, 10, 11] and can be given by the natural line-width, i.e. the radiative decay rate. FW M spectroscopy on individual exciton transitions can distinquish between these two broadening mechanisms. However, until now FW M on single exciton states was only performed using continuous wave excitation with nondegenerate frequencies [12, 13]. Therefore, the form ation of the photon echo from the interference of the FW M polarizations of individual transitions has, up to now , not been observed.

In this work, we present transient four-wave mixing measurements on individual, localized excitons. Using a multichannel heterodyne detection, the frequency-

resolved third-order polarization is measured in am plitude and phase, so that both the time and the spectrally resolved third-order polarization can be retrieved. A nalogous to the introduction of pulsed nuclear magnetic resonance spectroscopy to replace scanning techniques, the detection sensitivity is increased signic cantly by the multichannel detection. This enables us to investigate the evolution of the nonlinear response from the case of a free polarization decay to that of a photon echo as the number of individual transitions in an inhom ogeneously broadened ensemble is increased.

The size of the investigated excitonic states is much sm aller than the wavelength of the resonant light. Therefore, the emitted polarization of an individual state is essentially isotropic (apart from polarization e ects), rendering the commonly used directional selection of the four-wavem ixing signal useless. To discrim inate the fourwave mixing signal in such a case, we have to use the phase coherence of the signal relative to the excitation pulses, which is determined by the form of the thirdorder polarization P  $^{(3)}$  /  $E_{1}E_{2}E_{2}$  , with the excitation electric elds  $E_{1,2}$ . In order to be sensitive to the phase of the emitted FW M eld, we detect it via its interference with a reference eld  $E_r$ . Such a detection principle was used to measure pump-probe and four-wave mixing in wavequides [14, 15] and in planar InAs quantum dot ensem bles [10]. In these investigations of large ensem bles of excitonic states (N >  $10^5$ ), the FW M was emitted as a photon echo [9] of 100 fs duration given by the inverse inhom ogeneous broadening of the transition energies in the excited ensemble. Conversely, when probing individual transitions, the signal of each transition is expected to be emitted as a free polarization decay, with a decay time given by the intrinsic dephasing time of the transition, which can be many orders of magnitude longer than the ensemble photon echo. In order to e ciently measure a signal of such rich spectral com plexity, a multichannel detection is needed. We employ a multichannel heterodyne scheme using spectrally resolved detection with a charge-coupled device (CCD), and retrieve the signal by spectral interferom etry [16]. This scheme provides a sim ultaneous m easurem ent of all spectral com ponents of the signal in both am plitude and phase, allowing the determ ination of the signal in both frequency- and timedom ain by Fourier-transform.




FIG.1: Scheme of the experimental setup. Boxes: A coustooptical modulators of the indicated frequency. L1: High numerical aperture (0.85) microscope objective. Spectrometer: Im aging spectrometer of 15 eV resolution.

A schematic overview of the experimental setup is given in Fig.1. W e start with optical excitation pulses of 0.2 ps duration at 76M H z repetition rate from a modelocked T isopphire laser with a center frequency ! . Two pulse trains 1,2 are created by a beam -splitter, frequency shifted with acousto-optical modulators (AOM s) by the radio frequencies  $_1=2 = 79 \text{ MHz}$  and  $_2=2 = 80 \text{ MHz}$ , and recombined into the same spatialm ode, with a relative delay time , positive for pulse 1 leading. A frequency-unshifted reference pulse train is recombined with the pulse trains 1,2 in such a way as to pass through the same optics but in a sightly di erent direction. In this manner, passive phase stability between the excitation and the reference beam s is achieved over the whole opticalpath. The pulses are focussed onto the sam ple using a m icroscope ob jective of a num erical aperture NA = 0.85mounted in a helium bath cryostat. The FW M signal is collected by the sam e ob jective, and directed into a m ixing AOM, in such a way that the di racted beam of the signal overlaps with the reference beam re ected by the sam ple and vice versa. The mixed beam s a, b (see Fig. 1) are spectrally resolved and detected by a liquid nitrogen cooled silicon CCD, measuring their spectrally and tim e-resolved intensities  $I_{a:b}$  (!;t). In this notation, the variable ! describes the optical frequencies, with a resolution given by the spectrom eter ( 3GHz), while the time variable t describes the low-frequency dynam ics, which contains the modulation due to the frequency shifts by the AOM s [20]. The mixing AOM down-shifts the signal eld  $E_s$  in frequency by d when de ected into the reference eld Er, while the reference is frequency upshifted by d when de ected into the signal. In this way, the interference frequency of signal and reference elds in the beams  $a_{i}b$  is shifted by  $d_{i}$ . The detection  $e_{i}$ ciency is adjusted to 50%, so that the detected intensities are given by  $2I_{a,b}$  (!;t) =  $E_r f + E_s f = 2 < (E_r E_s e^{i_a t})$ . Since we detect Ia;b (!;t) tem porally integrated over the exposure time T of the CCD (which is typically 50-1000 m s), only the interference close to zero frequency ( < 1=T) is detected. To recover the interference term , we subtract the two detected intensities, yielding  $I_d$  (!) =  $I_a$   $I_b = 2 \frac{R_T}{0} < (E_r E_s e^{i - d t}) dt$ .

Having measured the interference intensity  $I_d$  (!), we deduce the signal eld in amplitude and phase by spectral interferom etry [16], using the fact that the reference eld is adjusted to precede the signal eld in time: F ( (t)F<sup>1</sup> ( $I_d$  (!))) =  $E_r$  (!) $E_s$  (!) $e^{i_d t}$  with the Heaviside function (t), and the Fourier-transform operator F. The time-range of the resulting time-resolved signal

eld of this technique is limited by the spectral resolution to about 100ps, which is much smaller than the repetition period. The reference eld amplitude can be

determ ined by blocking the signal beam and measuring  $I_{a,b} = f_{r,c}^{2}$  in this case. The reference phase can be determ ined by nonlinear pulse characterization techniques, or can be calculated from the chirp introduced by the optical components in the setup. Knowing the reference eld  $E_{r}(!)$ , the signal eld  $E_{s}(!)$  can be determ ined. The choice of  $_{d}$  selects the detected interference. For  $_{d} = _{1,2}$ , the rejected excitation pulses 1,2 are measured, while for  $_{d} = 2_{2}_{1}$ , the em itted FW M eld /  $E_{1}E_{2}E_{2}$  is measured. Higher-order non-linearities, like six-wave mixing, can be detected analogously.




FIG.2: a) Confocally excited / detected PL spectrum of a  $(0.5 \text{ m})^2$  area of a A IA s/G aA sQW with a thickness of about 20.8 ML (6 nm). The spectrum of the excitation pulses used in the FW M experiment of b) and Fig.3 is shown as dotted line. b) Spectrally resolved FW M intensity at = 1 ps.

The investigated sample [17] consists of an MBE { grown A IA s/G aA s/A IA s single quantum well with a thickness increasing from approximately 4 nm to 10 nm over a total lateral size of 200mm. The growth was interrupted for 120s at each interface, allowing for the form ation of large m onolayer islands on the growth surface. The sample was antire ection coated, and was held in a helium cryostat at a tem perature of T = 5K.Exciting non-resonantly at 1.96 eV, focussed to the di raction lim it, the confocally detected photolum inescence (PL) is shown in Fig.2a. In order to select individual states within the optical resolution of the experiment  $(0.5 \text{ m})_{r}$ weadjusted the fractionalm onolayer thickness of the QW to be about -0.2 M L [18], yielding very few localized exciton states in the largest m onolayer (ML) thickness. This was done by monitoring the PL spectrum while moving the excitation spot along the QW thickness gradient. Individual em ission lines are visible in the low -energy part of the spectrum, corresponding to individual localized excitons. Due to the di usion of the excited carriers prior to recombination, the spatial resolution of the PL spectrum is not signi cantly improved by the confocal excitation, and is essentially determ ined by the di raction limited intensity resolution of 0:61 = NA in the emission im aging. The sam e region was investigated by the FW M technique. The laser pulse spectrum shown in Fig.2a ex-

cited only the excitons localized in the lowerm onolayer in order to avoid large excited exciton densities. The measured spectrally resolved FW M at = 1 ps is given in Fig.2b. It consists of several sharp resonances of 20-30 eV FW HM. The FW M intensity is proportional to the third power of the excitation intensity, which im proves the spatial resolution to 0:36 =NA 320 nm . Only at the higher energy side of the PL emission are FW M resonances of signi cant strength observed. The FW M intensities of the resonances are not clearly correlated to the PL intensities. This can be understood considering the properties of the resonances determ ining the respective signal strength. The FW M intensity is determ ined only by the fourth power of the optical transition dipole moment of the resonance. The PL intensity instead is determ ined by the radiative rate, proportional to  $^{2}$ , and also by the relaxation dynam ics of excitons into the localized state. Additionally, in the PL we use non-resonant excitation, for which charged exciton em ission [19], having a binding energy of about 4m eV, could be present, explaining the lower energy peaks (e.g. at 1.628 eV) in the PL.




FIG.3: Time-resolved FW M intensity from a group of exciton states localized within an  $(0.5 \text{ m})^2$  area. Excitation pulses 1,2 (dashed line) and time-resolved FW M intensity (solid line) for a delay time of = 20 ps are shown. Excitation energies were 1.0 (1.9) fJ for pulse 1 (2), corresponding to an intensity per pulse of 0.4 (0.75) J/cm<sup>2</sup> at the quantum well.

The tem poral sequence of the experiment, consisting of the arrival of pulse 1, pulse 2, and the subsequent emission of the FW M intensity can be measured in the experiment by choosing d equal to 1, 2, or 2 2 1, respectively, and is shown in Fig.3. Pulse 1 arrives at t = 20 ps, and creates a rst-order polarization that oscillates at the resonance frequencies of the system . U pon the arrival of pulse 2 at t = 0, this polarization interferes with pulse 2 and creates a density that oscillates with the

frequency  $_2$  \_\_\_\_1. The polarization that is created by pulse 2 and that is proportional to this density is the third-order polarization. It has the frequency 2  $_2$  \_\_\_\_\_1, and is the source of the self-di racted FW M. The FW M is thus expected to start at t = 0, in agreement with the experimental observation. Since several resonances of frequencies !<sub>k</sub> are emitting, their superposition leads to a strong temporal beating in the signal. G enerally, we can express the emitted FW M eld E<sup>(3)</sup> for > 0 for a set of N two-level system s as:

with the dipole moments of the transitions  $_k$  and the appropriately normalized excitation eld amplitudes  $E_{1;2}$  (!) of pulse 1,2 at the frequency !. Here we assume




FIG.4: Measured relative phase evolution of the FW M eld of 4 individual transitions of an ensemble. The corresponding FW M spectrum is shown in the middle row of Fig.5. The phase noise of about 0.3 rad is not readily discernible due to the large phase scale.




FIG. 5: FW M intensity for = 20 ps, spectrally resolved (left) and time-resolved (right), for exciton state ensembles of di erent size. The estimated fractional enhancement by the superradiance at the photon echo time t = 20 ps is indicated.

that the pulse spectral width is much larger than the dephasing rates  $\ _k$  of the transitions. At t =  $\$ , the FW M

elds from all two-level systems are predicted to be in phase, and therefore to interfere constructively. This results in a signal amplitude N tim es larger than the individual FW M amplitudes of a single transition. For other times, the phases are, in general, random ly distributed due to the distribution of the transition frequencies, and the enhancem ent is reduced to N. In the lim it of a large number of systems in the ensemble, the signal at is thus far larger than at other tim es, and is called t =a photon echo. Until now, the signal away from the echo time, in the random interference time, was not observed. Here, we can see (Fig. 3) the form ation of the photon echo by the constructive interference at t = 20 ps. Since we measure the phase and amplitude of the signal, we can determ ine the phase evolution for each resonance separately by applying a spectral lter. The result of such an analysis for 4 transitions of an ensemble is shown in Fig.4 (the corresponding spectrally resolved FW M is given in the middle row of Fig.5). In the measured phase evolution, the rephasing of the FW M elds from the individual transitions at the photon echo time t = 20 ps is directly observed.

Furtherm ore, the fact that we can determ ine, in the spectral dom ain, the number of states contributing to the time-dom ain FW M signal allows us, by appropriate selection of regions of the sam ple, to control the size of the state ensemble probed in the FW M. By system atically increasing the number of participating transitions from one to many, we can therefore follow the form ation of the photon echo with increasing ensemble sizes. This evolution is shown in Fig.5 for ensembles of about 1, 4, and 10 transitions. With increasing ensemble size N, the intensity enhancement in the photon echo increases roughly / N, as expected from eqn.(1). The peaks o the photon echo time are due to subsidiary constructive interferences of subgroups of states, and are prominent due to the small number of participating states.

In conclusion, we have m easured the transient thirdorder polarization of individual quantum states in both amplitude and phase. The form ation of the photon echo with increasing ensemble size was experimentally dem onstrated and the signal was shown to vary from a free polarization decay for the single emitter to a photon echo in the ensemble limit; we have thus dem onstrated experimentally the microscopic origin of the photon echo in transient four-wave mixing in a solid state system.
