Quantum critical point in the spin glass-antiferrom agnetism competition for ferm ionic Ising M odels

A bstract

The competition between spin glass (SG) and antiferrom agnetic order (AF) is analyzed in two sublattice ferm ionic Ising models in the presence of a transverse and a parallel H magnetic elds. The exchange interaction follows a Gaussian probability distribution with 32=N, but only spins in di erent sublattices can mean $4J_0 = N$ and standard deviation J^{-} interact. The problem is formulated in a path integral formalism, where the spin operators have been expressed as bilinear com binations of Grassmann elds. The results of two ferm ionic m odels are compared. In the stone, the diagonal S $^{\rm z}$ operator has four states, where two eigenvalues vanish (4S model), which are suppressed by a restriction in the two states 2S m odel. The replica symmetry ansatz and the static approximation have been used to obtain the free energy. The results are showing in phase diagram sT=J (T is the tem perature) versus $J_0=J$, =J, and H=J. When is increased, T_f (transition temperature to a nonergodic phase) reduces and the Neel temperature decreases towards a quantum critical point. The eld H always destroys AF; however, within a certain range, it favors the frustration. Therefore, the presence of both elds, and H, produces e ects that are in competition. The critical tem peratures are low er for the 4S m odel and it is less sensitive to the m agnetic couplings than the 2S m odel.

1 Introduction

There are now several examples of competition between antiferrom agnetism (AF) and spin glass (SG) in strongly correlated systems as, for instance, heavy ferm ions and high T_c superconductors [1, 2]. In some of these systems, there is also a new physics involved with the presence of a quantum critical point (QCP) and deviation of the Ferm i liquid behavior, so called Non-Ferm i liquid (NFL) behavior. This raises the necessity of obtaining a solid fram ework to describe those systems where the ferm ions are operative to give origin to physical processes, such as the K ondo e ect, in connection with the presence of AF and frustration driven by disorder, particularly, at low tem peratures where quantum e ects become important.

The complexities of such description can be estimated by the controversies [3] involved in the quantum Ising SG which has been investigated by several techniques [4]. For instance, one of the most interesting open issues is whether the quantum tunneling between the local degenerated minimum of the free energy is able to stabilize the replica symmetric solution of the problem. Recently, the ferm ionic Ising SG in the presence of a transverse magnetic eld has been studied using the functional integral form alism [5]. The spins have been represented by bilinear combinations of the ferm ion operators. This ferm ionic problem has been presented in two versions. In the rst one, the ferm ionic spin operators have maintained their four natural eigenvalues, where two of them are non-magnetic. In the second one, it has been retained only the magnetic ones due to an imposed constraint to garantee complete equivalence between the spin and the ferm ionic problem [6]. The free energy has been obtained in both versions within the replica symmetric theory and the static

approximation. It has been found that the freezing temperature T_f () decreases to a QCP when enhances in a second order type transition. In that formulation, the replica symmetric solution is unstable in the entire SG region. The fermionic formulation is also a natural tool to study the interplay between frustration driven by disorder and, for instance, K ondo e ect at low temperature when quantum tunneling is important. A ctually, quite recently, the SG problem with transverse eld has been studied successfully in the disordered K ondo lattice with this technique [7].

The purpose of the present work is to investigate the SG /AF competition in the context of the ferm ionic representation for the Ising spins variables when a magnetic eld is applied with two components: one parallel (H) and other transverse () to the z direction. The component introduces a spin ipping mechanism in the problem which can lead the phase boundaries to a QCP [5]. The model used here is the ferm ionic version of the Korenblit-Shender (KS) model [8] introduced to study SG /AF competition with classical Ising spins. In the KS model, there are two sublattices, but only spins in distinct sublattices are allowed to interact with a random Gaussian coupling J_{ij} . The presence of the magnetic eld H breaks the symmetry between the sublattices. A sconsequence, it can introduce unusual ects as it has been shown in the mean eld theory with replica symmetry for the classical interlattice frustrated model [8]. For instance, the eld H can favor frustration within a certain range. This is in contrast with the well known result from the Sherrington-K irkpatrick model (SK) [9] where the freezing temperature $T_{\rm f}$, associated with the A lm eida-T houless instability, decreases m onotonically with the eld H . In fact, the dependence of the random internal eld with H in the KS model could explain its odd behavior [8]. The internal eld applied h_p in a particular sublattice (p = a, b) depends on the magnetization m_{p^0} and the SG order parameter q_{p^0} ($p^0 \in p$). Due to the break of the symmetry between the two sublattices, when H is increased in a particular range, one may have a nonmonotonic behavior in the order parameters m_{p^0} , q_{p^0} and, consequently, in the h_p . Therefore, T_f can be enhanced and the non-trivial ergodicity breaking region (SG) is enlarged.

This leads several issues for the SG /AF competition in the ferm ionic representation of the KS m odel, when both eld components (H and) are applied. Is the scenario described previously for the classical KS m odel preserved or not even for = 0 case? The answer is not obvious because the ferm ionic representation of the spin operators introduces an in portant di erence as compared with its classical counterpart. The replica diagonal spin glass order parameter for the two sublattices is not constrained to the unity. It must be solved together with the other order parameters, the replica o -diagonal SG order parameter and the magnetization for the two sublattices. As consequence, it would introduce a new component in the random internal eld. If the previous question is answered positively, is there any range of H which can favor frustration when $\neq 0$ as in the classical KS? The presence of H, by a mechanism sim ilar to the its classical counterpart, could enhance T_f while the component tends to suppress frustration leading the T_f to a QCP [5]. Therefore, the elds H and enforce two competing mechanisms in the problem which could deeply a ect the SG /AF phase boundaries.

The quantum mechanical partition function of the problem has been obtained following the approach introduced in reference [5]. Therefore, the functional integral approximation is used to dealwith non-commutativity of the spin operators which are represented by bilinear combinations of G rassmann variables. One important aspect of the fermionic representation of spins S_i^z is that (see Ref. [5]) it has four eingenvalues per site, where two of them are non-magnetic. For the rest of the paper, this representation is named 4S model. To recover the usual spin representation, a constraint is introduced in order to maintain only the magnetic eigenvalues. This version of the problem is named 2S model. The disorder in the problem is treated using the replica trick where the order parameters are obtained within the replica symmetric ansatz [9]. It should be noticed that the possible occupation of non-magnetic states can produce di erences concerning the phase boundaries between the two models. In fact, for the one lattice fermionic SG with transverse eld [5], $(T_f)_{2S} > (T_f)_{4S}$ for $<< _c$ where $_c$ is the value of the eld at the QCP. This also arises the question how these representations 2S and 4S respond (in term s of the phase boundaries) when H and are turned on. In order to allow us a better comparision between the two representations of the problem, the 4S m odel is kept in the half-lling.

In the present approach, the time dependence of the spin-spin correlation functions has not been considered (static approximation) [10]. The main argument to justify the use of this approximation (see Ref. [5, 11]), even at low temperature, is that our goal is to obtain the phase boundaries in the SG /AF competition in the spin ferm ionic representation and how these boundaries are a ected by the presence of H and . As it can be seen elsewhere [7, 12], that approximation is quite reasonable if the intention is not to reveal the complex nature of phases at very low temperature, but mainly to produce phase boundaries which can min ic the experimental ones.

It is hoped that the results presented here can be a rst step to provide a fram ework which can allow us to study the phase boundaries SG /AF competition present in several problem s of m any interacting ferm ions, such as the heavy ferm ion system $Ce_2Au_1 \ge Co_xSi_3$ [13] where disorder, competing RKKY interaction and the K ondo e ect have produced a SG alike state and an AF phase where the Neeltern perature seem s to decrease tow ards a QCP with no trace of NFL behavior.

This paper has the following structure. In section II, the model is introduced, the saddle point free energy and the corresponding order parameters are obtained. In section III, the numerical solutions of the order parameters allow us to construct phase diagram s to show the AF/SG com - petition. Particularly interesting, for the purposes of the present work, are the phase diagram s in the space temperature versus the components of the magnetic elds H and . It is also shown the behavior of the susceptibility. In the last section, the discussion of the results previously shown and the nal remarks are presented.

2 M odel

The model considered here is a ferm ionic Ising model [14] represented in two sublattices a and b where there are two magnetic elds applied: and H transverse and parallel to the Ising spins, respectively. One important point is that only spins located in distinct sublattices can interact like in the KS model [8]. Thus,

where the sum s are run over the N sites of each sublattice (a or b). The coupling $J_{i_a j_b}$ is assumed to be a random variable with a Gaussian distribution given by:

The spin operators in Eq. (1) are de ned as [5]:

where $\hat{n}_{i_p} = c_{i_p}^y c_{i_p}$ is the number operator, $c_{i_p}^y (c_{i_p})$ are fermions creation (destruction) operators, with = " or # indicating the spin projections, and the sub-index p = a or b represents the sublattice.

In Eq. (3), the spins have been written as bilinear combination of ferm ion operators which act on a space with four states per site (\mathcal{D} 0i, \mathcal{J} 0i, \mathcal{D} #i, \mathcal{J} #i). Therefore, $\hat{S}_{i_n}^z$ has four eigenvalues:

1=2 (when there is one ferm ion in the site i_p (= " or #)) and two when the site i_p is unoccupied or double occupied (= " and #). In the present work, two form ulations are considered: one unrestrained the number of states of the $S_{i_p}^z$ (4S m odel), but it considers the average occupation of one ferm ion per site, another restrained the occupation number to \hat{n}_{i_p} " + $\hat{n}_{i_p\#}$ = 1 (2S m odel). This last representation allow us to study the problem avoiding the presence of unoccupied and double occupied states [5].

The partition function is given in the Lagrangian path integral form alism where the spin operators are represented as anticommuting G rassmann elds (;). The partition function for the 2S model must consider only states that have one ferm ion per site. This restriction is obtained by using the K ronecker function ($(\hat{n}_{p^{"}} + \hat{n}_{i_{p^{\#}}} - 1) = \frac{1}{2} \int_{0}^{R_{2}} dx_{i_{p}} e^{ix_{i_{p}}(\hat{n}_{i_{p^{"}}} + \hat{n}_{i_{p^{\#}}} - 1)}$). Therefore, the partition function for both models can be represented in a compact form as [5]:

where $_{i_p} = 0$ for the 4S m odel, which corresponds to the half-lling situation, or $_{i_p} = ix_{i_p}$ for the 2S m odel. The action A f g can be Fourier transform ed in time. Thus, we have:

with the M atsubara's frequencies ! = (2m + 1) and = 2m (m = 0; 1;). In this work, the problem is analyzed in the static approximation, which considers only the term when = 0 in Eq. (7) [5, 10, 14].

The free energy per site is obtained by using the replica method: $F = \ln Z = \lim_{n \ge 0} 1 = (nN) (Z(n) = 1)$, where Z(n) $hZ^n i_{J_{i_a,j_b}}$ is the congurational averaged replicated partition function. The average over P (J_{i_a,j_b}) can be performed using the G aussian distribution given in Eq. (2). Thus:

where denotes the replica index and $S_{i_p} = S_{i_p}(0)$. Eq. (10) can be rearranged reviewing the sum s over di erent sublattices by square sum s over the same sublattice [8]. Then, these quadratic term s are linearized by using the Hubbard-Stratonovich transformation. This transformation inserts auxiliary elds fM $_3$, M $_p$, Q $_3$, and Q $_p$ g on the partition function, therefore:

In the therm odynam ic limit, the set of integrals in R dU can be performed exactly by the steepest descent method, where the auxiliary elds are given by the saddle point solutions:

At this stage, it is assumed the replica symmetric \ansatz" that considers the set $q_p = q_p$ for all 6 , $q_p = q_p + p_p$, and $m_p = m_p$ for all . The physical quantity $p = p_p = w$ here p_p is the magnetic susceptibility when $J_0 = 0$. The sum s over in Eq. (17) produce quadratic terms again, which can be linearized introducing new auxiliary elds in the expression (16), therefore:

with $p^0 \in p$. Therefore, the internal eld h_p applied in a particular sublattice depends entirely on the order parameters of the other sublattice [3].

The functional integral over the G rassm ann variables in Eq. (19) can be calculated (see R ef. [15]), thus, $\ln p_{eff} = \frac{1}{2} \ln (\det \underline{G}_p^{-1} (!))$. In the same equation, the sum over the M atsubara's frequencies can be performed like references [5, 14] to give the following expression:

Now, the restriction condition over the number of states can be used for both models. For the 4S model, the average occupation per site is one. It is obtained putting $_{p} = 0$, therefore the integral over x_{p} is equal to the unity. For the 2S model ($_{p} = ix_{p}$), which corresponds to the spin form ulation where there are only two states per site (j";0i, j);#i), the integral over x_{p} is equal to zero. This situation is equivalent to choose an in aginary and temperature-dependent chem ical potential in the Popov-Fedotov method [16]. Therefore, the main dimense between both models is that in the 2S model the contribution of the non-magnetic local states is exactly canceled, while in the 4S model it is adopted the half-lling situation. These results are used in Eq. (15) and the free energy can be written as:

where s represents the states number allowed in each model. The order parameters q_p ; p and m p are given by extrem e condition of the free energy (23):

In particular, when = 0, the set of integrals over $_{\rm p}$ can be performed analytically. In this case, it is easy to see that the parameter $q_{\rm p} = \frac{4}{N}h_{\rm i_p}S_{\rm i_p}S_{\rm i_p}$ i = $q_{\rm p} + _{\rm p} = 1$ (Eq. (27)) for the 2S m odel. However, in the 4S m odel, due to the presence of non-m agnetic states, $q_{\rm p}$ depends on the tem perature and the internal edd $h_{\rm p}$. Nevertheless, near T = 0, $q_{\rm p}$ can be expressed by using a low-tem perature expansion:

where $\$_p = \frac{J_0 m_p^0}{J_2 p_p^0}$. This result suggests that the occupation of non-magnetic states are exponentially smallat low T.




Figure 1: P hase diagram T=J versus $J_0=J$ for H=0. The solid lines correspond to the results obtained by the restricted m odel (2S), while the dashed lines correspond to the unrestricted m odel (4S). The dotted lines are the extrapolation carried for low ertem perature. $A_T = 0$ is the A lm eida-Thouless line.

It is well known that the replica symmetric solution can be unstable at low temperature in the spin glass phase [5], where the Alm eida-Thouless eigenvalue $_{AT}$ becomes negative. The equation for the $_{AT}$ following as [8]:

3 Results

The phase diagram s showing the competition between SG and AF for both models with two (2S) and four (4S) states can be obtained solving the replica symmetric order parameters given by the set of equations (25)-(27). In the present work, the numerical solutions for m_p , q_p , $-_p$ and A_T (with p = a or b) are studied by varying the three relevant parameters in the problem, which are $J_0=J$, =J and H=J. In this context, the AF phase is given by the order parameters $I_m = m_a - m_b \in 0$ and $q_a - q_b \in 0$; however, the same situation with the eigenvalue $A_T < 0$ characterizes the mixed phase (SG + AF). It can be considered that, in the SG phase, the order parameters parameters $I_m = 0$ and $q_a = q_b \in 0$ together with $A_T < 0$. In this quantum fermionic treatment, one can identify two situations for the diagonal component of the replica matrix ($q_p = q_p + -_p$). For the 2S model with = 0, $q_p = 1$. On the other hand, for the 4S model or for the 2S model when

> 0, it is necessary to consider the coupling between diagonal and o -diagonal replica m atrix elements. Consequently, the parameter $_{\rm p}$ must be calculated simultaneously with q_p and m_p, and hence it becomes relevant for determination of the remaining physical quantities. In particular, for H = 0, the Neel temperature T_{N 0} = T_N (J₀; ; H = 0) can be computed expanding the saddle

point equations in powers of m $_p$. At the second order critical line $T_{N 0}$, we can make $q_p = 0$, therefore $p = 1 = (_c J_0)$ and

For = 0, the Neel temperature is $T_{\rm N \ 0} = J_0 = [\frac{s \ 2}{2}]$ exp $(\frac{J^2}{T_{\rm N \ 0} J_0}) + 1]$, while for $T_{\rm N \ 0}$ close to zero, the critical value of the transverse eld is given by analytical solution of Eq. (31): $_{\rm N} = J_0 + 2J^2 = J_0$, for both m odels.

In Fig. (1), it is shown the diagram T=J (T is the temperature) versus $J_0=J$ when and H are zero. For that particular situation, the results for 2S and 4S m odels are qualitative equivalent to the KS model with classical Ising spins. A ctually, for the 2S model, the Fischer relation [3] $a_{ib} = 1$ $q_{a,b}$ (a_{ib} is the linear susceptibility for J_0 equal to zero). is recovered _____a;b Therefore, the 2S m odel reproduces exactly the KS results [8]. For high tem perature and high degree of frustration $\left[J_0=J\right]^{\perp}$, a param agnetic phase (PM) is found. The AF solution for both models can be found in the region where the degree of frustration is small enough. In this case, $m_a = m_b$ [3]. For increasing and decreasing tem perature, the A lm eida-T houless line in Fig. (1) show s the onset (at freezing tem perature T_f) of the complex ergodicity breaking region (the SG region). There is also an interm ediate m ixed phase region (SG + AF), where inside the SG, the m agnetization of the sublattices remains nite with opposite sign. It should be remarked that the transition tem peratures are di erent in both models. Particularly, for the same $(T_f)_{2S} > (T_f)_{4S}$, $(T_N)_{2S} > (T_N)_{4S}$ and $(dT_N = d)_{2S} < (dT_N = d)_{4S}$ (T_N is the Neelten perature). These distinct behaviors show the di erent sensitivity to the magnetic coupling between the two models. For the sake of completeness, in Fig. (1), it is also studied the region for $J_0=J < 0$ where a ferrom agnetic (FE) region is found with $m_a = m_b$. Thus, one recovers essentially the one lattice spin glassferrom agnetism competition [8, 17]. These results show that, in absence of magnetic elds, there is a symmetry between the two sublattices.




Figure 2: Phase diagram sT=J versus =J for H = 0, (a) 0 $J_0=J < \stackrel{P}{2}(> 1= \stackrel{P}{2})$ and (b) $J_0=J = 1:7 (= 0.59)$. The line conventions are the same as in Fig. (1).

If is turned on (with H = 0), two distict situations can be identied. For the degree of frustration > 1 = 2 (0 $J_0 = J < 2$), the magnetization of both sublattices is zero. Therefore, the problem is reduced to the one lattice problem in the presence of a transverse eld studied in reference [5] (see Fig. (2-a)). For small , the freezing temperature T_f is di erent for each model. However, when the temperature is decreased and the spin ipping increases due to , the critical behavior of both models tends to become identical. The critical eld $_c$, at the QCP for 2S and 4S models, is the same. The Fig. (2-b) shows a phase diagram for a smaller degree of frustration = 0.59 ($J_0 = J = 1.7$). For this set of parameters, the PM solution is still found at high temperature for any value of . For small values of , when the temperature is decreased, there is a transition to the AF phase at (T_N)_{2S;4S}, but (T_N)_{2S} > (T_N)_{4S}. For even lower temperature, there is other transition to the mixed phase (SG + AF) at (T_f)_{2S;4S} (again (T_f)_{2S} > (T_f)_{4S}), and nally to the SG phase. These transitions are mainly therm ally driven. On the other hand, when

is increased, the N eel tem perature T_N for both models decreases towards a QCP at $_N$. The tem peratures $(T_f)_{2S;4S}$, given by the AT line, decrease when increases like the N eel tem perature. We can observe that both models converge to the same critical behavior when is increased. The reasons for that behavior at = 0.59 are the same for large degree of frustration ($> 1 = \frac{1}{2}$). We hen we see Eq. (24), at very low tem perature, for the 4S model, the term which is integrated over $_p$ is dominant and the distinction between the two models can be neglected. It occurs because the contribution of magnetic states dominate the free energy [5]. Therefore, there is a distinction between the models in the region where the transitions are mostly therm ally driven.




Figure 3: Phase diagrams T=J versus H=J for = 0 and several values of $J_0=J$: (a) $J_0=J=1.5$ (= 0.67), (b) $J_0=J=1.6$ (= 0.63), (c) $J_0=J=1.7$ (= 0.59), and (d) $J_0=J=1.9$ (= 0.53). The insets represent a zoom in T near T_f . It is used the same convention as Fig. (1) for the line types.

Fig. (3) shows the phase diagram s T=J versus H=J when = 0. These phase diagram s are studied with four di erent values of degree of frustration . The eld H breaks the symmetry between the sublattices and produces an e ect similar to the KS m odel [8, 18]. It tends to destroy the AF phase. For instance, the N celtem peratures $(T_N)_{2S,4S}$ decrease fast when H is enhanced in the region $0 < H < H_c$ (H_c is the magnetic eld when $(T_f)_s = (T_N)_s$ (s = 2S, 4S)). However, as one can see quite clearly in Figs. (3-b)-(3-d), there is a range of magnetic eld close to H_c where

the freezing tem peratures, associated with the AT instability, increase showing that the frustration is favored in this two-sublattice problem [8, 18]. This behavior is di erent from the one lattice problem where the T_f decreases monotonically [9] for any value of H . Nevertheless, for $H > H_c$, the behavior of the AT line for 2S and 4S models become as similar to the one lattice problem . The favoring of frustration for both models as function of H can be related to drastic decreasing of N celtern perature [18] near H_c . D expite this, the presence of the magnetic eld produces di erent e ects for 2S and 4S models. The freezing tem perature, given by the AT instability, increases faster in the 2S model than in the 4S for increasing H . The AF solution is also more robust for the 4S m odel, it is found for greater values of H than the 2S m odel.




Figure 4: Phase diagram sT=J versus H=J for =J = 1:0 and several values of $J_0=J$: (a) $J_0=J = 1:5$ (= 0:67), (b) $J_0=J = 1:6$ (= 0:63), (c) $J_0=J = 1:7$ (= 0.59) and (d) $J_0=J = 1:9$ (= 0.53). The same convention as Fig. (3) is used for the line types and the insets.




Figure 5: Phase diagram s T=J versus H=J for $J_0=J = 1:7$ (= 0.59) and: (a) =J = 1:7, (b) =J = 2:4. The same convention as Fig. (1) is used for line types.

In Fig. (4), the phase diagram sT=J versus H=J is shown, but with the transverse eld tunned (=J = 1.0). The set of values of is the same as Fig. (3). For that situation, there are very in portant di erences if compared with the = 0 situation. One e ect of the applied is to depress $(T_N)_{2S;4S}$ and $(T_f)_{2S;4S}$ for any value of H . O ther in portant e ect is that the AT lines for both m odels have a quite di erent behavior in the range $0 < H < H_c$. For instance, in Fig. (4-a) where = 0:67 ($J_0=J=1:5$), when H is enhanced until H_c, the T_f, associated with the AT instability, decreases faster than the equivalent phase diagram with = 0 (see Fig. (3-a)). When is increased (see Figs. (4-b)-(4-c)), the AT line shows the delicate balance between the mechanism s enforced by and H. For H 0, where the presence of is dom inant, the spin ipping tends to destroy fustration ($dT_f = dH < 0$). As long as H increases, the fustration is favored again. When Η H_{c} , it is quite clear that dT_{f} = dH > 0. Particularly, close to H_{c} , there is a strong increase in the T_f as decreases. W hen the eld is enhanced as in Fig. (5) (where =J = 1:7 and =J = 2.4 with the degree of frustration = 0.59), the SG character is entirely suppressed. The N eeltem perature decreases towards H1. The di erences between 2S and 4S models still exist for 0. How ever, the increase of shifts the N celtem perature of both m odels tow ards zero. As Η consequence, the dierence $(T_N)_{2S}$ $(T_N)_{4S}$ is increasily sm all.

Finally, the study of the magnetic susceptibility allows one to con m the position of the N eel tem peratures and to study in detail the di erences between the 2S and 4S models near T_N. The magnetic susceptibility is obtained di erentiating the saddle point equations (25, 26, 27) with respect to H. In the limit of zero eld (H ! 0), the six-independent saddle point equations system is reduced to a three-independent saddle point equations with the following relations: $m_a(H = 0) = m_b(H = 0), q_a(H = 0) = q_b(H = 0)$ and a(H = 0) = b(H = 0). In this case, the resulting linear system for $@m_p=@H, @q_p=@H and @p_p=@H (p = a or b)$ is also simplied giving $= @m_a=@H = @m_b=@H, @q_a=@H = @q_b=@H, @q_a=@H = @p_b=@H (B]. Thus,$




Figure 6: The gures (a), (b) and (c) are plots of versus T=J for = H = 0 and several values of J_0 (1.7; 2.1; 2.5). The gure (d) is the as a function of =J for H = 0; T = 0.3J and $J_0 = 1.6J$. It is used the same convention as Fig. (1) for the line types. The inset in (a) represents a zoom of near the critical points.

where is given in Eq. (27) and is de ned in Eq. (34) of the Appendix.

For high tem perature, in the PM phase, the susceptibility has the expression $= = (T + J_0)$, as expected. Now, when the tem perature is decreased, shows a brusque change in its inclination at T_N and a cusp at T_q (T_q is the tem perature below T_f , where $m_p = m_{p^0} = 0$), but it does not show any anomaly at T_f , as we can see in Fig. (6). For interm ediaries values of J_0 , the susceptibility in the AF phase near T_N does not decrease with the decrease of tem perature (inset of Fig. (6-a)). However, it exhibits a slow increase until reaching a maximum value, then it decreases. That is because of the large num ber of frustrated couplings. Nevertheless, strong antiferrom agnetic average coupling, for example $J_0=J=2.5$, has a maximum in T_N for both models (Fig. (6-c)). In Fig. (6-b), for $J_0=J=2:1$ and =H=0, exhibits a maximum at T_N only for the 2S model, while for the 4S m odel, still increases close to T_N in the AF phase. Therefore, due to the presence of non-magnetic states in the 4S model, its frustrated couplings are less sensitive than the 2S model ones for the increasing of J_0 . A nother di erence of the m odels is in the value of the critical points at high temperatures as showed in Fig. (6). The Fig. (6-d) shows the for T = 0.3J; H = 0, = :625 as a function of . A gain, the critical points are marked by discontinuities in the and that is obtained changing the transverse eld. These discontinuities have the same shape described above.

4 Conclusion

In the present work, the competition between antiferrom agnetism (AF) and spin glass (SG) in disordered ferm ionic Ising models has been studied. The J_{ij} coupling among the spins is a random gaussian variable with average and variance given by $4J_0=N$ and $32J^2=N$, respectively. There

is also a magnetic eld applied with components transverse () and parallel (H) to the Ising spin direction. The model is similar to the K orenblit-Shender model (KS) [8] for classical Ising spin which consists of two sublattices where only the interlattice frustration has been considered.

The problem has been form ulated in the path integral form alism where the spin operators are represented by bilinear combinations of G rassmann elds following closely the approach introduced in a previous work [5], which has studied the SG critical properties in presence of a transverse eld using the static approximation. The focus in this work has been to investigate the boundary phase of the SG /AF competition in this two-sublattice model [8] for Ising spins in its ferm ionic representation. For that purpose, the static approximation has been adopted like the previous work in Ref. [5]. Two formulations for the ferm ionic representation for the operator S_1^z have been assumed: the rst one is the unrestricted four-state 4S model (four eingenvalues, two of them magnetically insensitive); the second one is the restrict 2S model where the non-magnetic eigenvalues are forbidden by an imposed constraint. It should be remarked that the transverse component can tune spin ipping while H destroys the symmetry between the sublattices. Therefore, these components have opposite roles as related to the emergence of frustration in the problem.

If = 0, the Fischer [19] relation $_{\rm p}$ = 1 $_{\rm q}$ (p = a, b) is recovered in the 2S m odel, as we can see from the equations (25)-(27). Thus, the results of the KS m odel are replicated [8]. That is an important di erence with the 4S m odel, where the Fischer relation is not satis ed due to the coupling between diagonal and o -diagonal replica m atrix elements. Therefore, the internal eld h_p (see Eq. 21) behaves in a quite distinct way for both m odels. These di erences can be seen very clearly in the phase diagram temperature versus $J_0=J$ given in Fig. (1) with H = 0. The onset of AF (at T_N) and the complex ergodicity breaking given by the A m eida-Thouless (AT) line (at T_f) appear for lower temperatures in the 4S m odel compared with the 2S one. That is a direct consequence of the distinct applied internal elds for each m odel. In the susceptibility , given in Eq. (32), these di erences can be seen even in a more detailed way (see gures (6-a)-(6-c)).

W hen the transverse component is turned on (H is kept equal to zero) (see Fig. (2)), there is an important change in the critical penavior for both m odels. In the range of degree of frustration

 $[J_0=J]^{-1} > 1=2$ (0 $J_0=J < 2$), the problem is reduced to the one lattice problem studied in Ref. [5]. For small , there are two di erent transition temperatures from paramagnetism (PM) to SG for each model. These transition temperatures converge to same value as increases given origin to the same QCP at $_{\rm c}$. For < 1=2, for small , when the temperature is low ered, there are the following sequences of transitions: (1) PM /AF at T_N ((T_N)_{2S} \notin (T_N)_{4S}); (2) AF/(AF+SG), given by the position of the Almeida-Thouless (AT) line at T_f ((T_f)_{2S} \notin (T_f)_{4S}), where (AF + SG) is a mixed phase; (3) (AF+SG)/SG at T_g ((T_g)_{2S} \notin (T_g)_{4S}), where at this transition temperature the sublattice magnetizations become null. For increasing , the T_N for each model decreases converging to the same transition line. The same e ect is found for T_f. A QCP for PM /AF transition is found at $_{\rm N} = J = J_0 = J + 2J = J_0$.

O ther in portant consequence appears when the parallel eld H is turned on and, consequently, the symmetry between the sublattices is broken. That is source of unusual e ects because the internal eld applied in the sublattice p = a, b depends on the order parameters of the other sublattice $p^0 = b$, a [8, 18]. For the 2S m odel, the results of the KS m odel are reproduced [8] (see Fig. (3)). The Neelten peratures for both m odels (which are di erent) have a strong decrease as H increases. How ever, the frustration is favored for a particular range of H as shown in Fig. (3) from the AT line behavior. It occurs due to the magnetization of a particular sublattice (for instance $p \text{ where } m_p > m_{p^0}$) which contributes to decrease the absolute value of the average internal eld $J_0 m_{p^0}$) that acts on the other one. Hence, in this H range where h_p decreases with H, $(h_p = H)$ T_f can be increased [8]. That e ect is stronger when is decreased ($J_0=J$ is enhanced), since the contribution of $J_0m_{p^0}$ on h_p is increased, as shown in Figs. (3-b)-(3-c). Because of the presence of non-m agnetic state, the 4S m odel has potentially a weaker response to the m agnetic interactions. The results show that the AT line can also increase, but slower than the 2S m odel for the same range of H. Nevertheless, in the 4S m odel, the AF phase is m ore robust than the 2S one, rem aining as solution even for higher values of H . However, for very low tem perature, the contribution of the non-m agnetic states in the 4S m odel becom es less signi cant. Therefore, both m odels exhibit quite sim ilar critical lines.

When the transverse eld and H are simultaneously turned on, the eld interval eld applied in a particular sublattice p becomes $_{p} = -h_{p}^{2} + -2$. Therefore, its elects due to the presence of H and start to compete. The elds from H in the h $_{p}$ are included explicitly, but they are also included implicitly by the order parameters. It should be noticed that elects of in the order parameters are present as well. As consequence, there is complex balance of the elds discussed in the previous paragraph, dependent on the relation H = .P articularly, for small H, the contribution from is dominant and the fluctration is not favored. As long as H enhances, there is a region in the diagram temperature versus H where the fluctration becomes favored (see Fig. (4)). Therefore, the transverse component of the magnetic eld produces the same elect in each sublattice. It suppresses the magnetic order and the fluctration. While, in the region where a two-sublattice structure is characterized, the parallel component acts in an asymmetric way in each sublattice. In this sense, it is always against the AF order. Nevertheless, it can favor fluctration within a certain range of H.

To conclude, we studied the SG /AF competition in a two sublattice model [8] where the Ising spins have a fermionic representation. There is a magnetic eld applied. This eld has a transverse component () which can ip the spins leading the transitions to a QCP. It has also a parallel component (H) which breaks the sym metry between the sublattices. These components produce opposite e ects on the frustration. Our hope is to use this representation to study the several strongly correlated problem swhere there is a SG /AF competition which is associated with a QCP as, for instance, in the Cerium alloy C $e_2Au_1 \ge Co_xSi_3$ [13]. On the other hand, we have used the static approximation and replica sym metry ansatz. Quite recently, a new scheme for breaking replica sym metry hasbeen proposed [20] which is particularly suitable for the present two-sublattice problem studied here. That could be used to improve considerably the description of the SG /AF competition of our fermionic model. That would be an object for future work.
