O xygen di usion in nanostructured perovskites

A bstract

Nonstoichiom etric perovskite-related oxides (such as ferrites and cobaltites, etc.) are characterized by fast oxygen transport at ambient temperatures, which relates to the microstructural texturing of these materials, consisting wholly of nanoscale microdomains.

We have developed an inhom ogeneous di usion model to describe the kinetics of oxygen incorporation into nanostructured oxides. Nanodom ain boundaries are assumed to be the high di usivity paths for oxygen transport whereas di usion into the dom ains proceeds much slower. Using Laplace transform methods, an exact solution is found for a ram ped stepw ise potential, allowing thing of the experimental data to theoretical curves (in Laplace transforms). A furthermodel generalization is considered by introducing additional parameters for the size distribution of domains and particles.

Them odelhas been applied for qualitative evaluation of oxygen di usion parameters from the data on wet electrochem ical oxidation of nano-structured perovskite $SrCo_{0.5}Fe_{0.2}Ta_{0.3}O_{3y}$ samples.

1 Introduction

At high temperature grossly nonstoichiom etric perovskite related oxides are solid state solutions with a high concentration of structural defects (oxygen vacancies, dopant ions, etc.). As tem perature decreases, structural ordering occurs, producing either superstructures, in which defects are assimilated as structural elements, or complex microstructures with a high density of extended defects [1]. The formation of the latter microstructures may be described using the concept of oversaturated solid solutions having a m iscibility gap: oversaturation due to cooling causes unm ixing of the initially hom ogeneous solid solution. The unmixing can proceed either by spinodal decomposition or hom ogeneous/heterogeneous nucleation [2]. Stabilization of nano-sized domains occurs due to a decrease in mobility of the domain boundaries at $0.3\,T_{m}$. The mechanisms that are responsible for the enhanced thermal stability against microdom ain growth are: (a) solute drag, (b) grain boundary segregation, (c) pinning by secondary phases and (d) chemical ordering B1. A nother approach to the explanation of intrinsic inhomogeneity of nonstoichiom etric and doped oxides related to a strong tendency toward phase separation in systems with strongly correlated electrons. Electron conducting oxides with transition metals having dierent charges (for example, $M n^{3-4+}$, Co^{3-4+} , Cu^{2-3+} , etc) and magnetic states can break into a stable statem adeout of nanoscale coexisting clusters because of complicated electron-phonon and m agnetic interactions [4]. The G ibbs energy of such a subm icro-heterogeneous (nanostructured) system is essentially in uenced by the nature of the interface between matrix and nucleus. This interface may be coherent, sem i coherent and incoherent. If the interface is coherent or sem icoherent the system behaves as a hom ogeneous single phase in term s of di raction. Microdom ain-textured oxides exem plify such system s rather well [1]. As shown in [5], unm ixing of nonstoichiom etric and doped oxides with perovskite-related structures produces microdomains of 5 {50 nm in size.

N anostructured materials may show enhanced ionic conductivity owing to the high density of interfaces which are enriched by defects due to the formation of space charge layers [6] or reduction of coordination number of cations in the vicinity of interface [7].

Therefore, nonstoichiom etric doped oxides with microdom ain texture may provide conductive channels for enhanced oxygen discionalong the microdom ain boundaries [8,9]. Materials with high oxygen mobility are of interest for applications such as oxygen electrolytes, electrodes, sensors and membranes for oxygen separation [8].

Num erous experim ental proofs of enhanced di usion along grain boundaries (including radiography, [10{12]) have initiated theoretical investigations of

inhom ogeneous di usion in polycrystalline materials [13{15]. The rst mathematical description of fast di usion along grain boundaries accompanied by penetration into the grains by means of bulk di usion (without phase transition though) is shown in [13,16]. In [17,18], a mathematical model of the two-phase oxidation of MDT nonstoichiometric perovskite has been considered. The crystal is conceived as an assembly of parallel domain boundaries, which are considered to be high di usivity paths. Oxidation proceeds as a result of rapid oxygen transport along the domain boundaries and two-phase oxidation of the microdomains.

Unlike the previous papers, here we assume that oxidation of microdom ains occurs as a result of one phase reaction. We employ a model for oxygen transport in the MDT perovskites in the course of single phase oxidation, assuming that dission along the nanodom ain boundaries is much faster than dission into the domains. Since nanostructured perovskites exhibit fast oxygen transport even at room temperature, the model was applied for the evaluation of oxygen dission parameters from data of wet electrochemical oxidation of nano-structured perovskite $SrCo_{0.5}Fe_{0.2}Ta_{0.3}O_{3.y}$ samples in 1M KOH at ambient temperatures.

Potentiostatic method [19,20] is considered to be a convenient tool for studying oxygen transport in perovskites (where electron conductivity far exceeds the ion one). In the present study we have used a version of this method.

2 Experim ental

K inetic studies were carried out for $SrCo_{0.5}Fe_{0.2}Ta_{0.3}O_{3~y}$ nonstoichiom etric perovskite. The samples were synthesized by solid state reaction from the corresponding metal oxides and carbonates with preliminary homogenization of the starting materials in a planetary ball mill. A stoichiom etric mixture of the powders was calcined at 900 C, pressed in pellets, annealed in air at 1400 C for 6 hours and cooled in the furnace.

For kinetic studies, the sintered sample was annealed at 950 C in a quartz am poule in dynamic vacuum (P 10^3 Pa). After that, the quartz am poule was closed and placed in water for rapid quenching of the sample to room temperature.

Experiments were performed at room temperature (25 C) in potentiostatic mode (three electrode cell, 1M KOH electrolyte, Hg/HgO reference electrode) with working electrodes of polycrystalline material (17{18 mg) pressed into Pt grids along with 1 wt% of Te on and 15{20 wt% of acetylene black. The working electrode was placed in a cell at the set temperature and was main-




Fig. 1. Applied potential (a) and current (b) versus time.

tained up to an equilibrium potential U_0 . At t=0 a voltage pulse between the working electrode and reference electrode has been applied. Re-equilibration through di usion of oxygen into the working electrode material takes place. The rate of re-equilibration can be measured easily by monitoring the electric current passing through the cell, see Fig. 1.

3 Theoretical model

Sim ilar to the model of spheres lling a half-space (grains in a thick metal plate, see [14]), we consider a model, where small spheres are inside large ones (nano-domains inside the perovskite powder particles). The simple geometry

of our model allows us to derive an exact solution for the current passing through the cellusing the Laplace transform method.

Inverse Laplace transform ation to determ ine the original function is not possible in analytical form (in analytical functions; this is the reason why one usually analyzes only the asymptotic current behavior at short and long times). Though there exist computational methods to do reverse Laplace transformations [21], they require intensive calculations (double Fourier transforms). Therefore, we have chosen another way ofmodel comparison with experiment. A fler we perform numerical Laplace transformation of measured current function, $J_{\rm exp}$ (t), (as well as potential function, if it is measured and is not given lanalytically with potentiostate) we adjust transform, $\hat{J}_{\rm exp}$ (p), with model curves $\hat{J}_{\rm th}$ (p) (which depend on the applied potential prole).

However, com puter inversion of Laplace transform may be useful for verifying the best approximation, or for the better choosing among several minima, if they occur.

A two-level model of spheres is used to describe the current passing through an electrochemical cell under potential of a chosen prole.

3.1 Di usion in a spherical particle

The di usion equation for a spherical particle, when the space derivatives (Laplacian) are reduced to di erentiation over the radius, is written as follows:

Di usion current (and electric one, if di using component carriers charge q), passing through the whole particle boundary, may be expressed as follows:

One may expect that the disciplination coes cient is independent of concentration, provided that the oxygen content in the perovskite lattice changes only slightly, e.g., y < 0:1. For this purpose the amplitude of potential pulse, U_A , applied to the cell, should be small enough (this is determined by the ratio of sample mass and charge). We assume that the access of oxygen ions to the particles is not limited and, hence, there is a linear dependence between concentration and the potential




Fig. 2. Regions of slow (white) and fast (grey) di usion

3.2 Inhom ogeneous di usion model: spheres of two types

Let us im agine that particles in the sample are non-uniform (see Fig. 2) and contain domains of a typical size r, where disciplinaries, where disciplinaries and p_1 , and well as regions neighboring with domains boundaries, where disciplinaries high, p_2 . More exactly, let us consider p_2 as an elective disciplinaries coefficient for a porous particle, obtained, when all domains are removed, as if they are non-permeable for disciplinaries. $p_1 = 0$. This elective coefficient may change not only with temperature, but also with parameters related to the nano-domain structure, such as oxygen content, quenching rate, etc.

If di usion coe cient D_1 is small but not equal to zero, then di usion equation should reject oxygen incorporation inside the domains. One may assume that the concentration along the boundary of each domain is approximately the same (since transport to the boundary is fast) and is equal (or at least proportional) to the current local concentration:

Here n_d is the concentration of domains, J_1 =q the di usion current into a domain, $v_1 = n_d 4 r^3$ =3; $v_2 = 1 v_1$ are volume fractions for regions of slow and fast di usion, respectively. A fler Laplace transformation we obtain (taking into account equations (5), (6)):

where = $v_1 = v_2$ is the ratio of above mentioned volume fractions (see Fig. 2).

As it is mentioned in [14], equilibrium concentrations (of di usant) along the boundaries and inside the domains (i.e. grains) may not coincide. Therefore, dimensionless parameter may include not only geometry but also the concentration factor.

One may derive the nalexpression for the current using equation (8) (it is necessary to remember that the particle is inhomogeneous):

3.3 A ssem bly of particles, particle size distribution

If powder particles are of dierent sizes, then the current expression (6) and expression (9) should be integrated with the function of volume (mass) distribution of particles, M (R) (norm per unit):

One may obtain this correction by e.g. integration with formal distribution (delta functions):

4 Experim ental results and computation




Fig. 3. Di raction patterns of samples $SrCo_{0.5}Fe_{0.2}Ta_{0.3}O_{3.y}$: (1) as sintered, (2) after annealing at 950 C and quenching in vacuum (P 10^3 Pa).

A coording to the X-ray di raction (Fig. 3) and iodom etric titration data, quenched samples of $SrCo_{0.5}Fe_{0.2}Ta_{0.3}O_{3~y}$ had the expanded cubic unit cell param eters (from 3.934 A to 3.952 A) and reduced oxygen content (from 2.92 to 2.70) with respect to slowly cooled ones.




Fig. 4. High resolution image of SrC $o_{0.5}$ Fe $_{0.2}$ Ta $_{0.3}$ O $_{2.7}$ sample possessing microdomain texture.

XRD suggests single phase behaviour, while the HREM data shows that the sam ples possess a micro-dom ain texture (Fig. 4) with a typical dom ain size of about 10 nm.




Fig. 5. In situ anodic oxidation of SrC $o_{0.5}$ Fe $_{0.2}$ Ta $_{0.3}$ O $_{2:7+ \, x}$: (a) potential E vs. charge transfer n, (b) change of unit-cell param eters with n, n=2 = x.

The mechanism of electrochem ical oxidation of SrC $o_{0.5}$ Fe $_{0.2}$ Ta $_{0.3}$ O $_{3~y}$ has been studied with chronopotentiom etry combined with in situ X-ray di raction. The results of evaluation of the in situ data are shown in Fig. 5.M onotonous changes in the unit cell parameters and potential vs. inserted oxygen (x) (x = n=2, where n is a charge transfer) provide evidence of one phase mechanism of oxidation [22].




Fig. 6.M ass distribution of particles over size.

For kinetic studies, the samples were powdered, and particle size distribution was measured (see Fig. 6).

Fig. 1 shows U (t) and $J_{\rm exp}$ (t) functions versus time, obtained in one of experiments. The time of current measurement averaging was 1 second. This obstacle somewhat distorted the current plot at short times.

Computations were performed in MatLab. For the data, presented in Fig. 1, potential step parameters are the following (see equations (5) and (9)):

A fter \hat{J}_{exp} (p)=Q was calculated (exponential slope at long times (t > 3000 s) was considered analytically), correction for the time of micro ammeter integration (1 s) was introduced:




Fig. 7. Normalized Laplace transform of experimental data (solid; $Q=0.44\ C$) and tting model curves for inhomogeneous (dot) and homogeneous (dash; = 0) model.

Computing results are shown in Fig. 7, model parameters for theoretical curve (dotted line) being as follows:

Let us note that thing by the homogeneous model gives essentially larger errors (see dashed curve in Fig. 7), and yields another value: $_2 = 15$ 10s.

5 Discussion and conclusions

As we have already noted, nonstoichiom etric and/or doped oxides are high tem perature systems, since solid solutions are stable at relatively high tem peratures only. At lower tem peratures the high free energy related to the high concentration of defects (oxygen vacancies, guest ions) can be reduced either by defects ordering and their localization as structural elements (superstructures formation), or by their elimination or precipitation (nanostructuring, microdomain texturing) [1]. The dierence between the MDT phases and ordered superstructures is that in MDT oxides part of disorder is already accumulated at low temperatures as excess interfacial energy (disordered lattice in the vicinity of interfaces). Therefore, the lower is working temperature, the more essential is the MDT oxide advantage with regard to oxygen transport. That is why MDT oxides are promising materials for low and moderate temperature oxidative catalysis, oxygen permeable membranes for partial oxidation of hydrocarbons, SOFC's electrodes, sensors etc.

W ith our developed model, we have shown that nanostructuring allows inhomogeneous oxygen di usion in domains and along the interfaces; the di erence in di usion coe cients may attain several orders of magnitude. The most important issue is that stationary ux of oxygen ions through a MDT perovskite membranes at temperatures lower than the point of order-disorder transition is determined mostly by coe cient D₂.

Since activation energy Ea, necessary for the oxygen ions migration along the grain boundaries (g.b.), may be essentially lower than that for the bulk (b.) di usion, Ea (q.b.) 1=2E_a (b:) [23], oxygen perm eable m em branes m ade of MDT oxides are able to provide several orders of magnitude higher oxygen uxes at the working tem peratures below the order-disorder transition point. Let us mention though that nanostructuring is not the su cient condition for intensive oxygen transport along the interfaces. For exam ple, alkali/rare earth m anganites possess a well-developed m icrostructure, but oxygen m obility in them is very low, whereas alkali/rare earth ferrites, and in particular cobaltites show unusually high oxygen transport [8]. A pparently, the transport properties of oxides are in uenced by the interfacial energy, which is dependent on a set of param eters (M (O bond strength, coordination of cations, their charges and size, electronic con quration, magnetic state of cations, etc.). In case if interfacial energy is high enough (disordered interface), one may expect high perm eability of oxygen. If interface is ordered (low interfacial energy), most likely it will be a barrier for the ion di usion.

W e shall further study the kinetics of M D T perovskites oxidation at various temperatures to determ ine the activation energy for oxygen ions m igration along the interfaces and inside the domains and develop the method for mea-

suring oxygen di usion parameters in the nanostructured materials. Com paring the data obtained at low temperature by means of relatively simple wet electrochemical technique with the data related to oxygen permeability at high temperatures, we might de ne the mechanism of oxygen transport in MDT oxides, elucidate the factors determining the high values of oxygen uxes in these materials and might open strategies to develop new oxygen-conducting materials operating at moderate temperature.
