A bstract
Q uite general, analytical (both exact and approxim ate) form $s$ for discrete probability distributions ( P ' 's) that $m$ axim ize $T$ sallis entropy for a xed variance are here investigated. T hey apply, for instance, in a w ide variety of scenarios in which the system is characterized by a series of discrete eigenstates of the H am iltonian. U sing these discrete PD's as \weights" leads to density operators of a rather general character. $T$ he present study allow s one to vividly exhibit the ects ofnon-extensivity. V arying T sallis' non-extensivity index $q$ one is seen to pass from unstable to stable system $s$ and even to unphysical situations of in nite energy.

## 1 Introduction

T sallis' them ostatistics is today a new naradiom for statistics, with applications to severalscienti c discipline N otw ithstanding its m anifold applications, som e details of the basce them ostatistical form alism rem ain unexplored. T his is why analytical results are to be welcom e, specially if they are, as the ones to be here investigated, of a very general nature. W e will provide this type of results for discrete probability distributions of xed variance that m axim ize T sallis' entropy.
$G$ iven a discrete probability distribution (DPD) $p=f_{p_{k}} g$, its $T$ sallis' inform ation $m$ easure (or entropic form) is de ned as

W thout loss of generality, we w illhere consider only centered random variables of xed variance.

The aim of this paper is to provide accurate estim ates of i) the param eters of the DPD's and ii) their behavior. The maxim izers of $T$ sallis' inform ation $m$ easure under variance constraint in the continuous, multivariate case have been discussed in

If we now nd a physical quantity Z whosem ean value is proportionalto the variance, we can interpret as them ixed state that $m$ axim izes $T$ sallis $m$ easure sub ject to the a-prioriknow $n$ expectation value of such a physical quantity. W e will show below that, in these circum stances, universal expressions can be given for the $\mathrm{p}_{\mathrm{k}}$ 's, and thus for.
W e discuss possible applications in the forthcom ing section. A fterw ards, after having introduced som e de nitions and notations, we characterize the discrete $T$ sallis $m$ axim izers for xed variance in both the $q<1$ and the $q>1$ cases, and discuss therm al stability questions. W e pass then to analyze extensions to the $m$ ultivariate cases. For the sake of com pleteness, som e of the proofs of assertions referenced to in what follow s are given in A nnex.

## 2 P ossible physical applications

Several physicalm odels can be adanted to the scenario described above (C f. Eqs. and The weights $p_{k}$ in will be of the $T$ sallis-pow er law form. $W$ ith these weights, $m$ axim izes $T$ salل1s' entropy sub ject to the constraint of a constant variance, which introduces a Lagrange m ultiplier that we will call. .
G iven a physicalquantity Z whose $m$ ean value is proportional to the variance, is that $m$ ixed state which $m$ axim izes $T$ sallis $m$ easure sub ject to the a-priori
known hZ i value. In the exam ples below $Z$ is the system's energy $E$, but $m$ any other possibilities can be im agined. Thus, $w$ illbe the state $m$ axim izing $T$ sallis' $H_{q}$ for a xed value of the expectation value $U=h E i=\operatorname{Tr} \mathbb{H} \quad$ ] of the H am iltonian. As a consequence, the multiplier can be thought of as an \inverse tem perature" $T$, that is, set $=1=\left(k_{B} T\right)$, with $k_{B}$ the Boltzm ann constant. This is so because we are at liberty of im arining that $U$ is kept constant because it is in contact with a heat reservoir $O$ f course, this is not necessarily the case. exists by itself and is a legitm ate stationary m ixed state of our system. But we can think of as either a \real" or an \equivalent" inverse tem perature.
C onsider, for exam ple, a system for which the energy spectrum consists of a denum erable set of $N$ ( $N$ possibly in nite) energy levels labeled by a quantum num ber $k$ with $p_{k}=p_{k}$; so that all levels exhibit a degeneracy

A s just stated, we may think, if we wish, that our system is in contact $w$ ith a heat reservoir, which xes the $m$ ean energy, and that the associated Lagrange multiplier can be assim ilated to an inverse tem perature $T$. A $m$ ong $m$ any exam ples of such a scenario we mention here:

## 3 Denitions and N otations

In what follow $\mathrm{s}, \mathrm{m}$ is a positive real num ber and n a positive integer. O ften, m w ill take the special form of an odd integer $m=2 n+1$ : $T$ he solutions to the problem of $m$ axim ization of $T$ sallis entropy \under variance constraint" (here equivalent to \for xed $m$ ean energy") w illibe called discrete $T$ sallis-probability laws (DTPL's) in this manuscript. Since (see preceding Section) xed mean energy can be thought of as im plying contact $w$ ith a heat reservoir at the xed tem perature $T=1=\left(k_{B}\right)$ we will call the pertinent Lagrange multipliers inverse tem peratures in what follows. D TPL's are given by the follow ing two theorem s .

In the lim it T ! 1 , our pmbability distribution converges to the classical discrete $G$ aussian distribution
$N$ otice the existence of a low er bound $q=1=3$. Sm aller $q$ wahes are unphysical because for them them ean energy ofthem odel (for the PD becom es in nite. A dditionally (see below) the system tums out to be them odynam ically unstable because the speci cheat becom es negative. In this case where $q<1$, we de ne the realpositive param eter $m$ that we need below by

## 4 A pproxim ate treatm ents for $q<1$

### 4.1 The two regím es

Let us recall that, for $q<1, m=(1+q)=\left(\begin{array}{ll}1 & q\end{array}\right)$. Thus, $m$ is large if $q!1$ (Boltzm ann lim it (BL)), while a sm all positive value of $m$ entails $q$ ! 1 . $C$ arefulinspection of the partition function $f_{q}(T)$ in the casesm $=3 \$ q=1=2$, $m=5 \$ q=2=3$, and $m=7 \$ q=3=4$ indicates that two regim es should be distinguished:
the rst regin e, called "pow er law " regim e, corresponds to the case $T$ (low tem peratures)
the second regim e called the "Student-t" regim e, corresponds to the case T 1 (high tem peratures)

A nticipating the results provided by the follow ing theorem s, we note that the cases "sm all T "/"large T" can be translated as joint range values of param eters U and $\mathrm{m} \quad(1+q)=\left(\begin{array}{ll}1 & q) \text { : typically, the large } T \text { case corresponds to jointly }\end{array}\right.$ large values of $U$ and $m$; as expected, while the sm all case corresponds to jointly sm all values of these param eters. This is ilhustrated on the curve below ( $F$ ig. 1), where the large $T$ property is translated as $T \quad 100$; and the $s m$ all $T$ property as $T \quad 0: 01: N$ ote that the left bound $n=1=2$ corresponds to $m=2 n+1=2$; i.e., $q=1=3$, and thus to an (unphysical) in nite $U$. For econom $y$ 's sake we set herefrom

### 4.2 The pow er law regím e

In the pow er-law regim e ( $T$ 1), a detailed characterization of the distribution can be obtained for all real values of $m$, as show $n$ in the follow ing theorem .

$T$ he speci $c$ heat $C=d U=d T$ is proportional to $(m+1) . T$ his is positive, and thus the system stable, for all $\frac{1}{3}<q<1$.

N otice that, according to only the ground state is populated at $\mathrm{T}=0$, as it should.

The probability $p_{k}$ decreases exponentially $w$ ith $k$; being thus concentrated around its $m$ ean value EX $=0$ : A s an exam ple, if $a=0: 1$; the follow ing table show $S$, for several values of $q>\frac{1}{3}$, the rst values of $\mathbb{R}$ :

Rem ark 6 A rem arkable result here is that expression $\quad$ is exactly the sam pled version - w ith the sam e partition function - of the mntanuous $m$ axim izer of the T sallis entropy whose expression is recalled here

$T$ his entails that, at very high $T$, one can approxim ate sum $s$ over discrete energy levels by an integral. In order to understand the situation, rem em ber that the results holds for m 1, which entails $q$ 1, i.e., the Boltzm ann lim it. In this $\lim$ it, replacing sum $s$ by integrals is a com $m$ onplace text-book procedure.

## 5 The q> 1 instance

### 5.1 A general result and its consequences

Recall that in the case $q>1, m=(q+1)=(q \quad 1)$. The equivalent of theorem w rites as follow s:

W e see from the form of that the speci cheat $C$ isproportionalto $1=(m+2)$. $T$ hus, the is system stable for all $q>1$. A lso, since $a^{2}=k_{B} T$, we see that the $m$ ean energy $U$ is an increasing function of $T$, as it should.

### 5.2 C onvergence to a sam pled Student-r law

A s a consequence of theorem the $T$ sallis $m$ axim izers can be approxim ated as follow $s$, for a large enough (1 large enough).

W e show now that, in the case where param eter $m$ grow $s$ to in nity, both discrete $T$ sallis distributions corresponding to either $q<1$ or q > 1 converge to the discrete norm aldistribution.

## 8 C onclusions

In this report, we have derived in analytic fashion som e elem entary properties of the discrete univariate and m ultivariate T sallis law s (probability distributions
$p_{k}$ running over a discrete index $k$ ) for both $q<1$ and $q>1$ : $M$ ost of the ensuing results are given by approxim ations, but num erical sim ulations show that they can be regarded as very accurate ones.
The discrete probability distributions $p_{k}$ de ne, for any $H$ am iltonian $H$ whose eigenvalue equation reads $H j k i=k j k i m i x e d$ states of the form

that com $m$ ute $w$ ith the H am iltonian by construction and represent thus bona de stationary states of the system de ned by H. These weights p are of the $T$ sallis-pow er law form. W th these weights, maxim izes $T$ sallis' entropy sub ject to variance constraint, which introduces a Lagrange multiplier. In this work we have considered situations for which the system 's m ean energy is proportional to the variance.
O ur present consideration allows one to nitidly appreciate the e ects of nonextensivity, as, varying $q$, one passes from unstable to stable system $s$ and even to unphysical situations of in nite energy.
