SIM PLEX TRIANGULATION INDUCED SCALE-FREE NETW ORKS

A b stract. We propose a simple rule that generates scale-free networks with very large clustering coe cient and very small average distance. These networks are called simplex triangulation networks (STNs) as they can be considered as a kind of network representation of simplex triangulation. We obtain the analytic results of power-law exponent = $2 + \frac{1}{d-1}$ for d-dimensional STNs, and clustering coe cient C. We prove that the increasing tendency of average distance of STNs is a little slower than the logarithm of the number of nodes in STNs. In addition, the STNs possess hierarchical structure as C(k) k^{-1} when k = 0 that in accord with the observations of many real-life networks.

1 Introduction

Recently, empirical studies indicate that the networks in various elds have som e com m on characteristics, which inspires scientists to construct a general m odel[1-3]. The most important characteristics are scale-free property and small-world e ect. The former means that the degree distribution obeys power law as p(k) / k, where k is the degree and p(k) is the probability density function for the degree distribution. is called the power-law exponent, and is usually between 2 and 3 in real-life networks. The latter involves two factors: small average distance as L lnN or even smaller and great clustering coe cient C, where L is the average distance, N is the number of nodes in the network, and C is the probability that a random ly selected node's two random ly picked neighbors are neighbor. One of the most well-known m odels is W atts and Strogatz's small-world network (W S network), which can be constructed by starting with a regular network and random ly moving one endpoint of each edge with probability p[4]. A nother signi cant one is Barabasi and Albert's scale-free network model (BA network) [5]. The BA m odel suggests that two main ingredients of self-organization of a network in a scale-free structure are growth and preferential attachment. However, both W S and BA networks fail to m im ic the reality in some aspects. Therefore,

a signi cant problem is how to generate networks displaying both scale-free property and small-world e ect [6-8].

In this paper, we propose a simple rule that generates scale-free networks with very large clustering coe cient and very small average distance. These networks are called simplex triangulation networks (STNs) as they can be considered as the one-dimensional framework of simplex triangulation in the view of algebraic topology [9]. Our model starts with a d-simplex, where d 2 is an integer. The network representation of this simplex contains d+1 nodes and $\frac{d(d+1)}{2}$ edges. Then, at each time step, a simplex is randomly selected, and a new node is added inside this simplex and linked to all its d+1 vertices (nodes). During each time step, the number of simplices, nodes and edges increases by d, one, d+1, respectively. Repeat this simple rule, one can get the d-STN of arbitrary order that he likes.

2 The degree distribution

As we have mentioned above, the degree distribution is one of the most important statistical characteristics of networks. Since many real-life networks are scale-free networks, whether the networks are of power-law degree distribution is a criterion to judge the validity of the model.

Since after a new node is added to the network, the number of sim plices increases by d, we can im mediately get that when the network is of order N , the number of sim plices is:

$$N_s = d(N - d - 1) + 1 = dN - 2d - d + 1$$

Let N_s^i be the number of simplices containing the node i, the probability that a new ly added node will link to the ith node is $N_s^i = N_s$. Apparently, N_s^i will increase by d-1 while k_i increases by one, and when the node is new ly added, it is of degree d+1 and contained by d+1 different simplices, thus

where N $_{\rm S}$ (k) denotes the number of sim plices containing a node of degree k. Let n (N ;k) be the number of nodes with degree k when N nodes are present, now we add a new node to the network, n (N ;k) evolves according

to the following rate equation [10]:

When N is su cient large, n (N;k) can be approximated as N p(k), where p(k) is the probability density function for the degree distribution. In terms of p(k), the above equation can be rewritten as:

U sing Eq.(1) & (2) and the expression p(k + 1) $p(k) = \frac{dp}{dk}$, we can get the continuous form of Eq.(4):

For large k (p(k+1) p(k), k d) and N d, we have:

This lead to p(k) / k with $= 2 + \frac{1}{d-1} 2$ (2;3], in accord with many real-life networks with power exponent between 2 and 3.

3 The clustering coe cient

The clustering coe cient of a node is the ratio of the total number of existing edges between all its neighbors and the number of all possible edges between them. The clustering coe cient C of the whole network is de ned as the average of all nodes' clustering coe cient. At rst, let us derive the analytical expression of C (k) denoting the clustering coe cient of a node with degree k. When a node is newly added into the network, its degree and clustering coe cient are d+1 and 1. After that, if its degree increases by one, then its new neighbor must link to its dexisting neighbors. Hence we have:

$$C(k) = \frac{\frac{d(d+1)}{2} + d(k - d - 1)}{\frac{k(k-1)}{2}} = \frac{d(2k - d - 1)}{k(k - 1)}$$

The clustering coe cient of the whole network can be obtained as the mean value of C(k) with respect to the degree distribution p(k):

$$C = \begin{cases} Z_{k_{max}} \\ C_{k_{min}} \end{cases} (8)$$

where $k_{min}=d+1$ is the minimal degree and k_{max} k_{min} is the maximal degree. Combine Eq.(7) and Eq.(8), note that $p(k)=A\,k^{\frac{2d-1}{d-1}}$ and

 $R_{k_{max}}$ Ap(k)dk = 1, we can get the analytical result of C by approximately treating k_{max} as +1 . For example, when d = 2, the clustering coe cient is

and when d = 3, it is

For larger d, the expression is too long thus it will not be shown here. The integral values for d=4;5;6;7;8;9;10 are 0.8406, 0.8660, 0.8842, 0.8978, 0.9085, 0.9171, and 0.9241, respectively.

It is remarkable that, the clustering coe cient of BA networks is very small and decreases with the increasing of network order, following approximately C $\frac{\ln^2 N}{N}$ [11]. Since the data—ow patterns show a large amount of clustering in interconnection networks, the STNs may perform better than BA networks. In addition, the demonstration exhibits that most real-life networks have large clustering coe cient no matter how many nodes they have. That agrees with the case of STNs but conicts with that of BA networks. Further more, many real-life networks are characterized by the existence of hierarchical structure [12], which can usually be detected by the negative correlation between the clustering coe cient and the degree. The BA network, which does not possess hierarchical structure, is known to have the clustering coe cient C (x) of node x independent of its degree k (x), while the STN has been shown to have C (k) k¹, in accord with the observations of many real networks [12].

4 The average distance

U sing sym bold(i; j) to represent the distance between i and j, the average distance of STN with order N, denoted by $\frac{L}{P}$ (N), is defined as: L(N) = $\frac{2 (N)}{N (N-1)}$, where the total distance is: (N) = $\frac{1}{1} \frac{1}{1 + 1} \frac$

A ssum e that the node N + 1 is added into the simplex y_1y_2 d+1 Athen the Eq.(11) can be rewritten as:

where D (i;y) = minfd(i;y_j); j = 1;2; ;d + 1g. Constrict this simplex continuously into a single node y, then we have D (i;y) = d(i;y). Since $d(y_i;y) = 0$, Eq.(12) can be rewritten as:

The sum $_{12}^{p}$ d(i; y) can be considered as the total distance from one node y to all the other nodes in STN with order N d. In a rough version, the sum $_{12}^{p}$ d(i; y) is approximated in terms of L (N d) as:

Combining Eqs.(13), (14) and (15), one can obtain the inequality:

$$(N + 1) < (N) + N + \frac{2(N)}{N}$$

Consider (15) as an equation, then we have:

$$\frac{d(N)}{dN} = N + \frac{2(N)}{N} \tag{17}$$

This equation leads to

$$(N) = N^2 \ln N + H$$

where H is a constant. As (N) $N^2L(N)$, we have L(N) lnN . Which should be pay attention to, since Eq. (16) is an inequality indeed, the precise increasing tendency of L m ay be a little slower than lnN .

5 Conclusion remarks

In conclusion, in respect that the simplex triangulation networks are of very large clustering coe cient and very small average distance, they are not only the scale-free networks, but also small-world networks. Since many real-life networks are both scale-free and small-world, STNs may perform better in minicking reality than BA and WS networks. In addition, STNs possess hierarchical structure in accord with the observations of many real networks.

Further more, we propose an analytic approach to calculate clustering coe cient, and an interesting technique to estimate the growing trend of

average distance. Since in the earlier studies, only few analytic results about these two quantities of networks with random icity are reported, we believe that our work may enlightened readers on this subject.

We also have done the corresponding numerical simulations, the simulation results agree with the analytical ones very well.
